## Current Executive Directors

**Mr. Lau Chi Yung, Kenneth**, aged 42, is the Chairman of the Company. He has over 20 years' experience in the manufacturing, international trading, and property investment and development businesses. He joined the Group as a Non-executive Director in November 1995 and was appointed as the Vice-Chairman in February 1996. He is responsible for steering the business direction and corporate development of the Group.

**Mr. Tsang Pak Chung, Eddy**, aged 44, is the Vice-Chairman and Managing Director of the Company. He is responsible for the general management of the Group and has an overall responsibility for the steel trading, steel manufacturing operations and business development of the Group. He joined the Group in 1996. He has over 20 years' experience in corporate finance, treasury, auditing and company secretarial practice and has spent ten years with an international accounting firm. He graduated from Monash University, Australia with a bachelor's degree in economics and also obtained a master's degree in commerce from the University of New South Wales, Australia. He is currently a member of the Institute of Chartered Accountants in Australia, the Hong Kong Society of Accountants and the Institute of Chartered Company Secretaries and Administrators.

**Ms. Leung Wei San, Saskia**, aged 42, joined the Group as an assistant to the Vice-Chairman in November 1995. She was appointed as an Executive Director of the Company on 21 March 1999. She is the wife of Mr. Lau Chi Yung, Kenneth.
