### 3、 公司內部職工股情況

本公司內部職工股發行日期為一九九二年四月二十九日,發行價格每股為人民幣1元,發行數量為35,000,000股,託管機構為南京證券登記公司,託管日期為一九九四年四月二十一日,其中5,000,000股於一九九六年十一月十八日上市流通,30,000,000萬股於一九九年十一月八日上市流通,至此公司內部職工股已全部上市流通。

### (3) Employee Shares

The employee shares of the Company were issued on 29 April 1992. Issue price was RMB1 per share and the number of the shares issued was 35,000,000. The shares were held on trust by Nanjing Securities Registration Company on 21 April 1994, of which 5,000,000 shares were listed on 18 November 1996. The rest of 30,000,000 shares were listed and circulated in the market on 8 November 1999. All the employee shares of the Company were listed and circulated in the market.

#### Shareholders

(1) As at 31 December 2001, there were 28,372 shareholders of the Company, including 28,317 holders of A Shares and 55 holders of H Shares.

- (1) 以上列出的股東情況中代表國家持有股份 的單位為熊貓電子集團有限公司持有本公 司股份355,015,000股,佔本公司已發行 股本的54.20%, 為未上市流涌的國有法 人股。熊貓電子集團有限公司最早前身成 立於一九三六年,後於一九九九年七月五 日經南京市政府批准改制轉為有限責任公 司,現註冊資本為人民幣9.8億元,其股 東為南京新港開發總公司(佔股本46%), 江蘇省國際信託投資公司(佔投本45%), 南京市國有資產經營(控股)有限公司(佔 股本9%)。法定代表人為奚永明,經營範 圍為無線電通信設備、廣播電視設備、電 器機械及器材,電子系統工程等。其所持 股份於報告期內未有變化,亦無質押或凍 結的情況。
- (2) 香港中央結算(代理人)有限公司所持有本公司H股240,076,899股(佔本公司已發行股本的36.76%),乃分別代表其多個客戶所持有,其中摩根士丹利添惠亞洲有限公司(MORGAN STANLEYD DEAN WITTER INVESTMENT MANAGEMENT COMPANY)透過香港匯豐銀行代理人有限公司持有本公司H股37,431,000股,佔H股總數比例為15.47%,佔本公司總股本比例為5.71%。除此之外,本公司並不知悉任何個別客戶持有本公司已發行股本10%以上的權益。
- (3) 以上第二至第十大股東所持H、A股均為 向社會公開發行的可流通股。
- (4) 前十名股東均不是本公司的戰略投資者, 且無關聯關係。

- Notes:
- (1) Among the shareholders named above, Panda Electronics Group Limited ("PEGL") held 355,015,000 shares, representing 54.20% of the issued share capital of the Company, on behalf of the State. The State-owned legal person shares are non-circulating shares. The predecessor of PEGL was formed in 1936 and converted into a limited company upon approval by Nanjing Municipal Government on 5 July, 1999. The registered capital of PEGL is RMB980 million and its shareholders include 南京新港開發總公司 (Nanjing Xingang Development Corporation), holding 46% of the share capital of PEGL, 江蘇省國際信 託投資公司 (Jiangsu International Trust and Investment Corporation), holding 45% of the share capital and 南京市國有資產經營(控股)有限 公司 (Nanjing Municipal Stated-owned Assets Operation Company), holding 9% of the share capital. The legal representative of PEGL is Mr. Xi Yongming. PEGL engages in the manufacture of wireless telecommunication equipment, broadcasting television equipment, electrical machinery and apparatus, electronic system projects, etc. The shareholding held by PEGL did not change and the shares were neither subject to pledge nor being frozen during the reporting period.
- (2) HKSCC Nominees Ltd. held 240,076,899 H Shares, representing 36.76% of the issued share capital of the Company, on behalf of several clients. Of which, Morgan Stanley Dean Witter Investment Management Company held 37,431,000 H shares of the Company through HSBC (Nominees) Ltd., which represented 15.47% of the total H shares and 5.71% of the total share capital of the Company. Save as above, the Company is not aware of any individual client holding more than 10% of share capital issued by the Company.
- (3) The H and A shares held by the above second to the tenth largest shareholder are circulating shares issued to the public.
- (4) All the ten largest shareholders are neither strategic investors of nor connected with the Company.
