

## DIRECTORS

### Executive Directors

Mr. Wong Chi Man (Notes a, b, c), aged 52, is the founder of the Group and the chairman and managing Director. He is responsible for corporate planning, strategic business and product development, marketing and overall management of the Group. He has approximately 41 years' experience in the restaurant and catering industries. Mr. Wong Chi Man is the elder brother of two Directors, Mr. Wong Chi Wing, Tenny and Ms. Wong Lan Fun, Roberta.
