五年財務摘要

以下為本集團禍去五個財政年度業績 及資產負債之摘要, 摘錄自相關已刊 發之經審核財務報告並按情況重新分 類列出。就影響到股息之具追溯力會 計政策變動(詳情載於財務報告附註 二) 而言, 五年財務摘要內若干數字已 按有關影響作出調整。受此等會計政 策改變之影響而作出以往年度調整, 將截至一九九九年、二零零零年及二 零零一年六月三十日止各年度之擬派 末期股息分别為2,530,000港元、 5.147.000港元及4.197.000港元,由本 來於相關年度年結日按流動負債確認 入賬,重新分類至資產負債表內資本 及儲備項下之擬派末期股息儲備賬。 此一調整導致本公司及本集團先前呈 報之截至一九九九年、二零零零年及 二零零一年六月三十日流動負債減少 及儲備增加,數額分別為2,530,000港 元、5,147,000港元及4,197,000港元。

FIVE YEAR FINANCIAL SUMMARY

A summary of the results and of the assets and liabilities of the Group for the last five financial years, as extracted from the respective published audited financial statements and reclassified as appropriate, is set out as below. Certain amounts in the five year financial summary have been adjusted for the effects of the retrospective changes in accounting policy affecting dividends, as detailed in note 2 to the financial statements. The effect of this change in accounting policy is that prior year adjustments have been made to reclassify the proposed final dividend of HK\$2,530,000, HK\$5,147,000 and HK\$4,197,000 for each of the years ended 30 June 1999, 2000 and 2001, respectively, which was recognised as a current liability at the respective year end, to the proposed final dividend reserve account within the capital and reserves section of the balance sheet. The result of this has been to reduce both the Company's and the Group's current liabilities and increase the reserves previously reported as at 30 June 1999, 2000 and 2001, by HK\$2,530,000, HK\$5,147,000 and HK\$4,197,000 respectively.
