Executive Directors

Madam Hou Li Ping, aged 47, is the chairman and a founding member of the Group. She obtained a diploma in medicine from Shanxi Medical Institute in 1984. Madam Hou became a qualified physician in 1988 in the Chinese medical field in the PRC and was further promoted to an honorary medical professor in 1993. She has been engaged in the field of medical and pharmaceutical business and the development of new medicines for over 20 years. She originated the therapeutic treatment of rheumatism, known as "Hou's Therapy" and created various new medicines for the treatment of rheumatism. She is also a well-reputed rheumatic specialist in the PRC. Madam Hou has received Awards of Scientific Technology Advancement at the national and provincial levels in 1991, 1992 and 1993 respectively and has made five publications in relation to rheumatism. She is currently a chairman of the committee of China Old-aged Pharmaceutical Rheumatism Professional Committee, a visiting professor of Shanxi Chinese Medicine Institute, an honorary chairman Japan Rheumatism Association, an honorary professor of Japan Dongyin Association, an honorary professor of Japan Dongyang Pharmaceutical Research Institute and an honorary chairman of Russian No. 10 People's Hospital, Madam Hou presently is also a committee member of the Shanxi Provincial Political Consultative Conference.
