- (1) 以上列出的股東情況中代表國家 持有股份的單位為能貓雷子集團 有限公司持有本公司股份 355.015.000股, 佔本公司已發 行股本的54.20%, 為未上市流通 的國有法人股。熊貓電子集團有 限公司最早前身成立於1936年, 後於1999年7月5日經南京市政府 批准改制轉為有限責任公司,現 註冊資本為人民幣9.8億元,其股 東為南京新港開發總公司(佔股 46%),江蘇省國際信託投資公 司(佔股45%),南京市國有資產 經營(控股)有限公司(佔股 9%)。法定代表人為奚永明,經 營範圍為無線電誦信設備, 廣播 電視設備,電器機械及器材,電 子系統工程等。其所持股份於報 告期內未有變化,亦無質押或凍 結的情況。
- 香港中央結算(代理人)有限公司 (2)所持有本公司H股239 643 899股 (佔本公司已發行股本的 36.59%), 乃分別代表其多個客 戶所持有,其中摩根士丹利添惠 亞洲有限公司(MORGAN STANLEY DEAN WITTER INVESTMENT MANAGEMENT COMPANY)於2001年4月12日誦 知本公司,其透過香港滙豐銀行 代理人有限公司持有本公司H股 37,431,000股, 佔H股總數比例 為15.47%,佔本公司總股本比例 為5.71%。(至報告期末未有變化 通知)除此之外,本公司並不知 悉任何個別客戶持有本公司已發 行股本5%以上的權益。
- 以上第二至第十大股東所持H、 A股均為向社會公開發行的可流 涌股。
- (4) 前十名股東均不是本公司的戰略 投資者,且均無關聯關係,亦非 一致行動人。

#### Notes:

- (1) Among the shareholders named above, Panda Electronics Group Limited ("PEGL") held 355,015,000 shares, representing 54.20% of the issued share capital of the Company, on behalf of the State. The State-owned legal person shares are noncirculating shares. The predecessor of PEGL was formed in 1936 and converted into a limited company upon approval by Nanjing Municipal Government on 5 July, 1999. The registered capital of PEGL is RMB980 million and its shareholders include 南京新港開發總公司 (Nanjing Xingang Development Corporation), holding 46% of the share capital of PEGL, 江蘇 省國際信託投資公司 (Jiangsu International Trust and Investment Corporation), holding 45% of the share capital and 南京市國 有資產經營(控股)有限公司 (Nanjing Municipal Stated-owned Assets Operation Company), holding 9% of the share capital. The legal representative of PEGL is Mr. Xi Yongming. PEGL engages in the manufacture of wireless telecommunication equipment, broadcasting television equipment, electrical machinery and apparatus, electronic system projects, etc. There was no change in the shareholding held by PEGL and the shares were neither subject to pledge nor being frozen during the reporting period.
- (2) HKSCC Nominees Ltd. held 239,643,899 H Shares, representing 36.59% of the issued share capital of the Company, on behalf of several clients. Of which, Morgan Stanley Dean Witter Investment Management Company notified the Company on 12 April, 2001 that it held 37,431,000 H shares of the Company through HSBC (Nominees) Ltd., which represented 15.47% of the total H shares and 5.71% of the total share capital of the Company (The Company had received no notice of change until the end of the reporting period). Save as above, as at the end of the reporting period, the Company is not aware of any individual client holding more than 5% of share capital issued by the Company.
- (3) The H and A shares held by the above second to the tenth largest shareholder are circulating shares issued to the public.
- (4) All the top ten shareholders are neither strategic investors of nor connected with the Company, nor parties acting in concert with each other.
