Save as disclosed above, none of the directors, supervisors or members of the senior management or their associates had any interest in the equity or debt recurities of the Company or any those of its associated corporation (as defined in the "Securities (Disclosure of Interests) Ordinance") as at 31 December 2002, and none of the directors or supervisors, or their spouses or children under the age of 18 had any right to subscribe for the equity or debt securities of the Company, or had exercised any such right.

### (3) Remuneration for the year

During the reporting period, directors, supervisors and senior management are paid based on their relevant post duties. Their remunerations are reviewed based on their performance.

For the year, the remuneration for the existing directors, supervisors and senior management totalled RMB2,248,000. The remuneration for the three highest paid directors totalled RMB440,000 and the remuneration for the three highest paid senior management staff totalled RMB400,000. For director's remuneration, 2 persons are entitled to the sum ranging from RMB120,000 to RMB160,000 and 9 persons are entitled to the sum ranging from RMB80,000 to RMB120,000. For supervisor's remuneration, 1 person is entitled to the sum ranging from RMB80,000 to RMB120,000 and 2 persons are entitled to the sum ranging from RMB60,000 to RMB80,000. For the remuneration of senior management staff, 1 person is entitled to the sum ranging from RMB120,000 to RMB160,000 and 5 persons are entitled to the sum ranging from RMB80,000 to RMB120,000.

Ms. Wan Hui, an independent non-executive director, Mr. Wu Shiyuan and Mr. Li Jianming, both the independent supervisors, are not entitled to remuneration granted by the Company, its parent company and associated companies.

# (4) Names of directors, supervisors and senior management resigned during the reporting period and their reasons

During the reporting period, there were no change to members of the Board of Directors and the Supervisory Committee. The fourth Board of Directors of the Company held its fourth meeting at which the Board resolved to appoint Mr. Tang Xiaoqun as Deputy General Manager of the Company. The fourth Board of Directors of the Company held its sixth meeting at which the Board agreed with the resignation of Mr. Tang Xiaoqun from the position of Deputy General Manager due to work rearrangement. The fourth Board of Directors of the Company held its seventh meeting at which the Board resolved to appoint Mr. Liu Kun as the Deputy General Manager.

#### (5) Company Staff

As at 31 December 2002, the Company had a total of 2,372 employees, 1,340 of which are production staff, 581 are technical staff, 124 are sales personel, 68 are financial staff, 259 are administrative and management staff. Of these employees, 779 are graduates of tertiary institutions and 28 hold master degrees. The Company had 650 staff having retired and which the Company have to bear the related expenses.
