Remuneration during the year

- The remuneration of directors, supervisors and senior management had been determined in accordance with the remuneration and appraisal system established by the Company. Directors, supervisors and senior management receiving remuneration from the Company are subject to the yearly remuneration package system. Pursuant to the relevant provisions in the Articles of Association of the Company, the remuneration of directors and supervisors are determined by general meetings while those of the senior management had been determined by the Board. The Board implements an annual appraisal policy for senior managers and its production and business operations are monitored by the Supervisory Committee. The Human Resources Department of the Company administers the appraisal policy.
- During the year, the nine directors, supervisors and senior management who were remunerated by the Company had received a total remuneration of approximately RMB1,019,500, of which approximately RMB388,500 was paid to the three highest paid directors. The remuneration to the three highest paid senior management totalled approximately RMB375,500. One individual's annual salaries fell within the range from RMB90,000 to RMB100,000, six fell within the range from RMB100,000 to RMB120,000 while 2 others received remuneration in the range from RMB120,000 to RMB140,000.
- Messrs. Zhang Jie, Fan Xinmin, Liu Hong, Pan Shunqun, Yin Shouen, Tu Kelin and Yan Fuquan received remunerations from the controlling shareholder, China Textile Machinery (Group) Company Limited. Mr. Liu Haitao, Mr. Wang Weizhi, Mr. Wang Zengjing, Mr. Gan Xiaojing, Ms. Wu Manju, Mr. Bao Weiguo and Mr. Zhao Wenjie received remuneration from their respective serving companies.
- Independent non-executive directors did not receive any allowances from the Company.

5. Resignation of directors, supervisors and senior management during the reporting period and the appointment of senior management

With the approval of 2001 Annual General Meeting of the Company held on 23rd May 2002, Messrs. Lu Yunliang and Li Shaoping ceased to be the directors of the Company due to reshuffling of duties, Mr. Liu Shitong ceased to be member of the Supervisory Committee of the Company due to age limit. By the nomination of the general manager, Mr. Wang Weizhi was appointed as the deputy general manager of the Company at the Extraordinary Board Meeting of the Company held on 5th June 2002.

Section 2. Staff

As at 31st December 2002, the total staff number of the Group was 12,822, among which 286, 962 and 946 were at the senior, middle and junior levels respectively, and 2,011 received tertiary education. Amongst them, 1,201 were deployed to technical, scientific research and development, 518 in sales and marketing, 414 in operations and management, 9,078 in production and 1,611 in others. In addition, the number of retired staff was 3,265 as at 31st December 2002.

Wage level was determined on the basis of individual performance.

In 2002, employees costs including directors' emoluments totalled RMB320,124,000 (2001: RMB216,704,000).
