Mr. YEUNG Wai Kin, aged 41, has been a director since 1997. He is a director of CAIML. Mr. Yeung is the chief financial officer and a director of First Shanghai Investments Limited. He is also a director of First Shanghai Direct Investments Limited and Golad Resources Limited. He has over 19 years of experience in auditing, finance and management positions. Mr. Yeung possesses professional memberships of the Association of Chartered Certified Accountants, the Hong Kong Society of Accountants and the Taxation Institute of Hong Kong. Mr. WANG Jun Yan, aged 32, has been a director since 1998. He has been appointed as director of CAIML on 1st October 2002.
