

Information of Directors, Supervisors, Senior Managers and Staff

(I) Basic information

1. The Directors and Supervisors of the Company were elected at the 2001 Annual General Meeting held on 14th June 2002, each with a service period of 3 years (from 14th June 2002 to 13th June 2005).

Executive Directors

Mr. Hu Guoliang, male, aged 57, senior engineer (Professional Level), chairman of the board of the directors, graduated from Shanghai Jiaotong University in 1967, and joined Guangzhou Shipyard in 1970. He experienced as chief of Marine Institute, deputy factory manager, No. 1 deputy factory manager of Guangzhou Shipyard, and as deputy general manager, and the general manager.

Mr. Yu Baoshan, male, aged 43, senior engineer (Professional Level), director and general manager of the Company, joined Guangzhou Shipyard in 1978, and graduated from Guangdong Zhanjiang Aquatic College in 1982. He experienced as director in the Second Design Office of Guangzhou Shipyard, and deputy manager in Shipbuilding Division and the deputy general manager of the Company.

Mr. Ye Peihua, male, aged 58, senior engineer, director of the board, deputy general manager of the Company and rector of the Guangzhou Marine Engineering Corporation, graduated from Shanghai Jiaotong University in 1968, and joined Guangzhou Shipyard in 1970. (II) Emoluments of Directors, Supervisors and Senior Managers

1. The emoluments of Directors of the fourth term of the Board of Directors and the fourth term of the Supervisory committee in the Company are paid on the basis of the annual emolument scheme for the directors and the supervisors, which was approved at the 2001 Annual General Meeting. The emolument of senior managers was decided by the Board of Directors.
2. As at the date of 31st December 2002, the aggregate remuneration paid by the Company to its executive Directors was RMB291,700, non-executive Directors and independent non-executive Directors amounted to RMB379,400, including the three highest emoluments paid to Directors amounted to RMB291,700, Supervisors amounted to RMB336,200 and Senior Managers RMB438,600, including the three highest emoluments paid to the senior managers amounted to RMB249,600. Apart from the above-mentioned emoluments, the Company did not offer further allowances or bonuses to the Directors, Supervisors and Senior Managers, nor payments to Directors, Supervisors and Senior Managers as an inducement to join the Company, nor any compensation to Directors, Supervisors and Senior Managers for their loss of office. The Directors, Supervisors and Senior Managers are liable to pay their respective income taxes to the responsible government departments directly. During the year, the pension schemes for executive Directors, Supervisors and Senior Managers were combined with the staff pension scheme of the Company, with total pension contributed by the Company for Directors amounted to RMB48,700, and there was no other special arrangement.
3. During the period under review, the amount bands of emoluments to Directors, Supervisors and Senior Managers are as follows:

(IV) Appointment and Dismissal of Senior Managers of Company

(V)Staff of the Company

As at 31st December 2002, the number of employees on the payroll register of the Company was 4,777, of which 2,533 were production related, 33 are sales related, 70 are finance related and 364 are administration related.

Among the employees in the Company, there are 1,287 technicians with different skills, including 141 senior technicians and 275 intermediate technicians.
