Executive Directors

Mr. Li Kwok Cheung, George, aged 43, is an executive Director. Mr. Li joined Upbest Securities Company Limited in 1996 and is now the executive director and dealing director of the company. He holds a master's degree in international marketing from the University of Strathclyde in Glasgow, Scotland, United Kingdom and is a fellow member of the Association of Chartered Certified Accountants and an associate member of the Hong Kong Society of Accountants.
