2. Remuneration of directors, supervisors and senior management

The remuneration paid to directors and supervisors for 2002 was approved at the Annual General Meeting of the Company in accordance with the working plan of the board of the Company for the year. The remuneration paid to senior management was approved by the board meeting of the Company in accordance with the working plan for the year. The total amount of the remuneration paid to directors, supervisors and senior management for 2002 was Rmb2,720,000. Among them, 2 persons were paid Rmb300,000 to 310,000, 3 persons were paid Rmb200,000 to 300,000, and another 10 persons were paid Rmb100,000 to 200,000. The total remuneration of the three highest paid directors was Rmb869,000.

The allowance paid to each of the independent directors was Rmb24,840, including the travel and accommodation expenses incurred from attendance of board meetings and general meetings.

3. Changes in directors, supervisors and senior management of the Company

The Company held its 2001 annual general meeting ("AGM") on 28 May 2002. The follwing resolutions were passed during the meeting: the resignation of Zhang Denghui as a director of the Company; the appointment of Yan Zhichong as a director of the Company (with effect immediately after the AGM), whereby Mr. Yan's term of office shall be the same as the term of office of directors of the current Board; the resignation of Liu Guoxiong as a supervisor of the Company; and the appointment of Wang Xiangyun as a supervisor of the Company (with effect immediately after the AGM), and Mr. Wang's term of office shall be the same as the other existing supervisors of the Company.

The Company held its third meeting of the 2003 board on 25 March 2003. The following resolutions were passed to approve: the resignation of Mr. Xu Zuyuan as the general manager of the Company, the appointment of Mr. Yan Mingyi as the general manager of the Company and Mr. Wang Kunhe as the deputy general manager of the Company; the resignation of Mr. Ye Yumang and the appointment of Ms. Yao Qiaohong as the company secretary of the Company.

4. Information of employees

As at 31 December of 2002, the number of employees of the Company was 7,849, of which 6,896 were operating employees. The number of employees who have various technical titles was 3,260, accounting for approximately 49.2 per cent of the staff. Among the 3,260 employees who have technical titles, 158 of them have senior technical titles. The number of employees graduating from colleges or universities was 2,076, accounting for approximately 31.3 per cent of the staff. The number of employees retiring and laid-off was 1,216 whose expenses was paid by the Company.
