The directors present their report and the audited financial statements of the Company and of the Group for the year ended 31 March 2003.

The principal activities of the Company are investment holding and the provision of management services.

The principal activities of the subsidiaries comprise the manufacture and sale of plastic injection moulding machines and related products. There were no significant changes in the nature of the Group's principal activities during the year.

RESULTS AND DIVIDENDS

The Group's profit for the year ended 31 March 2003 and the state of affairs of the Company and of the Group at that date are set out in the financial statements on pages 35 to 94.

An interim dividend of HK\$0.04 per ordinary share was paid on 23 January 2003. The directors recommend the payment of a final dividend of HK\$0.11 per ordinary share which, together with the interim dividend paid, makes a total dividend of HK\$0.15 per ordinary share for the year, to shareholders whose names appear on the register of members on 28 August 2003.

In addition, the Company's share premium account and capital redemption reserve account, in the amounts of HK\$478,662,000 and HK\$295,000, respectively, may be distributed in the form of fully paid bonus shares.
