EXECUTIVE DIRECTORS

Mr. Wang Dan Hui (汪丹輝), aged 34, is the Chairman and an Executive Director. He is responsible for the overall planning and management of the Group. Prior to joining the Group in June 1997, Mr. Wang held various management positions in several US based multinational companies in the US and has over four years of experience in corporate management from various sector of business such as investment banking and international trade. Mr. Wang has obtained a bachelor degree in commerce from the University of Shenzhen in the PRC, a bachelor degree in commerce from the City University of New York in the US and a master of business administration degree from Baruch College, City University of New York in the US.

Mr. Wang Hailou (王海樓), aged 53, is the Managing Director and founder of the Group. Mr. Wang is responsible for the overall operational planning of the Group. Mr. Wang has extensive experience in the chemical industry including the manufacturing of anti-corrosive coating for fluid pipelines and industrial-use lubricants. Prior to the establishment of the Group in November 1992, he worked in 大慶石油管理局 (Daqing Petroleum Authority) for more than 17 years. Mr. Wang was graduated from 黑龍江省委黨校大專 (the Heilongjiang Province Government Institute) in economic management.

Mr. Wang has worked as a leader of the oil extraction plant of the North China Strategic Headquarters in 1979 and took a post as a chief of the Daqing Technical Supervision Bureau in 1982. He is well experienced in the production of petroleum and chemical and quality control.

Mr. Li Xiao Hua(李曉華), aged 56, is the financial controller of the Group. Mr. Li joined the Group in July 2002. Mr. Li is responsible for the financial management functions of the Group. Mr. Li is well experienced in financial management and domestic taxation system. He has been the head of Taxation Bureau of Daqing Municipality Development Zone in Heilongjiang Province and the head of Taxation Audit Bureau of Daqing Municipality in Heilongjiang Province before joining the Group.

Mr. Xu is a senior economist and he graduated from 哈爾濱石油專科學校 (Harbin Petroleum School) in 1962. Mr. Xu has over 31 years experience in the lubricating grease industry. Mr. Xu joined the Group in July 2000.

Mr. Zhang Chengyi(張成義), aged 63, is a deputy manager of the Group's lubricant production division. Mr. Zhang is a senior engineer and graduated from 西安石油學院 (Xian Petroleum Institute) in petroleum refining discipline. Mr. Zhang has over 31 years experience in the manufacturing of lubricating oil and grease and has held the position of senior engineer and factory manager in various petroleum refining plants and petrol-chemical plants. Mr. Zhang joined the Group in July 1996.



Mr. Zhou Xueshu (周學書), aged 63, is the senior quality control engineer of the Group and is responsible for overall quality control of the Group's products. SENIOR MANAGEMENT REMUNERATION SYSTEM

The remuneration system of the senior management of the Group is a combination of the economic benefit of the senior management (including executive director) and the operation result and share performance of the Group. Most of the senior management have signed result examination contract with the Company. In this system, the remuneration of the senior management comprises three parts, including basic salary, bonus and share options. The floating remuneration of the senior management represents approximately 70% to 75% of their total potential remuneration, which includes result bonus and share option represent approximately 15% to 25% and 50% to 60% respectively of the total potential remuneration. Floating remuneration is linked with the specific business performance indicators, for example, the net profit, capital return and cost reduction indicator.
