

### DISCLOSURE UNDER PRACTICE NOTE 19 OF THE LISTING RULES

The total value of the amounts due from the Group's affiliated companies in respect of advances made by the Group was approximately HK\$38,299,000 as at 30th September, 2003, which represents approximately 33% of the net tangible asset value of the Group as set out in the condensed consolidated balance sheet.
