In respect of the Company's delay in publication of the Annual Results Announcement and Annual Report and the failure to make up its annual accounts to a date falling not more than 6 months before the date of its annual general meeting, the Stock Exchange reserves its right to take action against the Company and/or the Directors regarding the breaches of paragraphs 8(1), 8(2) and 11(1) of the Listing Agreement by the Company.

The unaudited financial results of the Group for the year ended 31 December 2002 were set out in the Company's announcement dated 30 April 2003.

The Company's Annual Report will be dispatched not later than 1 month from the date of the issue of the Annual Results Announcement.
