3. Remuneration during the year

- 1. The remuneration of directors, supervisors and senior management had been determined in accordance with the remuneration and appraisal system established by the Company. Directors, supervisors and senior management receiving remuneration from the Company are subject to the yearly remuneration package system. Pursuant to the relevant provisions in the Articles of Association of the Company, the remuneration of directors and supervisors are determined by general meetings while those of the senior management had been determined by the Board. The Board implements an annual appraisal policy for senior managers and its production and business operations are monitored by the Supervisory Committee. The Human Resources Department of the Company administers the appraisal policy.
- During the year, the ten directors, supervisors and senior management who were remunerated by the Company had received a total remuneration of approximately RMB1,662,600, of which approximately RMB662,000 was paid to the three highest paid directors. The remuneration to the three highest paid senior management totalled approximately RMB529,200. Two individuals' annual salaries fell within the range from RMB200,000 to RMB250,000, six fell within the range from RMB170,000 to RMB200,000 while two received remuneration below RMB100,000.
- 3. Messrs. Zhang Jie, Fan Xinmin, Liu Hong, Gong Enqing, Pan Shunqun, Yin Shouen, Tu Kelin and Yan Fuquan received remunerations from the controlling shareholder, China National Textile Machinery (Group) Company Limited. Mr. Liu Haitao, Mr. Wang Zengjing, Mr. Kon Hiu King, Ms. Wu Manju and Mr. Zhao Wenjie received remuneration from their respective serving companies.
- 4. Independent non-executive directors did not receive any allowances from the Company.

4. Resignation of directors, supervisors and senior management and the appointment of senior management during the reporting period

At the 2002 Annual General Meeting of the Company held on 28th May 2003, the resignation of Mr. Liu Xianming as a Director of the Company and the appointment of Mr. Liu Xianming as the supervisor representing the shareholders of the Company were approved. On the same date, Mr. Liu Xianming was appointed as Vice chairman of the Supervisory Committee at the Supervisory Committee Meeting.

Section 2 Staff

As at 31st December 2003, the total staff number of the Group was 11,772, among which 358, 922 and 847 were at the senior, middle and junior levels respectively, and 1,930 received tertiary education. Amongst them, 1,105 were deployed to technical, scientific research and development, 476 in sales and marketing, 380 in operations and management, 8,336 in production and 1,475 in others. In addition, the number of retired staff was 3,458 as at 31st December 2003.

Wage level was determined on the basis of individual performance.
