## (I) **BASIC INFORMATION**

1. The Company's current Directors and Supervisors except from Ms. An Xiaofei and Mr. Miao Jian were elected at the 2001 Annual General Meeting held on 14th June 2002, each with a service period of 3 years (from 14th June 2002 to 13th June 2005).

Ms. An Xiaofei and Mr. Miao Jian, the present directors-non-executive of the Company were elected at the 2002 Annual General Meeting held on 20th June 2003, each with a service period from 20th June 2003 to 13th June 2005.

### **Directors-executive**

Mr. Hu Guoliang, male, aged 58, senior engineer (Professional Level), chairman of the board of the directors, graduated from Shanghai Jiaotong University in 1967, and joined Guangzhou Shipyard in 1970. He experienced as chief of Marine Institute, deputy factory manager, No. 1 deputy factory manager of Guangzhou Shipyard, and as vice president, and president of the Company.

Mr. Yu Baoshan, male, aged 44, senior engineer (Professional Level), director and general manager of the Company, joined Guangzhou Shipyard in 1978, and graduated from Guangdong Zhanjiang Aquatic College in 1982. He experienced as director in the Second Design Office of Guangzhou Shipyard, and deputy manager in Shipbuilding Division and the vice president of the Company.

Mr. Ye Peihua, male, aged 59, senior engineer, director of the board, deputy general manager of the Company and rector of the Guangzhou Marine Engineering Corporation, graduated from Shanghai Jiaotong University in 1968, and joined Guangzhou Shipyard in 1970. He experienced as deputy chief of Marine Design Office and deputy factory manager of Guangzhou Shipyard, and vice president of the Company.

### Directors-non-executive

Mr. Xu Guoqing, male, aged 59, senior engineer, chairman of the board in Guangzhou Wenchong Shipyard Company Limited, graduated from Shanghai Shipbuilding School in 1965, and joined Guangzhou Shipyard in the same year. He experienced as chief of Engineering Department of Shipbuilding Branch Factory, manager of Branch Factory of the Guangzhou Shipyard, assistant to the general manager of the Company, and director of Wenchong Shipyard.

Mr. Li Junfeng, male, aged 41, senior engineer, graduated from Shanghai Jiaotong University in 1983, and joined Shiprepairing Bureau of CSSC in 1991. Presently he is the deputy director of the business & marketing department of CSSC.

Ms. An Xiaofei, female, aged 43, senior economist, graduated from Renmin University of China in 1985, and joined General Office of CSSC in 1989. Presently, she is the deputy director of the Assets Management Department of CSSC.

Mr. Miao Jian, male aged 39, senior engineer, graduated from Shanghai Jiaotong University in 1987 and joined in Economy and Trade Office of 601 Institute of CSSC in the same year. Presently, he is the chief of the Second Section in Financial Department of CSSC.

#### Independent non-executive director

Mr. David Hon To, Yu, male, aged 56, is a member of the Hong kong Society of Accountants in England and Wales, and was previously a partner of an international accounting firm. He joined the Company in 1996.

Mr. Philip Pat Yiu, Yuen, male, aged 69, is a practising solicitor in Hong Kong, the chief partner of Yung, Yu, Yuen & Co., and a member of the Chinese People's Political Consultative Conference. He joined the Company in 1996.

Mr. Bo Miaojin, male, aged 59, professor, graduated from China Renmin University in 1970, and started to work in the same year. He experienced as director of Management College, No. 1 deputy president of the Management College in Zhongshan University, the president of the Zhongkai Agrotechnical College.

## (II) EMOLUMENTS OF DIRECTORS, SUPERVISORS AND SENIOR MANAGERS

- 1. The emoluments of Directors of the fourth term of the Board of Directors and the fourth term of the Supervisory committee in the Company are paid on the basis of the annual emolument scheme for the directors and the supervisors, which was approved at the 2002 Annual General Meeting. The emolument of senior managers was decided by the Board of Directors.
- 2. As at the date of 31st December 2003, the aggregate remuneration paid by the Company to its executive Directors was RMB369,600, non-executive Directors and independent non-executive Directors amounted to RMB367,800, including the three highest emoluments paid to Directors amounted to RMB369,600, Supervisors amounted to RMB387,200 and Senior Managers RMB620,400, including the three highest emoluments paid to the senior managers amounted to RMB316,800. Apart from the above-mentioned emoluments, the Company did not offer further allowances or bonuses to the Directors, Supervisors and Senior Managers, nor payments to Directors, Supervisors and Senior Managers as an inducement to join the Company, nor any compensation to Directors, Supervisors and Senior Managers for their loss of office. The Directors, Supervisors and Senior Managers are liable to pay their respective income taxes to the responsible government departments directly. During the year, the pension schemes for executive Directors, Supervisors and Senior Managers were combined with the staff pension scheme of the Company, with total pension contributed by the Company for Directors amounted to RMB55,200, and there was no other special arrangement.
- **3.** During the period under review, the amount bands of emoluments to Directors, Supervisors and Senior Managers are as follows:

### (V) STAFF OF THE COMPANY

As at 31st December 2003, the number of employees on the payroll register of the Company was 4,525, of which 2,276 were production related, 39 were sales related, 66 were finance related and 335 are administration related.

Among the employees in the Company, there are 1,225 technicians with different skills, including 141 senior technicians, among which 17 were professor lever senior engineers, and 263 intermediate technicians.

Among the employees in the Company, there are 1,531 high school graduates, 448 college graduates and 513 university graduates, 25 postgraduates and 1 doctor.

As at 31st December 2003, the number of retired employees of the Company was 2,321, including 225 retired in 2003.

The remuneration of the employees of the Group includes their salaries, bonuses and other fringe benefits. The Group has different rates of remuneration for different employees, which are determined based on their performance, experience, position and other factors in compliance with the relevant PRC laws and regulations.
