3. Remuneration during the year

Decision-making procedures on remunerations of Directors, Supervisors and senior management and basis of determination

- 3.1 At 16th June 2004, the general meeting of the Company approved the establishment of the Personnel Nomination and Remuneration Committee of the Board of Directors of the Company as well as the adoption of the "Implementation Rules and Regulations of the Personnel Nomination and Remuneration Committee of the Board of Directors". Accordingly, the Personnel Nomination and Remuneration Committee of the Board of Directors of the Company formulated salary plan based on the major scope of work, job duty, importance of the positions of the Directors, Supervisors and senior management staff and salary level of relevant positions compared with similar positions in other relevant enterprises.
- 3.2 During the year, the twelve Directors, Supervisors and senior management who receive remuneration from the Company had received a total remuneration of approximately RMB1,830,000, of which approximately RMB662,000 was paid to the three highest paid directors. The remuneration to the three highest paid senior management totalled approximately RMB531,000. Two individuals' annual salaries fell within the range from RMB200,000 to RMB230,000, six fell within the range from RMB170,000 to RMB200,000 while three received remuneration which fell within the range of RMB80,000 to RMB120,000, and one received remuneration of less than RMB80,000.
- 3.3 Mr. Zhang Jie, Mr. Fan Xinmin, Mr. Liu Hong, Mr. Gong Enqing, and Mr. Tu Kelin received remunerations from the controlling shareholder, China Textile Machinery (Group) Company Limited. Mr. Wang Tiankai, Mr. Liu Haitao and Mr. Yan Fuquan, received remunerations from their respective serving companies.
- 3.4 Since the commencement of the tenure of the Fourth Board from 15th August 2004, annual remunerations of each of the Independent Non-Executive Directors of the Company during the tenure would be RMB30,000. The Independent Non-Executive Directors have not received remunerations from the Company before 15th August 2004.

4. Resignation and election of Directors, Supervisors and senior management during the reporting period

On 16th June 2004, upon elections at the Company's general meeting, Mr. Yu Shiquan was newly appointed as an Independent Non-Executive Director of the Company. Upon expiry of terms on 15th August 2004, Mr. Pan Shunqun and Mr. Wang Weizhi ceased to be the Directors of the Company. Mr. Yin Shouen, Madam Wu Manju and Mr. Zhao Wenjie ceased to be Supervisors of the Company. Mr. Gao Yong and Mr. Chen Zhong were newly appointed as Independent Non-executive Directors of the Company. Mr. Wang Tiankai was newly appointed as representative Supervisor for shareholders. On the same day, Mr. Wang Tiankai was elected as chairman of the Supervisory Committee upon elections at a meeting of the Supervisory Committee. At a staff representatives' meeting, Mr. Shi Jianping and Mr. Lian Jinhua were newly elected as Supervisors for staff representatives. On 29th March 2005, Mr. Zhang Qingxi retired after attaining his retirement age and no longer served as the Company's deputy general manager upon approval of the Board.

Section 2 Staff

As at 31st December 2004, the total staff number of the Group was 11,935, among which 382, 881 and 793 were at the senior, middle and junior levels respectively, and 1,984 received tertiary education. Amongst them, 1,629 were deployed to technical, scientific research and development, 346 in sales and marketing, 397 in operations and management, 7,155 in production and 2,408 in others. The salary and benefit of the staff maintained at a competitive level. In addition, the number of retired staff was 3,545 as at 31st December 2004.
