### **EXECUTIVE DIRECTORS**

**Mr. Lau Jin Wei, Jim**, aged 35, is the Chairman of the Company and a cofounder of the Group. He holds a bachelors of arts and science degree in economic studies from the University of York in Canada. Throughout the years, Mr. Lau is responsible for the overall strategic planning and business development of the Group as well as the overall management of the Group's operations. He successfully led the Group to expand the business from industrial surfactants to home and personal care products.
