COMPANY STAFF

As at 31st December, 2003, the Company had a total of 3,093 employees. During the reporting period, there were 208 staff with pension scheme retired. Up to 31st December, 2004, the total number of staff is 3,093, comprising 1,953 staff work on the production line, 134 salesmen, 433 technical staff (included of 173 technical staff working in the management level), 62 staff working in the financial department and 265 management staff.

The Company has 440 staff graduated from different universities and colleges, 416 staff completed their diploma education and 371 staff completed their post-secondary education. The Company also has 110 high level of professional technical staff and 232 intermediate level of professional technical staff.
