Mr. Pyvis (56) was appointed a Non-Executive Director of the Company on 6 June 2003 and became the Deputy Chairman of the Company on 21 May 2004. He has studied and worked in the Asia Pacific region since the early 1970's. Being the former CEO of CLSA Group (CLSA Capital Limited, a member of CLSA Group, is a substantial shareholder of the Company), he has a background in commercial banking, venture capital and debt restructuring in senior managerial roles. He sits on a number of public and private boards, is an Executive Committee member of Hong Kong Coalition of Services Industries – The Hong Kong General Chamber of Commerce and a member of the Hong Kong Securities Institute. He read Economics (Japanese Studies) at the University of Western Australia. Mr. Pyvis is a non-executive director of Apar Industries Limited and Havell's India Limited, both companies listed on the National Stock Exchange of India and the Bombay Stock Exchange, and also an independent non-executive director of Petra Foods Limited, a company listed on the Stock Exchange of Singapore.
