
# 4. Brief introduction of the controlling shareholder and actual controller

China State Shipbuilding Corporation ("CSSC") is the controlling shareholder of the State-owned shares, which accounted for 42.613% of the shares of the Company. CSSC, the registered capital of which is RMB6,374,300,000, was founded on July 1, 1999 through reorganizing China State Shipbuilding Company. Mr. Chen Xiaojin is legal representative of CSSC. The business of CSSC includes: shipbuilding, ship-repairing, manufacturing and export/import of marine equipment, diversified business such as other steel structure manufacturing and international cooperation, joint venture, financing, technology trading and exchange workforce exportation etc. None of the Company's shares held by CSSC was pledged during the period under review.

The actual controller of the Company is the State-owned Assets Supervision and Administration Commission of the State Council ("SASAC"). CSSC manages the state-owned shares of the Company under SASAC's authorization.

During the period under review, the controlling shareholder and actual controller e of the Company has not changed.
