

## Biographical Details of Directors

**Mr. LAO Yuan Yi**, aged 60, was a director from 1991 to 1993 and was re-elected in 1995. He is the chairman of the Company and China Assets Investment Management Limited (“CAIML”) and a director of various subsidiaries of the Company. He is also the chairman and managing director of First Shanghai Investments Limited which is a substantial shareholder and an associated company of the Company and a director of Golad Resources Limited. Previously, Mr. Lao was a senior policy researcher at China’s National Research Centre for Science and Technology and Social Development and worked at the PRC State Science and Technology Commission, Ministry of Communications of the People’s Republic of China and the PRC Railway Ministry. Mr. Lao graduated from Fudan University in Shanghai and obtained his master’s degree from Harvard University.

**Mr. WANG Jun Yan**, aged 35, has been a director since 1998. He is a director of various subsidiaries of the Company and also a shareholder and a director of CAIML. Mr. Wang is the managing director of First Shanghai Financial Holding Limited, an immediate holding company of the financial service division of First Shanghai Investments Limited. Mr. Wang has more than 10 years of experience in investment banking and securities industry. Mr. Wang holds a master’s degree in Finance from the University of Hong Kong and a bachelor’s degree with a major in International Trade from the Zhongshan University. He has also studied in a Ph.D. program of Finance in the City University of New York.

**Ms. LAO Yuan Yuan**, aged 27, was appointed as a director on 20th September 2005. Ms. Lao is presently a vice president of business development of Crimson Pharmaceutical (Hong Kong) Limited (“Crimson”), a subsidiary of First Shanghai Investments Limited. Prior to joining Crimson, Ms. Lao worked in investment banking at Merrill Lynch & Co. in New York City, where she was part of the Financial Sponsors Group. Ms. Lao graduated magna cum laude from Columbia University where she studied Engineering Management Systems. Ms. Lao is the daughter of Mr. Lao Yuan Yi, the Chairman and an executive director of the Company.

**Mr. JIANG Wei**, aged 43, has been a director since 1996. Mr. Jiang is currently a director and chief financial officer of China Resources (Holdings) Company Limited as well as the general manager of its finance department. He is the chairman of China Resources Peoples Telephone Company Limited and a non-executive director of China Resources Enterprise Limited, China Resources Cement Holdings Limited, China Resources Power Holdings Company Limited and China Resources Land Limited. He obtained both his bachelor’s degree in International Trade and master’s degree in International Business and Finance from the University of International Business and Economics in Beijing, China.

**Mr. YEUNG Wai Kin**, aged 44, has been a director since 1997. He is a director of various subsidiaries of the Company and also a shareholder and a director of CAIML. Mr. Yeung is the chief financial officer and a director of First Shanghai Investments Limited. He is also a director of First Shanghai Direct Investments Limited and Golad Resources Limited. He has over 20 years of experience in auditing, finance and management positions. Mr. Yeung possesses professional memberships of the Association of Chartered Certified Accountants, the Hong Kong Institute of Certified Public Accountants and the Taxation Institute of Hong Kong. He has a bachelor’s degree in law from Peking University.
