- 2005.12.31 Guangdong Top-E Expressway Service Zone Company Limited ("Guangdong Top-E") entered into three contracts with the Guangdong branch of China Petroleum & Chemical Corporation ("Sinopec") with respect to undertaking the operations of the three gas stations in the Guangdong Province Yue-Gan Expressway Reshui Service Zone, Guangdong Province Yue-Gan Expressway Heping Service Zone and Guangdong Province Yue-Gan Expressway Zhongxin Service Zone by Guangdong Top-E with a total contract sum of RMB234,000,000.
