(二)公司簡介

南京熊貓電子股份有限公司(「本公司」)是一家集科研、開發、生產、銷售及技術服務於一體的大型綜合性通信公司,於1992年4月由原熊貓電子集團公司改組重組後成立,其歷史可追溯到1936年,是中國最早的電子企業。1996年5月2日及11月18日公司股票分別在香港聯合交易所和上海證券交易所掛牌上市。

本公司主要業務是開發、生產及銷售衛星通信產品、移動通信產品、機電儀產品和信息技術產品以及電子製造業務等,註冊商標為「熊貓PANDA」,是全國電子行業第一個「中國馳名商標」。

(2) Corporate Profile

Nanjing Panda Electronics Company Limited (the "Company") is a large integrated telecommunications company which is engaged in scientific research and development, production, sale and technological services. In April 1992, the Company was established after the reorganization of the original Panda Electronics Group Company. The history of the Company can be traced back to 1936 and is the earliest electronics enterprise in the PRC. Shares of the Company were listed on The Stock Exchange of Hong Kong Limited and Shanghai Stock Exchange on 2 May 1996 and 18 November 1996 respectively.

The Company is mainly engaged in the development, production and sale of satellite communication mobile communication, electromechnical, IT and electronics manufacturing. Its registered trademark is "熊貓PANDA" which is the first "well known trademark in the PRC" in the electronics information industry in the country.

The Company owns a solid research and development capabilities and establishes 3 State-level engineering technology development centres. The level of its research and development gains a leading position in the same industry in China. The Company obtains a ISO-9001 certification and has established a scientific quality management system and an advanced corporate management information system.

Leveraging the opportunities from economic globalization, the Company is proactively promoting international cooperation. Joint ventures have been established with multinational companies such as Ericsson (Sweden), which will become a new base for the Company's growth and a major source of profit, demonstrating an optimistic prospect of the Company.

The Company's next development target is to establish the largest base for the development and production of satellite communication in the PRC. Besides, it aims at becoming a major company in electromechanical, IT and electronics manufacturing industries and an integrated international hitech giant.
