- Included total write back of impairment loss of HK\$127 million for a property under development for sale in Wen Chang Pavilion, Guangzhou, PRC and attributable interest in a hotel property in Hong Kong.
- II Included total write back of impairment loss of HK\$55 million for a leasehold land and building and attributable interest in a hotel property in Hong Kong.
- III Included a provision of HK\$109 million for impairment in value of a property under development in Guangzhou, as offset by the write back of provision of HK\$60 million for a leasehold land and building in Hong Kong, HK\$32 million for gain on deconsolidation of liquidated subsidiaries and HK\$18 million for write back of special retirement benefit costs.
