## **EXECUTIVE DIRECTOR**

**Mr. Budiman RAHARDJA**, aged 27, was appointed as a director of the Company in September 2001 and was subsequently elected as the chairman of the Company in September 2002. Mr. Rahardja is a relative of Mr. Chen Zhi Yung.

## NON-EXECUTIVE DIRECTORS

**Mr. CHEN Zhi Yung**, aged 39, was appointed as a non-executive director of the Company in September 2002. He is also a member of each of the Audit Committee and the Remuneration Committee of the Company. Mr. Chen has extensive experience in both local and overseas trading. He is currently running his own trading business. He is a relative of Mr. Budiman Rahardja.

**Mr. LO Yuk Lam**, aged 58, was appointed as an independent non-executive director of the Company in January 2002. He is also a member of each of the Audit Committee and the Remuneration Committee of the Company.
