## 3. Employees' remuneration and training

The Company adopted a performances - linked remuneration system. The system consists of 4 units including basic salary, seniority salary, position salary and performance salary, plus allowances. Basic salary and seniority salary are guaranteed incomes paid according to attendance, whereas position salary and performance salary are incentive based which are payable according to employers' position and performance.
