China Communications Construction Company Limited ("CCCC" or the "Company" including all of its subsidiaries except where the content otherwise requires) was incorporated on 8 October 2006 and its H Shares were listed on The Stock Exchange of Hong Kong Limited (the "Hong Kong Stock Exchange") with stock code of 1800 on 15 December 2006.

The Company and its subsidiaries (collectively, the "Group") are principally engaged in the construction and design of transportation infrastructure, dredging and port machinery manufacturing business. It is the largest port construction and design company in China, a leading company in road, bridge construction and design, the largest dredging company in China and the third largest in the world. The Company is also the world's largest container crane manufacturer. The Company currently has 37 subsidiaries.

Through participation in various key construction projects, the Company has made significant contribution to the transportation infrastructure in the PRC and has hit several "number one" records and gained the "top player" recognition in history of port and bridge construction in the PRC, Asia and around the world. The Company was involved in the design and construction of a significant number of large and medium-sized ports along the coast and waterways of inland rivers, major first-class expressway as well as large and extra large bridges and tunnels. The Company accounted for almost half of China's dredging market share in terms of dredging capacity. As at December 2006, the Company's container crane business accounted for more than 70% of the global market share in terms of units ordered in 2006.

The Company retains three members of the Chinese Academy of Engineering, one National Reconnaissance Master, twelve National Design Masters and many leading senior engineers, scientists and experts. It also has ten national design institutes, two national science and research centres and five key laboratories, holding various scientific achievements with its self-developed intellectual property rights which keeps the Company abreast of the international standards. In the past 10 years, the Company has won more than 120 awards including "National Prize for Scientific and Technical Progress", "China Construction Project Luban Award", "China Civil Engineering Zhantianyou Award", and "National High Quality Prize". The Company owns a diverse range of specialised equipment, including modern dredging fleet, dedicated transportation fleet for port machinery, various equipment for marine and onshore engineering as well as various state-of-the-art machinery and equipment for investigation, design and research. The Company's talent pool, advanced technologies, research and development capabilities and equipment will continue to serve as a competitive strength for the Company to win and perform contracts for the large-scale and complicated projects.

The Company has actively participated in the international contracting market for construction projects. It has eminent reputation in Asia, Africa and America for the past 20 years. It has been included in the Engineering News Records' list of top 225 international contractors since 1992 consecutively.

The Company is committed to developing the transportation infrastructure business in the PRC and abroad by consistently pursuing its corporate mission of "Trustworthy service to clients, High quality returns to shareholders and Consistent outperformance".
