Mr. Zhou Chu Jian He, aged 43, has been the Chairman of the Company since he joined the Group on 2 October 2003. Mr. Zhou acted as a Managing Director of the Company from the years of 2003 to 2005. He is also currently the President of Junefield (Holdings) Limited ("JHL"), the ultimate holding company of the Group, who is responsible for the overall business of JHL. Mr. Zhou serves as a member of the Beijing Committee of the People's Political Consultative Conference (中國人民政治協商會議北京委員會) in the PRC. Mr. Zhou has over 11 years of experience in managing property development companies and in operating department stores in the PRC.

Mr. Yiu Yu Keung, George, aged 63, has been the Deputy Chairman of the Company since he joined the Group on 2 October 2003. Mr. Yiu, joined JHL in 1994, has been the Vice-President of JHL since 2000. Mr. Yiu serves as a member of the Hong Kong Management Association. Mr. Yiu has over 18 years of experience in building construction and project management in Hong Kong, and has over 20 years of experience in China trade, including formation and managing joint ventures, hotels and property development, project management and turn-key construction projects. He holds a Diploma in Civil Engineering from the Hong Kong Baptist College and a Master's Degree in Business Administration from the University of Macau.

Mr. Li Jong Tong, Timothy, aged 65, has been an Executive Director of the Company since he joined the Group on 2 October 2003. Mr. Li has been the President's Strategic Advisor of JHL since 2003.
