## **Clarification Announcement**

As disclosed in the Announcement, the Board is in the process of considering the establishing of a Special Investigation Committee and the Special Investigation Committee will investigate the matters raised in the above paragraph. Further announcement will be made by the Company in due course.

This announcement is made pursuant to Rule 13.09 of the Listing Rules. Save as those disclosed in this announcement, the Directors confirm that there are no other price sensitive information to be disclosed.
