Reference is made to the joint announcements of the Company and the Investor dated 16 September 2010 and 30 September 2010, and the announcements of the Company dated 5 October 2010, 30 December 2010, 29 April 2011, 30 May 2011, 31 August 2011, 9 November 2011 and 30 December 2011 (the "Announcements"). Capitalised terms used herein shall have the same meanings as defined in the Announcements unless the context requires otherwise.

Under Rule 8.2 of the Takeovers Code, the Circular is required to be posted to the Shareholders within 21 days of the date of the announcement on 16 September 2010, which is on or before 7 October 2010. Pursuant to the letters from the SFC dated 8 October 2010, 10 January 2011, 9 May 2011, 7 September 2011 and 10 January 2012, the Executive has granted consent to extend the date of despatch of the Circular to 31 March 2012.

The Company submitted a revised resumption proposal (the “Revised Proposal”) to the Stock Exchange on 8 November 2011 to seek their approval for the resumption of trading in the Shares. On 16 March 2012, the Company provided further information to the Stock Exchange in response to the Stock Exchange’s queries and in support of the Revised Proposal.

The Company anticipates that additional time will be required to liaise with the Stock Exchange (including but not limited to providing further information to the satisfaction of the Stock Exchange) in relation to the Revised Proposal.

As a result, the Circular will not be despatched to the Shareholders by 31 March 2012. In this regard, the Company has applied to the Executive for a further extension of the latest time for despatching the Circular to 30 September 2012 and the Executive has indicated that it is minded to grant consent. The Company will make further announcement(s) as and when appropriate.

At the request of the Company, trading in the Shares has been suspended since 9:30 a.m. on 27 November 2009 and will remain suspended until further notice.
