As provided in the AGM Voting Results Announcement and the Circular, Mr. French served as president and the chief executive officer of Cirrus Logic Inc. ("CL") from 1999 to March 2007. Mr. French resigned from his office as the president and the chief executive officer of CL in light of the findings by the Special Committee of CL set up to investigate potential irregularities relating to the grant dates of CL stock-options (the "Investigated Matter"). The Special Committee considered that Mr. French was significantly involved in the approval process for certain grants and that he influenced the approval process with a view toward the stock price, and therefore the selection of granting dates. Furthermore, a formal investigation of CL regarding historical stock option practices was conducted by the United States Securities and Exchange Commission (the "SEC") in November 2007 and concluded in March 2008 with the SEC not recommending any enforcement action in respect of such matter.

The Board is aware of Mr. French's involvement in the Investigated Matter. Notwithstanding this the Board would like to state that the Appointment is appropriate and has been made after considering Mr. French's ability and his over 30 years experience in the semiconductor industry, which the Board believes to be conducive and beneficial to the business and operation of the Company.
