The Board would like to clarify that the Group has never given instructions to any of its directors and employees to offer any illegal bribes or commissions. The Group will closely monitor the court case mentioned in the Articles. Further announcement(s) will be made as and when appropriate in compliance with the Rules Governing the Listing of Securities (the "Listing Rules") on The Stock Exchange of Hong Kong Limited (the "Stock Exchange").

Save as disclosed above, the Company is not aware of any inside information in relation to the Company that will need to be disclosed pursuant to the requirements under Rule 13.09 of the Listing Rules and the Inside Information Provisions (as defined in the Listing Rules) under the Part XIVA of the Securities and Futures Ordinance (Chapter 571, Laws of Hong Kong).
