Chairman's Statement

主席報告



In 2017, the Group completed acquisition of Grid Dynamics, strengthening the Group's local support and global delivery capabilities to customers.

On behalf of the Board of Directors (the "Board"), I am pleased to present to the shareholders the annual report of Automated Systems Holdings Limited (the "Company") and its subsidiaries (collectively "ASL" or the "Group").

For the year ended 31st December 2017, the Group recorded a revenue of HK\$1,917.5 million, an increase of 26.0% compared to last year. Gross profit, profit before tax and profit after tax were HK\$344.2 million, HK\$69.7 million and HK\$52.6 million, increases of 106.5%, 78.9% and 82.6% compared to last year respectively. The significant increase of the revenue, gross profit and profit of the Group during the year compared to last year was mainly attributable to the revenue, gross profit and net profit of Grid Dynamics International, Inc. ("Grid Dynamics"), its whollyowned subsidiary, for the period from 7th April 2017 to 31st December 2017 were consolidated into the consolidated financial statements of the Group for the year ended 31st December 2017. The Group maintained a healthy financial position and recorded an increase of 20.6% of its cash balance as at 31st December 2017 to approximately HK\$286.8 million when compared to last year.

2017 was the Group's 20th listing anniversary in Hong Kong. Looking back, we are very proud that ASL has been keeping pace with the times in a changing market. Adhering to the principles of striving for constant changes and innovative development, ASL has committed to providing customers from various industries with innovative, high-quality, comprehensive and professional one-stop information technology ("IT") services and solutions to help them improving their overall operating benefits since its establishment in 1973.

IT services industry requires constant innovations, since no progress simply means regression. The Group completed the acquisition of a next-generation scalable e-commerce and digital technology solution provider Grid Dynamics (the "Acquisition") in the United States ("US") in April 2017, so as to capture the business opportunities arisen from cloud platform service and digital transformation of enterprises. Boasting extensive experience and management capability in open source technology, cloud application and real-time big data analytics, Grid Dynamics is headquartered in California, the US, with professional software research and development centers in four Eastern European countries. The Acquisition not only enabled the Group to enhance its capability on local support and realize global delivery, but also improved its comprehensive strength in cloud computing, big data and artificial intelligence, providing a positive effect to the overall revenue and profit of the Group in the future.

本人謹代表董事會(「董事會」)向股東發表自動系統集 團有限公司(「本公司」)及其附屬公司(統稱「自動系統」或「本集團」)年報。

截至二零一七年十二月三十一日止年度,本集團錄得收入1,917.5百萬港元,較去年增加26.0%。毛利、除税前溢利及除税後溢利分別為344.2百萬港元、69.7百萬港元及52.6百萬港元,較去年分別增加106.5%、78.9%及82.6%。年內本集團之收入、毛利及溢利較去年錄得顯著增長主因為由於其全資附屬公司Grid Dynamics International, Inc.(「Grid Dynamics」)於二零一七年四月七日至二零一七年十二月三十一日止期間之收入、毛利及溢利已於本集團截至二零一七年十二月三十一日止年度之綜合財務報表內綜合入賬。本集團的財務狀況維持穩健,於二零一七年十二月三十一日錄得現金結餘約286.8百萬港元,較去年增加20.6%。

二零一七年是慶祝本集團於香港上市二十周年的大日子。回顧過去,面對市場日新月異的變化,自動系統能夠與時俱進,實在非常值得驕傲。自一九七三年成立以來,自動系統一直秉持不斷求變、創新發展的理念,致力為各行業客戶提供一站式創新、優質且全面的專業資訊科技(「資訊科技」)服務及解決方案,以協助客戶提升整體營運效益。

資訊科技服務是一個逆水行舟、不進則退的行業,需要不斷尋求突破。為抓住當前企業走向雲端平台服務、數碼轉型的商機,本集團於二零一七年四月完成收購美國(「美國」)新一代大型電子商貿數碼科技解決方案商 Grid Dynamics (「該收購」)。 Grid Dynamics 在開源技術、雲端應用、大數據實時分析等方面擁有豐富的經驗及管理能力,其總部設於美國加州,在東歐四國擁有專業的軟件研發中心。該收購既加強本集團對客戶的本地支援,實現全球交付的佈局,亦提升了本集團在雲計算、大數據以及人工智能方面的自主綜合實力,為本集團未來整體收入和利潤帶來正面的影響。

In addition to the overall fruitful results of the Group this year contributed by Grid Dynamics, the Group also maintained steady growth in its performance in Hong Kong. The Group continued to obtain and complete various IT-related projects from public and private sectors in Hong Kong by giving play to its strength and performed spectacularly remarkable in businesses with rapidly increasing demands, including big data analytics, security and one-stop IT service management and solutions.

As one of the leading service providers in Hong Kong, the Group obtained numerous important awards such as "The Most Outstanding Partner Award" presented by its partners within the year. It is noteworthy that the Group stood out from the competitors in mainland China, Taiwan and Korea to be honoured the "Partner of the Year in North Asia Award" by McAfee, being the only Hong Kong IT company to receive such acclaim. It also won the first and second prize in Huawei's "2017 Southeast Asia Proof of Concept Competition" among Huawei partners from 14 countries. The above awards shall be attributed to the Group's abundant experienced professionals in various IT fields, as well as its strength to provide quality IT services. The Group not only won the recognition in the industry, but also obtained the "Listed Company Award of Excellence" of the Main Board presented by a well-known Hong Kong financial media *Hong Kong Economic Journal*, which displayed the recognition of the ASL's strength and development prospects from the international capital market and Hong Kong business circle.

The Group has been proactively adjusting strategies in the past several years. In the future, it will further promote the digital transformation of professional services with focus on three major businesses of the Group: next-generation one-stop IT Integrated Managed Services; leading-edge industry Innovative Solutions for its customers; and Intimate Tech Hub. The Group will strengthen its cooperation with leading suppliers having technology advantages, and provide one-stop international and brand-new IT service solutions and services for customers in Hong Kong and even the world.

ASL's outstanding business performance over the years shall be attributed to clear business strategies, enthusiasm and endeavour of all the employees, and continued support from valued customers, business partners and shareholders for years. The Board would like to take this opportunity to express its sincere gratitude to them. I hereby want to extend my gratitude to the all members of the Board for their contribution and support during the year.

MANAGEMENT DISCUSSION AND ANALYSIS

Financial Results

For the year ended 31st December 2017, total revenue of the Group was HK\$1,917.5 million, representing a 26.0% increase from last year, which was contributed by the increase in service revenue. As compared with last year, product sales were decreased by 11.5% to HK\$743.4 million while service revenue was increased by 72.2% to HK\$1,174.1 million. For the year ended 31st December 2017, product sales and service revenue contributed 38.8% and 61.2% to total revenue respectively.

For the year ended 31st December 2017, commercial and public sector sales contributed 59.1% and 40.9% to total revenue respectively, compared to 48.4% and 51.6% last year.

Gross profit for the year ended 31st December 2017 was HK\$344.2 million, an increase of HK\$177.5 million or 106.5% compared with last year. Gross profit margin for the year also increased from 11.0% to 17.9%. The increase in gross profit and gross profit margin was mainly attributable to the gross profit contribution from Grid Dynamics International, Inc. ("Grid Dynamics"), which was acquired on 7th April 2017.

Even though there were one-off professional fees for the amount of approximately \$9.0 million and finance costs for the amount of approximately \$16.9 million incurred for the acquisition of Grid Dynamics during the year ended 31st December 2017, the Group recorded a profit attributable to the Company's equity holders of HK\$52.6 million, a rise of 82.6% compared to last year of HK\$28.8 million.

For the year ended 31st December 2017, orders newly secured by the Group amounted to approximately HK\$1,976.5 million. As at 31st December 2017, the order book balance was approximately HK\$1,120.4 million, an increase of 16.2% from HK\$963.4 million of last year. The Group's cash stood at approximately HK\$286.8 million with a working capital ratio of 1.25:1. The Group maintained a healthy financial position during the year. As at 31st December 2017, the outstanding borrowings amounted to HK\$493.0 million.

管理層討論及分析

財務業績

截至二零一七年十二月三十一日止年度,本集團之總收入為1,917.5百萬港元,較去年同期增加26.0%,主要由於服務收入增長。與去年相比,其中產品銷售減少11.5%至743.4百萬港元而服務收入則上升72.2%至1,174.1百萬港元。截至二零一七年十二月三十一日止年度,產品銷售及服務收入分別佔總收入的38.8%及61.2%。

截至二零一七年十二月三十一日止年度,私營及公營機構銷售分別佔總收入的59.1%及40.9%,而去年同期則分別為48.4%及51.6%。

截至二零一七年十二月三十一日止年度的毛利為344.2 百萬港元,較去年同期增加177.5 百萬港元或106.5%。年內的毛利率由11.0%上升至17.9%。毛利及毛利率的上升主要是由於於二零一七年四月七日 收購的 Grid Dynamics International, Inc.(「Grid Dynamics」)對毛利的貢獻。

儘管於二零一七年十二月三十一日止年度內因收購 Grid Dynamics產生約9.0百萬港元一次性專業費用及 衍生約16.9百萬港元財務成本,本集團仍錄得公司股 本持有人應佔年內溢利52.6百萬港元,較去年28.8百 萬港元上升82.6%。

截至二零一七年十二月三十一日止年度,本集團新簽訂單約為1,976.5百萬港元。於二零一七年十二月三十一日,本集團手頭訂單餘額約為1,120.4百萬港元,較去年同期的963.4百萬港元上升16.2%。本集團的現金淨額約為286.8百萬港元,而營運資本比率為1.25:1。本集團於年內的財務狀況維持穩健。於二零一七年十二月三十一日,借貸餘額為493.0百萬港元。

Following the Company's announcements dated 19th March 2014 and 21st May 2014 with regard to the termination of a business contract entered into between Automated Systems (H.K.) Limited ("AHK"), a wholly-owned subsidiary of the Company and a customer, AHK has reached a settlement with the customer during the year under review. Such settlement brings no significant adverse impact on the Group's results as provision and settlement have been made properly during the year ended 31st December 2017.

Business Review

In 2017, the Group's local core business grew stably and its business expanded to Europe and the United States. The Group completed the acquisition of Grid Dynamics, a company located at Silicon Valley, California, the United States, on 7th April 2017 at a total consideration of US\$118.0 million (equivalent to approximately HK\$916.8 million) plus certain adjustments. Grid Dynamics is now a wholly-owned subsidiary of the Group, and its revenue, gross profit and profit for the period from 7th April 2017 to 31st December 2017 were consolidated into the consolidated financial statements of the Group for the year ended 31st December 2017, immediately leading to a significant increase in revenue, gross profit and profit of the Group, representing an increase of 26.0%, 106.5% and 82.6% respectively as compared with those for last year.

The Board recommended the payment of a final dividend of 1.0 HK cent per share and bonus issue ("Bonus Issue") of shares of par value HK\$0.1 each in the capital of the Company on the basis of two (2) bonus shares ("Bonus Shares"), credited as fully paid, for every ten (10) existing shares held by the shareholders of the Company whose names appear on the register of members on Tuesday, 29th May 2018 for the year ended 31st December 2017.

In respect of the public sector sales, the Group has always won the trust and support of government bureaux and departments. It was contracted a number of Information Technology ("IT") professional services projects included in the Standing Offer Agreement for Quality Professional Services 3 during the year under review, ranking among the top in the industry in terms of total contract amount which was a strong track record. In the second half of the year, building on its success, the Group was entrusted as one of the contractors for "Standing Offer Agreement for Quality Professional Services 4" (SOA-QPS4) by the Office of the Government Chief Information Officer, and was eligible for bidding four categories of IT Services for various government bureaux and departments. In addition, the Group continued to benefit from the government's policy of actively promoting innovation and utilizing IT to improve public services, and adopted a new delivery model DevOps in various government projects in the second half of this year to enhance the flexibility and effectiveness of delivery services.

In respect of the commercial sector sales, the sales of professional services during the year increased significantly by virtue of the Group's quality, innovative and one-stop IT services as well as market reputation established, which achieved an encouraging result. With more than 40-year experience in its focused-industries in the area of systems integration and bringing in new capability, the Group not only provided industry-specific professional infrastructure support services to a telecom operator, but also won a number of projects from different industries through the understanding of various industries and continuing to successfully keep up with the trend of big data and analytics, thus further consolidated the Group's positioning of one-stop IT services provider.

繼本公司日期為二零一四年三月十九日及二零一四年五月二十一日有關終止本公司之全資附屬公司自動系統(香港)有限公司(「自動系統香港」)與一名客戶訂立之商業合同之公告後,於本年度,自動系統香港與該名客戶達成和解。由於本集團於二零一七年十二月三十一日止年度內已作出撥備並完成支付,有關和解概無對本集團之業績帶來重大不利影響。

業務回顧

本集團於二零一七年的本地核心業務發展穩中有進,並將業務拓展至歐美。本集團於二零一七年四月七日以總代價118.0百萬美元(相當於約916.8百萬港元)連同若干調整完成收購一家位於美國加州矽谷之公司 Grid Dynamics之收購事項。Grid Dynamics現為本集團之全資附屬公司,其二零一七年四月七日至二零一七年十二月三十一日止期間之收入、毛利及溢利已於本集團截至二零一七年十二月三十一日止年度之綜合財務報表內綜合入賬,隨即為本集團之收入、毛利及溢利帶來顯著增長,較去年錄得分別26.0%、106.5%及82.6%之增長。

董事會建議向於二零一八年五月二十九日(星期二)名列股東名冊之本公司股東·派發截至二零一七年十二月三十一日止年度末期股息每股1.0港仙及按持有每十(10)股現有股份可獲發兩(2)股本公司每股面值0.1港元以入賬列作繳足股本之紅股(「紅股」)的基準發行紅股(「發行紅股」)。

公營機構銷售方面,本集團一直深得各政府決策局及部門的信任及支持。於回顧年內,本集團承辦多項優質資訊科技(「資訊科技」)專業服務常備承辦協議3範疇中的資訊科技專業服務項目,按合約總金額計算位列前矛,成績斐然。於本年度下半年再下一城,獲政府資訊科技總監辦公室選為「優質資訊科技專業服務常備承辦協議4」(SOA-QPS4)承辦商之一,取得投標資格向不同政府決策局及部門提供四類資訊科技服務。此外,本集團繼續受惠於政府積極推動創新及利用資訊科技改善公共服務的政策,並於本年度下半年在多項的政府項目中採用DevOps新型交付模式,以提高交付服務的彈性及成效。

私營機構銷售方面,憑藉優質、創新及一站式資訊科技服務,市場口碑,年內銷售的專業服務顯著增多,成績令人鼓舞。本集團亦利用擁有逾四十年所專注行業的系統集成經驗及引入新的技能,不但為一家電訊商提供電訊業專業基礎設施支援服務,亦通過對各行業的了解,繼續成功把握大數據及分析的趨勢,贏得多個來自不同行業的項目,進一步鞏固本集團一站式資訊科技服務供應商的定位。

With regard to expanding its managed service business, the Group, as a one-stop Information Technology Service Management ("ITSM") company, continued to leverage its advantages during the year, received a new long-term managed service order from a renowned bank client. The Group enhances the level and expands the coverage of support services for this bank client, as well as provides consultancy services to meet customers' buoyant demand on ITSM and fully meets the needs of customers for IT in a flexible way so that they can focus on their own business development.

資訊科技服務管理(「Information Technology Service Management」或「ITSM」)的公司,於年內繼續發揮優勢,從一知名銀行客戶接獲新長期管理服務訂單,為其提升支援服務水平及擴大支援服務涵蓋範圍,並就客戶對ITSM的殷切需求提供顧問服務,全面靈活支援客戶資訊科技的需要,讓其專注自身業務發展。

在拓展管理服務業務方面,本集團作為擁有一站式

In addition, the Group strived to improve its service level and technology in the information network security business and achieved good results during the year. Along with the cyberattacks attracted wide public concern in 2017 and the new "Cyber Resilience Assessment Framework" for banks issued by the Hong Kong Monetary Authority, the Group has successfully seized business opportunities to obtain relevant IT security projects in different industries, among which include the landmark project, the signing of a three-year security managed service project contract with a large Hong Kong transport operator, which successfully launched the Security Operation Center Plus ("SOC+") of its own managed security services together with managed services and service desk services to the market. It has also successfully entered the IT security market in the financial industry. Through the Group's SOC+ Security Information and Event Management (SIEM) platform, an advanced platform that helps integrating and detecting associated security information/events, we provide two-year one-stop security managed service to a well-known bank to assist the bank in meeting statutory cyber security level and effectively detect abnormal network activities for clients at any time.

此外,本集團在資訊網絡安全業務領域著力加強服務水平及技術,於本年度取得佳績。隨著二零一七年網絡攻擊引起社會廣泛關注及香港金融管理局對銀行作出全新的「網絡防衛評估框架」規定,本集團成功把握商機,於不同行業取得相關資訊科技安全項目,當中具標誌性的項目包括與香港一家大型運輸營運商簽訂一份為期三年的安全管理服務項目合約,成功將當一份為期三年的安全管理服務項目合約,成功將發安全運作中心+(「SOC+」)所提供的安全管理方案服務結合管理服務以及服務台服務一併推出市場。另外,本集團亦成功打進金融業資訊科技安全領域的市場,其中透過本集團先進的SOC+的安全資訊和事件管理(簡稱SIEM-有助整合和偵測關聯安全資訊/活動)平台,為一家知名銀行提供為期兩年的一站式安全管理服務,協助該銀行符合法定的網絡安全水平,並能有效地為客戶隨時偵測異常的網絡活動。

Outlook and Prospects

2017 is the Group's 20th listing anniversary in Hong Kong, the Group successfully acquired Grid Dynamics, a provider of scalable, next-generation e-commerce digital technology solutions in the United States. As a result, the Group becomes Hong Kong's first local IT company which grows beyond Asia and expands its business to global markets, laying a solid foundation for the future development of the Group and marking the Group's innovation journey of development.

Benefiting from customers' demand for third platform technologies such as cloud computing and big data analytics, Grid Dynamics expanded its business rapidly, and its number of employees grew from about 600 in early 2017 to over 800 currently to support its business growth. In 2018, Grid Dynamics is also planning to open its sixth research and development center in Serbia, Europe, which provides a highly skilled talent pool and high-quality communications network, to further strengthen the Group's local support and global delivery capabilities to meet different customer needs in various regions.

前景與展望

藉二零一七年為本集團於香港上市二十周年之際,本集團成功收購美國新一代大型電子商貿數碼科技解決方案供應商 Grid Dynamics,成為香港首家衝出亞洲,將業務擴展至全球的香港本土資訊科技公司,為本集團未來發展奠下穩健根基,亦標誌著本集團的發展跨進嶄新里程。

受惠於客戶在雲計算、大數據分析等第三平台技術的需求,Grid Dynamics 的業務迅速擴展,其規模由二零一七年初約600名僱員增加至現時逾800名僱員以支持其業務增長。Grid Dynamics更計劃於二零一八年在歐洲擁有高技術的人才庫及高質素通訊網絡的塞爾維亞開設其第六個的研發中心,以進一步加強本集團本地支持和全球交付的能力,滿足位於不同地區的客戶需要。

In order to cope with the challenge of anticipated gradual reduction in demand for IT infrastructure due to cloud computing and to consolidate our market position as a reliable and professional IT partner, the Group was committed to improving its strategy and further promoting the digital transformation of professional services in the second half of 2017. The major businesses of the Group will be divided into the next generation one-stop Integrated Managed Services; providing customers with leading-edge Innovative Solutions; and Intimate Tech Hub.

In respect of the next-generation one-stop Integrated Managed Services, the Group will continue to ensure the quality of IT services through service level agreement (SLA) and upgrade service platform (i.e. to connect customers with our SOC+ through our well-equipped and advanced service centre, a service hub, by utilising omni-channels including phones, emails, websites, instant messages, on-site services, applications on smart phones, etc. and to launch one-stop IT services which better meet customers' needs with innovative Online to Offline (O2O) model and integrated conceptual model) while achieving efficient synergy of management processes to enhance customer's IT operation and management level and capability and thus drives business growth and, through provision of high quality customer experience, strengthens the Group's position as a next-generation one-stop ITSM provider.

In respect of Innovative Solutions, the world is entering a new era of cloud, big data analytics and mobile internet. Technological changes will bring about major changes in the industry model and competition pattern. Industry vertical integration and convergence of IT products and services are increasingly noticeable. Therefore, it is particularly important for professional service providers to capitalize on their exceptional skills and accumulated experience in their specialized areas. Focusing on industries with competitive edges (namely government, banking and finance, public healthcare, transportation, real estate and education), the Group further strengthens its innovative ability with regard to Innovative Solutions. With considerable insight into the changes in customers' needs in various industries, the Group provides leading and high value-added solutions based on the integration and reconstruction of their business procedures and by using technologies that meet the core business needs of customers.

In respect of Intimate Tech Hub, the Group will focus on strengthening the integration of industry-specific knowledge, comprehensive skills and cross-platform technologies in the industry, and deepen cooperation with strategic partners on the new technologies such as artificial intelligence, robotics, machine learning, smart city and grasp business opportunities brought by related application trends. The Group will also provide one-stop innovative IT solutions and services to customers in Hong Kong and around the world through active cooperation with tier-one providers with technology advantages or industry-leading suppliers.

Looking forward, the Group will continue to seek opportunities in Hong Kong and the Mainland China arising from Belt and Road to provide leading IT services with higher value for our global customers, so as to speed up the globalization of the Group and consolidate the Group's position as a professional and reliable IT service partner in the Asia-Pacific region and around the globe.

Financial Resources and Liquidity

As at 31st December 2017, the Group's total assets of HK\$2,264.9 million were financed by current liabilities of HK\$779.9 million, non-current liabilities of HK\$387.2 million and shareholders' equity of HK\$1,097.8 million. The Group had a working capital ratio of approximately 1.25:1.

As at 31st December 2017, the Group had an aggregate composite banking facility from banks of approximately HK\$371.0 million (2016: HK\$170.0 million). The Group had pledged land and buildings of HK\$272.0 million (2016: HK\$107.3 million), investment properties of HK\$52.3 million (2016: Nil) and restricted bank deposits HK\$0.8 million (2016: HK\$0.5 million) for banking facility and performance bonds granted to the Group respectively. The performance bonds issued by the Group to customers as security of contracts were approximately HK\$63.3 million as at 31st December 2017 (2016: HK\$62.6 million). The Group's gearing ratio (total borrowings over total equity) was 44.9% as at 31st December 2017 (2016: 1.4%).

Material Acquisition

Reference is made to the announcements of the Company dated 19th December 2016 and 7th April 2017 and the circular of the Company dated 6th March 2017, respectively, in relation to, among other matters, the acquisition of Grid Dynamics. On 19th December 2016, the Board announced that the Company and Grid Dynamics entered into an agreement and plan of merger (the "Merger Agreement"). The Company agreed to acquire Grid Dynamics with a total cash consideration of up to approximately US\$118.0 million (equivalent to approximately HK\$916.8 million) plus certain adjustments, by the way of merger, which is subject to the terms and conditions set out in the Merger Agreement. On 7th April 2017, all the conditions to the closing of the Acquisition (the "Closing") as set out in the Merger Agreement had been fulfilled and the Closing took place on the same date. Upon the Closing, Grid Dynamics has become an indirect wholly-owned subsidiary of the Company and the financial results, assets and liabilities of Grid Dynamics and its subsidiaries are consolidated into the consolidated financial statements of the Group with effect from 7th April 2017.

Fund Raising Activities

(i) Rights Issue

Reference is made to the announcements of the Company dated 12th January 2017 and 24th February 2017, respectively and the prospectus of the Company dated 3rd February 2017, in relation to, among other matters, the issue of rights shares (the "Rights Shares") of the Company (the "Rights Issue"). On 12th January 2017, the Board announced that the Company proposed to raise gross proceeds of approximately HK\$192.9 million to approximately HK\$193.2 million by issuing not less than 175,394,450 Rights Shares and not more than 175,652,950 Rights Shares at the subscription price of HK\$1.10 per Rights Share on the basis of one (1) Rights Share for every two (2) existing shares held on the record date (i.e. 27th January 2017). The Rights Issue was completed on 27th February 2017 and 175,394,450 Rights Shares were issued.

For the actual net proceeds of approximately HK\$189.1 million from the Rights Issue, approximately HK\$170.2 million has been used for financing the Acquisition and approximately HK\$18.9 million has been used for repaying bank borrowings and improving the liquidity for the operations of the Group in Hong Kong. The uses are consistent with the intended use of proceeds as disclosed in the prospectus of the Company dated 3rd February 2017.

財政資源及流動資金

於二零一七年十二月三十一日,本集團之資產總值為2,264.9百萬港元,資金來自流動負債779.9百萬港元、非流動負債387.2百萬港元及股東股本1,097.8百萬港元。本集團之營運資本比率約為1.25:1。

於二零一七年十二月三十一日,本集團自銀行取得之綜合銀行融資總額約達371.0百萬港元(二零一六年:170.0百萬港元)。本集團已抵押土地及樓宇為272.0百萬港元(二零一六年:107.3百萬港元)、投資物業為52.3百萬港元(二零一六年:無),及受限制銀行存款為0.8百萬港元(二零一六年:0.5百萬港元)以分別獲得授予本集團之銀行融資及履約保證。本集團給予客戶作為合約抵押之履約保證於二零一七年十二月三十一日約為63.3百萬港元(二零一六年:62.6百萬港元)。於二零一七年十二月三十一日,本集團之資本負債比率(總借貸除以總權益)為44.9%(二零一六年:1.4%)。

重大收購

茲提述本公司日期分別為二零一六年十二月十九日及二零一七年四月七日之公告及本公司日期為二零一七年三月六日之通函,內容有關(其中包括)收購Grid Dynamics。於二零一六年十二月十九日,董事會宣佈本公司與Grid Dynamics訂立合併協議及計劃(「合併協議」)。本公司同意以合併方式,按總現金代價約118.0百萬美元(相當於約916.8百萬港元)連同若干調整收購Grid Dynamics,惟受合併協議所載之條款及條件所規限。於二零一七年四月七日,合併協議所載之所有以完成收購事項的條件(「完成」)已獲達成及完成已於同日落實。於完成後,Grid Dynamics已成為本公司之間接全資附屬公司,而Grid Dynamics之財務業績、資產及負債已於本集團之綜合財務報表內綜合入賬,自二零一七年四月七日生效。

集資活動

(i) 供股

茲提述本公司日期分別為二零一七年一月十二日及二零一七年二月二十四日之公告及本公司日期為二零一七年二月三日之供股章程,內容有關(其中包括)本公司發行供股股份(「供股股份」)(「供股」)。於二零一七年一月十二日,董事會宣佈本公司建議按認購價每股供股股份1.10港元發行不少於175,394,450股供股股份及不多於175,652,950股供股股份,以籌集所得款項總額約192.9百萬港元至約193.2百萬港元,基準為於記錄日期(即二零一七年一月二十七日)每持有兩(2)股現有股份獲發一(1)股供股股份。供股已於二零一七年二月二十七日完成及已發行175,394,450股供股股份。

供股實際所得款項淨額約為189.1百萬港元,約170.2 百萬港元已用於撥付收購事項及約18.9百萬港元已用 於償還銀行貸款及改善本集團於香港之營運之流動資 金。用途與本公司日期為二零一七年二月三日之供股 章程所披露之所得款項擬定用途一致。

(ii) Placing of Convertible Bonds

Reference is made to the announcements of the Company dated 12th January 2017, 23rd February 2017, 8th March 2017, 21st March 2017, 8th June 2017 and 25th August 2017 and the circular of the Company dated 24th February 2017 respectively, in relation to, among other matters, the placing (the "Placing") of the convertible bonds (the "Convertible Bonds"). On 12th January 2017, the Company and GF Securities (Hong Kong) Brokerage Limited (the "Placing Agent") entered into the placing agreement (the "Placing Agreement"). The Placing Agent has conditionally agreed to procure, on a best efforts basis, placee(s) to subscribe for the Convertible Bonds in an aggregate principal amount of up to HK\$350.0 million at the issue price equal to 100% of the principal amount of the Convertible Bonds due on the third anniversary of the date of issue at zero interest rate, with the conversion rights to convert the principal amount thereof into 291,666,666 conversion shares at the initial conversion price of HK\$1.20 per conversion share.

All conditions set out in the Placing Agreement have been fulfilled and the completion of the Placing took place on 21st March 2017 in accordance with the terms and conditions of the Placing Agreement. The Convertible Bonds with an aggregate principal amount of HK\$350.0 million, convertible into 291,666,666 conversion shares, have been successfully placed to two placees, namely Viewforth Limited and China Fortune Rich Private Equity Fund Limited ("China Fortune"). The conversion price of the Convertible Bonds and the number of conversion shares falling to be allotted and issued upon conversion of the Convertible Bonds were adjusted to HK\$1.09 (the "Adjusted Conversion Price") and 321,100,917 conversion shares respectively with effect from 30th May 2017 as a result of bonus issue of the Company approved at the annual general meeting of the Company held on 17th May 2017.

On 25th August 2017, China Fortune has exercised the conversion rights to convert the principal amount of HK\$100.0 million at the adjusted conversion price of HK\$1.09 per share into 91,743,119 Shares (the "Conversion"). The aggregate outstanding principal amount of the Convertible Bonds will be reduced to HK\$250.0 million immediately after the Conversion. Save as disclosed above, there was no conversion or redemption of the Convertible Bonds for the year ended 31st December 2017.

For the actual net proceeds of approximately HK\$345.9 million from the Placing of Convertible Bonds, approximately HK\$311.3 million has been used for financing the Acquisition and approximately HK\$34.6 million has been used for staff incentive and remuneration payment and improvement in the liquidity for the operations of the Group as enlarged upon completion of the Acquisition. The uses are consistent with the intended use of proceeds as disclosed in the circular of the Company dated 24th February 2017.

(ii) 配售可換股債券

茲提述本公司日期分別為二零一七年一月十二日、二零一七年二月二十三日、二零一七年三月八日、二零一七年三月八日入二零一七年三月二十四日之二四十五日之公告及本公司日期為二零一七年二月二十四日之通函,內容有關(其中包括)可換股債券(「可換股債券」)。於二零一七年二月十二日,本公司及廣發証券(香港)經紀有限公司(「配售代理」)訂立配售協議(「配售協議」)。配售代理已有條件同意盡其最大努力促使承配人按相限公司(「配售代理」)訂立配售協議(「配售協議」)。配售代理已有條件同意盡其最大努力促使承配人按相联的可換股債券100%本金額之發行價認購本金總額最多為350.0百萬港元的可換股債券,該可換股債券為零利率,將於發行日期起計第三週年到期且附帶可按初始價格每股換股股份1.20港元將其本金額轉換為291,666,666 股換股股份的換股權。

配售協議之所有條件已獲達成及根據配售協議之條款及條件,配售之完成已於二零一七年三月二十一日生效。本金總額350.0百萬港元之可換股債券(可轉換為291,666,666股換股股份)已成功配售予兩位承配人(即會福興業有限公司及中國祿豐私募資金有限公司(「中國祿豐」))。可換股債券之換股價及轉換可換股債券後將予配發及發行之換股股份數目因本公司發行紅股(本公司於二零一七年五月十七日舉行之股東週年大會上已獲批准)而分別調整為1.09港元(「經調整換股價」)及321,100,917股換股股份,自二零一七年五月三十日起生效。

於二零一七年八月二十五日,中國祿豐已行使換股權按經調整換股價每股1.09港元轉換本金額100.0百萬港元為91,743,119股股份(「該轉換」)。緊隨該轉換後,尚未行使之可換股債券本金總額將降至250.0百萬港元。除上文所述者外,截至二零一七年十二月三十一日止年度概無轉換或贖回可換股債券。

配售可換股債券實際所得款項淨額約為345.9百萬港元,約311.3百萬港元已用於撥付收購事項及約34.6 百萬港元已用於員工獎金及薪酬支付,以及因收購事項完成而擴大本集團營運而增加之流動資金。用途與本公司日期為二零一七年二月二十四日之通函所披露之所得款項擬定用途一致。

Chief Executive Officer's Statement

行政總裁報告

Treasury Policies

The Group generally financed its operations with internally generated resources and credit facilities provided by banks, as well as proceeds raised from issuance of bonds and equity financing exercises. Bank facilities available for the Group include trust receipt loans, clean import loans, overdrafts and term loans. The interest rates of most of them are fixed by reference to the respective countries' Interbank Offer Rate. The bank deposits are mainly denominated in Hong Kong dollars ("HKD") and United States dollars ("USD"). The bank borrowings are denominated in HKD.

Foreign Exchange Exposure

The Group mainly earns revenue and incurs costs in HKD and USD. Foreign exchange exposure to USD of the Group will continue to be minimal as long as the policy of The Government of the Hong Kong Special Administrative Region to link HKD to USD remains in effect. There was no material exposure to fluctuations in exchange rates and therefore no related hedging financial instrument was applied during the year ended 31st December 2017 (2016: same).

Contingent Liabilities

As at 31st December 2017, the Group had HK\$0.8 million restricted bank deposits held as security for performance bonds (2016: HK\$0.5 million). As at 31st December 2017, performance bonds of approximately HK\$63.3 million (2016: HK\$62.6 million) had been issued by the bank on behalf of the Group to customers as security of contracts.

Capital Commitments

As at 31st December 2017, the Group had contracted capital commitments amounting to approximately HK\$11.6 million (2016: HK\$0.1 million).

Major Customers and Suppliers

During the year ended 31st December 2017, the five largest customers and single largest customer of the Group accounted for approximately 25.5% and 6.9%, respectively, of the Group's revenue. The five largest suppliers and single largest supplier of the Group accounted for approximately 35.9% and 9.4%, respectively, of the Group's purchases.

At no time during the year ended 31st December 2017 did a Director, their close associate or any shareholder of the Company (which to the knowledge of the Directors owns more than 5% of the number of the Company's issued shares) has an interest in any of the Group's five largest customers or suppliers.

Employee and Remuneration Policies

As at 31st December 2017, the Group, excluding its associates, employed 2,056 permanent and contract staff in Hong Kong, Mainland China, Taiwan, Macau, Thailand, the United States, Russia, Poland and Ukraine. The Group remunerates its employees based on their performance, working experience and the prevailing market conditions. Bonuses are granted on a discretionary basis. Other employee benefits include mandatory provident fund, insurance, medical coverage and share option scheme.

庫務政策

本集團之營運經費一般以內部資源及銀行提供之信貸融資,以及發行債券及股權融資活動所籌集款項而撥付。本集團可動用之銀行融資包括信託票據貸款、無抵押進口貸款、透支及有期借貸。該等貸款之利率大部分參考有關國家之銀行同業拆息釐定。銀行存款主要以港元(「港元」)及美元(「美元」)為單位。銀行借貸以港元為單位。

外匯風險

本集團賺取之收益及產生之成本主要為港元及美元。 倘香港特別行政區政府一直維持港元與美元掛鈎政 策,則本集團所承受之美元外匯風險水平將維持輕 微。截至二零一七年十二月三十一日止年度,並無重 大匯率波動之風險,因此並無應用相關對沖金融工具 (二零一六年:相同)。

或然負債

於二零一七年十二月三十一日,本集團0.8百萬港元之受限制銀行存款已用作履約保證(二零一六年:0.5百萬港元)。於二零一七年十二月三十一日,由銀行代表本集團給予客戶作為合約抵押之履約保證約為63.3百萬港元(二零一六年:62.6百萬港元)。

資本承擔

於二零一七年十二月三十一日,本集團已訂約的資本 承擔約11.6百萬港元(二零一六年:0.1百萬港元)。

主要客戶及供應商

截至二零一七年十二月三十一日止年度,來自五大客戶及最大客戶之營業額分別約佔本集團總收入之25.5%及6.9%。五大供應商及最大供應商之購貨額分別約佔本集團總購貨額之35.9%及9.4%。

截至二零一七年十二月三十一日止年度,本公司之董事、董事的緊密聯繫人或任何股東(據董事所知擁有5%以上本公司發行股份數目者)未曾擁有於本集團之五大客戶或供應商權益。

僱員及薪酬政策

Hong Kong Teamsun is a wholly-owned subsidiary of Teamsun, the Company's ultimate holding company listed on the Shanghai Stock Exchange (Stock Code: 600410.SH). Mr. Wang is currently a director of certain subsidiaries of Teamsun. Prior to re-designation as the chairman and president of Teamsun, Mr. Wang was the general manager of Teamsun, and the vice chairman and general manager of the first board of directors of Teamsun. Mr. Wang holds an Executive Master's Degree in Business Administration from Tsinghua University in the People's Republic of China ("PRC") and a Master's Degree in Semi-Conductor Materials and Microelectronic Technology from the Information and Electronic Engineering Department of Zhejiang University in the PRC. The Company recognises the importance of good corporate governance to the Company's healthy growth and has devoted considerable efforts to identifying and formulating corporate governance practices appropriate to the needs of its business.

The Company's corporate governance practices are based on the principles and code provisions as set out in the Corporate Governance Code (the "Code") set out in Appendix 14 of the Rules Governing the Listing of Securities (the "Listing Rules") on The Stock Exchange of Hong Kong Limited (the "Stock Exchange"). During the year ended 31st December 2017, the Company has complied with all the code provisions, save and except for code provision A.6.7, details of which are explained below. The Company regularly monitors and reviews its corporate governance practices to ensure these continue to meet the increasing stringent regulatory requirements and to improve its practices.

The Company wishes to highlight the importance of its Board of Directors (the "Board") in ensuring effective leadership and control of the Company and transparency and accountability of all operations.

The key corporate governance principles and practices of the Company are summarised as follows:

THE BOARD

Responsibilities

The Company has formalised and adopted the written terms on the division of functions reserved to the Board and delegated to the management.

The Board provides leadership and approves strategic policies and plans with a view to enhancing shareholder interests while the day-to-day operations of the Company are delegated to the management.

The Board reserves its decisions for all major matters of the Company, including the approval of long term objectives and strategies, changes to capital and overall corporate structure, risk management and internal control systems, material transactions (in particular those which may involve conflicts of interests), financial information, appointment of Directors and other significant financial and operational matters.

All Directors have full and timely access to all relevant information as well as the advice and services from the Company Secretary, with a view to ensuring that Board procedures and all applicable rules and regulations are followed.

Each Director is normally able to seek independent professional advice in appropriate circumstances at the Company's expense, upon making request to the Board.

The day-to-day management, administration and operations of the Company are delegated to the Chief Executive Officer and senior management. The delegated functions and work tasks are periodically reviewed. Approvals have to be obtained from the Board prior to entering into any significant transactions by the abovementioned officers.

The Board has the full support from the Chief Executive Officer and senior management to discharge its responsibilities.

Through active participation in Board meetings and affairs of the Company, taking the lead in managing issues involving potential conflicts of interests and serving in Board committees, all Non-Executive Directors and Independent Non-Executive Directors make various contributions to the effective direction of the Company.

Appointment and Re-election of Directors

The Company has established formal, considered and transparent procedures for the appointment of Directors.

The Company has adopted the procedures for shareholders to propose a person for election as a Director of the Company. These procedures are available and accessible on the Company's website at http://www.asl.com.hk.

The procedures and process of appointment, re-election and removal of Directors are as set out in the Bye-laws of the Company. The Board established a Nomination Committee to review the structure, size, composition and diversity of the Board at least annually, identify suitable candidates for the Board, and to make recommendations on any matters in relation to the appointment and re-appointment of members of the Board. Appointment of new Directors is reserved for the Board's approval.

The Nomination Committee ensures that the Board comprises members with a diverse range of skills and experience with the appropriate knowledge necessary to oversee the business development, strategies, operations, challenges and opportunities of the Group. The Nomination Committee takes that person's skills, qualifications and expected contributions to the Company into account before making any recommendations to the Board in relation to the appointment or re-appointment of members of the Board.

Where vacancies on the Board exist, the Board will carry out the selection process, with the advice provided by the Nomination Committee, by making reference to the proposed candidates' skills, experience, professional knowledge, personal integrity and time commitments as well as the needs of the Company and other relevant statutory requirements and regulations. An external recruitment agency may be engaged to carry out the recruitment and selection process when necessary.

In accordance with the Bye-laws of the Company, at each annual general meeting of the Company ("AGM") one-third of the Directors for the time being, or, if their number is not three or a multiple of three, then the number nearest to but not less than one-third, shall retire from office by rotation, provided that every Director shall be subject to retirement by rotation at least once every three years and any new Director appointed to fill a casual vacancy or as additional Director shall be subject to reelection by shareholders at the first general meeting after appointment.

Each of the Non-Executive Directors is appointed under a specific term and they are subject to retirement by rotation and re-election at AGM in accordance with the Byelaws of the Company.

The Company has formal letters of appointment for all Non-Executive Directors (including Independent Non-Executive Directors) or service contracts for Executive Directors setting out the key terms and conditions of their appointment and the terms of references have set out the work scope of the Board committees and delegation were made by the Board in respect of the responsibilities of the Non-Executive Directors (including Independent Non-Executive Directors) in such Board Committees.

In accordance with the Bye-laws of the Company, Mr. Wang Weihang, Mr. Cui Yong and Mr. Deng Jianxin will retire by rotation at the forthcoming AGM and being eligible, offer themselves for re-election.

The Board recommended the re-appointment of these Directors standing for reelection at the forthcoming AGM.

The Company's circular regarding the notice of the forthcoming AGM contains detailed information of the Directors standing for re-election.

Ms. Or Siu Ching, Rerina, being a Director appointed by the Board during the year, shall hold office only until the next following general meeting pursuant to the Company's Bye-law 102(B). Ms Or, being eligible, has offered herself for re-election at the annual general meeting held on 17th May 2017.

Training for Directors

Directors keep abreast of responsibilities as a Director of the Company and of the conduct, business activities and development of the Company. Each newly-appointed Director receives a comprehensive, formal and tailored induction on the first occasion of his/her appointment, so as to ensure that he/she has an appropriate understanding of the business and operations of the Company and that he/she is fully aware of his/her responsibilities and obligations under the Listing Rules and relevant regulatory requirements.

The Company is responsible for arranging and funding suitable training for its Directors. All Directors are encouraged to participate in continuous professional development to develop and refresh their knowledge and skills. Directors are continually updated on developments in the statutory and regulatory regime and the business environment to facilitate the discharge of their responsibilities. Continuing briefing and professional development for Directors are arranged where necessary.

During the year ended 31st December 2017, the Company organised a training session in November 2017 on directors' responsibilities and rules on corporate governance for listed companies and provided Directors with relevant training materials. The training session was conducted by a professional institute with a presentation and briefing materials. All the Directors have participated in continuous professional development by attending the above training session or reading materials on the above training.

Insurance Cover for Directors

The Company has arranged appropriate insurance cover in respect of legal action against its Directors to comply with the requirement of the Code.

Practices and Conduct of Meetings

Regular Board meetings are scheduled in advance to facilitate maximum attendance of the Directors. Notices of regular Board meetings are served to all Directors at least 14 days before the meetings. For other Board meetings and Board committees meetings, reasonable notice is generally given.

Agenda and Board papers together with all appropriate, complete and reliable information are sent to all Directors at least three days (or such other period as agreed) before each Board meeting or Board committees meeting to keep the Directors apprised of the latest developments and financial position of the Company and to enable them to make informed decisions. The Board and each Director also have separate and independent access to the senior management whenever necessary.

The management has provided all members of the Board with monthly updates giving a balanced and understandable assessment of the Company's performance, position and prospects in sufficient detail to enable the Board as a whole and each Director to discharge their duties.

The Company Secretary is responsible to take and keep minutes of all Board meetings and Board committees meetings. Draft minutes are normally circulated to Directors for comment within a reasonable time after each meeting and the final version is open for Directors' inspection.

According to current Board practice, any material transaction, which involves a conflict of interest for a substantial shareholder or a Director, will be considered by the Board and dealt with by a physical board meeting rather than a written resolution. The Company's Bye-laws also contain provisions requiring Directors to abstain from voting and not to be counted in the quorum at meetings for approving transactions in which such Directors or any of their associates have a material interest.

CHAIRMAN AND CHIEF EXECUTIVE OFFICER

The Company fully supports the division of responsibility between the Chairman of the Board and the Chief Executive Officer to ensure a balance of power and authority.

The positions of Chairman and Chief Executive Officer are held by Mr. Li Wei and Mr. Wang Yueou respectively. Their respective responsibilities are clearly defined and set out in writing.

The Chairman provides leadership and is responsible for the effective functioning of the Board in accordance with good corporate governance practice. With the support of the senior management, the Chairman is also responsible for ensuring that the Directors receive adequate, complete and reliable information in a timely manner and appropriate briefing on issues arising at Board meetings.

The Chief Executive Officer focuses on implementing objectives, policies and strategies approved and delegated by the Board. He is in charge of the Company's day-to-day management and operations. The Chief Executive Officer is also responsible for developing strategic plans and formulating the organisational structure, control systems and internal procedures and processes for the Board's approval.

BOARD DIVERSITY POLICY

The Board has adopted a board diversity policy effective since 30th August 2013. All board appointments will be based on meritocracy, and candidates will be considered based on objective criteria, having due regard for the benefits of diversity on the Board.

Selection of candidates will be based on a range of diversity perspectives, including but not limited to gender, age, cultural and educational background, professional experience, skills, knowledge, independence and length of service. The ultimate decision will be based on merit and contribution that the selected candidates will bring to the Board.

As at the date of this report, the Board comprises seven Directors. One of them is female. Three of them are Independent Non-Executive Directors, thereby promoting critical review and control of the management process. The Board is also characterised by significant diversity, whether considered in terms of gender, professional background and skills.

BOARD COMMITTEES

The Board has established five committees, namely Remuneration Committee, Audit Committee, Nomination Committee, Management Committee and Investment Committee, for overseeing particular aspects of the Company's affairs. All Board committees of the Company are established with defined written terms of reference. The terms of reference of the Remuneration Committee, the Audit Committee and the Nomination Committee are posted on the websites of the Company and the Stock Exchange and/or are available to shareholders upon request.

Board committees are provided with sufficient resources to discharge their duties and, upon reasonable request, are able to seek independent professional advice in appropriate circumstances, at the Company's expense.

The Board shall establish other committees for specific purposes from time to time to facilitate the Company's operations.

Remuneration Committee

The Remuneration Committee currently comprises one Non-Executive Director and two Independent Non-Executive Directors, namely Mr. Li Wei, Mr. Pan Xinrong and Ms. Or Siu Ching, Rerina. Mr. Pan Xinrong is the chairman of the Remuneration Committee.

The primary objectives of the Remuneration Committee include making recommendations on and approving the remuneration policy and structure and remuneration packages of all Directors and the senior management and share options matters. The Remuneration Committee is also responsible for establishing transparent procedures for developing such remuneration policy and structure to ensure that no Director or any of his/her associates will participate in deciding his/her own remuneration, which remuneration will be determined by reference to the performance of the individual and the Company as well as market practice and conditions.

The Management Committee is primarily responsible for managing and reviewing the Company's day-to-day operations and financial reporting, and making recommendations in respect of the objectives and strategies of the Group. The Management Committee meets as appropriate and when required to discuss the related issues.

Investment Committee

The Investment Committee currently comprises two Executive Directors and two Independent Non-Executive Directors, namely Mr. Wang Weihang, Mr. Wang Yueou, Mr. Pan Xinrong and Mr. Deng Jianxin. Mr. Wang Weihang is the chairman of the Investment Committee.

The Investment Committee is primarily responsible for identifying and evaluating existing and potential investment opportunities for the Company, and making recommendations to the Board. The Investment Committee meets as and when required to discuss the related issues.

MODEL CODE FOR SECURITIES TRANSACTIONS

The Company has adopted the Model Code for Securities Transactions by Directors of Listed Issuers (the "Model Code") as set out in Appendix 10 to the Listing Rules.

Specific enquiry has been made of all the Directors and the Directors have confirmed that they have complied with the Model Code throughout the year ended 31st December 2017.

- (a) to develop and review the Company's policies and practices on corporate governance and make recommendations to the Board;
- (b) to review and monitor the training and continuous professional development of Directors and senior management;
- (c) to review and monitor the Company's policies and practices on compliance with legal and regulatory requirements;
- (d) to develop, review and monitor the code of conduct and compliance manual (if any) applicable to Directors and employees; and
- (e) to review the Company's compliance with the Code and disclosure in the Corporate Governance Report.

DIRECTORS' RESPONSIBILITY IN RESPECT OF THE FINANCIAL STATEMENTS

The Directors acknowledge their responsibility for preparing the financial statements of the Company for the year ended 31st December 2017.

The Directors are responsible for overseeing the preparation of financial statements of the Company with a view to ensuring that such financial statements give a true and fair view of the state of affairs of the Group and that relevant statutory and regulatory requirements and applicable accounting standards are complied with.

The Board has received from the management explanation and relevant information which enable the Board to make an informed assessment for approving the financial statements.

AUDITOR'S REMUNERATION

The statement of external auditor of the Company about their reporting responsibilities on the financial statements is set out in the "Independent Auditor's Report" on pages 63 to 68 of this annual report.

The remuneration paid and payable to Grant Thornton Hong Kong Limited, the existing external auditor of the Company, in respect of audit services and non-audit services for the year ended 31st December 2017 amounted to HK\$1,400,000 and HK\$1,145,000 respectively.

RISK MANAGEMENT AND INTERNAL CONTROL

The main features of the Group's risk management and internal control systems are to provide a clear governance structure, policies and procedures, as well as reporting mechanism to facilitate the Group to manage its risks across business operations.

The Group has established a risk management framework, which consists of the Board of Directors, the Audit Committee and the senior management. The Board has evaluated and determined the nature and extent of risks that shall be taken in achieving the Group's strategic objectives, and has overseen the senior management in the design, implementation and monitoring of the risk management and internal control systems.

The Group has formulated and adopted Risk Management Policy in providing direction in identifying, evaluating and managing significant risks. At least on an annual basis, the senior management identifies risks that would adversely affect the achievement of the Group's objectives, and assesses and prioritises the identified risks according to a set of standardised criteria. Risk mitigation plans and risk owners are then established for those risks considered to be significant.

In addition, the Group has engaged an independent professional advisor to assist the Board and the Audit Committee in ongoing monitoring of internal control systems of the Group. Deficiencies in the design and implementation of internal controls are identified and recommendations are proposed for improvement. Significant internal control deficiencies are reported to the Audit Committee and the Board on a timely basis to ensure prompt remediation actions are taken.

Risk management report and internal control report which covered financial, operational and compliance control for the year ended 31st December 2017, has submitted for the Audit Committee's and the Board's reviews. The Group has an internal audit function in place to provide an independent appraisal of the adequacy and effectiveness of the Group's risk management and internal control systems in accordance with the Code. The Board had performed annual review on the effectiveness of the Group's risk management and internal control systems, including but not limited to the change, since the last annual review, in nature and extent of significant risk, and the Group's ability to respond to changes in its business and external environment; the scope and quality of management's ongoing monitoring of risk management and internal control systems; the extent and frequency of communication with the Board in relation to monitoring result of risk and internal control review; significant failures or weaknesses identified and their related implications; and the effectiveness of the Company's processes for financial reporting and Listing Rules compliance. The Board considers the Group's risk management and internal control systems are effective. The Board in particular considers the adequacy of resources, staff qualifications and experience, training programmes and budget of the Company's accounting, internal audit and financial reporting functions.

The risk management and internal control systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss.

風險管理及內部監控

本集團亦已制定及採納企業風險管理制度以提供有效的辨認、評估及管理重大風險的指引。高級管理層至少每年一次對為本集團實現業務目標帶來負面影響的風險事項進行識別,並通過規範的機制進行評價及排序,對主要風險制定風險緩解計劃及指定風險負責人。

此外,本集團外聘獨立專業機構以協助董事會及審核 委員會持續監督本集團的內部監控系統,識別內部控 制設計及運行中的缺陷並提出適當的改進意見。如發 現嚴重的內部監控缺失,會及時向審核委員會及董事 會彙報,且適時跟進,確保情況得以改善。

於截至二零一七年十二月三十一日止年度之風險管理 報告和內部監控報告(涵蓋財務、營運及合規監控) 已提交審核委員會及董事會審核。本集團已設立內部 審核功能,根據《守則》對本集團的風險管理及內部監 控系統就有關系統是否足夠及有效作出獨立評估。董 事會已就本集團的風險管理及內部監控系統是否有效 進行年度檢討,包括但不限於自上年檢討後重大風險 的性質及嚴重程度的轉變、以及本集團應付其業務轉 變及外在環境轉變的能力、管理層持續監察風險及內 部監控系統的工作範疇及素質、向董事會傳達風險及 內部監控審核的監控結果的詳盡程度及次數、期內發 生的重大監控失誤或發現的重大監控弱項以及有關影 響、本集團有關財務報告及遵守上市規則規定的程序 是否有效等。董事會認為本集團風險管理及內部監控 系統有效。董事會特別考慮公司會計、內部審核及財 務滙報職能方面之資源、員工資歷及經驗,以及其培 訓課程及預算是否足夠。

上述風險管理及內部監控系統旨在管理而非消除未能 達成業務目標的風險。因此,該等系統只能就不會有 重大的失實陳述或損失作出合理而非絕對的保證。

Procedures and Internal Controls for the Handling and Dissemination of Inside Information

The Group complies with requirements of Securities & Futures Ordinance ("SFO") and the Listing Rules. The Group discloses inside information to the public as soon as reasonably practicable unless the information falls within any of the Safe Harbours as provided in the SFO. Before the information is fully disclosed to the public, the Group ensures the information is kept strictly confidential. If the Group believes that the necessary degree of confidentiality cannot be maintained or that confidentiality may have been breached, the Group would immediately disclose the information to the public. The Group is committed to ensure that information contained in announcements are not false or misleading as to a material fact, or false or misleading through the omission of a material fact in view of presenting information in a clear and balanced way, which requires equal disclosure of both positive and negative facts.

COMMUNICATION WITH SHAREHOLDERS AND INVESTORS

The Company considers that effective communication with shareholders is essential for enhancing investor relations and investor understanding of the Group's business performance and strategies. The Company endeavours to maintain an on-going dialogue with shareholders and in particular, through AGMs and other general meetings. The Chairman of the Board, all Executive Directors, Non-Executive Directors, Independent Non-Executive Directors, and the Chairmen of all Board committees or their delegate(s) will make themselves available at each AGM to meet shareholders and answer their enquiries.

The Board has adopted a shareholders' communication policy setting out the Company's procedures in providing the shareholders with clear communication and easy access to information about the Company.

The 2017 AGM was held on 17th May 2017 (the "2017 AGM"). The notice of 2017 AGM was sent to shareholders at least 20 clear business days before the 2017 AGM.

Code provision A.6.7 stipulates that independent non-executive directors and other non-executive directors should attend general meetings and develop a balanced understanding of the view of shareholders. All Non-Executive Directors and Independent Non-Executive Directors did not attend two special general meetings of the Company (the "SGM(s)") held on 13th March 2017 due to other commitments; and one Non-Executive Director and one Independent Non-Executive Director did not attend a SGM held on 22nd March 2017 due to other commitments.

The Chairman of the Board as well as the chairmen of the Remuneration Committee, Audit Committee, Nomination Committee, Management Committee and Investment Committee or their delegate(s), and the Company's external auditor have attended the 2017 AGM to answer questions.

To promote effective communication, the Company maintains a website at http://www.asl.com.hk, where extensive information and updates on the Company's business developments and operations, financial information, corporate governance practices and other information are posted.

The Company continues to enhance communication and relationships with its investors. Designated senior management maintains regular dialogue with institutional investors and analysts to keep them abreast of the Company's developments. Enquiries from investors are dealt with in an informative and timely manner.

守則條文第A.6.7條規定,獨立非執行董事及其他非執行董事應出席股東大會,並對股東的意見有公正的了解。所有非執行董事及獨立非執行董事由於其他職務未能出席本公司於二零一七年三月十三日舉行之兩次股東特別大會(「股東特別大會」);及一位非執行董事及一位獨立非執行董事由於其他職務未能出席本公司於二零一七年三月二十二日舉行之股東特別大會。

董事會主席及薪酬委員會、審核委員會、提名委員會、管理委員會、投資委員會的主席或彼等之代表, 以及本公司外聘核數師已出席二零一七年股東週年大會以回答問題。

During the year under review, the Company has increased the authorised share capital of the Company at the SGM held on 13th March 2017 and the 2017 AGM. For the year ended 31st December 2017, the Company has not made any changes to its Memorandum of Association and Bye-laws. An updated version of the Company's Memorandum of Association and Bye-laws are available on the websites of the Company and the Stock Exchange.

SHAREHOLDERS' RIGHTS

To safeguard shareholder interests and rights, a separate resolution is proposed for each substantially separate issue at general meetings, including the election of individual Directors. Save as provided under the Listing Rules, resolutions put to vote at the general meetings of the Company (other than procedural matters) are taken by poll and poll results will be posted on the websites of the Company and the Stock Exchange after the general meetings.

Convening of Special General Meetings on Requisition by Shareholders

Under Bermuda Companies Act 1981 (the "Companies Act"), shareholders holding in aggregate of not less than one-tenth (10%) of the paid up capital of the Company may convene a SGM by written requisition.

The written requisition, duly signed by the shareholders concerned, must state the purposes of the meeting and must be deposited at the registered office of the Company.

The Company would take appropriate actions and make necessary arrangements, and the shareholders concerned would be responsible for the expenses incurred in giving effect thereto in accordance with the requirements under Section 74 of the Companies Act once a valid requisition is received.

If the Directors do not within twenty-one days from the date of the deposit of the requisition proceed duly to convene a SGM, the requisitionists, or any of them representing more than one half of the total voting rights of all of them, may themselves convene a SGM, but any SGM so convened shall not be held after the expiration of three months from the date of deposit of the requisition.

A SGM so convened by the requisitionists shall be convened in the same manner, as nearly as possible, as that in which meetings are to be convened by the Directors.

Procedures for Making Proposals at General Meetings by Shareholders

The Companies Act allows certain shareholders to make requisition to the Company to give notice to the shareholders in respect of any resolution which is intended to be moved at AGM of the Company or circulate a statement in respect of any proposed resolution or business to be considered at a general meeting of the Company.

The number of shareholders necessary to put forward such proposal for consideration at a general meeting of the Company shall be:

- (a) either any number of members representing not less than one-twentieth (5%) of the total voting rights of all the shareholders having at the date of the requisition a right to vote at the meeting; or
- (b) not less than 100 shareholders.

Environmental, Social and Governance Report

環境、社會及管治報告

This Environmental, Social and Governance ("ESG") report, complying with the "comply or explain" provisions of the ESG Reporting Guide in Appendix 27 to the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "ESG Guide"), provides our stakeholders with an annual update of the Group's corporate social responsibility performance and gives them a better understanding of it. Unless otherwise stated, the scope of the ESG report covers issues of environmental and social aspects in relation to the Group's core business operations in Hong Kong headquarters for the year ended 31st December 2017. The ESG report should be read in conjunction with the Company's annual report, in particular the Corporate Governance Report contained therein.

Since the Group is principally engaged in the delivery of comprehensive one-stop information technology ("IT") services, no significant levels of pollutants were discharged into the air or water and no substantial amount of packaging materials was used during the reporting period. Therefore, disclosures relating to these aspects, as set forth in the ESG Guide, are not applicable to the Group and so have not been made.

A. ENVIRONMENTAL ASPECTS

Environmental Policies and Performance

The Group's Environmental Policy stresses carbon reduction and waste reduction with the principle of "Reduce, Reuse and Recycle" to promote better utilization of environmental resources. To further encourage stakeholder engagement in protecting the environment, the Group is committed to promoting an environmental-friendly ambience among its employees.

In the long run, the Company will enhance its energy saving management in minimizing the usage of lighting, air-conditioning and electronic appliances and track its energy consumption regularly in the coming years.

In the following sections, unless otherwise specified, the environmental data covers the Group's business operations in overseas are excluded from scope as scale of each of them are insignificant as compared to the Group's operation in Hong Kong headquarters. The total floor area coverage and the total employees of the Group's operation in Hong Kong headquarters are 9,100 m² and 580 respectively.

A.1 Emissions¹

Our main business being IT services, our environmental impact, on the whole, is relatively low. Our emissions, energy consumption and water consumption mainly come from the use of resources in our offices in Hong Kong. During the year, there was no material non-compliance with applicable legislation or regulations.

由於本集團主要從事綜合的一站式資訊科技(「資訊科技」)服務,報告期內並無排放大量污染物至空氣或水中,且並無使用大量的包裝材料。因此,《環境、社會及管治指引》中所載的有關上述方面的披露不適用於本集團,及無就此作出相關披露。

A. 環境層面

環境政策及績效

本集團的環境政策以「減廢、重用及回收」為原則, 強調減少碳及廢棄物排放,促進環境資源的有效利 用。為進一步鼓勵持份者保護環境,本集團致力於提 升員工的環保意識。

長遠而言,本公司將於未來幾年透過節約使用照明, 空調及電器提高節能管理,並會定期檢查其能源消 耗。

由於本集團於各海外業務的營運規模與本集團於香港總部的營運相比並不顯著,因此以下部份並不包括本集團於各海外業務營運之環境數據(除非另有指明)。本集團於香港總部營運覆蓋的樓面總面積及僱員總人數分別為9,100平方米及580人。

A.1排放物1

我們的主要業務為資訊科技服務,總括而言,我們對環境造成的影響相對較少。我們的排放物、能源消耗及用水量主要源於我們位於香港的辦事處對有關資源的使用。年內並無嚴重違反適用法律或規例。

Waste Management

For the business operations of the Group's major subsidiaries, a standard policy and procedures for handling damaged components and materials have been established to ensure all damaged components and materials are properly identified and handled. For handling hazardous waste produced, the Company has registered as a Chemical Waste Producer under the Waste Disposal (Chemical Waste) (General) Regulation and sent the waste to specialists for recycling. Besides, our subsidiaries, Grid Dynamics International, Inc. ("Grid Dynamics") and its subsidiaries ("Grid Dynamics Group"), have implemented a policy for collection of hazardous waste for further utilization. There was no material non-compliance with applicable legislation or regulations during the year.

Water management is not a material area for the Group. Much of our water consumption is for basic cleaning and sanitation, as well as certain catering facilities in our offices.

During the year, the Company adopted the following procedures in its office to minimizing carbon emission and waste generation:

- Use energy saving light across all office areas
- Utilize electronic communication where applicable such as e-form system, e-leave, e-memo and e-cards for festival greetings
- Use high performance and quality all-in-one "multi-function printers" that
 incorporate printer, scanner and copier functions into a single device. This can be
 shared among teams in order to reduce a large number of devices with different
 functions so as to minimize power consumption and carbon footprint as well as
 follow-up maintenance
- Send used toner cartridges to specialists for further recycling when feasible
- Redeploy usable and suitable office furniture within the Company to reduce the amount of material going to landfills
- Redeploy usable and suitable computers or notebooks within the Company
- Reuse or recycle computer parts by selection from a team of engineers; for those
 parts and materials cannot be reused by the Company will be further sent to
 specialist for further recycling
- Send spent batteries to specialists for recycling
- Minimise waste wherever feasible

A.3 The Environment and Natural Resources

Although the core business of the Group has a minimal impact on the environment and natural resources, we recognize the corporate social responsibility in minimizing the negative environmental impact of our business operations and investment portfolio as our ongoing commitment, in order to achieve a sustainable development for generating long-term values to our stakeholders and community as a whole. We regularly assess the environmental risks of our business, and adopt preventive measures, where necessary, to reduce the risks and ensure the compliance of relevant laws and regulations.

B. SOCIAL ASPECTS

Employment and Labour Practices

The Group values its human capital with a belief that its employees are pivotal to its success in the IT industry. The Group has established a series of policies and measures regarding employment policy, health and safety, development and training, labour standards and workplace quality to provide its employees with a fair and comfortable working environment.

B.1 Employment Policy

The Group ensures our employees in different locations are protected by the law of employment in such jurisdictions and has implemented its comprehensive Employment Policy which comprises recruitment, change of employment in relation to promotion and transfer, working hours, annual leave entitlement, maternity and paternity leave, annual salary review through annual performance appraisal, job-related allowances, insurance schemes, compensation and termination of employment. The Group stresses equal opportunities in relation to recruitment or promotion of an individual, without discrimination against their age, gender, race, family status, sexual orientation, disability, nationality or region. There was no material non-compliance with applicable legislation or regulations during the year.

B.2 Health and Safety

Being committed to maintaining a safe and healthy working environment for its employees, the Company has established a safety and health policy and complied with applicable laws regarding safety in the workplace in Hong Kong. For safety measures, the Administrative Department of the Company is responsible for monitoring and reviewing the safety and security management from time to time and performing regular checking in the entire office to ensure furniture, fixtures and fittings are well-maintained and replaced when necessary to avoid unnecessary physical injuries. For health measures, smoking is prohibited in the entire office premises including enclosed offices, conference rooms and other open areas while proper lighting and ventilation are ensured to safeguard employees' health. In addition, first aid kits are available at an easily-accessible location on every floor of the entire office. Meanwhile, Grid Dynamics has its safety and health policy regarding workplace bullying, violence in the workplace and smoke-free workplace. Policies are also set up to cover the prevention of injuries and illnesses and workplace violence. There was no non-compliance with legislation or regulations related to occupational safety and health during the year.

Apart from putting the safety and health measures in place, safety and health programmes are organised from time to time by the Human Resources Department of the Company to enrich employees' knowledge in the aforesaid area.

A.3 環境及天然資源

B. 社會層面

僱傭及勞工常規

本集團重視其人員資本,深信僱員對其於資訊科技行業取得成功至關重要。本集團已就僱傭政策、健康與安全、發展及培訓、勞工準則及工作場所質素制定一系列政策及措施,以為僱員提供公平及舒適的工作環境。

B.1 僱傭政策

本集團確保我們於不同地區的僱員受其管轄區域的僱傭法律所保障,並已實施全面的僱傭政策,其中包括招聘、有關升遷及調任的僱傭變動、工時、年假資格、產假及侍產假、透過年度表現考核檢討年度薪酬、工作相關補貼、保險計劃、補償及終止僱用。本集團為個人的招聘或升遷提供平等的機會,不會因年齡、性別、種族、家庭狀況、性向、殘疾、國籍或地區產生歧視。年內,概無嚴重不遵守適用法律或規例。

B.2 健康與安全

除制定安全與健康措施外,本公司人力資源部亦不時 組織安全與健康課程,以豐富僱員於上述方面之知 識。

B.3 Development and Training

The Group understands that training and development are indispensable for its staff to keep abreast of the latest trend in the IT industry and the dynamic pace in the current domestic market. In light of this, the Group provides regular training, development programmes and training sponsorship. For the development of IT staff in Hong Kong, the Company promotes an e-Learning platform to hone their hard and soft skills. For the development of non-IT staff, the Company encourages department heads to work closely in assessing areas of training and development for their subordinates to improve their capabilities and ability in career advancement. Sponsorships are available to employees who have met certain conditions set by the Company.

Within Grid Dynamics Group, there is an internal educational platform which delivers employee trainings, certifications and seminars as a part of knowledge management and career development. Learning paths, comprising target role, duration and covered skills and technologies, are clearly set to assist employees' career development. Meanwhile, employees are encouraged to declare their skills in a system to enhance personal and corporate development. Grid Dynamics also set up a web application which provides electronic catalogue of books, articles, presentations and videos that are available to employees and creates an environment in which employees can share, collaborate and recommend their favorite content to promote self-learning.

During the year, the Group spent approximately HK\$3.4 million and US\$0.3 million on staff training in Hong Kong's subsidiaries and Grid Dynamics Group, respectively, and most of them were spent on strengthening staff's competence and aiding them in obtaining qualifications.

B.4 Labour Standard

There was no child nor forced labour in the Group's operations in the reporting period. Meanwhile, each candidate's personal particulars are confirmed during recruitment processes. The Group also ensures a fair recruitment process and working environment without any coercive acts. There was no non-compliance with legislation or regulations related to child labour or forced labour during the year.

Workplace Quality

The Group is concerned about its employees' quality of life and promotes a positive work-life balance. During the year, the Group has organised hundreds of large and small events to enhance work-life balance and to strengthen employee relations. Some of the large events were 20th Listing Anniversary Grand Celebration Dinner, ASL Christmas BBQ Party, ASL Summer Baking Workshop, Grid Dynamics Christmas Party and Grid Dynamics New Year Party. Meanwhile, the Company and Grid Dynamics Group provide employees with various facilities, such as recreation area/room, gym room, shower and massage chair, etc. The Group always makes its best endeavours to develop a happy and caring working environment for its employees.

Moreover, the Group is committed to building a family-friendly environment so as to allow its staff to achieve their full potential. During the year, the Group has implemented a series of measures to promote a balance between work and family. In Hong Kong, the Company provides its employees with marriage leave, compassionate leave and welcome red packets to its employees' newborn babies. The Company is also proud of having set up a nursing room with comprehensive facilities and strict privacy in its office to support its breastfeeding employees.

B.3 發展及培訓

本集團明白培訓及發展對其僱員緊貼資訊科技行業最新趨勢及目前當地市場動態而言不可缺少。因此,本公司為僱員提供定期培訓、發展計劃及培訓資助。就於香港資訊科技員工的發展而言,本公司為彼等提供網絡教學平台,鍛煉彼等的軟硬技能。就非資訊科技員工的發展而言,本公司鼓勵部門主管緊密合作,對下屬的培訓及發展情況進行評估,提高其職業發展能力。符合本公司設定的若干條件之僱員可獲得資助。

Grid Dynamics集團內設有內部教育平台,為僱員提供培訓、認證及研討會,以作為知識管理及職業發展的一部分。清晰制定學習軌道(包含目標職位、所需時間及所涵蓋技能及科技),以協助僱員的職業發展。同時鼓勵僱員於系統上申報他們的技能以加強個人及企業發展。Grid Dynamics亦開設一個網絡應用程式,向僱員提供可使用的書籍、文章、演講及視頻的電子目錄,創立一個可予分享、合作及推薦其喜愛內容以促進僱員自學的環境。

年內,本集團於香港附屬公司及 Grid Dynamics集團員 工培訓方面支出分別約3.4 百萬港元及0.3 百萬美元, 其中大部分用於加強員工能力並幫助彼等獲得資格證 書。

B.4 勞工標準

於報告期內,本集團業務內概無童工及強迫勞動。同時,於招聘過程中,本集團會確認每名求職者的個人資料。本集團亦確保提供無強迫之公正招聘流程及工作環境。年內,概無不遵守有關童工或強迫勞動法例及規例的情況。

工作環境質量

本集團關切其僱員的生活質量,並致力提升工作與生活的平衡。年內,本集團組織了數以百計大大小小的活動以提升工作與生活的平衡及加強員工關係。其中的大型活動有上市二十周年慶祝晚宴、ASL聖誕燒烤派對、ASL暑期烘焙班、Grid Dynamics聖誕派對及Grid Dynamics新年派對。同時,本公司及Grid Dynamics集團為僱員提供各類設施,如娛樂空間/室、健身室、淋浴間及按摩椅等。本集團始終致力為其僱員提供輕鬆愉快的工作環境。

此外,本集團致力營造家庭友善的工作環境,讓員工 全面發揮所長。年內,本集團實施了一系列促進工作 與家庭平衡的措施。於香港,本公司為僱員提供婚 假、喪假及向僱員的新生嬰兒派發歡迎利是。本公司 對其配備設施齊全的哺乳室及於辦公室內嚴格保障母 乳餵哺僱員的隱私感到自豪。

Operating Practices

The Group believes that monitoring and evaluation of the vendors are important management tools to track the business progress and facilitate decision making and, in return, the Group could serve the customers towards their satisfaction through the products and services with the best quality. The Group will continue to maintain the vendor management policy and proactively seek room for improvement.

B.5 Supply Chain Management

The Company's two major Hong Kong subsidiaries, Automated Systems (H.K.) Limited ("ASLHK") and ELM Computer Technologies Limited ("ELM"), are committed to complying with a vendor management policy established for ensuring the quality of services offered. The policy covers the control of vendors, including nomination and evaluation, selection, monitoring, suspension and blacklisting when necessary. A list of approved vendors has been created and updated on an ongoing basis according to procedures clearly stated in the policy. The Company's another major subsidiary, Grid Dynamics, has implemented and complied with policies on third party information security. The policies include a set of information security and related requirements as prerequisites to become Grid Dynamics' vendors.

ASLHK demonstrates our commitment to high standards of quality in provision of supply chain management services in accordance with ISO 9001:2015 from Hong Kong Quality Assurance Agency.

During the year, the Group evaluated the top 15 product vendors for our two major Hong Kong subsidiaries in 2016 in terms of the purchase amount which equal to 75% of the total product purchase amount. For service vendors, the Group particularly got the relevant service delivery team(s) involved in selecting, monitoring and performance evaluation of service vendors to ensure the quality of services provided to customers.

In view of increasing environmental concerns in society, the Company is aware of the importance in managing environmental and social risks of its supply chain. The top 10 IT product brands from which ASLHK purchased during the year demonstrated excellent environmental awareness. The IT product brands took initiatives in minimizing their negative operational impacts on the environment and society. The Company will continue to monitor its supply chain in accordance with environmental and social standards.

營運慣例

本集團認為對供應商的監督和評核是重要的管理工具,幫助監察業務進展從而加快決策過程,最終可從 產品及服務質量提昇令客戶更滿意。本集團將繼續實 行供應商管理政策,並會繼續留意任何改進的空間。

B.5 供應鏈管理

本公司兩大香港附屬公司自動系統(香港)有限公司(「香港自動系統」)及榆林電腦科技有限公司(「榆林」)致力遵守供應商管理政策,確保所提供服務的質素。該政策涵蓋對供應商的監控,包括有關從提名、評估、甄選、監督、暫停採購並在必要時列入黑名單的程序。我們已根據政策清晰列明的程序創建核准供應商名單並持續對其進行更新。本公司的另一主要附屬公司Grid Dynamics已實施及履行第三方資訊安全政策,政策包括一系列的資訊安全及作為成為Grid Dynamics的供應商先決條件的相關要求。

香港自動系統展示我們對高質量標準的承諾,其供應 鍊管理服務取得由香港品質保證局發出的質量管理認 證ISO 9001:2015。

年內,本集團向二零一六年我們兩大香港附屬公司之首十五間購買貨品金額總和相等於75%總貨品購買金額的供應商進行評審。而服務供應商方面,本集團特別要求相關服務交付團隊須參與甄選、監督服務供應商並評估其表現,從而確保向客戶提供優質服務。

鑒於社會對環境的關注日增,本公司明白管理其供應 鏈中的環境及社會風險之重要性。香港自動系統年內 向其採購的前十大資訊科技產品品牌已彰顯我們高度 的環保意識。該等資訊科技產品品牌已採取措施盡量 減輕其營運對環境及社會的負面影響。本公司將繼續 遵照環境及社會標準監控其供應鏈。

B.6 Product (Service) Responsibility

Customers' support has been of paramount importance to the Group. The Group therefore put strong emphasis on assuring the quality and reliability of its services.

The Group has implemented its IT Security Policy on the major subsidiaries in Hong Kong over a decade, the policy ensures the confidentiality, integrity and availability of internal and customers' security systems, which addresses security considerations in physical security, access control security, data security, security on application systems, network & communication security, security risk assessment & auditing and security incident management. For Grid Dynamics, the policy provides regulations in relation to all types and forms of information processing, transmission and storage, telecommuter and remote computer use security, acceptable use, and developing and maintaining software within the Grid Dynamics Group. The Group's relevant staff must comply with regulations in relation to physical security, access control security, data security and network and communication security, which are all covered in the IT Security Policy, to protect the customers' privacy. For redressing security incidents, such as network or systems software malfunctions, the Company has adopted a set of reporting and handling procedures, which are executed by the relevant staff and a Customer Care Unit (the "Unit"). There was no non-compliance with legislation or regulations related to the services provided by the Group during the year.

In addition, the Group has long established a policy with a set of procedures to handle customers' feedbacks or complaints in a professional manner. The Unit reviews the feedbacks or complaints and coordinates relevant teams to address the concerns. The Unit will also escalate the feedbacks or complaints to appropriate level(s) of management if necessary.

Intellectual Property Rights

Regarding intellectual property rights, employees of the Group are reminded that the Group has exclusive ownership of its intellectual property while all materials made or compiled by them in the course of employment is the property of the Group, details of which are set out in Business and Ethical Code of Conduct of the Group or relevant guidelines of its subsidiaries.

Personal Data Protection

In relation to the customers' data protection, the Group requires its staff to handle customers' data in a strictly confidential manner to prevent data leakage, details of which are set out in our IT Security Policy. The staff shall observe and comply with the non-disclosure agreements made with the Group and the agreements entered into between the Group and customers from time to time. Besides this, the Group may collect personal data from different parties through the enguiry box on the Company's website, from candidates or employees through recruitment or employment during the year. A privacy policy statement and the relevant personal information collection statements have been set out and uploaded on the Company's website so that relevant parties were timely informed before giving their personal information. During the year, the Company follows the six general principles relating to data protection as set down by the Hong Kong Privacy Commission. During the year, there was no confirmed case or non-compliance with any rules and regulation of the Group as regards the Personal Data (Privacy) Ordinance (Cap.486) and Personal Data (Privacy) (Amendment) Ordinance, as well as any applicable rules and regulations in the United States.

B.6 產品(服務)責任

客戶的支持對本集團而言至關重要。因此,本集團著 重保證其服務的質量及可靠性。

Quality Assurance

For quality assurance, the quality office of the Group has performed quality reviews and internal audit functions monitoring the effectiveness of the corrective actions taken and advised any risk mitigation plans can be taken for years. The Company's three major subsidiaries, ASLHK, ELM and Grid Dynamics, have been confident in their quality management systems, IT service management system and information security management system. During the year, ASLHK and ELM have upgraded its quality management system standard from ISO 9001:2008 to ISO 9001:2015 and extended the service scope of both ISO 9001 and ISO 20000-1 to synchronize with the Group's development and cope with the contemporary needs in quality management.

B.7 Anti-corruption

The Company has established an anti-corruption policy included in Business and Ethical Code of Conduct of the Group. Employees must not solicit or accept an advantage as a reward or inducement for doing any act or showing favour to any person or corporate without the permission of the Company. Any gifts or souvenirs offered or received shall be reported and passed to the Company. Besides the anti-bribery policy, employees are encouraged to report without fear of reprisal any business malpractices including questionable accounting and auditing matters. In line with the Group's commitment to anti-corruption, a whistle-blower policy is also placed to allow employees to report any malpractice and misconduct to the Legal Manager of the Company with completed confidentiality. During the year, there was no confirmed case of corruption or non-compliance with any rules and regulation of the Group as regards anti-corruption such as the Prevention of Bribery Ordinance, as well as any applicable rules and regulations in the United States.

A competition compliance policy has also been adopted in the Company's subsidiaries involving business conducted in Hong Kong, of which to prohibit any conducts that prevents, restricts or distorts competition in Hong Kong. Online training workshop is available on the Company's intranet to help employees understand the competition compliance policy and the Competition Ordinance. Any employees in doubt about the legality of any business activity may consult the Legal Manager of the Company. Employees are also encouraged to make a complaint or disclose any potential violations of such policy in accordance with the Company's whistle-blower policy and procedure. During the year, there was no confirmed case or non-compliance with any rules and regulation of the Group as regards the Competition Ordinance, as well as any applicable rules and regulations in the United States.

Community

B.8 Community investment

The Group, as a corporate citizen, makes every effort in giving back to the community through helping the social vulnerable groups. This is the second consecutive year for the Group to become a Platinum Sponsor of the Annual Hong Kong 24 Hour Pedal Kart Grand Prix through charitable donations, which contributed to a variety of charities, primarily in Hong Kong but also in other places in need across Asia.

Apart from taking the social vulnerable groups into consideration, the Group is dedicated to developing a social responsibility culture among its employees. Our core subsidiary, ASLHK, has long been recognised by the Hong Kong Council of Social Service with "Caring Company Award" under Caring Company Scheme for eight consecutive years. The Group joined Tung Chung Family Walk 2017 and continued in building up its volunteer team during the year.

In addition, the Group takes initiatives in nurturing our next generation with information and guidance on career development in the IT industry. The Group has coorganised an IT exploration tour with Hong Kong Association for Computer Education for secondary students with keen interest in IT industry during the year.

Apart from nurturing the youth, ASL sponsored the 3rd Hong Kong International Entrepreneurs Festival Roadshow to support and encourage the start-ups and the young entrepreneurs to showcase their creativity at a dynamic and competitive global business environment. With visionary and innovative technology horizon, ASL actively participated in the investment project roadshow competition activities and identified outstanding entrepreneurship projects. Thus, ASL was awarded the "Innovation Entrepreneurship Coach" certificate. Going forward, ASL will continue to support young people to put their dreams into practice and cultivate youth being bold to innovate.

PRINCIPAL ACTIVITIES

The Company acts as an investment holding company and provides corporate management services. The principal activities of its major subsidiaries and associates are set out in Notes 48 and 22, respectively, to the consolidated financial statements.

RESULTS AND APPROPRIATION

The results of the Group for the year ended 31st December 2017 are set out in the consolidated statement of profit or loss and consolidated statement of comprehensive income on pages 69 and 70 of the annual report respectively.

The Directors had resolved to recommend the payment of a final dividend of 1.0 HK cent per share for the year ended 31st December 2017 (2016: Nil) to the shareholders of the Company whose names appeared on the register of members on Tuesday, 29th May 2018.

The Directors had also resolved to recommend a bonus issue ("Bonus Issue") of shares of par value HK\$0.1 each in the capital of the Company ("Bonus Shares") on the basis of two (2) Bonus Shares, credited as fully paid, for every ten (10) existing shares held by the shareholders of the Company whose names appeared on the register of members on Tuesday, 29th May 2018.

The final dividend and the Bonus Issue are conditional upon shareholders' approval at the forthcoming annual general meeting, and the Bonus Issue is conditional upon the Listing Committee of The Stock Exchange of Hong Kong Limited (the "Stock Exchange") granting listing of, and permission to deal in, the Bonus Shares and compliance with the relevant legal procedures and requirements (if any) under the applicable laws of Bermuda and the Bye-laws of the Company to effect the Bonus Issue.

For determining the entitlement of the final dividend and the Bonus Shares, the register of members of the Company will be closed from Thursday, 24th May 2018 to Tuesday, 29th May 2018, both days inclusive, during which period no transfer of shares of the Company will be registered. In order to qualify for the final dividend and the Bonus Shares, all completed transfer forms accompanied by the relevant share certificates must be lodged with the Company's branch share registrar in Hong Kong, Tricor Tengis Limited at Level 22, Hopewell Centre, 183 Queen's Road East, Hong Kong, for registration not later than 4:30 p.m. on Wednesday, 23rd May 2018. The final dividend warrants and share certificates for the Bonus Shares are expected to be despatched to the qualifying shareholders of the Company on or before Friday, 8th June 2018.



1. GENERAL INFORMATION

The Company was incorporated in Bermuda as an exempted company with limited liability and its shares are listed on The Stock Exchange of Hong Kong Limited (the "Stock Exchange"). At 31st December 2017, its immediate holding company is Teamsun Technology (HK) Limited ("Hong Kong Teamsun"), a company incorporated in Hong Kong. Its ultimate holding company is Beijing Teamsun Technology Co., Ltd. ("Teamsun"), a company incorporated in the People's Republic of China (the "PRC") and its shares are listed on The Shanghai Stock Exchange of the PRC. The addresses of the registered office and principal place of business of the Company are Canon's Court, 22 Victoria Street, Hamilton HM12, Bermuda, and 15th Floor, Topsail Plaza, 11 On Sum Street, Shatin, New Territories, Hong Kong, respectively.

The Company is an investment holding company and provides corporate management services to its subsidiaries. The principal activities of its major associates and subsidiaries are set out in Notes 22 and 48 respectively.

The consolidated financial statements are presented in thousands of units of Hong Kong dollars (HK\$'000), unless otherwise stated. These consolidated financial statements have been approved for issue by the Board of Directors (the "Board") on 28th March 2018.

2. BASIS OF PREPARATION

The consolidated financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards ("HKFRSs") which collective term includes all applicable individual Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards ("HKAS") and Interpretations issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA") and the accounting principles generally accepted in Hong Kong.

The consolidated financial statements also comply with the applicable disclosure requirements of the Hong Kong Companies Ordinance and include the applicable disclosure requirements of the Rules Governing the Listing of Securities on the Stock Exchange ("Listing Rules").

The significant accounting policies that have been used in the preparation of these consolidated financial statements are summarised in Note 3. These policies have been consistently applied to all the years presented unless otherwise stated. The adoption of new or amended HKFRSs and the impacts on the Group's consolidated financial statements, if any, are disclosed below.

The consolidated financial statements have been prepared under the historical cost basis except that the land and buildings, investment properties and contingent consideration payable are stated at fair values.

The directors anticipate that all of the pronouncements will be adopted in the Group's accounting policy for the first period beginning after the effective date of the pronouncement. Information on new and amended HKFRSs that are expected to have impact on the Group's accounting policies is provided below. Other new and amended HKFRSs are not expected to have a material impact on the Group's financial statements.

HKFRS 9: Financial Instruments

HKFRS 9 replaces HKAS 39 "Financial Instruments: Recognition and Measurement". It makes major changes to the previous guidance on the classification and measurement of financial assets and introduces an "expected credit loss" model for the impairment of financial assets.

HKFRS 9 also contains new requirements on the application of hedge accounting. The new requirements look to align hedge accounting more closely with entities' risk management activities by increasing the eligibility of both hedged items and hedging instruments and introducing a more principles-based approach to assessing hedge effectiveness.

HKFRS 9 is effective for annual reporting periods beginning on or after 1st January 2018. Based on the assessment completed to date, the Group has identified the following areas that are expected to be impacted by the application of HKFRS 9:

- the classification and measurement of the Group's financial assets will need to be reviewed based on the new criteria that considers the assets' contractual cash flows and the business model in which they are managed. The Group has assessed that its financial assets currently measured at amortised cost will continue with their respective classification and measurements upon the adoption of HKFRS 9, except for the Group's unlisted equity investment currently classified as available-for-sale financial asset (Note 23), which the Group intends to hold beyond 1st January 2018 (i.e. not held for trading), will satisfy the conditions for classification as fair value through other comprehensive income. To present changes in other comprehensive income requires making an irrevocable designation on initial recognition or at the date of transition to HKFRS 9. Currently, the Group intends to elect to present changes in the equity investment in other comprehensive income.
- the impairment of financial assets will apply the expected credit loss model. This will apply to the Group's trade receivables. The Group applies a simplified model of recognising lifetime expected credit losses as trade receivables do not have significant financing component. The directors do not anticipate the adoption of expected credit loss model will have material impact on the Group's performance and financial position.

HKFRS 15: Revenue from Contracts with Customers

HKFRS 15 and the related clarification to HKFRS 15 (hereinafter referred to as "HKFRS 15") presents new requirements for the recognition of revenue, replacing HKAS 18 "Revenue", HKAS 11 "Construction Contracts", and several revenue-related Interpretations. HKFRS 15 establishes a single comprehensive model that applies to contracts with customers and two approaches to recognising revenue; at a point in time or overtime. The model features a contract-based five-step analysis of transactions to determine whether, how much and when revenue is recognised.

HKFRS 15 is effective for annual periods beginning on or after 1st January 2018. Based on the assessment completed to date, the Group has identified the following areas which are expected to be affected:

(a) Timing of revenue recognition

The Group's revenue recognition policies are disclosed in note 3(u). Currently, revenue arising from provision of services other than installation service is recognised over time, whereas revenue from sale of goods is generally recognised when the risks and rewards of ownership have passed to the customers.

Under HKFRS 15, revenue is recognised when customer obtains control of the promised good or service in the contract. HKFRS 15 identifies three situations in which control of the promised good or service is regarded as being transferred over time:

- When the customer simultaneously receives and consumes the benefits provided by the entity's performance, as the entity performs;
- (ii) When the entity's performance creates or enhances an asset (for example work in progress) that the customer controls as the asset is created or enhanced; or
- (iii) When the entity's performance does not create an asset with an alternative use to the entity and the entity has an enforceable right to payment for performance completed to date.

香港財務報告準則第15號及對香港財務報告準則第15號之相關澄清(下文統稱「香港財務報告準則第15號」)提出了收入確認之新規定,取代香港會計準則第18號「收入」、香港會計準則第11號「建築合約」及若干與收入相關之詮釋。香港財務報告準則第15號建立單一適用於客戶合約之綜合模式及確認收入之兩種方法;以一個時點確認或以一段時間確認。該模式之特點是基於合約之五步交易分析,以確定是否確認收入以及確認收入之金額及時間。

If the contract terms and the entity's activities do not fall into any of these three situations, then under HKFRS 15 the entity recognises revenue for the sale of that good or service at a single point in time, being when control has passed. Transfer of risks and rewards of ownership is only one of the indicators that will be considered in determining when transfer of control occurs.

The Group has assessed that the adoption of HKFRS 15 is not likely to have significant impact on how it recognises from contracts.

(b) Contracts with multiple performance obligations

Many of the Group's contracts comprise a variety of performance obligations including, but not limited to, system enhancement services, installation services with sales of products and maintenance services. Under HKFRS 15, the Group must evaluate the separability of the promised goods or services based on whether they are "distinct". A promised good or service is "distinct" if both:

- the customer benefits from the items either on its own or together with other readily available resources; and
- it is "separately identifiable" (i.e. the Group does not provide a significant service integrating, modifying or customising it).

While this represents significant new guidance, the implementation of this new guidance did not have a significant impact on the timing or amount of revenue recognised by the Group in any year.

The directors do not consider that the application of HKFRS 15 will have a material impact on the timing and amounts of revenue recognised in the respective reporting period.

本集團已評估並認為香港財務報告準則 第15號之採納不大可能會對其確認合約 收入之方式造成重大影響。

(b) 多項履約責任合約

本集團多數合約包含多項履約責任(包括但不限於系統增強服務、安裝服務及銷售產品及維修服務)。根據香港財務報告準則第15號,本集團須按照承諾商品或服務是否「獨特」評估其獨立性。倘承諾商品或服務符合以下兩項,則其屬「獨特」:

- 客戶從其本身或連同其他隨時可 得來源之項目獲益;及
- 其可「單獨識別」(即本集團並不提 供整合、修訂或定制承諾商品或 服務之重大服務)。

儘管其屬重大新指引,但該新指引之執 行對本集團於任何年度確認收入之時間 或金額並無重大影響。

董事認為應用香港財務報告準則第15號將 不會對相關報告期間確認收入之時間及金額 產生重大影響。

HKFRS 16: Leases

HKFRS 16 "Leases" will replace HKAS 17 and three related Interpretations.

As disclosed in note 3(y), currently the Group classifies leases into finance leases and operating leases and accounts for the lease arrangements differently, depending on the classification of the lease. The Group enters into some leases as the lessor and others as the lessee.

HKFRS 16 is not expected to impact significantly on the way that lessors account for their rights and obligations under a lease. However, once HKFRS 16 is adopted, lessees will no longer distinguish between finance leases and operating leases. Instead, subject to practical expedients, lessees will account for all leases in a similar way to current finance lease accounting, i.e. at the commencement date of the lease, the lessee will recognise a corresponding "right-of-use" asset. After initial recognition of this asset and liability, the lessee would recognise interest expense accrued on the outstanding balance of the lease liability, and the depreciation of the right-of-use asset, instead of the current policy of recognising rental expenses incurred under operating leases on a systematic basis over the lease term. As a practical expedient, the lessee can elect not to apply this accounting model to short-term leases (i.e. where the lease term is 12 months or less) and to leases of low-value assets, in which case the rental expenses would continue to be recognised on a systematic basis over the lease term.

HKFRS 16 will primarily affect the Group's accounting as a lessee of leases of office premises, staff quarter and computer equipment which are currently classified as operating leases. The application of the new accounting model is expected to lead to an increase in both assets and liabilities and to impact on the timing of the expense recognition in the statement of profit or loss over the period of the lease. As disclosed in note 42, as at 31st December 2017, the Group's future minimum lease payments under non-cancellable operating leases amount to approximately HK\$36,929,000 for office premises, staff guarter and computer equipment, the majority of which is payable either within 1 year or between 1 and 5 years after the reporting date. Some of these amounts may therefore need to be recognised as lease liabilities, with corresponding right-of-use assets, once HKFRS 16 is adopted. The Group will need to perform a more detailed analysis to determine the amounts of new assets and liabilities arising from operating lease commitments on adoption of HKFRS 16, after taking into account the applicability of the practical expedient and adjusting for any leases entered into or terminated between now and the adoption of HKFRS 16 and the effects of discounting.

香港財務報告準則第16號「租賃」將取代香港會計準則第17號及三項相關詮釋。

如附註 3(y) 所披露,本集團現時將租賃分類 為融資租賃和經營租賃,並且根據租賃之分 類對租賃安排進行不同之會計處理。本集團 作為出租人及承租人訂立租約。

預期香港務報告準則第16號將不會對出租 人將其於租賃項下權利及義務入賬之方式產 生重大影響。然而,採用香港財務報告準則 第16號後,承租人將不再區分融資租賃及 經營租賃。相反,受可行權益方法之規限, 承租人將按與現有融資租賃會計處理方法類 似之方法將所有租賃入賬,即於租賃開始日 期,承租人將確認相應之「使用權」資產。 於初步確認該資產及負債後,承租人將確認 租賃負債未償還結餘所產生之利息開支及使 用權資產折舊,而非根據現有政策於租期內 按系統基準確認根據經營租賃所產生之租金 開支。作為一項可行權宜方法,承租人可選 擇不將此會計模式應用於短期租賃(即租期 為12個月或以下)及低價值資產之租賃,於 此情況下,租金開支將繼續於租期內按系統 基準確認。

香港財務報告準則第16號將主要影響本集 團作為承租人就辦公室物業、員工宿舍及電 腦設備(現時分類為經營租賃)之會計處理方 法。預期應用新會計模式將導致資產及負債 均有所增加,及影響租賃期間於損益表內確 認開支之時間。如附註42所披露,於二零 一七年十二月三十一日,本集團於不可撤銷 經營租賃項下就辦公室物業、員工宿舍及電 腦設備之未來最低租賃付款為約36,929,000 港元,其中大部分須於期末日後一年內或一 至五年支付。因此,採用香港財務報告準則 第16號後,若干該等款項或須確認為租賃 負債,並附帶相應使用權資產。經考慮可行 權宜方法之適用性及就現時與採用香港財務 報告準則第16號期間已訂立或終止之任何 租賃及貼現影響作出調整後,本集團將須進 行更為詳細之分析以釐定於採用香港財務報 告準則第16號時經營租賃承擔所產生之新 資產及負債之金額。

HKFRS 16: Leases (Continued)

HKFRS 16 is effective for annual periods beginning on or after 1st January 2019. The standard offers different transition options and practical expedients, including the practical expedient to grandfather the previous assessment of which existing arrangements are, or contain, leases. If this practical expedient is chosen, the Group will apply the new definition of a lease in HKFRS 16 only to contracts that are entered into on or after the date of initial application. If the practical expedient is not chosen, the Group will need to reassess all of its decisions about which existing contracts are, or contain, leases, using the new definition. Depending on whether the Group elects to adopt HKFRS 16 retrospectively or follow a modified retrospective method of recognising a cumulative-effect adjustment to the opening balance of equity at the date of initial application, the Group may or may not need to restate comparative information for any changes in accounting resulting from the reassessment.

3. SIGNIFICANT ACCOUNTING POLICIES

The principal accounting policies applied in the preparation of these consolidated financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

(a) Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and its subsidiaries made up to 31st December each year.

Subsidiaries are entities controlled by the Group. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. When assessing whether the Group has power, only substantive rights (held by the Group and other parties) are considered.

An investment in a subsidiary is consolidated into the consolidated financial statements from the date that control commences until the date that control ceases. Intra-group balances, transactions and cash flows and any unrealised profits arising from intra-group transactions are eliminated in full in preparing the consolidated financial statements. Unrealised losses resulting from intra-group transactions are eliminated in the same way as unrealised gains but only to the extent that there is no evidence of impairment.

Changes in the Group's interests in a subsidiary that do not result in a loss of control are accounted for as equity transactions, whereby adjustments are made to the amounts of controlling and non-controlling interests within consolidated equity to reflect the change in relative interests, but no adjustments are made to goodwill and no gain or loss is recognised.

(a) 綜合基準

綜合財務報表包括本公司及其附屬公司截至 每年十二月三十一日的財務報表。

附屬公司是指受本集團控制的實體。本集團 具有承擔或享有參與有關實體所得之可變回 報的風險或權利,並能透過其在該實體的權 力影響該等回報,即本集團對該實體具有控 制權。當評估本集團是否具有該權力時,只 會考慮由本集團或其他人士之實質權。

於附屬公司的投資於控制權開始日期至控制權終止日期期間於綜合財務報表中綜合計算。集團內公司間的結餘、交易及現金流以及集團內公司間之交易所產生的任何未變現溢利,均於編製綜合財務報表時悉數對銷。集團間交易產生的未變現虧損均按與未變現收益相同的方式對銷,惟僅限於無減值憑證時方予對銷。

倘本集團於附屬公司之權益變動不會導致喪 失控制權,則作為股權交易入賬,而於綜合 權益內之控股及非控股權益金額會作出調 整,以反映相關權益變動,惟但不調整商譽 及確認盈虧。

When the Group loses control of a subsidiary, it is accounted for as a disposal of the entire interest in that subsidiary, with a resulting gain or loss being recognised in profit or loss. Any interest retained in that former subsidiary at the date when control is lost is recognised at fair value and this amount is regarded as the fair value on initial recognition of a financial asset or, when appropriate, the cost on initial recognition of an investment in an associate or joint venture.

In the Company's statement of financial position, an investment in a subsidiary is stated at cost less impairment losses, unless the investment is classified as held for sale (or included in a disposal group that is classified as held for sale).

The results of subsidiaries are accounted for by the Company on the basis of dividends received and receivable. All dividends whether received out of the investee's pre or post-acquisition profits are recognised in the Company's profit or loss.

(b) Business combination

Acquisitions of subsidiaries and businesses are accounted for using the acquisition method. The consideration transferred in a business combination is measured at fair value, which is calculated as the sum of the acquisition-date fair values of the assets transferred by the Group, liabilities incurred by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. Acquisition-related costs are recognised in profit or loss as incurred.

Identifiable assets acquired and liabilities and contingent liabilities assumed in a business combination are measured initially at their fair values at the acquisition date.

Goodwill is measured as the excess of the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree, and the fair value of the acquirer's previously held equity in the acquiree (if any) over the net of the acquisition-date amounts of the identifiable assets acquired and liabilities assumed. If, after assessment, the net of the acquisition-date amounts of the identifiable assets acquired and liabilities assumed exceeds the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree and the fair value on the acquirer's previously held interest in the acquiree (if any), the excess is recognised immediately in profit or loss as bargain purchase gain.

Where the consideration the Group transfers in a business combination includes assets or liabilities resulting from a contingent consideration arrangement, the contingent consideration is measured at its acquisitiondate fair value and considered as part of the consideration transferred in a business combination. Changes in the fair value of the contingent consideration that qualify as measurement period adjustments are adjusted retrospectively, with the corresponding adjustments being made against goodwill or gain on bargain purchase. Measurement period adjustments are adjustments that arise from additional information obtained during the measurement period about facts and circumstances that existed as of the acquisition date. Measurement period does not exceed one year from the acquisition date. The subsequent accounting for changes in the fair value of the contingent consideration that do not qualify as measurement period adjustments depends on how the contingent consideration is classified. Contingent consideration that is classified as equity is not remeasured at subsequent reporting dates and its subsequent settlement is accounting for within equity. Contingent consideration that is classified as a financial liability is remeasured at subsequent reporting dates at fair value with corresponding gain or loss being recognised in profit or loss.

附屬公司之業績仍由本公司按已收及應收股息基準入帳。所有收購前或後溢利所收股息均包括於本公司的損益中確認。

(b) 業務合併

收購附屬公司及業務按收購法入賬。於業務 合併中轉讓之代價以公允價值計量,公允價 值則按本集團所轉讓資產、由本集團向被收 購方前擁有人所產生之負債以及本集團為換 取被收購方之控制權而發行股本權益於收購 日期之公允價值總和計算。與收購有關之成 本會於產生時在損益確認。

於收購日期,於業務合併中已收購之可識別 資產及須承擔之負債及或然負債按其公允價 值予以初步確認。

商譽按所轉讓代價、被收購方之任何非控股權益金額及收購方先前於被收購方持有之股本權益公允價值(如有)之總額超出所收購可識別資產扣除所承擔負債後於收購日期之金額之差額計量。倘經評估後,所收購可識別資產扣除所承擔負債後於收購日期之金額超出所轉讓代價、被收購方之任何非控股權益金額及收購方先前於被收購方持有之權益公允價值(如有)之總額,則該超出之金額即時在損益內確認為議價收購收益。

當本集團於一項業務合併轉移之代價包括或 然代價安排所產生之資產或負債,則或然代 價乃按收購日期之公允價值計算,並視為業 務合併轉移之代價的一部份。合資格作計量 期間調整之或然代價之公允價值變動乃追溯 調整,並對商譽或議價收購收益作出相應調 整。計量期間調整為於計量期間因取得於收 購日期已存在之事件及環境之額外資料而作 出之調整。計量期間不得超過收購日期起計 一年。不符合作為計量期間調整之或然代價 公允價值變動之其後會計處理,取決於或然 代價如何分類。分類為權益的或然代價於其 後期末日不會重新計量,其後結算於權益內 進行入賬處理。分類為金融負債之或然代價 於其後期末日按公允價值重新計量,而相應 收益或虧損乃於損益中確認。

(b) Business combination (Continued)

Changes in the value of the previously held equity interest recognised in other comprehensive income and accumulated in equity before the acquisition date are reclassified to profit or loss when the Group obtains control over the acquiree.

If the initial accounting for a business combination is incomplete by the end of the reporting period in which the combination occurs, the Group reports provisional amounts for the items for which the accounting is incomplete. Those provisional amounts are adjusted during the measurement period, or additional assets or liabilities are recognised, to reflect new information obtained about facts and circumstances that existed as of the acquisition date that, if known, would have affected the amounts recognised as of that date.

(c) Interests in associates

An associate is an entity in which the Group has significant influence, but not control or joint control, over its management, including participation in the financial and operating policy decisions.

An investment in an associate is accounted for in the consolidated financial statements under the equity method, unless it is classified as held for sale. Under the equity method, the investment is initially recorded at cost, adjusted for any excess of the Group's share of the acquisition-date fair values of the investee's identifiable net assets over the cost of the investment (if any). Thereafter, the investment is adjusted for the post acquisition change in the Group's share of the investee's net assets and any impairment loss relating to the investment. Any acquisition-date excess over cost, the Group's share of the post-acquisition, post-tax results of the investees and any impairment losses for the year are recognised in the consolidated statement of profit or loss, whereas the Group's share of the post-acquisition post-tax items of the investees' other comprehensive income is recognised in the consolidated statement of profit or loss or consolidated statement of comprehensive income. Adjustments are made to bring into line any dissimilar accounting policies that may exist.

When the Group's share of losses exceeds its interest in the associate, the Group's interest is reduced to nil and recognition of further losses is discontinued except to the extent that the Group has incurred legal or constructive obligations or made payments on behalf of the investee. For this purpose, the Group's interest is the carrying amount of the investment under the equity method together with the Group's long-term interests that in substance form part of the Group's net investment in the associate.

Unrealised profits and losses resulting from transactions between the Group and its associates are eliminated to the extent of the Group's interest in the investee, except where unrealised losses provide evidence of an impairment of the asset transferred, in which case they are recognised immediately in profit or loss.

(c) 聯營公司權益

聯營公司指本集團或本公司對其管理層有重 大影響力(而非控制或共同控制),包括參與 財務及經營決策之實體。

於聯營公司之投資按權益法於綜合財務報表入賬,除非該投資分類為持作出售。根據權益法,投資初步按成本記賬,並按本集團應佔被投資公司於收購日期可識別淨資產之公允價值超出投資成本之差額(如有)作資企產變動及與投資有關之任何過虧損作出調整。收購假之淨資產變動及與投資有關之任任何虧損作出調整。收購日期超出成本之任何減值虧損不禁,而本集團應佔被投資公司於收購後業績以及本年度任何減值虧損乃於綜合損益表確認,而本集團應佔被投資公司於於合損益表確認,而本集團應佔被投資公司於於合損益表或綜合全面收益表內確認。本公司會作出調整至令可能存在的任何不類同會計政策一致化。

當本集團應佔聯營公司之虧損超出其權益時,本集團之權益將減至零,並不再確認進一步虧損,除非本集團已承擔法律或推定責任,或代被投資公司付款外。就此而言,本集團之權益為根據權益法計算之投資賬面值,連同實質上構成本集團於聯營公司淨投資一部分之本集團長期權益。

本集團與其聯營公司間之交易所產生之未變 現損益,乃以本集團於被投資公司之權益為 限予以對銷,除非未變現虧損提供已轉讓資 產之減值證據,在此情況下,則該等未變現 虧損乃即時於損益中確認。

If an investment in an associate becomes an investment in a joint venture or vice versa, retained interest is not remeasured. Instead, the investment continues to be accounted for under the equity method.

In all other cases, when the Group ceases to have significant influence over an associate, it is accounted for as a disposal of the entire interest in that investee, with a resulting gain or loss being recognised in profit or loss. Any interest retained in that former investee at the date when significant influence or joint control is lost is recognised at fair value and this amount is regarded as the fair value on initial recognition of a financial asset.

(d) Segment reporting

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operating decision-maker. The chief operating decision-maker, who is responsible for allocating resources and assessing performance of the operating segments, has been identified as the Board that makes strategic decisions.

(e) Foreign currency translation

(i) Functional and presentation currency

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). The consolidated financial statements are presented in Hong Kong dollars (HKD or HK\$), which is the Company's functional currency and the Group's presentation currency.

(ii) Transactions and balances

Foreign currency transactions are translated into the functional currency using the exchange rates prevailing at the dates of the transactions or valuation where items are remeasured. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at year-end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in the consolidated statement of profit or loss.

Foreign exchange gains and losses that relate to cash and cash equivalents are presented in the consolidated statement of profit or loss. All other foreign exchange gains and losses are presented in the consolidated statement of profit or loss.

(d) 分部報告

經營分部之報告方式須與主要營運決策者獲 提供之內部報告之方式一致。作出決策之董 事會是主要經營決策者,其負責分配資源並 且評核營運分部之表現。

(e) 外幣折算

(i) 功能及呈列貨幣

本集團旗下各實體之財務報表所列項目 均以該實體經營所在主要經濟環境之通 行貨幣(「功能貨幣」)計量。綜合財務報 表以港元呈列,其亦為本公司之功能貨 幣及本集團之呈列貨幣。

(ii) 交易及結餘

外幣交易按交易日期或估值日期(倘重新計量項目)之通行匯率折算為功能貨幣。因繳付該等交易及按年末匯率折算以外幣列值之貨幣資產及負債所產生之外匯收益及虧損,均於綜合損益表中確認。

(iii) Group companies

The results and financial position of all the Group entities (none of which has the currency of a hyperinflationary economy) that have a functional currency different from the presentation currency are translated into the presentation currency as follows:

- (i) assets and liabilities for each statement of financial position presented are translated at the closing rate at the reporting date;
- (ii) income and expenses for each statement of profit or loss presented are translated at average exchange rates (unless this average is not a reasonable approximation of the cumulative effect of the rates prevailing on the transaction dates, in which case income and expenses are translated at the rate on the dates of the transactions); and
- (iii) all resulting exchange differences are recognised in other comprehensive income and accumulated separately in the translation reserve in equity.

Goodwill and fair value adjustments arising on the acquisition of a foreign entity are treated as assets and liabilities of the foreign entity and translated at the closing rate. Currency translation differences arising are recognised in other comprehensive income.

(f) Property, plant and equipment

Land and buildings are stated at fair value. Property, plant and equipment, other than land and buildings, are stated at cost less accumulated depreciation and accumulated impairment losses.

Land and buildings are stated in the consolidated statement of financial position at their revalued amounts, being the fair value at the date of revaluation less any subsequent accumulated depreciation and amortisation and accumulated impairment losses. Revaluations are performed with sufficient regularity such that the carrying amount does not differ materially from that which would be determined using fair values at the reporting date

Any revaluation increase arising on revaluation of land and buildings is credited to the revaluation reserve, except to the extent that it reverses a revaluation decrease of the same assets previously recognised as an expense, in which case the increase is credited to the consolidated statement of profit or loss to the extent of the decrease previously charged. A decrease in net carrying amount arising on revaluation of an asset is dealt with as an expense to the extent that it exceeds the balance, if any, on the revaluation reserve relating to a previous revaluation of that asset.

Depreciation and amortisation of property, plant and equipment is calculated using the straight-line method to allocate cost or revalued amounts to their residual values over their estimated useful lives, as follows:

Furniture and fixtures 10% – 331/3%

Motor vehicles 20%

Computer and office equipment 16²/₃% – 50%

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at each reporting date.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gains and losses on disposals are determined by comparing the proceeds with the carrying amount and are recognised in the consolidated statement of profit or loss. When revalued assets are sold, the amounts included in other reserves are transferred to retained earnings.

(g) Investment properties

Property that is held for long-term rental yields and is not occupied by the Group, is classified as investment properties. Investment property is measured initially at its cost, including related transaction costs.

After initial recognition at cost, investment properties are carried at fair value, representing open market value determined at each reporting date by external valuers. Fair value is based on active market prices, adjusted, if necessary, for any difference in the nature, location or condition of the specific asset. If this information is not available, the Group uses alternative valuation methods such as recent prices on less active markets or discounted cash flow projections. Changes in fair values are recorded in the consolidated statement of profit or loss.

If an item of property, plant and equipment becomes an investment property because its use has changed, any difference resulting between the carrying amount and the fair value of this item at the date of transfer is recognised in equity as a revaluation of property, plant and equipment. However, if a fair value gain reverses a previous impairment loss, the gain is recognised in the consolidated statement of profit or loss.

(h) Goodwill

Goodwill arising in a business combination is recognised as an asset at the date that control is acquired (the acquisition date). Goodwill is measured as the excess of the aggregate of the fair value of the consideration transferred, the amount of any non-controlling interests in the acquiree, and the fair value of the acquirer's previously held equity interest in the acquiree (if any) over the Group's interest in the net fair value of the acquiree's identifiable assets and liabilities measured as at the acquisition date.

If, after reassessment, the Group's interest in the fair value of the acquiree's identifiable net assets exceeds the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree and the fair value of the acquirer's previously held equity interest in the acquiree (if any), the excess is recognised immediately in profit or loss as a bargain purchase gain.

Goodwill is stated at cost less accumulated impairment losses. Goodwill is allocated to cash-generating units and is tested annually for impairment.

On subsequent disposal of a subsidiary, the attributable amount of goodwill capitalised is included in the determination of the amount of gain or loss on disposal.

Technical know-how and customer relationship

Technical know-how and customer relationships acquired in business combination are recognised initially at fair value at the acquisition date. After initial recognition, those have a finite useful lives and are subsequently carried at cost less accumulated amortisation and any impairment losses. Amortisation for technical know-how and customer relationships is provided on the straight-line basis over the estimated useful lives of 3 years and 15 years, respectively.

Intangible assets, with finite and indefinite useful lives, are tested for impairment as described below in Note 3(j).

Research and development expenditure

Costs associated with research activities are expensed in the consolidated statement of profit or loss as incurred. Costs that are directly attributable to development activities are recognised as intangible assets provided they meet the following recognition requirements:

- (a) demonstration of technical feasibility of the prospective product for internal use or sale;
- (b) there is intention to complete the intangible asset and use or sell it;
- (c) the Group's ability to use or sell the intangible asset is demonstrated;
- (d) the intangible asset will generate probable economic benefits through internal use or sale;
- (e) sufficient technical, financial and other resources are available for completion; and
- (f) the expenditure attributable to the intangible asset can be reliably measured.

The amount initially recognised for internally-generated intangible asset is the sum of the direct costs incurred from the date when the intangible asset first meets the recognition criteria. Where no internally-generated intangible asset can be recognised, development expenditure is recognised as an expense in the period in which it is incurred. Direct costs include employee costs incurred on development activities along with an appropriate portion of relevant overheads.

Subsequent to initial recognition, internally-generated intangible asset is reported at cost less accumulated amortisation and any impairment losses. Amortisation is calculated using straight-line method over the estimated useful life of 3 years.

研發開支

與研究活動有關之成本於產生時在綜合損益 表內支銷。開發活動直接應佔之成本在符合 以下確認規定時確認為無形資產:

- (a) 供內部使用或銷售的潛在產品之技術可 行性之證明;
- (b) 有意圖完成並使用或出售無形資產;
- (c) 顯示出本集團有能力使用或出售無形資產:
- (d) 無形資產將可透過內部使用或銷售產生 經濟利益;

The following assets are subject to impairment testing:

- Goodwill arising on acquisition of subsidiaries
- Other intangible assets
- Property, plant and equipment
- Interests in associates
- The Company's investments in subsidiaries

Goodwill and other intangible assets with indefinite useful life or those not yet available for use are not subject to amortisation and are tested for impairment at least annually, irrespective of whether there is any indication that they are impaired. All other assets are tested for impairment whenever there are indications that the asset's carrying amount may not be recoverable.

An impairment loss is recognised as an expense immediately for the amount by which the asset's carrying amount exceeds its recoverable amount. Recoverable amount is the higher of fair value, reflecting market conditions less costs of disposal, and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessment of time value of money and the risk specific to the asset.

For the purposes of assessing impairment, where an asset does not generate cash inflows largely independent from those from other assets, the recoverable amount is determined for the smallest group of assets that generate cash inflows independently (i.e., a cash-generating unit). As a result, some assets are tested individually for impairment and some are tested at cash-generating unit level. Goodwill in particular is allocated to those cash-generating units that are expected to benefit from synergies of the related business combination and represent the lowest level within the Group at which the goodwill is monitored for internal management purpose and not be larger than an operating segment.

不論是否有任何減值跡象,商譽及具有無限 使用年期或該等尚未可供使用之其他無形資 產,無須進行攤銷,惟須最少每年進行一次 減值測試。所有其他資產於有任何跡象顯示 資產賬面值可能無法收回時進行減值測試。

當資產之賬面值高於其可收回金額時,高出金額為減值虧損並立即被確認為開支。可收回金額為公允價值(反映市場情況減去出售成本)與使用價值之較高者。於評估使用價值時,本集團會使用可反映目前市場對貨幣時值之評估及該項資產具有之風險之除稅前貼現率,將估計日後現金流量貼現至其現值。

Impairment losses recognised for cash-generating units, to which goodwill has been allocated, are credited initially to the carrying amount of goodwill. Any remaining impairment loss is charged pro rata to the other assets in the cash generating unit, except that the carrying value of an asset will not be reduced below its individual fair value less cost of disposal, or value in use, if determinable.

An impairment loss on goodwill is not reversed in subsequent periods. In respect of other assets, an impairment loss is reversed if there has been a favourable change in the estimates used to determine the asset's recoverable amount and only to the extent that the asset's carrying amount does not exceed the carrying amount that would have been determined, net of depreciation or amortisation, if no impairment loss had been recognised.

Impairment losses recognised in an interim period in respect of goodwill are not reversed in a subsequent period. This is the case even if no loss, or a smaller loss, would have been recognised had the impairment been assessed only at the end of the financial year to which the interim period relates.

(k) Financial assets and liabilities

The Group classifies its financial assets and financial liabilities depending on the purpose for which the financial assets and financial liabilities were acquired at initial recognition and where allowed and appropriate, reevaluates this designation at each reporting date.

(i) Financial assets

The Group classifies its financial assets into loans and receivables and available-for-sale financial assets.

Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. They are included in current assets, except for the amounts that have maturities greater than 12 months after the reporting date which are classified as non-current assets. Subsequent to initial recognition, they are carried at amortised cost using the effective interest method, less any identified impairment losses.

The Group's loans and receivables comprise "trade receivables", "other receivables and deposits", "finance lease receivables", "restricted bank deposits" and "bank balances and cash" as set out in the consolidated statement of financial position.

Available-for-sale financial assets

Non-derivative financial assets that do not qualify for inclusion in any of the other categories of financial assets are classified as available-forsale financial assets. They are included in non-current assets unless the investment matures or management intends to dispose of it within 12 months after the reporting date.

For available-for-sale investments in equity securities that do not have a quoted market price in an active market and whose fair value cannot be reliably measured and derivatives that are linked to and must be settled by delivery of such unquoted equity instruments, they are measured at cost less any identified impairment losses at each reporting date subsequent to initial recognition.

Regular way purchases and sales of financial assets are recognised on the trade-date – the date on which the Group commits to purchase or sell the asset. Investments are initially recognised at fair value plus transaction costs for all financial assets not carried at fair value through profit or loss. Financial assets are derecognised when the rights to receive cash flows from the investments have expired or have been transferred and the Group has transferred substantially all risks and rewards of ownership.

At each reporting date, financial assets are reviewed to assess whether there is objective evidence of impairment. If any such evidence exists, impairment loss is determined and recognised based on the classification of the financial asset.

貸款及應收款項

可供出售的金融資產

可供出售股權投資如於活躍市場上並無市場報價及其公允值不能可靠計量,以及與此等無報價股本工具掛鈎並必須通過交付此等無報價股本工具以進行結算之衍生工具,則於初步確認後的各期末日按成本減去任何已識別減值虧損計量。

金融資產之一般買賣於交易日期確認 (即本集團承諾購買或銷售該資產當日)。所有並非按公允價值透過損益列 賬之金融資產投資按公允價值加交易成本予以初步確認。當投資所收取現金流量之權利屆滿或已轉讓及本集團已將所有風險及回報之擁有權轉讓時,金融資產會被終止確認。

金融資產均於每個期末日被檢討以評估 會否有客觀證據證明減值需要。若存在 其證據,產生的減值虧損將根據其金融 資產的分類進行釐定及確認。

The Group's financial liabilities include "trade payables", "other payables and accruals", "contingent consideration payable", "liability component of convertible bonds" and "bank borrowings". They are included in the consolidated statement of financial position as trade payables, other payables and accruals, contingent consideration payable and borrowings.

Financial liabilities are recognised when the Group becomes a party to the contractual provisions of the financial instruments. All interest related charges are recognised in accordance with the Group's accounting policy for borrowing costs (see Note 3(w)).

A financial liability is derecognised when the obligation under the liability is discharged or cancelled or expires.

Where an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and the recognition of a new liability, and the difference in the respective carrying amount is recognised in profit or loss.

Trade payables and other payables and accruals

They are recognised initially at fair value, net of transaction costs incurred and subsequently measured at amortised cost, using the effective interest method.

Borrowings

They are recognised initially at fair value, net of transaction costs incurred. Borrowings are subsequently stated at amortised cost; any difference between the proceeds (net of transaction costs) and the redemption value is recognised in profit or loss over the period of the borrowings using the effective interest method.

They are classified as current liabilities unless the Group has an unconditional right to defer settlement of the liability for at least 12 months after the reporting date.

應付貿易款項及其他應付款項及應計費 用

各項均以公允價值扣除所產生之交易成 本以初始確認,其後利用實際利率法按 攤銷成本計量。

借貸按公允價值(扣除所產生的交易成本)予以初始確認。借貸其後按攤銷成本列賬:所得款項(扣除交易成本)與贖回價值的任何差額於借貸期間採用實際利率法在損益中確認。

Contingent consideration payable

Contingent consideration payable is classified as financial liability and is subsequently remeasured to fair value with changes in fair value recognised in profit or loss.

Convertible bonds

Convertible bonds that can be converted to equity share capital at the option of the holder, where the number of shares that would be issued on conversion and the value of the consideration that would be received at that time do not vary, are accounted for as compound financial instruments which contain a liability component, a derivative component and an equity component.

Convertible bonds issued by the Group that contain both financial liability and equity components are classified separately into respective liability, derivative and equity components on initial recognition. On initial recognition, the fair value of the liability component is determined using the prevailing market interest rate for similar non-convertible debts. The difference between the proceeds of the issue of the convertible bonds and the fair value assigned to the liability component, representing the call option for conversion of the convertible bonds into equity, is included in equity as convertible bonds reserve.

The liability component is subsequently carried at amortised cost using the effective interest method. The equity component will remain in equity until conversion or redemption of the bond.

When the convertible bond is converted, the equity component of convertible bond and the carrying value of the liability component at the time of conversion are transferred to share capital and share premium as consideration for the shares issued. If the bond is redeemed, the convertible bonds reserve is released directly to retained profits.

Financial assets and liabilities are offset and the net amount reported in the consolidated statement of financial position when there is a legally enforceable right to offset the recognised amounts and there is an intention to settle on a net basis or realise the asset and settle the liability simultaneously.

應付或然代價

應付或然代價分類為金融負債,及於其後按公允價值重新計量,有關之公允價值變動則在損益中確認。

可換股債券

當可換股債券的持有人可以選擇將該債券轉換成權益性股本,而轉換的股票數量和轉換對價隨後不會變動,則可換股債券按照包含負債部分、衍生部分和權益部分的混合金融工具進行會計處理。

本集團所發行包含財務負債及權益部分 之可換股債券,於初步確認時乃分別列 入負債、衍生工具及權益部分。於初步 確認時,負債部分之公允價值按類似之 非可換股負債之現行市場利率釐定。發 行可換股債券所得款項與分配為負債部 分公允價值之差額為將可換股債券轉換 為權益之認購期權,乃於權益列為可換 股債券儲備。

負債部分於其後使用實際利息法按攤銷 成本列賬。股權部分將一直列於權益 內,直至轉換或贖回債券為止。

當轉換債券時,於轉換之時可換股債券 之股權部份及負債部分之賬面值撥入股 本及股份溢價賬,作為已發行股份之代 價。倘債券被贖回,可換股債券儲備直 接撥回至保留溢利。

倘本公司擁有抵銷已確認金額之法定權利及 有意按淨值基準償付或將資產變現並同時償 付負債,則金融資產及負債可作抵銷及於綜 合財務狀況表內以淨額呈報。

(I) Impairment of financial assets

The Group assesses at each reporting date whether there is objective evidence that a financial asset or group of financial assets, other than those at fair value through profit or loss, is impaired. A financial asset or a group of financial assets is impaired and impairment losses are incurred only if there is objective evidence of impairment as a result of one or more events that occurred after the initial recognition of the asset (a "loss event") and that loss event (or events) has an impact on the estimated future cash flows of the financial asset or group of financial assets that can be reliably estimated.

Evidence of impairment may include indications that the debtors or a group of debtors is experiencing significant financial difficulty, default or delinquency in interest or principal payments, the probability that they will enter bankruptcy or other financial reorganisation, and where observable data indicate that there is a measurable decrease in the estimated future cash flows, such as changes in arrears or economic conditions that correlate with defaults.

For loans and receivables carried at amortised cost, the amount of the loss is measured as the difference between the asset's carrying amount and the present value of estimated future cash flows (excluding future credit losses that have not been incurred) discounted at the financial asset's original effective interest rate. The asset's carrying amount is reduced and the amount of the loss is recognised in profit or loss.

If, in a subsequent period, the amount of the impairment loss decreases and the decrease can be related objectively to an event occurring after the impairment was recognised (such as an improvement in the debtor's credit rating), the reversal of the previously recognised impairment loss is recognised in profit or loss.

For unquoted equity securities carried at cost, the impairment loss is measured as the difference between the carrying amount of the financial asset and the estimated future cash flows, discounted at the current market rate of return for a similar financial asset where the effect of discounting is material. Impairment losses for equity securities carried at cost are not reversed.

(I) 金融資產之減值

本集團於各期末日評估有否客觀證據證明一項金融資產或一組金融資產(以公允價值透過損益列賬的除外)已減值。當有客觀證據顯示於初步確認資產後曾發生一宗或多宗導致減值的事件(「虧損事件」),而該宗或該等虧損事件對該項金融資產或該組金融資產之估計未來現金流量構成能可靠地估計之影響,則該項金融資產或該組金融資產已減值及產生減值虧損。

減值跡象可包括一名或一組借款人正面臨重 大財務困難、違約或未能償還利息或本金、 彼等將有可能破產或進行其他財務重組,以 及有可觀察數據顯示估計未來現金流量出現 可計量減少,例如欠款數目變動或出現與違 約相關的經濟狀況。

按攤銷成本列賬之貸款及應收款項,虧損金額按資產賬面金額與估計未來現金流量(不包括未產生之未來信貸虧損)並經該金融資產原有實際利率貼現之差額計量。資產之賬面金額會被減少,虧損金額於損益內確認。

若在其後期間,減值虧損之金額減少,而該減少是可客觀地與確認減值後發生之事件相關(例如債務人信貸評級有所改善),則之前確認之減值虧損之撥回會於損益內確認。

就以成本列賬的非上市權益證券而言,減值 虧損是以金融資產的賬面值與以類似金融資 產的當前市場回報率貼現(如果貼現會造成 重大的影響)的預計未來現金流量之間的差 額計量。按成本列賬的權益證券的減值虧損 不可轉回。

(m) Derivative financial instruments

Derivative financial instruments, in individual contracts or separated from hybrid financial instruments, are initially recognised at fair value on the date the derivative contract is entered into and subsequently remeasured at fair value. Derivatives that are not designated as hedging instruments are accounted for as financial assets or financial liabilities at fair value through profit or loss. Gains or losses arising from changes in fair value are taken directly to profit or loss for the year.

(n) Inventories

Inventories comprise goods held for resale and goods pending for customers' acceptance and are stated at the lower of cost and net realisable value. Cost is determined using the first-in, first-out method. Net realisable value is the estimated selling price in the ordinary course of business, less applicable variable selling expenses.

(o) Trade and other receivables

Trade receivables are amounts due from customers for merchandise sold or services performed in the ordinary course of business. If collection of trade and other receivables is expected in one year or less (or in the normal operating cycle of the business if longer), they are classified as current assets. If not, they are presented as non-current assets.

Trade and other receivables are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method, less provision for impairment. See note 3(k)(i) for further information about the Group's accounting policies for trade receivables and note 3(l) for a description of the Group's impairment policies.

(p) Cash and cash equivalents

In the consolidated statement of cash flows, cash and cash equivalents includes cash on hand, deposits held at call with banks with original maturities of three months or less, and bank overdrafts.

(q) Share capital

Ordinary shares are classified as equity. Incremental cost directly attributable to the issue of new shares or options are shown in equity as deduction, net of tax, from the proceed.

(r) Trade and other payables

Trade and other payables are obligations to pay for goods or services that have been acquired in the ordinary course of business from suppliers. Trade and other payables are classified as current liabilities unless payment is not due within 12 months after the reporting period.

Trade and other payables are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method.

(m)衍生金融工具

衍生金融工具(個別合約或與混合金融工具分開),於訂立衍生工具合約日按公允價值予以初步確認,隨後以公允價值重新計量。並非用來對沖的衍生工具列賬為按公允價值計入損益的金融資產或金融負債。公允價值的變動引致的獲利或虧損直接在該年的損益入賬。

(n) 存貨

存貨包括持作轉售之貨品及有待客戶接納之 貨品,以成本及可變現淨值兩者中之較低者 入賬。成本以先進先出法釐定。可變現淨值 為日常業務過程中之估計售價減適當可變銷 售開支計算。

(o) 應收貿易款項及其他應收款項

應收貿易款項為於日常業務過程中客戶就已售商品或已提供服務之欠款。倘應收貿易款項及其他應收款項預期可於一年或以內(或於正常業務週期內(如較長))收回,則獲分類為流動資產。不然以非流動資產呈列。

應收貿易款項及其他應收款項初步按公允價值確認,其後按實際利率法以攤銷成本計量,扣除減值撥備。關於本集團應收賬款的會計政策及減值政策的進一步資料,分別詳見附註 3(k)(i) 及附註 3(l)。

(p) 現金及現金等價物

在綜合現金流量表內,現金及現金等價物包括手頭現金、原定期限於三個月或以內之存放於銀行之通知存款及銀行誘支。

(q) 股本

普通股乃分類為權益。因發行新股份或股份 期權而直接產生的增量成本於權益內列作所 得款的扣減項目(扣除稅項)。

(r) 應付貿易款項及其他應付款項

應付貿易款項及其他應付款項為於日常業務 過程中向供應商購入之貨品或服務之付款責任。除非款項並非於期末日後十二個月內到期,應付貿易款項及其他應付款項會被分類 為流動負債。

應付貿易款項及其他應付款項初步按公允價值確認,其後按實際利率法以攤銷成本計量。

(s) Current and deferred income tax

The tax expense for the period comprises current and deferred tax. Tax is recognised in the consolidated statement of profit or loss, except to the extent that it relates to items recognised in other comprehensive income or directly in equity. In this case, the tax is also recognised in other comprehensive income or directly in equity, respectively.

(i) Current income tax

The current income tax charge is calculated on the basis of the tax laws enacted or substantively enacted at the reporting date in the places/ countries where the Company's subsidiaries and associates operate and generate taxable income. Management periodically evaluates positions taken in tax returns with respect to situations in which applicable tax regulation is subject to interpretation. It establishes provisions where appropriate on the basis of amounts expected to be paid to the tax authorities.

(ii) Deferred income tax

Deferred income tax is recognised, using the liability method, on temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the consolidated financial statements. However, deferred tax liabilities are not recognised if they arise from the initial recognition of goodwill, the deferred income tax is not accounted for if it arises from initial recognition of an asset or liability in a transaction other than a business combination that at the time of the transaction affects neither accounting nor taxable profit or loss. Deferred income tax is determined using tax rates (and laws) that have been enacted or substantively enacted by the reporting date and are expected to apply when the related deferred income tax asset is realised or the deferred income tax liability is settled.

Deferred income tax assets are recognised only to the extent that it is probable that future taxable profit will be available against which the temporary differences can be utilised.

Deferred income tax is provided on temporary differences arising on investments in subsidiaries and associates, except for deferred income tax liability where the timing of the reversal of the temporary difference is controlled by the Group and it is probable that the temporary difference will not reverse in the foreseeable future.

(iii) Offsetting

Income tax assets and liabilities are offset when there is a legally enforceable right to offset current tax assets against current tax liabilities and when the deferred income taxes assets and liabilities relate to income taxes levied by the same taxation authority on either the taxable entity or different taxable entities where there is an intention to settle the balances on a net basis.

(s) 即期及遞延所得税

本期間税項支出包括即期及遞延税項。税項 乃於綜合損益表確認,惟與在綜合其他全面 收益或直接在權益確認之項目有關者除外。 在此情況下,税項亦分別在綜合其他全面收 益或直接在權益確認。

(i) 即期所得税

即期所得稅開支以本公司之附屬公司及 其聯營公司之營運及產生應課稅收入 所在地/國家於期末日已頒佈或實質頒 佈之稅法為基準計算。管理層定期就適 用稅務規例須作出詮釋之情況評估報稅 單,並按預期支付予稅務機關之適當數 額計提合嫡之撥備。

(ii) 遞延所得税

遞延所得稅就資產及負債之稅基與綜合 財務報表所示賬面金額之間之暫時差 額,以負債法確認。然而,倘遞延稅項 負債於初步確認商譽時產生,則不獲確 認,倘遞延所得稅於交易(業務合併除 外)中初步確認資產或負債時產生及在 交易時不影響會計或應課稅損益,則不 交易時不影響會計或應課稅損益,則不 或實際實施,並以在變現有關遞延所得 稅資產或清償遞延所得稅負債時預期將 會適用之稅率(及法例)而釐定。

遞延所得税資產就可能有未來應課税盈 利而就此可使用暫時差異方會確認。

遞延所得稅就於附屬公司及聯營公司之 投資產生之暫時差異而撥備,惟其暫時 差異之撥回時間由本集團控制且在可預 見將來可能不會撥回之遞延所得稅負債 除外。

(iii) 抵銷

當存在法律上可執行權利以將即期稅項 資產抵銷即期稅項負債,以及當遞延所 得稅項資產及負債乃關於同一稅務機關 對應課稅實體或不同應課稅實體(而其 有意按淨額基準償付餘款)所徵收之所 得稅時,所得稅資產可抵銷負債。

(t) Provisions, contingent liabilities and financial guarantee contract

(i) Provisions

Provisions are recognised when the Group has a present legal or constructive obligation as a result of past events; it is probable that an outflow of resources will be required to settle the obligation; and the amount has been reliably estimated. Provisions are not recognised for future operating losses. Where there are a number of similar obligations, the likelihood that an outflow will be required in settlement is determined by considering the class of obligations as a whole. A provision is recognised even if the likelihood of an outflow with respect to any one item included in the same class of obligations may be small.

Provisions are measured at the present value of the expenditures expected to be required to settle the obligation using a pre-tax that reflects current market assessments of the time value of money and the risks specific to the obligation. The increase in the provision due to passage of time is recognised as interest expense.

(ii) Contingent liabilities

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future uncertain events not wholly within the control of the Group, are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

(iii) Financial guarantee contract

A financial guarantee contract is a contract that requires the issuer (or guarantor) to make specified payments to reimburse the holder for a loss it incurs because a specified debtor fails to make payment when due in accordance with the terms of a debt instrument.

Where the Group issues a financial guarantee, the fair value of the guarantee is initially recognised as deferred income within trade and other payables. Where consideration is received or receivable for the issuance of the guarantee, the consideration is recognised in accordance with the Group's policies applicable to that category of asset. Where no such consideration is received or receivable, an immediate expense is recognised in profit or loss on initial recognition of any deferred income.

(t) 撥備,或然負債及財務擔保合約

(i) 撥備

在出現以下情況時作出撥備:本集團因已發生之事件而產生現有之法律或推定責任:可能需要有資源流出以償付責任:及金額已經可靠估計。未來經營虧損概不作撥備。如有多項類似責任,其需要在償付中流出資源之可能性是根據責任之類別作整體考慮。縱使在同一責任類別所包含之任何一個項目相關之資源流出之可能性極低,仍須確認撥備。

撥備按預期履行責任所需開支之現值, 以可反映現時市場評估之貨幣時間價 值及責任之特定風險之稅前比率計量。 時間過去產生之撥備升幅確認為利息開 支。

(ii) 或然負債

如果經濟效益外流的可能性較低,或是 無法對有關數額作出可靠的估計,便 會披露為或然負債,資源外流的可能性 極低則除外。若果本公司的義務須視乎 某宗或多宗未來不明確和未能被公司全 權控制的事件是否發生才能確定是否存 在,亦會披露為或然負債,但資源外流 可能性極低的則除外。

(iii) 財務擔保合約

財務擔保合約乃規定發行人(或擔保人) 需作出特定款項以償付持有人蒙受損失 之合約,而發生損失之原因為指定債務 人未能按照債務工具條款於該債項到期 時作出款項。

倘本集團發行財務擔保,該擔保之公允 價值初始確認為貿易及其他應收款項內 之遞延收益。倘就發行擔保已收或應收 代價時,該代價將按適用於該資產類別 之本集團政策確認。倘並無已收或應收 有關代價,則任何遞延收益於初始確認 時將一筆即時開支於損益確認。

(iii) Financial guarantee contract (Continued)

The amount of the guarantee initially recognised as deferred income is amortised in profit or loss over the term of the guarantee as income from financial guarantees issued. In addition, provisions are recognised if and when it becomes probable that the holder of the guarantee will call upon the Group under the guarantee and the amount of that claim on the Group is expected to exceed the current carrying amount i.e., the amount initially recognised less accumulated amortisation, where appropriate.

(u) Revenue recognition

Revenue is measured at the fair value of the consideration received or receivable, and represents amounts receivable for goods supplied, stated net of discounts, returns and value added taxes. The Group recognises revenue when the amount of revenue can be reliably measured; when it is probable that future economic benefits will flow to the entity; and when specific criteria have been met for each of the Group's activities, as described below. The Group based on its estimates of return on historical results, taking into consideration the type of customer, the type of transaction and the specifics of each arrangement.

Revenue from sales of goods is recognised when significant risks and rewards of ownership of the goods are transferred to buyers (generally on delivery, satisfactory installation and customer acceptance) and the amount of revenue and the costs incurred for the transaction can be measured reliably.

Revenue from rendering of services, other than installation services and maintenance services, is recognised as revenue by reference to the stage of completion, provided that the revenue, the costs incurred and the estimated costs to completion can be measured reliably. Stage of completion is established by reference to the costs incurred to date as compared to the total costs to be incurred under the transaction. Provision is made for foreseeable losses as soon as they are anticipated by the management.

Where recognised profits less recognised losses exceed progress billings, the surplus is shown as amounts due from customers for contract work. Amounts received before the related work is performed are included in the consolidated statement of financial position, as a liability, as receipts in advance. The balances will be recognised as revenue when earned.

(t) 撥備,或然負債及財務擔保合約 (續)

(iii) 財務擔保合約(續)

初始確認為遞延收益之擔保金額按該擔保作為所發行財務擔保收益之年期內於損益攤銷。此外,倘當該擔保之持有人可能根據擔保要求本集團催繳款項,而向本集團追討之金額預期將超出目前賬面值(即初始確認之金額減累計攤銷)(倘情況適用),將確認撥備。

(u) 收益確認

收益乃按已收或應收代價之公允價值計量,即供應商品之應收款項(扣除折扣、退回及增值稅後列賬)。當收益金額可以可靠地計量、未來經濟利益將流入實體及符合如下文所述有關本集團活動之特定條件時,本集團確認收入。本集團根據其過往業績並考慮客戶類型、交易類型及各項安排之特性估計退回。

來自銷售貨物之收益於貨物所有權之重大風 險及回報轉移至買方(一般於交付、安裝妥 當及客戶接納時),以及交易所產生之收益 金額及成本能可靠地計算時確認。

有關來自提供服務(安裝服務及保養服務除外)之收益,乃參照完成之階段予以確認,惟所涉及之收益、成本以及估計完成交易所需之成本必須能夠以可靠之方法計算。完成之階段乃參照當時所產生之成本對比交易所產生之總成本而釐定。可預見虧損乃於管理層預期出現時即作出撥備。

倘已確認溢利減已確認虧損超逾工作進度 款,則有關溢額以合約工程應收客戶款項入 賬。進行相關工作前已收之款項會以預收收 益列入綜合財務狀況表內之負債。結餘將在 賺取時確認為收益。

(u) Revenue recognition (Continued)

Installation services are generally provided incidentally to the sale of a product, in which case they are recognised upon satisfactory installation and customer acceptance.

Maintenance service income is recognised on a straight line basis over the term of the maintenance service contract.

Rental income is recognised in the consolidated statement of profit or loss on a straight-line basis over the terms of the relevant leases.

Finance income implicit in finance lease is recognised as interest income over the period of the lease so as to produce an approximately constant periodic rate of return of the outstanding net investment in the leases for each accounting period.

Interest income is recognised using the effective interest method.

(v) Retirement benefit costs

The Group operates Mandatory Provident Fund Scheme (the "MPF Scheme") and other defined contribution retirement benefit plans for all qualifying employees. The MPF Scheme is established under the Mandatory Provident Fund Ordinance in December 2000. Contributions are made based on a percentage of the employees' basic salaries and are charged to the consolidated statement of profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme and other defined contribution retirement benefit plans are held separately from those of the Group, in funds under the control of trustees. The Group's contributions vest fully with the employees when contributed into the MPF Scheme and other defined contribution retirement benefit plans.

In addition, the Group offers a defined contribution retirement benefit plan under section 401(k) of the Inland Revenue Code of the United States for substantially all of its United States based employees who are eligible to participate in. The scheme is a qualified profit-sharing plan that allows employees to contribute a portion of their wages to individual accounts up to 60% of their eligible compensation, subject to the maximum allowed by Internal Revenue Service. The Group is not required to make contributions to the plan but can make discretionary contributions.

(u) 收益確認(續)

安裝服務通常連帶銷售產品提供,於此情況 下,其於成功安裝及客戶接納時確認。

保養服務收入以直線法於保養服務合約期內 確認。

租金收入按有關租期以直線法於綜合損益表內確認。

融資租賃隱含財務收入按租期確認為利息收入,以令每個會計年度期間剩餘之淨租賃投資定期回報率大致相同。

利息收入採用實際利息法進行確認。

(v) 退休福利成本

本集團為所有合資格僱員營辦一項強積金計劃(「強積金計劃」)及其他界定福利計劃。 強積金計劃乃於二零零零年十二月根據強制性公積金條例設立。供款乃按僱員基本薪金之某一百分比計算,並於根據強積金計劃之規則須支付時於綜合損益表中扣除。強積金計劃及其他界定福利計劃之資產由信託人控制之基金持有,與本集團資產分開存放。本集團向強積金計劃及其他界定福利計劃供款後,供款即全數撥歸僱員所有。

此外,本集團按美國《稅務法》第401(k)條, 為其絕大部分合資格參與並於美國定居的僱 員提供界定供款退休福利計劃。該計劃為合 資格溢利分享計劃,允許僱員按其合資格報 酬最多60%之薪金比例向個人賬戶進行供 款,該上限需經美國國家稅務局批准。本集 團無須向該計劃供款,惟可酌情作出供款。

(w) Borrowing costs

Borrowing costs incurred, net of any investment income earned on the temporary investment of the specific borrowings, for the acquisition, construction or production of any qualifying asset are capitalised during the period of time that is required to complete and prepare the asset for its intended use. A qualifying asset is an asset which necessarily takes a substantial period of time to get ready for its intended use or sale. Other borrowing costs are expensed when incurred.

Borrowing costs are capitalised as part of the cost of a qualifying asset when expenditure for the asset is being incurred, borrowing costs are being incurred and activities that are necessary to prepare the asset for its intended use or sale are being undertaken. Capitalisation of borrowing costs ceases when substantially all the activities necessary to prepare the qualifying asset for its intended use or sale are complete.

(x) Share-based payment

The fair value of services received were determined by reference to the fair value of shares and share options granted at the grant date and expensed on a straight-line basis over the vesting period or recognised as an expense in full at the grant date when the shares and share options granted vest immediately, with a corresponding increase in equity (share-based payment reserve).

At each reporting date, the Group revises its estimates of the number of shares and share options that are expected to ultimately vest. The impact of the revision of the estimates during the vesting period, if any, is recognised in the consolidated statement of profit or loss, with a corresponding adjustment to share-based payment reserve.

At the time when the share options are exercised, the amount previously recognised in share option reserve will be transferred to share premium. After vesting date, when the shares or share options are forfeited after the vesting date or are still not exercised at the expiry dates, the amount previously recognised in share-based payment reserve will be transferred to retained earnings.

(w)借貸成本

就收購、建造或生產任何合資格資產而產生 之借貸成本(扣除就特別借貸之暫時投資賺 取之任何投資收入),於完成及準備資產投 入其擬定用途所需期內撥充資本。合資格資 產乃指需要頗長時間方可達致其擬定用途或 出售的資產。其他借貸成本於產生時支銷。

當資產產生開支、借貸成本產生及就資產投入其擬定用途或出售而言屬必要的準備工作進行時,借貸成本乃撥充資本作為合資格資產成本之部分。當就合資格資產投入其擬定用途或出售而言屬必要的絕大部分準備工作完成時,借貸成本則停止撥充資本。

(x) 以股份為基礎支付之款項

所接收服務之公允價值乃參考於授出日期所 授出股份及購股權之公允價值而釐定,以直 線法於歸屬期內支銷,或倘授出之股份及購 股權立即歸屬,則於授出日期悉數支銷,並 於權益計入相應數額(以股份為基礎支付儲 備)。

於各期末日,本集團修訂其對預期將最終歸屬之股份及購股權數目之估計。估計變動於歸屬期(如有)之影響於綜合損益表確認,並對以股份為基礎支付儲備作出相應調整。

購股權獲行使時,過往於購股權儲備中確認之數額將轉撥至股份溢價賬。在歸屬日後,當股份或購股權於歸屬日後被沒收或於屆滿日期仍未行使,則過往於以股份為基礎支付儲備確認之金額將轉撥至保留盈利。

(y) Leases

An arrangement, comprising a transaction or a series of transactions, is or contains a lease if the Group determines that the arrangement conveys a right to use a specific asset or assets for an agreed period of time in return for a payment or a series of payments. Such a determination is made based on an evaluation of the substance of the arrangement and is regardless of whether the arrangement takes the legal form of a lease.

(i) Classification of assets leased to the Group

Assets that are held by the Group under leases which transfer to the Group substantially all the risks and rewards of ownership are classified as being held under finance leases. Leases which do not transfer substantially all the risks and rewards of ownership to the Group are classified as operating leases, with the following exceptions:

- property held under operating leases that would otherwise meet the definition of an investment property is classified as investment property on a property-by-property basis and, if classified as investment property, is accounted for as if held under a finance lease; and
- land held for own use under an operating lease, the fair value of which cannot be measured separately from the fair value of a building situated thereon at the inception of the lease, is accounted for as being held under a finance lease, unless the building is also clearly held under an operating lease. For these purposes, the inception of the lease is the time that the lease was first entered into by the Group, or taken over from the previous lessee.

(ii) Operating lease charges

Where the Group has the use of assets held under operating leases, payments made under the leases are charged to the consolidated statement of profit or loss in equal instalments over the accounting periods covered by the lease term, except where an alternative basis is more representative of the pattern of benefits to be derived from the leased asset.

The cost of acquiring land held under an operating lease is amortised on a straight-line basis over the period of the lease term except where the property is classified as an investment property.

(a) Critical accounting judgements in applying the Group's accounting policies

In the process of applying the Group's accounting policies, management has made the following accounting judgements:

(i) Provision for impairment of trade and other receivables

The provisioning policy for trade and other receivables of the Group is based on the evaluation of the collectability of those receivables and on management's judgement. A considerable amount of judgement is required in assessing the ultimate realisation of these receivables, including the current creditworthiness and the past collection history of each customer and the realisation of any repayment pattern promised. If the financial conditions of these customers were to deteriorate, additional provision may be required.

(ii) Income taxes

The Group is subject to income taxes in jurisdictions in which the Group operates. Significant judgement is required in determining the provision for income taxes. There are many transactions and calculations for which the ultimate tax determination is uncertain. The Group recognises liabilities for anticipated tax audit issues based on estimates of whether additional taxes will be due. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will impact the income tax and deferred tax provisions in the year in which such determination is made.

(b) Sources of estimation uncertainty

The Group makes estimates and assumptions concerning the future. The resulting accounting estimates will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are discussed below:

(i) Revenue recognition

According to the accounting policy as stated in Note 3(u), the Group uses the percentage of completion (the "POC") method to determine the appropriate revenues to be recognised from rendering of services (other than installation service and maintenance services). The stage of completion is measured by reference to the actual costs incurred up to the reporting date as a percentage of total estimated costs of completion. When the outcome of a POC contract cannot be estimated reliably, revenue is recognised only to the extent of contract costs incurred that it will be probably recoverable.

(ii) Valuation of investment properties, land and buildings

The best evidence of fair value is current prices in an active market for similar leases and other contracts. In the absence of such information, the Group determines the amount within a range of reasonable fair values estimated. In making its estimates, the Group considers the information from the valuations of investment properties and land and buildings performed by external professional valuers by using the market comparison approach. The market comparison approach is referenced to recent sale price of comparable properties on a price per square foot basis, adjusted for a premium or a discount specific to the quality and floor of the Group's buildings compared to the recent sales.

Had the Group used different valuation techniques, the fair value of the investment properties and land and buildings would be different and thus may have an impact to the consolidated statement of profit or loss.

At 31st December 2017, the carrying amount of the Group's land and buildings and investment properties carried at revalued amount/ fair value were HK\$271,950,000 (2016: HK\$262,500,000) and HK\$52,300,000 (2016: HK\$50,600,000) respectively.

(b) 估計不確性因素來源

本集團作出有關未來之估計及假設。顧名思義,所作會計估計甚少與有關之實際結果相同。存有重大風險導致下個財政年度之資產及負債之賬面值作出重大調整之估計和假設討論如下:

(i) 收益確認

根據附註 3(u) 所述之會計政策,本集團採用完工百分比(「完工百分比」) 法確定在提供服務(不包括安裝服務及維修服務) 時應確認之適當收益。完工比例參考截至期末日止已產生之實際成本佔完工之估計總成本之百分比計算。當完工百分比合約之結果不能以可靠方式估計,收益僅於合約成本產生及其將可能可收回之情況下確認。

(ii) 投資物業、土地及樓宇之估值

公允價值之最佳憑證為類似租賃及其他 合約於活躍市場中之現行價格。倘缺 乏有關資料,本集團將會把金額釐訂在 合理之公允價值估計範圍內。於作出估 計時,本集團考慮由外聘專業估值師以 市場比較法進行之投資物業、土地及樓 宇估值所得資料。市場比較法乃參考最 近可比較物業每平方尺之銷售價格而釐 定,並按本集團物業質量及樓層與最近 銷售比較作溢價或折扣調整。

倘本公司使用不同之估值方法,投資物業、土地及樓宇之公允價值將有所出入,而對綜合損益表可能構成影響。

於二零一七年十二月三十一日,本集團土地及樓宇以及投資物業按重估金額/公允價值列賬之賬面值分別為271,950,000港元(二零一六年:262,500,000港元)及52,300,000港元(二零一六年:50,600,000港元)。

(iii) Estimated impairment of interests in associates

An impairment exists when the carrying value of an asset or cash generating unit exceeds its recoverable amount, which is the higher of its fair value less costs of disposal and its value in use.

The value in use was determined based on the estimated present value of the estimated future cash flows expected to be generated by i-Sprint Holdings Limited and its subsidiaries ("i-Sprint Group"), including cash flows from the operations of i-Sprint Group and estimated terminal value. Based on the assessment, the recoverable amount of i-Sprint Group is lower than its carrying amount. Hence, an impairment loss of HK\$4,400,000 on the interests in i-Sprint Group was recognised in the consolidated statement of profit or loss during the year ended 31st December 2017.

(iv) Recognition of share-based payment expenses

The Company has granted share options to the Group's management and employees during the year ended 31st December 2017. The directors, with the assistance of an independent professional valuer, have used the Binomial Lattice Model to determine the total fair value of the options granted, which is to be expensed over the vesting period as appropriate. Significant estimate on assumptions, such as share price volatility and dividend yield, is required to be made by the directors in applying the Binomial Lattice Model. Details of share-based payment expenses are set out in Note 38.

(v) Valuation of identifiable assets and liabilities acquired through business combinations

The Group applies the acquisition method to account for business combinations, which requires the Group to recognise assets acquired and liabilities assumed at their fair values on the date of acquisition. Significant judgement is used to estimate the fair values of the assets and liabilities acquired, including estimating future cash flows from the acquired business, determining appropriate discount rates and other assumptions.

The acquisition of Grid Dynamics Group during the year ended 31st December 2017 is accounted for as business combination and details of the fair value of the assets acquired and liabilities recognised at the date of acquisition are set out in Note 39.

(iv) 確認以股份為基礎支付之開支

本公司於截至二零一七年十二月三十一日止年度授予本集團管理層及員工購股權。董事在獨立專業估值師的協助下已採用二項式期權定價模型確定了授出的購股權的公允價值總額,其將於歸屬期內列支(如適用)。董事於採用二項式期權定價模式時需就股份價格波動及股息率等假設作出重大估計。以股份為基礎支付之開支之詳情載於附註38。

(v) 通過業務合併取得的可識別資產和負債 的估值

本集團採用收購法對業務合併進行會計處理,該等法規要求本集團於收購日期以公允價值確認所收購資產及所承擔負債。重大判斷用於估計所收購資產和負債的公允價值,包括估計所收購業務的未來現金流量,確定適當的貼現率和其他假設。

截至二零一七年十二月三十一日止年度,收購Grid Dynamics集團之事項已作為業務合併入賬,於收購日期所收購資產及確認負債之公允價值詳情載於附註39。

(vi) Estimated impairment of goodwill and intangible assets

The Group determined whether goodwill is impaired at least on an annual basis, while for the acquired intangible assets, technical know-how and customer relationship with finite useful lives, they are tested for impairment whenever there are indications that the asset's carrying amount may not be recoverable. This requires an estimation of the value in use of the cash-generating units to which goodwill and the acquired intangible assets are allocated. Estimating the value in use requires the Group to estimate the future cash flows expected to arise from the cash-generating unit and a suitable discount rate in order to calculate present value of those cash flows. Details of goodwill and intangibles assets are set out in Note 21.

(vii) Valuation of contingent consideration payable

For acquisitions accounted for under HKFRS 3, future anticipated payments to vendors in respect of earnouts are based on the management's best estimates of future obligations, which are dependent on future performance of the interests acquired and assume the operating companies improve profits in line with management's estimates and are included in liabilities greater or less than one year as appropriate. These estimates will likely differ from future actual results of operations and cash flows, and it is possible that these differences could be material. Changes to earnouts are recorded in the profit or loss. Details of contingent consideration payable are set out in Notes 6(d) and 39.

5. CAPITAL RISK MANAGEMENT

The Group manages its capital to ensure that entities within the Group will be able to continue as a going concern while maximising the return to stakeholders through the optimisation of the debt and equity balance.

The capital structure of the Group consists of equity attributable to equity holders of the Company, comprising issued capital, reserves and retained earnings as disclosed in the consolidated statement of changes in equity.

The directors of the Company review the capital structure periodically. As part of this review, the directors of the Company prepare the annual budget taking into account of the provision of funding. Based on the proposed annual budget, the directors of the Company consider the cost of capital and the risks associated with each class of capital. Based on recommendations of the management of the Group, the Group will balance its overall capital structure through the payment of dividends, new share issues, bank borrowings and share buy-backs as well as the issue of new debt or the redemption of existing debt, if necessary.

(b) 估計不確性因素來源(續)

(vi) 商譽和無形資產的估計減值

本集團至少每年釐定商譽是否發生減值,而對於具有限可使用年期之收購的無形資產,包括技術知識以及客戶關係,在有跡象表明該資產的賬面值可能無法收回時進行減值測試。這需要估計已獲分配商譽和所收購無形資產的現金產生單位的使用價值。估計使用價值需要本集團估計預期由現金產生單位產生的未來現金流量及適當貼現率以計算該等現金流量的現值。商譽和無形資產的詳情載於附註21。

(vii) 應付或然代價之估值

對於根據香港財務報告準則第3號入賬的收購事項,就獲利能力付款方案預計日後支付予賣方的款項乃基於管理層對未來責任的最佳估計,視乎所收購權益的未來表現及假設經營公司之溢利按管理層估計而改善,及計入多於或少於一年的負債(倘適當)。該等估計很可能與日後實際經營業績及現金流不同,且該等差異可能重大。獲利能力付款方案的變更於損益中入賬。應付或然代價之詳情載於附註6(d)及39。

本集團管理其資本乃為確保本集團之實體有能力 持續經營,並通過優化債務及權益平衡,盡量增 大股東之回報。

本集團之資本結構包括股權持有人應佔本公司之權益,並由已發行股本、儲備及保留盈利構成,該等項目於綜合權益變動表內披露。

本公司董事定期檢討其資本結構。作為檢討其中 一環,本公司董事在顧及資金撥備下編製年度預 算。根據所提交之年度預算,本公司董事考慮資 本成本及連同每個資本類別之風險。根據本集團 管理層之建議,本集團將通過支付股息、發行新 股份、銀行借貸及購回股份及在有需要時另行舉 借或償還現有債務,以平衡整體資本結構。

6. FINANCIAL RISK MANAGEMENT AND FAIR VALUE MEASUREMENT

The Group's activities expose it to a variety of financial risks: market risk (including foreign exchange risk and interest rate risk), credit risk, and liquidity risk. The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

(a) Market risk

(i) Foreign exchange risk

The Group mainly earns revenue and incurs costs in HKD and United States dollars ("USD"). Foreign exchange exposure to USD of the Group will continue to be minimal as long as the policy of the Government of the Hong Kong Special Administrative Region to peg the HKD to the USD remains in effect. There was no material exposure to fluctuations in exchange rates, and therefore no related hedging financial instrument was applied during the year ended 31st December 2017 and 2016.

(ii) Interest rate risk

The Group's exposure to interest rate risk mainly concentrated on the fluctuation in relations to variable interest rate on bank balances and bank borrowings. The Group currently does not have any interest rate hedging policy.

The sensitivity analysis below have been determined based on the exposure to interest rates for non-derivative instruments including bank balances and bank borrowings, at the reporting date and the stipulated change taking place at the beginning of the financial year and held constant throughout the reporting period in the case of instruments that have floating rates. A 50 basis point increase or decrease is used when reporting interest rate risk internally to key management personnel and represents management's assessment of the reasonably possible change in interest rate.

本集團之業務承受多種財務風險:市場風險(包括外匯風險及利率風險)、信貸風險及流動性風險。本集團之整體風險管理政策集中關注難以預測之金融市場,並致力將對本集團財務表現造成之潛在不利影響減至最低。

(a) 市場風險

(i) 外匯風險

本集團賺取之收益及產生之成本主要為港元及美元(「美元」)。倘香港特別行政區政府一直維持港元與美元掛鈎政策,則本集團所承受對美元之外匯風險水平將維持輕微。截至二零一七年及二零一六年十二月三十一日止年度,並無重大匯率波動之風險,因此並無應用相關對沖金融工具。

(ii) 利率風險

本集團之利率風險,主要集中在銀行結 餘及銀行借貸之相關浮動利率波幅。本 集團現時並無任何利率對沖政策。

以下敏感度分析乃按非衍生工具(包括銀行結餘及銀行借貸)於期末日所面臨之利率風險,以及於財政年度開始時已規定之變動及(若為以浮動利率計息之工具)於整個報告期間內以劃一利率計息為基準。50點子之增減乃內部向主要管理人員匯報利率風險時所用,即管理層就利率之合理可能變化所作評估。

If interest rates had been 50 basis points higher/lower and all other variables were held constant, the Group's profit for the year ended 31st December 2017 would decrease/increase by approximately HK\$565,000 (2016: increase/decrease by approximately HK\$935,000). This is mainly attributable to the Group's exposure to interest rates on its variable-rate bank borrowings and bank balances.

(b) Credit risk

Credit risk was managed on a group basis. Credit risk arises from bank balances and cash, restricted bank deposits, as well as credit exposures to customers, including outstanding receivables and committed transactions. The Group only places deposits in reputable banks and financial institutions and manages its credit risk associated with trade receivable through the application of credit approvals, credit rating and monitoring procedures.

In order to minimise the credit risk, the management of the Group has delegated a team responsible for determination of credit limits, credit approvals and other monitoring procedures to ensure that follow-up action is taken to recover overdue trade receivables. In addition, the Group reviews the recoverable amount of each individual trade debt at the end of each reporting date to ensure that adequate impairment losses are made for irrecoverable amounts. In this regard, the directors of the Company consider that the Group's credit risk is significantly reduced.

The Group has no significant concentration of credit risk in relation to trade receivables, bank balances and deposits, with exposure spread over a number of counterparties and customers.

The maximum exposure to credit risk is represented by the carrying amount of each financial asset (Note 24) in the consolidated statement of financial position after deducting any impairment provision.

(c) Liquidity risk

Ultimate responsibility for liquidity risk management rests with the Board, which has built a liquidity risk management framework for the management of the Group's short, medium and long-term funding and liquidity management requirements. The Group manages liquidity risk by maintaining adequate reserves and banking facilities by continuously monitoring forecast and actual cash flows and matching the maturity profiles of financial assets and financial liabilities. The Group relies on its operating cash flows as a significant source of liquidity.

During the year ended 31st December 2017, amortisation of approximately HK\$7,304,000 (2016: HK\$1,668,000) has been charged to "cost of services rendered" in the consolidated statement of profit or loss.

Goodwill is attributable to the Group's cash-generating units ("CGUs") of the Grid Dynamics Group and is allocated to the IT Services operating segment.

The recoverable amount of the CGU was determined from value in use calculations based on cash flow projections from formally approved financial budgets and forecasts covering a five-year period. The cash flows for the subsequent years are extrapolated from the fifth year cash flow using 2.2% growth rate, and discounted using a pre-tax discount rate of 19.45%.

The discount rate reflects current market assessment of the time value of money and the risks specific to the CGU. The growth rate used was based on historical growth and past experience and did not exceed the long-term average growth rate for the business in which the CGU operates.

The recoverable amount has been determined to be higher than the carrying amount of the CGU, and thus no impairment is required.

Such bank borrowings were fully repaid during the year ended 31st December 2017.
- (b) During the year ended 31st December 2017, the Group obtained a banking facility in relations to a term loan of HK\$250,000,000 to finance the acquisition of Grid Dynamics Group as detailed in Note 39. As at 31st December 2017, bank borrowings of approximately HK\$247,800,000 (2016: Nil) are repayable by five semi-annually instalments commencing from 29th March 2018 to 20th February 2020 and bears interest at floating rates. The bank borrowings are denominated in HKD with an effective interest rate of 4.42% (2016: Nil) per annum as at 31st December 2017.

As at 31st December 2017, the bank borrowings are secured by the followings:

- the legal charges over the Group's land and buildings with carrying amount of HK\$271,950,000 (2016: Nil) (Note 46);
- the legal charges over the Group's investment properties with carrying amount of HK\$52,300,000 (2016: Nil) (Note 46);
- (3) the guarantee given by the Company and certain subsidiaries of the Group up to a limit of HK\$250,000,000;
- (4) assignment of rental and sales proceeds from the Group's land buildings and investment properties; and
- (5) assignment of insurance of all insurance policies (other than third party liabilities and public liabilities) over the Group's land buildings and investment properties.

The banking facilities of term loan is subject to the fulfillment of certain financial and non-financial covenants relating to certain subsidiaries of the Group as are commonly found in lending arrangements with financial institutions. If the Group was to breach the covenants, the drawn down facilities would become repayable on demand

The Group regularly monitors its compliance with these covenants, is up to the date with the scheduled repayments of the loans and does not consider it probable that the banks will exercise its discretion to demand repayment for so long as the Group continues to meet these requirements.

Subject to repayment on demand clauses which can be exercised at the banks' sole discretion, the above bank borrowings are classified as current liabilities as at 31st December 2017 and 2016.

On 21st March 2017, the Group issued HKD denominated zero coupon convertible bonds of a principal amount of HK\$350,000,000 (the "Convertible Bonds").

At the issue date, the Convertible Bonds can be converted into 291,666,666 shares (the "Conversion Shares") at the initial conversion price of HK\$1.20 per share (subject to adjustment). As a result of the bonus issue on 8th June 2017 as detailed in Note 32(iv), the number of shares falling to be allotted and issued upon conversion of the Convertible Bonds and the conversion price of the Convertible Bonds have been adjusted to 321,100,917 shares and HK\$1.09 per share respectively, pursuant to the terms of conditions of the Convertible Bonds.

The Convertible Bonds are convertible during the period commencing from the 90th day after the date of issue of the Convertible Bonds and ending on the 5th business day prior to the maturity date of the Convertible Bonds on 21st March 2020 (the "Maturity Date"). Unless previously purchased or converted for Conversion Shares, the Company shall on the Maturity Date redeem the outstanding principal amount of the Convertible Bonds together with the accrued return of 3% internal rate of return per annum.

Early redemption at the option of the Company and the Bondholder

The Company and the bondholder have the right to redeem the Convertible Bonds early in the event that the completion of the acquisition of Grid Dynamics Group does not take place in accordance with its terms, the Company shall have the right to redeem and the bondholder shall have the right to require redemption of the Convertible Bonds outstanding before the Maturity Date (the "Early Redemption Option") at its principal amount outstanding plus 6% internal rate of return per annum. The acquisition of Grid Dynamics Group was completed on 7th April 2017 and the Early Redemption Option expired on that date.

The conversion option embedded in the Convertible bonds meet the definition of equity instrument of the Company, and is classified as equity and included in the convertible bonds reserves. Under the 2002 Share Option Scheme, the directors of the Company may grant options to eligible employees, including directors of the Company and its subsidiaries, to subscribe for shares in the Company. The total number of shares in respect of which options may be granted under the 2002 Share Option Scheme is not permitted to exceed 10% of the shares of the Company in issue at any point in time. The total number of shares in respect of which options may be granted to any individual in any one year is not permitted to exceed 1% of the shares of the Company in issue at any point in time.

Options granted must be taken up within 28 days of the date of offer, upon payment of HK\$1 as consideration per grant. There is no general requirement that an option must be held for any minimum period before it can be exercised but the directors of the Company are empowered to impose at its discretion any such minimum period at the time of grant of any particular option. The period during which an option may be exercised will be determined by the directors of the Company at its absolute discretion, save that no option may be exercised more than 10 years after it has been granted.

The exercise price is determined by the directors of the Company, and will not be less than the higher of (a) the closing price of the shares on the Stock Exchange on the date of grant of the options; (b) the average of the closing prices of the shares on the Stock Exchange for the five trading days immediately preceding the date of grant of the options; and (c) the nominal value of a share. The 2002 Share Option Scheme expired on 7th August 2012.

On 16th December 2016, the Company, GDD International Holding Company and GDD International Merger Company, indirect wholly-owned subsidiaries of the Company, entered into an agreement and plan of merger ("Merger Agreement") with Grid Dynamics and BGV II, LP, the representative of the holders of the shares or vested options of Grid Dynamics (the "Securityholders Representative"), pursuant to which the Group agreed to acquire the entire share capital of Grid Dynamics Group (the "Acquisition"). Details of the Acquisition are set out in the Company's circular dated 6th March 2017 and the Acquisition was completed on 7th April 2017 (the "Completion Date").

The transaction was made as part of the Group's strategy to provide third platform technologies, including cloud, mobile, big data and analytics and social business and to expand the Group's geographical coverage beyond Asia Pacific.

Pursuant to the terms of the Merger Agreement, the total consideration for the Acquisition (the "Purchase Consideration") are as follows:

(a) Cash consideration

A purchase price of approximately US\$100,000,000 plus certain adjustments based on the net asset value on Completion Date, to be paid by the Company in cash, US\$2,000,000 of which will be paid on or before the first anniversary of the Completion Date; and

(b) Contingent Consideration

An earnout payment in the sum of up to US\$18,000,000 to be paid by the Company in cash and in two instalments with each instalment to be paid no later than 10 business days following the date upon which the determination of the earnout payment for each earnout period becomes final and binding upon the Company and the Securityholders Representative, subject to Grid Dynamics Group meet with the agreed revenue target and profit before tax target in respect of each relevant earnout period.

The transaction costs of approximately HK\$9,025,000 have been expensed and are included in administrative expenses in the consolidated statement of profit or loss for the year ended 31st December 2017, and the remaining portion of approximately HK\$5,575,000 are included in administrative expenses in the consolidated statement of profit or loss for the year ended 31st December 2016.

Since the Acquisition, Grid Dynamics Group contributed approximately HK\$411,445,000 to the Group's revenue and profit before income tax of approximately HK\$74,130,000 to the Group for the year ended 31st December 2017

Had the Acquisition been effected at the beginning of the year, the total amount of revenue and profit before income tax of Grid Dynamics Group for the year ended 31st December 2017 would have been approximately HK\$2,052,922,000 and HK\$93,971,000, respectively. The pro forma information is for illustrative purposes only and is not necessarily an indication of revenue and results of the operations of the Group that actually would have been achieved had the acquisition been completed at the beginning of the year, nor is it intended to be a projection of future results.

Depending on the upcoming financial performance of Grid Dynamics Group, the contingent consideration payable for the Acquisition may range from nil to USD18,000,000. The potential undiscounted amount of all future payments that the Group could be required to make under this arrangement can be up to USD18,000,000. The fair value of the amount payable of approximately USD17,075,000 (equivalent to approximately HK\$132,670,000) was recognised as contingent consideration payable on the Completion Date. The amount was estimated based on an assumed probability weighting in fulfilling the performance requirements, using a discount rate of 3.18%. During the year ended 31st December 2017, fair value change of approximately USD413,000 (equivalent to approximately HK\$3,221,000) was recognised in the consolidated statement of profit or loss for the contingent consideration.

As at 31st December 2017, the purchase consideration for cash and contingent components of approximately USD6,276,000 (equivalent to approximately HK\$49,057,000) and approximately USD17,488,000 (equivalent to approximately HK\$136,691,000) remained unpaid, of which HK\$49,057,000 was included in other payables and accruals and HK\$69,429,000 and HK\$67,262,000 was included in current and non-current portion of contingent consideration payable, respectively.
