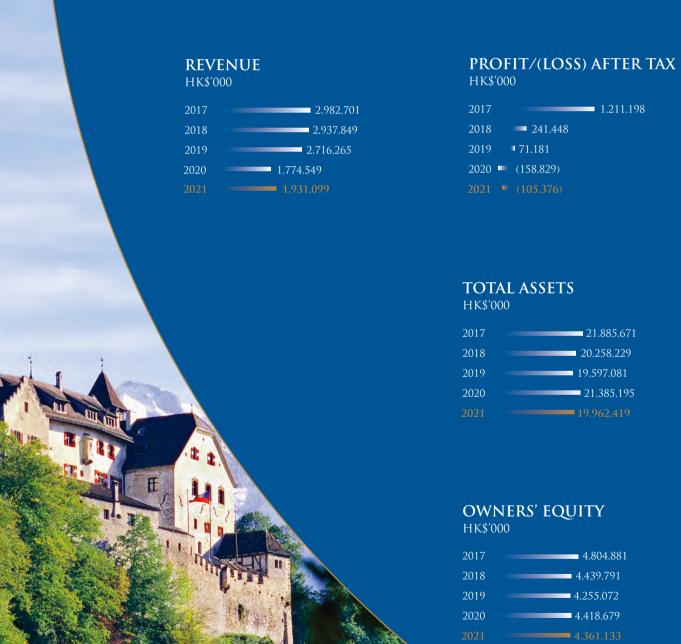

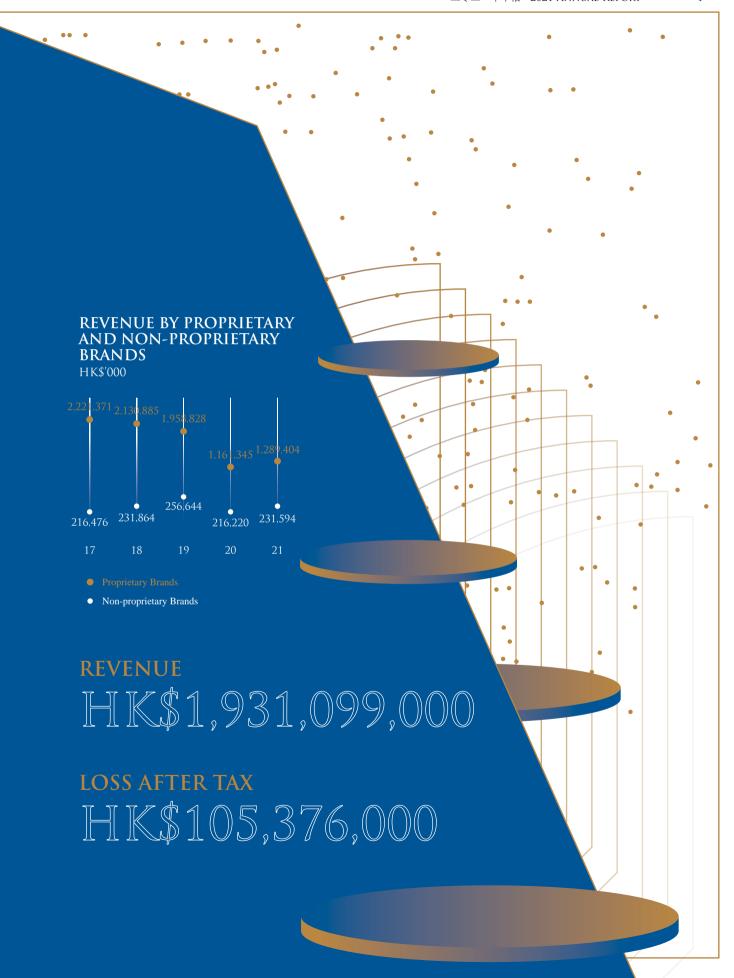

# FINANCIAL HIGHLIGHTS







THE COVID-19 IS ONE OF THE WORST DISASTERS EVER IN HUMAN HISTORY. 2021 CONTINUES TO BE AN EXCEPTIONALLY CHALLENGING YEAR NOT ONLY FOR HEALTH OF PEOPLE ALL OVER THE WORLD BUT ALSO FOR ECONOMIC ACTIVITIES OF ALL NATIONS. THE COVID-19 HAS DISRUPTED NUMEROUS INDUSTRIES THAT SUFFER FROM SHARP FALLS IN PRODUCTION AND DEMAND, AND GLOBAL SUPPLY CHAIN CRISIS, OWING TO SOCIAL DISTANCING MEASURES, LOCK-DOWNS AND TRAVEL RESTRICTIONS. IT PARTICULARLY AFFECTS ADVERSELY THE CONSUMPTION.

One of the key upwind favourable factors is that Mainland China has been proven relatively successful in bringing the COVID-19 under control in 2021. By many indicators, Mainland China's economic performance in 2021 was relatively stronger than 2020 and the rest of the world.

FACING THIS UNPRECEDENTED CRISIS, WE HAVE DEMONSTRATED RESILIENCE, SOMETHING WE OWE TO THE REMARKABLE EFFORTS OF OUR DIRECTORS AND KEY MANAGERS. WE HAVE ADOPTED A NEW MINDSET AND TAKE THIS AS THE MOST IMPORTANT OPPORTUNITY AND LESSON THAT WE SHOULD LEARN AND IMPROVE FROM. WE HAVE REVIEWED THE PROCESSES, PROCEDURES, AND STRUCTURE OF OPERATIONS IN ORDER TO STREAMLINE WORKFLOW AND WORKFORCE, AND STRENGTHEN E-COMMERCE, VIRTUAL COMMUNICATION AND DIGITAL TRANSFORMATION AS A WHOLE TO ENHANCE EFFICIENCY AND EFFECTIVENESS, AS WELL AS TAKEN DECISIVE DECISIONS PARTICULARLY RELATED TO HUMAN RESOURCES TO ACHIEVE COST SAVINGS ACROSS THE GROUP. MOST IMPORTANTLY, WE MANAGE TO TAKE ALL NECESSARY MEASURES TO ENSURE THE BUSINESS CONTINUITY OF DIFFERENT BUSINESSES IN DIFFERENT COUNTRIES AND TO MAINTAIN THE HEALTH AND SAFETY OF ALL OUR COLLEAGUES, THAT IS UNDOUBTEDLY ONE OF THE MOST VALUABLE RESOURCES OF THE GROUP.

# CHAIRMAN'S STATEMENT

# **RESULTS OVERVIEW**

The distresses of the COVID-19 exacerbated competitive pressures inherent in our watch industry, making this one of the toughest operating environments in recent times. Against this backdrop, our net loss for FY2021 decreased by 34% from HK\$158 million for FY2020.

Revenue increased by 9% to HK\$1.93 billion in 2021, versus HK\$1.77 billion generated in 2020. Loss attributable to the owners of the Company in 2021 decreased to HK\$101 million, which was HK\$68 million or 40.4% lower than HK\$169 million loss in 2020. Basic loss per share were HK\$2.32 cents.

The Board resolved not to recommend a final dividend for the year ended 31 December 2021 to preserve sufficient funds to meet the financial needs of the Group.

# STRATEGIC DEVELOPMENT

The transaction to sell our equity interests in and loans to all watch companies except Ernest Borel, was mutually terminated due to the continuously variated COVID-19 and the change of business planning and strategy of the purchaser. As such, the watch business remains in the Group and continues to be a major business of the Group.

# BUSINESS AND MARKET DEVELOPMENT

In 2021, despite the challenging period, the local proprietary watch brand business in Mainland China performed slightly better than last year for the following reasons: (a) the economy has emerged from 2021 stronger than at the start; (b) production and distribution

were gradually recovered through opening-up of business activities; (c) consumer confidence was slightly re-established; and (d) most importantly, the local watch companies imposed necessary measures, especially those related to e-commerce, for revenue generation and cost reduction.

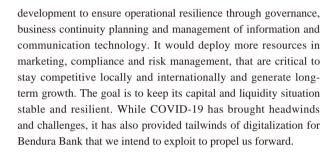
While Rossini maintained essentially the same revenue and profitability as the previous year, EBOHR had a silver lining for local proprietary brand watch business, as it made a stronger recovery and became profitable in 2021.

The foreign proprietary watch brand business, owing to economic tremors from the COVID-19 and the profound business disruption to the key international markets, where the general demand was weak, still suffered in 2021. Accordingly, certain measures were successfully implemented to increase the cashflow and reduce the extent of loss.

The COVID-19 dampened the performance and growth for certain subsidiaries. As a result, we took non-cash impairment for certain companies and commenced a strategic review to put them back on track for growth.

Bendura Bank, although its operation and performance being slightly affected by the COVID-19 due to lesser extent of communication and interaction with clients, has developed organically as shown by the steady healthy growth of asset under management and marginally increased headcount amid challenging market conditions. Bendura Bank has taken various measures in the wake of COVID-19 to withstand significant operational disruptions and would closely monitor further

# **BOARD OF DIRECTORS**

The appointment of Mr. Siu Chun Wa and Mr. Hao Xiaohui as CO-CEO and executive directors underlined the Board's belief that they are the best executives to lead the delivery of the strategic plan. We look forward to working closely with Mr. Siu, Mr. Hao and the management team as they focus on executing our strategic priorities in 2022. Their substantial business, banking and financial experience are inevitably valuable to our watch businesses and banking and financial businesses.

On behalf of the Board, I would like to express my sincere gratitude to Mr. Shang Jiangaung for his outstanding contributions to the Company during his tenure as our CEO and executive director.

# ENVIRONMENTAL, SOCIAL, AND GOVERNANCE ("ESG") PERFORMANCE

As a good corporate citizen, we not only continue to monitor our environmental impact but also contributes to the communities that we operate our businesses, especially in Mainland China. In accordance with the recently published requirements of the Listing Rules, we have designated a director to head the ESG and strengthened the relevant activities and disclosures.

# RISK MANAGEMENT

We monitor our risks and uncertainties facing the Group and formulate and adopt appropriate risk management measures against each principal risk and uncertainty. Special efforts are applied to analyze the risks related to COVID-19. Our risk committee has reviewed the major risks and suggested the relevant way to manage those risks.

#### **OUTLOOK**

The latest WHO data shows (1) approximately 70% of the population in richer nations have been fully vaccinated, compared with only 5% in poorer nations; (2) over 40% of the world's population has not yet received a first dose; and (3) the WHO's goal of vaccinating 70% of the population in poorer nations can only be achieved in the third quarter of 2022. COVID-19 is going to continue to mutate; Omicron, being the dominant variant in the Europe, is more contagious than Delta but generally leads to less severe infection among vaccinated people. Vaccination remains the best safeguard against COVID-19 as data showing vaccination is useful in cutting rates of hospitalization and mortality and it is incumbent upon the developed countries to supply vaccine to the developing countries. Presently, there are drugs with high level of

effectiveness against COVID-19, including against Omicron and earlier variants. All countries, both developed and developing, are affected by importation of cases and resurgence of domestic inflection. It is likely all countries still need to deal with it for a prolonged period of time until it becomes endemic like the flu (immunity against wider transmission and mutations due to the infection), when the global vaccination rates are sufficiently high or when the generic versions of effective drugs are available to all countries.

COVID-19 has profoundly transformed lives and businesses all over the world and cast spotlight on how we operate our businesses. In a time of unprecedented disruption, we embarked on a strategic reset to sharpen the Group's focus. Our strategic reset represents a deep-set change across the Group to reposition and emerge stronger post-COVID. Our sharpened focus will give us the agility to navigate the waves of new business model and digital growth. As we recalibrate for growth, we are committed to harnessing the power of the strategic thinking and technology to create a sustainable future for the Group.

Our foundation of sound governance, risk management and taking responsibility of our people and communities give our businesses a strong platform for continued success.

The geopolitical uncertainty of the regions, especially Central Asian states, remains a prominent feature of our operating environment. The actual military incursion in Ukraine, the first major conflict on European land, in the late February 2022 has

adversely affected the political stabilities in the region that is important to our overseas business. The crisis in Ukraine could well change the global economic landscape for a long time. Unless the crisis can be resolved quickly by negotiation between two parties or the United Nations responds decisively for the sake of global peace, expectations for global growth in 2022 and 2023 will take a dive. There are tough economic sanctions against Russia from the west and an escalation is always a possibility. The risk that Russia retaliates against sanctions by cutting off the supply of oil and gas to European countries, which could undermine economic activity, returning the region into the grip of another recession. The economies of the US and Mainland China will not be immune.

For Mainland China, the leadership implements appropriate decisions on monetary and fiscal policies which are lending support to a recovery of the economy. Particularly, the government strengthens measures and policies to boost the domestic consumption. With long-term positive economic fundamentals, Mainland China is expected to remain one of the world's resilient and fundamentally sound market.

The market conditions for watches are expected to improve in the longer term when the COVID-19 becomes endemic like the flu or when the global vaccination rates are sufficiently high. At that time, market conditions are expected to improve when the consumer confidence is gradually recovered and the demand for watches in Mainland China and all over the world is expected to be gaining momentum again.

With the completion of its new building, Bendura Bank has laid the foundation for its future growth. Bendura Bank reached new all-time time highs in assets under manager in the past financial year, which should by now means tempt us to rest on our laurels, but rather spur us on to further growth. While the Hong Kong Representative Office provides the optimum infrastructure for developing the Asian markets, the recruitment of experienced customer advisors and implementation of the trainee programs provides experienced members and promising members for the continuously expanded operation. Given that most of clients focus on prudent investments and Bendura Bank adopts a prudent asset allocation policy, particularly the lending policy, we believe Bendura Bank would be in a secure position even in the currently challenging financial market situation and in the scenario of slowing, if not negative, global economic growth.

We continue the new mindset and take the COVID-19 as the most important opportunity and lesson that we should learn and improve from. How we emerge from this challenging period will determine our performance over the coming years and we are taking the necessary actions now.

Looking ahead, we would remain calm and apply courage and wisdom to take on the strong headwind challenges. We have full confidence that our strengthened management team, collective resilience and razor-sharp focus on achieving our goals shall underpin our efforts to recover and retool for much-altered post-COVID-19 era. We shall look back on these challenging times as a memory.

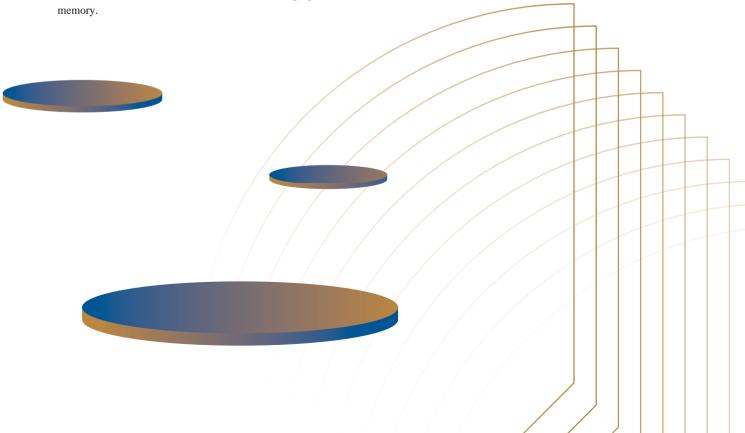

# **OPERATING RESULT**

For the year ended 31 December 2021, the Group recorded total revenue of approximately HK\$1,931,099,000 (31 December 2020: HK\$1,774,549,000), an increase of HK\$156,550,000 or 8.8% over 2020.

Operating expenses (including selling and distribution expenses and administrative expenses) for the year ended 31 December 2021 was approximately HK\$1,233,917,000 (31 December 2020: HK\$1,278,860,000), a decrease of HK\$44,943,000 or 3.5% over 2020.

Gross profit generated from non-banking and financial businesses for the year ended 31 December 2021 was approximately HK\$825,914,000 (31 December 2020: HK\$769,515,000), an increase of HK\$56,399,000 or 7.3% over 2020.

Gross profit generated from banking and financial businesses for the year ended 31 December 2021 was approximately HK\$359,961,000 (31 December 2020: HK\$357,629,000), an increase of HK\$2,332,000 or 0.7% over 2020.

The EBITDA for the year ended 31 December 2021 was approximately HK\$110,966,000 (31 December 2020: HK\$111,176,000), a decrease of HK\$210,000 or 0.2% over 2020.

Net loss after tax for the year ended 31 December 2021 was approximately HK\$105,376,000 (31 December 2020: HK\$158,829,000).

For the year ended 31 December 2021, Zhuhai Rossini Watch Industry Limited ("Rossini"), a 91% subsidiary of the Group, recorded revenue of HK\$597,929,000, an increase of HK\$18,282,000 or 3.1% from HK\$579,647,000 in 2020. Net profit after tax attributable to owners of the Company for the year ended 31 December 2021 was HK\$100,063,000, representing an increase of HK\$50,505,000 or 101.9%, from HK\$49,558,000 in 2020.

In the past few years, the traditional retail model of watch industry has been challenged by the ever-growing e-commerce in Mainland China. The outbreak of COVID-19 since late 2019 further intensified the existing challenges. 2021 was a year marked by aggregated spread of COVID-19. The uncertainties concerning COVID-19 development have not only affected customers, but also brought unprecedented level of disruption to the production line. To cope with this difficult time, Rossini implemented diversified sales models and flexible policies, by maintaining agility to respond to market changes, and thereby mitigate adverse effects.

The COVID-19 significantly affected the overall consumer sentiment and as a result, sales of physical stores borne the brunt of the entire outbreak. To reduce the impact from the COVID-19, Rossini firstly continued to consolidate and develop the position of physical market sales by implementing flexible policies to physical stores based on provinces, regions, and branches, strengthening the control of trade receivables, and encouraging branches to expand into shopping malls of third-tier and fourth-tier cities and so forth. Secondly, a work-from-home working pattern was adopted by Rossini to maintain a flexible and minimum level of operation to avoid unnecessary cost. Despite the challenging environment for physical sales, Rossini generated approximately 10.1% increase in physical sales revenue compared to prior year.

For the year ended 31 December 2021, e-commerce sales increased to HK\$247,381,000 from HK\$236,552,000 last year, representing an increase of HK\$10,829,000 or 4.4%. The COVID-19 raised the demand in online sales, it also introduced a higher level of market competition. However, with the effort of Rossini in e-commerce, it delivered a positive result under the ever-challenging environment.

Considering the changing consumer preference, Rossini directed more focus on e-commerce and omnichannel capabilities to offset the current weak sales demand from physical stores. Specifically, it kept expanding its penetration through online distributors on leading e-commerce platforms including Taobao, Tmall, JD and Pinduoduo. In addition, the shopping preferences of Chinese consumers, especially those of the younger generation, were influenced by key opinion leaders (KOL), who spread their reviews on social media live streaming apps. Rossini's e-commerce team seized the current trend and as a result, e-commerce livestreaming has taken off. Rossini actively explored new opportunities for engagement on popular social media platforms including Xiaohongshu, Kuaishou and Tik Tok to strengthen its brand awareness.

The ever-growing e-commerce in Mainland China has transformed the consumption behaviour of the customers. E-commerce live-streaming became more popular among consumers, especially the younger customers.

Since the outset of COVID-19, the tourism industry entered into harsh winter for a period of time. Rossini's revenue from industrial tourism was also inevitably affected. Throughout the year of 2021, the number of tourists was approximately 40,000 (2020: 50,000), and revenue from which was approximately HK\$3,792,000 (2020: HK\$4,834,000), representing a decrease of approximately 21.6% over the prior year. The performance is expected to be recovered when the COVID-19 is over. In order to better face future competition, Rossini makes use of the current time to design more specific events, i.e. talks, seminars and workshop, and provides more internal trainings to the tourists guides as a further development of its industrial tourism strategy.

EBOHR Group is composed of EB Brand Limited, EBOHR Luxuries International Limited ("EBOHR"), Shenzhen EBOHR Luxuries Online E-commerce Co., Ltd., PAMA Precision Manufacturing Limited and Shenzhen EBOHR PAMA Sales Co., Ltd.

Revenue from watches and timepieces business of EBOHR Group for the year ended 31 December 2021 was HK\$353,750,000, an increase of HK\$59,816,000 or 20.4%, from HK\$293,934,000 in 2020. Net profit after tax from watches and timepieces business for the year ended 31 December 2021 was HK\$3,959,000, compared with net loss after tax of HK\$29,322,000 in 2020.

Apart from watches and timepieces business, EBOHR Group's investment properties also contributed rental income and net profit of HK\$7,273,000 during the year ended 31 December 2021 (31 December 2020: HK\$4,401,000) which was recorded in property investment segment result.

The rise in profits was mainly attributable to several reasons. Firstly, EBOHR stepped up its efforts to stimulate consumption, resulting in the increase in sales volume greater than the drop in unit price. Secondly, affected by the decline in the exchange rate of the US dollar, EBOHR incurred exchange losses on the transaction amount (HKD) with the parent company, but the losses was smaller than that in 2020. Thirdly, since the outbreak of COVID-19, EBOHR has been actively adjusting the sales direction, conducting clearly defined assessments and management on business outlets. EBOHR discontinued some outlets with unsatisfactory performance. Around 200 physical stores were closed, the sales expenses, including remuneration of sales persons, expenses of commercial centers and advertising costs, thus decreased.

Apart from COVID-19, the emergence of the smartwatch industry has deeply eroded the market share of the traditional watch industry, resulting in a tougher market environment for the traditional watch industry. All have brought unprecedented negative impact to the company's overall strategic deployment and business plan. To contain such impact, EBOHR on the one hand continues to optimize its existing product lines to maintain competitiveness, on the other hand it deploys more focus on the research and development team, aiming to reinforce its ability in better product design.

Regarding e-commerce, the retail sales in 2021 are broadly in line with the prior year, causing downward pressure on overall sales. For the year ended 31 December 2021, the e-commerce sales increased to HK\$110,772,000 from HK\$101,586,000 last year, representing an increase of HK\$9,186,000 or 9.0%. The retail sales of the three major platforms, Tmall, JD.com, and Vipshop, declined sharply, which was covered by the increased sales mainly from the expansion of third-party platforms. The performance of EBOHR's e-commerce has improved due to the overall downward trend on promotion cost of e-commerce, which dropped by 27% compared with 2020. Among them, the cost of Tmall and JD dropped significantly, but the entire cost rate was still very high.

2021 coincides with the 30th anniversary of the EBOHR brand. Combined with new product launches, festival promotions, hot events, etc., EBOHR carried out omni-marketing that spanned the whole year. The 30th anniversary marketing events, as a whole, met our expectations, boosted sales confidence and sales performance internally, strengthened brand recognition and brand image externally, and deepened brand influence. These integrated marketing events also enriched our experience and provided the Group with the incubator of future direction to explore.

In the coming year, EBOHR will carefully consider a more stringent control on the number of POS, and actively try to package stores, develop shopping malls, and chain channels according to the company's own positioning. In terms of brand building, EBOHR will seek to gain an in-depth understanding of the customer base, refine its positioning, and offering new ways of connection through new distribution channels for the new generation, such as Xiaohongshu grass, Tik Tok search, etc. dedicating push in the shoppertainment and the e-commerce sales through driving stronger engagement with younger clients.

# ERNEST BOREL HOLDINGS LIMITED

The Group held 64.08% equity interest in Ernest Borel Holdings Limited ("Ernest Borel", together with its subsidiaries, the "Ernest Borel Group") as at 31 December 2021.

For the year ended 31 December 2021, Ernest Borel Group recorded revenue of approximately HK\$143,671,000, representing an increase of HK\$27,428,000 or 23.6% over HK\$116,243,000 in 2020. Net loss after tax attributable to the owners of the Company was HK\$22,433,000, representing a increase of HK\$17,788,000 or 382.9% over HK\$4,645,000 in 2020.

Mainland China remains as the core market of the Ernest Borel Group. Revenue from Mainland China was approximately HK\$136,830,000 for the year ended 31 December 2021, accounting for approximately 95.2% of its total revenue.

The extensive distribution network of the Ernest Borel Group covers retail markets in Mainland China, Hong Kong, Macau and Southeast Asian countries. As at 31 December 2021, Ernest Borel Group had more than 825 POS (31 December 2020: 804), comprising around 715 POS in Mainland China, around 45 POS in Hong Kong and Macau, and 65 POS in other countries mainly in Southeast Asia and European.

During 2021, the outbreak remained the main challenges to the performance of Ernest Borel, especially in late 2021. The recurring rebound in infection rate imposed a greater interruption to the traditional retail market, resulting in lower customer consumption and affecting the performance. To reduce the impact of the COVID-19 on revenue, Ernest Borel Group applied different strategies. It optimized the pricing structure of watches, marking appropriate downward adjustment on prices to capture market share of Swiss watches at different price levels. At the same time, it also optimized the customer profit margins by adjusting the supply chain, and reducing costs. Strong efforts of Ernest Borel eventually posted a slightly increase in physical stores revenue.

To adapt rapidly to the accelerated growth of e-commerce, Ernest Borel Group launched a series of marketing activities with the new brand spokespersons to fuel online and offline sales in Mainland China. However, as the cost from e-commerce platform still at a high level, there is still room for Ernest Borel to improve e-commerce performance in future. As at 31 December 2021, sales revenue from Ernest Borel increased by approximately 48% compared to prior year.

Although there was an increase in sales revenue, the progression has not yet reached a satisfactory level. The decrease in profits was mainly due to impairment and provisions. In addition, operating cost of Ernest Borel returned to normal level to enhance its marketing strategy. Given that the cost increment was far more than the revenue, the profits therefore declined. Despite the challenging economic environment, the evidence of sales improved showing that Ernest Borel was now on the right direction to success.

# **Other Foreign Proprietary Brands**

Collectively, Corum, Eterna and The Dreyfuss Group Limited (the "Dreyfuss Group") contributed revenue and net loss after tax for the year ended 31 December 2021 of HK\$194,054,000 (31 December 2020: HK\$171,521,000) and HK\$82,826,000 (31 December 2020: HK\$128,128,000), respectively.

Asia, Europe and the US have been the major markets for Corum. Asian and European market sales represented around 78% of the turnover of Corum. COVID-19 affected adversely the overall sales performance of Corum for the year 2020. The shutdown of international tourism created obstacles to sales of luxury goods, including watches. However, there was an unexpected fast recovery for Swiss watch exports in 2021. The return to pre-crisis levels and positive performance in the fourth quarter 2021 produced

the best-ever annual results for the watchmaking industry. Since the adverse effect of COVID-19 has been under control by the increasingly high worldwide vaccination, the activity and the results in the second half of 2021 have been driven up. The revenue of Corum got 8% increase in 2021 when compared with the previous year.

With the beginning of the general lockdowns, Corum had taken "Asset Management" strategy to minimise the negative impact. Firstly, the management adopt a "less is more" approach, by reduction of the point of sales, product re-positioning, brand value promotion and more stringent cost control, it successfully improved the margin. Corum revised all the contracts to cut drastically the operational expenses, which have been reduced in 2021 by 20% compared to 2020. Secondly, the entire inventory of Corum was reduced. The Asset Management strategy enabled Corum to effectively allocate and transfer existing pieces to clients, resulting in a 7% decreasing in inventory level in 2021 and reach an improved performance. Thirdly, the new management closely monitored the level of account receivables and its collection. By active collection of old overdues and readjustment of old contracts, Corum made a great effort on minimizing the risk of bad debt. To cope with this difficult time, Corum also applied for the Swiss COVID-19 loan, an eight-years loan without interests, from the government to subsidise the loss from the pandemic.

Chinese consumers are considered to be the main contributors to the growth in demand for the luxury goods over the next five years. Corum hence focused on China markets in 2021 and expected to set up some local event, dedicated to these markets.

The performance for the year ended 31 December 2021 basically reach the management's expectation, especially at the end of year. With the recovery of market demand, it is believed that Eterna would achieve positive result soon.

Eterna's strongest markets remained in Europe. There was a trend of growing interest in both Asia and Greater China market Eterna entered.

UK is the Dreyfuss Group's largest single market, representing 81% of its revenue for the year ended 31 December 2021. With the COVID-19 still continuing in 2021, Dreyfuss Group recorded sales growth with lower costs over 2020, resulting in a profit in 2021, compared with a loss in previous year.

Though lockdowns were eased in 2021, but high street confidence remained slim. High street retailers, which comprises the majority of UK sales, still remain to underperform. The closure of UK stores has continued over the last few years, therefore customer strategy of Dreyfuss Group has been redirected to online stores wherever possible.

The Dreyfuss Group's key strategy in 2021 was to continue to increase profitability by continuing to review policies and relationships with customers, raising the online presence and marketing output, and minimizing the cost to reduce the adverse effect of COVID-19 situation. The Group focused resources on profitable sales growth opportunities in key markets, particularly through the distributor network, with increased use of cash in advance for the smaller markets.

The Group has developed a new website which is developed for sales of its own watches. Sales have increased with this new website due to its ease-of-use for customers and administrators. Social media follower of the Group increased by 22% and the brand awareness and corporate image amongst new and existing audiences grew as the Dreyfuss Group launched a two-year watch partnership with Prostate Cancer UK. This campaign together with the new website helped lead to an increase in new acquisitions on Rotarywatches.com of 68% in 2021 vs 2020.

The Dreyfuss Group continues its efforts in developing the international market in order to reduce its reliance in the UK market. Brexit finally officially took place in January 2021 and resulted in increased duty and legal costs. Despite this, there is still an increase in number of point of sales in Europe during 2021 as it is the key market of the Dreyfuss Group. Due to Brexit, Germany is planned to be the centre of EU trade, with all EU trade to be performed within the German branch. Negotiations are already underway and approaching final stage.

Backed by our competitive strengths and deep understanding of the needs of our customers, we will redeploy our resources to realize gains in efficiency and synergy and will build on the good progress we have made to provide longterm value.

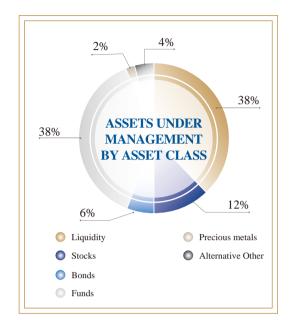
Currently, the Group holds four distribution companies. Collectively, distribution companies contributed revenue and net profit after tax for the year ended 31 December 2021 of HK\$231,594,000 (31 December 2020: HK\$216,220,000) and HK\$2,249,000 (31 December 2020: HK\$3,093,000) respectively.

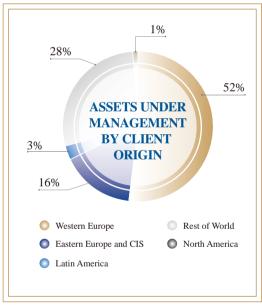
# **l.D.** Watches and Timepieces Business – Others

Other non-major subsidiaries of the Group are also engaged in other non-major categories of watches and timepieces businesses, which collectively contributed revenue and net loss after tax for the year ended 31 December 2021 of HK\$34,116,000 (31 December 2020: HK\$28,247,000) and HK\$29,458,000 (31 December 2020: HK\$14,882,000), respectively.

# MANAGEMENT DISCUSSION AND ANALYSIS







Revenue of Bendura Bank AG ("Bendura Bank" or the "Bank") and its subsidiaries (the "Bendura Group") for the year ended 31 December 2021 was HK\$353,731,000, an increase of HK\$7,007,000 or 2.0% from HK\$346,724,000 over 2020. Net profit of the Bendura Group after tax attributable to owners of the Company for the year ended 31 December 2021 was HK\$30,602,000, compared with net loss after tax of HK\$3,633,000 in 2020. The positive result was due to recovery of economic growth and success in transitioning from transactional banking to wealth management services.

During 2021, the Bank continued to face low interest rates in Swiss Francs and Euros. Despite a further expansion of the credit volume, net interest income fell from HK\$128.028.000 in 2020 to HK\$94.164.000.

Income from commission and service fee activities of the Bank recorded HK\$223,370,000, showing an increase of 13.4% over the previous year.

Client's assets under management of the Bank grew by CHF0.4 billion year on year, ending at CHF4.1 billion in 2021. The increase was mainly due to a pleasing net new money inflow of CHF81.59 million.

Due to increased income from foreign exchange transactions for clients on one hand and another negative valuation adjustment of an investment in the trading portfolio on the other hand, the Bank's income from financial transactions amounted to HK\$36,197,000, about HK\$14,495,000 higher than the previous year.

Operating expenses of the Bank amounted to HK\$304,052,000, representing a decrease of 2.0% compared to prior year, primarily due to lower personnel costs.

The positive result in 2021 enables the Bank to strengthen equity by CHF2.5 million after planned profit distribution. The total capital ratio of the Bank continued to be at an above-average level for the banking industry.

Bendura Bank has taken various measures in the wake of the COVID-19. The Bank has successfully transitioned from transactional banking to wealth management services despite: (a) low interest rate environment in USD/GBP and negative interest rate environment in Euro/Swiss, (b) newly introduced of regulations and increasing due diligence. This transition sets up the foundation for further growth of the Bank.

In 2021, Bendura Group disposed 100% of its equity interest in its subsidiary, namely Bendura Fund Management Alpha AG as part of a restructuring measure. Since then, the entire fund management business in Bendura Group is focused on the subsidiary, Bendura Fund Management Beta AG. Bendura Fund Management Beta AG offers a complete set of offering of fund type with "Alternative Investment Fund" (AIF) and its range of services extends from consulting and structuring to the establishment and operation of AIF in its capacity as a state-licensed "Alternative Investment Fund Manager" (AIFM).

To safeguard and help employees navigate the health crisis, the Bank introduced remote working policy. Almost all employees had the option to work from home. This provides the highest level of assurance for business and operation continuity in the safest condition and to remain uninterrupted by future pandemic developments. Almost all employees could work from home if desired. Regardless of future pandemic developments, the operation of all banking processes was ensured at the highest level of "Business as usual". E-banking has been upgraded with optimized interface design and QR scanner for fast payments processing.

As an innovative private bank, Bendura Bank continues to grow organically with regionally-focused mandates and advisory services for clients. The Bank may also forged strategic partnership with external asset manager, which showed interest to profit from the Bank's emerging market expertise, especially the Asian Dragon mandates as one of the current new investing portfolio of the Bank.

The Bank continued to record growth in net new money inflows during 2021, which demonstrated strong growth potentials. The global economy is expected to continue to recover in 2022. The Bank will closely monitor further developments to ensure seamless service and business operations for clients. The Bank aims to keep its capital and liquidity levels stable and resilient.

# II.B SHUN HENG FINANCE HOLDING (HONG KONG) LIMITED

The Group currently conducts securities and asset management businesses supported by Shun Heng Finance Holding (Hong Kong) Limited ("Shun Heng Finance Holding"), which is 60% owned by the Group. It comprises Shun Heng Securities Limited and Hong Kong Metasequoia Capital Management Limited.

For the year ended 31 December 2021, Shun Heng Finance Holding contributed revenue and net loss after tax attributable to owners of the Company of HK\$6,230,000 (31 December 2020: HK\$10,905,000) and HK\$420,000 (31 December 2020: profit of HK\$4,535,000) respectively.

# SHUN HENG SECURITIES LIMITED

Shun Heng Securities Limited ("Shun Heng Securities"), a corporate licensed to conduct Type 1 (dealing in securities) regulated activity under the Securities and Futures Ordinance (the "SFO"), is mainly engaged in securities brokerage and margin businesses.

In addition to the traditional brokerage business, Shun Heng Securities has actively seek opportunities to grow through underwriting business for overseas bonds issued by Chinese enterprises. During 2021, Shun Heng Securities assisted in the completion of three private equity US dollar bond underwriting projects and one stock underwriting project. As at the end of 2021, Shun Heng Securities has successfully underwritten various bond projects with a cumulative amount of over US\$1 billion, achieving brand awareness in Hong Kong Financial Market.

# HONG KONG METASEQUOIA CAPITAL MANAGEMENT LIMITED

Hong Kong Metasequoia Capital Management Limited ("Metasequoia Capital"), a corporate licensed to conduct Type 4 (advisory on securities) and Type 9 (asset management) regulated activities under the SFO, is mainly engaged in asset management business.

Metasequoia Capital has launched two funds since its inception, namely Global Opportunities Fund and Stable Growth Fund. Global Opportunities Fund invests mainly in securities markets in Mainland China, Hong Kong and the US, with assets under management ranging from US\$10.24 million initially to approximately US\$14.32 million as at 31 December 2021. The Stable Growth Fund, launched in 2019, invests in domestic RMB bond and its assets under management reached approximately US\$6.23 million as at 31 December 2021. As at 31 December 2021, the aggregate assets under management of Metasequoia Capital was approximately US\$20,556,000 (31 December 2020: US\$18,720,000).

# **III.A Listed Equity Investment**

#### (1) Citychamp Dartong Company Limited

As at 31 December 2021, financial assets at fair value through other comprehensive income of the Group was HK\$504,117,000. HK\$147,133,000 was related to the listed equity investment in the equity share of Citychamp Dartong Company Limited ("Citychamp Dartong"). Citychamp Dartong is a company listed on the Shanghai Stock Exchange (Stock code: 600067) and engaged in real estate, enameled wire, banking and new energy. As at 31 December 2021, the Group owned 30,389,058 shares of Citychamp Dartong at the market price of RMB3.95 per share (equivalent to HK\$4.84 per share) with the fair value of HK\$147,133,000. The shares held by the Group accounted for 2.04% of the total issued share capital of Citychamp Dartong as at 31 December 2021. Such fair value accounted for 0.7% of the Group's total assets.

The Group incurred a net gain on fair value change through other comprehensive income in investment in Citychamp Dartong of HK\$15,497,000 for the period ended 31 December 2021, as a result of increase in the share price of Citychamp Dartong from RMB3.65 (equivalent to HK\$4.33) as at 1 January 2021 to RMB3.95 (equivalent to HK\$4.84) as at 31 December 2021. The Group recognized dividend income of HK\$2,779,000 from Citychamp Dartong for the year ended 31 December 2021.

Due to healthy dividend yield and price appreciation, this will be the Group's long-term investment. We are optimistic about the future prospects of the Citychamp Dartong. Given its substantial land bank reserves for development and profitability of certain business segments.

#### (2) Min Xin Holdings Limited

Investment in Min Xin Holdings Limited ("Min Xin") (Stock code: 222) was measured at fair value through other comprehensive income. The Company intends to hold the investment on a long-term basis.

Min Xin is a company engaged in financial services, securities trading, real estate development, toll road and manufacturing. As at 31 December 2021, the investment in Min Xin was HK\$350,837,000, i.e. 88,150,000 shares at the market price of HK\$3.98 per share as at 31 December 2021. Such fair value of the investment accounted for 1.8% of the Group's total assets. The shares held by the Company accounted for 14.76% of the total issued share capital of Min Xin as at 31 December 2021.

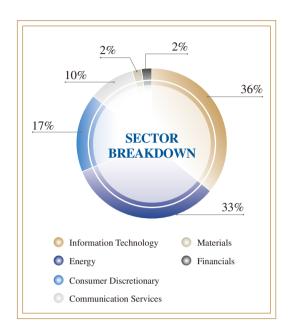
The Company incurred a net gain on fair value change in Min Xin's investment of HK\$17,630,000 for the period ended 31 December 2021 (31 December 2020: net gain of HK\$51,127,000), as a result of increase in the share price of Min Xin from HK\$3.78 as at 1 January 2021 to HK\$3.98 as at 31 December 2021. For the year ended 31 December 2021, the Company's dividend income from Min Xin was HK\$8,815,000.

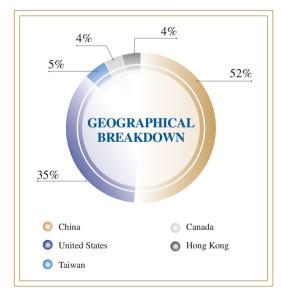
#### **III.B Property Investment**

The properties in Mainland China and Hong Kong owned by the Group have been leased out, with stable stream of rental income to the Group for the year under review. During the year, these investment properties generated rental income of HK\$16,024,000 (31 December 2020: HK\$11,108,000). Net profit after tax from the property investment business for the year ended 31 December 2021 was HK\$25,423,000 (31 December 2020: HK\$15,378,000).

#### III.C OTHER MARKETABLE SECURITIES

The Group has acted as the founder investor and invested USD5.12 million in "Metasequoia Investment Fund SPC - Global Opportunities Fund SP" (the "Fund") since 15 August 2017 in order to facilitate establishing the fund management business with an initial capital of USD10.24 million and the rest of the fund was subscribed by other investors with the capital of USD5.12 million. As of 31 December 2021, the total net asset value of the Fund was USD14.18 million, which composed by USD2.58 million and USD11.60 million for the Group and other inventors respectively. The composition of investments in the Fund were approximately 36.10% in information technology, 33.38% in energy, 17.27% in consumer discretionary, 10.00% in communication services, 1.69% in materials and the rest 1.56% in financial sector. Geographically, the Fund invested in companies of origin were approximately 52.21.% in Mainland China, 35.58% in the US, 4.55% in Taiwan, 3.90% in Canada and the remaining 3.77% in Hong Kong. For the year ended 31 December 2021, the unrealized loss on fair value of the investment was approximately USD326,050.





# **HEADQUARTER AND OTHERS**

Losses from administrative expenses, finance costs and income tax of the headquarter and other non-major subsidiaries and/or non-major categories of businesses for the year ended 31 December 2021 was HK\$128,066,000 (31 December 2020: HK\$61,187,000).

# **FINANCIAL POSITION**

#### (1) Liquidity, Financial Resources and Capital Structure

As at 31 December 2021, the Group had non-pledged cash and bank balances of approximately HK\$6,531,968,000 (31 December 2020: HK\$5,612,645,000). Based on the borrowings of HK\$1,176,635,000 (31 December 2020: HK\$1,564,822,000), due to a shareholder of HK\$12,000,000 (31 December 2020: HK\$12,000,000), due to directors of HK\$73,515,000 (31 December 2020: HK\$21,233,000), due to a related company of HK\$88,000,000 (31 December 2020: Nil), due to an associate of HK\$10,000,000 (31 December 2020: Nil) and shareholders' equity of HK\$4,361,133,000 (31 December 2020: HK\$4,418,679,000), the Group's gearing ratio (being borrowings plus due to a shareholder, directors, a related company and an associate divided by shareholders' equity) was 31% (31 December 2020: 36%).

#### (2) Charge on assets

As at 31 December 2021, the Group's borrowings were mainly secured by:

- (a) corporate guarantees provided by certain subsidiaries within the Group;
- (b) equity interest of certain subsidiaries within the Group; and
- (c) a legal charge over the Group's property, plant and equipment with the carrying amount of HK\$309,573,000 (2020: HK\$310,118,000).

# (3) Capital commitment

Capital commitments as at 31 December 2021 were approximately HK\$270,000,000 in total (31 December 2020: HK\$270,000,000), for investment in an associate – Citychamp Allied International Limited and purchase of property, plant and equipment.

Except for the above, the Group had no other material capital commitments as at 31 December 2021.

It is the objective of the Group to maintain certain level of liquidity in the form of trading portfolio investments for unplanned capital expenditure. The liquidity is usually parked with the listed equities in order to generate short term return.

As at 31 December 2021, there were HK\$626,000 invested in a variety of listed equities in Hong Kong and HK\$3,944,000 invested in Mainland China and overseas markets.

The debt instruments of HK\$7,234,000 invested in the Mainland China by PRC company.

Trading assets of CHF1.1 million (equivalent to HK\$9,558,000) represents the single investment by Bendura Bank in the form of an unlisted investment fund. Bendura Bank acquired above trading assets from a professional counterparty in March 2019. The investment policy of Bendura Bank AG includes strict implementation of the investment process and is subject to constant review by the investment committee.

Investments in other financial products consist of the financial product investments of HK\$6,546,000 invested by Eternal Brands.

In the derivative financial assets of HK\$34,608,000, there were forward and option contracts conducted by Bendura Bank.

Bendura Bank offers derivative products including currency forwards and swaps to its clients. These derivative positions were managed through entering back-to-back deals with external parties to ensure that remaining exposures are within acceptable risk levels. First-rate banks serve as counterparties, as is generally the case in trading business. It is not the objective of Bendura Bank to speculate the gain on the change in the price by conducting forward and option contracts without having invested in the underlying assets.

As at 31 December 2021, forward contracts of HK\$34,608,000, whereof HK\$7,688,000 relate to FX swaps entered by Bendura Bank. Based upon risk/return considerations, client deposits denominated in foreign currencies were, in part, no longer invested on the interbank market but were swapped into Swiss francs or Euro using currency swaps and deposited with the Swiss National Bank (SNB) and Austrian National bank (OenB) accordingly. Income from the interest component of currency swaps exceeded the expense of SNB/OenB negative interest and the reduced level of interest from banks.

BENDURA BANK AG invested in listed debt instruments issued by government and public sector, financial institutions and corporations amounting to HK\$1,852,934,000. The portfolio was composed of 90 listed debt instruments with different maturity, geography, segment and currency and hence, diversification is ensured. Almost all listed debt instruments were considered upper-medium-grade and are subject to low credit risk. The average remaining term of the HTM portfolio is 1.95 years, while the modified duration of the portfolio is only 1.70%. Largest single investments are bonds issued by UK Treasury Bill (CHF15 million) and ESM Treasury Bill (CHF13 million). Both issuers are double-A rated. Risk concentration is analyzed and presented to the senior management on a monthly basis.

As at 31 December 2020, Bendura Bank invested in listed debt instruments issued by government and public sector, financial institutions and corporations amounting to HK\$1,449,886,000, the portfolio was composed of 79 listed debt instruments with different maturity, geography, segment and currency and hence, diversification is ensured. Almost all listed debt instruments were considered upper-medium grade and are subject to low credit risk. Largest single investments are bond issued by European Investment Bank (CHF11 million) and followed by International Bank for Reconstruction and Development (CHF9 million). Both are triple-A issuers. Risk concentration is analyzed and presented to the senior management on a monthly basis.

#### (10) Finance costs from non-banking business

Finance costs from non-banking business was HK\$67,351,000, representing a decrease of HK\$15,605,000 or 18.8%. It was composed of the interest charged on corporate bonds and the interest charged on bank borrowings, bank overdrafts and lease liabilities.

#### (11) Loss/profit attributable to owners of the Company

Loss attributable to owners of the Company was HK\$100,907,000 (31 December 2020: loss of HK\$169,233,000) for the year ended 31 December 2021.

#### (12) Inventories

Inventories was HK\$2,193,281,000, a decrease of HK\$62,272,000 or 2.8%.

#### THE IMPACT OF THE COVID-19 ON THE GROUP

The COVID-19 was firstly reported in late 2019 and has been spreading throughout the world continuously till now. The COVID-19 has brought adversely impacted supply and demand of a large number of industries and hence global economy in general.

To overcome the adverse impacts of the COVID-19, the watch and timepieces businesses have adopted a number of strategies, including implementation of employee optimization, operation cost control, investigation of new sales model, exploring new distribution channels such as e-commence and new retailing tactics, shortening production time to increase inventory turnover, etc. Starting from late 2021, with the development and implementation of the vaccine and the herd immunity due to massive infection rates in a number of countries, particularly the US and the European countries, it appeared that the COVID-19 has been gradually contained all over the world. Mainland China has demonstrated satisfactory results controlling the COVID-19 and recorded economic recovery. However, global recovery of other countries still considers as weak but the medium-term forecasts of the global economy are favorable. The improved performance in our watch and timepieces businesses in 2021 was a strong evidence. The COVID-19 led to new opportunities in e-commerce as customer behavior has been changed due to the social distancing measures. Our longstanding preparation efforts on e-commerce development has began to bear fruit and become one of our important competitive advantage. For banking business, the COVID-19 led to limited operation of Bendura Bank and reduction in client interaction which adversely affected its revenue last year. To overcome this situation, Bendura Bank pushed its digital transformation for the employees to have full access to all necessary information when working at home. In May 2021, the revised design of e-Banking version was launched, which enables rapid and registered access to archive data. This led to a substantial improvement in efficiency and reduction in the response time for customers. In addition, Bendura Bank focused more on online marketing which improves the effectiveness in communication that leads to a closer relationship with its clients.

The surge in imported cases and domestic infectious rebound have greatly impacted businesses across the globe. The current uncertainty and disruption are likely to prevail until advancement of herd immunity through vaccination or development of effective drugs.

# **OUTLOOK**

Every corner of the world is affected by importation of cases and resurgence of domestic infection. It is likely the world still needs to deal with it for a prolonged period of time until it becomes endemic like the flu (immunity due to the infection), when the global vaccination rates are sufficiently high or when the generic versions of effective drugs are available to all countries.

Infection rates remain very high in Europe, the US and Latin America and new variants of the virus have spread exponentially. Coupled with the deployment of multiple vaccines and effective drugs, the COVID-19 would hopefully be tackled before the end of year 2022. Our focus will therefore remain on maintaining agility and flexibility to face potential impacts should the COVID-19 continue beyond 2022. We are also considering the impact of the military invasion in Ukraine that began in late February 2022, the tough economic sanctions against Russia from the west, and the Russia's retaliation against sanctions by cutting off the supply of oil and gas to European countries.

In response to accelerated digital penetration, Rossini and EBOHR and advanced direct-to-consumer (D2C) strategies R&E have significantly strengthened their omni-channel capabilities. They have also deployed innovative digital engagement models to promote products, such as live stream videos via online platforms like TikTok, Tmall, or WeChat, allowing social media engagement to drive purchases. Brand reputations are also established through key opinion leaders (KOL) or between consumers. Both companies leverage the key post-COVID-19 trend and to further strengthen our unique and comprehensive e-commerce initiatives.

Bendura Bank expanded its online marketing onto Google, LinkedIn and YouTube to target specific clients such as wealthy private individuals, medium-sized companies and intermediates. It will continue to emphasize its existing strategy as a highly specialized niche player, capturing the needs of international clients by expanding the advisory and investment services offering.

We have adopted a new mindset and taken the COVID-19 as a valuable opportunity and lesson that we maintain our adaptability in the face of COVID-19 and be prepared to take necessary measures to manage the economic impact.

# EMPLOYEES AND REMUNERATION POLICY

Our sustained success would not be possible without the high levels of expertise, professionalism and commitment shown by our employees.

As at 31 December 2021, the Group had approximately 4,100 fulltime staff in Hong Kong and Mainland China and approximately 260 fulltime staff in Europe. The remuneration packages offered to the employees were determined and reviewed on an arm's length basis with reference to the market condition and individual performance. The Group also provides other benefits to its employees, including year-end double pay, medical insurance and retirement benefits, and incentive bonuses are offered with reference to the Group's operating results and employees' individual performance. All employees of the Group in Hong Kong have joined the provident fund schemes. Employees of Group's subsidiaries in Mainland China also have participated in social insurance scheme administrated and operated by local authorities and contributions were made according to the local laws and regulations.

The Company has applied the principles and complied with all the applicable code provisions of the Corporate Governance Code (the "CG Code") and Corporate Governance Report as set out in Appendix 14 to the Rules ("Listing Rules") Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Stock Exchange") for the year ended 31 December 2021 except with the details disclosed below:

#### (i) CG Code E.1.2

CG Code E.1.2 stipulates that the Chairman of the board of directors (the "Board") should attend the annual general meeting of the Company. The Chairman of the Board was unable to attend the annual general meeting of the Company held on 28 May 2021 (the "AGM 2021") due to other business engagement.

#### (ii) CG Code A.6.7

CG Code A.6.7 stipulates that independent non-executive directors should generally attend general meetings. Two independent non-executive directors of the Company (the "Independent Non-executive Director") did not attend the AGM 2021 due to travel restrictions under COVID-19.

The Chairman of the Board and Independent Non-executive Directors will endeavor to attend all future general meetings of the Company unless unexpected or special circumstances preventing them from doing so. The Board will continuously review and improve the corporate governance practices and standards of the Company to ensure that business activities and decision-making processes are properly regulated.

#### MODEL CODE FOR SECURITIES TRANSACTIONS BY DIRECTORS

The Company has adopted the Model Code for Securities Transactions by Directors of Listed Issuers ("Model Code") as set out in Appendix 10 to the Listing Rules as the code of conducts for securities transactions by Directors of the Company. All the members of the Board have confirmed, following specific enquiry by the Company, that they have complied with the required standard as set out in the Model Code throughout the year ended 31 December 2021.

#### **BOARD OF DIRECTORS**

The principal focus of the Board is on the overall strategic development and direction of the Group. The Board also monitors the financial performance and the internal controls of the Group's business operations. Moreover, the Board is responsible for performing the corporate governance duties. The Board has established a clear segregation of duties and responsibilities between the Board and the management as to which types of decisions are to be taken by the Board and which are to be delegated to management. This segregation of duties and responsibilities will be regularly reviewed by the Board. With the Chairman as a facilitator in the establishment that promotes discussion among Directors, all the Directors have brought a wide spectrum of valuable business experience, knowledge and professionalism to the Board for its efficient and effective delivery of the board functions.

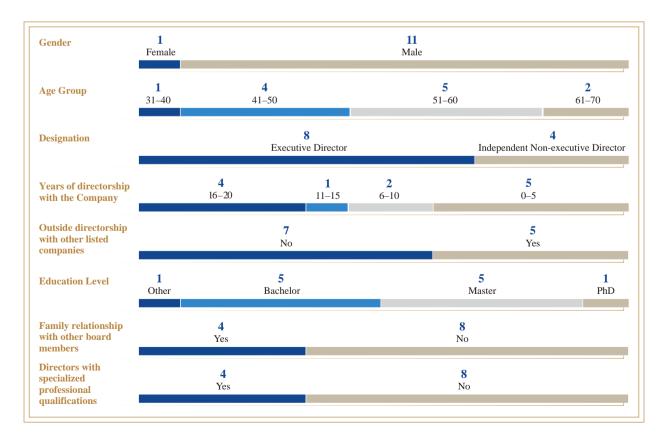
With a view to achieving a sustainable and balanced development, the Company sees increasing diversity at the board level as an essential element in supporting the attainment of its strategic objectives and its sustainable development. All board appointments will be made on a merit basis but the Company will ensure that the Board has a balance of skills, experience and diversity of perspectives appropriate to the needs of the Company's business. Selection of candidates will be based on a range of diversity perspectives, including but not limited to gender, age, cultural and educational background, independence from or relationship with other members of the Board, experience (professional or otherwise), skills, knowledge and length of service. The ultimate decision will be based on merit and contribution that the selected candidates will bring to the Board.

The nomination committee of the Company (the "Nomination Committee") will review the Board Diversity Policy, as appropriate, to ensure its effectiveness and discuss any revisions that may be required, and recommend any such revisions to the Board for consideration and approval.

#### **Nomination of Board Members and Nomination Policy**

The Company adopted a nomination policy (the "Nomination Policy"), aiming to ensure that the Board has a balance of skills, experience and diversity of perspectives appropriate to the needs of the Company's business. The Nomination Policy sets out, among others, factors that will be given due consideration to in assessing, selecting and recommending candidates for directorship to the Board and the nomination procedures, details of which are set out on pages 64 to 66 of this annual report.

For every newly appointed director, the Company will provide comprehensive, formal and tailored induction on appointment, including but not limited to, briefing from external lawyers about the governance policies of the Company, responsibilities of directors under applicable rules and regulations. He/she will also receive an information pack and has a chance to meet with the Company's management. If necessary, the Board members have access to external professional advice at the Company's expense.

#### **Independent Non-executive Directors**

One of the Independent Non-executive Directors possesses appropriate professional accounting qualifications and financial management expertise.

With a wide range of expertise and a balance of skills, the Independent Non-executive Directors bring independent judgment on issues of strategy, policy, performance, accountability, resources, key appointments and standards of conduct through their participating in board meetings and committee work.

The views of the Independent Non-executive Directors carry significant weight in the Board's decision-making process. The Board considers that each Independent Non-executive Director is independent in character and judgment and that they all meet the specific independent criteria as required by the Listing Rules. The assessments of the independence of Independent Non-executive Directors are carried out upon appointment and annually pursuant to Rule 3.13 of the Listing Rules and at any other time where the circumstances require special consideration.

#### **Chairman and Chief Executive Officer**

The posts of Chairman and CEO are segregated and each of them plays a distinct role. The segregation of such two roles ensures a clear division between the respective responsibilities of the Chairman and the CEO. The Chairman, Mr. Hon Kwok Lung, is mainly responsible for setting direction and strategies of the business development, and leading and managing the Board. The ex-CEO, Mr. Shang Jianguang, undertakes, and now the Co-CEOs, Mr. Siu Chun Wa and Mr. Hao Xiaohui, undertake, a supervisory role to manage the day-to-day operation and business of the Group.

#### **AGM, Board Meetings and Board Practices**

The Board meets regularly throughout the year to review the overall strategy, discuss business opportunities and to monitor the operation as well as the financial performance of the Group. With the assistance of the Company Secretary, the Chairman and the CEO/Co-CEOs is/are primarily responsible for drawing up and approving the agenda for each board meeting in consultation with all Directors. Notice of at least 14 days have been given to all Directors for all regular board meetings and the Directors can include matters for discussion in the agenda if necessary. Agenda and accompanying board papers in respect of regular board meetings are sent out in full to all Directors within reasonable time prior to confirmation.

Minutes of board meetings and meetings of board committees are kept by the Company Secretary. All Directors have access to board papers and related materials and are promptly provided with adequate information, which enable the Board to make an informed decision on matters placed before it.

#### **Re-election of Directors**

All Independent Non-executive Directors of the Company were appointed for a specific term and are subject to the relevant provisions of the Articles of Association of the Company whereby the Directors shall retire by rotation.

According to Article 99 of the Articles of Association of the Company, any Director appointed as an addition to the Board shall hold office only until the following general meeting of the Company and shall be eligible for re-election at that meeting. Further, according to Article 116 of the Articles of Association, at each annual general meeting, one-third of the Directors for the time being or, if their number is not a multiple of three, then the number nearest to but not less than one-third shall retire from office by rotation. Every Director should be subject to retirement by rotation at least once every three years. To enable shareholders of the Company to make an informed decision on the re-election of retiring directors at the forthcoming annual general meeting, their biographies are set out in the circular of the Company dated 29 April 2022.

#### **Continuing Professional Development**

All Directors participate in continuous professional development to develop and refresh their knowledge and skills, so as to ensure that their contribution to the Board remains informed and relevant.

To facilitate the Directors to discharge their responsibilities, monthly updates and reference materials are provided to Directors for their reading including the latest changes and development of the Listing Rules, corporate governance practices and other regulatory regime, the business and market changes, the strategic development of the Group and the information on directors' training courses. Directors are also encouraged to attend outside talks and seminars to enrich their knowledge and skills in discharging their duties.

#### **Communication with Directors**

The Company acknowledges the importance of providing sufficient and accurate information to all members of the Board on a timely basis so as to enable them to discharge their duties and responsibilities effectively. All Directors are entitled to have access to board papers and relevant materials. Agenda, board papers and those relevant materials are sent to all Directors in a timely manner before the date of a board or board committee meeting, to enable the Board to make informed decisions on matters placed before it at the meetings. All Directors are provided with monthly consolidated accounts of the Group and financial information updates giving a balanced and understandable assessment of the performance, financial position and prospects of the Group. Board briefings are issued and circulated to all members of the Board when necessary and appropriate, covering financial and operating highlights of the Group. All Directors are also provided from time to time the latest changes and development of the Listing Rules, corporate governance practice and other regulatory regime. The management is prepared to provide additional information and explanations if there are areas the Directors need to elaborate.

Independent Non-executive Directors are given the opportunity to discuss issues of the Group with the Chairman in the absence of Executive Directors. Besides, they are also given the opportunity to discuss issues of the Group with the management in the absence of Executive Directors. The Independent Non-executive Directors, also being the members of audit committee, regularly pay visit to major subsidiaries of the Company and meet the management of those subsidiaries. During the visits, Independent Non-executive Directors receive presentations from the management of subsidiaries in relation to the updated developments of those subsidiaries and review and comment on the issues concerning the internal control and risk management systems.

#### **Insurance for Directors and Officers**

The Company has arranged Directors' and Officers' Liability Insurance ("D&O Insurance") for Directors and officers of the Company. The Company undertakes an annual review of the Company's D&O Insurance policy in terms of the amount of cover, the reputation and financial strength of the potential insurer and the provisions of the insurance policy to ensure that sufficient cover and protection are provided to the Directors and officers of the Company.

#### **COMPANY SECRETARY**

Mr. Fong Chi Wah is the Chief Financial Officer and Company Secretary of the Company. The Company Secretary supports the Chairman in promoting the highest standards of corporate governance and facilitates the effective functioning of the Board and its committees. All Directors have direct access to the advice and services of the Company Secretary. The Company Secretary reports to the Chairman on board governance matters, and is responsible for ensuring that board policy and procedures are followed and for facilitating timely and appropriate information flows among Directors. The Company Secretary also plays an essential role in the communication with investors, regulators and other stakeholders. The Company Secretary and the assistant company secretary participate in a variety of trainings organized by the professional accounting and company secretarial associations. During 2021, the Company Secretary undertook over 10 hours of relevant professional training respectively to update his skills and knowledge in compliance with Rule 3.29 of the Listing Rules.

The biography of the Company Secretary is set out in the Directors and Senior Management section on page 38 of this annual report.

#### **INTERNAL AUDIT**

The Group has established its internal audit function in 2020 as required under CG Code C.2 and the Group Internal Audit applies the Standards for Professional Practice of Internal Auditing set by the Institute of Internal Auditors. The Group Internal Auditor, reporting directly to the Audit Committee of the Company and administratively to the Chief Executive Officer of the Company.

The Group Internal Auditor provides independent assurance as to the existence and effectiveness of the risk management activities and controls in the Group's business operations. The Company maintains adequate oversight of the risk through strengthening the rules of procedures of internal control and corporate governance. The audit committee reviews the internal audit reports and activities of the department as well as the adequacy and effectiveness of the internal audit function, at least annually.

Internal audit is responsible for assessing the Group's risk management and internal control systems, including reporting its findings to the Audit Committee and the senior management concerned as well as following up on the issues to ensure that they are satisfactorily resolved. In addition, internal audit maintains a regular dialogue with the Group's external auditor so that the parties are aware of the significant factors which may affect their respective scope of work.

The Board notes that the system of internal controls and risk management provides reasonable, but not absolute assurance that the Group will not be affected by any event that could be reasonably foreseen as it strives to achieve its business objectives.

#### **EXTERNAL AUDITOR**

The Group's external auditor for the year ended 31 December 2021 was BDO Limited ("BDO"). The audit committee reviews and monitors the independence of the external auditor to ensure the effectiveness of the audit process in accordance with applicable standards and the objectivity of the financial statements. BDO has made a written declaration to the audit committee that they are independent with respect to the Company and that they are not aware of any matters which may reasonably be though to bear on their independence. #### **DIRECTORS' RESPONSIBILITY STATEMENT**

The Board acknowledges its responsibility for preparing the financial statements for the year ended 31 December 2021, which give a true and fair view of the Group's state of affairs, results and cash flow for that period. In preparing the financial statements for the year ended 31 December 2021, the Board:

- (a) selected suitable accounting policies and applied them consistently;
- (b) adopted appropriate Hong Kong Financial Reporting Standards;
- (c) made adjustments and estimates that are prudent and reasonable; and
- (d) ensured that the financial statements were prepared on the going concern basis.

The Board is also responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the Company.

The Board is committed to present a balanced, clear and comprehensive assessment of the Group's performance, position and prospects.

#### **DIVIDEND POLICY**

The Company considers stable and sustainable returns to the shareholders to be our goal. The Company may declare and distribute dividends to shareholders provided that the declaration and distribution of dividends does not affect the normal operations of the Group.

A dividend policy has been approved and adopted (the "Dividend Policy") in order to provide return to the shareholders of the Company whilst retaining adequate reserves for the Group's future development.

According to the Dividend Policy, in deciding whether to propose a dividend and in determining the dividend amount, the Board shall take into account the following factors:

- (a) the Group's retained earnings and distributable reserves;
- (b) the Group's future earnings;
- (c) the Group's capital requirements;
- (d) the Group's working capital requirements;
- (e) the general financial conditions of the Group;
- (f) the Group's business development strategies and future expansion plans;
- (g) contractual restrictions on payment of dividends;
- (h) the general economic and industrial conditions; and
- (i) any other factors that the Board considers relevant.

The declaration and payment of dividends by the Company shall be determined at the sole discretion of the Board and shall be subject to any restrictions under the Companies Law of the Cayman Islands and the Articles of Association of the Company. The Dividend Policy will continue to be reviewed from time to time. There can be no assurance that dividends will be proposed or declared in any particular amount for any given period.

#### SHAREHOLDERS' RIGHT

Pursuant to Article 72 of the Articles of Association of the Company, an extraordinary general meeting shall be convened on the written requisition of any two shareholders of the Company or any one or more shareholders of the Company together holding shares carrying not less than one tenth of the voting rights at general meetings of the Company deposited at the registered office of the Company specifying the objects of the meeting and signed by the requisitionists.

If the Directors do not within twenty-one days from the date of deposit of the requisition proceed duly to convene the meeting, the requisitionists themselves may convene the general meeting in the same manner, as nearly as possible, as that in which meetings may be convened by the Directors, and all reasonable expenses incurred by the requisitionists as result of the failure of the Directors shall be reimbursed to them by the Company.

Shareholders and other stakeholders may send their enquiries and concerns to the Board by addressing them to the Company Secretary of the Company. The Company Secretary will forward the enquiries or concerns to the CEO or the chairman of the board committees or senior management of the Company as appropriate within their area of responsibilities for handling.

Shareholders are welcomed to suggest proposals relating to the operations, strategy and/or management of the Group to be discussed at shareholders' meeting. Proposal shall be sent to the Board or the Company Secretary by written requisition. Pursuant to the Articles of Association of the Company, shareholders who wish to put forward a proposal shall convene an extraordinary general meeting by following the procedures set out above.

#### COMMUNICATION WITH SHAREHOLDERS AND INVESTOR RELATIONSHIP

The Company endeavors to maintain a high level of transparency in communicating with shareholders and the investment community at large. In order to ensure effective, clear and accurate communications with the shareholders and investors, all corporate communications are arranged and handled by the Executive Directors and designated senior executives according to established practices and procedures of the Company. The Company provides up-to-date and extensive information in its annual reports, interim reports, circulars and announcements in a timely manner and within the time limits set out in the Listing Rules to ensure that all shareholders are able to form an accurate understanding of the business performance and financial position of the Group and make informed investment decisions.

The Company treats annual general meetings as the principal forum for the Board to meet and communicate with the shareholders face to face. The Chairman of the Board, all Executive Directors, chairmen of the board committees and the external auditors endeavor to attend the annual general meetings to report the business and operation of the Group to the shareholders, to answer questions and develop a balanced understanding of the view of the shareholders.

The most recent annual general meeting was the AGM 2021 held at Studio 1, 7/F, W Hong Kong, 1 Austin Road West, Kowloon, Hong Kong on 28 May 2021. At the AGM 2021, separate resolutions were proposed on each substantially separate issue including the re-election of individual directors. The procedures for demanding a poll were explained in the circular to shareholders despatched together with the Annual Report 2020. The major items discussed at the AGM 2021 were:

- receiving and adopting the audited consolidated financial statements and the report of the directors and the independent auditor's report for the year ended 31 December 2020;
- re-electing Directors and authorising the Board to fix their remuneration;
- re-appointing the auditor and authorising the Board to fix their remuneration;
- approving a general mandate to authorise the Directors to make share buy-backs; and
- approving a general mandate to authorise the Directors to allot and issue shares.

The poll results were posted on the websites of both the Company (www.irasia.com/listco/hk/citychamp) and the Stock Exchange on the same day after the AGM 2021.

The Company continues to enhance communications and relationships with investment community at large. Executive Directors and designated senior management will maintain open and active dialogues with shareholders, institutional investors, fund managers, analysts and the media. The management is pleased to help them better understand the Company and respond to enquiries raised by them during meetings, interviews and road shows, within the constraints of information already provided to the public.

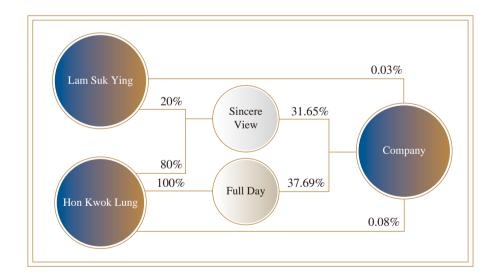

### REPORT OF THE DIRECTORS

#### CONNECTED TRANSACTION

During the year, the Group conducted the following transaction with connected person of the Company. This transaction constituted very substantial disposal and connected transaction of the Company and is subject to reporting requirements under Chapter 14A of the Listing Rules.

On 16 December 2020, after trading hours, the Company (as the vendor), Tycoon Idea Global Limited (the "Purchaser", which is an associate of Mr. Hon Kwok Lung and therefore connected person of the Company under the Listing Rules) and Sincere View International Ltd. (the "Purchaser's Guarantor") entered into the Sale and Purchase Agreement, pursuant to which the Company has conditionally agreed to sell, and the Purchaser has conditionally agreed to acquire, all the issued shares of (the "Sale Shares") and the entire sum owing to the Company (the "Sale Loans") by each of the following target companies: International Volant Limited, EB Brand Limited, Jia Cheng Investment Limited, Joyful Surplus International Limited, Sharptech International Limited, Unique Leader Limited and Sure Best Management Limited at consideration comprising (i) the consideration for the Sale Shares of HK\$1.5 billion; and (ii) the consideration for the Sale Loans of HK\$2.03 billion (being the face value of the Sale Loans as at 30 June 2020), to be paid by the Purchaser (or its nominee(s)) to the Company (or its nominee(s)), subject to adjustment at completion of the transaction. The gross proceeds to be received by the Company shall be HK\$3.53 billion, which will be settled in four stages by the Purchaser by (i) a cashier order issued by a licensed bank in Hong Kong, (ii) a banker's draft drawn against a licensed bank in Hong Kong, (iii) by telegraphic transfer to the designated bank accounts of the Company (or its nominee(s)) or as the Company may direct in writing, or (iv) by such other method as the Purchaser and the Company agree in writing.

The connected transaction was approved by independent shareholders at the extraordinary general meeting of the Company held on 25 March 2021. Pursuant to the terms of the Sale and Purchase Agreement, the completion of transaction is subject to the satisfaction or waiver (where applicable) of a number of conditions and, accordingly, may or may not proceed. The Company, the Purchaser, and the Purchaser's Guarantor (collectively, the "Parties") have entered into supplemental agreements to the Sale and Purchase Agreement on 25 June 2021 and 30 September 2021 to extend the Long Stop Date to 31 December 2021.

On 3 January 2022, the Company received a written notice from the Purchaser in relation to the termination of the Sale and Purchase Agreement. The Board of Directors believed that continuously waiting for the Completion to take place is not at the best interest of the Company and the shareholders as a whole. Accordingly, the Parties entered into a termination agreement on the same date pursuant to which the Parties have mutually agreed to terminate the Sale and Purchase Agreement.

Details are set out in the announcements of the Company dated 16 December 2020, 25 March 2021, 27 June 2021, 30 September 2021 and 3 January 2022 and circular of the Company dated 25 February 2021.

#### CONVERTIBLE SECURITIES, WARRANTS, OPTIONS OR SIMILAR RIGHTS

There is no conversion or subscription rights under any convertible securities, warrants or options or similar rights issued or granted by the Company or any of its subsidiaries during the year or subsisted at the end of the year. In addition, no equity-linked agreements were entered into by the Company, or existed during the year.

#### **DIRECTORS' INTERESTS IN A COMPETING BUSINESS**

During the year under review, no Director is considered to have an interest in a business which competes or is likely to compete, either directly or indirectly, with the businesses of the Group pursuant to the Listing Rules, other than those businesses to which the Directors were appointed as directors to represent the interest of the Company and/or the Group.

#### SUFFICIENCY OF PUBLIC FLOAT

Based on information that is publicly available to the Company and within the knowledge of the Directors, the Company's shares which are in the hands of the public represented approximately 25.49% of the Company's total issued share capital as at the date of this report, which satisfies the requirement of the Listing Rules.

#### **CORPORATE GOVERNANCE**

The Board is committed to achieving a high standard of corporate governance practices. A report on the corporate governance practices of the Company is set out on pages 39 to 52 of this annual report.

#### MODEL CODE FOR SECURITIES TRANSACTIONS

The Board has adopted the Model Code as the Company's code of conduct for dealings in securities of the Company by the Directors. Having made specific enquiry with all the Company's Directors, the Company has ascertained that all of its Directors have complied with the required standards set out in the Model Code throughout the year ended 31 December 2021.

## SPECIFIC PERFORMANCE OBLIGATIONS ON CONTROLLING SHAREHOLDER OF THE COMPANY

On 16 July 2019, the Company and a syndicate of banks (the "Syndicated Banks") entered into a facility agreement (the "Syndicated Loan Agreement"), with Hang Seng Bank Limited ("Hang Seng") as the mandated lead arranger, pursuant to which the Syndicated Banks have agreed to grant a term loan facility in the amount up to US\$150,000,000 (the "Syndicated Loan") to the Company for a term of 36 months.

Pursuant to the Syndicated Loan Agreement, it will be an event of default if (1) Mr. Hon Kwok Lung ("Mr. Hon") together with his direct family members and Ms. Sit Lai Hei (the "Hon Family") fail to maintain (i) directly or indirectly, at least 60% of the beneficial shareholding interest in the issued share capital of the Company; or (ii) control over the management and business of the Company and its subsidiaries (excluding Bendura Bank AG and its subsidiaries and Shun Heng Finance Holding (Hong Kong) Limited and its subsidiaries); or (2) Mr. Hon (or another member of the Hon Family) is not the chairman of the Board of the Company. On and at any time after the occurrence of such event which is continuing, Hang Seng as the agent may, and shall if so directed by the Syndicated Banks whose commitments aggregate  $66^2/_3\%$  or more of the total commitment, by notice to the Company, (i) cancel the commitments (and reduce them to zero); (ii) declare that all or part of the Syndicated Loan, together with accrued interest, and all other amounts accrued or outstanding be immediately due and payable; (iii) declare that all or part of the Syndicated Loan be payable on demand; and/or (iv) exercise or direct Hang Seng as the security agent to exercise any or all of its rights, remedies, powers or discretions under the Syndicated Loan Agreement.

Details are set out in the announcement of the Company dated 16 July 2019. The Company has fully repaid the loan in 2021.

#### REVIEW BY THE AUDIT COMMITTEE

The Audit Committee has reviewed with the auditor of the Company the consolidated financial statements for the year ended 31 December 2021 and has also discussed auditing, internal control and financial reporting matters including the review of the accounting practices and principles adopted by the Group.

#### **AUDITOR**

The financial statements for the year ended 31 December 2021 have been audited by BDO Limited.

A resolution will be proposed at the forthcoming annual general meeting of the Company to re-appoint BDO Limited as auditor of the Company.

It is the practice of the Company that minutes of meetings of the Audit Committee be recorded in sufficient detail of the matters considered by the Audit Committee, decisions reached, including any concerns raised by the members or dissenting views expressed. Draft and final versions of minutes of the Audit Committee are sent to the members within a reasonable time after the date of the respective meeting, for their comments and records respectively. The Company Secretary is responsible to keep all the minutes of meetings of the Audit Committee in a proper manner.

## NOMINATION COMMITTEE REPORT

The Company has established a nomination committee (the "Nomination Committee") on 26 March 2012 in compliance with the Listing Rules, terms of reference of which have been adopted by the Board of the Company and are consistent with the requirements of the CG Code. #### **Nomination Policy**

#### **Purpose**

The Nomination Policy aims to ensure that the Board has a balance of skills, experience and diversity of perspectives appropriate to the needs of the Company's business.

#### **Nomination Criteria**

- In assessing, selecting and recommending candidates for directorship to the Board, the Nomination Committee will give due consideration to the factors including but not limited to (collectively, the "Factors"):
  - (a) reputation for character and integrity;
  - (b) accomplishment and experience in the relevant industries in which the Company's business is involved and other professional qualifications;
  - (c) number of directorship the candidate holds in listed companies, commitment in respect of available time and relevant interest;
  - (d) diversity in all aspects including but not limited to gender, age, cultural
    and educational background, experience (professional or otherwise), skills,
    knowledge and length of service;
  - (e) contribution that the candidates can potentially bring to the Board;
  - (f) whether cross-directorship or significant links with other Directors through involvements in other companies or bodies exists, and
  - (g) plans in place for the orderly succession of the Board.

#### **Nomination Policy**

#### **Nomination Criteria**

The above Factors are for reference only, and not meant to be exhaustive and decisive. The Nomination Committee has the discretion to nominate any person, as it considers appropriate.

- Petiring Directors, save for those who have served as independent non-executive Directors for a period of nine consecutive years, are eligible for nomination by the Board to stand for re-election at a general meeting. If an independent non-executive Director serves more than nine years, his/her further appointment should be subject to a separate resolution to be approved by the shareholders of the Company. The circular to the shareholders accompanying that resolution should include the reasons why the Board believes he/she is still independent and should be eligible for re-election. For the avoidance of doubt, (a) the nine-year period for determining the eligibility of an independent non-executive Director for nomination by the Board to stand for election at a general meeting would count from his/her date of first appointment as an independent non-executive Director until the date of the forthcoming annual general meeting when his/her current term of service will expire at the end of that meeting; and (b) an independent non-executive Director who has been serving on the Board for a period of nine consecutive years or more may continue to hold office until expiry of his/her current term.
- In addition to the Factors, the Nomination Committee will assess, select and recommend candidates for the position of the independent non-executive director of the Company by giving due consideration to the factors including but not limited to those set out in Rules 3.10(2) and 3.13 of the Listing Rules (as amended from time to time).

#### **Nomination Procedures**

- The Board may from time to time and at any time to appoint any person as a
  Director or the Company may by ordinary resolution elect any person to be a
  Director either to fill a casual vacancy on the Board, or as an addition to the existing
  Board.
- The Nomination Committee will recommend candidates of directorship to the Board in accordance with the following procedures and process:
  - (a) the Nomination Committee may consult any source it deems appropriate in identifying or selecting suitable candidates, such as referrals from existing Directors, advertising, recommendations from third-party agency firm and proposals from shareholders of the Company with due consideration given to the Factors;
  - the Nomination Committee may adopt any process it deems appropriate in evaluating the suitability of the candidates, such as interviews, background checks, presentations and third party reference checks;
  - (c) the proposed candidates will be asked to submit the necessary personal information for the Nomination Committee's consideration. The Nomination Committee may request the candidate(s) to provide additional information and documents, if considered necessary;

- (d) upon considering a candidate suitable for the directorship, the Nomination Committee will hold a meeting and/or by way of written resolutions to, if thought fit, approve the recommendation to the Board for appointment;
- the Nomination Committee will provide the relevant information of the selected candidate to the Remuneration Committee for consideration of remuneration package of such selected candidate;
- (f) the Nomination Committee will thereafter make the recommendation to the Board in relation to the proposed appointment, and where a nonexecutive Director is considered, the Remuneration Committee will make the recommendation to the Board on the proposed remuneration package;
- (g) the Board may arrange for the selected candidate to be interviewed by the members of the Board who are not members of the Nomination Committee;
- (h) the Board will thereafter deliberate and decide the appointment or a shareholder circular will be issued and sent to shareholders of the Company in order to provide information of the candidates nominated by the Board to stand for election at a general meeting and to invite nominations from shareholders (as the case may be);
- (i) a shareholder can serve a notice to the Company within the lodgement period of its intention to propose a resolution to elect a certain person as a Director, without the Board's recommendation or the Nomination Committee's consideration and nomination, other than those candidates set out in the shareholder circular. The particulars of the candidates so proposed will be sent to all shareholders for information by a supplementary circular; and
- (j) all appointment of Directors will be confirmed by the filing of the consent to act as Director of the relevant Director (or any other similar filings requiring the relevant Director to acknowledge or accept the appointment as Director, as the case may be) to be filed with the Companies Registry of Hong Kong and updating the Register of Directors of the Company. The Director shall consent to the public disclosure of their personal data on any documents or announcements in the relevant websites for the purpose of or in relation to their appointment as a Director.
- The Board shall have the final decision on all matters relating to the appointment of Directors and its recommendation of candidates to stand for election at any general meeting.

The Nomination Committee will review this Policy, as appropriate, to ensure the effectiveness of this Policy. The Nomination Committee will discuss any revisions that may be required, and recommend any such revisions to the Board for consideration and approval.

#### Vision

The Company recognises and embraces the benefits of diversity of Board members to enhance the quality of its performance. The Company upholds that a high performing board is one that composes directors with the combination of competencies and diversity of perspectives aligning with the Company's strategy and objectives, and which is in the best position to deal with the key issues that the Company faces.

#### **Policy Statement**

With a view to achieving a sustainable and balanced development, the Company sees increasing diversity at the board level as an essential element in supporting the attainment of its strategic objectives and its sustainable development. In designing the Board's composition, board diversity has been considered from a number of aspects, including but not limited to gender, age, cultural and educational background, independence from or relationship with other members of the Board, experience (professional or otherwise), skills, knowledge and length of service. In assessing, selecting and recommending suitable candidates to fill in vacancies for directorship to the Board during the year, the Nomination Committee followed the Nomination Policy and the Board Diversity Policy. The Nomination Committee considered, including but not limited to, the candidate's social diversity (e.g. gender, race and age diversity), professional qualifications, regional and industry experience, reputation and integrity, potential contribution bring to the Board, the factors set out in Rules 3.10(2) and 3.13 of the Listing Rules (as amended from time to time), etc. The Company upholds that a high performing board composes directors with the combination of competencies and diversity of perspectives aligning with the Company's strategy and objectives, and which is in the best position to deal with the major issues that the Company faces.

The Company notes increasing diversity at the board level as an essential element in supporting the attainment of its strategic objective and its sustainable development. The Nomination Committee recommended to the Board on the appointment of Mr. Siu Chun Wa and Mr. Hao Xiaohui as Co-Chief Executive Officers and executive directors of the Company during the year to fill vacancies caused by resignations of Mr. Shang Jianguang and Mr. Lam Toi Man, with effect from 5 January 2022. Mr. Siu Chun Wa has extensive knowledge and rich experience in corporate and investment management. Mr. Siu successively served as the assistant to president, director, vice president and secretary to the board of directors of First Capital Securities Co., Ltd. (a company listed on the Shenzhen Stock Exchange, stock code: 002797). His experience and knowledge in investment management would help the Board to strengthen the development of the Company's investment strategies.

Mr. Hao Xiaohui has extensive experience in domestic and international investment and financing management. Mr. Hao has spent many years engaging in international trade, international finance, investment banking and other financial businesses and is specialized in private education investment and financing business. In the past three decades, he has successively held various senior management positions in various Chinese banks domestically and overseas. With his extensive experience in the banking industry, it is believed that he can make constructive comments to the Company's business strategies.

In our opinion, the consolidated financial statements give a true and fair view of the consolidated financial position of the Group as at 31 December 2021, and of its consolidated financial performance and its consolidated cash flows for the year then ended in accordance with Hong Kong Financial Reporting Standards issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA") and have been properly prepared in compliance with the disclosure requirements of the Hong Kong Companies Ordinance.

### **BASIS FOR OPINION**

We conducted our audit in accordance with Hong Kong Standards on Auditing ("HKSAs") issued by the HKICPA. Our responsibilities under those standards are further described in the "Auditor's Responsibilities for the Audit of the Consolidated Financial Statements" section of our report. We are independent of the Group in accordance with the HKICPA's "Code of Ethics for Professional Accountants" (the "Code"), and we have fulfilled our other ethical responsibilities in accordance with the Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

### **KEY AUDIT MATTERS**

Key audit matters are those matters that, in our professional judgement, were of most significance in our audit of the consolidated financial statements of the current period. These matters were addressed in the context of our audit of the consolidated financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

Management will perform impairment assessment on the amount of goodwill and intangible assets with indefinite useful lives at least annually, and will perform impairment assessment when there is an indication that an intangible asset with definite useful lives may be impaired. For the purpose of assessing impairment, management assessed the recoverable amount of these assets based on higher of its fair value less costs of disposal and value-in-use. These assets were allocated to cash generating units ("CGU"), and the recoverable amount of each CGU was determined by management based on either value-in-use calculations using cash flow projections or fair value less cost of disposal.

The impairment test involves significant judgements and assumptions by the management under the value-in-use calculation and the determination of fair value less cost of disposal.

Management concluded that, based on the impairment assessment, no impairment losses would be recognised for the year.

### Our response

Our procedures on the management's impairment assessment on goodwill and intangible assets included:

- (i) Assessing the reasonableness of market data, discount rates and growth rates applied in determining the recoverable amount;
- (ii) Challenging the reasonableness of other key assumptions based on our knowledge of the business and industry; and
- (iii) Checking input data to supporting evidence, such as approved budgets and considering the reasonableness of these budgets.

#### 商譽及無形資產之減值評估

參照綜合財務報表附註29及30以及綜合財務報表附註4.6、4.7及4.12之主要會計政策。

於二零二一年十二月三十一日, 貴集團擁有賬面值分別為1,151,788,000港元及52,411,000港元之商譽及無形資產,乃由於收購銀行、金融及鐘錶業務所致。

管理層將每年至少一次就商譽及具無限可使用 年期之無形資產之金額進行減值評估,並將於 有跡象顯示具有限可使用年期之無形資產可能 減值時進行減值評估。就評估減值而言,管理 層按其公平值減出售成本及使用價值之較高 評估該等資產之可收回金額。該等資產獲分配 至現金產生單位(「現金產生單位」),而各個現 金產生單位之可收回金額由管理層根據按現金 流量預測計算之使用價值或按公平值減出售成 本計算。

滅值測試需要管理層利用使用價值計算及釐定公平值減出售成本作出重大判斷及假設。

管理層總結,根據減值評估,於本年度並無確 認減值虧損。

### 我們的回應

我們關於管理層就商譽及無形資產之減值評估 程序包括以下方面:

- (i) 評估應用於釐定可收回金額之市場數據、 貼現率及增長率之合理性;
- (ii) 根據我們對業務及行業之認知質疑其他重 要假設之合理性;及
- (iii) 檢查支持證據之輸入數據,如核准預算及 考慮該等預算之合理性。

#### OTHER INFORMATION IN THE ANNUAL REPORT

The directors are responsible for the other information. The other information comprises the information included in the Company's annual report, but does not include the consolidated financial statements and our auditor's report thereon.

Our opinion on the consolidated financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the consolidated financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the consolidated financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

# DIRECTORS' RESPONSIBILITY FOR THE CONSOLIDATED FINANCIAL STATEMENTS

The directors are responsible for the preparation of consolidated financial statements that give a true and fair view in accordance with Hong Kong Financial Reporting Standards issued by the HKICPA and the disclosure requirements of the Hong Kong Companies Ordinance, and for such internal control as the directors determine is necessary to enable the preparation of consolidated financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the consolidated financial statements, the directors of the Company are responsible for assessing the Group's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the directors either intend to liquidate the Group or to cease operations, or have no realistic alternative but to do so.

The directors are also responsible for overseeing the Group's financial reporting process. The Audit Committee assists the directors in discharging their responsibilities in the regard.

### 年報之其他資料

於我們審計綜合財務報表而言,我們之責任是 閱覽其他資料,在此過程中,考慮其他資料是 否與綜合財務報表或我們在審計過程中所瞭解 之情況有重大抵觸,或者似有重大錯誤陳述。 基於已執行之工作,倘我們認為此其他資料有 重大錯誤陳述,則須報告該事實。我們概無有 關此方面之任何報告。

### 董事就綜合財務報表須承擔之責任

Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these consolidated financial statements.

As part of an audit in accordance with HKSAs, we exercise professional judgement and maintain professional skepticism throughout the audit. We also:

- identify and assess the risks of material misstatement of the consolidated financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. 合理保證屬高度保證,但並非關於根據香港核 數準則進行之審計總能發現某一存在之重大錯 誤陳述之擔保。錯誤陳述可由欺詐或錯誤引起, 倘個別或整體合理預期可影響使用者根據該等 綜合財務報表作出之經濟決定,則有關錯誤陳 述可被視作重大。

作為根據香港核數準則進行之審計工作之一部 分,我們於整個審計過程中行使專業判斷並抱 持專業懷疑態度。我們亦:

- 識別及評估綜合財務報表由於欺詐或錯 誤而導致之重大錯誤陳述風險,設計及執 行審計程序以應對該等風險,以及獲取充 分及適當審計憑證為我們之意見提供基 礎。由於欺詐可能涉及串謀、偽造、蓄意 遺漏、虛假陳述或僭越內部控制,故因未 能發現欺詐而導致之重大錯誤陳述 風險。

我們亦向審核委員會提交聲明,說明我們已遵守有關獨立性之相關道德要求,並與彼等溝通可能被合理認為會影響我們獨立性之所有關係及其他事宜以及(倘適用)為消除威脅採取措施或採用保障措施。

從與董事溝通之事項中,我們決定該等事項對本期綜合財務報表之審計最為重要,因而構成關鍵審計事項。我們在核數師報告中描述該等事項,除非法律或法規不允許公開披露該事項,或於極端罕見情況下,倘合理預期在報告中溝通某事項造成之負面後果超過其產生之公眾利益,則我們決定不應在報告中溝通該事項。

#### 1. GENERAL INFORMATION

Citychamp Watch & Jewellery Group Limited (the "Company") is a limited liability company incorporated in Cayman Islands. Its registered office address is P.O. Box 309, Ugland House, South Church Street, Grand Cayman, KY1-1104, Cayman Islands and its principal place of business is Units 1902–04, Level 19, International Commerce Centre, 1 Austin Road West, Kowloon, Hong Kong. The Company's shares are listed on The Stock Exchange of Hong Kong Limited (the "Stock Exchange").

During the year, the principal activities of the Company and its subsidiaries (together referred to as the "Group") include:

- Manufacturing and distribution of watches and timepieces;
- Property investments; and
- Banking and financial businesses.

There was no significant change in the Group's operations during the year.

The Group's principal places of the business are in Hong Kong, Switzerland, United Kingdom, Liechtenstein and the People's Republic of China (the "PRC").

Hong Kong Interpretation 5 (2020) was revised as a consequence of the amendments to HKAS 1 issued in August 2020. The revision to Hong Kong Interpretation 5 (2020) updates the wordings in the interpretation to align with the amendments to HKAS 1 with no change in conclusion and do not change the existing requirements.

The amendments clarify the distinction between changes in accounting policies and changes in accounting estimates. Among other things, the amendments now define accounting estimates as monetary amounts in financial statements that are subject to measurement uncertainty, and clarify that the effects of a change in an input or a measurement technique used to develop an accounting estimate are changes in accounting estimates unless they result from the correction of prior period errors.

# Amendments to HKAS 12, Deferred Tax Related to Assets and Liabilities arising from a Single Transaction

The amendments narrow the scope of the recognition exemption in paragraphs 15 and 24 of HKAS 12 so that it does not apply to such transactions as leases and decommissioning provisions that, on initial recognition, give rise to equal taxable and deductible temporary differences. Consequently, entities will need to recognise a deferred tax asset and a deferred tax liability for temporary differences arising on these transactions.

# Amendments to HKAS 16 – Property, Plant and Equipment: Proceeds before Intended Use

The amendments prohibit deducting from the cost of an item of property, plant and equipment any proceeds from selling items produced while bringing that asset to the location and condition necessary for it to be capable of operating in the manner intended by management. Instead, the proceeds from selling such items, and the cost of producing those items, is recognised in profit or loss.

# Amendments to HKAS 37 – Onerous Contracts – Cost of Fulfilling a Contract

The amendments specify that the 'cost of fulfilling' a contract comprises the 'costs that relate directly to the contract'. Costs that relate directly to a contract can either be incremental costs of fulfilling that contract (e.g. direct labour and materials) or an allocation of other costs that relate directly to fulfilling contracts (e.g. the allocation of the depreciation charge for an item of property, plant and equipment used in fulfilling the contract).

該等修訂禁止自物業、廠房及設備項目的成本中扣除使資產達致能夠 項目的成本中扣除使資產達致能夠 按照管理層擬定的方式開展經營所 必要的位置及條件過程中產出的項 目的銷售所得款項。相反,於溢利 或虧損中確認出售該等項目的成本。

# Amendments to HKFRS 3 – Reference to the Conceptual Framework

The amendments update HKFRS 3 so that it refers to the revised Conceptual Framework for Financial Reporting 2018 instead of the version issued in 2010. The amendments add to HKFRS 3 a requirement that, for obligations within the scope of HKAS 37, an acquirer applies HKAS 37 to determine whether at the acquisition date a present obligation exists as a result of past events. For a levy that would be within the scope of HK(IFRIC)-Int 21 Levies, the acquirer applies HK(IFRIC)-Int 21 to determine whether the obligating event that gives rise to a liability to pay the levy has occurred by the acquisition date. The amendments also add an explicit statement that an acquirer does not recognise contingent assets acquired in a business combination.

# Amendments to HKFRS 16 – COVID-19-Related Rent Concessions Beyond 30 June 2021

The amendment extends the time limit in one of the qualifying criteria of the practical expedient for COVID-19-related rent concessions from 30 June 2021 to 30 June 2022. As such, the use of the practical expedient is available to more rent concessions, in particular those involving reduction in lease payments originally due after 30 June 2021 but before 30 June 2022.

Similarly, any gains or losses resulting from the remeasurement of retained interest in any former subsidiary (that has become an associate or a joint venture) to fair value are recognised in the profit or loss only to the extent of the unrelated investors' interests in the new associate or joint venture.

### 3. BASIS OF PREPARATION

#### 3.1 Statement of compliance

The consolidated financial statements have been prepared in accordance with all applicable individual HKFRSs, Hong Kong Accounting Standards ("HKASs") and Interpretations (hereinafter collectively referred to as the "HKFRS") issued by the HKICPA. The consolidated financial statements also included the disclosure requirements of the Hong Kong Companies Ordinance and the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules").

#### 3.2 Historical cost convention

The consolidated financial statements have been prepared under historical cost basis except for investment properties and certain financial instruments, which are measured at fair value. The adoption of new or revised HKFRSs and the impacts on the Group's consolidated financial statements, if any, are disclosed in note 2.

It should be noted that accounting estimates and assumptions are used in preparing these consolidated financial statements. Although these estimates are based on management's best knowledge and judgement of current events and actions, actual results may ultimately differ from those estimates.

#### 3.3 Functional and presentation currency

The consolidated financial statements are presented in Hong Kong Dollars ("HK\$"), which is also the functional currency of the Company and all values are rounded to the nearest thousand ("HK\$'000") unless otherwise stated.

#### 4. SIGNIFICANT ACCOUNTING POLICIES

### 4.1 Business combination and basis of consolidation

The consolidated financial statements comprise the financial statements of the Company and its subsidiaries. Inter-company transactions and balances between group companies together with unrealised profits are eliminated in full in preparing the consolidated financial statements. Unrealised losses are also eliminated unless the transaction provides evidence of impairment on the asset transferred, in which case the loss is recognised in profit or loss.

The results of subsidiaries acquired or disposed of during the year are included in the consolidated statement of comprehensive income from the effective dates of acquisition or up to the effective dates of disposal, as appropriate. Where necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies into line with those used by other members of the Group.

Acquisition of subsidiaries or businesses is accounted for using acquisition method. The cost of an acquisition is measured at the aggregate of the acquisition-date fair value of assets transferred, liabilities incurred and equity interests issued by the Group, as the acquirer. The identifiable assets acquired and liabilities assumed are principally measured at acquisition-date fair value. The Group's previously held equity interest in the acquire is re-measured at acquisition-date fair value and the resulting gains or losses are recognised in profit or loss. The Group may elect, on a transactionby-transaction basis, to measure non-controlling interest that represent present ownership interests in the subsidiary either at fair value or at the proportionate share of the acquiree's identifiable net assets. All other non-controlling interests are measured at fair value unless another measurement basis is required by HKFRSs. Acquisition-related costs incurred are expensed unless they are incurred in issuing equity instruments in which case the costs are deducted from equity.

Subsequent adjustments to consideration are recognised against goodwill only to the extent that they arise from new information obtained within the measurement period (a maximum of 12 months from the acquisition date)

they arise from new information obtained within the measurement period (a maximum of 12 months from the acquisition date) about the fair value at the acquisition date. All other subsequent adjustments to contingent consideration classified as an asset or a liability are recognised in profit or loss.

Contingent consideration balances arising from business combinations whose acquisition dates preceded 1 January 2010 (i.e. the date the Group first applied HKFRS 3 (2008)) have been accounted for in accordance with the transition requirements in the standard. Such balances are not adjusted upon first application of the standard. Subsequent revisions to estimates of such consideration are treated as adjustments to the cost of these business combinations and are recognised as part of goodwill.

Changes in the Group's interests in subsidiaries that do not result in a loss of control are accounted for as equity transactions. The carrying amounts of the Group's interest and the non-controlling interests are adjusted to reflect the changes in their relative interests in the subsidiaries. Any difference between the amount by which the non-controlling interests is adjusted and the fair value of the consideration paid or received is recognised directly in equity and attributed to owners of the Company.

When the Group loses control of a subsidiary, the profit or loss on disposal is calculated as the difference between (i) the aggregate of the fair value of the consideration received and the fair value of any retained interest and (ii) the previous carrying amount of the assets (including goodwill), and liabilities of the subsidiary and any non-controlling interests. Amounts previously recognised in other comprehensive income in relation to the subsidiary are accounted for in the same manner as would be required if the relevant assets or liabilities were disposed of.

Subsequent to acquisition, the carrying amount of non-controlling interests that represent present ownership interests is the amount of those interests at initial recognition plus such non-controlling interests' share of subsequent changes in equity. Total comprehensive income is attributed to such non-controlling interests even if this results in the non-controlling interests having a deficit balance.

#### 4.2 Subsidiaries

A subsidiary is an investee over which the Company is able to exercise control. The Company controls an investee if all three of the following elements are present: power over the investee, exposure, or rights, to variable returns from the investee, and the ability to use its power to affect those variable returns. Control is reassessed whenever facts and circumstances indicate that there may be a change in any of these elements of control.

In the Company's statement of financial position, investments in subsidiaries are stated at cost less impairment loss, if any. The results of subsidiaries are accounted for by the Company on the basis of dividend received and receivable.

#### 4.3 Structured entities

The collective investment instruments of the Group are structured entities as defined under HKFRS 12. If the Group operates such an investment instrument acting as an agent primarily in the interests of investors, this structured entity is not consolidated. Investments in such investment instruments held by the Group are recognised as financial instruments. If the Group acts as principal primarily in its own interests, the investment instrument is consolidated.

#### 4.4 Associates

An associate is an entity over which the Group has significant influence and that is neither a subsidiary nor a joint arrangement. Significant influence is the power to participate in the financial and operating policy decisions of the investee but not control or joint control over those policies.

Associates are accounted for using the equity method whereby they are initially recognised at cost and thereafter, their carrying amount are adjusted for the Group's share of the post-acquisition change in the associates' net assets except that losses in excess of the Group's interest in the associate are not recognised unless there is an obligation to make good those losses.

Profits and losses arising on transactions between the Group and its associates are recognised only to the extent of unrelated investors' interests in the associate. The investor's share in the associate's profits and losses resulting from these transactions is eliminated against the carrying value of the associate. Where unrealised losses provide evidence of impairment of the asset transferred they are recognised immediately in profit or loss.

#### 4.2 附屬公司

附屬公司指本公司可對其行使控制權之被投資方。倘下列三項因素全部存在,則本公司控制被投資方:對被投資方擁有權力、就被投資方擁有權力人,就被投資資源與國報承受風險或享有權利及能夠運用其權力影響該等可變回報。當事實及情況顯示任何該等控制權因素可能發生變動,則會重新評估控制權。

於本公司之財務狀況表中,於附屬公司之投資按成本減任何減值虧損(如有)列賬。本公司按已收或應收股息將附屬公司業績入賬。

### 4.3 結構實體

本集團集體投資工具為香港財務報告準則第12號所界定之結構實體。 倘本集團主要為投資者之利益充當 代理人經營該投資工具,則本結構 實體不予綜合入賬。本集團持有於 該投資工具之投資確認為金融工 具。倘本集團主要為其自身利益作 為當事人行事,則投資工具綜合入 賬。

#### 4.4 聯營公司

聯營公司為本集團可對其行使重大 影響力,且並非附屬公司或共同安 排之實體。重大影響力指參與被投 資方之財務及經營政策決定,但並 非對該等政策實施控制或共同控制 之權力。

本集團以權益會計法將聯營公司入 賬,初步按成本確認,其後按本集 團應佔聯營公司之資產淨值於收購 後之變動調整其賬面值。惟數額超 出本集團於聯營公司權益之虧損不 予確認,除非本集團有責任彌補該 等虧損。

本集團與其聯營公司之間進行交易 產生之溢利或虧損僅以聯營公司之 無關投資者權益確認。投資者因進 行該等交易而分佔聯營公司之溢利 及虧損與聯營公司賬面值對銷。當 未變現虧損有證據顯示已轉讓資產 減值,則即時於溢利或虧損確認。

#### **4.4 Associates** (Continued)

Any premium paid for an associate above the fair value of the Group's share of the identifiable assets, liabilities and contingent liabilities acquired is capitalised and included in the carrying amount of the associate. Where there is objective evidence that the investment in an associate has been impaired, the carrying amount of the investment is tested for impairment in the same way as other non-financial assets. Accounting policies on impairment of interests in associates are described in note 4.7 below.

### 4.5 Joint arrangements

The Group is a party to a joint arrangement where there is a contractual arrangement that confers joint control over the relevant activities of the arrangement to the group and at least one other party. Joint control is assessed under the same principles as control over subsidiaries.

The Group classifies its interests in joint arrangements as either:

- Joint ventures: where the Group has rights to only the net assets of the joint arrangement; or
- Joint operations: where the Group has both the rights to assets and obligations for the liabilities of the joint arrangement.

In assessing the classification of interests in joint arrangements, the Group considers:

- The structure of the joint arrangement;
- The legal form of joint arrangements structured through a separate vehicle;
- The contractual terms of the joint arrangement agreement; and
- Any other facts and circumstances (including any other contractual arrangements).

Any premium paid for an investment in a joint venture above the fair value of the Group's share of the identifiable assets, liabilities and contingent liabilities acquired is capitalised and included in the carrying amount of the investment in joint venture. Where there is objective evidence that the investment in a joint venture has been impaired the carrying amount of the investment is tested for impairment in the same way as other non-financial assets.

### 4.4 聯營公司(續)

任何就聯營公司支付之溢價高於本 集團應佔所收購可識別資產、負債 及或然負債公平值之差額會撥充資 本,並於聯營公司賬面值入賬。倘有 客觀證據表明於聯營公司之投資已 減值,則有關投資賬面值按與其他 非金融資產相同之方式測試減值。 有關於聯營公司權益減值之會計政 策載於下文附註4.7。

#### 4.5 合營安排

倘合約安排賦予本集團及至少一名 其他訂約方對安排之相關活動之共 同控制權時,則本集團為合營安排 之訂約方。共同控制權乃根據與附 屬公司控制權之相同原則予以評估。

本集團將其於合營安排之權益分類 為:

- 合營企業:本集團僅對合營安 排之資產淨值擁有權利;或

評估於合營安排之權益之分類時, 本集團會考慮:

- 合營安排之結構;

- 任何其他事實及情況(包括任何其他合約安排)。

任何就合營企業投資支付之溢價高 於本集團應佔所收購可識別資產、 負債及或然負債公平值之差額會撥 充資本,並於合營企業投資賬面值 入賬。倘有客觀證據表明於合營企 業之投資已減值,則有關投資賬面 值按與其他非金融資產相同之方式 測試減值。

#### 4.6 Goodwill

Goodwill is initially recognised at cost being the excess of the aggregate of consideration transferred and the amount recognised for non-controlling interests over the fair value of identifiable assets, liabilities and contingent liabilities acquired. The consideration transferred is measured at the aggregate of fair values, at the date of exchange, of assets given, liabilities incurred or assumed, and equity instruments issued by the Group.

Where the fair value of identifiable assets, liabilities and contingent liabilities exceed the fair value of consideration paid, the amount of any non-controlling interests in the acquiree and the acquisition date fair value of the acquirer's previously held equity interest in the acquiree, the excess is recognised in profit or loss on the acquisition date, after re-assessment.

Goodwill is measured at cost less accumulated impairment losses. For the purpose of impairment testing, goodwill arising from an acquisition is allocated to each of the relevant cash generating units that are expected to benefit from the synergies of the acquisition. A cash generating unit is the smallest identifiable group of assets that generates cash inflows that are largely independent of the cash inflows from other assets or groups of assets. A cash generating unit to which goodwill has been allocated is tested for impairment annually, and whenever there is an indication that the unit may be impaired.

For goodwill arising on an acquisition in a financial year, the cash generating unit ("CGU") to which goodwill has been allocated is tested for impairment before the end of that financial year. When the recoverable amount of the CGU is less than the carrying amount of the unit, the impairment loss is allocated to reduce the carrying amount of any goodwill allocated to the unit first, and then to the other assets on pro-rata basis over the carrying amount of each asset in the unit. However, the loss allocated to each asset will not reduce the individual asset's carrying amount to below its fair value less cost of disposal (if measurable) or its value-in-use (if determinable), whichever is the higher. Any impairment loss for goodwill is recognised in profit or loss and is not reversed in subsequent periods.

#### 4.7 Impairment of non-financial assets

At the end of each reporting period, the Group reviews the carrying amounts of the following assets to determine whether there is any indication that those assets have suffered an impairment loss or an impairment loss previously recognised no longer exists or may have decreased:

- property, plant and equipment;
- intangible assets; and
- · interests in subsidiaries, associates and joint ventures.

If the recoverable amount (i.e. the higher of the fair value less costs of disposal and value-in-use) of an asset is estimated to be less than its carrying amount, the carrying amount of the asset is reduced to its recoverable amount. An impairment loss is recognised in profit or loss immediately, unless the relevant asset is carried at a revalued amount under another HKFRS, in which case the impairment loss is treated as a revaluation decrease under that HKFRS.

Where an impairment loss subsequently reverses, the carrying amount of the asset is increased to the revised estimate of its recoverable amount to the extent that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset in prior years. A reversal of an impairment loss is recognised in profit or loss immediately.

Value-in-use is based on the estimated future cash flows expected to be derived from the asset or cash generating unit (note 4.6), discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset or cash generating unit.

Cost comprises direct costs incurred during the periods of construction, installation and testing. CIP is reclassified to the appropriate class of property, plant and equipment when substantially all the activities necessary to prepare the assets for their intended use are completed. No depreciation is provided for in respect of CIP until it is completed and ready for its intended use.

The gain or loss arising on retirement or disposal is determined as the difference between the net sale proceeds and the carrying amount of the asset and is recognised in profit or loss.

#### 4.10 Investment properties

Investment properties are land and/or buildings which are owned or held under a leasehold interest to earn rental income and/or for capital appreciation.

On initial recognition, investment property is measured at cost, including any directly attributable expenditure. Subsequent to initial recognition, investment property is stated at fair value. Fair value is determined by external professional valuers, with sufficient experience with respect to both the location and the nature of the investment property. The carrying amounts recognised in the consolidated statement of financial position reflect the prevailing market conditions at the reporting date.

#### Accounting as a lessee

All leases are required to be capitalised in the consolidated statement of financial position as right-of-use assets and lease liabilities, but accounting policy choices exist for an entity to choose not to capitalise (i) leases which are short-term leases and/or (ii) leases for which the underlying asset is of low-value. The Group has elected not to recognise right-of-use assets and lease liabilities for low-value assets and leases for which at the commencement date have a lease term 12 months or less. The lease payments associated with those leases have been expensed on straight-line basis over the lease term.

#### Right-of-use assets

The right-of-use assets should be recognised at cost and would comprise: (i) the amount of the initial measurement of the lease liability (see below for the accounting policy to account for lease liability); (ii) any lease payments made at or before the commencement date, less any lease incentives received; (iii) any initial direct costs incurred by the lessee and (iv) an estimate of costs to be incurred by the lessee in dismantling and removing the underlying asset to the condition required by the terms and conditions of the lease, unless those costs are incurred to produce inventories. Except for right-of-use asset that meets the definition of an investment property or a class of property, plant and equipment to which the Group applies the revaluation model, the Group measures the right-of-use assets applying a cost model. Under the cost model, the Group measures the right-to-use assets at cost, less any accumulated depreciation and any impairment losses, and adjusted for any remeasurement of lease liability. For right-of-use asset that meets the definition of an investment property, they are carried at fair value.

The Group accounts for leasehold land and buildings that are held for rental or capital appreciation purpose under HKAS 40 and are carried at fair value.

The following payments for the right-to-use the underlying asset during the lease term that are not paid at the commencement date of the lease are considered to be lease payments: (i) fixed payments less any lease incentives receivable: (ii) variable lease payments that depend on an index or a rate, initially measured using the index or rate as at commencement date; (iii) amounts expected to be payable by the lessee under residual value guarantees; (iv) the exercise price of a purchase option if the lessee is reasonably certain to exercise that option and (v) payments of penalties for terminating the lease, if the lease term reflects the lessee exercising an option to terminate the lease.

Subsequent to the commencement date, the Group measures the lease liabilities by: (i) increasing the carrying amount to reflect interest on the lease liabilities; (ii) reducing the carrying amount to reflect the lease payments made; and (iii) remeasuring the carrying amount to reflect any reassessment or lease modifications, or to reflect revised in-substance fixed lease payments.

When the Group revises its estimate of the term of any lease (because, for example, it re-assesses the probability of a lessee extension or termination option being exercised), it adjusts the carrying amount of the lease liability to reflect the payments to make over the revised term, which are discounted using a revised discount rate. The carrying value of lease liabilities is similarly revised when the variable element of future lease payments dependent on a rate or index is revised, except the discount rate remains unchanged. In both cases, an equivalent adjustment is made to the carrying value of the right-of-use asset, with the revised carrying amount being amortised over the remaining (revised) lease term. If the carrying amount of the right-of-use asset is adjusted to zero, any further reduction is recognised in profit or loss.

#### Accounting as a lessor

The Group has leased out its investment properties to a number of tenants. Rental income from operating leases is recognised in profit or loss on a straight-line basis over the term of the relevant lease. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised as an expense on the straight-line basis over the lease term.

When the Group acts as a lessor, it determines at lease inception whether each lease is a finance lease or an operating lease. A lease is classified as a finance lease if it transfers substantially all the risks and rewards incidental to the ownership of an underlying assets to the lessee. If this is not the case, the lease is classified as an operating lease.

When the Group is an intermediate lessor, the sub-leases are classified as a finance lease or as an operating lease with reference to the right-of-use asset arising from the head lease. If the head lease is a short-term lease to which the Group applies the exemption, then the Group classifies the sub-lease as an operating lease.

#### (iii) Impairment

Intangible assets with definite useful lives are tested for impairment when there is an indication that an asset may be impaired. Intangible assets with indefinite useful lives and intangible assets not yet available for use are tested for impairment annually, irrespective of whether there is any indication that they may be impaired. Intangible assets are tested for impairment by comparing their carrying amounts with their recoverable amounts (note 4.7).

If the recoverable amount of an asset is estimated to be less than its carrying amount, the carrying amount of the asset is reduced to its recoverable amount.

An impairment loss is recognised as an expense immediately.

When an impairment loss subsequently reverses, the carrying amount of the asset is increased to the revised estimate of its recoverable amount; however, the carrying amount should not be increased above the lower of its recoverable amount and the carrying amount that would have resulted had no impairment loss been recognised for the asset in prior years. All reversals are recognised in the profit or loss immediately.

A financial asset (unless it is a trade receivable without a significant financing component) is initially measured at fair value plus, for an item not at fair value through profit or loss ("FVPL"), transaction costs that are directly attributable to its acquisition or issue. A trade receivable without a significant financing component is initially measured at the transaction price.

All regular way purchases and sales of financial assets are recognised on the trade date, that is, the date that the Group commits to purchase or sell the asset. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the period generally established by regulation or convention in the market place.

Financial assets with embedded derivatives are considered in their entirely when determining whether their cash flows are solely payment of principal and interest.

### **Debt instruments**

Subsequent measurement of debt instruments depends on the Group's business model for managing the asset and the cash flow characteristics of the asset. There are three measurement categories into which the Group classifies its debt instruments:

Amortised cost: Assets that are held for collection of contractual cash flows where those cash flows represent solely payments of principal and interest are measured at amortised cost. Financial assets at amortised cost are subsequently measured using the effective interest rate method. Interest income, foreign exchange gains and losses and impairment are recognised in profit or loss. Any gain on derecognition is recognised in profit or loss.

Fair value through other comprehensive income ("FVOCI"): Assets that are held for collection of contractual cash flows and for selling the financial assets, where the assets' cash flows represent solely payments of principal and interest, are measured at FVOCI. Debt investments at fair value through other comprehensive income are subsequently measured at fair value. Interest income calculated using the effective interest rate method, foreign exchange gains and losses and impairment are recognised in profit or loss. Other net gains and losses are recognised in other comprehensive income. On derecognition, gains and losses accumulated in other comprehensive income are reclassified to profit or loss.

FVPL include financial assets held for trading, financial assets designated upon initial recognition at fair value through profit or loss, or financial assets mandatorily required to be measured at fair value. Financial assets are classified as held for trading if they are acquired for the purpose of selling or repurchasing in the near term. Derivatives, including separated embedded derivatives, are also classified as held for trading unless they are designated as effective hedging instruments. Financial assets with cash flows that are not solely payments of principal and interest are classified and measured at fair value through profit or loss, irrespective of the business model. Notwithstanding the criteria for debt instruments to be classified at amortised cost or at fair value through other comprehensive income, as described above, debt instruments may be designated at fair value through profit or loss on initial recognition if doing so eliminates, or significantly reduces, an accounting mismatch.

## **Equity instruments**

On initial recognition of an equity investment that is not held for trading, the Group could irrevocably elect to present subsequent changes in the investment's fair value in other comprehensive income. This election is made on an investment-by-investment basis. Equity investments at fair value through other comprehensive income are measured at fair value. Dividend income are recognised in profit or loss unless the dividend income clearly represents a recovery of part of the cost of the investments. Other net gains and losses are recognised in other comprehensive income and are not reclassified to profit or loss. All other equity instruments are classified as FVPL, whereby changes in fair value, dividends and interest income are recognised in profit or loss.

# (ii) Impairment loss on financial assets

The Group recognises loss allowances for expected credit loss ("ECL") on trade receivables, contract assets, financial assets measured at amortised cost and debt investments measured at FVOCI. The ECLs are measured on either of the following bases: (1) 12 months ECLs: these are the ECLs that result from possible default events within the 12 months after the reporting date: and (2) lifetime ECLs: these are ECLs that result from all possible default events over the expected life of a financial instrument. The maximum period considered when estimating ECLs is the maximum contractual period over which the Group is exposed to credit risk.

ECLs are a probability-weighted estimate of credit losses. Credit losses are measured as the difference between all contractual cash flows that are due to the Group in accordance with the contract and all the cash flows that the Group expects to receive. The shortfall is then discounted at an approximation to the assets' original effective interest rate.

The Group measures loss allowances for trade receivables using HKFRS 9 simplified approach and has calculated ECLs based on lifetime ECLs. The Group has established a provision matrix that is based on the Group's historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

For other debt financial assets at amortised cost or at FVOCI, the ECLs are based on the 12-months ECLs. However, when there has been a significant increase in credit risk since origination, the allowance will be based on the lifetime ECLs.

For the due from clients and due from banks, except for precious metal, ECL is determined by reference to the estimation of the exposure at default ("EAD"), probability of default ("PD") as well as a loss given default ("LGD"). The 12-months and lifetime PDs represent the probability of default occurring over the next 12 months and the remaining maturity of the instrument respectively. The EAD represents the expected balance at default, taking into account the repayment of principal and interest from the reporting date to the default event together with any expected drawdowns of committed facilities. The LGD represents expected losses on the EAD given the event of default, taking into account, among other attributes, the mitigating effect of collateral value at the time it is expected to be realised and the time value of money.

When determining whether the credit risk of a financial asset has increased significantly since initial recognition and when estimating ECL, the Group considers reasonable and supportable information that is relevant and available without undue cost or effort. This includes both quantitative and qualitative information analysis, based on the Group's historical experience and informed credit assessment and including forward-looking information.

The Group assumes that the credit risk on a financial asset has increased significantly if it is more than 30 days past due.

The Group considers a financial asset to be credit-impaired when: (1) the borrower is unlikely to pay its credit obligations to the Group in full, without recourse by the Group to actions such as realising security (if any is held); or (2) the financial asset is more than 90 days past due.

Interest income on credit-impaired financial assets is calculated based on the amortised cost (i.e. the gross carrying amount less loss allowance) of the financial asset. For non credit-impaired financial assets interest income is calculated based on the gross carrying amount.

In making this reassessment, the Group considers that a default event occurs when (i) the debtor is unlikely to pay its credit obligations to the group in full, without recourse by the Group to actions such as realising security (if any is held); or (ii) the financial asset is 90 days past due. The Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort. In particular, the following information is taken into account when assessing whether credit risk has increased significantly since initial recognition:

- failure to make payments of principal or interest on their contractually due dates;
- an actual or expected significant deterioration in a financial instrument's external or internal credit rating (if available);
- an actual or expected significant deterioration in the operating results of the debtor; and
- existing or forecast changes in the technological, market, economic or legal environment that have a significant adverse effect on the debtor's ability to meet its obligation to the Group.

For loan commitments, the date of initial recognition for the purpose of assessing ECLs is considered to be the date that the group becomes a party to the irrevocable commitment. In assessing whether there has been a significant increase in credit risk since initial recognition of a loan commitment, the Group considers changes in the risk of default occurring on the loan to which the loan commitment relates.

#### (iii) Financial liabilities

The Group classifies its financial liabilities, depending on the purpose for which the liabilities were incurred. Financial liabilities at fair value through profit or loss are initially measured at fair value and financial liabilities at amortised cost are initially measured at fair value, net of directly attributable costs incurred.

# Financial liabilities at fair value through profit or loss

Financial liabilities at fair value through profit or loss include financial liabilities held for trading and financial liabilities designated upon initial recognition as at fair value through profit or loss.

Financial liabilities are classified as held for trading if they are acquired for the purpose of sale in the near term. Derivatives, including separated embedded derivatives, are also classified as held for trading unless they are designated as effective hedging instruments. Gains or losses on liabilities held for trading are recognised in profit or loss.

Where a contract contains one or more embedded derivatives, the entire hybrid contract may be designated as a financial liability at fair value through profit or loss, except where the embedded derivative does not significantly modify the cash flows or it is clear that separation of the embedded derivative is prohibited.

Financial liabilities may be designated upon initial recognition as at fair value through profit or loss if the following criteria are met: (i) the designation eliminates or significantly reduces the inconsistent treatment that would otherwise arise from measuring the liabilities or recognising gains or losses on them on a different basis; (ii) the liabilities are part of a group of financial liabilities which are managed and their performance evaluated on a fair value basis, in accordance with a documented risk management strategy; or (iii) the financial liability contains an embedded derivative that would need to be separately recorded.

Subsequent to initial recognition, financial liabilities at fair value through profit or loss are measured at fair value, with changes in fair value recognised in profit or loss in the period in which they arise, except for the gains and losses arising from the Group's own credit risk which are presented in other comprehensive income with no subsequent reclassification to the statement of profit or loss. The net fair value gain or loss recognised in the statement of profit or loss does not include any interest charged on these financial liabilities.

# Financial liabilities at amortised cost

Financial liabilities at amortised cost including trade payables, borrowings, and other financial liabilities are subsequently measured at amortised cost, using the effective interest method. The related interest expense is recognised in profit or loss.

Gains or losses are recognised in profit or loss when the liabilities are derecognised as well as through the amortisation process.

# (iv) Effective interest method

The effective interest method is a method of calculating the amortised cost of a financial asset or financial liability and of allocating interest income or interest expense over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash receipts or payments through the expected life of the financial asset or liability, or where appropriate, a shorter period.

# (vi) Financial guarantee contracts

A financial guarantee contract is a contract that requires the issuer to make specified payments to reimburse the holder for a loss it incurs because a specified debtor fails to make payment when due in accordance with the original or modified terms of a debt instrument. A financial guarantee contract issued by the Group and not designated as at fair value through profit or loss is recognised initially at its fair value less transaction costs that are directly attributable to the issue of the financial guarantee contract. Subsequent to initial recognition, the Group measures the financial guarantee contact at the higher of: (i) the amount of the loss allowance, being the ECL provision measured in accordance with principles of the the accounting policy set out in 4.13(ii); and (ii) the amount initially recognised less, when appropriate, cumulative amortisation recognised in accordance with the principles of HKFRS 15.

## (vii) Derecognition

The Group derecognises a financial asset when the contractual rights to the future cash flows in relation to the financial asset expire or when the financial asset has been transferred and the transfer meets the criteria for derecognition in accordance with HKFRS 9.

Financial liabilities are derecognised when the obligation specified in the relevant contract is discharged, cancelled or expires.

Where the Group issues its own equity instruments to a creditor to settle a financial liability in whole or in part as a result of renegotiating the terms of that liability, the equity instruments issued are the consideration paid and are recognised initially and measured at their fair value on the date the financial liability or part thereof is extinguished. If the fair value of the equity instruments issued cannot be reliably measured, the equity instruments are measured to reflect the fair value of the financial liability extinguished. The difference between the carrying amount of the financial liability or part thereof extinguished and the consideration paid is recognised in profit or loss for the year.

The gross carrying amount of a financial asset is written off either partially or in full) to the extent that there is no realistic prospect of recovery. This is generally the case when the group determines that the debtor does not have assets or sources of income that could generate sufficient cash flows to repay the amounts subject to the write-off.

Subsequent recoveries of an asset that was previously written off are recognised as a reversal of impairment in profit or loss in the period in which the recovery occurs.

#### 4.14 Inventories

Inventories are initially recognised at cost, and subsequently at the lower of cost and net realisable value. Cost is determined using weighted average basis, and in the case of work-in-progress and finished goods, comprises direct materials, direct labour and an appropriate proportion of overheads. Net realisable value is the estimated selling price in the ordinary course of business less any applicable selling expense and the estimated costs necessary to make the sale.

# 4.15 Cash and cash equivalents

Cash and cash equivalents include cash and bank balances, demand deposits with banks, and short-term highly liquid investments with original maturities of three months or less that are readily convertible to a known amount of cash and subject to an insignificant risk of changes in values.

## 4.16 Government grants

Government grants are recognised when there is reasonable assurance that they will be received and that the Group will comply with the conditions attaching to them. Grants that compensate the Group for expenses incurred are recognised as revenue in profit or loss on a systematic basis in the same periods in which the expenses are incurred. Grants that compensate the Group for the cost of an asset are deferred and recognised in profit or loss over the useful life of the asset.

Provisions are recognised when the Group has a present obligation (legal or constructive) as a result of a past event, and it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditures expected to settle the obligation.

All provisions are reviewed at each reporting date and adjusted to reflect the current best estimate.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future uncertain events not wholly within the control of the Group, are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

Contingent liabilities are recognised in the course of the allocation of purchase price to the assets and liabilities acquired in a business combination. They are initially measured at fair value at the date of acquisition and subsequently measured at the higher of the amount that would be recognised in a comparable provision as described above and the amount initially recognised less any accumulated amortisation, if appropriate.

## 4.18 Income tax

Income tax comprises current tax and deferred tax.

Current tax is based on the profit or loss from ordinary activities adjusted for items that are non-assessable or disallowable for income tax purposes and is calculated using tax rates that have been enacted or substantively enacted at the end of reporting period.

Deferred tax is recognised in respect of temporary differences between the carrying amounts of assets and liabilities for financial reporting purposes and the corresponding amounts used for tax purposes. Except for goodwill and recognised assets and liabilities that affect neither accounting nor taxable profits, deferred tax liabilities are recognised for all taxable temporary differences. Deferred tax assets are recognised to the extent that it is probable that taxable profits will be available against which deductible temporary differences can be utilised, provided that the deductible temporary differences are not arises from initial recognition of assets and liabilities in a transaction other than in a business combination that affects neither taxable profit nor the accounting profit. Deferred tax is measured at the tax rates appropriate to the expected manner in which the carrying amount of the asset or liability is realised or settled and that have been enacted or substantively enacted at the end of reporting period.

An exception to the general requirement on determining the appropriate tax rate used in measuring deferred tax amount is when an investment property is carried at fair value under HKAS 40 "Investment Property". Unless the presumption is rebutted, the deferred tax amounts on these investment properties are measured using the tax rates that would apply on sale of these investment properties at their carrying amounts at the reporting date. The presumption is rebutted when the investment property is depreciable and is held within a business model whose objective is to consume substantially all the economic benefits embodied in the property over time, rather than through sale.

Deferred tax liabilities are recognised for taxable temporary differences arising on investments in subsidiaries and associates, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future.

Income taxes are recognised in profit or loss except when they relate to items recognised in other comprehensive income in which case the taxes are also recognised in other comprehensive income or when they relate to items recognised directly in equity in which case the taxes are also recognised directly in equity.

- (a) the Group has a legally enforceable right to set off current tax assets against current tax liabilities; and

  - (i) the same taxable entity; or
  - (ii) different taxable entities which intend either to settle current tax liabilities and assets on a net basis, or to realise the assets and settle the liabilities simultaneously, in each future period in which significant amounts of deferred tax liabilities or assets are expected to be settled or recovered.

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services, excluding those amounts collected on behalf of third parties. Revenue excludes value added tax or other sales taxes and is after deduction of any trade discounts.

Depending on the terms of the contract and the laws that apply to the contract, control of the goods or service may be transferred over time or at a point in time. Control of the goods or service is transferred over time if the Group's performance:

- provides all of the benefits received and consumed simultaneously by the customer;
- creates or enhances an asset that the customer controls as the Group performs; or
- does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

If control of the goods or services transfers over time, revenue is recognised over the period of the contract by reference to the progress towards complete satisfaction of that performance obligation. Otherwise, revenue is recognised at a point in time when the customer obtains control of the goods or service.

When the contract contains a financing component which provides the customer a significant benefit of financing the transfer of goods or services to the customer for more than one year, revenue is measured at the present value of the amounts receivable, discounted using the discount rate that would be reflected in a separate financing transaction between the Group and the customer at contract inception.

Where the contract contains a financing component which provides a significant financing benefit to the Group, revenue recognised under that contract includes the interest expense accreted on the contract liability under the effective interest method. For contracts where the period between the payment and the transfer of the promised goods or services is one year or less, the transaction price is not adjusted for the effects of a significant financing component, using the practical expedient in HKFRS 15.

A contract asset represents the Group's right to consideration in exchange for services that the Group has transferred to a customer that is not yet unconditional. In contrast, a receivable represents the Group's unconditional right to consideration, i.e. only the passage of time is required before payment of that consideration is due.

A contract liability represents the Group's obligation to transfer services to a customer for which the Group has received consideration (or an amount of consideration is due) from the customer.

### (a) Service fees and commission income

Service fees and commission income is generally recognised when the corresponding service is provided.

Service fees and commission income are recognised at a point in time when the relevant services such as broking services, provided to the customers and there is no unfulfilling performance obligation after services rendering. Except for a few services, such as custody account services, of which revenue is recognised over time so as to depict the pattern of delivery of services.

Origination or commitment fees received/paid by the Group which result in the creation or acquisition of a financial asset are deferred and recognised as an adjustment to the effective interest rate. When a loan commitment is not expected to result in the draw-down of a loan, loan commitment fees are recognised.

## (b) Sales of goods

Revenue from sales of goods is recognised at a point in time as when the control of the goods has been transferred to the customer and there is no unfulfilling performance obligation after the acceptance of the goods.

# i) Revenue from other sources

### (a) Interest income

Interest income arising from the use of entity assets by others is recognised in profit or loss based on the duration and the effective interest rate. Interest income includes the amortisation of any discount or premium or other differences between the initial carrying amount of an interest bearing instrument and its amount at maturity calculated on an effective interest rate basis.

The effective interest method is a method of calculating the amortised cost of financial assets and liabilities and of allocating the interest income and interest expense over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash payments or receipts through the expected life of the financial instrument or, when appropriate, a shorter period to the net carrying amount of the financial instrument. When calculating the effective interest rate, the Group estimates cash flows considering all contractual terms of the financial instrument (for example, call and similar options) but does not consider future credit losses. The calculation includes all fees and interests paid or received between parties to the contract that are an integral part of the effective interest rate, transaction costs and all other premiums or discounts.

Interest on the impaired financial assets is recognised using the rate of interest used to discount future cash flows ("unwinding of discount") for the purpose of measuring the related impairment loss.

#### (b) Rental income

Rental income under operating leases is recognised on straight-line method over the term of the relevant lease.

#### (c) Dividend income

Dividend is recognised when the right to receive the dividend is established.

#### 4.20 Retirement benefits

Retirement benefits to employees are provided through defined contribution plans and defined benefit pension plans.

#### (i) Defined contribution plans

A defined contribution plan is a pension plan under which the Group pays fixed contributions into a separate entity. The Group has no legal or constructive obligations to pay further contributions after payment of the fixed contribution.

The contributions recognised in respect of defined contribution plans are expensed as they fall due. Liabilities and assets may be recognised if underpayment or prepayment has occurred and are included in current liabilities or current assets as they are normally of a short-term nature.

The Group also operates a defined contribution Mandatory Provident Fund retirement benefits scheme (the "MPF Scheme") under the Mandatory Provident Fund Schemes Ordinance, for those employees in Hong Kong who are eligible to participate in the MPF Scheme. Contributions are made based on a percentage of the employees' basic salaries and are charged to profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when contributed into the MPF Scheme.

The employees of the Group's subsidiaries which operate in the PRC are required to participate in a central pension scheme operated by the local municipal government (the "Scheme"). These subsidiaries are required to contribute certain percentage of its payroll costs to the central pension scheme. The Scheme is responsible for the entire pension obligations payable to the retired employees and the Group has no further obligations for the actual pension payments or other post-retirement benefits beyond the employer contributions. Contributions under the Scheme are charged to profit or loss as they become payable in accordance with the rules of the PRC.

本集團亦為合資格參與強制 性公積金退休福利計劃(「強 積金計劃」)的香港僱員根 強積金計劃。供款按僱員基 本薪金一定百分比作出,於由 據強積金計劃規則應付出,於由 證利或虧損扣除。強積金計劃 資產與本集團資產分開,由 宣管理基金持有。本集團之僱 主供款於向強積金計劃作出 時全數歸僱員所有。

本集團於中國經營業務之附屬 公司之僱員須參與有關地方市 政府管理之中央退休金計劃 (「該計劃」)。該等附屬公司規 定須按工資成本若干百分比向 中央退休金計劃供款。該計劃 負責向已退休僱員支付全款外, 本集團就實際退休款項或其任。 該計劃供款於根據中國規則 應付時在溢利或虧損內扣除。

# (ii) Defined benefit pension plans

Defined benefit pension plans define an amount of pension benefit that an employee will receive on retirement, usually dependent on one or more factors such as age, years of service and compensation.

The liability recognised in the consolidated statement of financial position in respect of defined pension plans is the present value of the defined benefit obligation at the end of the reporting period less the fair value of plan assets. The defined benefit obligation is calculated annually by independent actuaries using the projected unit credit method. The present value of the defined benefit obligation is determined by discounting the estimated future cash outflow using interest rates of high-quality corporate bonds that are denominated in the currency in which the benefits will be paid, and that have terms to maturity approximating to terms of the related pension obligation. In countries where there is no deep market in such bonds, the market rates on government bonds are used.

Actuarial gains and losses arising from experience adjustments and changes in actuarial assumptions are charged or credited to equity in other comprehensive income in the period in which they arise.

Past service costs are recognised immediately in profit or loss.

## (iii) Short-term employee benefits

Short term employee benefits are employee benefits (other than termination benefits) that are expected to be settled wholly before twelve months after the end of the annual reporting period in which the employees render the related service. Short term employee benefits are recognised in the year when the employees render the related services.

Non-accumulating compensated absences such as sick leave and maternity leave are not recognised until the time of leave.

# 4.21 Share-based employee compensation

The Group operates equity-settled share-based compensation plans for remuneration of its employees.

All employee services received in exchange for the grant of any share-based compensation are measured at their fair values. These are indirectly determined by reference to the share options awarded. Their value is appraised at the grant date and excludes the impact of any non-market vesting conditions.

Upon exercise of share options, the amount previously recognised in share option reserve and the proceeds received net of any directly attributable transaction costs up to the nominal value of the share issued are reallocated to share capital with any excess being recorded as share premium. When the share options are lapsed, forfeited or still not exercised at the expiry date, the amount previously recognised in share option reserve will be transferred to retained profits.

## 4.22 Borrowing costs

Borrowing costs attributable directly to the acquisition, construction or production of qualifying assets which require a substantial period of time to be ready for their intended use or sale, are capitalised as part of the cost of those assets. Income earned on temporary investments of specific borrowings pending their expenditure on those assets is deducted from borrowing costs capitalised. Capitalisation of borrowing costs ceases when substantially all the activities necessary to prepare the qualifying asset for its intended use or sale are complete. All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

# 4.23 Foreign currency

Transactions entered into by group entities in currencies other than the currency of the primary economic environment in which they operate (the "functional currency") are recorded at the rates ruling when the transactions occur. Foreign currency monetary assets and liabilities are translated at the rates ruling at the end of reporting period. Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing on the date when the fair value was determined. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences arising on the settlement of monetary items, and on the translation of monetary items, are recognised in profit or loss in the period in which they arise. Exchange differences arising on the retranslation of non-monetary items carried at fair value are included in profit or loss for the period except for differences arising on the retranslation of non-monetary items in respect of which gains and losses are recognised in other comprehensive income, in which case, the exchange differences are also recognised in other comprehensive income.

On consolidation, income and expense items of foreign operations are translated into the presentation currency of the Group (i.e. Hong Kong dollars) at the average exchange rates for the year, unless exchange rates fluctuate significantly during the period, in which case, the rates approximating to those ruling when the transactions took place are used. All assets and liabilities of foreign operations are translated at the rate ruling at the end of reporting period. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity as exchange reserve (attributed to non-controlling interests as appropriate). Exchange differences recognised in profit or loss of group entities' separate financial statements on the translation of long-term monetary items forming part of the Group's net investment in the foreign operation concerned are reclassified to other comprehensive income and accumulated in equity as exchange reserve.

On disposal of a foreign operation, the cumulative exchange differences recognised in the exchange reserve relating to that operation up to the date of disposal are reclassified to profit or loss as part of the gain or loss on disposal.

Goodwill and fair value adjustments on identifiable assets acquired arising on an acquisition of a foreign operation on or after 1 January 2005 are treated as assets and liabilities of that foreign operation and translated at the rate of exchange prevailing at the end of reporting period. Exchange differences arising are recognised in the exchange reserve.

# 4.24 Share capital and share premium

Ordinary shares are classified as equity. Share capital is determined using the nominal value of shares that have been issued.

Share premium includes any premiums received on the issuance of share over the par value. Any transaction costs associated with the issuing of shares are deducted from the share premium (net of any related income tax benefit) to the extent that they are incremental costs directly attributable to the equity transaction.

綜合賬目時,海外業務之收支項目 以年內平均匯率換算為本集團之早 列貨幣(即港元),除非期內匯率大 幅波動,在此情況下,則按進行該 等交易時之相若匯率換算。所有海 外業務之資產及負債均以報告期間 結算日之匯率換算。所產生匯兑差 額(如有)於其他全面收入確認,並 於權益內累計入賬為外匯儲備(非控 股權益應佔外匯儲備(如適用))。 於換算構成本集團於所涉海外業務 部分投資淨額之長期貨幣項目時, 在集團實體獨立財務報表之溢利或 虧損內確認之匯兑差額則重新分類 至其他全面收入,並於權益內累計 入賬為外匯儲備。

出售海外業務時,與截至出售當日 該業務有關之外匯儲備確認之累計 匯兑差額,重新分類至溢利或虧損 作為出售收益或虧損一部分。

於二零零五年一月一日或之後收購 海外業務產生之所收購可識別資產 之商譽及公平值調整已當作該海外 業務之資產及負債,並於報告期間 結算日按當前匯率進行換算。所產 生之匯兑差額於外匯儲備確認。

普通股分類為權益。股本採用已發 行股份之面值釐定。

Where any group company purchases the Company's equity share capital, the consideration paid, including any directly attributable incremental costs (net of taxes) is deducted from equity attributable to owners of the Company until the shares are cancelled or reissued. Where such ordinary shares are subsequently reissued any consideration received net of any directly attributable incremental transaction costs and the related income tax effects, is included in equity attributable to owners of the Company.

# 4.25 Segment reporting

The Group identifies operating segments and prepares segment information based on the regular internal financial information reported to the executive directors for their decisions about resources allocation to the Group's business components and for their review of the performance of those components. The business components in the internal financial information reported to the executive directors are determined following the Group's major lines of business.

The Group has identified the following reportable segments: (a) manufacturing and distribution of watches and timepieces; (b) property investments and (c) banking and financial businesses.

Each of these operating segments is managed separately as each of the product and service lines requires different resources as well as marketing approaches. All inter-segment transfers, if any, are carried out at arm's length prices.

The measurement policies the Group uses for reporting segment results under HKFRS 8 are the same as those used in its financial statements prepared under HKFRSs.

Segment assets include all assets but interests in associates, interests in joint ventures, and certain trading portfolio investments. In addition, corporate assets which are not directly attributable to the business activities of any operating segment are not allocated to a segment, which primarily applies to the Group's headquarter.

Segment liabilities exclude corporate liabilities which are not directly attributable to the business activities of any operating segment and are not allocated to a segment. These include certain borrowings and due to a shareholder and certain lease liabilities related parties.

No asymmetrical allocations have been applied to reportable segments.

本集團已確定以下報告分類:(a)鐘 錶及時計產品製造及分銷;(b)物業 投資;及(c)銀行及金融業務。

由於各產品及服務類別所需資源以 及市場方針不同,各經營分類獨立 管理。所有分類間轉讓(如有)乃按 公平價格計算。

本集團根據香港財務報告準則第8 號就報告分類業績所用計量政策與 根據香港財務報告準則編製財務報 表所用者相同。

分類資產包括所有資產,但不包括 於聯營公司之權益、於合營企業之 權益、若干交易組合投資。此外, 並非直接計入任何經營分類業務活 動之公司資產不會分配至分類,主 要應用於本集團總部。

分類負債不包括並非直接計入任何 經營分類業務活動之公司負債,且 不會分配至分類,當中包括若干借 貸及應付一名股東款項及若干租賃 負債。

並無就可報告分類作出不均分配。

In the application of the Group's accounting policies, the directors are required to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

The Group makes estimates and assumptions concerning the future. Such estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. The resulting accounting estimates will, by definition, rarely equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are discussed below:

# Impairment assessment of goodwill

The Group tests on an annual basis whether goodwill has suffered any impairment in accordance with the accounting policy stated in note 4.6. The recoverable amounts of the CGUs have been determined based on value-in-use calculations or fair value less costs of disposal ("FVLCD"), whichever is higher. The value-in-use calculations require the use of judgement and estimates of the future cash flows expected to arise from the CGUs, the timeframe for the cash flows forecast and the suitable discount rates in order to calculate the present value. In the process of estimating expected future cash flows management makes assumptions about future revenues and profits. These assumptions relate to future events and circumstances. The actual results may vary and may cause a material adjustment to the carrying amount of goodwill within the next financial year. Determining the appropriate discount rate involves estimating the appropriate adjustment for market risk and for asset specific risk factors. Calculation of FVLCD may involve the selection of valuation model, adoption of key assumption, and input data, which are subject to management judgement. Details in impairment assessment are set out in note 30 to the consolidated financial statements.

# 商譽減值評估

本集團每年根據附註4.6所述會計政策就 商譽有否減值進行測試。現金產生單位之 可收回金額按所計算之使用價值或公平值 減出售成本(「公平值減出售成本」)(以較 高者為準) 釐定。使用價值計算須採用預 期現金產生單位所產生未來現金流量之判 斷及估計、現金流量預測時間表以及適合 貼現率,以計算現值。於估計預期未來現 金流量過程中,管理層就未來收入及溢利 作出假設。該等假設與未來事件及情況有 關。實際結果或會有所不同,並可能導致 下個財政年度之商譽賬面值須作重大調 整。釐定合適之貼現率涉及估計市場風險 及資產特定風險因素之適當調整。計算公 平值減出售成本可能涉及選擇估值模型、 採納主要假設及輸入數據,而以上項目均 需管理層作出判斷。減值評估詳情載於綜 合財務報表附註30。

### **Provision for inventories**

In determining the amount of allowance required for obsolete and slow-moving inventories, the Group would evaluate ageing analysis of inventories and compare the carrying value of inventories to their respective estimated net realisable value. The assessment of the provision involves management judgement and estimates. Where the actual outcome or expectation in future is different from the original estimate, such differences will impact the carrying value of inventories and provision charge/write-back in the period in which such estimate has been changed.

#### **Depreciation and amortisation**

The Group depreciates and amortises its property, plant and equipment and intangible assets with definite useful lives using straight-line method over their respective estimated useful lives, starting from the date on which the assets are available for intended use, in accordance with accounting policy stated in notes 4.9 and 4.12. The estimated useful lives reflect the directors' estimate of the period that the Group intends to derive future economic benefits from the use of these assets.

# Estimated impairment of trade and other receivables

The Group's management determines the provision for impairment of trade and other receivables on a forward-looking basis. The provision matrix is determined based on the Group's historical observed default rates over the expected life of the trade receivables with similar credit risk characteristics and is adjusted for forward-looking estimates. Other receivables is considered 12-months expected credit losses, given credit risk has not increase significantly since initial recognition. In making the judgement, management considers available reasonable and supportive forward-looking information such as actual or expected significant changes in the operating results of customers, actual or expected significant adverse changes in business and customers' financial position. At every reporting date, the historical observed default rates are updated and changes in the forward-looking estimates are analysed by the Group's management.

#### 存貨撥備

# 折舊及攤銷

本集團根據附註4.9及4.12所述會計政策, 採用直線法按估計可用年期為物業、廠房 及設備以及可用年期有限之無形資產計算 折舊及攤銷,自資產可用於擬定用途日期 起計算。估計可用年期反映董事估計本集 團擬自使用該等資產衍生未來經濟利益之 期間。

# 應收賬款及其他應收款之估計減值

本集團管理層以前瞻性方式釐定應收賬款 及其他應收款減值撥備。撥備矩陣乃根據 本集團於具有類似信貸風險特徵之應收賬 款之預期年期內之歷史觀察違約率釐定, 並就前瞻性估計作出調整。鑑於信貸風險 自初步確認以來並無大幅增加,其他應收 款被視為12個月預期信貸虧損。在作出的 斷時,管理層會考慮可得之合理有據前瞻 性資料,如客戶經營業績之實際或預期 性資料、業務及客戶財務狀況之實際或預 期重大不利變動。於各報告日,本集團管 理層會更新歷史觀察違約率,並分析前瞻 性估計變動。

#### Impairment assessment of non-financial assets

The Group assesses impairment at each reporting date by evaluating conditions specific to the Group that may lead to impairment of nonfinancial assets. Where an impairment trigger exists, the recoverable amount of the asset is determined. The recoverable amount is determined based on value-in-use calculation or fair value less costs of disposal ("FVLCD"). The calculations of value-in-use require the use of judgement and estimates of the future cash flows expected to arise from the CGUs, the timeframe for the cash flows forecast and the suitable discount rates in order to calculate the present value. In the process of estimating expected future cash flows management makes assumptions about future revenues and profits. These assumptions relate to future events and circumstances. The actual results may vary and may cause a material adjustment to the carrying amount of non-financial assets within the next financial year. Determining the appropriate discount rate involves estimating the appropriate adjustment for market risk and for asset specific risk factors. Calculation of FVLCD involves the selection of valuation model, adoption of key assumption, and input data, which are subject to management judgement.

# **Income taxes**

The Group is subject to income taxes in Hong Kong, Switzerland, United Kingdom, Liechtenstein and the PRC. Significant judgement is required in determining the amount of the provision for income taxes and the timing of the payments of related taxes. There are many transactions and calculations for which the ultimate tax determination is uncertain during the ordinary course of business. The Group recognises liabilities for anticipated tax based on estimates of whether additional taxes will be due. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will impact the income tax and deferred tax provisions in the period in which such determination is made.

# Warranty provision

Warrant provision is made for expenditure associated with future variable repair services and repair cost related to warranty claims. The management makes an assessment of the future costs related to this work by using the proportion of actual tasks related to warranty work as the basis for the calculation. The assessment of provision involves management judgement and estimates. When the actual outcome or expectation in future is different from the original estimate, such differences will impact the carrying value of warrant provision and provision charge/write-back in the period in which such estimate has been changed.

本集團須繳納香港、瑞士、英國、列支敦 士登及中國之所得税。於決定就所得稅撥 備之金額及就有關稅項付款之時間時,須 作出重大判斷。於日常業務過程中,有許 多交易及計算均難以明確作出最終之稅務 釐定。就預計稅項確認負債時,本集團按 有否額外稅項即將到期應付而估計。倘此 等事項之最後稅項結果與初步記錄金額不 同,該等差額將影響作出該項決定期間之 所得稅及遞延稅項撥備。

## 保修撥備

本集團就日後各種維修服務及與保修索賠 有關之維修成本相關開支作出保修撥備。 管理層採用有關保修工作實際任務比例作 為計算基準,以評估有關此工作之未來成 本。評估撥備涉及管理層判斷及估計。當 日後之實際結果或預期情況與原先估計存 在差異,則有關差異將影響該等估計有變 期間之保修撥備以及扣除/撥回撥備賬面 值。

# **Estimation of defined benefit obligations**

The Group operates three defined benefit plans. Pension costs for defined benefit plans are assessed using the projected unit credit method in accordance with HKAS 19, Employee Benefits. Under this method, the cost of providing pensions is charged to the profit or loss in accordance with the advice of the actuaries who carry out a full valuation of the plans. The pension obligation is measured at the present value of the estimated future cash outflows using interest rates determined by reference to market yields at the end of the reporting period based on government agency or high quality corporate bonds with currency and term similar to the estimated term of benefit obligations. All actuarial gains and losses are recognised in full, in the year in which they occur, in other comprehensive income.

Management appointed actuaries to carry out a full valuation of these pension plans to determine the pension obligations that are required to be disclosed and accounted for in the accounts in accordance with the requirements of HKFRSs.

The actuaries use assumptions and estimates in determining the fair value of the defined benefit plans and evaluate and update these assumptions on an annual basis. Judgement is required to determine the principal actuarial assumptions to determine the present value of defined benefit obligations and service costs. Changes to the principal actuarial assumptions can significantly affect the present value of plan obligations and service costs in future periods.

# Valuation adjustments on credit positions

Various factors can influence the expected credit loss allowances for credit positions. Management considers factors such as external rating and days past due to determine the HKFRS 9 staging allocation. Management further estimates the exposure at default, probability of default as well as loss given default to calculate the expected credit losses allowance.

# 定額福利責任估計

本集團營辦三項定額福利計劃。定額福利計劃之退休金成本根據香港會計準則第19號僱員福利之規定,使用預期單位記賬法進行評估。根據此方法,提供退休金之成本按對計劃作出全面估值之精算師意見於溢利或虧損內扣除。退休金責任為估計未來現金流出數額之現值,該現值參照於報告期間結算日與福利責任估計年期之條款及貨幣相若之政府機構或高質素公司債券之市場孳息率釐定之利率計算所得。所有精算收益及虧損於發生年度內在其他全面收入全數確認。

管理層委任精算師對該等退休金計劃進行 全面估值,以釐定根據香港財務報告準則 規定,須於賬目內披露及入賬之退休金責 任。

精算師在釐定定額福利計劃之公平值時使 用假設及估計,並每年評估及更新該等假 設。在釐定主要精算假設時須運用判斷, 以釐定定額福利責任之現值與服務成本。 改變所採用之主要精算假設可對未來期間 之計劃責任現值與服務成本造成重大影響。

## 信貸狀況之估值調整

多項因素可影響信貸狀況之預期信貸虧損 撥備。管理層會考慮外部評級及逾期日數 等因素,以釐定香港財務報告準則第9號 之階段分配。管理層進一步估計違約風險 承擔、違約或然率及違約損失率計算預期 信貸虧損撥備。

#### **Provisions**

The Group recognises provisions for imminent threats if in the opinion of the responsible experts the probability that losses will occur is greater than the probability that they will not occur and if their amount can be reliably estimated. In judging whether the creation of a provision and its amount are reasonable, the best-possible estimates and assumptions as at the end of reporting periods are applied. If necessary, these will be adjusted to reflect new knowledge and circumstances at a later date. New knowledge may have a significant effect to profit or loss.

As part of the normal business activities of banking business, the Group is exposed to a wide range of legal risks. These include in particular risks relating to litigation. The Group recognises provisions for such litigation risks if the Group's management and its legal advisors are of the opinion that an outflow of resources embodying economic benefits is probable and a reliable estimate can be made of the amount. The amount of the provisions and their timing are by their nature subject to uncertainty. However, these uncertainties are evaluated as being low since it was possible to reliably estimate the individual amounts and the majority of the recognised provisions will probably become due within one year.

# Research and development costs

In accordance with the accounting policy set out in note 4.12, costs associated with research activities are expensed in profit or loss as they are incurred, while costs that are directly attributable to development activities are recognised as intangible assets provided they meet all the requirements as set out in note 4.12. This requires the management to make judgements to distinguish the research phase and development phase of the projects being undertaken. Research is original and planned investigation undertaken with the prospect of gaining new scientific or technical knowledge and understanding. Development is the application of research, findings or other knowledge to a plan or design for the production of new or substantially improved materials devices, products, processes, systems or services before the start of commercial production or use. Determining the amounts to be expensed in profit or loss or to be capitalised required management to make judgement, and assumptions regarding the expected progress and outcome of the research and development activities the future expected cash generation of the assets, discount rates to be applied, and also the expected period of, probable future economic benefits. Because of the nature of the Group's research and development activities the criteria for the recognition of such costs as an asset are generally not met until late in the development stage of the projects. Hence research costs are generally recognised as expenses in the period in which they are incurred.

## 撥備

倘相關專家認為發生虧損之可能性高於不 會發生之可能性並能可靠估計虧損金額 時,則本集團就當前威脅確認撥備。於判 斷計提撥備及撥備金額有否合理時,應用 報告期間結算日之最佳可能估計及假設。 如有必要,日後可調整此最佳可能估計及 假設以反映新認知及情況。新認知或會對 溢利或虧損有重大影響。

作為銀行業務日常業務活動一部分,本集團面臨多類法律風險。該等風險包括與訴訟有關之特定風險。倘本集團管理層及其法律顧問認為體現經濟利益之資源可能流出且金額能可靠估計,則本集團就該訴訟風險確認撥備。撥備金額及其時間根據其性質受不確定因素規限。然而,由於能可靠地估計個別金額及大多數已確認撥備可能於一年內到期,故此經評估該等不確定因素為低。

### 研發成本

根據附註4.12載列之會計政策,研究活動 相關之開支於產生時於溢利或虧損列作 開支,而倘直接歸屬於開發活動之開支符 合附註4.12載列之所有規定,則其將確認 為無形資產。此要求管理層作出判斷以將 所承接項目之研究階段及開發階段予以 區分。研究乃所進行之原創及受規劃之調 查,旨在獲得新科學或技術知識及瞭解。 開發乃於開始作商業生產或使用前應用研 究、結果或其他知識,以規劃或設計生產 全新或重大改良物料器具、產品、工序、 系統或服務。釐定於溢利或虧損列作開支 或予以資本化之金額時,管理層須作出判 斷及有關研發活動之預期進度及結果、 資產之未來預期現金產生、將應用之貼現 率,及可能未來經濟效益之預期期間之假 設。基於本集團之研究及開發活動性質, 確認該等成本為資產之條件一般直至達到 項目之開發階段後期時方會達成。因此, 研究成本一般於產生期間內確認為開支。

#### Right-of-use assets

The Group uses its incremental borrowing rate ("IBR") to measure lease liabilities. The IBR is the rate of interest that the Group would have to pay to borrow over a similar term, and with a similar security, the funds necessary to obtain an asset of a similar value to the right-of-use asset in a similar economic environment. The IBR therefore reflects what the Group 'would have to pay', which requires estimation when no observable rates are available or when they need to be adjusted to reflect the terms and conditions of the lease.

The Group estimates the IBR using observable inputs (such as market interest rates) when available and is required to make certain entity-specific estimates.

#### Fair value measurement

A number of assets and liabilities included in the Group's financial statements require measurement at, and/or disclosure of, fair value. The fair value measurement of the Group's financial and non-financial assets and liabilities utilises market observable inputs and data as far as possible. Inputs used in determining fair value measurements are categorised into different levels based on how observable the inputs used in the valuation technique utilised are (the 'fair value hierarchy'):

- Level 1: unadjusted quoted prices in active markets for identical assets or liabilities:

- If the expected salary rate of increase/(decreases) by 50 basis points, the defined benefit obligations would increase by HK\$11,463 (2020: HK\$8,267,000)/ decrease by HK\$367,000 (2020: HK\$7,731,000).

The sensitivity analysis presented above may not be representative of the actual change in the defined benefit obligations as it is unlikely that the change in assumptions would occur in isolation of one another as some of the assumptions may be correlated.

Furthermore, in presenting the above sensitivity analysis, the present value of the defined benefit obligation has been calculated using the projected unit credit method at the end of the reporting period, which is the same as that applied in calculating the defined benefit liability recognised in the consolidated statement of financial position.

There was no change in the methods and assumptions used in preparing the sensitivity analysis from prior years.

The Group has various financial assets and financial liabilities such as trading portfolio investments, derivative financial assets, cash and deposits, due from banks and clients, trade receivables, financial assets at fair value through other comprehensive income, other financial assets at amortised cost, other assets, derivative financial liabilities, due to banks and clients, trade payables, borrowings, due to a shareholder, due to directors, lease liabilities and other liabilities, which arise directly from its operations. The main risks arising from the Group's financial instruments are interest rate risk, foreign currency risk, credit risk, liquidity risk, fair value risk and equity price risk.

It is not the Group's policy to actively engage in the trading of financial instruments for speculative purposes. Its treasury department works under the policies approved by the directors and identifies ways to access financial markets and monitors the Group's financial risk exposures. Regular reports are provided to the directors. The board has reviewed and agreed policies periodically for managing each of these risks and they are summarised below.

#### 49.2 Interest rate risk

Interest rate risk relates to the risk that the fair value or cash flows of a financial instrument will fluctuate because of changes in market interest rates. The Group's interest rate risk arises primarily from borrowings and bank deposits. Borrowings and bank deposits bearing variable rates and fixed rates expose the Group to cash flow interest rate risk and fair value interest rate risk respectively. The interest rate and repayment terms of the borrowings outstanding at the end of the reporting period are disclosed in note 35.

The Group's exposure to the risk of changes in market interest rates relates primarily to the Group's borrowings and bank deposits with a floating interest rate.

### **Sensitivity Analysis**

At 31 December 2021, it is estimated that a general increase/decrease of 50 basis points in interest rates, with all other variables held constant, would decrease/increase the Group's loss after income tax and increase/decrease the Group's retained profits by approximately HK\$16,219,000 (2020: increase/decrease the Group's loss after income tax and retained profits by approximately HK\$16,427,000). The assumed changes have no impact on the Group's other components of equity.

The sensitivity analysis above has been determined assuming that the change in interest rates had occurred at the end of reporting period. The assumed changes in interest rates are considered to be reasonably possible changes on observation of current market conditions and represent management's assessment of a reasonably possible change in interest rates over the next twelve month period.

The calculation is based on a change in average market interest rates for each period, and the financial instruments held at each reporting date that are sensitive to changes in interest rates. All other variable are held constant. The sensitivity analysis for the year ended 31 December 2020 has been prepared on the same basis.

Foreign currency risk refers to the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in foreign exchange rates. The Group mainly operates in Hong Kong, Switzerland, United Kingdom, Liechtenstein and the PRC with most of the transactions denominated and settled in HK\$, US\$, Euro, CHF, GBP and RMB. The Group's exposure to foreign currency risk primarily arise from certain financial instruments including financial assets at fair value through other comprehensive income, other assets, cash and deposits, due from clients and banks, trading portfolio investments, derivative financial assets, other financial assets at amortised cost, due to clients, derivative financial liabilities, other liabilities and borrowings which are denominated in US\$, Euro, CHF, GBP and RMB. The management continuously monitors the foreign exchange exposure.

The following table summarises the Group's major financial assets and financial liabilities denominated in currencies other than the functional currencies of the respective group companies as at 31 December 2021 and 2020.

Credit risk refers to the risk that the counterparty to a financial instrument would fail to discharge its obligation under the terms of the financial instruments and cause a financial loss to the Group.

The Group considers the probability of default upon initial recognition of assets and whether there has been a significant increase in credit risk on an ongoing basis throughout each reporting period. To assess whether there is a significant increase in credit risk, the Group compares the risk of a default occurring on the assets as at the reporting date with the risk of default as at the date of initial recognition.

It considers available reasonable and supportive forward looking information. Especially the following indicators are incorporated:

- external credit rating (as far as available)
- actual or expected significant adverse changes in business, financial or economic conditions that are expected to cause a significant change to the counterparty's ability to meet its obligations
- actual or expected significant changes in the operating results of the counterparty
- significant expected changes in the performance and behaviour of the counterparty, including changes in the payment status of counterparties in the group and changes in the operating results of the counterparty

A default on a financial asset is when the counterparty fails to make contractual payments when they fall due.

Financial assets are written off when there is no reasonable expectation of recovery.

The assessment of credit risk and the estimation of ECL are unbiased and probability-weighted, and incorporate all available information that is relevant to the assessment including information about past events, current conditions and reasonable and supportable forecasts of future events and economic conditions at the reporting date. In addition, the estimation of ECL should take into account the time value of money.

The credit risk of the Group is primarily attributable to the cash and deposit, due from clients and banks, trade receivables, other financial assets at amortised cost and other assets.

The credit risk of the cash and deposit is limited because the majority of the counterparties are banks with good reputation. No impairment had been provided under 12-month expected credit loss assessment.

The credit risk of due from clients and banks (excluding the precious metal) is determined based on the combination of the internal and external credit rating, the average debt recovery, peer review information and comparison with publically available date. The Group calculates ECL using three main components: a probability of default, a loss given default ('LGD') and the exposure at default ('EAD'). The 12-month ECL is calculated by multiplying the 12-month PD, LGD and EAD. Lifetime ECL is calculated using the lifetime PD instead. The 12-month and lifetime PDs represent the probability of default occurring over the next 12 months and the remaining maturity of the instrument respectively. The EAD represents the expected balance at default, taking into account the repayment of principal and interest from the balance sheet date to the default event together with any expected drawdowns of committed facilities. The LGD represents expected losses on the EAD given the event of default, taking into account, among other attributes, the mitigating effect of collateral value at the time it is expected to be realised and the time value of money. Expected credit losses for due from banks and clients of HK\$593,000 has been recognised (2020: expected credit losses for due from banks and clients of HK\$278,000) under expected credit loss assessment for the year ended 31 December 2020.

The balance of due from clients also subject to concentration risk which the ten largest single exposures encompass HK\$1,402,533,000 (2020: HK\$1,116,031,000), which are related to due from clients of the banking business as of 31 December 2021.

The Group adopts the "ECL model" on its debt instruments which are classified as financial assets measured at amortised cost in accordance with the provisions of HKFRS 9. For financial assets that are included in the measurement of ECL, the Group evaluates whether the credit risks of related financial assets have increased significantly since initial recognition. The "three stage" impairment model is used to measure their loss allowances respectively to recognise ECL and their movements. The ECL assessment made by the Group mainly reference to the internal and market credit rating information. Amount to HK\$2,014,000 (2020: provision for impairment allowance of HK\$29,348,000) impairment allowance on other financial assets at amortised cost has been reversed after the assessment during the year.

For the trade receivables, the Group carries out regular review on these balances and follow-up action on any overdue amounts to minimise exposures to credit risk. The Group measures the lifetime expected credit losses based on the outstanding balances and historical credit loss experience adjusted to reflect the Group's view of current and forecast economic conditions that may affect the ability of the debtors to settle receivables. Amounted to HK\$2,361,000 (2020: HK\$16,960,000) impairment allowance had been provided under expected credit loss assessment which calculated using simplified approach according to the ageing by due date disclose in note 22.

For the other assets mainly comprise of rental deposits, dividend receivables, amounts due from an associate and related parties. Management considers rental deposits do not have significant credit risk since the deposits are refundable from landlords upon end of lease term or recoverable by the Group through using the leased property. For the remaining balance, given the short term nature of these assets, the ECL is had been provided under 12-month expected credit loss assessment given credit risk has not increase significantly since initial recognition. The management has provided an ECL provision of HK\$786,000 (2020: HK\$826,000) for the year ended 31 December 2021 after their assessment.

At the end of the reporting period, the directors of the Company have assessed the past due status of the debts under guarantee, the financial position of the debtors as well as the economic outlook of the industries in which the debtors operate, and concluded that there has not been a significant increase in the credit risk since initial recognition of the financial guarantee contract. Accordingly, the loss allowance for financial guarantee contract issued by the Group is measured at an amount equal to 12-month ECL.

In both years, the amount of loss allowance is lower than the premium less cumulative amortisation, therefore, no loss allowance was recognised in profit or loss for the financial guarantee contract.

### 49.5 Liquidity risk

Liquidity risk related to the risk that the Group will not able to meet its obligation associated with its financial liabilities. The Group manages its liquidity needs by carefully monitoring scheduled debt servicing payments for long-term financial liabilities as well as cash-outflows due in day-to-day business. Liquidity needs are monitored on a day-to-day basis. Long-term liquidity needs for a 360-day lookout period are identified monthly.

The Group maintains mainly cash to meet its liquidity requirements for up to 30-day periods. Funding for long-term liquidity needs is additionally secured by an adequate amount of committed credit facilities.

The following tables show the remaining contractual maturities at the reporting date of the Group's financial liabilities, which are based on contractual undiscounted cash flow (including interest payments computed using contractual rates or, if floating, based on rates current at the reporting date) and the earliest date the Group can be required to pay. Specially, for bank borrowings which contain a repayment on demand clause which can be exercised at the bank's sole discretion, the analysis shows the cash outflow based on the earliest period in which the entity can be required to pay, that is if the lenders were to invoke their unconditional rights to call the loans with immediate effect.

The fair value of the Group's current financial assets and liabilities are not materially different from their carrying amounts because of the immediate or short-term maturity. The fair values of non-current financial assets and liabilities were not disclosed because the carrying values were not materially different from their fair values.

#### 49.7 Equity price risk

Equity price risk related to the risk that the fair values or future cash flows of a financial instrument will fluctuate because of change in market price (other than changes in interest rate and foreign exchange rate). The Group is exposed to equity price changes arising from equity investments classified as trading portfolio investments and financial assets at fair value through other comprehensive income.

Decisions to buy or sell trading portfolio investments are based on daily monitoring of the performance of individual securities and other industry indicators, as well as the Group's liquidity needs. Financial assets at fair value through other comprehensive income are based on their longer term growth potential and are monitored regularly for performance against expectations.

The following table indicates the approximate change in the Group's profit after income tax and consolidated equity in response to reasonably possible changes in the share prices of the listed investments classified as trading portfolio investments and financial assets at fair value through other comprehensive income to which the Group has significant exposure at the reporting date. ### 49.8 Operational risks

Operational risk is the risk of losses due to faulty internal processes, procedures and systems, inappropriate behaviour by employees, or external influences. The definition includes all legal risks as well as reputational risks. However, it excludes strategic risks. The ongoing monitoring of operational risk is, whenever possible, embedded in the operational processes. Separation of functions and a dual control principle are crucial elements in monitoring. The directors oversee the management of operational risk based on standardised reporting and ad hoc information.

The Group sets the amount of equity capital in proportion to its overall financing structure. The Group manages the capital structure and makes adjustments to it in the light of changes in economic conditions and the risk characteristics of the underlying assets. To maintain or adjust the capital structure, the Group may adjust the amount dividends paid to shareholders, return capital to shareholders, issue new shares, or sell assets to reduce debts.

#### Capital adequacy of Bendura Group

Starting 1 February 2015, the calculation of regulatory capital incorporates the capital requirements following the Capital Requirements Regulation (EU) No. 575/2013 (Capital Requirements Regulation – CRR) and the Capital Requirements Directive No. 2013/36/EU (CRD 4) as implemented into Liechtenstein law. The minimum capital requirement is 8% of risk weighted assets which consists at least of 4.5% common equity tier 1 (CET 1) capital, 1.5% additional tier 1 capital and 2% tier 2 capital. In addition, the Bendura Group has to fulfill 2.5% buffer requirements (capital conservation buffer). The buffer requirement must be fulfilled with CET 1 capital.

Capital ratios measure capital adequacy by comparing the the Bendura Group's eligible capital with balance sheet assets, off-balance sheet commitments and market positions at weighted amounts to reflect their relative risk. Assets are weighted according to broad categories of notional risk, first being multiplied by a conversion factor and then being assigned a risk weighting according to the amount of capital deemed to be necessary for them. Off-balance sheet commitments and default risk positions are also multiplied and risk-weighted. Market risk is calculated with the standard approach.

All results are based on the full application of the final CRR and CRD 4 framework in the European Union and thus without consideration of applicable transitional rules. The Bendura Group has complied with all externally imposed capital requirements as at 31 December 2021 and 2020.
