### FINANCIAL HIGHLIGHTS 財務摘要

- Revenue for the year ended 31 December 2021 amounted to RMB252.7 million, representing an increase of 11.6% from RMB226.3 million recorded in 2020.
- Gross profit for the year ended 31 December 2021 amounted to RMB68.5 million, representing an increase of 50.2% from RMB45.6 million recorded in 2020.
- Loss attributable to ordinary equity holders of the Company for the year ended 31 December 2021 amounted to RMB318.4 million, representing a decrease of 62.3% from RMB845.3 million recorded in 2020.
- The Board does not recommend the payment of a final dividend for the year ended 31 December 2021.

## CHAIRMAN'S STATEMENT 主席報告

It is a great honour for me, on behalf of the board (the "Board") of directors (the "Directors") of Honworld Group Limited (the "Company" or "Lao Heng He"), to present the annual report of the Company and its subsidiaries (collectively, the "Group" or "we") for the financial year ended 31 December 2021.

本人非常榮幸地代表老恒和釀造有限公司(「本公司」或「老恒和」)董事(「董事」)會(「董事會」),提呈本公司及其附屬公司(統稱「本集團」)或(「我們」)截至二零二一年十二月三十一日止財年的年報。

### **BUSINESS REVIEW**

We are one of the leading manufacturers of condiment products in the People's Republic of China (the "PRC" or "China"). We offer high quality and healthy brewed cooking wine as well as other condiments, including naturally-brewed soy sauce, naturally-brewed vinegar, soybean paste, sesame oil and fermented bean curd. In 2021, we attained the following achievements:

- Our research projects, including Key Technologies and Applications for Electronic Nose and Intelligent Online Analysis, as well as Key Technological Development and Applications for Yellow Wine Tank Storage and Aging Quality Control, were awarded by China National Light Industry Council the second prizes in both Scientific and Technological Invention and Scientific and Technological Advancement:
- 2. We were awarded the "2020 Model Enterprise for the Construction of 2. Integrity Management System in the Food Industry of Zhejiang Province (2020年度浙江省食品工業企業誠信管理體系建設示範企業)" by the Zhejiang Food Industry Organization (浙江省食品工業協會); and
- 3. Our important contribution to the brewing industry during the 13th Five-year Plan was awarded by the Science and Technology Awarding Committee of the China Alcoholic Drinks Association the "Outstanding Enterprise for Technological Advancement in the Alcoholic Industry of China" (中國酒業科技進步優秀企業獎).

In 2021, industrial competition further intensified in the context of changing complicated economic conditions, successive impacts due to the resurgent novel coronavirus (COVID-19) pandemic, and weak consumer demands. As a result, a variety of consumer business models continued to emerge, posing brand new challenges to sales campaigns of the Company. While adhering to prevention and control amid the pandemic, the Group actively adapted to changes in the market. By continuing its fundamental principle of "focusing on natural brewing cooking wine industry and refining other industries", the Group focused on sales targets set at the beginning of the year by making orderly progress in conducting marketing reforms, carrying out project construction, and rectifying internal control.

### 業績回顧

我們是中華人民共和國(「中國」)的領先調味品生產商之一。我們提供優質、健康的釀造料酒以及其他調味品,包括原釀醬油、原釀醋、黃豆醬、麻油、腐乳等產品。於二零二一年,我們取得如下成就:

- 1. 我們的科研項目:電子鼻儀器與智能在線分析關鍵技術及應用、黃酒大罐貯存陳釀品質控制關鍵技術開發與應用等項目分別獲得中國輕工業聯合會科學技術發明二等獎及科學技術進步二等獎證書;
- 我們被浙江省食品工業協會授予「2020年度 浙江省食品工業企業誠信管理體系建設示範 企業」的稱號:及
- 3. 我們在「十三五」期間對釀酒行業做出重要貢獻特被中國灑業協會科學技術獎勵委員會, 授予「中國酒業科技進步優秀企業獎」。

於二零二一年,經濟形勢複雜多變,新冠疫情持續 反復衝擊、消費需求疲軟、行業競爭進一步加劇; 各種消費業態相繼涌現,給企業銷售帶來全新的挑 戰,在堅持疫情防控的同時,本集團積極順應市場 的變化,貫徹「聚焦天然釀造料酒產業,做精做細 其他產業」的基本原則,圍繞年初制定的銷售目標, 有序推進營銷變革和項目建設、企業內控整改等各 項工作。

### CHAIRMAN'S STATEMENT 主席報告

In 2021, the Group achieved a sales revenue of approximately RMB252.7 million, representing an increase of approximately RMB26.3 million or around 11.6% from the same period in 2020. On one hand, as distributors could not withstand the resurgent pandemic outbreaks in various regions, with some of these distributors facing closure, the Group made timely adjustments to the regular customers by dividing their respective market and adding potential distributors for leading to an increase of approximately RMB24.7 million or around 14.5% in the distribution channels under partnership as compared with the same period in 2020. On the other hand, due to decreasing social activities in other cities, travel restrictions, suspension of upstream and downstream businesses, and the consumers' shift to online consumption patterns caused by the pandemic, the sales of e-commerce channels directly benefited from the growth of household consumption. The sales of the Group's e-commerce channels increased by approximately RMB0.6 million or around 3.9% as compared to the same period in 2020.

本集團於二零二一年實現銷售收入約人民幣252.7 百萬元,較二零二零年同期上升了人民幣約26.3百 萬元,約11.6%。一方面,因疫情各地反復不斷 現導致經銷商無法承受,部分面臨倒閉,本集團及 時對老客戶進行調整,切分相應的市場,增加潛在 經銷商的合作,導致本集團的流通渠道合作較二零年同期上升人民幣約24.7百萬元,約14.5%; 另一方面,受益於疫情導致其他城市社會活動下 降、交通管制及上下游企業停工等原因影響及消費 者線上消費習慣的轉移,電商渠道的銷售情況直接 受益於家庭居家消費的增長,本集團的電商渠道的 銷售額較二零二零年同期上升了人民幣約0.6百萬元,約3.9%。

In 2021, our cooking wine products remained as a major source of revenue of the Company, accounting for approximately 67.2% of our total revenue. In addition, as our soy sauce production capacity has not been effectively released, sales of our soy sauce products in 2021 were approximately RMB25.9 million, accounting for approximately 10.2% of our total revenue. In terms of market and brand strategies, we continued the implementation of the market strategy planning and thinking in 2021 with an aim to cope with the adverse impact of the pandemic on the business environment by strengthening our distribution network, as well as expanding the online channel. We have maintained the number of distributors at approximately 697, and extended the network to cover 30 provinces, autonomous regions and municipalities across the country. In order to cope with the aforementioned arrangements and to deal with the adverse effects of the pandemic, the Group adjusted its product structure to increase the proportion of sales of high-end products with relatively higher gross profit. As a result, the gross profit margin of the Group's products increased from 20.1% in 2020 to 27.1% in 2021.

## CHAIRMAN'S STATEMENT 主席報告

The loss attributable to ordinary equity holders of the parent company of the Group was approximately RMB318.4 million, representing a decrease of approximately 62.3% as compared to the corresponding period of 2020, mainly due to the impact of the one-off issues arising from the investigation in 2020, and the impact of the aforementioned increase in revenue and gross profit. In view of the growing demand of our customers and the anticipated sales growth of soy sauce, rice vinegar, sesame oil and fermented bean curd products brought by the further development of the sales channels, we consider that a rich and diversified condiment products portfolio would be more beneficial to the business development of the Group in the coming years. Thus, we are pursuing in-depth development for the industry chain of the Group's condiment products at multiple levels, thereby establishing Lao Heng He as a diversified condiment manufacturer with cooking wine as a dominant product.

主要由於二零二零年調查產生的一次性問題以及上述收入及毛利上升的影響,本集團母公司普通權益持有人應佔虧損約為人民幣318.4百萬元,較二零年同期下降約62.3%。基於對現有不斷增長的客戶需求和對銷售渠道進一步發展而帶來的醬油、米醋、麻油、腐乳等產品的銷售增長預期,我們認為豐富而多元化的調味品結構將更有利於本集團未來幾年的業務發展。因此我們正多層次地深度開發本集團的調味品產業鏈,將老恒和打造成以料酒為主導產品的多元化調味品製造商。

Our profitability mainly depends on product pricing and our cost of sales, marketing strategy and the product structure and mix. We are actively monitoring any potential risk factors that may have impact on our financial results, and trying to mitigate any upward pressure on costs and expenses with more efficient operation, higher profit margins and better product mix and sales channels. The Group faces certain risks in its business development, including: (1) the risk of significant increase in production costs, such as the increase in the prices of subsidiary agricultural products, rising packaging cost and labour cost; (2) the negative impact on our sales due to changes in customers' spending habits in condiment products; (3) the greater-than-expected increase in market expansion costs and selling expenses; (4) the possible failure of our new products to obtain market recognition in the short run; (5) the increasingly complicated situation facing survival for distributors and sales policies due to the recurring COVID-19 pandemic; and (6) the adverse effects of the ongoing COVID-19 pandemic.

我們的盈利能力主要受產品訂價及我們的銷售成本、營銷策略、產品架構及組合所影響。我們正積極監控任何可能影響我們財務業績的潛在風險因素,並試圖憑藉更高效的營運及利潤率以更佳的產品組合和銷售渠道緩和成本和費用的增加。然而,本集團在業務發展過程中同樣面臨一定風險,包括:(1)生產成本大幅上漲的風險,如農副產品價格品的人物,為我們的銷售帶來負面影響;(3)市場實質的轉變,為我們的銷售帶來負面影響;(3)市場的拓展成本和銷售費用較公司預期大幅上升;(4)我們的新產品短期內可能無法獲得市場認可;(5)面對疫情持續且反複不斷,經銷商的生存空間,銷售政策等變得更加複雜;(6)新冠疫情持續帶來的不利影響。

### **EXECUTIVE DIRECTORS**

**Mr. Chen Wei (陳偉)**, aged 44, is the chairman of the Board and the executive Director. He is primarily responsible for our Group's overall strategic planning, recipes use and control, distribution network expansion and overall business operations.

Mr. Chen has been the chairman of the board of directors of Huzhou Wuxing City Investment Development Group Limited\* (湖州吳興城市投資發展集團有限公司) ("Huzhou Wuxing City") since September 2017. Huzhou Wuxing City is a stated-owned enterprise principally engaging in the business of urban infrastructure construction, agricultural development, mine ecological development, land development and the management of social facilities. From August 2012 to September 2017, Mr. Chen worked at Zhejiang Province Huzhou Municipality Nantaihu High Technology Industrial Park Management Committee\* (浙江省湖州市南太湖高新技術產業園區管理委員會) with his last position as the director of the management committee.

Mr. Chen received a diploma of agricultural economic management (financial management in township enterprise) from the Zhejiang University in June 1999 and a Bachelor's degree of political ideology from the Party School of the Central Committee of Chinese Communist Party in December 2002. From September 2010 to January 2014, he pursued a part-time postgraduate study of the Master's degree of Marxist Philosophy from the Party School of the Zhejiang Province of Chinese Communist Party.

Mr. Liu Jianbin (劉 建 鑌), aged 45, is our executive Director and chief executive officer. Mr. Liu is primarily responsible for the management of our Group's financing activities and assisting Mr. Chen to manage the overall business operations. He has been the manager of financing department of Huzhou Laohenghe Brewery Co., Limited\* (湖州老恒和釀造有限公司) since September 2019. Before joining the Group, Mr. Liu worked in Bank of China Huzhou Branch from August 1998 to March 2008, during which he successively served as an account manager of the business department, an account manager of the asset security department and an intermediate manager of the business department. Subsequently, Mr. Liu served as a general manager of the company business department of Shanghai Pudong Development Bank Huzhou Branch from April 2008 to January 2013, and a general manager of the small and medium enterprise department and the sales department of Huaxia Bank Huzhou Branch successively from February 2013 to June 2014. Mr. Liu was the president of Huaxia Bank Zhili Branch during July 2014 to September 2015, and then worked as a deputy general manager of the risk management department of Huaxia Bank Huzhou Branch. # MANAGEMENT DISCUSSION AND ANALYSIS 管理層討論與分析

#### Revenue

The revenue of the Group increased by 11.6% from RMB226.3 million in 2020 to RMB252.7 million in 2021, primarily attributable to the combined effect of factors such as the slowdown of our growth due to COVID-19 pandemic and adjustments of key customers, the normal operation of supply chain and the development of new products.

Revenue from cooking wine products increased by 8.3% from RMB156.9 million in 2020 to RMB169.9 million in 2021, primarily due to the combined effects of the improvement of the COVID-19 pandemic and the increase in large order on the cooking wine products.

Revenue from the Group's soy sauce products increased by 2.7%, from RMB25.2 million in 2020 to RMB25.9 million in 2021. This mainly reflects the impacts of factors such as the slowdown in the COVID-19 pandemic and optimization of product structure.

Revenue from the Group's rice vinegar products increased by 10.2% from RMB16.7 million in 2020 to RMB18.4 million in 2021. This mainly reflects our efforts to readjust the structure of our rice vinegar products by focusing on the development of crab vinegar products, thus contributing to a slight increase in the sales revenue.

In addition to launching new products into the market and developing our sesame oil products, we also adjusted the product portfolio of our other products during the year by downsizing products with poor market performance. As a result, the Group's revenue from other products increased by 40.0% from RMB27.5 million in 2020 to RMB38.5 million in 2021.

#### Cost of Sales

Our cost of sales increased by 1.9% from RMB180.7 million in 2020 to RMB184.2 million in 2021. The increase in cost of sales was primarily attributable to the increased prices of raw materials and energy.

#### **Gross Profit and Gross Profit Margin**

Our gross profit increased by 50.2% from RMB45.6 million in 2020 to RMB68.5 million in 2021. The gross profit margin increased from 20.1% in 2020 to 27.1% in 2021, primarily due to the growth in proportion of sales of products with high gross profit.

### 收入

本集團的收入由二零二零年的人民幣226.3百萬元增加11.6%至二零二一年的人民幣252.7百萬元,主要原因新冠疫情放緩我們的增長及重要客戶調整、供應鏈趨於正常作業及新產品的開發等綜合因素影響所致。

料酒產品的收入由二零二零年的人民幣 156.9 百萬元增加 8.3%至二零二一年的人民幣 169.9 百萬元,主要由於新冠疫情有所好轉及大單品增加的綜合影響所致。

本集團醬油產品的收入由二零二零年的人民幣25.2 百萬元增加2.7%至二零二一年的人民幣25.9百萬元,主要由於新冠疫情放緩及產品結構優化等因素 影響。

本集團米醋產品的收入由二零二零年的人民幣 16.7 百萬元增加10.2%至二零二一年的人民幣 18.4百萬元。主要反映對米醋產品結構重新梳理,重點開發 蟹醋產品,從而帶來銷售收入小幅增長。

在向市場投放新產品及開發麻油產品的同時,我們於本年也對我們其他產品的產品結構進行調整,縮減市場表現不好的產品。因此,本集團其他產品的收入從二零二零年的人民幣27.5百萬元增加40.0%至二零二一年的人民幣38.5百萬元。

#### 銷售成本

我們的銷售成本由二零二零年的人民幣180.7百萬元增加1.9%至二零二一年的人民幣184.2百萬元。銷售成本的增加主要是由於原材料及能源價格上漲所致。

#### 毛利及毛利率

我們的毛利由二零二零年的人民幣45.6百萬元增加50.2%至二零二一年的人民幣68.5百萬元。毛利率由二零二零年的20.1%上升至二零二一年的27.1%,主要由於毛利高的產品銷售佔比上升影響所致。

#### Other Income and Gains

Other income and gains decreased by 53.7% from RMB14.6 million in 2020 to RMB6.8 million in 2021. Other income and gains primarily include subsidies received, bank interest income and foreign exchange gain, net. The decrease in other income and gains was primarily due to the decrease of subsidy received, bank interest income and foreign exchange gain.

### **Selling and Distribution Expenses**

Selling and distribution expenses primarily consist of advertising expenses, marketing expenses, promotion expenses, travelling expenses, and remuneration of our sales employees.

Our selling and distribution expenses increased from RMB55.7 million in 2020 to RMB74.6 million in 2021, and the distribution expenses as a percentage of the Group's revenue increased from 24.6% in 2020 to 29.5% in 2021, primarily due to an increase in marketing expenses.

### **Administrative Expenses**

The administrative expenses decreased by 15.0% from RMB72.1 million in 2020 to RMB61.3 million in 2021. The decrease in administrative expenses was primarily due to a decrease in research and development expenses.

#### **Finance Costs**

Finance costs increased by 40.9% from RMB96.2 million in 2020 to RMB135.6 million in 2021. The increase in finance costs primarily reflected the increase in interest expenses from RMB96.2 million in 2020 to RMB135.6 million in 2021 primarily attributable to the increase in average borrowing amount.

#### Loss before Income Tax

Due to the aforesaid reasons, the loss before income tax decreased by 62.2% from RMB843.2 million in 2020 to RMB318.4 million in 2021.

### 其他收入及收益

其他收入及收益由二零二零年的人民幣 14.6 百萬元減少53.7%至二零二一年的人民幣 6.8 百萬元。其他收入及收益主要包括收到的補貼、銀行利息收入及外匯收益淨值。其他收入及收益減少主要由於收到的補貼、銀行利息收入及外匯收益減少所致。

#### 銷售及經銷開支

銷售及經銷開支主要包括廣告開支、營銷開支、推廣開支、差旅開支及我們銷售僱員的酬金。

我們的銷售及經銷開支由二零二零年的人民幣 55.7 百萬元增加至二零二一年的人民幣 74.6 百萬元,而 經銷開支佔本集團收入的百分比由二零二零年的 24.6%增加至二零二一年的 29.5%,乃主要由於市 場推廣費用開支增加所致。

### 行政開支

行政開支由二零二零年的人民幣72.1百萬元減少 15.0%至二零二一年的人民幣61.3百萬元。行政開 支減少主要由於研發費用減少所致。

#### 融資成本

融資成本由二零二零年的人民幣96.2百萬元增加40.9%至二零二一年的人民幣135.6百萬元。融資成本增加主要反映利息費用由二零二零年的人民幣96.2百萬元增加至二零二一年的人民幣135.6百萬元,乃主要歸因於平均借款金額增加所致。

### 除所得税前虧損

由於上述原因,除所得税前虧損由二零二零年的人 民幣843.2百萬元減少62.2%至二零二一年的人民 幣318.4百萬元。

### **Income Tax Expense**

The corporate income tax of the Group in respect of its operations in China has been provided at the rate of 25% (2020: 25%) on the taxable profits, based on the existing laws, interpretations and practices in respect thereof.

Pursuant to the approval from the National Office of Leading Group for Administration of Hi-tech Enterprise Recognition, Huzhou Laohenghe Brewery Co., Limited (湖州老恒和釀進有限公司) and Huzhou Laohenghe Wine Co., Limited (湖州老恒和酒業有限公司), both being wholly-owned subsidiaries of the Company, were granted the "Advanced and New Technology Enterprise" status and were entitled to the preferential tax rate of 15%, which remained stable as compared to that of 2020 (2020: 15%).

Income tax expense decreased from RMB2.1 million in 2020 to Nil in 2021, mainly due to the loss resulting from the increase in certain one-off expenses.

### Loss Attributable to Owners of the Company

Loss attributable to ordinary equity holders of the Company decreased by 62.3% from RMB845.3 million in 2020 to RMB318.4 million in 2021, which was mainly attributable to the decrease in net loss as a result of the aforesaid reasons.

### Loss per Share Attributable to Ordinary Equity Holders of the Company

Loss per share decreased from RMB1.46 in 2020 to RMB0.55 in 2021. The decrease in loss per share was attributable to the decrease in loss attributable to ordinary equity holders of the Company.

#### **Net Loss Margin**

Net loss margin decreased by 66.3% from 373.5% in 2020 to 126.0% in 2021, which was mainly attributable to the combined effect of the aforesaid reasons and the recognition of one-off loss arising from the Incident of approximately RMB600.6 million in 2020.

### 所得税開支

有關本集團於中國經營業務的企業所得税,已經根據相關現行法律、詮釋及慣例按税率25%(二零二零年:25%)對應課稅利潤作出撥備。

根據全國高新技術企業認定管理工作領導小組辦公室發出的批文,本公司全資附屬公司湖州老恒和釀造有限公司及湖州老恒和酒業有限公司獲得「高新技術企業」資格,並可享受15%的優惠税率,與二零二零年相比保持平穩(二零二零年:15%)。

所得税開支由二零二零年的人民幣2.1百萬元減少至二零二一年的零,主要由於若干一次性開支增加產生虧損所致。

### 本公司擁有人應佔虧損

本公司普通股權益持有人應佔虧損由二零二零年的人民幣845.3百萬元減少62.3%至二零二一年的人民幣318.4百萬元,主要是由於上述原因導致虧損淨值減少所致。

### 本公司普通權益持有人應佔每股虧損

每股基本虧損由二零二零年的人民幣 1.46元減少至二零二一年的人民幣 0.55元,每股虧損的減少乃由於本公司普通股權益持有人應佔虧損減少所致。

#### 淨虧損率

淨虧損率由二零二零年的373.5%下降66.3%至二零二一年的126.0%。淨虧損率下降主要是由於上述原因的綜合影響及於二零二零年自事件確認一次虧損約人民幣600.6百萬元所致。

#### Trade receivables

Trade receivables decreased from RMB20.4 million as at 31 December 2020 to RMB19.1 million as at 31 December 2021 and the turnover days of trade receivables decreased from 44 days in 2020 to 35 days in 2021, mainly because our customers are increasingly adopting transaction terms in the form of "prepayment". Details of the ageing analysis of trade receivables are set out in note 21 to the consolidated financial statements in this report.

In 2021, we classified our distributors into two categories, namely core distributors and non-core distributors, based on their scale, channels, capability and cooperativeness, local influence and other factors, and provided them with our resources in respect with terminal construction and market development for their orderly development and reasonable allocation, with an aim of molding all of them to be our core distributors.

### 應收貿易款項

應收貿易款項由二零二零年十二月三十一日的人民幣20.4百萬元減少至二零二一年十二月三十一日的人民幣19.1百萬元,應收貿易款項週轉天數從二零二零年的44天減少至二零二一年的35天,主要由於我們的客戶更多地採用「預付款」形式的交易條款。應收貿易款項賬齡分析詳情載於本報告的綜合財務報表附註21。

於二零二一年,我們依據經銷商的規模、渠道、能力及配合度、當地影響力等因素將其分為核心經銷商與非核心經銷商兩類,在終端建設、市場開發方面給予資源聚焦,有序發展、合理配置,使其全部培養為核心經銷商。

#### **Inventories**

As at 31 December 2021, the carrying amount of the Group's inventories amounted to RMB653.6 million (2020: RMB684.9 million), of which RMB586.0 million (2020: RMB524.7 million) were base wine.

Inventories decreased from RMB684.9 million as at 31 December 2020 to RMB653.6 million as at 31 December 2021, primarily due to the decrease in the number of work in progress. A substantial part of our inventories are work in progress, mainly representing base wine, base soy sauce, semi-finished soybean paste and base vinegar in the brewing period. Due to the long production cycle and short sales cycle, we reserve certain amount of well-aged base wine to cope with the sales growth in the future.

We regularly monitor the inventory level maintained by our distributors. Our sales representatives maintain frequent telephone or email communications with our distributors to inquire about their monthly inventory reports, and pay regular visits to their warehouses. Our sales representatives conduct statistics on the inventory of distributors at least once a week on Saturday, which is reported to the Company weekly, and pay regular visits to the warehouses of distributors to ensure that they keep optimal stock level and our products are sold to end consumers within the shelf life. We generally expect our distributors to maintain sufficient stock for 30 to 60 days of supply. In the event a distributor maintains stocks of more than 45 days of supply, the relevant sales representatives will assist such distributor in marketing and promotional activities and suggest orders with a smaller amount to be placed for the subsequent periods to minimize excess inventory.

As at 31 December 2021, our inventories with a carrying amount of RMB612.7 million (31 December 2020: RMB549.2 million) were pledged to secure other borrowings granted to the Group, for details please refer to note 20 to the consolidated financial statements.

### 存貨

於二零二一年十二月三十一日,本集團存貨賬面值 為人民幣653.6百萬元(二零二零年:人民幣684.9 百萬元),其中人民幣586.0百萬元(二零二零年: 人民幣524.7百萬元)的存貨為基酒。

存貨由二零二零年十二月三十一日的人民幣 684.9 百萬元減至二零二一年十二月三十一日的人民幣 653.6 百萬元,主要由於在製品的數目減少所致。 我們存貨的絕大部分為在製品,主要指處於釀造期 的基酒、基醬油、黃豆醬半成品及基醋。由於較長 的生產週期及較短的銷售週期,我們會儲備一定數 量的經過長年陳釀的基酒存貨,以應對未來的銷售 增長。

我們定期監控經銷商維持的存貨水平。我們的銷售代表與經銷商保持頻繁的電話或電郵聯繫,詢問彼等的月度存貨報告並定期到訪彼等的倉庫。我們的銷售代表至少每周六統計一次經銷商的庫存,每周上報給本公司,以及定期到訪一次經銷商倉庫,確保彼等維持最佳的存貨水平,並確保我們的產品乃在保質期內出售予終端消費者。我們通常期望我們的經銷商維持足以供應30至60天的存貨。倘若某經銷商所維持存貨的供應天數超過45天,相關銷售代表將協助該經銷商進行市場推廣及促銷活動,並建議在隨後期間下達較小額訂單,儘量降低過剩存貨。

於二零二一年十二月三十一日,我們已將賬面值人 民幣612.7百萬元的存貨(二零二零年十二月三十一 日:人民幣549.2百萬元)已予質押以擔保本集團獲 授的其他借款,詳情請參閱綜合財務報表附註20。

### **Borrowings**

As at 31 December 2021, our total borrowings amounted to RMB1,760.4 million (31 December 2020: RMB1,495.5 million).

Our principal sources of liquidity include cash generated from business operation, bank borrowings and other borrowings. The cash from these sources are primarily used for our working capital, the expansion of production capacity, other capital expenditures and debt service requirements.

As at 31 December 2021, the Group does not have outstanding bank loans that were not in compliance with certain financial loan convenants. All of the bank loans has been repaid by Group.

### Foreign currency risks

The Group mainly operates in the PRC and its operations mainly settled in Renminbi. The Group will closely monitor the fluctuations of the Renminbi exchange rate and give prudent consideration as to entering into any currency swap arrangement as and when appropriate for hedging corresponding risks. For the year ended 31 December 2021, the Group was not engaged in hedging activities for managing foreign exchange rate risk.

#### Liquidity and Financial Resources

As at 31 December 2021, we had cash and cash equivalents of RMB31.0 million (31 December 2020: RMB8.4 million). As at 31 December 2021, we had interest-bearing bank and other borrowings of an aggregate amount of RMB1,760.4 million (31 December 2020: RMB1,495.5 million), which were denominated in RMB with interest rates from 4.8% to 24.0% per annum.

Our principal sources of liquidity include cash generated from business operation, bank borrowings and other borrowings. We used cash from such sources for working capital, production facility expansions, other capital expenditures and debt repayment. We expect these uses will continue to be our principal uses of cash in the future, and that our cash flow will be sufficient to fund our ongoing business requirements. Meanwhile, we have decided to further broaden our financing channel to improve our capital structure.

#### 借款

於二零二一年十二月三十一日,我們借款總額為人民幣1,760.4百萬元(二零二零年十二月三十一日:人民幣1,495.5百萬元)。

我們的流動資金主要來源包括從業務營運產生的現金、銀行借款及其他借款。自該等來源獲得的現金主要用作我們的營運資金、擴張產能、其他資本開支及債務服務需求。

於二零二一年十二月三十一日,本集團並無未遵守 若干財務貸款契諾的未償還銀行貸款。所有銀行貸 款均由本集團償還。

### 外幣風險

本集團主要在中國營運,大部分業務以人民幣進行結算。本集團將密切監察人民幣匯率的波動,並審慎考慮於適當時候進行貨幣掉期安排,以對沖相應的風險。截至二零二一年十二月三十一日止年度,本集團並未進行管理外匯匯率風險的對沖活動。

### 流動資金及財務資源

於二零二一年十二月三十一日,我們的現金及現金等價物為人民幣31.0百萬元(二零二零年十二月三十一日:人民幣8.4百萬元)。於二零二一年十二月三十一日,我們的計息銀行及其他借款合計為人民幣1,760.4百萬元(二零二零年十二月三十一日:人民幣1,495.5百萬元),均以人民幣計值,按年利率介乎4.8%至24.0%計息。

我們流動資金的主要來源包括業務營運產生的現金、銀行借款及其他借款。我們過去將來自該等來源的現金用於營運資金、生產設施擴張、其他資本支出及償債需要。我們預期該等用途將繼續為我們未來的主要現金用途,及預期我們的現金流量將足以滿足我們持續經營業務的需求。同時,我們已決定進一步拓寬我們的融資渠道以改善我們的資本架構。

### **GEARING RATIO**

The gearing ratio of the Group was 220.9% as at 31 December 2021, representing a increase of 16.5% over 2020.

The gearing ratio is based on net debt divided by total deficit plus net debt as at 31 December 2021. Net debt includes total debt net of cash and cash equivalents. Total debt includes trade payables, other payables and accruals, amounts due to related companies, amount due to ultimate holding company, interest-bearing bank and other borrowings, provision for loss on unauthorised guarantees and other long term liabilities.

### CAPITAL COMMITMENT

Capital commitment as at 31 December 2021 amounted to RMB9.8 million (31 December 2020: RMB5.0 million), which was mainly related to equipment installation works in condiment workshop.

### **CONTINGENT LIABILITIES**

Save as disclosed in note 41 to the consolidated financial statements in this annual report, as at 31 December 2021, we did not have other material contingent liabilities.

### **PLEDGE OF ASSETS**

As at 31 December 2021, our inventories with a carrying amount of RMB612.7 million, property, plant and equipment with a carrying amount of RMB235.2 million and leasehold land with a carrying amount of RMB49.6 million were pledged to secure general banking facilities granted to us.

Except as disclosed in this report, to the best knowledge and belief of the Directors, we have not entered into any off-balance sheet guarantees or other commitments to guarantee the payment obligations of any third party. It does not have any interest in any unconsolidated entity that provides financing, liquidity, market risk or credit support to it or engage in leasing or hedging or research and development or other service.

### MATERIAL ACQUISITION AND DISPOSAL

The Company has no material acquisition and disposal as at 31 December 2021.

### SIGNIFICANT INVESTMENTS HELD

Our Group did not hold any significant investments during the year ended 31 December 2021.

### **FUTURE PROSPECTS**

In the wake of uncertainties brought by the COVID-19 pandemic and consumers' concern over the global economic prospect, the proportion of household consumption of condiment products is expected to increase, while the proportion of catering and entertainment consumption is expected to decrease accordingly. Therefore, the Company will continue to commit resources to the supermarket, distribution and e-commerce channels related to household consumption in the short term. In the long run, the Group still believes that the catering market will be the main growth point of its future business as the post-pandemic recovery continues in the catering industry. The Group is committed to developing and gradually launching value-for-money products suitable for consumption in the catering market to gain a larger market share.

As for the cooking wine market, the brewing standards of the cooking wine market have been further regulated with the introduction and implementation of the standards for brewing cooking wine. It has become a trend for "pure brewing" to replace the "prepared" and "blended" condiment products in the market. Considering that the growth in sales of brewed cooking wine can be achieved through guiding the consumers' usage habits, the Group will strive to influence consumers from the aspects of raw materials, wine quality, years and brewing technology of its products, aiming at boosting the market share and sales price of the Group's cooking wine products. With the food safety and environmental protection measures deepening, the Group, as a leading player in the cooking wine industry, clearly enjoys more advantages in terms of technology, capital, market and risk resistance over other small and medium-sized enterprises in the market. The Group's outstanding brand awareness, modernised traditional craftsmanship, mature quality control system and comprehensive product research and development system will provide the cooking wine products under "Lao Heng He" brand with more room for development.

In addition to maintaining the leading position of our cooking wine products, we will endeavor to adhere to our strategy of "diversified" product structure so as to meet the diversified market demand for green, healthy and tasty condiment products. We will also keep expanding our production capacity and achieving automation upgrade to enhance our overall profitability. Leveraging on the product quality and technology of "Lao Heng He" brand as our core-competitiveness, we hope to stand out amid fierce market competition through differentiation in product quality.

Therefore, we believe that our "Lao Heng He" products will continue to grow in China.

### 未來前景

面對當前新型冠狀病毒疫情的不確定性及消費者對 全球經濟前景感到擔憂,調味品產品的家庭居家消 費比重將預期會有所增加,相應的,在餐飲娛樂消 費的比重將預期會有所下降。因此,公司將會在短 期保持家庭消費相關的商超、流通和電商等渠道的 資源投入。而從長遠發展看,隨著餐飲業在疫情後 的持續回暖,本集團依舊認為餐飲市場將會是本集 團未來業務的主要增長點,正在致力於開發並逐步 推出性價比高的適合餐飲市場消費的產品以獲取更 大的市場份額。

### **GOALS AND STRATEGIES**

As the pandemic has intensified the cutthroat competition in the condiment market, we will adhere to a consumer-oriented sales strategy. By "diversifying" resources to develop products for different sales channels, we are committed to achieving higher customer loyalty. We focus on our business segments to provide consumers with higher-quality, safer and healthier naturally-brewed condiment products.

Our business goal is to enhance our position in the condiments industry by leveraging on our leading position in the cooking wine industry to diversify the sales channels and conduct sales of portfolio products. On one hand, we will further increase the input in establishing the marketing team and training our staff. On the other hand, we will enrich the product structure of the Company and offer a variety of high-quality products commensurate with the spending power of the general public. In respect of the expansion of distributors, we will continue to cooperate with capable distributors through our diversified sales channels, as well as to actively improve the market share of our "Lao Heng He" brand in the PRC market.

In view of the new spending patterns due to the resurgent pandemic that has lasted more than two years, we also actively accelerated the development of new retail channels and enriched our online products. A batch of new platforms with strategic cooperation have been formed, such as the online platform of KA (Key Account) malls and supermarkets, the community e-commerce platform, and the e-commerce platform for group-buying members, which achieved multi-dimensional and full coverage of promotional effects through live stream videos, short videos, etc. In addition, we also strived to activate the linkage of social e-commerce and the community to create a community distribution model for all shopping guides.

We always pay close attention to and actively address any risks that may come along with the growth of business. In 2021, we released the vitality of the marketing team by reforming the marketing architecture in response to the possible negative impact caused by the incompetence of our sales teams in the sales of the Group's products under the influence of the pandemic. Meanwhile, we also continue to further strengthen the credit risk management of customers by strengthening credit approval and establishing an information sharing platform for distributors to deal with the risks caused by the pandemic.

"Lao Heng He" strives to become a preferred choice of consumers.

### 目標及策略

疫情加劇了調味品市場的激烈競爭,我們的銷售策略仍以消費者為中心,我們的「多元化」地將資源用於開發適合不同銷售渠道的產品,致力實現更高的客戶忠誠度。我們專注於向消費者提供更優質、更安全和更健康的天然釀造的調味品。

我們的經營目標為通過我們在料酒行業的龍頭地位 拓展多元化的銷售渠道,進行組合產品的銷售,提 升公司在調味品行業的市場地位。一方面,我們將 更進一步增加對營銷團隊建設的投入和員工培訓。 另一方面,我們將豐富公司的產品結構,推出更多 優質的且符合大眾消費能力的各類別產品。在經銷 商拓展方面,我們將在不斷地多元化發展的渠道中 與有實力的經銷商合作,繼續積極地提升「老恒和」 品牌在中國市場的市場佔有率。

疫情反復不斷時間跨度超過二年從而帶來的新消費習慣的養成,我們亦積極加快新零售渠道開發速度,豐富線上品項,形成了一批具備戰略合作的新平台,如KA商超的線上平台、社區電商平台、團購會員電商平台等。各平台通過線上直播、短視頻等方式達到多維度全覆蓋的傳播效果。另外,我們也努力驅動社交電商和社群的聯動,打造全員導購的社群分銷模式。

我們亦時刻關注並積極應對增長可能帶來的風險。 二零二一年,我們對營銷架構進行改革,釋放營銷 團隊的活力,來應對疫情影響下銷售團隊能力不足 可能對本集團產品銷售產生的負面影響。同時,我 們還通過加強授信審批及建立經銷商信息共享平台 來進一步加強對客戶的信用風險管理應對疫情導致 的風險。

### EMPLOYEES AND WELFARE CONTRIBUTION

As at 31 December 2021, the Group had approximately 490 full-time employees (31 December 2020: 422). The employees' remuneration packages are determined with reference to their experience and qualifications and general market conditions. The remuneration policies, bonus, evaluation systems and training programs for employees of our Group were implemented continuously according to policies disclosed in the 2020 annual report and no change has been made in 2021.

The total remuneration paid to the Group's employees (excluding Directors' and chief executive's remuneration) for the year ended 31 December 2021 amounted to approximately RMB39.5 million (2020: approximately RMB33.6 million), which included the Group's contribution to the employee benefit plan for the year 2021 of RMB4.0 million (2020: RMB3.5 million). Details of the employee benefit expense are disclosed in note 2.19 to the consolidated financial statements in this annual report.

### **DISCUSSION ON QUALIFIED OPINION**

## (a) Management analysis on the impact of the qualified opinion on the Company's financial position

The Company's auditor expressed a qualified opinion on the Company's consolidated financial statements for the year ended 31 December 2021 (the "Audit Qualification"), on the basis as set out in the section headed "Basis for the Qualified Opinion" in the Independent Auditor's Report. The reason which gave rise to the qualified opinion was due to issues arising from the independent investigation, existence, accuracy, valuation and completeness of inventories and the opening balances and corresponding figures of the Consolidated Financial Statements for the financial year ended 31 December 2020 (the "Prior Year's Consolidated Financial Statements") and the absence of involvement of laboratory examination to validate its chemical contents from an independent third-party examination agency as at 31 December 2020 as Grant Thornton Hong Kong Limited were appointed as auditors subsequent to 31 December 2020 and not able to observe the physical stockcounts at that date, Grant Thornton Hong Kong Limited were unable to obtain sufficient and appropriate audit evidence to satisfy themselves as to the existence, accuracy, valuation and completeness of the inventories as at 31 December 2020 and 1 January 2021.

In relation to the Audit Qualification mentioned in Independent Auditor's Report, the auditor was not able to observe the physical stock-counts of inventories as at 31 December 2020. The qualification on the auditor's opinion for FY2021 is only limited to the opening balances and other corresponding figures of the FY2021 financial statements (the "Qualified Items"), which represented a residual effect of the FY2020 financial statements, on which the auditor has issued a disclaimer of opinion. Accordingly, the Management considers, which the Board and the Audit Committee concurs that, other than the Qualified Items, the consolidated financial statements for FY2021 presents a reasonable view of the affairs of the Group.

The Management has considered the auditor's view as mentioned in the "Basis for Qualified Opinion" of the Independent Auditor's Report and considers the Audit Qualification has been properly addressed.

The Audit Committee has also reviewed the Independent Auditor's Report which highlighted, among other things, the key issues and findings during their audit and the details of the Audit Qualification. For the year ended 31 December 2021, there are no disagreements between the Audit Committee and the Management concerning the Audit Qualification.

The Audit Committee had further discussed with the Company's auditor the impact of the Audit Qualification and agreed that the Audit Qualification would be removed for the financial year 2022 as the Audit Qualification only affect the comparability of figures for the year ended 31 December 2021 and prior year. There is no further impact in upcoming financial year.

### (C) THE BOARD OF DIRECTORS

### **Board Responsibilities**

The Board is responsible for the overall management of the Company, including establishing and overseeing the Company's strategic development, business plans, financial objectives, capital investment proposals and assumes the responsibilities of corporate governance of the Company.

The Board gave their input and considered the priorities and initiatives, aiming at developing a sustainable plan for the Company to generate and preserve its long-term corporate values and to achieve its business strategies and objectives.

The Board may from time to time delegate all or any of its powers that it may think fit to a Director or member of senior management of the Company. The Board has formulated clear and specific rules and policies on such delegation of power to facilitate efficient operation of the Company and is supported by three board committees together the "Board Committees", which are audit Committee (the "Audit Committee"), remuneration Committee (the "Remuneration Committee") and nomination Committee (the "Nomination Committee").

Directors must dedicate sufficient time and attention to the Group's affairs. Besides, the Company also requested all Directors to disclose to the Company annually the number and the nature of offices held in public companies or organizations and other significant commitments with an indication of the time involved.

The Company has arranged appropriate insurance for all Directors in respect of legal actions against the Directors arising out of corporate activities.

There is no financial, business, family or other material or relevant relationships among the Directors of the Company.

An updated list of the roles and functions of Directors is maintained on the websites of the Company and the Stock Exchange, and the Company shall keep updating whenever necessary. The details of the Directors' biographical information (save for those that have resigned) are contained in the section headed "Profile of Directors and Senior Management" of this annual report.

The Company has adopted a Board diversity policy on 25 March 2014 (the "Board Diversity Policy"). The Company recognizes and embraces the benefits of having a diverse Board to the quality of its performance. The Board Diversity Policy aims to set out the approach to achieve diversity on the Board. The Remuneration Committee and Nomination Committee will evaluate the balance and blend of skills, experience and diversity of perspectives of the Board. Selection of candidates will be based on a range of diversity experiences, including but not limited to age, gender, cultural and educational background, and merit and contribution that the selected candidates will bring to the Board.

Having reviewed the Board composition, the Nomination Committee recognises the importance and benefits of the gender diversity at the Board level and will take initiatives to enhance the gender diversity among the Board members when selecting and making recommendation on suitable candidates for Board appointments.

The Board currently consists of only male Directors. In recognising the particular importance of gender diversity, the Company targets to appoint at least one female director by no later than 31 December 2024.

#### **Director Nomination Policy**

In assessing the Board composition, the Nomination Committee would take into account various aspects set out in the Board Diversity Policy, including but not limited to gender, age, cultural and educational background, professional qualifications, skills, knowledge and industry and regional experience. The Nomination Committee would review the implementation of the Board Diversity Policy in achieving the objectives set for the benefits of the Company.

In identifying and selecting suitable candidates for directorships, the Nomination Committee would consider the candidate's character, qualifications, experience, independence and other relevant criteria necessary to complement the corporate strategy and achieve Board diversity, where appropriate, before making recommendation to the Board.

### **Independent Non-executive Directors**

The Company at all times complied with the requirement of Rule 3.10A of the Listing Rules, which requires an issuer's board of directors to have at least one-third of its members being independent non-executive directors. In addition, the Company has duly complied with Rule 3.10(1) and Rule 3.10(2) of the Listing Rules, which requires the issuer's board must include at least three independent non-executive directors and at least one of the independent non-executive directors to have appropriate professional qualifications or accounting or related financial management expertise.

Mr. Ng Wing Fai, chairman of the Company's Audit Committee and being one of the independent non-executive Director, possesses over 20 years of experience in audit, taxation and consultancy in government and non-government institutions. Together with another two independent non-executive Directors, Mr. Shen Zhenchang and Mr. Sun Jiong, all of whom have wide exposure and experience in the cooking food industry and provide the Group with diversified expertise and experience.

Their views and participation in Board and Board committee meetings bring independent judgment and advice on issues relating to the Group's strategies, performance, conflicts of interest, management process and to ensure that the interests of all Shareholders are taken into account.

The Company has received an annual confirmation from each of the independent non-executive Directors on their respective independence pursuant to Rule 3.13 of the Listing Rules and the Board considers that each of them be independent. The Board believes that the present structure of the Board can ensure the independence and objectivity of the Board and provide an effective system of checks and balance to safeguard the interests of the Shareholders and the Company.

The Board considers that the balance between executive and non-executive Directors is reasonable and adequate to provide sufficient checks and balances that safeguard the interests of Shareholders and the Group as a whole. The composition of the Board reflects the necessary balance of skills and experience appropriate for the requirements of the business development of the Group and for effective leadership. The Board has separate and independent access to the senior management and the company secretary at all times.

All Directors, including independent non-executive Directors, are clearly identified as such in all corporate communications containing the names of the Directors.

### Appointment, Re-election and Removal of Directors

Each of the Directors has entered into a service contract or a letter of appointment with the Company for a specific term. The initial term of office for each Director is a term of three years from their respective appointment date and is subject to retirement by rotation at an annual general meeting (the "AGM") at least once every three years. According to the articles of association of the Company (the "Articles"), one-third of the Directors for the time being shall retire from office by rotation at each AGM provided that every Director shall be subject to retirement by rotation at least once every three years. The retiring Directors shall be eligible for re-election at the relevant AGM. In addition, the Articles provide that any Director appointed by the Board to fill a casual vacancy shall hold office only until the first general meeting of the Company after his/her appointment, whereas any Director appointed by the Board as an addition to the existing Board shall hold office only until the next following AGM. The Director appointed by the Board as aforesaid shall be eligible for re-election at the relevant general meeting.

Shareholders may, at any general meeting of the members convened and held in accordance with the Articles, remove a Director at any time before the expiration of his/her period of office notwithstanding to the contrary in the Articles or in any agreement between the Company and such Director.

No annual general meeting of the Company was held since 29 June 2020. Therefore, no Directors have been subject to retirement and re-election by the Shareholders at the annual general meeting.

#### **Board and Board Committee Meetings**

Under code provision A.1.1 of the Governance Code (which has been renumbered as code provision C.5.1 with effect from 1 January 2022), the Board should meet regularly and Board meetings should be held at least four times a year at approximately quarterly intervals and under code provision A.2.7 of the Governance Code (which has been renumbered as code provision C.2.7 with effect from 1 January 2022), the chairman of the board should at least annually hold meeting with the non-executive Directors (including independent non-executive Directors) without the executive Directors present.

At least 14 days' notice for all regular Board meetings will be given to all Directors and all Directors must be given the opportunity to include items or businesses for discussion in the agenda. For all other Board meetings, reasonable notice will be given. Relevant agenda and accompanying Board papers will be sent to all Directors at least three days in advance of every regular Board meeting.

All matters and decisions reached, including any concerns raised by Directors or dissenting views expressed, will be recorded in minutes of Board meeting or other Board committees meetings in sufficient detail. Draft and final versions of minutes of Board/Board committee meetings will be sent to all Directors/committee members for comment and records respectively, within reasonable time after the respective meetings are held. The final versions of these minutes are kept by the Company secretary of the Company and are available for inspection at any reasonable time on reasonable notice by any Director and auditor of the Company.

During the year ended 31 December 2021, the Board convened a total of eight Board meetings, one Remuneration Committee meeting, one Nomination Committee meeting, six Audit Committee meetings, based on the need of the operation and business development of the Company.

The Board intends to meet at least four times per year in the future, and the chairman of the Board intends to hold at least one meeting per year with the non-executive Directors (including the independent non-executive Directors) without the executive Directors present.

During the year ended 31 December 2021, the Board considers that all meetings have been legally and properly convened in compliance with the relevant laws and regulations (including the Listing Rules and the Articles). With the assistance of the company secretary, the chairman of the Board takes the lead to ensure that Board meetings and Board committee meetings are convened in accordance with the requirements set out in the Articles, the terms of reference of the respective Board committees and the Listing Rules. The Director's attendance at the Board meetings is set out in the section headed "Attendance at Board and Board Committee Meetings" below.

Upon making reasonable request to the Company, Board members have the right to seek independent professional advice or services at the Company's expense to assist them to perform their duties to the Company.

Should a potential conflict of interest involving substantial Shareholder(s) or Director(s) arise and the Board considers the matter to be material, the Company will hold a physical Board meeting to discuss and consider the matter, instead of passing a written resolution. Independent non-executive Directors who, and whose associates, have no material interest in the transaction should be required to be present at that Board meeting.

#### **Corporate Governance Responsibilities**

The Board is responsible for fulfilling the following corporate governance responsibilities:

- develop and review the Company's corporate governance policies and practices and put forward recommendations to the Board;

- review the Company's compliance with the Code and disclosure in the corporate governance report; and
- develop shareholder communications policy and regularly review the policy to ensure its effectiveness.

## (D) CHAIRMAN AND CHIEF EXECUTIVE

Code provision A.2.1 of the Governance Code (which has been renumbered as code provision C.2.1 with effect from 1 January 2022) provides that the roles of the chairman and the chief executive officer (the "CEO") should be separate and should not be performed by the same individual. The division of responsibilities between the chairman and the CEO should be clearly established and set out in writing.

The Group has complied with the practice in code provision A.2.1 of the Governance Code (which has been renumbered as code provision C.2.1 with effect from 1 January 2022) since 11 September 2020 when Mr. Chen Weizhong resigned as the chairman of the Board and Mr. Chen Wei ("Mr. Chen") has been appointed as the chairman of the Board and an executive Director.

The Remuneration Committee and Nomination Committees also regularly review the structure and composition of the Board and will make appropriate recommendations to the Board regarding any proposed changes.

The Board will continue to review and monitor the practices of the Company with an aim to maintaining and implementing a high standard of corporate governance practices.

Mr. Chen, as the chairman of the Board, is responsible for ensuring that the Directors receive in a timely manner, adequate information which is accurate, clear, complete and reliable. He ensures that all Directors are properly briefed on issues arising at the Board meetings. Mr. Chen is also responsible for ensuring good corporate governance practices and procedures are maintained, all Directors make full and active contribution to the Board's affairs, and the Board acts in the best interests of the Company and its Shareholders.

Under the leadership of Mr. Chen, the Board works effectively and performs its responsibilities with all key and appropriate issues discussed in a timely manner. Appropriate steps are taken to provide effective communication between the Shareholders and the Board. Mr. Chen will ensure appropriate steps are taken and the Shareholders' views are communicated to the Board as a whole.

A culture of openness and constructive relations among Directors are promoted within the Board, facilitating effective contribution of non-executive Directors and ensuring constructive relations between executive and non-executive Directors.

In the year ended 31 December 2021, Mr. Chen, the chairman of the Board has met with the independent non-executive Directors (without the presence of the executive Directors) once to discuss, and obtain independent views of, the Board affairs.

The Board is supported by the Board Committees, and the Board has delegated various responsibilities to the Board Committees, namely the Audit Committee, Remuneration Committee and the Nomination Committee. All Board Committees perform their distinct roles in accordance with their respective terms of reference which are available to public on the websites of the Company and the Stock Exchange.

The Company has provided the Board Committees with sufficient resources and the Board Committees may seek independent professional advice as and when required at the Company's expense.

#### **Audit Committee**

The Company established the Audit Committee on 17 December 2013 with written terms of reference in compliance with the Rules Governing the Listing of Securities (the "Listing Rules") on the Stock Exchange and the Governance Code. The Audit Committee currently has four members, namely Mr. Ng Wing Fai, Mr. Sun Jiong, Mr. Shen Zhenchang and Mr. Gu Wei. Mr. Ng Wing Fai, the Company's independent non-executive Director, has been appointed as the chairman of the Audit Committee, and possess the appropriate professional qualifications required under the Listing Rules. The Audit Committee has access to professional advice, if required, and is provided with sufficient resources to perform its duties.

The primary responsibilities of the Audit Committee are to review and supervise the financial reporting process, financial control, internal control and risk management systems of the Company, nominate and monitor external auditor, oversee the audit process and perform other duties and responsibilities as assigned by the Board on an annual basis.

These events or conditions indicate that a material uncertainty exists that may cast significant doubt on the Group's ability to continue as a going concern. Their opinion is not modified in respect of this matter. Save as disclosed in note 2.2 of the consolidated financial statements in this annual report, the Directors are not aware of any other material uncertainties relating to events or conditions that may cast significant doubt upon the Company's ability to continue as a going concern.

The statement of the auditors of the Company in respect of their reporting responsibilities on the Company's consolidated financial statements for the year ended 31 December 2021 is set out in the "Independent Auditors' Report" contained in this annual report.

# (I) RISK MANAGEMENT AND INTERNAL CONTROL

The Board is responsible for maintaining effective risk management and internal control systems and conducting regular review on the effectiveness of the risk management and internal control system of the Company. The risk management and Internal Control systems of the Group are characterised by distinct division between power and authority, clear procedures, high transparency and efficiency. The Company has worked out a procedure for identifying, evaluating and managing significant risks of the Company. Business departments including the production and sales departments are responsible for identifying, supervising and evaluating the risks related to themselves, and report to the Company's senior management on a regular basis. The senior management shall evaluate and set priorities for the identified risks according to the procedure set by the Board's Audit Committee, and then submit risk alleviation plans to the Audit Committee which shall appoint officers responsible for risk management.

However, the system can only provide reasonable but not absolute assurance against misstatements or losses.

The Board is responsible for presenting a balanced and clear assessment of the Group's performance and prospects. Management of the Company provides all relevant information to the Board, giving its members sufficient information and explanation that it needs to discharge their responsibilities.

The Board acknowledged that there are major internal control deficiencies identified as a result of the findings from the forensic investigation and internal control review.

As at the date of this report, the internal control review has completed. Please refer to the announcement of the Company dated 27 September 2022 for further details of the internal control review, defects identified in the internal control systems and procedures of the Group and remediation actions taken by the Group.

As disclosed in the Company's announcement dated 30 March 2021, 26 April 2021, 24 June 2021, 30 August 2021, 31 March 2022 and 31 August 2022, (1) the publication of the annual results for the year ended 31 December 2020 and 31 December 2021; (2) the despatch of the annual report for the year ended 31 December 2020 and 31 December 2021; (3) the publication of the interim results for the six months ended 30 June 2021 and 30 June 2022; and (4) the despatch of the interim report for the six months ended 30 June 2021 had been delayed (the "**Delay**"). For reasons of the delay, please refer to the mentioned announcements.

The Delay constitutes non-compliance of Rules 13.49(1), 13.46(2)(a), 13.48(1) and 13.49(6) of the Listing Rules respectively. The failure to lay the financial statements for the year ended 31 December 2020 and 31 December 2021 before its members at an annual general meeting within 6 months after the end of the financial year constitutes non-compliance of Rule 13.46(2)(b) of the Listing Rule.

The Company had kept the Shareholders and potential investors informed of the progress of the aforesaid matters by announcements. Eventually, the mentioned annual results and interim results were released and published on the websites of the Stock Exchange and the Company in September 2022. It is expected that the relevant reports will be despatch in due course. The Board is of the view that the aforesaid delays are one-off incidents and that the aforesaid matters had been/will be rectified eventually and the Company had complied with the Listing Rules in keeping the Shareholders and investors informed of the progress of the aforesaid matters.

To safeguard Shareholders' interests and rights, a separate resolution is proposed for each substantially separate issue at general meetings, including the election of individual Directors. All resolutions put forward at Shareholders' meetings will be voted on by poll pursuant to the Listing Rules and poll results will be posted on the websites of the Company (www.hzlaohenghe.com) and Stock Exchange after each Shareholders' meeting. The Articles allow a Shareholder to attend and vote at a general meeting or to appoint a proxy, who needs not be a Shareholder, to attend the meeting and vote thereat on his/her/its behalf.

Pursuant to the Articles, any one or more Shareholders holding at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company carrying the right of voting at general meetings of the Company shall have the right, by written requisition to the Board or the secretary of the Company, to require an extraordinary general meeting to be called by the Board for the transaction of any business specified in such requisition, and such meeting shall be held within two months after the deposit of such requisition. If within 21 days of such deposit the Board fails to proceed to convene such meeting, the requisitionist(s) himself (themselves) may do so in the same manner, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to the requisitionist(s) by the Company.

With respect to the Shareholders' right in proposing persons for election as Directors, please refer to the procedures available on the website of the Company.

There is no provision allowing Shareholders to move new resolutions at general meetings under the Cayman Islands Companies Law or the Articles. Shareholders who wish to move a resolution may request the Company to convene a general meeting following the procedures set out in the preceding paragraph.

As at 31 December 2021, the Group had 490 full-time employees, as compared to 422 employees as at 31 December 2020. The Group enters into employment contracts with its employees to cover matters such as position, term of employment, wage, employee benefits, liabilities for breaches and grounds for termination. Remuneration of the Group's employees includes basic salaries, allowances, bonus and other employee benefits and are determined with reference to their experiences, qualifications, competence and general market conditions.

The emoluments payable to the Directors will depend on their respective contractual terms under their employment contracts or service agreements as approved by the Remuneration Committee and Nomination Committee, having regard to the Company's operating results, individual performance and comparable market statistics. No Director should determine his or her own remuneration.

Details of the Directors' emoluments and emoluments of the five highest paid individual in the Group are set out in notes 12 and 13 to the consolidated financial statements in this annual report.

#### RETIREMENT BENEFITS SCHEME

The Company participates in the Mandatory Provident Fund Schemes ("MPF Schemes") registered under the Mandatory Provident Scheme Fund Ordinance. The contributions represent contributions payable to the MPF Schemes by the Company in accordance with government regulations.

The employees employed in the PRC subsidiaries are members of the state-managed retirement benefits schemes operated by the PRC government. The PRC subsidiaries are required to contribute to the retirement benefits schemes based on a certain percentage of their payroll to fund the benefits. The only obligation of the Group with respect to these retirement benefits schemes is to make the required contributions under the schemes.

Contributions paid or payable for these retirement benefits schemes for the year of 2021 are approximately RMB4.0 million (2020: RMB3.4 million). No forfeited contributions are available to reduce the contribution payable by the Group in future years.

By increasing investment in team building and employee training, the Group provides employees with competitive remuneration packages and social security. The Group also continuously improves employee communication and transparent promotion mechanism to provide employees with a fair working environment while enhancing employees a sense of belonging.

The Group is well aware of the importance of partnership and customer relationship maintenance in the development and is determined to become the preferred brand for consumers. On one hand, the Group actively establishes a long-term cooperative relationship based on the principle of responsible procurement to ensure a stable supply of raw materials. On the other hand, the Group has enriched products' structure, launched more high-quality products that meet customers' needs, and cooperated with powerful distributors to actively increase the market share of our "Lao Heng He" brand, market influence and customer loyalty. The Group always pays close attention to and actively responds to the feedback and suggestions from suppliers and customers, during the year ended 31 December 2021, there were no significant or major disputes with our suppliers and/or customers.

We have audited the consolidated financial statements of Honworld Group Limited (the "Company") and its subsidiaries (collectively referred to as the "Group") set out on pages 77 to 192, which comprise the consolidated statement of financial position as at 31 December 2021, and the consolidated statement of profit or loss and other comprehensive income, the consolidated statement of changes in equity and the consolidated statement of cash flows for the year then ended, and notes to the consolidated financial statements, including a summary of significant accounting policies.

In our opinion, except for the possible effect of the matters described in the Basis for Qualified Opinion section of our report, the consolidated financial statements give a true and fair view of the consolidated financial position of the Group as at 31 December 2021, and of its consolidated financial performance and its consolidated cash flows for the year then ended in accordance with International Financial Reporting Standards ("IFRSs") issued by the International Accounting Standards Board ("IASB") and have been properly prepared in compliance with the disclosure requirements of Hong Kong Companies Ordinance.

#### **BASIS FOR QUALIFIED OPINION**

Our auditors' report on the consolidated financial statements of the Group for the financial year ended 31 December 2020 as contained in the annual report of the Company for that financial year (the "Prior Year's Consolidated Financial Statements") contained disclaimer of opinion, which form the basis for the corresponding figures presented in the current year's consolidated financial statements, as we were unable to obtain sufficient and appropriate audit evidence in respect of the issues arising from the independent investigation, existence, accuracy, valuation and completeness of inventories and the opening balances and corresponding figures of the Prior Year's Consolidated Financial Statements. Accordingly, the matters in respect of the independent investigation and the opening balances and corresponding figures of the Prior Year's Consolidated Financial Statements would affect the financial performance of the Group for the year ended 31 December 2020. Our opinion on the current year's consolidated financial statements for the year ended 31 December 2021 is also modified because of the possible effects of these matters on the comparability of the current year's figures and the corresponding figures.

In addition, due to the absence of involvement of laboratory examination to validate its chemical contents from an independent third-party examination agency at 31 December 2020 as we were appointed as auditors subsequent to 31 December 2020 and not able to observe the physical stock-counts at that date, we were unable to obtain sufficient and appropriate evidence to satisfy ourselves as to the existence, accuracy, valuation and completeness of the inventories as at 31 December 2020 and 1 January 2021. Any adjustments that might be found necessary as a result of this matter described above might affect the accuracy on the cost of sales charged for the year ended 31 December 2021, which have a consequential effect on the Group's results and cash flows for the year ended 31 December 2021 and the related disclosures thereof in the consolidated financial statements. Accordingly, our audit opinion on the current year's financial performance and consolidated cash flows for the year ended 31 December 2021 is also modified.

We conducted our audit in accordance with Hong Kong Standards on Auditing ("HKSAs") issued by the HKICPA. Our opinion is not modified in respect of this matter.

#### **KEY AUDIT MATTERS**

Key audit matters are those matters that, in our professional judgement, were of most significance in our audit of the consolidated financial statements of the current period. These matters were addressed in the context of our audit of the consolidated financial statements, and in forming our opinion thereon, and we do not provide a separate opinion on these matters. In addition to the matters described in the Basis for Qualified Opinion section, we have determined the matters described below to be the key audit matters to be communicated in our report. For each matter below, our description of how our audit addressed the matter is provided in that context.

#### Existence for inventories 存在存貨

We identified the existence for inventories as key audit matter due to the significance of the balance to the consolidated financial statements and the involvement of risks of material misstatement.

The Group has a significant balance of inventories and needs to maintain its inventories at an appropriate level to meet the future market and production needs. As at 31 December 2021, the inventory balance of the Group was approximately RMB653,611,000, representing approximately 54.8% of the Group's total assets. The majority of the inventories were the work in progress which are base wine and base soy sauce amounted approximately RMB631,304,000. The existence of base wine and base soy sauce could not be easily substantiated via physical observation since it was massive in quantity and this needs involvement of laboratory examination to validate its chemical contents.

The disclosures of inventory provision are included in note 20 to the consolidated financial statements.

我們將存在存貨識別為關鍵審計事項,原因為有關結餘對綜 合財務報表而言屬重大且涉及重大錯報風險。

貴集團有大量存貨結餘且需要維持適當水平的存貨以滿足未來的市場及生產需求。於二零二一年十二月三十一日, 貴集團存貨結餘約為人民幣653,611,000元,佔 貴集團總資產約54.8%,且大部分存貨為在製品基酒及基醬油,其金額約為人民幣631,304,000元。由於基酒及基醬油數量極大且需要實驗室檢驗以驗證其化學成分,因此基酒及基醬油的存在不能通過實物觀察而輕易證實。

有關存貨撥備的披露載於綜合財務報表附註20。

Our audit procedures in relation to the existence for inventories included the following:

- discussed with management and understood the Group's internal controls over the inventories;
- observed the Group's physical stock-counts at the end of the current reporting period which covered the major types of the Group's inventories, and randomly selected certain inventory samples (the "Inventory Samples") during the observation and assessed the laboratory examination results of the chemical contents of the Inventory Samples from an independent third- party examination agency (the "Laboratory Examination Results") engaged by us; and
- assessed the results regarding the independence and competence of industry experts from the examination agency (the "Experts"), and with the assistance of the Experts assessed the reasonableness of (i) the input-output ratios of the Group's base wine with different alcohol levels and base soy sauce, which represented the proportional relations that exist between input volumes of raw materials and output volumes of base wine and base soy sauce, and (ii) the Laboratory Examination Results.

- 與管理層展開討論,了解 貴集團對存貨的內部監控;

#### Provision for inventories 存貨撥備

We identified the inventory provision as key audit matter due to the significance of the balance to the consolidated financial statements and the involvement of subjective judgement and management estimates in inventory provision at the end of the reporting period.

The Group has a significant inventory balance and needs to maintain the majority of its base wine at an appropriate level for a period over one year to meet the future production needs. We focused on this area because the determination of inventory provisions involved significant estimation of the net realisable values (the "NRV") of the inventories which were influenced by assumptions concerning future sales and usage and judgements in determining the appropriate level of inventory provisions against identified surplus or obsolete items.

The significant accounting judgements and estimates and disclosures of inventory provision are included in notes 4.2(c) and 20 to the consolidated financial statements.

我們將存貨撥備識別為關鍵審計事項,原因為有關結餘對綜合財務報表而言屬重大且報告期末之存貨撥備涉及主觀判斷 及管理層估計。

貴集團有大量存貨結餘且需要在一年以上期間內將其大部分 基酒維持於適當水平以滿足未來的生產需求。我們關注此方 面是由於存貨撥備涉及對存貨可變現淨值(「**可變現淨值**」)的 重大估計,而關於未來銷售及使用情況的假設以及釐定相對 於已識別過剩品或過時品的適當存貨撥備水平時的判斷將影 響該等估計。

有關存貨撥備的重大會計判斷及估計以及披露載於綜合財務 報表附註4.2(c)及20。 Our audit procedures in relation to the inventory provision included the following:

- obtained an understanding on the internal controls and process over inventory provision and how management estimates the provision for inventories;
- reviewed the ageing of the Group's inventories;
- assessed the Group's assumptions used in the inventory provision calculation by reviewing the basis, the rationale and the consistency of the inventory provision policy;
   and
- on a sampling basis, reviewed the NRV of inventories with reference to selling prices achieved and cost to sell after the financial year end.

If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. Because of the possible effects of the matters described in the Basis for Qualified Opinion section above, we are unable to conclude whether or not the Other Information is materially misstated with respect to these matters.

## RESPONSIBILITIES OF DIRECTORS FOR THE CONSOLIDATED FINANCIAL STATEMENTS

The directors are responsible for the preparation of the consolidated financial statements that give a true and fair view in accordance with IFRSs issued by the IASB and the disclosure requirements of the Hong Kong Companies Ordinance, and for such internal control as the directors determine is necessary to enable the preparation of consolidated financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the consolidated financial statements, the directors of the Company are responsible for assessing the Group's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the directors either intend to liquidate the Group or to cease operations or have no realistic alternative but to do so.

The directors assisted by the Audit Committee are responsible for overseeing the Group's financial reporting process.

#### 1. CORPORATE INFORMATION

The Company was incorporated in the Cayman Islands on 4 December 2012 as an exempted company with limited liability under the Companies Law, Cap 22 (Law 3 of 1961, as consolidated and revised) of the Cayman Islands. The Company's registered office address is Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman KY1-1111, Cayman Islands.

The Company is an investment holding company. During the year, the Company and its subsidiaries (collectively known as the "**Group**") were principally engaged in the manufacture and sale of condiment products under the brand name of "Lao Heng He" in the People's Republic of China (the "**PRC**").

In the opinion of the directors, the holding company and the ultimate holding company of the Company is Key Shine Global Holdings Limited ("**Key Shine**"), which was incorporated in the British Virgin Islands ("**BVI**").

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### 2.1 Basis of preparation

These annual consolidated financial statements have been prepared in accordance with International Financial Reporting Standards ("IFRSs") which collective term includes all applicable individual International Financial Reporting Standards, International Accounting Standards ("IASs") and Interpretations issued by the International Accounting Standards Board ("IASB") and the disclosure requirements of the Hong Kong Companies Ordinance.

The consolidated financial statements also comply with the applicable disclosure requirements of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited ("Listing Rules").

The significant accounting policies that have been used in the preparation of these consolidated financial statements are summarised below. These policies have been consistently applied to all the years presented unless otherwise stated. The adoption of new or amended IFRSs and the impacts on the Group's consolidated financial statements, if any, are disclosed in note 3.

The consolidated financial statements have been prepared on the historical cost basis.

The measurement bases are fully described in the accounting policies below.

#### 2.2 Going concern assumption

In preparing the consolidated financial statements, the directors of the Company have given consideration to the future liquidity of the Group in light of its net cash used in operating activities of approximately RMB97,809,000 and net loss of approximately RMB318,449,000 incurred for the year ended 31 December 2021 and, as of that date, the Group had net current liabilities of approximately RMB1,476,620,000, capital deficiency of approximately RMB1,317,894,000 and accumulated losses of approximately RMB2,191,201,000, respectively.

As at 31 December 2021, the Group's total borrowings comprising interest-bearing other borrowings amounting to approximately RMB1,760,412,000, of which current borrowings amounted to approximately RMB1,694,722,000 and approximately RMB983,393,000 were overdue as disclosed in note 29 to the consolidated financial statements, while its cash and cash equivalents amounted to approximately RMB31,015,000.

#### 2. 主要會計政策概要

#### 2.1 編製基準

#### 2.2 持續經營假設

在編製綜合財務報表時,鑑於本集團於截至二零二一年十二月三十一日止年度經營活動所用淨現金約為人民幣97,809,000元及虧損淨值約人民幣318,449,000元,而截至該日,本集團之流動負債淨值約為人民幣1,476,620,000元、資本虧絀約為人民幣1,317,894,000元及累計虧損約為民幣2,191,201,000元,本公司董事已慮及其日後之流動資金。

於二零二一年十二月三十一日,本集團的借款總額包括計息其他借款約人民幣1,760,412,000元,其中即期借款約為人民幣1,694,722,000元及約人民幣983,393,000元已逾期(如綜合財務報表附註29所披露),而其現金及現金等價物則約為人民幣31,015,000元。

#### 2.2 Going concern assumption (Continued)

Despite of these circumstances, the consolidated financial statements have been prepared on a going concern basis on the assumption that the Group is able to operate as a going concern for the foreseeable future. In the opinion of the directors of the Company, the Group can meet its financial obligations as and when they fall due within the next year from the end of the reporting period, after taking into consideration of the measures and arrangements that the Group has implemented or is in the process of implementing as detailed below:

- The chargor, Wuxing City Investment HK Company Limited\*, has undertaken to provide continuing financial support to the Group for a period of fourteen months from the date of approval of the consolidated financial statements by the directors in order to maintain the Group as a going concern;
- The Group is in negotiation with banks and financial institutions for the renewals of the Group's short term borrowings upon expiry, new borrowings and applying for future credit facilities. Up to the date of approval of these consolidated financial statements, the Group's major lenders, 湖州吳興南太湖建設投資集團有限公司 (formerly known as 湖州吳興南太湖建設投資有限公司) ("南太湖")\*, 湖州湖盛融資租賃有限公司 ("湖盛融資")\* and Huzhou Wuxing Chengshi Tousi Fazhan Jituan Youxian Gongsi 湖州吳興城市投資發展集團有限公司 ("湖州吳興城市")\* have shown the positive support on the Group by not require the Group to repay the loan of RMB1,358,534,000, RMB207,918,000 and RMB138,736,000 respectively and has undertaken to provide new financing facilities of approximately RMB300,000,000 for a period of fourteen months from the date of approval of these consolidated financial statements. Therefore, the directors of the Company are confident that the entire borrowings can be renewed upon expiration and future credit facilities can be applied based on the Group's past experience and credit history; and
- The directors have evaluated all the relevant facts available to them and made a business plan to improve its liquidity by (i) monitoring the production activities in order to fulfill the forecast production volume and meet sales forecast, (ii) taking measures to tighten cost controls over various production costs and expenses, and (iii) any feasible financial arrangement.

- 本集團現正與銀行及財務機構磋 商於本集團之短期借貸到期時為 借貸續期、申請新借貸及申請未 來信貸融資。截至該等綜合財務 報表獲批准之日,本集團主要貸 款人湖州吳興南太湖建設投資集 團有限公司(前稱湖州吳興南太湖 建設投資有限公司)(「南太湖」)、 湖州湖盛融資租賃有限公司(「湖 盛融資1)及湖州吳興城市投資發 展集團有限公司(「湖州吳興城 市」)不要求本集團在批准本綜合 財務報表之日起十四個月期間分 別償還貸款人民幣1,358,534,000 元,人民幣207,918,000元及人民 幣 138,736,000 元,以對本集團表 示積極支持,並已承諾提供新融 資額度約人民幣300,000,000元。 因此,按照本集團之過往經驗及 信用記錄,本公司董事相信,整 筆借貸可於到期時續期及可動用 未來信貸融資;及

#### 2.2 Going concern assumption (Continued)

The directors of the Company have reviewed the Group's cash flows forecast, prepared by management which covers a period of two years from the end of the reporting period. They are of the opinion that, taking into account the abovementioned plans and measures, the Group will have sufficient cash resources to satisfy its working capital and other financial obligations for the next twelve months from the end of the reporting period after having taken into account of the Group's projected cash flows, current financial resources and capital expenditure requirements with respect to the production facilities and development of its business. Accordingly, the directors are of the opinion that it is appropriate to prepare the consolidated financial statements of the Group for the year ended 31 December 2021 on a going concern basis.

Notwithstanding the above, significant uncertainties exist as to whether the management of the Company will be able to achieve its plans and measures as described above. Whether the Group will be able to continue as a going concern would depend upon the Group's ability to generate adequate financing and operating cash flows in the near future and obtain the continuous financial support from its chargor and major lenders.

Should the going concern assumption be inappropriate, adjustments may have to be made to write down the carrying values of assets to their recoverable amounts, to provide for any further liabilities that might arise, and to reclassify noncurrent assets and non-current liabilities as current assets and current liabilities, respectively. The effects of these adjustments have not been reflected in the consolidated financial statements.

\* Pursuant to a share mortgage deed dated 2 April 2019, Key Shine charged 229,424,000 shares of the Company to Wuxing City Investment HK Company Limited, which is wholly owned by 湖州吳興城市. 南太湖 and 湖盛融資 were also the subsidiaries of 湖州吳興城市.

#### 2.3 Basis of consolidation

The consolidated financial statements include the financial statements of the Group for the year ended 31 December 2021. A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

When the Company has, directly or indirectly, less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- (a) the contractual arrangement with the other vote holders of the investee:
- (b) rights arising from other contractual arrangements; and
- (c) the Group's voting rights and potential voting rights.

The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control and continue to be consolidated until the date that such control ceases.

Profit or loss and each component of other comprehensive income are attributed to the owners of the Company of the Group and to the non-controlling interests, even if this results in the non-controlling interests having a deficit balance. All intragroup assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control described above. A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction.

If the Group loses control over a subsidiary, it derecognises (i) the assets (including goodwill) and liabilities of the subsidiary, (ii) the carrying amount of any non-controlling interest and (iii) the cumulative translation differences recorded in equity; and recognises (i) the fair value of the consideration received, (ii) the fair value of any investment retained and (iii) any resulting surplus or deficit in profit or loss. The Group's share of components previously recognised in other comprehensive income is reclassified to profit or loss or retained profits, as appropriate, on the same basis as would be required if the Group had directly disposed of the related assets or liabilities.

#### 2.4 Foreign currency translation

The consolidated financial statements are presented in Renminbi ("RMB"), which is also the functional currency of the Company.

In the individual financial statements of the consolidated entities, foreign currency transactions are translated into the functional currency of the individual entity using the exchange rates prevailing at the dates of the transactions. At the reporting date, monetary assets and liabilities denominated in foreign currencies are translated at the foreign exchange rates ruling at that date. Foreign exchange gains and losses resulting from the settlement of such transactions and from the reporting date retranslation of monetary assets and liabilities are recognised in profit or loss.

Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing on the date when the fair value was determined. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated (i.e. only translated using the exchange rates at the transaction date).

In the consolidated financial statements, all individual financial statements of foreign operations, originally presented in a currency different from the Group's presentation currency, have been converted into RMB. Assets and liabilities have been translated into RMB at the closing rates at the reporting date. Income and expenses have been converted into the RMB at the exchange rates ruling at the transaction dates, or at the average rates over the reporting period provided that the exchange rates do not fluctuate significantly. Any differences arising from this procedure have been recognised in other comprehensive income and accumulated separately in the translation reserve in equity.

Goodwill and fair value adjustments arising on the acquisition of a foreign operation on or after 1 January 2005 have been treated as assets and liabilities of the foreign operation and translated into Hong Kong dollars at the closing rates. Goodwill arising on the acquisitions of foreign operations before 1 January 2005 is translated at the foreign exchange rate that applied at the date of acquisition of the foreign operation.

On the disposal of a foreign operation (i.e., a disposal of the Group's entire interest in a foreign operation, or a disposal involving loss of control over a subsidiary that includes a foreign operation, or loss of significant influence over an associate that includes a foreign operation), all of the accumulated exchange differences in respect of that operation attributable to the Group are reclassified to profit or loss. Any exchange differences that have previously been attributed to noncontrolling interests are derecognised, but they are not reclassified to profit or loss.

In the case of a partial disposal (i.e., no loss of control) of a subsidiary that includes a foreign operation, the proportionate share of accumulated exchange differences are re-attributed to non-controlling interests and are not recognised in profit or loss. For all other partial disposals (i.e., of associates not involving a change of accounting basis), the proportionate share of the accumulated exchange differences is reclassified to profit or loss.

## 2.5 Property, plant and equipment and depreciation

Property, plant and equipment (other than construction in progress as described below) are initially recognised at acquisition cost or manufacturing cost, including any cost directly attributable to bringing the assets to the location and condition necessary for them to be capable of operating in the manner intended by the Group's management. They are subsequently stated at cost less accumulated depreciation and accumulated impairment losses, if any.

Properties in the course of construction for production, supply or administrative purposes are carried at cost, less any recognised impairment loss. Costs include professional fees and, for qualifying assets, borrowing costs capitalised in accordance with the Group's accounting policy. Such properties are classified to the appropriate categories of property, plant and equipment when completed and ready for intended use. Depreciation of these assets, on the same basis as other property assets, commences when the assets are ready for their intended use.

Depreciation is recognised so as to write off the cost of assets, other than construction in progress, less their residual values over their estimated useful lives, using the straight-line method, as follows:

Buildings 5%
Machinery and equipment 5% to 20%
Furniture and fixtures 20% to 33½%
Motor vehicles 20%
Leasehold improvements Over the lease terms

Accounting policy for depreciation of right-of-use assets is set out in note 2.13.

Estimates of residual value and useful life are reviewed, and adjusted if appropriate, at each reporting date.

Gain or loss arising on retirement or disposal is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in profit or loss.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. The carrying amount of the replaced part is derecognised. All other costs, such as repairs and maintenance, are charged to profit or loss during the financial period in which they are incurred.

Construction in progress represents property, plant and equipment under construction, which are stated at cost less any impairment losses, and are not depreciated. Cost comprises the direct costs of construction during the period of construction. Construction in progress is reclassified to the appropriate category of property, plant and equipment when completed and ready for use.

## 2.6 Intangible assets (other than goodwill) and research and development activities

#### Intangible assets (other than goodwill)

Acquired intangible assets are recognised initially at cost. After initial recognition, intangible assets with finite useful lives are carried at cost less accumulated amortisation and any accumulated impairment losses. Amortisation for intangible assets with finite useful lives is provided on straight-line basis over their estimated useful lives. Amortisation commences when the intangible assets are available for use. The following useful lives are applied:

Computer software

5 years

Intangible assets with indefinite useful lives are carried at cost less any subsequent accumulated impairment losses.

The assets' amortisation methods and useful lives are reviewed, and adjusted if appropriate, at each reporting date.

Intangible assets, with finite and indefinite useful lives, are tested for impairment as described below in note 2.18.

Costs associated with research activities are expensed in profit or loss as they occur. Costs that are directly attributable to development activities are recognised as intangible assets provided they meet the following recognition requirements:

- demonstration of technical feasibility of the prospective product for internal use or sale;
- there is intention to complete the intangible asset and (ii) use or sell it;
- the Group's ability to use or sell the intangible asset is demonstrated:
- the intangible asset will generate probable economic benefits through internal use or sale;
- sufficient technical, financial and other resources are available for completion; and
- the expenditure attributable to the intangible asset can be reliably measured.

Direct costs include employee costs incurred on development activities along with an appropriate portion of relevant overheads. The costs of development of internally generated software, products or knowhow that meet the above recognition criteria are recognised as intangible assets. They are subject to the same subsequent measurement method as acquired intangible assets.

All other development costs are expensed as incurred.

Financial assets and financial liabilities are recognised when the Group becomes a party to the contractual provisions of the financial instrument.

Financial assets are derecognised when the contractual rights to the cash flows from the financial asset expire, or when the financial asset and substantially all of its risks and rewards are transferred. A financial liability is derecognised when it is extinguished, discharged, cancelled or expires.

#### Financial assets

Classification and initial measurement of financial assets

Except for those trade receivables that do not contain a significant financing component and are measured at the transaction price in accordance with IFRS 15, all financial assets are initially measured at fair value, in case of a financial asset not at fair value through profit or loss ("FVTPL"), plus transaction costs that are directly attributable to the acquisition of the financial asset. Transaction costs of financial assets carried at FVTPL are expensed in the consolidated statement of profit or loss and other comprehensive income.

Financial assets, other than those designated and effective as hedging instruments, are classified into the following categories:

- amortised cost; or
- FVTPL.

The classification is determined by both:

- the entity's business model for managing the financial asset; and
- the contractual cash flow characteristics of the financial asset.

All income and expenses relating to financial assets that are recognised in profit or loss are presented within "other income and gains" or "finance costs", except for expected credit losses ("ECLs") of financial assets which is presented within "impairment loss".

Financial assets at amortised cost

Financial assets are measured at amortised cost if the assets meet the following conditions (and are not designated as FVTPL):

- they are held within a business model whose objective is to hold the financial assets and collect its contractual cash flows; and
- the contractual terms of the financial assets give rise to cash flows that are solely payments of principal and interest on the principal amount outstanding.

After initial recognition, these are measured at amortised cost using the effective interest method. Interest income from these financial assets is included in "other income and gains" in profit or loss. Discounting is omitted where the effect of discounting is immaterial. The Group's bank balances and cash, pledged deposits, trade and other receivables and amounts due from related companies fall into this category of financial instruments.

#### Financial assets at FVTPL

Financial assets that are held within a different business model other than "hold to collect" or "hold to collect and sell' are categorised at FVTPL. Further, irrespective of business model, financial assets whose contractual cash flows are not solely payments of principal and interest are accounted for at FVTPL.

#### Equity investments

An investment in equity securities is classified as FVTPL unless the equity investment is not held for trading purposes and on initial recognition of the investment, the Group elects to designate the investment at FVOCI (non-recycling) such that subsequent changes in fair value are recognised in other comprehensive income and accumulated in "fair value reserve — non-recycling" in equity. Such elections are made on an instrument-by-instrument basis, but only be made if the investment meets the definition of equity from the issuer's perspective.

The equity instruments at FVOCI are not subject to impairment assessment. The cumulative gain or loss in "fair value reserve — non-recycling" will not be reclassified to profit or loss upon disposal of the equity investments, and will be transferred to retained earnings.

Dividends from these investments in equity instruments are recognised in profit or loss when the Group's right to receive the dividends is established, unless the dividends clearly represent a recovery of part of the cost of the investment. Dividends are included in the "other income and gains" in profit or loss.

#### Financial liabilities

Classification and measurement of financial liabilities

The Group's financial liabilities include trade and other payables, amounts due to related companies, amount due to ultimate holding company, other liabilities, interest-bearing bank and other borrowings (included lease liabilities), other long term liabilities and provision for loss on unauthorised guarantees.

Financial liabilities (other than lease liabilities) are initially measured at fair value, and, where applicable, adjusted for transaction costs unless the Group designated a financial liability at FVTPL.

Subsequently, financial liabilities (other than lease liabilities) are measured at amortised cost using the effective interest method except for derivatives and financial liabilities designated at FVTPL, which are carried subsequently at fair value with gains or losses recognised in profit or loss (other than derivative financial instruments that are designated and effective as hedging instruments).

All interest-related charges and, if applicable, changes in an instrument's fair value that are reported in profit or loss are included within "finance costs" or "other income and gains".

#### Financial liabilities (Continued)

Trade and other payables

Trade and other payables are recognised initially at their fair value and subsequently measured at amortised cost, using the effective interest method.

Interest-bearing bank and other borrowings (other than lease liabilities)

Interest-bearing bank and other borrowings (other than lease liabilities) are recognised initially at fair value, net of transaction costs incurred. Interest-bearing bank and other borrowings (other than lease liabilities) are subsequently stated at amortised cost; any difference between the proceeds (net of transaction costs) and the redemption value is recognised in profit or loss over the period of the borrowings using the effective interest method.

Interest-bearing bank and other borrowings (other than lease liabilities) are classified as current liabilities unless the Group has an unconditional right to defer settlement of the liability for at least twelve months after the reporting date.

#### Offsetting financial instruments

Financial assets and liabilities are offset and the net amount reported in the consolidated statement of financial position when there is a legally enforceable right to offset the recognised amounts and there is an intention to settle on a net basis or realise the asset and settle the liability simultaneously. The legally enforceable right must not be contingent on future events and must be enforceable in the normal course of business and in the event of default, insolvency or bankruptcy of the company or the counterparty.

#### 金融負債(續)

#### 貿易及其他應付款項

貿易及其他應付款項初步按其公平值確 認,其後採用實際利率法按攤銷成本計 量。

#### 計息銀行及其他借款(租賃負債除外)

計息銀行及其他借款(租賃負債除外)初步按公平值扣除已產生的交易成本確認。計息銀行及其他借款(租賃負債除外)隨後按攤銷成本列賬;所得款項(扣除交易成本)與贖回價值之間的任何差額使用實際利率法在借款期間於損益中確認。

計息銀行及其他借款(租賃負債除外)分類為流動負債,除非本集團無條件有權將負債的清償延遲至報告日期後至少十二個月。

#### 抵銷金融工具

倘有可合法執行權利以抵銷已確認的款項,且有意償付該款項的淨值,或同時變現資產及償付負債,則可抵銷金融資產及負債,並於綜合財務狀況表內呈列淨值。可合法執行權利不得以未來事件為條件,並且必須在正常業務過程中以及在公司或交易對手違約、資不抵債或破產的情況下可執行。

IFRS 9's impairment requirements use forward-looking information to recognise ECL — the "ECL model". Instruments within the scope included loans and other debt-type financial assets measured at amortised cost and trade receivables.

The Group considers a broader range of information when assessing credit risk and measuring ECL, including past events, current conditions, reasonable and supportable forecasts that affect the expected collectability of the future cash flows of the instrument.

In applying this forward-looking approach, a distinction is made between:

- financial instruments that have not deteriorated significantly in credit quality since initial recognition or that have low credit risk ("Stage 1") and
- financial instruments that have deteriorated significantly in credit quality since initial recognition and whose credit risk is not low ("Stage 2").

"Stage 3" would cover financial assets that have objective evidence of impairment at the reporting date.

"12-month ECL" are recognised for the Stage 1 category while "lifetime ECL" are recognised for the Stage 2 category.

Measurement of the ECL is determined by a probabilityweighted estimate of credit losses over the expected life of the financial instrument.

國際財務報告準則第9號的減值規定採用前瞻性的資料確認預期信貸虧損一「預期信貸虧損模式」。屬於該範疇的工具包括貸款、按攤銷成本計量之其他債務型金融資產以及應收貿易款項。

本集團在評估信貸風險及計量預期信貸 虧損時考慮更廣泛的資料,包括過往事 件、當前狀況、影響工具未來現金流量 預期可收回性的合理且言之有據的預測。

於應用該前瞻性方法時,須對下列各項 作出區別:

- 一 自初步確認以來信貸質素未顯著 惡化或信貸風險較低的金融工具 (「第一階段」)及
- 一 自初步確認以來信貸質素顯著惡 化且信貸風險不低的金融工具 (「**第二階段**」)。

「第三階段」將涵蓋於報告日期具有客觀 減值證據的金融資產。

「12個月預期信貸虧損」於第一階段內確認,而「全期預期信貸虧損」於第二階段內確認。

#### Trade receivables

For trade receivables, the Group applies a simplified approach in calculating ECL and recognises a loss allowance based on lifetime ECL at each reporting date. These are the expected shortfalls in contractual cash flows, considering the potential for default at any point during the life of the financial assets. In calculating the ECL, the Group has established a provision matrix that is based on its historical credit loss experience and external indicators, adjusted for forward-looking factors specific to the debtors and the economic environment.

To measure the ECL, trade receivables have been grouped based on shared credit risk characteristics and the days past due.

#### Other financial assets measured at amortised cost

The Group measures the loss allowance for other receivables equal to 12-month ECL, unless when there has been a significant increase in credit risk since initial recognition, the Group recognises lifetime ECL. The assessment of whether lifetime ECL should be recognised is based on significant increase in the likelihood or risk of default occurring since initial recognition.

In assessing whether the credit risk has increased significantly since initial recognition, the Group compares the risk of a default occurring on the financial assets at the reporting date with the risk of default occurring on the financial assets at the date of initial recognition. In making this assessment, the Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort.

就貿易應收款項而言,本集團採用簡化 方法計算預期信貸虧損,並於各報告日 期基於全期預期信貸虧損確認虧損 備。考慮到金融資產存續期內任何時間 點均可能出現違約事件,這些是合約現 金流量的預期缺口。於計算預期信貸虧 損時,本集團已建立基於其過往信貸虧 損記錄及外部指標的撥備矩陣,並根據 債務人特定前瞻性因素及經濟環境作調 整。

於計量預期信貸虧損時,貿易應收款項 已根據共同信貸風險特徵及逾期天數分 類。

#### 按攤銷成本計量的其他金融資產

本集團按相等於12個月預期信貸虧損計量其他應收款項的虧損撥備,除非自初步確認以來信貸風險大幅增加,則本集團確認全期預期信貸虧損。評估是否應確認全期預期信貸虧損乃基於自初步確認以來發生違約的可能性或風險的大幅增加。

於評估信貸風險是否自初步確認以來已 大幅增加時,本集團比較金融資產於報 告日期出現違約的風險與該金融資產於 初步確認日期出現違約的風險。作此評 估時,本集團會考慮合理及有理據的定 量及定性資料,包括歷史經驗及毋須花 費過度成本或精力即可獲得的前瞻性資 料。

## Other financial assets measured at amortised cost (Continued)

In particular, the following information is taken into account when assessing whether credit risk has increased significantly:

- an actual or expected significant deterioration in the financial instrument's external (if available) or internal credit rating;
- significant deterioration in external market indicators of credit risk, e.g. a significant increase in the credit spread, the credit default swap prices for the debtor;
- existing or forecast adverse changes in regulatory, business, financial, economic conditions, or technological environment that are expected to cause a significant decrease in the debtor's ability to meet its debt obligations; and
- an actual or expected significant deterioration in the operating results of the debtor.

Despite the aforegoing, the Group assumes that the credit risk on a debt instrument has not increased significantly since initial recognition if the debt instrument is determined to have low credit risk at the end of each reporting period. A debt instrument is determined to have low credit risk if it has a low risk of default, the borrower has strong capacity to meet its contractual cash flow obligations in the near term and adverse changes in economic and business conditions in the longer term may, but will not necessarily, reduce the ability of the borrower to fulfill its contractual cash flow obligations.

For internal credit risk management, the Group considers an event of default occurs when information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into account any collateral held by the Group).

Detailed analysis of the ECL assessment of trade receivables and other financial assets measured at amortised cost are set out in note 40.2.

- 監管、業務、財務、經濟條件或 技術環境出現或預期出現不利變 動,可能導致債務人償還能力大 幅下降;及
- 一 債務人經營業績的實際或預期重 大惡化。

儘管如此,倘於各報告期末釐定債務工 具的信貸風險較低,則本集團假設該債 務工具之信貸風險自初步確認以來並無 顯著增加。在下列情況下,一項債務 具被定為具有較低的信貸風險,倘該 務工具違約風險較低、借款人近期具 分償付合約現金流量負債的能力;及長 期而言經濟及業務狀況的不利變動未必 降低借款人償付合約的現金流量負債的 能力。

就內部信貸風險管理而言,本集團認為,違約事件在內部制訂或自外界來源的資料顯示債務人不大可能悉數向債權人(包括本集團)還款(未計及本集團所持任何抵押品)時發生。

#### Financial guarantee contracts

For a financial guarantee contract, the Group is required to make payments only in the event of a default by the debtor in accordance with the terms of the instrument that is guaranteed. Accordingly, the ECL is the present value of the expected payments to the holder for a credit loss that it incurs less any amounts that the Group expects to receive from the holder, the debtor or any other party.

#### 2.9 Inventories

Inventories are carried at the lower of cost and net realisable value. Net realisable value is the estimated selling price in the ordinary course of business less the estimated cost of completion and applicable selling expenses. For condiment products, cost is determined using the weighted average basis, and in the case of work in progress and finished goods, comprise direct materials, direct labour and an appropriate proportion of overheads. It excludes borrowing costs.

#### 2.10 Cash and cash equivalents

Cash and cash equivalents include cash at bank and in hand, demand deposits with banks and short term highly liquid investments with original maturities of three months or less that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value. For the purpose of the consolidated statement of cash flows presentation, cash and cash equivalents include bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

#### 2.11 Contract liabilities

A contract liability is recognised when the customer pays consideration before the Group recognises the related revenue (see note 2.16). A contract liability would also be recognised if the Group has an unconditional right to receive consideration before the Group recognises the related revenue. In such cases, a corresponding receivable would also be recognised (see note 2.8).

#### 財務擔保合約

就財務擔保合約而言,本集團僅於債務 人未能按所擔保工具的條款履約時付 款。因此,預期信貸虧損為向持有人信 貸虧損的預期付款現值減本集團預期從 持有人、債務人或任何其他人士收取的 任何款項。

#### 2.9 存貨

存貨乃按成本值及可變現淨值之較低者 列賬。可變現淨值是在日常業務過程中 的估計售價減估計完成成本及適用的銷 售開支。就調味品而言,成本採用加權 平均法確定,就在製品及成品而言,包 括直接材料、直接勞工及適當比例之間 接成本,惟不包括借款成本。

#### 2.10 現金及現金等價物

現金及現金等價物包括銀行現金及現存 現金、銀行活期存款以及原到期日為三 個月或以內可隨時轉換為已知數額現金 的短期高度流通性投資,有關投資承受 價值變動的風險不大。就綜合現金流量 表呈列而言,現金及現金等價物包括須 按要求償還並構成本集團現金管理組成 部分的銀行透支。

#### 2.11 合約負債

當客戶在本集團確認相關收入前支付代價時確認合約負債(參閱附註2.16)。倘本集團在確認相關收入前擁有收取代價的無條件權利,則亦會確認合約負債。在上述情況下,亦將確認相應應收款項(參閱附註2.8)。

#### 2.12 Financial guarantees issued

A financial guarantee contract is a contract that requires the issuer (or guarantor) to make specified payments to reimburse the holder for a loss it incurs because a specified debtor fails to make payment when due in accordance with the terms of a debt instrument.

Where the Group issues a financial guarantee, the fair value of the guarantee is initially recognised as deferred income within "trade and other payables". The fair value of financial guarantees is determined based on the present value of the difference in cash flows between the contractual payments required under the debt instruments and the payments that would be required without the guarantee, or the estimated amount that would be payable to a third party for assessing the obligations. Where consideration is received or receivable for the issuance of the guarantee, the consideration is recognised in accordance with the Group's policies applicable to that category of asset. Where no such consideration is received or receivable, an immediate expense is recognised in profit or loss on initial recognition of any deferred income.

Subsequently, financial guarantees are measured at the higher of the amount determined in accordance with ECL under IFRS 9 as set out in note 2.8 and the amount initially recognised less, where appropriate, the cumulative amount of income recognised over the guarantee period.

財務擔保合約乃要求發行人(即擔保人) 就持有人因特定債務人未能根據債務工 具的條款於到期時付款而蒙受的損失, 而向持有人支付特定款項的合約。

當本集團發出財務擔保,該擔保的公平值最初確認為「貿易及其他應付款項」內的遞延收入。財務擔保的公平值先務工具要求的合約付款及在並無無機的情況下須作出付款之間的現金流計數額釐定。倘在發行該擔保時收取代價,該代價則根據適用於強致資產的本集團政策而予確認。倘是數學,即時於損益內確認任何遞延收入時,即時於損益內確認用支。

其後,財務擔保按附註2.8所載國際財務報告準則第9號項下預期信貸虧損所 釐定金額及初步確認金額減(如適用)於 擔保期內確認的累計收益金額計量(以 較高者為準)。

#### Definition of a lease and the Group as a lessee

At inception of a contract, the Group considers whether a contract is, or contains a lease. A lease is defined as 'a contract, or part of a contract, that conveys the right to use an identified asset (the underlying asset) for a period of time in exchange for consideration'. To apply this definition, the Group assesses whether the contract meets three key evaluations which are whether:

- the contract contains an identified asset, which is either explicitly identified in the contract or implicitly specified by being identified at the time the asset is made available to the Group:
- the Group has the right to obtain substantially all of the economic benefits from use of the identified asset throughout the period of use, considering its rights within the defined scope of the contract; and
- the Group has the right to direct the use of the identified asset throughout the period of use. The Group assess whether it has the right to direct 'how and for what purpose' the asset is used throughout the period of use.

For contracts that contains a lease component and one or more additional lease or non-lease components, the Group allocates the consideration in the contract to each lease and non-lease component on the basis of their relative stand-alone prices.

Measurement and recognition of leases as a lessee

At lease commencement date, the Group recognises a right-of-use asset and a lease liability on the consolidated statement of financial position. The right-of-use asset is measured at cost, which is made up of the initial measurement of the lease liability, any initial direct costs incurred by the Group, an estimate of any costs to dismantle and remove the underlying asset at the end of the lease, and any lease payments made in advance of the lease commencement date (net of any lease incentives received).

The Group depreciates the right-of-use assets on a straight-line basis from the lease commencement date to the earlier of the end of the useful life of the right-of-use asset or the end of the lease term unless the Group is reasonably certain to obtain ownership at the end of the lease term. The Group also assesses the right-of-use asset for impairment when such indicator exists.

At the commencement date, the Group measures the lease liability at the present value of the lease payments unpaid at that date, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, the Group's incremental borrowing rate.

Lease payments included in the measurement of the lease liability are made up of fixed payments (including in-substance fixed payments) less any lease incentives receivable, variable payments based on an index or rate, and amounts expected to be payable under a residual value guarantee. The lease payments also include the exercise price of a purchase option reasonably certain to be exercised by the Group and payment of penalties for terminating a lease, if the lease term reflects the Group exercising the option to terminate.

於租賃開始日期,本集團於綜合財務狀況表確認使用權資產及租賃負債。使用權資產按成本計量,而成本乃包括租賃負債的初始計量、本集團產生的任何初始直接成本、租賃結束時拆除及移除相關資產的任何估計成本以及於租賃開始日期前作出的任何租賃付款(經扣除任何已收租賃獎勵)。

本集團的使用權資產於租賃開始日期至 使用權資產的可使用年期結束或租期結 束(以較早者為準)期間以直線基準計算 折舊,除非本集團合理地確定於租期結 束時可獲得擁有權則作別論。本集團亦 於出現減值跡象時評估使用權資產的減 值。

於開始日期,本集團按該日未支付租賃 付款的現值計量租賃負債,並使用租賃 中的隱含利率或(倘該利率不可釐定)本 集團的增量借貸利率進行折現。

計量租賃負債時計入的租賃付款包括固定付款(包括實質固定付款)減任何應收租賃獎勵、基於某一指數或比率的可變付款及根據殘值保證應付的預期金額。倘本集團合理地確定將行使購買選擇權,則租賃付款亦包括購買選擇權的行使價,而倘租期反映本集團將行使終止選擇權,則租賃付款亦包括終止租賃的罰金。

Subsequent to initial measurement, the liability will be reduced for lease payments made and increased for interest cost on the lease liability. It is remeasured to reflect any reassessment or lease modification, or if there are changes in in-substance fixed payments. The variable lease payments that do not depend on an index or a rate are recognised as expense in the period on which the event or condition that triggers the payment occurs.

The Group remeasures lease liabilities whenever:

- there are changes in lease term or in the assessment of exercise of a purchase option, in which case the related lease liability is remeasured by discounting the revised lease payments using a revised discount rate at the date of reassessment.
- the lease payments changes due to changes in market rental rates following a market rent review, in which cases the related lease liability is remeasured by discounting the revised lease payments using the initial discount rate.

For lease modification that is not accounted for as a separate lease, the Group remeasures the lease liability based on the lease term of the modified lease by discounting the revised lease payments using a revised discount rate at the effective date of modification. The only exception is any rent concessions which arose as a direct consequence of the COVID-19 pandemic and which satisfied the conditions set out in paragraph 46B of IFRS 16 "Leases".

In such cases, the Group took advantage of the practical expedient set out in paragraph 46A of IFRS 16 and recognised the change in consideration as if it were not a lease modification. When the lease is remeasured, the corresponding adjustment is reflected in the right-of-use asset, or profit and loss if the right-of-use asset is already reduced to zero.

於初始計量後,負債將按已付租賃付款減少,並按租賃負債的利息成本增加。 為反映任何重新評估或租賃修改,或倘 實質固定付款出現變動,負債需要重新 計量。並不取決於某一指數或利率的可 變租賃付款於觸發付款的事件或情況發 生期間確認為開支。

每當出現以下情況時,本集團重新計量 租賃負債:

- 租期有變或對行使購買選擇權的 評估有變,在此情況下,藉在重 新評估日使用經修訂折現率折現 經修訂租賃付款,重新計量相關 租賃負債。

The Group has elected to account for short-term leases using the practical expedients. Instead of recognising a right-of-use asset and lease liability, the payments in relation to these leases are recognised as an expense in profit or loss on a straight-line basis over the lease term. Short-term leases are leases with a lease term of 12 month or less.

Right-of-use assets are presented as a separate line on the consolidated statement of financial position.

Refundable rental deposits paid are accounted for under IFRS 9 and initially measured at fair value. Adjustments to fair value at initial recognition are considered as additional lease payments and included in the cost of right-of-use assets.

#### Sales and leaseback transactions

The Group as a seller-lessee

For a transfer that does not satisfy requirements as a sale in accordance with IFRS 15, the transaction are in substance a financing arrangement under IFRS 9. Therefore, the Group as a seller-lessee accounts for the proceeds received as "other borrowings — secured" within the scope of IFRS 9.

Provisions are recognised when the Group has a present obligation (legal or constructive) as a result of a past event, and it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate of the amount of the obligation can be made. Where the time value of money is material, provisions are stated at the present value of the expenditure expected to settle the obligation.

All provisions are reviewed at each reporting date and adjusted to reflect the current best estimate.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future uncertain events not wholly within the control of the Group, are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

Contingent liabilities assumed in a business combination which are present obligations at the date of acquisition are initially recognised at fair value, provided the fair value can be reliably measured. After the initial recognition at fair value, such contingent liabilities are recognised at the higher of the amount initially recognised, less accumulated amortisation where appropriate, and the amount that would be recognised in a comparable provision as described above. Contingent liabilities assumed in a business combination that cannot be reliably fair valued or were not present obligations at the date of acquisition are disclosed as per above.

Probable inflows of economic benefits to the Group that do not yet meet the recognition criteria of an asset are considered as contingent assets.

#### 2.15 Share capital

Ordinary shares are classified as equity. Share capital is recognised at the amount of consideration of shares issued, after deducting any transaction costs associated with the issuing of shares (net of any related income tax benefit) to the extent they are incremental costs directly attributable to the equity transaction.

#### 2.16 Revenue recognition

Revenue arises mainly from the sales of condiment products.

To determine whether to recognise revenue, the Group follows a 5-step process:

- 1. Identifying the contract with a customer
- 2. Identifying the performance obligations
- 3. Determining the transaction price
- Allocating the transaction price to the performance obligations
- 5. Recognising revenue when/as performance obligation(s) are satisfied

In all cases, the total transaction price for a contract is allocated amongst the various performance obligations based on their relative stand-alone selling prices. The transaction price for a contract excludes any amounts collected on behalf of third parties.

Revenue is recognised either at a point in time or over time, when (or as) the Group satisfies performance obligations by transferring the promised goods or services to its customers.

Where the contract contains a financing component which provides a significant financing benefit to the customer for more than 12 months, revenue is measured at the present value of the amount receivable, discounted using the discount rate that would be reflected in a separate financing transaction with the customer, and interest income is accrued separately under the effective interest method. Where the contract contains a financing component which provides a significant financing benefit to the Group, revenue recognised under that contract includes the interest expense accreted on the contract liability under the effective interest method.

Further details of the Group's revenue and other income recognition policies are as follows:

#### Sale of goods

Revenue from the sale of goods is recognised at the point in time when control of the asset is transferred to the customer, generally on delivery of the products.

Some contracts for the sale of products provide customers with rights of return and volume rebates. The rights of return and volume rebates give rise to variable consideration.

#### (a) Rights of return

For contracts which provide a customer with a right to return the goods within a specified period, the expected value method is used to estimate the goods that will not be returned because this method best predicts the amount of variable consideration to which the Group will be entitled. The requirements in IFRS 15 on constraining estimates of variable consideration are applied in order to determine the amount of variable consideration that can be included in the transaction price. For goods that are expected to be returned, instead of revenue, a refund liability is recognised. A right-of-return asset (and the corresponding adjustment to cost of sales) is also recognised for the right to recover products from a customer.

#### (b) Volume rebates

Retrospective volume rebates may be provided to certain customers once the quantity of products purchased during the period exceeds a threshold specified in the contract. Rebates are offset against amounts payable by the customer. To estimate the variable consideration for the expected future rebates, the most likely amount method is used for contracts with a single-volume threshold and the expected value method for contracts with more than one volume threshold. The selected method that best predicts the amount of variable consideration is primarily driven by the number of volume thresholds contained in the contract. The requirements on constraining estimates of variable consideration are applied and a refund liability for the expected future rebates is recognised.

#### Other income

Interest income is recognised on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial asset.

Grants from the government are recognised at their fair value where there is a reasonable assurance that the grant will be received and the Group will comply with all attached conditions. Government grants are deferred and recognised in profit or loss over the period necessary to match them with the costs that the grants are intended to compensate.

Government grants relating to income is presented in gross under "other income and gains" in the consolidated statement of profit or loss and other comprehensive income.

#### 2.18 Impairment of non-financial assets

The following assets are subject to impairment testing:

- Other intangible assets;
- Property, plant and equipment;
- Right-of-use assets; and
- Interests in subsidiaries in the Company's statement of financial position.

Other intangible assets with indefinite useful life or those not yet available for use are tested for impairment at least annually, irrespective of whether there is any indication that they are impaired. All other assets are tested for impairment whenever there are indications that the asset's carrying amount may not be recoverable.

An impairment loss is recognised as an expense immediately for the amount by which the asset's carrying amount exceeds its recoverable amount. Recoverable amount is the higher of fair value, reflecting market conditions less costs of disposal, and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pretax discount rate that reflects current market assessment of time value of money and the risk specific to the asset.

For the purposes of assessing impairment, where an asset does not generate cash inflows largely independent from those from other assets, the recoverable amount is determined for the smallest group of assets that generate cash inflows independently (i.e. a cash-generating unit). As a result, some assets are tested individually for impairment and some are tested at cash-generating unit level.

Impairment losses recognised for cash-generating units, to which goodwill has been allocated, are credited initially to the carrying amount of goodwill. Any remaining impairment loss is charged pro rata to the other assets in the cash generating unit ("CGU"), except that the carrying value of an asset will not be reduced below its individual fair value less cost of disposal, or value in use, if determinable,

#### 2.19 Employee benefits

#### Pension obligations

The Group has various defined contribution plans in accordance with the local conditions and practices in the municipalities and provinces in which they operate. Defined contribution plans are pension and/or other social benefit plans under which the Group pay fixed contributions into a separate entity (a fund) and will have no legal or constructive obligations to pay further contributions if the fund does not hold sufficient assets to pay all employees benefits relating to employee service in the current and prior periods. The contributions are recognised as labour costs when they are due. Under the defined contribution schemes, forfeited contributions could not be used to reduce the existing level of contributions.

#### Bonus entitlements

The expected cost of bonus payments is recognised as a liability when the Group has a present contractual or constructive obligation as a result of services rendered by employees and a reliable estimate of the obligation can be made. Liabilities for bonus are expected to be settled within twelve months and are measured at the amounts expected to be paid when they are settled.

### Equity-settled share-based compensation transactions

The Group operates a number of equity-settled share-based compensation plans under which the Group receives services from employees as consideration for equity instruments (options) of the Group. The fair value of the services received in exchange for the grant of the equity instruments is recognised as expense.

The total amount to be expensed is determined by reference to the fair value of the equity instruments granted including any market performance conditions; excluding the impact of any service and non-market performance vesting conditions; and including the impact of any non-vesting conditions.

Non-market performance and service conditions are included in assumptions about the number of options and shares that are expected to vest. The total expense is recognised over the vesting period over which all of the specified vesting conditions are to be satisfied.

At the end of each reporting period, the Group revises its estimates of the number of options and shares that are expected to vest based on the non-marketing performance and service conditions. The Group recognises the impact of the revision to original estimates, if any, in the profit or loss, with a corresponding adjustment to equity.

Where the terms of an equity-settled award are modified, as a minimum an expense is recognised as if the terms had not been modified, if the original terms of the award are met. In addition, an expense is recognised for any modification that increases the total fair value of the share-based payments, or is otherwise beneficial to the employee as measured at the date of modification.

Where an equity-settled award is cancelled, it is treated as if it had vested on the date of cancellation, and any expense not yet recognised for the award is recognised immediately. This includes any award where non-vesting conditions within the control of either the Group or the employee are not met. However, if a new award is substituted for the cancelled award, and is designated as a replacement award on the date that it is granted, the cancelled and new awards are treated as if they were a modification of the original award, as described in the previous paragraph.

When the options are exercised, the Company issues new shares. The proceeds received net of any directly attributable transaction costs are credited to share capital (nominal value) and share premium.

### Share-based payment transactions among group entities

The grant by the Company of options over its equity instruments to the employees of subsidiary undertakings in the Group is treated as a capital contribution. The fair value of employee services received, measured by reference to the grant date fair value, is recognised over the vesting period as an increase to investment in subsidiary undertakings, with a corresponding credit to equity (share option reserve) in the separate financial statements of the Company.

#### 2.20 Borrowing costs

Borrowing costs incurred, net of any investment income earned on the temporary investment of the specific borrowings, for the acquisition, construction or production of any qualifying asset are capitalised during the period of time that is required to complete and prepare the asset for its intended use. A qualifying asset is an asset which necessarily takes a substantial period of time to get ready for its intended use or sale. Other borrowing costs are expensed when incurred.

Borrowing costs are capitalised as part of the cost of a qualifying asset when expenditure for the asset is being incurred, borrowing costs are being incurred and activities that are necessary to prepare the asset for its intended use or sale are being undertaken. Capitalisation of borrowing costs ceases when substantially all the activities necessary to prepare the qualifying asset for its intended use or sale are complete.

#### 2.21 Accounting for income taxes

Income tax comprises current tax and deferred tax.

Current income tax assets and/or liabilities comprise those obligations to, or claims from, fiscal authorities relating to the current or prior reporting period, that are unpaid at the reporting date. They are calculated according to the tax rates and tax laws applicable to the fiscal periods to which they relate, based on the taxable profit for the year. All changes to current tax assets or liabilities are recognised as a component of tax expense in profit or loss.

Deferred tax is calculated using the liability method on temporary differences at the reporting date between the carrying amounts of assets and liabilities in the financial statements and their respective tax bases. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are recognised for all deductible temporary differences, tax losses available to be carried forward as well as other unused tax credits, to the extent that it is probable that taxable profit, including existing taxable temporary differences, will be available against which the deductible temporary differences, unused tax losses and unused tax credits can be utilised.

Deferred tax assets and liabilities are not recognised if the temporary difference arises from goodwill or from initial recognition (other than in a business combination) of assets and liabilities in a transaction that affects neither taxable nor accounting profit or loss.

Deferred tax liabilities are recognised for taxable temporary differences arising on investments in subsidiaries and associates, except where the Group is able to control the reversal of the temporary differences and it is probable that the temporary differences will not reverse in the foreseeable future.

Deferred tax is calculated, without discounting, at tax rates that are expected to apply in the period the liability is settled or the asset realised, provided they are enacted or substantively enacted at the reporting date.

Changes in deferred tax assets or liabilities are recognised in profit or loss, or in other comprehensive income or directly in equity if they relate to items that are charged or credited to other comprehensive income or directly in equity.

When different tax rates apply to different levels of taxable income, deferred tax assets and liabilities are measured using the average tax rates that are expected to apply to the taxable income of the periods in which the temporary differences are expected to reverse.

The determination of the average tax rates requires an estimation of (i) when the existing temporary differences will reverse and (ii) the amount of future taxable profit in those years. The estimate of future taxable profit includes:

- income or loss excluding reversals of temporary differences; and
- reversals of existing temporary differences.

Uncertainty about these assumptions and estimates could result in outcomes that could require a material adjustment to the carrying amounts of the assets or liabilities affected in the future.

#### 4.1 Judgements

In the process of applying the Group's accounting policies, management has made the following judgements, apart from those involving estimations, which have the most significant effect on the amounts recognised in the consolidated financial statements:

#### (a) Going concern basis

These consolidated financial statements have been prepared on a going concern basis, the validity of which depends upon the successful outcomes of the Group's plans and measures to strengthen its capital base and liquidity. Details are explained in note 2.2 to the consolidated financial statements.

#### (b) Tax provision

Determining income tax provisions involves judgement on the future tax treatment of certain transactions. The Group carefully evaluates the tax implications of transactions and tax provisions are made accordingly. The tax treatment of such transactions is assessed periodically to take into account all the changes in tax legislation and practices.

#### 4.2 Estimation uncertainty

The key assumptions concerning the future and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are described below.

### (a) Useful lives and residual values of property, plant and equipment

In determining the useful life and residual value of an item of property, plant and equipment, the Group has to consider various factors, such as technical or commercial obsolescence arising from changes or improvements in production, or from a change in the market demand for the product or service output of the asset, expected usage of the asset, expected physical wear and tear, the repair and maintenance of the asset, and legal or similar limits on the use of the asset. The estimation of the useful life of the asset is based on the experience of the Group with similar assets that are used in a similar way. Additional depreciation is made if the estimated useful lives and/or the residual values of items of property, plant and equipment are different from the previous estimation. Useful lives and residual values are reviewed at each financial year end date based on changes in circumstances. The carrying amounts of the property, plant and equipment are disclosed in note 17 to the consolidated financial statements.

### (b) Impairment of property, plant and equipment and right-of-use assets

The Group assesses whether there are any indicators of impairment for property, plant and equipment and rightof-use assets at the end of each reporting period. Property, plant and equipment and right-of-use assets are tested for impairment when there are indicators that the carrying amounts may not be recoverable. An impairment exists when the carrying value of an asset or a CGU exceeds its recoverable amount, which is the higher of its fair value less costs of disposal and its value in use. The calculation of the fair value less costs of disposal is based on the valuation report from an independent qualified professional valuer (the "Valuer") determining appropriate valuation techniques and key inputs for fair value measurements of the Group's property, plant and equipment. When value in use calculations are undertaken, management make assumptions about future revenue, gross profit, operating expense and capital expenditure. These assumptions relate to future events and circumstances and the actual results may vary. Determining the appropriate discount rate involves estimating the appropriate adjustment for market. The carrying amount of the property, plant and equipment and right-of-use assets are set out in notes 17 and 18 to the consolidated financial statements, respectively.

The provision rates are based on days past due for groupings of various customer segments that have similar loss patterns (i.e., by geography, product type and customer type). The provision matrix is initially based on the Group's historical observed default rates. The Group will calibrate the matrix to adjust the historical credit loss experience with forward-looking information. For instance, if forecast economic conditions (i.e., gross domestic product) are expected to deteriorate over the next year which can lead to an increased number of defaults in the manufacturing sector, the historical default rates are adjusted. At each reporting date, the historical observed default rates are updated and changes in the forward-looking estimates are analysed.

The individual assessment is by reference to the credit rating, including the Group's historical credit loss experiences, adjusted for factors that are specific to the debtors.

The assessment of the correlation among historical observed default rates, forecast economic conditions and ECLs is a significant estimate. The amount of ECLs is sensitive to changes in circumstances and forecast economic conditions. The Group's historical credit loss experience and forecast of economic conditions may also not be representative of a customer's actual default in the future. In respect of findings of the Investigation, seven unauthorised guarantees were entered with several financial institutions and creditors as security for several loans granted to the Associates of Mr. Chen Weizhong, as set out in note 30. Due to the failure of repayment by the Associates of Mr. Chen Weizhong, these creditors have commenced legal proceedings against the Associates of Mr. Chen Weizhong as the borrower and the Group as the guarantor. The court hearings against the Group as the guarantor to five creditors have completed and court hearings to two creditors are suspended. The court judgements for the completed court hearings has released the Group's liabilities on these unauthorised guarantees. In 2021, the Group has fully repaid the Company G of RMB10,000,000 on behalf of Zhejiang Zhongwei, accordingly, the Group is no longer liable to this financial guarantee contracts as at 31 December 2021.

It is still uncertain as to how much the borrowers will be able to repay these creditors for the suspended court hearings. Based on the legal advice, the Group had recognised a provision of RMB17,500,000 (2020: RMB27,500,000) which was the best estimate of the Group on the probable cash outflow of the obligations under the financial guarantee contracts of the suspended court hearings for the year ended 31 December 2021. Details are set out in note 30.

#### 7. LOSS ARISING FROM THE INCIDENT

As described in details in the Group's consolidated financial statements for the year ended 31 December 2020, the Company has established an Independent Investigation Committee of the board of directors and the Independent Investigation Committee has engaged FTI Consulting (China) Limited ("FTI Consulting") had undertaken an independent investigation (the "Investigation") on certain issues in relation to the discrepancy of a bank account balance, unauthorised quarantees and outstanding issues of prepayments for fixed assets and tax matters of the Group. A report and a supplemental report on the Investigation had been issued by FTI Consulting on 30 May 2022 and 28 September 2022 respectively and key findings of the Investigation had been published by the Company on 30 May 2022 and 28 September 2022 respectively. Prior year adjustments have been made in the Group's annual consolidated financial statements for the year ended 31 December 2020 in relation to the Incident (as defined in note 2.1 to the Group's consolidated financial statements for the year ended 31 December 2020). The findings of the Investigation and the Management Reassessment (as defined in note 2.1 to the Group's consolidated financial statements for the year ended 31 December 2020) with respect to the Incident led to the recognition of a loss arising from the Incident as a whole of RMB600,575,000 for the year ended 31 December 2020.

As described in details in the Group's consolidated financial statements for the year ended 31 December 2020, Mr. Chen Weizhong entered into guarantee agreements with the above creditors for providing guarantees to these lenders as security for loans granted. The guarantee agreements entered were not approved by the Group's shareholders or directors or disclosed. The lenders also did not register the guarantees with the Credit Reference Center of the People's Bank of China. The directors of the Company considered that these guarantees were illegal and not enforceable.

These lenders have commenced legal proceedings against the Associates of Mr. Chen Weizhong as the borrower and the Group as the guarantor. The court hearings against the Group as the guarantor to five creditors have completed and court hearings to two creditors are suspended. The court judgements for the completed court hearings has released the Group's liabilities on these unauthorised guarantees. The Group has repaid the Company G of RMB10,000,000 on behalf of Zhejiang Zhongwei during the year ended 31 December 2021, accordingly, the Group is no longer liable to this financial guarantee contract as at 31 December 2021.

It is still uncertain as to how much the borrowers will be able to repay these creditors for the suspended court hearings. Based on the legal advice, a provision of RMB17,500,000 (2020: RMB27,500,000) for loss on unauthorised guarantees, which was the best estimate of the Group on the probable cash outflow of the obligations under the financial guarantee contracts, was recognised for the suspended court hearings for the year ended 31 December 2021.

On 6 May 2016, two wholly-owned subsidiaries of the Company, Huzhou Chenshi and Huzhou Laohenghe which is also a wholly-owned subsidiary of Huzhou Chenshi entered into an investment agreement with China Development Fund Co., Ltd. (the "CD Fund") (國開發展基金有限公司) (the "Investment Agreement"). Pursuant to the Investment Agreement, the CD Fund agreed to subscribe for a 3.5% equity interest in Huzhou Laohenghe at a total cash consideration of RMB133,000,000 (the "Capital Investment") and Huzhou Laohenghe shall pay the CD Fund a fixed annual return equal to 1.2% of the Capital Investment from the date of the agreement. In addition, Huzhou Chenshi has a contractual obligation to repurchase the entire equity interest in Huzhou Laohenghe held by the CD Fund within 8 years according to the repayment schedule under the Investment Agreement.

Further details of the Investment Agreement have been disclosed in the announcements of the Company dated 9 May 2016 and 29 June 2016, respectively.

As Huzhou Chenshi does not have the unconditional right to avoid delivering cash to CD Fund pursuant to the Investment Agreement, the Capital Investment of RMB133,000,000 was recorded as a financial liability.

According to the repayment schedule under the Investment Agreement, RMB33,000,000 was payable on 20 September 2022, RMB33,000,000 was reallocated as current portion included in other liabilities as at 31 December 2021. The remaining balance was payable on 20 September 2023 and 2 February 2024 respectively.

#### 40.4 Capital management

The primary objectives of the Group's capital management are to safeguard the Group's ability to continue as a going concern and to maintain healthy capital ratios in order to support its business and maximise shareholders' value. The Group manages its capital structure and makes adjustments to it in light of changes in economic conditions. To maintain or adjust the capital structure, the Group may adjust the dividend payment to shareholders, return capital to shareholders or issue new shares.

The Group monitors capital using a gearing ratio, which is net debt divided by net debt plus total deficit. Net debt includes trade payables, other payables and accruals, other liabilities, amounts due to related companies, amount due to ultimate holding company, interest-bearing bank and other borrowings, provision for loss on unauthorised guarantees and other long term liabilities less cash and cash equivalents. The Group's policy is to keep the gearing ratio at a reasonable level. The gearing ratios as at the end of the reporting periods are as follows:

#### 41. CONTINGENCIES

(a) On 6 December 2019, the Company received a writ of summons by Natural Seasoning International (HK) Limited (the "Plaintiff") against, among others, the Company, Mr. Chen Weizhong and Key Shine as defendants, on the ground that Key Shine and Mr. Chen Weizhong have been in breach of certain agreements in relation to, among others, the operation of the Company and restrictions on disposal of shares in the Company (the "Litigation"). Details of the Litigation were set out in the announcement of the Company dated 16 December 2019.

Subject to receipt of further evidences or details of claim from the Plaintiff; and after having taken into account, amongst other factors, the fact that the Company is not a party to the agreements leading to the Litigation, the Company does not consider that the Litigation will have any material adverse impact on the business and/or operations of the Group and accordingly have not made any provision for any claim arising from the Litigation, other than the related legal and other costs.

(b) There are two court hearings against the Group as the guarantor to two creditors are suspended as disclosed in note 30 and it is still uncertain as to how much the borrowers will be able to repay these creditors for the suspended court hearings. Based on the legal advice, it is expected the court judgements might require the Group to pay to these creditors 50% of the loan amount should the debtors eventually fail to repay these creditors. A provision of RMB17,500,000 (2020: RMB27,500,000) has been recognised in provision for unauthorised guarantee for the year ended 31 December 2021.

## 42. EVENTS AFTER THE REPORTING PERIOD

### (a) Impact of new coronavirus pneumonia epidemic

The outbreak of the COVID-19 since January 2020 in Mainland China have brought disruptions to the Group's operation. The consequential precautionary and control measures released by the local government and authorities have temporarily stunt the logistics activities across the country which has once stagnated the Group's supply chain and delivery.

The Group's production has been resumed. And the extent of epidemic prevention and control measures have been gradually released responding to the request from the local government. However, given the dynamic nature of the circumstances and the uncertainty of the duration of the epidemic and the situation of epidemic preventive measures, the Group will pay close attention to the development of the COVID-19 pandemic and perform further assessment on its impact and take relevant measures.

#### (b) Investigation

As set out in note 7 to the consolidated financial statement, the Company has established the Independent Investigation Committee and engaged FTI Consulting to undertake the Investigation on certain issues. FTI Consulting issued a report and a supplemental report in relation to its findings on the Investigation on 30 May 2022 and 28 September 2022 respectively.

#### (c) Agreements with related parties

In 2022, the Group entered into a trilateral agreement among  $\bar{n} \pm \bar{m}$  and Zhejiang Zhongwei such that part of the amount due to  $\bar{n} \pm \bar{m}$  of approximately RMB19,036,000 included in interest-bearing bank and other borrowings set out in note 29 was settled by the transfer of right of debts of Zhejiang Zhongwei to  $\bar{n} \pm \bar{m}$ .

In 2022, 南太湖, 湖州吳興城市 and 湖盛融資 have confirmed that they do not intend to demand payment from the Group for the amount due to them for a period of fourteen months from the date of approval of these consolidated financial statements.
