- Reference is made to the circular and announcement of CITIC Limited dated 25 May 2023 and 21 June 2023, respectively, with respect to (a) the payment of final dividend of HK\$0.451 per share for the year ended 31 December 2022 and (b) the option given to the shareholders to elect to receive all (but not part) of their dividend in Renminbi (“RMB”) at the exchange of HK\$1.0:RMB0.913738.

If no election form is received by the Company's Share Registrar by the Closing Time, you will receive your 2022 Final Dividend in HONG KONG DOLLARS. The Closing Time will be adjusted, as the case may be, in accordance with (a) or (b) below if a Typhoon Warning Signal No. 8 or above is hoisted, a Black Rainstorm Warning is in force in Hong Kong or “extreme conditions” resulting from a typhoon or a rainstorm are announced by the Government of the Hong Kong Special Administrative Region of the People's Republic of China:  
(a) at any local time before 12:00 noon on Monday, 24 July 2023. In such a case, the Closing Time will be extended to 5:00 p.m. on the same business day; or  
(b) at any local time between 12:00 noon and 4:30 p.m. on Monday, 24 July 2023. In such a case, the Closing Time will be extended to 4:30 p.m. on the next business day which does not have any of the above warnings in force at any time between 9:00 a.m. and 4:30 p.m.
