

# CORPORATE PROFILE

# 企業資料

Chu Kong Petroleum and Natural Gas Steel Pipe Holdings Limited (the "Company", together with its subsidiaries hereinafter referred to as the "Group") is the largest manufacturer and exporter of longitudinal welded steel pipes and is engaged in property development and investment in the People's Republic of China (the "PRC"). The Company has been listed on the Main Board of The Stock Exchange of Hong Kong Limited (the "Stock Exchange") (Stock Code: 1938) since February 2010. The Group's steel pipes are mainly used for energy transmission including oil and gas transmission pipelines, deep sea pipelines, city gas networks, and petrochemicals, mining, infrastructure construction, offshore engineering, steel structures and water utilities industries.

The Group's production bases and offices are located in Panyu, Zhuhai, Lianyungang, Nanjing, Hong Kong, Yunfu and Indonesia, with five production lines for longitudinal submerged arc-welded ("LSAW"), two production lines for spiral submerged arc-welded ("SSAW") and other production lines with a combined annual production capacity of 1,800,000 tonnes as at 31 December 2024.

The Group is an industry pioneer, particularly strong in research and development, holding 114 patents (including 51 invention patents) and 19 international quality certificates and having a long standing international and nationwide track record. Furthermore, the Group is the first and only steel pipe manufacturer in the PRC to manufacture and successfully develop deep sea welded steel pipes for use at a water depth of 3,500m and a qualified supplier of Petrobras and Petronas. The Group is a welded steel pipe manufacturer in the PRC that has received various honours and awards, including "Gold Cup Prize for Actual Quality of Metallurgical Products", "Superior Quality Award for Actual Quality of Metallurgical Products", "National Key New Products", "Provincerecognised Enterprise Technology Centre" and "High and New Technology Enterprise". hosted a "Academician Workstation" and is the main drafter of the national standard for longitudinal welded steel pipes in the PRC.

珠江石油天然氣鋼管控股有限公司(「本公司」, 連同其 附屬公司於下文統稱為(「本集團」))是於中華人民共和 國(「中國」)最大的直縫焊管製造商及出口商並從事物業 開發及投資。本公司由二零一零年二月起於香港聯合交 易所有限公司(「聯交所」)主板上市(股份代號:1938)。 本集團鋼管產品主要用於能源運輸,包括油氣傳輸管 線、深海管道、城市燃氣網絡,以及石化產品、採礦、 基建工程、海洋工程、鋼結構及水務行業。

本集團的生產基地及辦事處位於番禺、珠海、連雲港、 南京、香港、雲浮及印度尼西亞,共設有五條直縫埋弧 焊管(「LSAW」)生產線、兩條螺旋埋弧焊管(「SSAW」) 生產線及其他生產線,於二零二四年十二月三十一日的 年產能合共為1,800,000噸。

本集團為行業先驅,憑藉強大研發實力,擁有一百一十 四項專利(包括五十一項發明專利)及十九項國際質量認 證,以悠久往績享譽海外及全國。另外,本集團是中國 第一家及唯一製造及成功研發用於3,500米水深深海焊 管的焊管製造商。本集團亦為巴西石油及馬油的合資格 供應商。本集團是中國焊管製造商,獲得[中國冶金產 品實物質量金杯獎」、「中國冶金產品實物質量特優質量 獎」、「國家重點新產品」、「省級認定企業技術中心」及 [高新技術企業 | 等各項榮譽,設有[院士工作站],也是 中國直縫焊管國家標準的主要起草單位。

#### Dear Shareholders,

On behalf of the Board of Chu Kong Petroleum and Natural Gas Steel Pipe Holdings Limited (the "Company", together with its subsidiaries, the "Group"), I would like to present to you the audited consolidated annual results of the Group for the year ended 31 December 2024.

# 主席報告書

In 2024, the global and Chinese economic situation was complex and volatile. The ongoing Russia-Ukraine conflict and the tensions in the Middle East have heightened uncertainties in the global energy market. The Group's international trade faces challenges caused by persistent global deflation, continued economic sluggishness in Europe, slowing growth in the US, the persistently strong US dollar, and the weakening RMB. Notwithstanding the above, as China continued to promote the adjustment of its energy structure and pursue the "dual-carbon" goals, the construction of natural gas pipelines has maintained a certain scale, presenting development opportunities for the Group.

二零二四年,全球及中國經濟形勢複雜多變。俄烏衝突持續,中東地區局勢緊張,加劇了全球能源市場的不確定性。全球經濟持續通縮,歐洲經濟持續低迷,美國經濟增長放緩,美元持續走強,人民幣貶值,均為本集團的國際貿易帶來挑戰。儘管如此,中國持續推進能源結構調整和「雙碳」目標,天然氣管道建設仍保持一定規模,為本集團提供了發展機遇。

In the challenging environment, the Group has achieved satisfactory results by virtue of its superior capabilities, leading edge in technology and world-class welded pipe quality, reputation and standing. The Group recorded sales of approximately RMB2,939.9 million (2023: RMB2,651 million), representing an increase of approximately 10.9% over 2023. The Group recorded a profit of approximately RMB212.7 million (2023: RMB183.8 million). Earnings per share attributable to ordinary equity holders was approximately RMB0.21 (2023: RMB0.18). The Board did not recommend the payment of final dividend for the year ended 31 December 2024.

在充滿挑戰的環境下,本集團憑藉超強能力、技術領先優勢及世界一流的焊管質量、聲譽及地位,取得了令人滿意的業績。本集團錄得銷售約人民幣2,939,900,000元,(二零二三年:人民幣2,651,000,000元),較二零二三年增加約10.9%。本集團錄得溢利約為人民幣212,700,000元(二零二三年:人民幣183,800,000元)。普通股權持有人應佔每股盈利約人民幣0.21元(二零二三年:人民幣0.18元)。董事會不建議派發截至二零二四年十二月三十一日止年度之末期股息。

The Group delivered a total of 414,000 tonnes of steel pipes for several important projects during the year and received orders for 272,000 tonnes of steel pipes, further consolidating the Group's leading position in the industry. The steel pipe projects received include: Tieshan Port Natural Gas Branch Pipeline Project of Guangxi Natural Gas Branch Pipeline Network Project, EL-FAYOUM Gas Pipeline Project, Guinea Rio Tinto Simandou Port Project, Iseni Gas Delivery Project, Mexico Spiral Pipe Project, Abu Dhabi Structure Pipe Project and the Shell Offshore Platform Project and other projects.

本集團年內共交付多個重要項目共414,000噸的鋼管,並接獲共272,000噸的鋼管訂單,進一步鞏固了本集團在行業中的領先地位。接獲的鋼管項目包括:廣西天然氣支線管網項目鐵山港天然氣支線管道工程、EL-FAYOUM天然氣管道項目、幾內亞力拓西芒杜港口項目、Iseni天然氣輸送項目、墨西哥螺旋管項目、阿布扎比結構管項目、殼牌海洋平台等。

Among the newly received orders, there is a project for constructing offshore platform structural modules. This project is jointly developed by Shell Australia and its joint venture partner, SGH Energy. The offshore platform structural modules are located at the floating liquefied natural gas (FLNG) facility in the Crux natural gas field off the coast of Western Australia. FLNG is an offshore floating natural gas processing platform that integrates natural gas processing, liquefaction, storage, loading and unloading. It is generally designed in a ship-shaped structure, mainly consisting of upper process modules, hull, riser, turret, and mooring cables, and is used for the production and transportation of liquefied natural gas (LNG). The Group provided approximately 30,000 tonnes of doublesided submerged-arc longitudinal welded pipes with diameters ranging from 700mm to 3,760mm and wall thicknesses from 15mm to 100mm, and was specifically responsible for the procurement of raw materials including the structural modules, as well as the necessary manufacturing processes such as cutting, rolling, edge preparation, longitudinal seam welding, and circumferential seam welding, and transporting the welded pipes to the port.

The Group successfully won the bidding for the Middle East Wharf Project of Daewoo Engineering & Construction Co., Ltd. of South Korea (韓國大宇工程公司 — 中東碼頭工程) with its strong product strength during the year. Once completed, this Middle East Wharf Project will become the largest port in the Middle East, completely reversing the local shortcomings of a short coastline and poor port handling capacity, and adding new impetus to the local economic development. The construction of Phase I project of this port includes infrastructure projects such as breakwaters, channel dredging, five container berths (with a handling capacity of 3.5 million TEUs), and roads. The Phase I project will be completed in 2025 and will be able to accommodate the world's largest container ships. The Group provided spiral steel pipes for submarine piling with a pipe length of 44-52m, a wall thickness of 25mm, and pipe diameters of 1,420mm and 1,220mm respectively for the project, with a total weight of approximately 68,000 tonnes. Spiral steel pipes for submarine piling have higher strength, better toughness, and excellent corrosion resistance. These characteristics make it an ideal support material for marine structures and it is widely used in fields such as offshore oil platforms, offshore wind power generation, cross-sea bridges, port and terminals, and tunnel projects. Meanwhile, taking into account the special nature of the marine environment, the surface of the spiral steel pipes for submarine piling needs to be coated with a high-performance anticorrosion coating to resist the erosion of seawater, salt spray, and other corrosive substances. The products in this project were coated with the external anti-corrosion technology of epoxy glassflake paint (環氧玻璃鱗片漆) to ensure their stability and durability in marine infrastructure projects.

新接訂單當中有建造海洋平台結構模塊項目,是由殼牌澳大利亞公司及其合資夥伴SGH Energy共同開發的,海洋平台結構模塊位於西澳大利亞海岸外的Crux天然氣田浮式液化天然氣 (FLNG)設施,FLNG是集天然氣處理、液化、存儲、裝卸於一體的海上浮式天然氣處理平台,一般設計為船型結構,主要由上部工藝模塊、船體、立管、轉塔和繫泊纜組成,用於生產和運輸液化天然氣(LNG)。本集團提供約30,000噸直徑為700mm-3,760mm,壁厚為15mm-100mm的直縫雙面埋弧焊管,並具體負責包括結構模塊的原材料採購以及必要的切割、軋制、邊緣準備、長縫、環縫等製作工藝,並將焊管運輸至港口。

本集團憑藉過硬的產品實力,年內成功贏得韓國大宇工 程公司 - 中東碼頭工程的競標。此中東碼頭工程項目 建成後將成為中東地區最大港口,徹底扭轉當地海岸線 短、港口吞吐能力差的短板狀況,為當地經濟發展增添 新動能。建設此港口一期工程,包括防波堤、航道浚 深、5個集裝箱泊位(吞吐能力350萬TEU)、公路等基 建工程。一期工程將於二零二五年完工,能靠泊全球最 大的集裝箱船。本集團為項目提供管長為44-52m、壁 厚為25mm、管徑分別為1,420mm、1,220mm的海底打 椿用螺旋鋼管,總重約68.000噸鋼管。海底打椿用螺旋 鋼管具有更高的強度、更好的韌性和優異的抗腐蝕性 能。這些特點使其成為海洋建築物的理想支撑材料,並 廣泛應用於海上石油平台、海上風力發電、跨海橋樑、 港口碼頭、隧道工程等領域。同時,考慮到海洋環境的 特殊性,海底打樁用螺旋鋼管的表面需要塗覆一層高性 能的防腐塗層,以抵抗海水、鹽霧和其他腐蝕性物質的 侵蝕。此次的產品應用了環氧玻璃鱗片漆的外塗防腐技 術,確保其在海洋基礎設施項目中的穩定性和耐久性。

The Group was invited to participate in the TotalEnergies Supplier Day 2024 held at the headquarter of TotalEnergies in Paris, France during the year. It is the third supplier conference held by TotalEnergies, one of the world's top five international oil companies. As one of the leading steel pipe manufacturers in China and one of four suppliers, the Group was invited to share its experience with its outstanding performance in the East African Crude Oil Pipeline (EACOP) project. The Group mainly introduced its experience of successfully supplying 1,500 kilometers of oil pipelines in the EACOP project. The EACOP project in East Africa has a total length of 1,540 kilometers and is currently the world's longest heated crude oil pipeline project. Once completed, the project will connect Uganda and Tanzania, and vigorously promote the rapid development of the economy in East Africa region. The pipeline laying of this project needs to overcome challenges such as complex terrain and high-temperature environments. The Group has taken up this EACOP project with such strict technical requirements from TotalEnergies, and has successfully completed most of the deliveries.

At the end of June 2024, the Shenzhen-Zhongshan Link, an important transportation project connecting Shenzhen and Zhongshan, was officially opened to traffic after seven years of construction. The opening of the Shenzhen-Zhongshan Link indicates that the Group has once again successfully delivered a national key super project after the Pingtan Straits Rail-cum-Road Bridge and the Hong Kong-Zhuhai-Macao Bridge projects. Relying on its superior geographical location and rich experience in participating in many national major projects, the Group successfully became an important supplier for this major project and provided high-quality pipes for the Shenzhen-Zhongshan Link. Since 2018, the Group has continuously participated in several important engineering bidding sections of the Shenzhen-Zhongshan Link, such as the construction of the East Artificial Island and the main line cofferdam section tunnel (Lot S03) and the main project of the cross-river channel (Lot S09), providing a solid guarantee for the successful opening of the Shenzhen-Zhongshan Link. 90% of the steel pipes for the pile foundation used in the Shenzhen-Zhongshan Link come from the Group. The steel pipes for the pile foundation are highly resistant to sea corrosion, which increases the service life of the bridge by 30% and solves the problem of easy fracturing of concrete piles. The smooth opening of the Shenzhen-Zhongshan Link symbolises a further acceleration of the integration process of the Guangdong — Hong Kong — Macao Greater Bay Area and is another important milestone in the Group's development history.

本集團年內受邀參加在法國巴黎道達爾能源公司總部舉辦的道達爾能源二零二四年度供應商大會(TotalEnergies Supplier Day 2024)。這是道達爾能源(TotalEnergies)舉辦的第三屆供應商大會,道達爾能源(TotalEnergies)為全球五大國際石油公司之一,本集團作為中國領先的鋼管製造企業之一及四家供應商之一,憑藉在東非原油管道項目(EACOP)中的卓越表現,受邀於台上分享經驗,重點介紹了本集團在EACOP項目中成功供應1,500公里輸油管道的經歷。東非EACOP項目全長1,540公里,是目前世界上最長的加熱原油管道項目。項目建成後將連接烏幹達和坦桑尼亞並大力推動非洲東部區域經濟的迅速發展。該項目管道鋪設需要克服複雜地形和高溫環境等挑戰。本集團已承接道達爾東非原油管道公司技術要求如此嚴苛的項目,並順利完成大部分交付工作。

In January 2024, the Group was awarded the Specialized and New Annual Masterpiece ("年度絕活") case award by China Media Group at the Innovation Leads The New Industrialization 2023 Specialized and New • Manufacturing Power Annual Ceremony ("創新引領新型工 業化2023專精特新·製造強國年度盛典"), and outperformed among the 12,000 Specialized and New Little Giant enterprises across the country, showcasing the characteristics, highlights and achievements of the development of specialized and new enterprises in China. On the way of developing the enterprise's characteristic products, the Group attaches great importance to the deep sea development strategy of oil and gas resources, and has continued to develop deep sea and ultra-deep sea oil and gas pipeline steel pipes for a long time: in 2012, PCKX65 LSAW steel pipe was applied to the Liwan deepwater natural gas project in the South China Sea of CNOOC, which enabled the Group to enter into the advanced ranks of deep sea pipe manufacturing, and the engineering application record was extended to a depth of 1,500 meters underwater. From 2019 to 2022, focusing on the international engineering of deep sea and ultra-deep sea oil and gas pipelines and the development of deep sea resources, the Group successfully developed underwater oil and gas, clean energy and resources pipeline transmission pipe up to 3,500 meters deep water for the first time in the world, forming a set of steel pipe manufacturing technology for 1,500-3,500 meters ultra-deep sea pipeline in the world. The commendation from China Media Group for the Group is a recognition of the Group's past efforts and the beginning of a new journey.

本集團於二零二四年一月獲中央廣播電視總台在「創新 引領新型工業化二零二三專精特新•製造強國年度盛典」 榮獲專精特新「年度絕活」案例的嘉獎,在全國1.2萬家 專精特新小巨人企業中脱穎而出,展現中國專精特新企 業發展的特色、亮點和成就。本集團在發展企業特色產 品的道路上,看重油氣資源深海發展戰略,長時間持續 開發深海及超深海油氣管線鋼管:二零一二年,PCKX65 直縫埋弧焊接鋼管,應用於中海油南海荔灣深水天然氣 項目,使本集團進入了深海管材製造先進行列,工程應 用記錄拓展到海底1.500米深度。二零一九年~二零二二 年,本集團圍繞深海及超深海油氣管線國際工程及深海 資源開發,在全球內首次成功開發了最深可達3,500米 的水底油氣、清潔能源及資源管道輸送鋼管,形成一套 全球首創1,500-3,500米超深海管線用鋼管製造技術。 此次中央廣播電視總台對本集團的嘉獎,是對本集團過 往努力的肯定,也是一個新里程的開始。

2024 is the 30th anniversary of the establishment of the Group. In March 2025, the Group was honoured to be interviewed by Guangzhou Daily, with the headline Guangzhou-made "Steel Pipe Dragon" Bravely Enter 3,500-metre Deep Sea-Guangdong Enterprises Develop World's Deepest Submarine Oil and Gas Transmission Pipeline Steel Pipe, which was a special report for the National Two Sessions. The report pointed out how the Group has broken the technological monopoly of Europe and the United States in the past 30 years with a three-step process to produce the world's first 3,500-metre ultra-deep submarine oil and gas transmission pipeline steel pipe, which can be sunk to the seabed at a depth of 3,500 metres, and is resistant to low temperature, high pressure and strong corrosion. The Group has adhered to the glorious history of expanding and strengthening the main business of steel pipes, continuing to cultivate deeply in the field of welded pipes, and making unremitting efforts over the 30 years. Looking forward to the future, all staff of the Group will continue to carry forward the spirit of indomitable, exploit enterprising, make continuous breakthroughs in technological innovation, and strive for excellence in product quality and set benchmarks, forge ahead in the market competitiveness and bravely scale new heights. The bold spirit of creating one new product after another to replace imports contributes more strength to the prosperity and development of the steel pipe industry. The Group will follow the national strategy, adhere to independent innovation, focus on marine engineering, and use the "steel backbone" to support China's dream of becoming a maritime power.

二零二四年,本集團成立三十週年。本集團於二零二五 年三月承蒙獲廣州日報專訪,標題為廣州造[鋼管蛟龍] 勇闖3.500米深海 一 廣東企業研製出全球最深海底油 氣輸送管道鋼管,此屬全國兩會特別專訪報導。報導指 出,本集團如何在過去30年以三部曲打破歐美技術壟 斷,製造全球首條3,500米超深海底油氣輸送管道鋼管, 可下沉海底,深度為3,500米,具有不懼低溫、高壓、強 腐蝕的特性。本集團創業三十年以來,堅持做大做強鋼 管主業,在焊管領域持續深耕,不懈努力奮鬥的光輝歷 程,展望未來本集團所有員工繼續發揚百折不撓、開拓 進取的精神,在技術創新上不斷突破,追求卓越;在產 品質量上精益求精,樹立標桿;在市場競爭力上鋭意進 取,勇攀高峰。創出一個又一個新產品替代進口的豪邁 氣魄,為鋼管行業的繁榮發展貢獻更多力量。本集團將 跟隨國家戰略,堅持自主創新,聚焦海洋工程,用「鋼 鐵脊樑」, 托起中國海洋強國夢。

#### **PROSPECT**

In 2025, the road to global economic recovery will remain uncertain. The evolution of Sino-US relations, the strong position of U.S. dollars, the depreciation pressure of Renminbi, the pace of economic recovery in Europe, the direction of the Russia-Ukraine conflict, and the situation in the Middle East will have a profound impact on the global energy market.

#### 管理層討論與分析

#### **BUSINESS REVIEW**

The Group mainly (i) manufactures and sells longitudinal welded steel pipes, as well as provides manufacturing service for processing raw materials into steel pipes; and (ii) engages in property development and investment.

#### Steel pipe business

Our welded steel pipe products can be broadly categorised into LSAW steel pipes, SSAW steel pipes and ERW steel pipes. We are the largest LSAW steel pipe manufacturer and exporter in the PRC, and are capable of producing LSAW steel pipes that meet the X100 standard. We are also accredited with 14 international quality certifications such as Det Norske Veritas and American Petroleum Institute. In addition, we are the first and the only PRC manufacturer that has successfully produced and developed deep sea welded pipes for use at 3,500m under water. Our products are widely used in major oil and gas pipeline projects (both onshore and offshore) and infrastructure projects domestically and internationally.

Our Group is capable of manufacturing subsea pipes and drilling platforms structure pipes for offshore projects and is being classified as a member of the Offshore Engineering Equipment Industry\* (海洋工程裝備製造業).

#### **Order Status**

In 2024, the Group received new orders of approximately 272,000 tonnes of welded steel pipes. The Group delivered approximately 414,000 tonnes of welded steel pipes during 2024. The Group has delivered some sizeable overseas orders, such as orders from steel pipes for the East African Crude Oil Pipeline project, Nigeria Iseni Gas Delivery Project, and Mcdermott Asia Pacific Sdn Bhd.

#### 業務回顧

本集團主要(i)製造及銷售直縫焊接鋼管,以及提供將原材料加工為鋼管的製造服務:及(ii)從事物業開發與投資。

#### 鋼管業務

本集團的焊接鋼管產品大致可分為直縫埋弧焊管、螺旋埋弧焊管及電阻焊管。我們是中國最大直縫埋弧焊管製造商及出口商,可生產符合X100標準的直縫埋弧焊管,而我們已取得挪威船級社及美國石油協會等十四項國際質量認證。此外,我們為中國首名和唯一能成功生產及研發出3,500米深海焊管的製造商。我們的產品在國內外被廣泛用於大型石油及天然氣管道項目(岸上和海上)及基建項目。

由於本集團可製造海上工程使用的海底管及海上鑽井平台結構管,故此本集團被劃入海洋工程裝備製造業企業之一。

#### 訂單狀況

於二零二四年,本集團接獲的新訂單數量約為272,000 噸焊接鋼管。本集團已於二零二四年交付約414,000噸焊接鋼管。本集團已接獲若干大型海外訂單,如東非原油管道項目、尼日利亞Iseni天然氣輸送項目及Modermott Asia Pacific Sdn Bhd等鋼管訂單。

#### 管理層討論與分析

#### **LSAW Steel Pipes**

The Group is one of the largest LSAW steel pipe manufacturers and exporters in the PRC. Sales and manufacturing of LSAW steel pipe was the major source of revenue of the Group and accounted for approximately 80.5% of our total steel pipe revenue for the year ended 31 December 2024. For the year ended 31 December 2024, revenue from the sales and manufacturing service of LSAW steel pipes amounted to approximately RMB2,195.4 million and RMB46.9 million, respectively, where sales of LSAW steel pipes were higher than that for the year ended 31 December 2023 was due to increase in delivery of LSAW steel pipes to East African Crude Oil Pipeline ("EACOP").

#### **SSAW Steel Pipes**

Our SSAW steel pipes are produced in our plant in Lianyungang using the pre-welding and precision welding SSAW technique, which is the most advanced technique among all SSAW technologies. Revenue from the sales and manufacturing service of SSAW steel pipes amounted to approximately RMB366.9 million and RMB62.8 million respectively. The total revenue from SSAW steel pipes accounted for approximately 15.4% of the total steel pipe revenue for the year ended 31 December 2024 which were lower than that for the year ended 31 December 2023. The decrease was mainly attributable to less delivery of SSAW Steel Pipes to infrastructure projects.

#### Property development

Apart from the steel pipe manufacturing business, the Group also engaged in property development and investment. Following the conversion of a land in Panyu, PRC in 2013, the Group grasped the opportunity of asset appreciation to convert the land use right of the Panyu production plant from industrial use to commercial use. The property project in relation to Golden Dragon City Fortune Plaza (金龍城財富廣場) ("GDC"), is a large scale integrated commercial complex of offices, shops, apartments and villas. The land area of the converted land accounted for approximately 25% of the total land area of our factory in Panyu. The total permitted construction area of the land (including underground construction area) is approximately 550,000 m².

本集團是中國最大的直縫埋弧焊管製造商及出口商之一。直縫埋弧焊管銷售及製造服務為本集團主要收入來源,截至二零二四年十二月三十一日止年度佔本集團總鋼管收入約80.5%。截至二零二四年十二月三十一日止年度,直縫埋弧焊管的銷售及製造服務收入分別約為人民幣2,195,400,000元及人民幣46,900,000元,當中直縫埋弧焊管的銷售較截至二零二三年十二月三十一日止年度增加,由於向東非原油管道(「東非原油管道」)交付的直縫埋弧焊管數量增加。

#### 螺旋埋弧焊管

我們於連雲港廠房生產的螺旋埋弧焊管採用預精焊螺旋埋弧焊管技術製造,該項技術屬所有螺旋埋弧焊管工藝中最先進的工藝。螺旋埋弧焊管的銷售及製造服務分別錄得收入約人民幣366,900,000元及人民幣62,800,000元。螺旋埋弧焊管的總收入佔截至二零二四年十二月三十一日止年度總鋼管收入約15.4%,較截至二零二三年十二月三十一日止年度大幅減少。該減少主要由於向基建項目交付的螺旋埋弧焊管減少所致。

#### 物業開發

除鋼管製造業務外,本集團亦從事物業開發與投資。於二零一三年中國番禺土地改變用途後,本集團適時利用資產增值機會,將番禺生產廠房的土地用途由工業轉為商業用途。有關金龍城財富廣場(「金龍城」)的物業項目為集寫字樓、商舖、公寓及別墅為一體的大型綜合商業體。已改土地佔番禺廠區土地的總面積約四分之一。該土地的總許可建築面積(包括地下建築面積)約為550,000平方米。

#### **FINANCIAL REVIEW**

#### Revenue and gross profit

Revenue of the Group mainly comprises (i) sales of steel pipe, and (ii) sales of property.

Our revenue increased from RMB2,651 million for the year ended 31 December 2023 to approximately RMB2,939 million in 2024. Such increase was mainly due to increase in overseas sales of steel pipes in 2024. The Group has delivered a sizable order of the East African Crude Oil Pipeline project during the year. Increase in steel pipes sales in 2024 as compared to that of 2023 was due to the increase in demand from overseas market.

The revenue generated from the sales of steel pipes accounted for approximately 92.0% of our total steel pipe revenue in 2024 as compared with approximately 89.2% in 2023. Steel pipe manufacturing services accounted for approximately 4.0% of our total steel pipe revenue in 2024 as compared with approximately 7.6% in 2023. The revenue classified as "Others" mainly represented the trading of steel plates, sales of steel fittings and sales of scrap materials which accounted for approximately 4.0% of our total steel pipe revenue in 2024 as compared with approximately 3.2% in 2023.

Gross profit of steel pipe sales for 2024 was approximately RMB494.6 million as compared with approximately RMB513.4 million in 2023, representing an decrease of approximately 3.7% or RMB18.9 million. Gross profit margin for 2024 was approximately 17.7% which was lower than that of 21.5% in 2023. Decrease in gross profit margin was due to relatively lower gross profit margin of one significant overseas project which dragged down the average gross profit margin.

Overseas Sales for 2024 was approximately RMB2,218.7 million as compared with approximately RMB1,370.5 million in 2023, representing an increase of approximately 61.9%. Our overseas sales accounted for approximately 79.6% of our total steel pipe revenue in 2024, as compared with approximately 57.3% in 2023.

Revenue generated from the property development and investment segment mainly comprises sales of property of GDC-Phase II and rental income from shops in Phase I of GDC. Revenue under property development and investment was approximately RMB152.3 million in 2024 as compared with approximately RMB260.0 million in 2023, representing a decrease of approximately 41.4% or RMB107.7 million. Decrease in revenue was due to most of sales of Phase II recognized in 2022 and 2023. Most of the units under Phase I of GDC were sold in 2018 and 2019.

Cost of sales primarily represents the costs we incurred directly for the Group's property development activities. The principal component of cost of sales is cost of properties sold, which includes the direct costs of construction and the costs of obtaining land use rights. Cost of sales was approximately RMB129.5 million in 2024 as compared with approximately RMB219.2 million in 2023, representing a decrease of 40.9% or RMB89.7 million. Decrease in cost of sales was due to less properties sold out so as the allocation of cost of Phase II of GDC.

Gross profit of property sales was approximately RMB22.8 million in 2024 as compared with approximately RMB40.8 million in 2023, representing a decrease of 44.0% or RMB17.9 million. Decrease in

All revenue under property development and investment was domestic in nature.

gross profit was due to decrease in sales of Phase II of GDC.

# CHANGE IN FAIR VALUES OF INVESTMENT PROPERTIES

The Group has adopted the accounting policy of measuring investment properties by using fair values. Accordingly, gains or losses arising from the changes in the fair values of investment properties are reflected as profit or loss for 2024. The investment properties as at 31 December 2024 were the shops of Phase I of GDC. The Group has engaged RHL Appraisal Limited, an independent valuer, to value the investment properties as at 31 December 2024. According to the valuation report as at 31 December 2024 issued by RHL Appraisal Limited, the market value of the investment properties as at 31 December 2024 was RMB355 million. Loss in fair values of the investment properties in 2024 was approximately RMB5 million (2023: loss of RMB2 million).

#### OTHER INCOME AND GAINS

Other income and gains in 2024 mainly represented bank interest income and subsidy income from government. Other income and gains increased by approximately 1,138.3% or RMB181.9 million from approximately RMB16.0 million in 2023 to approximately RMB197.9 million in 2024. Increase in other income and gains was mainly due to the increase in reversal of provision of interest expense and subsidy income from government.

#### 投資物業公平值變動

本集團已採納會計政策,以公平值計量投資物業。因此,投資物業公平值變動產生之盈虧,已於二零二四年 反映為損益。於二零二四年十二月三十一日的投資物業 為金龍城第一期的商舖。本集團已委聘獨立估值師永利 行評值顧問有限公司,為於二零二四年十二月三十一日 的投資物業進行估值。根據永利行評值顧問有限公司於 二零二四年十二月三十一日出具的估值報告,投資物業 於二零二四年十二月三十一日的市值為人民幣 355,000,000元。於二零二四年,投資物業的公平值虧 損約為人民幣5,000,000元(二零二三年:虧損人民幣 2,000,000元)。

#### 其他收入及收益

二零二四年的其他收入及收益主要指銀行利息收入及政府補貼收入。其他收入及收益由二零二三年約人民幣16,000,000元,增加約1,138.3%或人民幣181,900,000元至二零二四年約人民幣197,900,000元。其他收入及收益增加主要由於利息費用撥回撥備及政府補貼收入增加。

#### **SELLING AND DISTRIBUTION EXPENSES**

Selling and distribution expenses decreased by approximately 37.6% or RMB24.6 million from approximately RMB65.5 million in 2023 to approximately RMB40.9 million in 2024. Decrease in selling and distribution expenses was mainly due to decrease in sales commission.

#### **ADMINISTRATIVE EXPENSES**

Administrative expenses increased by approximately 5.3% or RMB14.3 million from approximately RMB270.0 million in 2023 to approximately RMB284.4 million in 2024. The increase in administrative expenses was mainly due to increase in research and development expenses.

#### **FINANCE COSTS**

The finance costs for 2024 was approximately RMB110.2 million as compared with that of 2023 of approximately RMB94.5 million, representing an increase of RMB15.7 million or 16.6%. The effective interest rate in 2024 was approximately 5.9% (2023: 5.2%). Increase in finance costs was due to the increase in interest rate and increase in borrowing.

#### **OTHER EXPENSES**

Other expenses decreased by approximately 34.1% or RMB64.0 million from approximately RMB187.9 million in 2023 to approximately RMB123.9 million in 2024. The decrease was mainly due to decrease in write off and impairment of other receivable.

#### **EXCHANGE GAIN, NET**

The Group recorded exchange gain of approximately RMB15.6 million in 2024 as compared with exchange gain of approximately RMB15.1 million in 2023. The exchange gain was mainly due to appreciation of USD against RMB in collection of USD trade receivables.

#### **INCOME TAX CREDIT**

The Group recorded income tax credit of RMB46.2 million in 2024 as compared with income tax credit of RMB144.7 million in 2023.

#### 銷售及分銷開支

銷售及分銷開支由二零二三年約人民幣65,500,000元,減少約37.6%或人民幣24,600,000元,至二零二四年約人民幣40,900,000元。銷售及分銷開支減少主要由於銷售佣金減少。

#### 其他費用

其他費用由二零二三年約人民幣187,900,000元,減少約34.1%或人民幣64,000,000元,至二零二四年約人民幣123,900,000元。該減少主要由於其他應收款項撇銷及減值減少所致。

#### 匯兑收益淨額

#### PROFIT FOR THE YEAR

As a result of the reasons discussed above, the Group recorded a profit of approximately RMB212.7 million in 2024 (2023: profit of RMB183.8 million).

#### **NET CASH FLOWS FROM OPERATING ACTIVITIES**

The Group's net cash inflows from operating activities of approximately RMB431.1 million in 2023 decreased to approximately RMB205.9 million in 2024. The decrease in net cash inflows from operating activities were primarily due to the combined effect of (i) increase in profit before tax; (ii) increase in inventories, trade and bills receivables, pledged and restricted bank balances, trade and bills payables and other payables and accruals; and (iii) decrease in completed properties held for sale, prepayments, other receivables and other assets, and contract liabilities.

# NET CASH FLOWS USED IN INVESTING ACTIVITIES

The Group's net cash flows used in investing activities changed from outflow of approximately RMB8.7 million in 2023 to outflow of approximately RMB55.8 million in 2024. The increase in outflow were mainly due to the combined effects of (i) purchase of items of property, plant and equipment in 2024; and (ii) receipt of government grants.

# NET CASH FLOWS USED IN FINANCING ACTIVITIES

The Group's net cash flows used in financing activities decreased from approximately RMB366.0 million in 2023 to approximately RMB78.5 million in 2024. The decrease was mainly resulted from the combined effect of (i) the new interest- bearing loans and other borrowings of approximately RMB798.2 million; and (ii) decrease in an amount due to a director, the repayment of bank loans, other borrowings, bonds and principal portion of payment of lease and payment of interest of approximately RMB876.7 million.

#### **EXCHANGE RISK EXPOSURE**

The Group mainly operates in the PRC and most of its operating transactions are settled in Renminbi except for export sales and overseas borrowings which are mostly denominated in US dollar and HK dollar. Most of the Group's assets and liabilities are denominated in Renminbi. Although the Group may be exposed to foreign currency exchange risks, the Board does not expect that future currency fluctuations would materially impact the Group's operations. The Group did not adopt formal hedging policies nor instruments of foreign currency for managing the exchange risk exposure during the year ended 31 December 2024.

#### **CAPITAL EXPENDITURE**

For the year ended 31 December 2024, the Group invested approximately RMB62.3 million for the upgrading of property, plant and equipment. These capital expenditures were fully financed by internal resources.

#### FINANCIAL GUARANTEE

As at 31 December 2024, the Group guaranteed RMB17.9 million (2023: RMB27.4 million) to certain purchasers of the Group's properties for mortgage facilities.

#### PLEDGE OF ASSETS

The Group pledged the following assets with an aggregate net book value to secure bank loans granted to the Group as at 31 December 2024:

- (i) certain property, plant and equipment of approximately RMB662.3 million (2023: RMB696.4 million);
- (ii) certain leasehold land of approximately RMB464.7 million (2023: RMB481.6 million); and
- (iii) completed properties held for sale of approximately RMB1,001.2 million (2023: RMB1,003.0 million).

# CAPITAL STRUCTURE, LIQUIDITY AND FINANCIAL RESOURCES

The Group's gearing ratio is calculated based on the sum of bank loans, other borrowings and fixed rate bonds and notes divided by total assets. The gearing ratio of the Group as at 31 December 2024 and 2023 were approximately 28.7% and 28.5%, respectively. There was no major change in gearing ratio in 2024 as compared with that of 2023.

On 27 April 2020, the Company entered into a subscription agreement with an investment fund, pursuant to which the Company agreed to issue, and the investment fund agreed to subscribe for HK\$140,000,000 12% bonds due in April 2022 (the "Bonds"). The Company and the noteholder mutually agreed to extend the maturity date to 20 January 2025. Mr. Chen Chang, an executive Director and the controlling shareholder of the Company, undertakes and covenants that for so long as any of the Bonds remain outstanding, he shall remain as (i) the single largest direct or indirect shareholder of the Company; and (ii) the chairman of the Board and executive Director (the "Specific Performance Obligations"). Any breach of the Specific Performance Obligations may constitute an event of default under the Bonds and the bondholder is entitled to redeem the Bonds immediately upon the occurrence of the breach in accordance with the terms and conditions of the Bonds. Subsequent to 31 December 2024 and up to the date of this report, the Company has fully settled the Bonds.

As at 31 December 2024, the Group's total borrowings amounted to approximately RMB1,865 million, of which approximately 45% (2023: 8%) were long term borrowings and approximately 55% (2023: 92%) were short term borrowings. The total borrowings included, (i) a loan of RMB736 million in relation to the Group's property development business; and (ii) net borrowings under steel pipe business of around RMB1,129 million. The Group had to finance its working capital of steel pipe business by short term borrowings as around 90% of the cost of sales was incurred on the procurement of steel plates and steel coils. Once the Group received sales proceeds from its customers, it would then repay the short term borrowings. Taking into account the Group's cash in hand, the Group has sufficient liquidity and is in a strong financial position to repay its short term borrowings.

As at 31 December 2024, (i) approximately 81% (2023: 80%) of the total borrowings were denominated in Renminbi which carried interest rates linked to the benchmark lending rate published by the People's Bank of China; (ii) approximately 14% (2023: 16%) of the total borrowings were denominated in Renminbi which carried fixed interest rate; and (iii) approximately 5% (2023: 4%) of the total borrowings were denominated in US dollar and HK dollar which carried fixed interest rate.

#### **EMPLOYEE AND REMUNERATION POLICY**

For the year ended 31 December 2024, staff costs (including Directors' remuneration in the form of salaries) were approximately RMB123.5 million (2023: RMB151.4 million).

The Group remunerates its employees based on their performance, experience and prevailing industry practice. The emoluments of the Directors are recommended by the Remuneration Committee and are decided by the Board, having regard to the Group's operating results, individual performance and comparable market statistics. Competitive remuneration package is offered to retain elite employees. Our package includes salaries, medical insurance, discretionary bonuses, on-job training, other benefits as well as mandatory provident funds schemes for employees in Hong Kong and state-managed retirement benefit schemes for employees in the PRC. Pursuant to the Company's share option scheme, options to subscribe for shares in the Company may be granted to eligible employees. No share option was granted under the share option scheme during the year ended 31 December 2024.

As at 31 December 2024, the Group had a total of 858 full time employees (2023: 875 employees). The following sets forth the total number of our staff by functions:

#### **PROSPECT**

#### **Prospect**

Tension in the Middle East and climate change have exacerbated uncertainty in the global energy market amidst the ongoing Russia-Ukraine conflict. The continued downward trend in global inflation, the continued sluggishness of the European economy, the slowdown in the economic growth of the United States, the appreciation of the US dollar and the depreciation of the Renminbi have posed challenges to the Group's international trade. The Group expects that the year 2025 will remain a challenging year for the oil and natural gas industry. In the medium and long term, it is expected that the oil and natural gas industry will continue to develop due to the combined effects of the insufficient oil and natural gas pipeline facilities, and China's emphasis on energy security and the promotion of clean energy.

For a long time, oil and natural gas have always been the overriding primary energy in the global energy consumption structure, and China is no exception. In recent years, the output of crude oil and natural gas has continued to increase, especially for clean energy such as natural gas, which has experienced long-term rapid growth in output. Oil and gas pipeline construction industry is an important part of the development of China's energy industry, as well as an important support for national energy security and economic development. With the rapid development of China's economy, the oil and gas pipeline industry has developed rapidly, and the market size has been expanding. In August 2024, the State Council Information Office of the PRC issued the white paper on China's Energy Transition. The white paper pointed out that in order to enhance the optimal allocation of resources, China has accelerated the construction of energy network infrastructure spanning east to west, north to south, and covering the whole country, enhancing the ability of energy transmission over a wide range of long distances. The interconnection of energy pipelines and networks has been strengthened, and the national network of oil, gas and electricity is becoming more and more dense, with the resilience of the energy system being continuously improved.

#### 展望

#### 未來展望

面對俄烏衝突持續,中東地區局勢緊張,和與氣候變化,加劇了全球能源市場的不確定性。全球通脹持續下行,歐洲經濟持續低迷,美國經濟增長放緩,美元持續走強,人民幣貶值,為本集團的國際貿易帶來挑戰。本集團預計二零二五年對石油及天然氣行業而言仍將是充滿挑戰的一年,從中長期來看,石油及天然氣管道的建設不足、中國對能源安全的重視和推動清潔能源等有望繼續對石油及天然氣行業構成支撐。

長期以來,石油及天然氣一直是全球能源消費結構中最主要的一次能源,在中國也不例外,近年來原油以及天然氣的產量也在持續提升,尤其是清潔能源,如天然氣產量長期快速增長。油氣管道工程建設行業是中國能源行業發展的重要組成部分,也是國家能源安全和經濟發展的重要支撐。隨著中國經濟的快速發展,油氣管道行業發展迅速,市場規模不斷擴大。二零二四年八月中國國務院新聞辦公室發佈《中國的能源轉型》白皮書。白皮書指出,為加強資源優化配置,中國加快建設橫跨東西、縱貫南北、覆蓋全國的能源網路基礎設施,提升能源大範圍遠距離輸送能力。加強能源管網互聯互通,油氣電全國網路正越織越密,能源系統的韌性不斷增強。

At the beginning of 2022, the National Development and Reform Commission and the National Energy Administration issued the "14th Five-Year Plan Modern Energy System Plan", which put forward the goal that by 2025, the scale of domestic oil and gas pipeline network would reach approximately 210,000 kilometers. As of the end of 2023, the total mileage of long-distance oil and gas pipelines in China reached approximately 190,000 kilometers, including 33,000 kilometers of crude oil pipelines, 33,000 kilometers of refined oil pipelines and 124,000 kilometers of natural gas pipelines. According to the demand forecast under the "dual carbon" goal, it is expected that China will add a total of approximately 65,000 kilometers of natural gas pipeline construction by 2035, including 29,500 kilometers of new trunk pipelines and 35,300 kilometers of provincial pipelines, approximately 2,000 kilometers of new crude oil pipelines and 4,000 kilometers of refined oil product pipelines. The "14th Five-Year Plan" will see China's oil and gas pipeline network enter into a new development stage of "national network" with physical interconnection and fair and open services, and it is expected that China will enjoy a stable growth in pipeline transportation in the next 10 to 20 years, of which the construction of pipeline transportation for natural gas pipelines and other ancillary facilities will be the focus of development. In 2024, major trunk pipeline projects such as the China Russia East Line (except for the Nantong-Luzhi section which is under construction), the West-East line 3 (except for the Zhongwei-Zaoyang section which is under construction), and the Shaanxi-Beijing line 3/4 have been completed and commissioned. The Group will benefit from the construction of oil and natural gas pipelines.

二零二二年初,國家發展改革委、國家能源局印發《[十 四五」現代能源體系規劃》提出到二零二五年,全中國油 氣管網規模達到21萬公里左右的目標。截至二零二三年 底,全中國長輸油氣管網總里程約19萬公里,其中包括 原油管道3.3萬公里,成品油管道3.3萬公里,天然氣管 道12.4萬公里。按照「雙碳」目標下的需求預測,預計到 二零三五年中國還將新增天然氣管道建設總里程約6.5 萬公里,其中新增幹線管道2.95萬公里,省級管道3.53 萬公里,新建原油管道約2.000公里,成品油管道約 4.000公里。「十四五規劃 | 將是中國油氣管網全面進入 物理互聯互通、服務公平開放的「全國一張網」發展新階 段,預計未來10年至20年中國管道運輸還將處於穩定 增長期,其中天然氣管道等配套設施管道運輸建設將是 發展重點。二零二四年,當中位中俄東線(除南通 - 甪 直段在建)、西氣東輸三線(除中衛 - 棗陽段在建)、 陝京三/四線等大型幹線管道專案建成投產。本集團將 受惠於石油及天然氣管道的建設。

In order to implement the energy security strategy of "Four Revolutions and One Co-operation", China Oil & Gas Pipeline Network Corporation ("Pipe China") was formally established at the end of 2019, which is principally engaged in the investment, construction and operation of infrastructure such as oil and gas trunk pipeline networks and gas storage and peak shaving, the interconnection of the trunk pipeline network and the connection of social pipelines, as well as the operation and scheduling of the national oil and gas pipeline network. In recent years, Pipe China has accelerated the interconnection of the trunk pipeline network and promoted the interconnection of the west-east gas transmission pipeline system with the China-Russia East Line and the Jiangsu-Anhui Pipeline in the Yangtze River Delta Region, so as to weave the "line" into a "network" and form the "west-east gas transmission, Russian-south gas transmission, south-north gas transmission, Sichuan-east gas transmission, sea gas delivery to land, flexible deployment, comprehensive protection" pattern of gas supply, enhancing the oil and gas transportation capacity, to ensure a safe and stable supply of oil and gas energy. Pipe China plans to accelerate the construction of a "national network" of oil and gas in the future, and to unify the advantages of planning, construction and operation, and to accelerate the layout of the "6 major strategic channels + 7 verticals, 7 horizontals" natural gas pipeline network structure, "4 major strategic channels + 3 major regions" crude oil pipeline network structure, and the "3 verticals, 3 horizontals + 5 major regions" refined oil pipeline network structure. Since its establishment, Pipe China has been constantly strengthening the overall co-ordination of China's oil and gas pipeline network layout, which has a positive impact on the development of the industry, and the Group's position as a qualified supplier of Pipe China has also had a positive impact on the Group.

為了落實「四個革命、一個合作」能源安全戰略,國家石 油天然氣管網集團有限公司(「國家管網集團」)於二零一 九年底正式成立,國家管網集團主要從事油氣幹線管網 及儲氣調峰等基礎設施的投資建設和運營,負責幹線管 網互聯互通和與社會管道聯通,以及全中國油氣管網的 運行調度。國家管網集團近年來加速推進管網互聯互 通,推動西氣東輸管道系統在長三角地區與中俄東線、 蘇皖管道等互聯互通,織「線」成「網」,形成了「西氣東 輸、俄氣南下、南氣北上、川氣東送、海氣登陸、靈活 調配、全面保障 | 的供氣格局,提升油氣運輸能力,確 保油氣能源安全穩定供應。國家管網集團規劃未來加快 構建油氣「全國一張網」,統一規劃、統一建設、統一運 營的優勢作用,加快佈局「六大戰略通道+七縱七橫」天 然氣管網架構、「四大戰略通道+三大區域」原油管網架 構、「三縱三橫十五大區域」成品油管網架構。國家管網 集團成立以來,不斷加強對中國油氣管網佈局的整體統 籌,對產業發展起到積極影響,本集團作為國家管網集 團的合資格供應商,也對本集團有正面的影響。

According to the China Natural Gas Development Report (2024), in 2023, a series of major achievements were made in domestic natural gas exploration, with major breakthroughs in onshore ultradeep, deepwater and unconventional gas exploration, and the discovery of a number of hundreds of billions of cubic meters of gas zones in basins such as the Tarim, Sichuan and Erdos, etc. National natural gas consumption increased from 184.8 billion cubic meters in 2014 to 394.5 billion cubic meters in 2023, and the increase in consumption accounted for 37% of the total increase in global consumption. 165.6 billion cubic meters of natural gas was imported into the country in 2023, a year-on-year increase of 9.9%, with the main sources of imports including Turkmenistan, Australia, Russia, Qatar, etc. In 2023, the total mileage of long-distance natural gas pipelines in China was 124,000 kilometers, with more than 4,000 kilometers of long-distance pipelines completed, and it is expected that more than 4,000 kilometers of new pipelines will be added in 2024. As a manufacturer of natural gas welded steel pipe, the Group will firmly seize these opportunities.

國內天然氣勘探取得一系列重大成果,陸上超深層、深水、非常規氣勘探取得重大突破,在塔里木、四川、鄂爾多斯等盆地發現多個千億立方米級大氣區。全國天然氣消耗量由二零一四年的1,848億立方米增長至二零二三年的3,945億立方米,消耗增量佔全球總增量的37%。二零二三年,全國進口天然氣1,656億立方米,同比增長9.9%,主要進口來源包括土庫曼斯坦、澳大利亞、俄羅斯、卡達等國。二零二三年,全國長輸天然氣管道總里程達12.4萬公里,建成長輸管道里程超4,000公里,預計二零二四年將新增管道里程超4,000公里。本集團作為天然氣焊管製造商,定能為本集團帶來機遇。

根據《中國天然氣發展報告(二零二四)》,二零二三年,

In order to achieve the "dual carbon" strategic goal of "achieving peak carbon dioxide emission before 2030 and carbon neutrality before 2060", China indicates that ecology-focused green and low-carbon development will become the leading strategy in the future. In the medium to long term, natural gas will become the focus of energy development, while oil and gas companies will also actively develop and explore clean energy, such as hydrogen, wind power and hydro-power. The construction of a series of natural gas pipeline, wind power and offshore platforms will be accelerated. In addition, the Group will actively expand its insulation pipe business, aiming to meet the demand for green and low-carbon products. With its technical strength and track record, the Group will be able to jointly achieve the "dual carbon" strategic goal of "carbon neutrality".

中國為實現「二零三零年前實現碳達峰,二零六零年前實現碳中和」的「雙碳」戰略目標,標誌著以生態為重點的綠色低碳發展將成為未來的主導戰略。中長期天然氣將成為重點發展的能源,同時油氣企業也會積極發展探索清潔能源,如氫氣、風力發電及水力發電等清潔能源。一系列天然氣管網、風電及海上平台的建設將會加快。另外,本集團積極拓展保溫管業務,目標滿足綠色低碳產品的需求。憑藉本集團技術實力及往績記錄將能共同實現「碳中和」的「雙碳」戰略目標。

In the international market, although the ongoing Russia-Ukraine conflict and the tense situation in the Middle East have exacerbated uncertainty of the global energy market, the continued increase in crude oil supply has put international oil prices on a long-term bearish trend. On the other hand, insufficient global economic growth momentum, increased use of alternative energy, and warmer winter temperatures have led to a sharp drop in international gas prices. According to the China Natural Gas Development Report (2024), in 2023, the total mileage of natural gas pipelines in operation worldwide was 1.36 million kilometers, mainly in North America, Europe, Asia-Pacific, Russia-Central Asia, and China, indicating that the natural gas pipeline coverage rate in other undeveloped countries is still low. In addition, the report mentioned that according to the report "On the Path to 100% Clean Electricity" released by the U.S. Department of Energy, it is planned to achieve 100% clean electricity by 2035, and the proportion of clean energy power generation will be increased from 44% to 71%, and certain countries will continue to withdraw from nuclear and coal power generation, which will enable the Group to further expand its market share of the welded pipe overseas.

國際市場方面,雖然俄烏衝突持續和中東地區局勢緊張,加劇了全球能源市場的不確定性,但原油供應持續增加以致國際油價長期看跌。另一邊廂,全球經濟增長動力不足、替代能源使用增加、冬季氣溫偏暖令國際氣價大幅回落。根據《中國天然氣發展報告(二零二四)》,二零二三年,全球在役天然氣管道總里程達136萬公里,主要分佈在北美、歐洲、亞太、俄羅斯 一 中亞、中國,顯示其他未發展國家的天然氣管道覆蓋率仍然很低。另外,報告中提及根據美國能源部發佈《邁向100%清潔電力之路》報告,計劃二零三五年實現100%清潔電力,清潔能源發電佔比將由44%提升至71%,而某些國家將會持續退出核電及煤電,這些更令本集團進一步擴大海外焊管市場份額。

The Group believes that it is also our mission to achieve national energy safety and dual carbon goal, which will create business opportunities for the steel pipe manufacturing industry at the same time. Therefore, the Group will firmly seize the opportunities to boost its sales. As our long-term strategic goal is to become a leading global steel pipe manufacturer, the Group will expand our customer bases and market share by participating in more global oil and gas and engineering projects, diversify the use of steel pipes by supplying steel pipes for projects in infrastructure and high-end construction fields, such as bridges, wind power generation, offshore platforms, insulation pipe and water pipes. The Group will also continue to leverage its strengths in the steel pipe industry to secure more project orders.

Employees: The Group remunerates its employees based on their performance, experience and prevailing industry practice. Our package includes salaries, medical insurance, discretionary bonuses, on-job training, other benefits as well as mandatory provident funds schemes for employees in Hong Kong and statemanaged retirement benefit schemes for employees in the PRC. Our current relationship with our employees and the labour unions are good and are based on mutual support and respect.

Customers: We have built strong, long-standing relationships with our major customers, and established a strong customer base. We have obtained numerous patents, awards and recognitions, international certificates and long standing international and nationwide track record to establish our stable customer base. We are an industry pioneer and are the first and only steel pipe manufacturer in the PRC to manufacture and successfully develop deep sea welded steel pipes for the use at a water depth of 3,500m and a qualified supplier of Petrobras and Petronas. We believe that this can enable us to establish and maintain market leadership in the steel pipe industry.

Suppliers: We choose our suppliers of raw materials mainly based on the prices and quality of raw materials offered. We issue purchase orders to our suppliers that set out the quantities, prices and specifications of the products to be purchased, delivery arrangement and credit terms which were determined at arms' length negotiations between the parties based on normal commercial terms. We believe the relationship between us and our major suppliers is good and stable. Most of our procurements were paid in RMB.

The Board does not recommend the payment of any final dividend for the year ended 31 December 2024. The reserves of the Group available for distribution depend on the dividend distributable by the Company's subsidiaries. For dividend purpose, the amount which the Company's subsidiaries in the PRC can legally distribute by way of dividend is determined by reference to their distributable profits as reflected in the PRC statutory financial statements which are prepared in accordance with accounting principles generally accepted in the PRC. These distributable profits differ from those that are reflected in the Group's financial statements prepared in accordance with IFRS Accounting Standards.

**TAX RELIEF** 

The Company is not aware of any relief from taxation available to shareholders of the Company (the "Shareholders") by reason of their holding of the Company's shares.

#### **MAJOR CUSTOMERS AND SUPPLIERS**

For the year ended 31 December 2024, sales to the Group's five largest customers accounted for 64.3% of the total revenue of the Group, and sales to the largest customer amounted to 46.8%. Purchases from the Group's five largest suppliers accounted for 54.6% of the total cost of sales of the Group, and purchases from the largest supplier amounted to 35.4%. None of the Directors or any of their associates or any Shareholders (which, to the best knowledge of the Directors, own more than 5% of the number of the Company's issued shares) had any beneficial interest in the Group's five largest customers and five largest suppliers.

The Board is committed to maintaining a good standard of corporate governance practices and business ethics in the firm belief that they are essential for maintaining and promoting investors' confidence and maximising shareholders' returns.

The Company has adopted the code provisions in the Corporate Governance Code (the "CG Code") as set out in Appendix C1 to the Listing Rules as its own code of corporate governance. The Board considers that up to the date of this annual report, in the opinion of the Board, saved as disclosed in section "Chairman and Chief Executive" below, the Company has complied with the CG Code. The Company will continue to enhance its corporate governance practices appropriate to the conduct and growth of its business and to review its corporate governance practices from time to time to ensure they comply with the evolving regulatory requirements and to meet the rising expectations of the Shareholders and other stakeholders.

The following summarises the Company's corporate governance practices.

## **CORPORATE GOVERNANCE PRACTICES**

### (A) Board of Directors

### Responsibilities and Delegation

The Board is responsible for the leadership and control of the Company, overseeing the Group's businesses, strategic decisions, internal control, risk management systems, monitoring the performance of senior management and determining the policy for corporate governance. The management is responsible for daily operations of the Group under the leadership of the Chairman. The Directors have the responsibility to act objectively in the interests of the Company.

All Directors have carried out their duties in good faith, in compliance with applicable laws and regulations and in the interests of the Company and its shareholders at all times.

The Board has delegated various responsibilities to the Board committees including the Audit Committee, the Nomination Committee and the Remuneration Committee. Further details of these Committees are set out below in section B of this corporate governance report.

The Company has received annual confirmation from each of the independent non-executive Directors (including Mr Chen Ping who has served the Company for more than nine years) of their independence pursuant to Rule 3.13 of the Listing Rules. The Company considers that all of the independent non-executive Directors are independent.

Upon reviewing the directorships and major commitments of each Director, and the attendance rate of each Director at the meetings of the Board and its committees, the Board is satisfied that all Directors have spent sufficient time in performing their responsibilities during 2024.

### **Board Meetings and Board Practices**

The Company has adopted the practice of holding Board meetings regularly for at least four times a year at approximately quarterly intervals. Ad-hoc meetings will also be convened if necessary to discuss the overall strategy as well as financial performance of the Group. Notice of Board meeting is sent to all Directors at least 14 days prior to a regular Board meeting. Reasonable notice will be given to the Directors for ad-hoc Board meetings. Directors may participate either in person or through electronic means of communication.

The company secretary of the Company is responsible for keeping the minutes of Board meetings and meetings of Board committees. All minutes are open for inspection by any Director at reasonable time on reasonable notice.

The quality of deliberations at meetings of the Board are reviewed during the annual evaluation of the Board's performance.

#### Chairman and Chief Executive

The Company is aware of the requirement under paragraph C.2.1 of the CG Code that the roles of chairman and chief executive should be separated and should not be performed by the same individual. The Company does not separately have any officer with the title of "chief executive". Mr Chen Chang, the Chairman and founder of the Group, is also responsible for the leadership and effective running of the Board, ensuring that all material issues are decided by the Board in a conducive manner. The Board will meet regularly to consider major matters affecting the operations of the Group. The Board considers that this structure will not impair the balance of power and authority between the Board and the management of the Company. The roles of the respective executive Directors and senior management, who are in charge of different functions complement the role of the chairman and chief executive. The Board is of the view that this structure provides the Group with strong and consistent leadership, facilitates effective and efficient planning and implementation of business decisions and strategies, and ensures the generation of shareholders' benefits.

The Board shall nevertheless review the structure from time to time to ensure appropriate measures are being taken should suitable circumstance arise.

本公司知悉,企業管治守則第C.2.1條規定主席及行政總裁的職務應予分離,而不應由同一人擔任。本公司並未獨立設「行政總裁」一職。本集團主席及創辦人陳昌先生同時負責董事會的領導工作及實際運作,確保所有重大事宜均由董事會的領導不會,一個人工學,不可行方式決定。董事會將定期舉行會議考慮不可行方式決定。董事會將定期舉行會議考慮不可能是數學,不可以與實際不可以的。一個人工學,不可以與實際。各位負責不同職能的執行董事及高級管理學會互補主席及行政總裁的職務。董事會認為此架構可為本集團提供強大一致的領導,有助於切實不及有效地規劃及執行商業決策及策略及確保帶來股東利益。

# Appointments, Re-election and Removal of Directors

The Board is responsible for selection and approval of candidates for appointment as Directors. The Company has established a Nomination Committee on 22 March 2012. The Nomination Committee is responsible for reviewing Board composition including the board diversity policy, evaluating the balance of skills, knowledge and experience of the Board and making recommendations on the appointment of Directors.

Each of the executive Directors has signed or renewed his/ her service contract with the Company for a period of three years. All of their appointments are subject to retirement by rotation and re-election in accordance with the Articles of Association of the Company.

Each of the independent non-executive Directors has been appointed or re-appointed for a term of two years, and are subject to retirement by rotation and re-election in accordance with the Articles of Association of the Company.

The Nomination Committee has reviewed the reappointments/appointment of both executive Directors and independent non-executive Directors and recommended to the Board of Directors for decision.

In accordance with the Company's Articles of Association, all Directors shall be subject to retirement by rotation at least once every three years and any new Director appointed to fill a causal vacancy shall submit himself/herself for re-election by shareholders at the first general meeting after appointment. In accordance with the Articles of Association, Mr Chen Chang and Mr Au Yeung Kwong Wah will retire and, being eligible, will offer themselves for re-election at the forthcoming AGM of the Company.

In accordance to the Company's Articles of Association, a separate resolution will be proposed for the re-election of each of Mr Chen Chang and Mr Au Yeung Kwong Wah and at the forthcoming AGM of the Company.

# Training Induction and Continuing Development of Directors

The Directors have endeavoured to keep abreast of the changes in their responsibilities as a Director and of the business activities and development of the Company.

Each newly appointed Director receives formal, comprehensive and tailored induction on the first occasion of his/her appointment to ensure appropriate understanding of the business and operations of the Company and full awareness of director's responsibilities and obligations under the Listing Rules and relevant statutory requirements.

Directors are continually updated on developments in the statutory and regulatory regime and the business environment to facilitate the discharge of their responsibilities. The Directors have provided to the Company their records of continuous professional development during the year ended 31 December 2024.

During the year ended 31 December 2024, all Directors (being Mr Chen Chang, Ms Chen Zhao Nian, Mr Chen Ping, Mr Au Yeung Kwong Wah and Mr Zhan Jian Zhou) attended seminars and training courses in relation to corporate governance, Listing Rules update or financial markets update arranged by professional firms/institutions. Records of continuing professional development have been maintained by the company secretary. Besides, the company secretary also conducted briefings on corporate governance, directors' duties and responsibilities and provided materials for Listing Rules amendments to all Directors for their reference.

#### Model Code for Securities Transactions

The Company has adopted the Model Code for Securities Transactions by Directors of Listed Issuers (the "Model Code") as set out in Appendix C3 to the Listing Rules. Following a specific enquiry, all the Directors has confirmed that they have complied with the Model Code throughout the year ended 31 December 2024.

When the Company is aware of any restricted period for dealings in the Company's securities, the Company will notify its Directors in advance.

#### Non-Competition Undertakings

The independent non-executive Directors have also reviewed the confirmations given by Mr Chen Chang and Bournam, being controlling shareholders of the Company, in respect of each of their compliance with the non-competition undertakings as disclosed in the prospectus of the Company dated 28 January 2010. The independent non-executive Directors are satisfied that the controlling shareholders have fully complied with the terms of the non-competition undertakings and no new competing business was reported by the controlling shareholders throughout the year ended 31 December 2024.

#### (B) Board Committees

The Board has established three committees, namely the Audit Committee, Nomination Committee and Remuneration Committee, for overseeing particular aspects of the Company's affairs. All Board committees of the Company are established with defined written terms of reference. The terms of reference of the Board committees are posted on the websites of the Company and the Stock Exchange.

The majority of the members of each Board committee are independent non-executive Directors.

Board committees are provided with sufficient resources to discharge their duties and, upon reasonable request, are able to seek independent professional advice in appropriate circumstances at the Company's expense.

#### Audit Committee

The Audit Committee consists of three independent non-executive Directors, namely Mr Chen Ping, Mr Au Yeung Kwong Wah and Mr Zhan Jian Zhou. Mr Au Yeung Kwong Wah is the Chairman of the Audit Committee. The primary duties of the Audit Committee are to review and supervise the financial reporting process and the internal control and risk management procedures and systems of our Group. The Audit Committee has reviewed the Company's audited consolidated financial statements for the year ended 31 December 2024 and the condensed unaudited consolidated interim financial statements for the six months ended 30 June 2024, including the accounting principles and practices adopted by the Company and the Group.

The main duties of the Audit Committee include the following:

- To review the financial statements and reports and consider any significant or unusual items raised by the internal auditor or external auditors before submission to the Board;
- To review the relationship with the external auditors by reference to the work performed by the auditors, their fees and terms of engagement, and make recommendations to the Board on the appointment, reappointment and removal of external auditors; and
- To review the adequacy and effectiveness of the Company's financial reporting system, risk management and internal control systems and associated procedures.

The Audit Committee held six meetings during the year ended 31 December 2024, of which two meetings with external auditors' presence, and all members of the Audit Committee attended all meetings. At the meetings, it reviewed the financial reporting and compliance procedures, the report of the internal auditor on the Company's internal control and risk management systems and processes, and the reappointment of the external auditors. No major issue on the internal control system of the Group has been identified.

There was no disagreement between the Audit Committee and the Directors in respect of matters about selection, appointment, resignation or dismissal of an external auditor.

The Company had established a whistleblowing policy and system for employees to raise concerns of possible improprieties where all concerns are addressed to the Audit Committee.

The Company's annual results for the year ended 31 December 2024 and interim results for the six months ended 30 June 2024 have been reviewed by the Audit Committee.

#### Nomination Committee

The Company recognises the benefits of a board that is composed of a balance of skills, experience, expertise and diversity of perspectives appropriate to the business development of the Company. The Board has adopted a board diversity policy in 2013. The Board has reviewed its composition and considered a number of aspects, including gender, age, educational background, professional experience, skills, knowledge and length of service in accordance with its board diversity policy. The Board considers that the existing board composition is well diversified and appropriate to the business development of the Company.

The Company established the Nomination Committee on 22 March 2012 in compliance with Appendix C1 to the Listing Rules. The Nomination Committee consists of three members, namely Mr Chen Ping, Mr Zhan Jian Zhou and Mr Chen Chang. Mr Chen Ping is the chairman of the Nomination Committee. The majority of them are independent non-executive Directors.

The primary functions of the Nomination Committee are to review and monitor the structure, size and composition (including the skills, knowledge and experience) of the Board to complement the Company's corporate strategy and make recommendations to the Board on matters relating to the appointment or re-appointment of Directors and succession planning for Directors, assess the independence of independent non-executive Directors, and review the board diversity policy and review the measurable objectives that the Board has set for implementing the board diversity policy, and the progress on achieving the objectives.

During the year and up to the date of this annual report, the Nomination Committee has reviewed the composition of the Board and made recommendations to the Board for the reappointment of Directors and succession planning for the chairman, assessed the independence of independent non-executive Directors and reviewed the board diversity policy determined the policy for nomination of directors, nomination procedure process and criteria to select and recommend candidates.

- whether the candidate can contribute to the Board a diversity of perspectives, including but not limited to gender, age, race, cultural and educational background, professional experience, skills, knowledge and length of service;
- (where the candidate is proposed to be appointed as an independent non-executive Director) whether the candidate is in compliance with the criteria of independence under the Listing Rules; and
- any other factors as may be determined by the Board from time to time.

For nomination of independent non-executive Director, the Nomination Committee will also assess the candidate's independence in accordance with the CG Code and the Listing Rules. For re-appointment of retiring Directors, the Nomination Committee will review the candidate's overall contribution and performance (including the candidate's attendance at Board committee meetings, Board meetings and general meetings, his/her level of participation and performance on the Board), and make recommendations to the Board and shareholders for re-election at general meetings.

The primary functions of the Remuneration Committee are to make recommendations to the Board on the remuneration of our Directors and senior management, determine on behalf of the Board specific remuneration packages and conditions of employment for our Directors and senior management and to review and/or approve the matters relating to share schemes under Chapter 17 of the Listing Rules. Remuneration will be determined by reference to the duties and level of responsibilities as well as market practice and conditions. None of the Directors themselves approve their own remuneration.

During the year and up to the date of this annual report, the Remuneration Committee has reviewed the Group's remuneration policy, assessed the performance of executive Directors and reviewed the remuneration package of the executive Directors and senior management and recommended to the Board on the remuneration packages of the executive Directors and senior management. No share option has been granted during the year ended 31 December 2024.

For the year ended 31 December 2024, two meetings of the Remuneration Committee were held and all members attended the meetings.

The Directors are responsible for overseeing the preparation of financial statements for the year ended 31 December 2024 with a view to ensuring that such financial statements give a true and fair view of the state of affairs of the Group and of the results and cash flows for that period. The Company's accounts are prepared in accordance with all relevant statutory requirements and suitable accounting standards.

The Directors are responsible for ensuring that appropriate accounting policies are selected and applied consistently; judgements and estimates made are prudent and reasonable; and the financial statements are prepared on a going concern basis.

The statement of the external auditor of the Company about their reporting responsibilities on the financial statements is set out in the Independent Auditor's Report on pages 111 to 121 of this annual report.

Management had provided monthly updates to Directors for giving a balanced and understandable assessment of the Company's performance, position and prospects to enable the Directors to discharge their duties.

#### (D) Internal Controls and Risk Management

The Board has overall responsibilities for maintaining a sound and effective internal control system of the Group. The Company has an internal audit department to ensure effective internal control system of the Group. The Group's system of internal control includes a defined management structure with limits of authority, and is designed to help the Group achieve its business objectives, safeguard its assets against unauthorised use or disposition, ensure the maintenance of proper accounting records for the provision of reliable financial information for internal use or for publication, and ensure compliance with relevant laws and regulations. The system is designed to provide reasonable, but not absolute, assurance against material misstatement or loss, and to manage rather than eliminate risks of failure in the Group's operational systems and in the achievement of the Group's business objectives.

The internal audit department conducts internal audit throughout the year. The internal audit process includes conducting supervision and examination on financial management and contract management, identifying problems and overseeing the rectification and correction of these problems, and reporting to the Audit Committee and the Board any material issues identified in the internal audit and the rectification and correction thereof for their review.

Shareholder(s) holding not less than one-tenth of Company's paid-up capital may request the Board to convene an extraordinary general meeting. The extraordinary general meeting will be held within 2 months after the deposition of such requisition.

A shareholder may propose a person for election as a Director by lodging the following documents to the Board or Company Secretary at our Hong Kong office at Unit 605-606, 6/F., Tower III, Enterprise Square, No. 9 Sheung Yuet Road, Kowloon Bay, Kowloon, Hong Kong: 1) a notice in writing of the intention to propose that person (with full name and biographical details as required by Rule 13.51(2) of the Listing Rules) for election as a Director; and 2) a notice in writing by that person of his willingness to be elected as a Director. Such notices shall be lodged at least 7 clear days before the date of the general meeting and the period for lodgement of such notices shall commence no earlier than the day after the dispatch of the notice of the general meeting appointed for such election and shall be at least 7 clear days in length.

To safeguard shareholder interests and rights, a separate resolution is proposed for each substantial separate issue at shareholder meetings, including the election of individual Directors.

All resolutions put forward at shareholder meetings will be voted on by poll pursuant to the Listing Rules and poll results will be posted on the websites of the Company and of the Stock Exchange after each shareholder meeting.

The Company considers that effective communication with shareholders is essential for enhancing investor relations and investor understanding of the Group's business performance and strategies. - the contractual restrictions on the payment of dividends imposed by the Company's lenders and other institutions; and
- any other factors that the Board considers to be applicable from time to time.

The Group maintains and effectively implements a comprehensive system of internal control and stringent policies for anti-corruption, and is committed to preventing and monitoring any malpractices or unethical practice.

The Group is in compliance with all applicable anti-bribery and corruption laws including the Prevention of Bribery Ordinance (Chapter 201 of the Laws of Hong Kong) in Hong Kong. The Group has also applied the Corporate Governance Code as the basis in formulating the internal rules and regulations for integrity discipline and clean administration. The Group will adhere to its corporate ethics and uphold its reputation to prevent corruption.

To prevent corruptive practices and raise employees' awareness regarding such matter, the expectations and appropriate procedures of engaging third parties, and standards relating to anti-bribery and anti-corruption are set out in the anti-corruption and bribery policy of the Group.

Employees, who are found breaching the Group's code and policies will be investigated and may be subject to warning, suspension, termination of contract, dismissal and disciplinary discharge.

In addition, a whistleblowing policy has been established to provide employees with guidance and channels for the reporting of fraud, corruption, bribery, criminal offences, conflict of interest, harassment, workplace bullying and other non-compliances with the laws, regulations and internal controls or other forms of misconducts without fear of adverse consequences.

The Group is trying to keep the damage to the environmental at a minimal level by reducing pollutants and hazardous wastes during the manufacturing process and ensuring our activities and operations are to be energy, water and resources saving, and to prevent pollution, reduce wastes and minimize the negative impacts on and harmonize with the environment. The Group has set up procedures and systems to comply with the rules and impose control on emissions.

#### Hazardous waste

Hazardous wastes were produced during production, including waste oil, waste sludge, waste mineral oil, paint, paint residue, waste grease, waste grease drum, waste paint drum, waste emulsion drum, waste activated carbon, waste organic solvent, waste developer, and fixer. Total hazardous waste produced in 2024 was approximately 329 tonnes and 0.0008 tonnes of hazardous waste was produced for each tonne of product.

#### Non-hazardous waste

Non-hazardous wastes were produced during production including welding slag, iron filings, scrap steel. Total non-hazardous waste produced in 2024 was approximately 9,251 tonnes and 0.022 tonnes of non-hazardous waste was produced for each tonne of product.

Emissions are proportional to the production level. Therefore, total emissions in 2024 increased as compared to 2023. Intensity amount per each tonne of product in 2024 decreased as compared to 2023. Nevertheless, in an aim to reduce emission of greenhouse gas, the Group has implemented the policies as follow:

- The factory in Lianyungang and Zhuhai is designed to let in more natural light and allow for natural ventilation in order to reduce use of electricity;
- Solar photovoltaic power generation equipment are installed on the roof of the factories of Lianyungang and Zhuhai factories in order to facilitate the use of clean energy;
- 3) The light and equipment would be turned off during luncheon rest time.

#### Treatment of hazardous and non-hazardous wastes

- The Group has set up procedures in the collection, storage, transportation and disposal of polluting wastes to prevent scattering, draining, leakage. Authorization is need for dumping, stacking, discarding or scattering the wastes;
- The Group has identified specific rubbish bins for different types of wastes like scrap steel, industrial wastes, domestic wastes, oil-bearing wastes, and delivered the wastes to units with waste treatment qualification for waste disposal or recycling;
- The Group has strengthened training for employees to enhance their skills and knowledge of handling waste;

#### Water source

The water source that is fit for purpose of the Company and is the running water supplied by the government which guarantees reliable quality and supply. There has been no suspension of water supply.

Water was consumed mainly for office general use, hydrostatic pressure test and ultrasonic tests.

Measures to enhance water efficiency:

- 1. Reuse water for production;
- 2. Use of water-saving taps and sanitary wares with sensor;
- Increase awareness of employees on water saving by training.

Water consumption efficiency was improved. Total water consumption in 2024 was similar to that of 2023.

#### Package material

The Group uses packing rope, packing tape and dunnage for packaging final products.

#### A.3 The Environmental and Natural Resources

In an aim to minimize surplus materials, the Group would estimate the materials needed for production prior to procurement. In addition, the Group puts in place a scrap metal recycling mechanism to sell the wasted steel produced in our production process to recycling companies.

#### A.4 Climate Change

Extreme weather events are becoming more frequent and severe and tackling climate change has become a global consensus. The Group has realized that climate change will affect its business operations. The Group regularly reviews global and local government policies, regulatory updates and market trends to identify potential climate-related risks which may have impact on the Group's business operation.

In accordance to the reporting framework developed by the Task Force on Climate-related Financial Disclosures, there are two major categories of climate-related risks, physical and transition risks. Climate change can pose threats to the Group, such as business disruption, physical damage and rise in operational costs due to severe and extreme weather events. The Group has insurance policies in place to mitigate such risks.

#### **B.1** Employment

The Group has committed in cultivating a good workplace practice free from discrimination and providing equal opportunities for all regardless of age, gender, race, colour, sexual orientation, disability or marital status to increase employee satisfaction.

#### **B.2** Health and Safety

The Group has complied with the laws and regulations and adopted the Health Safety and Environmental ("HSE") management policy, in an effort to prevent pollution, ensure health and safety of our employees, and promote sustainable development. Our target is to achieve zero accidents, zero injuries and zero losses in order to meet the international HSE management standard.

The Group's employees reside in the neighbourhood areas. Within our plant zone, there are gardening landscape, fish ponds and recreational facilities, which offer a comfortable environment and a sports ground for our employees.

The Group's management is responsible for organising periodic risk identification and evaluation exercises, and is responsible for sorting, aggregation and distribution of relevant information, which includes the identification of risk factors for occupational safety and health, risk assessment on operating conditions, possibility of accidents, the formulation of operational control procedures, contingency plans, safety level standards, as well as training and education issues.

The Group has kept records and documents relating to risk management, including the "Control procedures of the new, rebuilding and extension projects", "Risk sources identification and risk evaluation form" and "List of major risks" for staff reference.

The Group always finds great importance in occupational safety and regularly provides training for staff. In 2024, the Group hosted trainings and rehearsals in productions bases for fire alert, so as to enhance safety awareness and emergency response, and held hazards identification programs and assemblies of risk management activities.

## **B.3** Development and Training Staff Development and Training

Through meetings, trainings and notifications on notice board, the Group promotes its safety philosophy and amiable working environment among various departments and teams. We offer our employees access to learning and understanding about the Group, so that each employee and contractors of the Group or visitors can recognize their responsibilities and obligations in the aspect of improving the environment and enhancing occupational health and safety performance. We make great efforts on improving the environment and occupational safety.

Our adherence to the HSE management policy is a testimony of the greatest commitment of the Group towards environment and occupational health and safety. This policy is available for review by employees at any time. In the year, the Group further improved site management standards, achieved the goal of dedicated management, and further promoted the 6S management model in the Company. Project meetings were kicked off in the production sites of Zhuhai and Lianyungang.

The Group endeavours to enhance the skills of each employee in various aspects by providing staff trainings, which include the "Weekly Star" and "Weekly Talk". A wide array of training courses are provided for employees to strengthen their work-related knowledge and skills. Also, the Group hosted an "advanced employee's election", whereby each of the employees obtaining a certificate of honorary was offered an outdoor training opportunity. To enable excellent employees to take up management positions and to bolster our team's management capabilities, the Company also organised the "team leader for production and management training" courses during the year.

The Group has set up a labour union to further promote spiritual positive energy with various social activities.

The Company honored the advanced teams and individuals emerging from various functions with great ceremony, and called on all employees to learn from such advanced teams and individuals. The Zhuhai Company also organized a warm spring trip for the 8th March Women's Day.

#### **B.4 Labour Standards**

The Group has complied with the Labour Law of the People's Republic of China (《中華人民共和國勞動法》), Labour Contract Law of People's Republic of China (《中華人民共和國勞動合同法》), the Law of the PRC on Prohibition of Using Child Labour\* (《禁止使用童工規定》) and other relevant laws. The Group has specified staff recruitment procedures which avoid the recruitment of child labour and ensure the fulfilment of entry requirements by recruited staff through examining their identification card and certificate. The Company is required to enter into written labour contracts with employees upon their entry. There is no forced labour within the Group. The Group has not employed any staff aged under 16.

#### Staff Code

The staff code of the Group is prepared based on the PRC labour law and is in line with the national standards of the PRC. The Group has also been providing its staff with guidance in accordance with the national legislation.

#### **B.5 Supply Chain Management**

The Group has maintained proven track records of high production efficiency and timely delivery. We have established deep and cordial relationships with our suppliers. The Group keeps a list of qualified suppliers, whose appraisal is based on their track record of compliance with international standards and the Group's past cooperation relationship with them. The Group also consider factors such as compliance with environmental requirements in our supplier vendor assessment, selection and evaluation process.

For the year ended 31 December 2024, the Group had 1,303 suppliers which are located in the PRC.

The Group has adopted the following procedures to select and evaluates suppliers:

- Evaluating their product quality and company background including but not limited to the environment, health and safety awareness;
- Comparing historical level and test results of products;

Our product quality has met a number of international standards. We are also the only domestic welded steel pipe manufacturer being granted five honors, namely the "Superior Quality Award for Actual Quality of Metallurgical Products", "Gold Cup Prize for Actual Quality of Metallurgical Products", "High and New Technology Enterprise", "Province-recognised Enterprise Technology Center", and "National Key New Products" and hosts a "Academician Workstation". We are the main drafter of the national standard for longitudinal welded steel pipes in China. Meanwhile, with the setting up of the "Post-doctoral Research Station" and "Academician Workstation", the Company strives to further enhance its product quality and extend the application of its products.

#### Quality assurance process

The Group strictly upholds the ISO9001 quality management system. With the use of advanced testing equipment, and the conduct of on-line and off-line testing as well as mechanical and chemical properties testing, we inspect the products at each production process stage in accordance with the highest product quality requirements through a myriad of tests, such as steel ultrasonic testing, ultrasonic welding detection, weld X-ray inspection system, hydrostatic testing and flattening test. Upon obtaining post-test data, we will make a rigorous analysis on product quality, so as to ensure that each product meets customer requirements. We have built a testing center in compliance with the national standards and the center has been recognised by China National Accreditation Service for Conformity Assessment (CNAS). The Group's testing center is equipped with a wide variety of laboratory equipment, including universal materials testing machine, low temperature impact material testing machine, drop weight tear test (DWTT) machine, hydrogen induced cracking (HIC) testing, sulfide stress corrosion cracking (SSC), crack tip opening displacement (CTOD) test, computer-controlled chemical composition vacuum direct reading spectrometer and microscope. Achieving six standards, our measuring chamber has passed through the ISO10012: 2003 AAA measurement management system certification. This proves that our measuring instruments are of high qualification and effectiveness. The Group's testing centre has passed the "National safety quality standardisation" and obtained the "TUV SUD Metal Materials Laboratory Accreditation Certificate". Our products, an unfailing symbol of quality, are blessed with unparalleled reputation in the international market under the "PCK" brand.

In 2024, return of products sold or delivered due to safety and health reasons was zero. The Group would repair the products to customers if there are problems.

The Group put emphasis on product quality and customer satisfaction. The Group will handle any product complaints immediately. Our staff will identify, evaluate and record every product complaint and reply and address the issues as soon as possible. In 2024, the Group did not receive any product complaints.

The Group also protects our know-how by requiring our employees, in particular, the technical and mechanical personnel, to enter into confidentiality and non-competition undertakings with the Group. In addition, in order to improve the Company's intellectual property protection system, strengthen the company's core competitiveness, promote technological innovation, promote technological progress, encourage employees to invent and create, and increase employees' enthusiasm for applying for independent intellectual property rights, the Group rewards employees for independent research and development on intellectual property rights.

#### Consumer data protection

The Group respects the values and rights of the customers' information assets, and in the process of providing our customers with products, we strictly comply with the customers' information security management systems and standards. The Group has classified the business-related information as highly confidential and requires employees not to disclose confidential information to third parties to ensure that the data will not be leaked. The Group has also formulated the rules and regulations in relation to data protection in the employee handbook for employees to perform their duties.

## MATERIAL UNCERTAINTY RELATED TO GOING CONCERN

We draw attention to note 2.1 to the consolidated financial statements, which indicates that the Group had net current liabilities of approximately RMB427,360,000 as at 31 December 2024. The condition, along with other matters as set out in note 2.1, indicate that a material uncertainty exists which may cast significant doubt on the Company's ability to continue as a going concern. As set out in note 2.1 to the consolidated financial statements, the directors of the Company have implemented a number of plans and measures to improve the Group's liquidity and consider that the Group will have sufficient funds to meet its financial obligations for at least the next twelve months from the date of approval of these consolidated financial statements. Our opinion is not modified in respect of this matter.

#### **KEY AUDIT MATTERS**

Key audit matters are those matters that, in our professional judgement, were of most significance in our audit of the consolidated financial statements of the current period. These matters were addressed in the context of our audit of the consolidated financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

- In accordance with the Company Law of the People's Republic of China (the "PRC"), the Company's subsidiaries registered in the PRC are required to appropriate 10% of the annual statutory net profit after tax (after offsetting any prior years' losses) to the statutory reserve fund. When the balance of an entity's reserve fund reaches 50% of its registered capital, any further appropriation is optional. The statutory reserve fund can be utilised to offset prior years' losses or to increase the registered capital. However, such balance of the statutory reserve fund must be maintained at a minimum of 25% of the registered capital after such usage.

#### CORPORATE AND GROUP INFORMATION

#### 2. MATERIAL ACCOUNTING POLICIES

#### 2.1 Basis of preparation

The consolidated financial statements of the Group have been prepared in accordance with IFRS Accounting Standards (which include all International Accounting Standards ("IASS"), International Financial Reporting Standards ("IFRSs") and interpretations) issued by the International Accounting Standards Board ("IASB"), and the disclosure requirements of the Hong Kong Companies Ordinance. They have been prepared under the historical cost convention, except for investment properties which have been measured at fair value. These financial statements are presented in Renminbi ("RMB") and all values are rounded to the nearest thousand except when otherwise indicated.

#### Basis of consolidation

The consolidated financial statements include the financial statements of the Group for the year ended 31 December 2024. A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

When the Company has, directly or indirectly, less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- the size of the Group's holding of voting rights relative to the size and dispersion of holdings of the other vote holders;
- potential voting rights held by the Group, other vote holders or other parties;
- rights arising from other contractual arrangements;
   and
- any additional facts and circumstances that indicate that the Group has, or does not have, the current ability to direct the relevant activities at the time that decisions need to be made, including voting patterns at previous shareholders' meetings.

The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases.

Profit or loss and each component of other comprehensive income are attributed to the owners of the parent of the Group and to the non-controlling interests, even if this results in the non-controlling interests having a deficit balance. All intragroup assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control described above. A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction.

If the Group loses control over a subsidiary, it derecognises (i) the assets (including goodwill) and liabilities of the subsidiary, (ii) the carrying amount of any non-controlling interest and (iii) the cumulative translation differences recorded in equity; and recognises (i) the fair value of the consideration received, (ii) the fair value of any investment retained and (iii) any resulting surplus or deficit in profit or loss. The Group's share of components previously recognised in other comprehensive income is reclassified to profit or loss or retained profits, as appropriate, on the same basis as would be required if the Group had directly disposed of the related assets or liabilities.

## 2.1 Basis of preparation (Continued) Going concern basis

As at 31 December 2024, the Group maintained cash and cash equivalents of approximately RMB53,323,000 (2023: RMB32,191,000) and recorded net current liabilities of approximately RMB427,360,000 (2023: RMB845,744,000). In view of these circumstances, the directors of the Company have considered the future liquidity and performance of the Group and its available sources of finance in assessing whether the Group will have sufficient financial resources to continue as a going concern.

In order to improve the Group's liquidity and cash flows to sustain the Group as a going concern, the Group implemented or is in the process of implementing the following measures:

## (1) Active negotiation with banks to obtain adequate bank borrowings to finance the Group's operations

As at 31 December 2024, the Group are expected to have sufficient financial support to pay off debts in the next 12 months, so the consolidated financial statements are prepared on the basis of going concern.

Subsequent to 31 December 2024 and up to the date of this report, the Group obtained the new loan amounted to RMB92.642.000 and the renewal of the existing loan amounting to approximately RMB600,670,000 is under negotiation and the Group expects that the renewal of the existing loan could be renewed with related banks upon expiry. The Group continues to actively negotiate with the banks for the renewal of the Group's borrowings when they fall due or obtain additional sources of finance to meet the Group's working capital and financial requirements in the near future. The directors of the Company have evaluated all the relevant facts available to them and are of the opinion that they have a good track record and relationship with the banks and considered that the Group would be able to renew the Group's loans upon expiry.

為改善本集團的流動資金及現金流量,使本集團得以持續經營,本集團已實施或正在實施以下措施:

#### Improvement of the Group's operating cash flows

The Group is taking measures to tighten cost control over various production costs and expenses with an aim to attain profitable and positive cash flow operations. The eventual outcome of the above measures is inherently uncertain and cannot be estimated with reasonable certainty.

The directors of the Company have prepared a cash flow forecast for the Group which covers a period of twelve months from the end of the reporting period. Taking into account the positive cash flows from the Group's steel pipes business and the continued sale of the Group's existing real estate projects, the directors considered that the Group will have sufficient working capital to finance its operations and meet its financial obligations as and when they fall due. Accordingly, the consolidated financial statements of the Group have been prepared on a going concern basis.

Should the going concern assumption be inappropriate, adjustments may have to be made to reflect the situation that assets may need to be realised at amounts other than those which are currently recorded in the consolidated statement of financial position. In addition, the Group may have to provide for any further liabilities that might arise, and to reclassify non-current assets and non-current liabilities as current assets and current liabilities, respectively. The effects of these adjustments have not been reflected in the consolidated financial statements.

Unrealised gains and losses resulting from transactions between the Group and its joint venture are eliminated to the extent of the Group's investment in the joint venture, except where unrealised losses provide evidence of an impairment of the assets transferred. Goodwill arising from the acquisition of the joint venture is included as part of the Group's investment in a joint venture.

If an investment in a joint venture becomes an investment in an associate or vice versa, the retained interest is not remeasured. Instead, the investment continues to be accounted for under the equity method. In all other cases, upon loss of significant influence over the associate or joint control over the joint venture, the Group measures and recognises any retained investment at its fair value. Business combinations are accounted for using the acquisition method. The consideration transferred is measured at the acquisition date fair value which is the sum of the acquisition-date fair values of assets transferred by the Group, liabilities assumed by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. For each business combination, the Group elects whether to measure the non-controlling interests in the acquiree that are present ownership interests and entitle their holders to a proportionate share of net assets in the event of liquidation either at fair value or at the proportionate share of the acquiree's identifiable net assets. All other components of non-controlling interests are measured at fair value. Acquisition-related costs are expensed as incurred.

The Group determines that it has acquired a business when the acquired set of activities and assets includes an input and a substantive process that together significantly contribute to the ability to create outputs.

When the Group acquires a business, it assesses the financial assets and liabilities assumed for appropriate classification and designation in accordance with the contractual terms, economic circumstances and pertinent conditions as at the acquisition date. This includes the separation of embedded derivatives in host contracts of the acquiree.

If the business combination is achieved in stages, the previously held equity interest is remeasured at its acquisition-date fair value and any resulting gain or loss is recognised in profit or loss.

Any contingent consideration to be transferred by the acquirer is recognised at fair value at the acquisition-date. Contingent consideration classified as an asset or liability is measured at fair value with changes in fair value recognised in profit or loss. Contingent consideration that is classified as equity is not remeasured and subsequent settlement is accounted for within equity.

Goodwill is initially measured at cost, being the excess of the aggregate of the consideration transferred, the amount recognised for non-controlling interests and any fair value of the Group's previously held equity interests in the acquiree over the identifiable net assets acquired and liabilities assumed. If the sum of this consideration and other items is lower than the fair value of the net assets acquired, the difference is, after reassessment, recognised in profit or loss as a gain on bargain purchase.

After initial recognition, goodwill is measured at cost less any accumulated impairment losses. Goodwill is tested for impairment annually or more frequently if events or changes in circumstances indicate that the carrying value may be impaired. The Group performs its annual impairment test of goodwill as at 31 December. For the purpose of impairment testing, goodwill acquired in a business combination is, from the acquisition date, allocated to each of the Group's cash-generating units, or groups of cash-generating units, that are expected to benefit from the synergies of the combination, irrespective of whether other assets or liabilities of the Group are assigned to those units or groups of units.

An impairment loss recognised for goodwill is not reversed in a subsequent period.

Where goodwill has been allocated to a cash-generating unit (or group of cash-generating units) and part of the operation within that unit is disposed of, the goodwill associated with the operation disposed of is included in the carrying amount of the operation when determining the gain or loss on the disposal. Goodwill disposed of in these circumstances is measured based on the relative value of the operation disposed of and the portion of the cash-generating unit retained.

#### Fair value measurement

The Group measures its investment properties at fair value at the end of each reporting period. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either in the principal market for the asset or liability, or in the absence of a principal market, in the most advantageous market for the asset or liability. The principal or the most advantageous market must be accessible by the Group. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

All assets and liabilities for which fair value is measured or disclosed in the financial statements are categorised within the fair value hierarchy, described as follows, based on the lowest level input that is significant to the fair value measurement as a whole:

- Level 1 based on quoted prices (unadjusted) in active markets for identical assets or liabilities
- Level 2 based on valuation techniques for which the lowest level input that is significant to the fair value measurement is observable, either directly or indirectly
- Level 3 based on valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable

Where an indication of impairment exists, or when annual impairment testing for an asset is required (other than inventories, deferred tax assets, financial assets, investment properties, goodwill, non-current asset classified as held for sale), the asset's recoverable amount is estimated. An asset's recoverable amount is the higher of the asset's or cash-generating unit's value in use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cash-generating unit to which the asset belongs.

An impairment loss is recognised only if the carrying amount of an asset exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to the statement of profit or loss in the period in which it arises in those expense categories consistent with the function of the impaired asset.

An assessment is made at the end of each reporting period as to whether there is an indication that previously recognised impairment losses may no longer exist or may have decreased. If such an indication exists, the recoverable amount is estimated. A previously recognised impairment loss of an asset other than goodwill is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined (net of any depreciation/amortisation) had no impairment loss been recognised for the asset in prior years. A reversal of such an impairment loss is credited to the statement of profit or loss in the period in which it arises, unless the asset is carried at a revalued amount, in which case the reversal of the impairment loss is accounted for in accordance with the relevant accounting policy for that revalued asset.

ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive, discounted at an approximation of the original effective interest rate. The expected cash flows will include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms.

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12 months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

At each reporting date, the Group assesses whether the credit risk on a financial instrument has increased significantly since initial recognition. When making the assessment, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition and considers reasonable and supportable information that is available without undue cost or effort, including historical and forward-looking information.

For debt investments at fair value through other comprehensive income, the Group applies the low credit risk simplification. At each reporting date, the Group evaluates whether the debt investments are considered to have low credit risk using all reasonable and supportable information that is available without undue cost or effort. In making that evaluation, the Group reassesses the external credit ratings of the debt investments. In addition, the Group considers that there has been a significant increase in credit risk when contractual payments are more than 30 days past due.

The Group considers a financial asset in default when contractual payments are 90 days past due. However, in certain cases, the Group may also consider a financial asset to be in default when internal or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group. A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

Debt investments at fair value through other comprehensive income and financial assets at amortised cost are subject to impairment under the general approach and they are classified within the following stages for measurement of ECLs except for trade and bills receivables and contract assets which apply the simplified approach as detailed below.

- Stage 1 Financial instruments for which credit risk has not increased significantly since initial recognition and for which the loss allowance is measured at an amount equal to 12-month ECLs.
- Stage 2 Financial instruments for which credit risk has increased significantly since initial recognition but that are not credit-impaired financial assets and for which the loss allowance is measured at an amount equal to lifetime ECLs.
- Stage 3 Financial assets that are credit-impaired at the reporting date (but that are not purchased or originated credit-impaired) and for which the loss allowance is measured at an amount equal to lifetime ECLs.

For trade and bills receivables that do not contain a significant financing component or when the Group applies the practical expedient of not adjusting the effect of a significant financing component, the Group applies the simplified approach in calculating ECLs. Under the simplified approach, the Group does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date. The Group has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

For trade and bills receivables that contain a significant financing component and lease receivables, the Group chooses as its accounting policy to adopt the simplified approach in calculating ECLs with policies as described above.

#### Financial liabilities

#### Initial recognition and measurement

Financial liabilities are classified, at initial recognition, as financial liabilities at fair value through profit or loss, loans and borrowings or payables, as appropriate.

Gains and losses are recognised in the statement of profit or loss when the liabilities are derecognised as well as through the effective interest rate amortisation process.

#### Financial guarantee contracts

Financial guarantee contracts issued by the Group are those contracts that require a payment to be made to reimburse the holder for a loss it incurs because the specified debtor fails to make a payment when due in accordance with the terms of a debt instrument. A financial quarantee contract is recognised initially as a liability at its fair value, adjusted for transaction costs that are directly attributable to the issuance of the guarantee. Subsequent to initial recognition, the Group measures the financial guarantee contracts at the higher of: (i) the ECL allowance determined in accordance with the policy as set out in "Impairment of financial assets"; and (ii) the amount initially recognised less, when appropriate, the cumulative amount of income recognised.

When the effect of discounting is material, the amount recognised for a provision is the present value at the end of the reporting period of the future expenditures expected to be required to settle the obligation. The increase in the discounted present value amount arising from the passage of time is included in finance costs in the statement of profit or loss.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

#### Income tax

Income tax comprises current and deferred income tax. Income tax relating to items recognised outside profit or loss is recognised outside profit or loss, either in other comprehensive income or directly in equity.

Deferred tax is provided, using the liability method, on all temporary differences at the end of the reporting period between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes.

Deferred tax liabilities are recognised for all taxable temporary differences, except:

- when the deferred tax liability arises from the initial (a) recognition of goodwill or an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss;
- in respect of taxable temporary differences (b) associated with investments in subsidiaries and a joint venture, when the timing of the reversal of the temporary differences can be controlled and it is probable that the temporary differences will not reverse in the foreseeable future:
- taxable temporary differences arising on the initial recognition of goodwill; and
- (d) those related to the income taxes arising from tax laws enacted or substantively enacted to implement the Pillar Two model rules published by the Organisation for Economic Co-operation and Development.

The group recognised deferred tax assets and deferred tax liabilities separately in relation to its lease liabilities and right-of-use assets.

Where the Group receives government loans granted with no or at a below-market rate of interest for the construction of a qualifying asset, the initial carrying amount of the government loans is determined using the effective interest rate method, as further explained in the accounting policy for "Financial liabilities" above. The benefit of the government loans granted with no or at a below-market rate of interest, which is the difference between the initial carrying value of the loans and the proceeds received, is treated as a government grant and released to the statement of profit or loss over the expected useful life of the relevant asset by equal annual instalments.

#### Revenue recognition

#### Revenue from contracts with customers

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services.

When the contract contains a financing component which provides the customer with a significant benefit of financing the transfer of goods or services to the customer for more than one year, revenue is measured at the present value of the amount receivable, discounted using the discount rate that would be reflected in a separate financing transaction between the Group and the customer at contract inception. When the contract contains a financing component which provides the Group with a significant financial benefit for more than one year, revenue recognised under the contract includes the interest expense accreted on the contract liability under the effective interest method. For a contract where the period between the payment by the customer and the transfer of the promised goods or services is one year or less, the transaction price is not adjusted for the effects of a significant financing component, using the practical expedient in IFRS 15.

#### Sale of goods

Revenue from the sale of goods is recognised at the point in time when control of the asset is transferred to the customer, generally on delivery of the goods.

#### Sale of properties

Revenue from the sale of properties is recognised at the point in time when the purchasers obtained the physical possession of the completed property and the Group has a present right to payment and the collection of the consideration is probable.

### Manufacturing services

Revenue from the provision of manufacturing services is recognised over time, using an input method to measure progress towards complete satisfaction of the service, because the Group's performance creates or enhances an asset that the customer controls as the asset is created or enhanced. The input method recognises revenue based on the proportion of the actual costs incurred relative to the estimated total costs for satisfaction of the manufacturing services.

Rental income is recognised on a time proportion basis over the lease terms. Variable lease payments that do not depend on an index or a rate are recognised as income in the accounting period in which they are incurred.

#### Other income

Interest income is recognised on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial asset.

#### Contract liabilities

A contract liability is recognised when a payment is received or a payment is due (whichever is earlier) from a customer before the Group transfers the related goods or services. Contract liabilities are recognised as revenue when the Group performs under the contract (i.e., transfers control of the related goods or services to the customer).

#### Pension schemes

The Group operates a defined contribution Mandatory Provident Fund retirement benefit scheme (the "MPF Scheme") under the Mandatory Provident Fund Schemes Ordinance for those employees who are eligible to participate in the MPF Scheme. Contributions are made based on a percentage of the employees' basic salaries and are charged to profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when contributed into the MPF Scheme.

The employees of the Group's subsidiaries which operate in Mainland China are required to participate in central pension schemes operated by the local municipal government. These subsidiaries are required to contribute certain percentages of their payroll costs to the central pension schemes. The contributions are charged to the statement of profit or loss as they become payable in accordance with the rules of the central pension schemes.

#### Other benefits

The Group contributes on a monthly basis to defined contribution housing, medical and other benefit plans organised by the PRC government. The PRC government undertakes to assume the benefit obligations of all existing and retired employees under these plans. Contributions to these plans by the Group are expensed as incurred. The Group has no further obligations for benefits for their qualified employees under these plans.

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, i.e., assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalised as part of the cost of those assets. The capitalisation of such borrowing costs ceases when the assets are substantially ready for their intended use or sale. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs capitalised. All other borrowing costs are expensed in the period in which they are incurred. Borrowing costs consist of interest and other costs that an entity incurs in connection with the borrowing of funds.

#### Foreign currencies

These financial statements are presented in RMB. Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of the reporting period. Differences arising on settlement or translation of monetary items are recognised in the statement of profit or loss.

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was measured. The gain or loss arising on translation of a non-monetary item measured at fair value is treated in line with the recognition of the gain or loss on change in fair value of the item (i.e., translation difference on the item whose fair value gain or loss is recognised in other comprehensive income or profit or loss is also recognised in other comprehensive income or profit or loss, respectively).

In determining the exchange rate on initial recognition of the related asset, expense or income on the derecognition of a non-monetary asset or non-monetary liability relating to an advance consideration, the date of initial transaction is the date on which the Group initially recognises the non-monetary asset or non-monetary liability arising from the advance consideration. If there are multiple payments or receipts in advance, the Group determines the transaction date for each payment or receipt of the advance consideration.

For the purpose of presenting consolidated financial statements, the assets and liabilities of the Group's foreign operations are translated at exchange rates prevailing on the reporting date. Income and expense items are translated at the average exchange rates for the period, unless exchange rates fluctuate significantly during that period, in which case the exchange rates at the date of transactions are used. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in a foreign exchange translation reserve (attributed to non-controlling interests as appropriate).

For all other partial disposals (i.e. partial disposals of associates or joint arrangements that do not result in the Group losing significant influence or joint control), the proportionate share of the accumulated exchange differences is reclassified to profit or loss.

- (a) current prices in an active market for properties of a different nature, condition or location, adjusted to reflect those differences;
- (b) recent prices of similar properties on less active markets, with adjustments to reflect any changes in economic conditions since the date of the transactions that occurred at those prices; and
- (c) discounted cash flow projections based on reliable estimates of future cash flows, supported by the terms of any existing lease and other contracts and (when possible) by external evidence such as current market rents for similar properties in the same location and condition, and using discount rates that reflect current market assessments of the uncertainty in the amount and timing of the cash flows.

# Impairment of non-financial assets (other than goodwill)

The Group assesses whether there are any indicators of impairment for all non-financial assets (including the right-of-use assets) at the end of each reporting period. Non-financial assets are tested for impairment when there are indicators that the carrying amounts may not be recoverable. An impairment exists when the carrying value of an asset or a cash-generating unit exceeds its recoverable amount, which is the higher of its fair value less costs to sell and its value in use. The calculation of the fair value less costs to sell is based on available data from binding sales transactions in an arm's length transaction of similar assets or observable market prices less incremental costs for disposing of the asset. When value in use calculations are undertaken, management must estimate the expected future cash flows from the asset or cash-generating unit and choose a suitable discount rate in order to calculate the present value of those cash flows.

# Useful lives and residual values of property, plant and equipment

In determining the useful lives and residual values of items of property, plant and equipment, the Group has to consider various factors, such as technical or commercial obsolescence arising from changes or improvements in production, or from a change in the market demand for the product or service output of the asset, expected usage of the asset, expected physical wear and tear, the care and maintenance of the asset, and legal or similar limits on the use of the asset. The estimation of the useful life of the asset is based on the experience of the Group with similar assets that are used in a similar way. Additional depreciation is made if the estimated useful lives and/or the residual values of items of property, plant and equipment are different from the previous estimation. Useful lives and residual values are reviewed at each financial year end date based on changes in circumstances.

#### Deferred tax assets

Deferred tax assets are recognised for all unused tax losses to the extent that it is probable that future taxable profits will be available against which the unused tax losses can be utilised, based on all available evidence. Recognition primarily involves significant management's judgements regarding the future performance of a particular legal entity or tax group in which the deferred tax asset has been recognised. A variety of other factors are also evaluated in considering whether there is convincing evidence that it is probable that some portions or all of the deferred tax assets will ultimately be realised, such as the existence of taxable temporary differences, tax planning strategies and the periods in which estimated tax losses can be utilised. The carrying amounts of the deferred tax assets and related financial models and budgets are reviewed at the end of the reporting period and to the extent that there is insufficient convincing evidence that sufficient taxable profits will be available within the utilisation periods to allow the utilisation of the carryforward of tax losses, and that the asset balance will be reduced and charged to profit or loss.

#### Write-down of inventories to net realisable value

A write-down of inventories to net realisable value is made based on the estimated net realisable value of inventories. The assessment of the write-down involves management's judgement and estimates. Where the actual outcome or expectation in future is different from the original estimate, such differences will have an impact on the carrying amount of inventories and the write-down/write-back of inventories in the period in which such estimate has been changed. Further details are given in note 18 to the financial statements.

## Provision for expected credit losses on trade receivables

The Group applies the provision matrix method in the assessment of the ECLs on trade receivables at each reporting period. This method studies the probability of default to arrive at the ECLs of trade receivables.

The provision matrix method is initially based on the Group's historical observed default rates. The Group will calibrate the matrix to adjust the historical credit loss experience with forward-looking information. For instance, if forecast economic conditions (i.e., gross domestic product) are expected to deteriorate over the next year which can lead to an increased number of defaults in the manufacturing sector, the historical default rates are adjusted. At each reporting date, the historical observed default rates are updated and changes in the forward-looking estimates are analysed.

The assessment of the correlation among historical observed default rates, forecast economic conditions and ECLs is a significant estimate. The amount of ECLs is sensitive to changes in circumstances and forecast economic conditions. The Group's historical credit loss experience and forecast of economic conditions may also not be representative of customers' actual default in the future. The information about the ECLs on the Group's trade receivables is disclosed in note 19 to the financial statements.

Revenue in respect of manufacturing services is recognised over time using input method to measure progress towards complete satisfaction of the service. In addition, revenue and profit recognition is dependent on estimating the proportion of the actual costs incurred relative to the estimated total costs for satisfaction of the manufacturing services. Based on the Group's recent experience and the nature of the activity undertaken by the Group, the Group makes estimates of the point at which it considers the work is sufficiently advanced such that the costs to complete and revenue can be reliably estimated. Based on the latest information available in respect of the market environment, the Group prepares budgets for contracts individually and the budget, which is used in the Group's financial reporting, is reviewed regularly. Onerous contracts are provided for when identified. Material adjustments to the budgeted costs may occur in future if there is a significant change in the market environment.

#### PRC land appreciation tax

The Group is subject to land appreciation tax in Mainland China. The provision for land appreciation tax is based on management's best estimates according to its understanding of the requirements set forth in the relevant PRC tax laws and regulations. The actual land appreciation tax liabilities are subject to the determination by the tax authorities upon the completion of the property development projects. The Group has not finalised its land appreciation tax calculations and payments with the tax authorities for certain property development projects.

The final outcome could be different from the amounts that were initially recorded, and any differences will impact the land appreciation tax expenses and the related provision in the period in which the differences are realised.

The adjusted profit/loss before tax is measured consistently with the Group's profit/loss before tax except that head office and corporate expenses are excluded from such measurement.

Segment assets exclude unallocated head office and corporate assets as these assets are managed on a group basis.

Segment liabilities exclude unallocated head office and corporate liabilities as these liabilities are managed on a group basis.

There were no intersegment sales during the years ended 31 December 2024 and 2023.

#### Sale of steel pipes

For sale of steel pipes, revenue is recognised when control of the goods has transferred, being when the goods have been shipped to the customer's specific location (delivery). Transportation and handling activities that occur before customer obtain control are considered as fulfilment activities. Following the delivery, the customer has full discretion over the manner of distribution and price to sell the goods, has the primary responsibility when on selling the goods and bears the risks of obsolescence and loss in relation to the goods. Payment is generally due 30 days to 90 days from the invoice date, except for new customers, where payment in advance is normally required.

#### Sale of properties

The performance obligation is satisfied upon the physical possession of the completed property is obtained by the purchasers.

#### Manufacturing services

The Group provides manufacturing services to customers. Such services are recognised as a performance obligation satisfied over time as the Group creates or enhances an asset that the customer controls as the asset is created or enhanced. Revenue is recognised for these manufacturing services based on the stage of completion of the contract using input method. Payment is generally due within 50 days from the date of delivery or customer acceptance of the product processed.

The Group generally offers one-year warranties for its product. The Group recognised retention money as contract assets as the Group's entitlement to the consideration was conditional on satisfactory completion of the warranty period. The retention money will be recognised as trade receivables at the end of warranty period.

The Group does not recognise the warranty service as a separate performance obligation in a single contract as the warranty service is assurance type which based on management's best estimate on the Group's liabilities under the standard warranty terms granted with reference to the prior experience for the defective products, and the Group's obligation to repair or replace faulty products under the warranty terms is recognised as a provision, if any.

#### Corporate income tax ("CIT")

The Company, which was incorporated in the Cayman Islands, is not subject to CIT.

Lessonstart and Lucknow, which were incorporated in the British Virgin Islands, are not subject to CIT. Crown Central, CKSPG and View Sharp International Limited, which were incorporated in Hong Kong, were subject to profits tax at the rate of 16.5% on the estimated assessable profits arising in Hong Kong during the year, except for one subsidiary of the Group which is a qualifying entity under the two-tiered profits tax rates regime. The first HK\$2,000,000 (2023: HK\$2,000,000) of assessable profits of this subsidiary are taxed at 8.25% (2023: 8.25%) and the remaining assessable profits are taxed at 16.5% (2023: 16.5%).

PCKSP (Zhuhai), as a High and New Technology Enterprise ("HNTE") qualified on 30 September 2015 and with the qualification renewed in 2021 and 2024, is entitled to a reduced tax rate of 15% from 1 January 2021 to 31 December 2023 and 1 January 2024 to 31 December 2026 respectively. PCKSP (Lianyungang), as a HNTE qualified on 5 December 2019 and with the qualification renewed in 2023, is entitled to a reduced tax rate of 15% from 1 January 2023 to 31 December 2025.

According to the PRC corporate income tax law and its relevant regulations issued in 2019 and renewed policy issued in 2023, entities that qualified as Small and Micro Enterprises are entitled to a preferential income tax rate of 5% for taxable income less than RMB3,000,000 (2023: 5% for taxable income less than RMB3,000,000). During the year ended 31 December 2024, 11 (2023: 13) subsidiaries of the Group are qualified as small and low profit enterprise and enjoyed a preferential tax rate of 5% (2023: 5%), whereas applicable.

Pursuant to the PRC CIT Law and the respective regulations, except for the above-mentioned preferential tax treatments, the companies of the Group which operate in Mainland China were subject to CIT at a rate of 25% on their respective taxable income for the years ended 31 December 2024 and 2023.

Taxes on profits assessable in Mainland China have been calculated at the prevailing tax rates, based on existing legislation, interpretations and practices in respect thereof.

#### Land appreciation tax ("LAT")

According to the requirements of the Provisional Regulations of the PRC on LAT effective from 1 January 1994 and the Detailed Implementation Rules on the Provisional Regulations of the PRC on LAT effective from 27 January 1995, all income from the sale or transfer of state-owned land use rights and buildings in Mainland China (being the proceeds from the sale of properties less deductible expenditures including borrowing costs and property development expenditures) is subject to LAT at progressive rates ranging from 30% to 60% of the appreciation of land value with an exemption provided for property sales of ordinary residential properties if their appreciation values do not exceed 20% of the sum of the total deductible items.

The Group estimated and made provision for LAT according to the requirements set forth in the relevant PRC tax laws and regulations. The actual LAT liabilities are subject to the determination by the tax authorities upon completion of the property development projects and the LAT determined by the tax authorities might be different from the basis on which the provision for LAT is calculated.

#### Impairment testing of CGU

When any indicators of impairment are identified, property, plant and equipment are reviewed for impairment based on each CGU. The CGU is an individual plant or operating entity. The carrying values of these individual plants or entities were compared to the recoverable amounts of the CGUs, which were based predominantly on value in use. Value in use calculations use pre-tax cash flow projections based on financial budgets approved by management covering a 5-year period. Cash flows beyond the 5-year period are extrapolated using the same cash flow projections of the fifth year. Other key assumptions applied in the impairment tests include the expected product price, demand for the products, product cost, finance costs and other related expenses, with the consideration of the possible significant decrease in finance costs following the measures adopted by management.

Each customer has a maximum credit limit. The Group seeks to maintain strict control over its outstanding receivables to minimise credit risk. Overdue balances are reviewed regularly by senior management. In view of the aforementioned and the fact that the Group's trade receivables relate to a large number of diversified customers, there is no significant concentration of credit risk. The Group does not hold any collateral or other credit enhancements over its trade receivable balances. Trade receivables are non-interest-bearing.

The Group applied the provision matrix method in the assessment of the ECLs on trade receivables at each reporting period. This method studies the probability of default to arrive at the ECLs of trade receivables. The process involves a review of, among others, the Group's historical sales recordings and trade receivables, in order to determine the default rate of the debtors.

The Group have considered and conducted, among other things, the following key steps:

- Define a period of sales and bad debts relating to those sales;
- Collect the historical data of trade receivables;
- Calculate the historical default loss percentage; and
- Calculate the ECL using the default rate determined aforementioned.

The provision matrix method involves the definition of an appropriate period of time to analyse the proportion of receivables written off as bad debts. Based on the best estimation of the management, over 3 years unpaid trade receivables as at each reporting date have been defined in this exercise.

As at 31 December 2024 and 31 December 2023, all the trade receivables of the Group have been reasonably investigated and assessed for ECLs after management considered the economic situation. Based on management's experience and best estimation, an amount payables held by a subsidiary due to a debtor (the "Debtor") had a relatively high likelihood to loss. Therefore, impairment loss of 100% on the trade receivables from the Debtor had been recognised for the year ended 31 December 2023.

As at 31 December 2024, the Group endorsed certain bills receivable accepted by banks in Mainland China (the "Derecognised Bills") to certain of its suppliers in order to settle the trade payables due to such suppliers with an aggregate carrying amount of RMB22,418,000 (2023: RMB64,975,000). The Derecognised Bills had a maturity of one to nine months (2023: one to nine months) at the end of the reporting period. In accordance with the Law of Negotiable Instruments in the PRC, the holders of the Derecognised Bills have a right of recourse against the Group if the PRC banks default (the "Continuing Involvement"). In the opinion of the directors of the Company, the Group has transferred substantially all risks and rewards relating to the Derecognised Bills. Accordingly, it has derecognised the full carrying amounts of the Derecognised Bills and the associated trade payables. The maximum exposure to loss from the Group's Continuing Involvement in the Derecognised Bills and the undiscounted cash flows to repurchase these Derecognised Bills was equal to their carrying amounts. In the opinion of the directors of the Company, the fair values of the Group's Continuing Involvement in the Derecognised Bills were not significant.

During the years ended 31 December 2024 and 31 December 2023, the Group had not recognised any gain or loss on the date of transfer of the Derecognised Bills. No gains or losses were recognised from the Continuing Involvement, both during the year and cumulatively. The endorsement had been made evenly throughout the year.

- Pursuant to the relevant regulations in the PRC, certain property (a) development companies of the Group are required to place at designated bank accounts certain amounts of pre-sales proceeds of properties as guarantee deposits for the construction of the related properties. The deposits can only be used for purchases of construction materials and payments of construction fees for the relevant property projects. As at 31 December 2024, such guarantee deposits amounted to approximately RMB930,000 (2023: RMB984,000).
- As at 31 December 2024, the Group's cash and cash (b) equivalents denominated in US\$ amounted to approximately RMB4,091,000 (2023: RMB1,051,000) and denominated in RMB amounted to approximately RMB48,949,000 (2023: RMB30,627,000). Cash at banks earns interest at floating rates based on daily bank deposit rates. The bank balances and pledged deposits are deposited with creditworthy banks with no recent history of default.

## 25. FIXED RATE BONDS AND NOTES (Continued) US\$3,000,000 7% bonds due in 2023 (2017 Bonds A)

On 28 April 2017, the Company issued bonds with a principal amount of US\$3,000,000 to an individual investor (the "2017 Bonds A"). The bonds should be repayable in full by 28 April 2020 but the expiry date had been extended to 30 June 2022 and further extended to 31 March 2023 and 30 September 2023 by the Company and the investor. The bonds beared interest at a fixed coupon interest rate of 7% per annum, payable semiannually in arrears commencing on 28 October 2017. The bonds were unsecured. The 2017 Bonds A matured on 30 September 2023 and was not repaid by the Company upon the maturity date. Interest on the 2017 Bonds A carried interest at 7% per annum was recognised in the profit and loss of the Group and the related interests payable were included in other payables and accruals. As at December 2024, the Company had fully redeemed the 2017 Bonds A.

#### HK\$140,000,000 12% notes due in 2023 (2020 Notes)

On 27 April 2020, the Company issued 12% notes due on 27 April 2022 but the expiry date could be extended to 30 September 2022 with a principal amount of HK\$140.000.000 to an investment fund (the "2020 Notes"). The notes bear interest at a fixed rate of 12% per annum, payable semiannually in arrears. Pursuant to the purchase agreement, specific performance obligations are imposed on the controlling shareholder of the Group. Any breach of the specific performance obligations may constitute a breach under the note purchase agreement, pursuant to which the investment fund is entitled to redeem the 2020 Notes in accordance with the terms and conditions. The Company and the noteholder mutually agreed to extend the maturity date to 22 December 2023. The 2020 Notes matured on 22 December 2023 and was not repaid by the Company upon the maturity date. Interest on the 2020 Notes carried interest at 12% per annum was recognised in the profit and loss of the Group and the related interests payable were included in other payables and accruals (note 23). As at December 2024, the Company had partially redeemed the 2020 Notes with a principal amount of HK\$81,000,000. At the end of the reporting period, the 2020 Notes with the principal amount of HK\$59,000,000 remained outstanding. On 19 December 2024, the Company entered a settlement deed with the noteholder. The Company covenanted and agreed to pay a sum of HK\$54.000.000 (the "Settlement Amount") to the noteholder into the noteholder's bank account, in full and final settlement of all liabilities and obligations at any time due. Subsequent to 31 December 2024 and up to the date of this report, the Company had fully redeemed the Settlement Amount and the noteholder had surrendered the entire 2020 Notes and released and discharged the Company from all its obligations pursuant to or under the above transaction documents.

Pursuant to the terms of the guarantees, in the event of default on mortgage payments by these purchasers before the expiry of the guarantees, the Group is responsible for repaying the outstanding mortgage principals together with the accrued interest and penalties owed by the defaulted purchasers to the banks, net of any auction proceeds as described below.

Pursuant to the above arrangement, the related properties were pledged to the banks as collateral for the mortgage loans, and in the event of default on mortgage repayments by these purchasers, the banks are entitled to take over the legal titles and will realise the pledged properties through open auction. The Group is responsible for repaying the banks when the proceeds from the auction of the properties cannot cover the outstanding mortgage principals together with the accrued interest and penalties.

The Group's guarantee period starts from the date of grant of the relevant mortgage loans and ends upon the issuance of real estate ownership certificates to the purchasers, which will generally be available within one to two years after the purchasers take possession of the relevant properties.

The fair value of the guarantees is not significant and the directors of the Company consider that in the event of default on payments, the net realisable value of the related properties can cover the repayment of the outstanding mortgage principals together with the accrued interest and penalties, and therefore, no provision has been made in the financial statements for the guarantees.

### 39. FINANCIAL RISK MANAGEMENT OBJECTIVES **AND POLICIES**

The Group's principal financial instruments include bank and other borrowings, fixed rate bonds and notes, cash and short term deposits. The main purpose of these financial instruments is to raise finance for the Group's operations. The Group also has various other financial assets and liabilities such as trade receivables and trade payables, which arise directly from its operations.

The main risks arising from the Group's financial instruments are interest rate risk, foreign currency risk, credit risk and liquidity risk. Generally, the Group introduces prudent strategies on its risk management. The board of directors reviews and agrees policies for managing each of these risks and they are summarised below:

#### Interest rate risk (a)

The Group's exposure to the risk of changes in market interest rates relates primarily to the Group's bank loans and government loans with floating interest rates. The Group is also exposed to fair value interest rate risk in relation to fixed-rate bank and other borrowings.

The Group regularly reviews and monitors the mix of fixed and floating interest rate borrowings in order to manage its interest rate risk. Interest-bearing loans, cash and short term deposits are stated at amortised cost and not revalued on a periodic basis. Floating rate interest income and expenses are credited/charged to the statement of profit or loss as earned/incurred.

If there was a general increase/decrease in the interest rate of bank and other borrowings with floating interest rates by one percentage point, with all other variables held constant, the consolidated operating results would have decreased/ increased by approximately RMB12,449,000 (2023: RMB12,559,000), and there would have been no impact on other components of the consolidated equity, except for accumulated losses, of the Group.

The Group trades only with recognised and creditworthy third parties. It is the Group's policy that all customers who wish to trade on credit terms are subject to credit verification procedures. In addition, receivable balances are monitored on an ongoing basis and the Group's exposure to bad debts is not significant. For transactions that are not denominated in the functional currency of the relevant operating unit, the Group does not offer credit terms without the specific approval of the Head of Credit Control.

### Maximum exposure and year-end staging

- The credit quality of the financial assets included in (ii) prepayments, other receivables and other assets is considered to be "normal" when they are not past due and there is no information indicating that the financial assets had a significant increase in credit risk since initial recognition.

Further quantitative data in respect of the Group's exposure to credit risk arising from trade receivables are disclosed in note 19 to the financial statements.

Since the Group trades only with recognised and creditworthy third parties, there is no requirement for collateral. Concentrations of credit risk are managed by customer/counterparty, by geographical region and by industry sector. There are no significant concentrations of credit risk within the Group as the customer bases of the Group's trade receivables are widely dispersed in different sectors and industries.

### (d) Liquidity risk

The Group's objective is to ensure continuity of sufficient funding and flexibility by utilising a variety of bank and other borrowings with debt maturities spreading over a range of periods, thereby ensuring that the Group's outstanding borrowing obligation is not exposed to excessive repayment risk in any one year. Due to the capital intensive nature of the Group's businesses, the Group ensures that it maintains sufficient cash and credit lines to meet its liquidity requirements.

The liquidity of the Group is primarily dependent on its ability to maintain adequate cash inflows from operations to meet its debt obligations as they fall due, and its ability to obtain external financing to meet its committed future capital expenditure. With regard to its future capital commitments and other financing requirements, the Group has already obtained banking facilities with several banks of up to an amount of approximately RMB2,512,960,000 as at 31 December 2024, of which an amount of approximately RMB1,462,805,000 has been utilised.

The primary objectives of the Group's capital management are to safeguard the Group's ability to continue as a going concern and to maintain healthy capital ratios in order to support its business and maximise shareholders' value.

The Group monitors capital using a gearing ratio, which is total debts divided by total assets. Total debts include interest-bearing bank and other borrowings and fixed rate bonds and notes. The gearing ratio as at 31 December 2024 was 28.7% (2023: 28.5%).
