Reminder letter regarding the Arrangements on Electronic Dissemination of Corporate Communications

With reference to the notification letter dated July 19, 2024 titled “New Arrangements on Electronic Dissemination of Corporate Communications”, Kuaishou Technology (the “Company”) is writing to remind you that the Company has adopted electronic dissemination of corporate communications (the “Corporate Communications”), which means any documents issued or to be issued by the Company for the information or action of holders of any of its securities, including but not limited to (a) the directors’ report, its annual accounts together with a copy of the auditors’ report and, where applicable, its summary financial report; (b) the interim report and, where applicable, its summary interim report; (c) a notice of meeting; (d) a listing document; (e) a circular and (f) a proxy form.

Please note that both the English and Chinese versions of all future Corporate Communications will be available on the website of the Company at www.kuaishou.com and the website of The Stock Exchange of Hong Kong Limited (the “Stock Exchange”) at www.hkexnews.hk (the “Website Version”) in place of printed copies. A notice of publication of the Website Version of Corporate Communications will not be sent by the Company and you need to proactively check the Company’s website and the Stock Exchange’s website to keep up with the publication of Corporate Communications.

Solicitation of electronic contact details

The Company has not received your email address for the electronic dissemination of Corporate Communications. Further request in writing will be required if you prefer to continue receiving printed copy of future Corporate Communications (including Actionable Corporate Communications).
