Arrangement of Electronic Dissemination of Corporate Communications

Pursuant to Rule 2.07 of the Rules Governing The Listing of Securities on The Stock Exchange of Hong Kong Limited (the “Listing Rules”) relating to the expansion of paperless listing regime and electronic dissemination of corporate communications, which came into effect on 31 December 2023 and the articles of associations (“Articles”) of the Company, the Company is writing to inform you that the Company has adopted electronic dissemination of corporate communications (the “Corporate Communications”). Corporate communications mean any documents issued or to be issued by the Company for the information or action of holders of any of its securities, including but not limited to (a) the directors’ report, its annual accounts together with a copy of the auditors’ report and, where applicable, its summary financial report; (b) the interim report and, where applicable, its summary interim report; (c) a notice of meeting; (d) a listing document; (e) a circular and (f) a proxy form. Please note that both the English and Chinese versions of all future Corporate Communications will be available electronically on the website of the Company at www.vicon.com.hk and the HKEXnews website at www.hkexnews.hk in place of printed copies. A notice of availability of Corporate Communications will be sent to you by email (if you have provided a functional email address ^(Note 1)) or by post (if you have not provided an email address or the email address is non-functional) as long as the Articles requires doing so. The Company is also required by the Listing Rules to send Actionable Corporate Communications ^(Note 2) to each shareholder individually.

As a non-registered holder, if you wish to receive corporate communications from the Company pursuant to the Listing Rules, you should liaise with your bank(s), broker(s), custodian(s), nominee(s) or HKSCC Nominees Limited through which your Shares are held (collectively, the “Intermediaries”) and provide your email address to your Intermediaries. If the Company does not receive your functional email address from the Intermediaries, until such time that the functional email address is provided to the Intermediaries, you will be unable to receive any notifications regarding the publication of Corporate Communications by email; and until such time that a functional email address is provided to the Share Registrar, the Company will send you the notice of availability of Corporate Communications in printed form in the future.
