Reference is made to the circular and the announcement of Sun Art Retail Group Limited (the “Company”) dated 18 July 2025 and 14 August 2025, respectively, with respect to the payment of final dividend of Hong Kong dollars (“HKD”) \$0.17 per share for the year ended 31 March 2025 (“FY25 Final Dividend”) and the option given to the shareholders to elect to receive all or part of their dividend in Renminbi (“RMB”) at the exchange rate of HK\$1:RMB0.9047 (offshore), in United States dollars (“USD”) at the exchange rate of HK\$1:US\$0.1269, or a combination of HKD, RMB and USD.
茲提述高鑫零售有限公司「本公司」分別於二零二五年七月十八日刊發的通函及二零二五年八月十四日刊發的公告，內容有關派付截至二零二五年三月三十一日止的年度末期股息每股港幣0.17元（「25財年末期股息」）及給予股東以人民幣（「人民幣」）收取全部或部分股息的選擇權，匯率為港元1元兌美元0.1269元；或港幣、人民幣和美元的組合。

(a) at any local time before 12:00 noon on Monday, 15 September 2025. In such a case, the Closing Time will be extended to 5:00 p.m. on the same business day; or
(b) at any local time between 12:00 noon and 4:30 p.m. on Monday, 15 September 2025. In such case, the Closing Time will be extended to 4:30 p.m. on the next business day which does not have any of the above warnings in force at any time between 9:00 a.m. and 4:30 p.m.
