Flash Report on Production and Sales Volume for August 2025

The Company's total sales volume for the first eight months of 2025 was 1,138,573 units, representing a decrease of 5.0% year-on-year. Of these, new energy vehicle sales amounted to 304,770 units, marking a 38.2% year-on-year increase. Dongfeng Motor Corporation, the parent company of the Company, recorded a total of 1,472,385 vehicle sales for the first eight months, representing a decrease of 7.0% year-on-year. The sales volume of Dongfeng Automobile Company Limited (A-share code 600006, hereinafter referred to as "DFAC"), a subsidiary of the Company, recorded a sales volume of 84,713 units for the first eight months of 2025, representing a decrease of 17.4% year-on-year.
