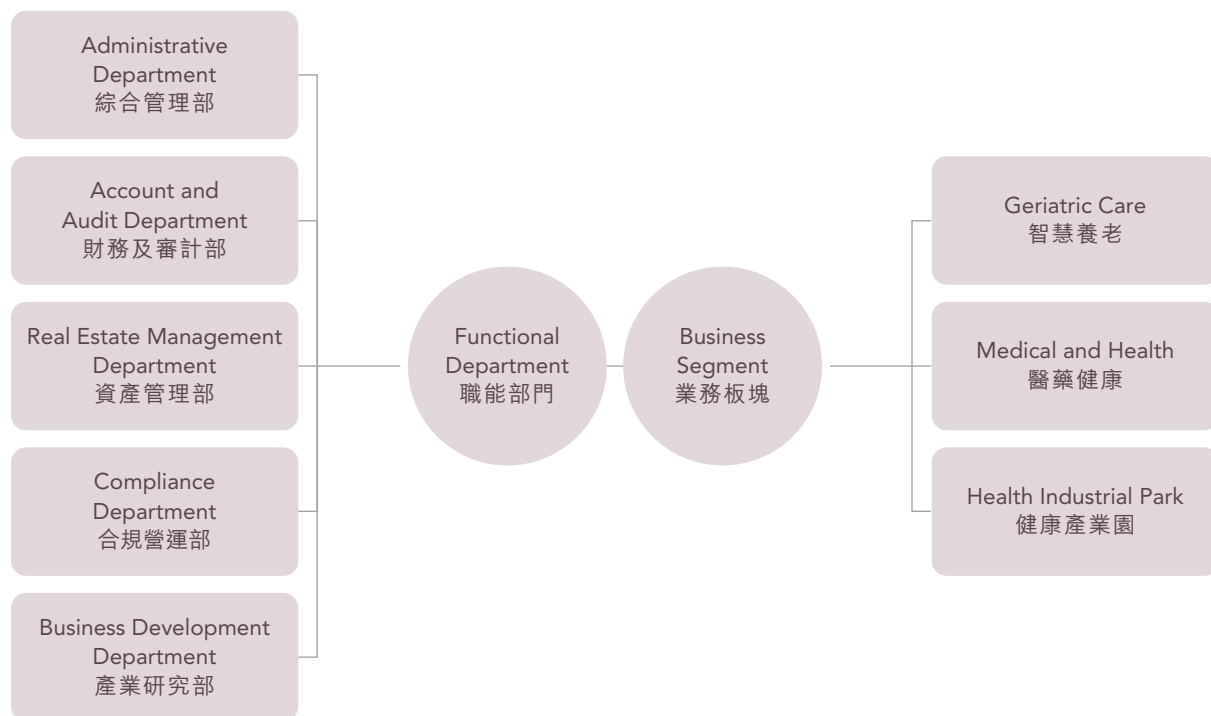
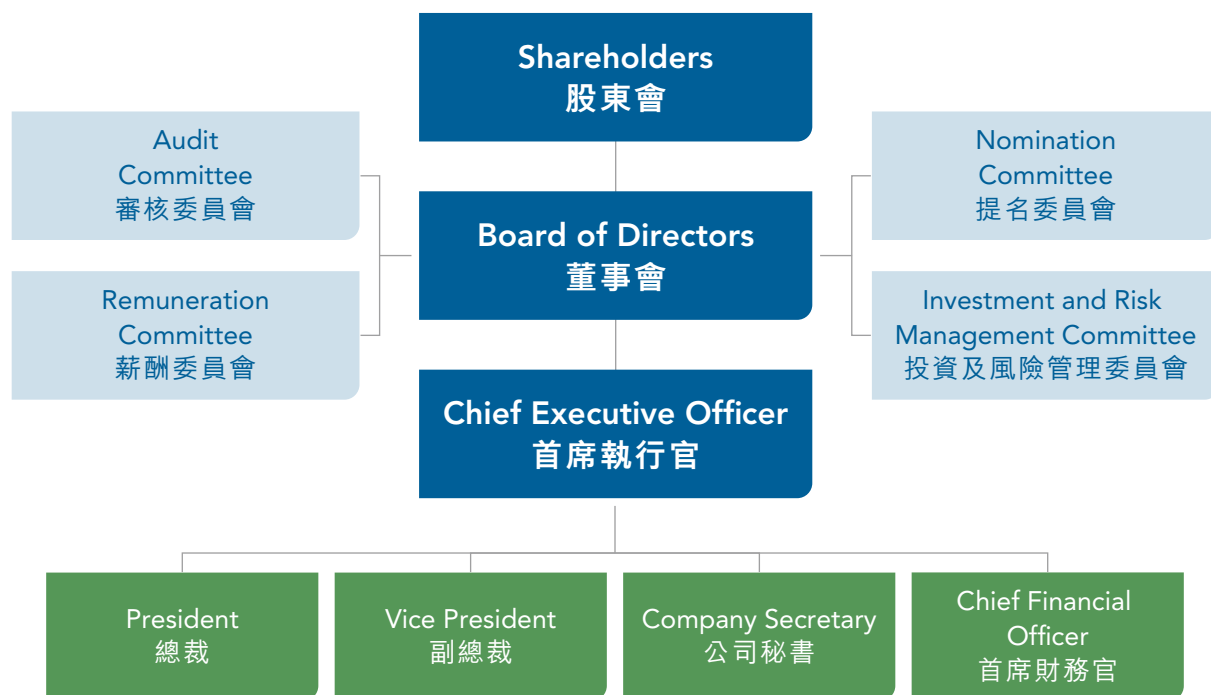

# Chairman's Statement

## 主席報告

### Dear Shareholders,

On behalf of the Board of Directors (the "Board") of Beijing Health (Holdings) Limited (the "Company" and its subsidiaries collectively, the "Group"), I am pleased to present the annual report for the year ended 31 December 2025 (the "Reporting Period") of the Group and would like to take this opportunity to review our business performance over the past year and articulate our strategies for future growth.

### 2025 YEAR UNDER REVIEW: RESILIENT OPERATIONS FOR BUILDING FUTURE MOMENTUM

Looking back to 2025, against the backdrop of a complex and volatile macro landscape and intensified industry competition, the Group has always closely aligned with the nation's "Healthy China" initiative and actively responded to aging population strategy. By adhering to the development roadmap of fostering synergies between the three core pillars – "Geriatric Care Services + Health Industrial Parks + Medical and Geriatric Products and Home Furnishings", the Group is dedicated to creating a comprehensive "All-Scenario Healthy Living" ecosystem. Thanks to the resilient efforts of all staff, and the clear and focused execution of strategies, the Group has generally maintained steady growth across its businesses, with significant improvements achieved in occupancy rates and revenues of key projects, further consolidating the market competitiveness of our model of "standardized chain operation with integrated medical and geriatric care".

### STRATEGIC FOCUS AND IMPLEMENTATION AMIDST THE WAVE OF RISING SILVER ECONOMY

China's aging population continues to accelerate, and the silver economy has become an important pillar of the country's strategic emerging industries. The Group is seizing both policy and market opportunities, focusing on the Yangtze River Delta region and deeply cultivating the inclusive and institutional geriatric care service market. Our "Beikang Medical and Geriatric Care" brand has established a strong market reputation. The Group has operated and managed seven geriatric care institutions with a total capacity of 1,373 beds and an average occupancy rate of approximately 75%, indicating stable operating cash flows. During the Year, the geriatric care business segment achieved revenue of RMB55.37 million, representing a year-on-year increase of approximately 23%; and recorded a net profit of RMB3.31 million, representing a year-on-year increase of approximately 55%, demonstrating our outstanding operational efficiency and improved profitability.

### 致各位股東：

本人謹代表北京健康(控股)集團有限公司(「本公司」，連同其附屬公司統稱「本集團」)董事會(「董事會」)，欣然提呈本集團截至二零二五年十二月三十一日止年度(「報告期」)之年度報告，並藉此機會回顧過去一年的業務表現，以及闡述未來的發展策略。

### 二零二五年回顧：堅韌經營，蓄力未來

回顧二零二五年，本集團在複雜多變的宏觀環境與行業競爭加劇的背景下，始終緊扣國家「健康中國」及積極應對人口老化戰略，堅守「養老服務+健康產業園+醫養產品及家具」三大核心板塊協同發展的路徑，致力於構建「全場景健康生活」生態系統。憑藉全體同仁的堅韌努力與清晰聚焦的戰略執行，集團整體業務保持穩健增長，重點項目的入住率及收入均實現顯著提升，進一步鞏固了「醫養結合、連鎖標準化」模式的市場競爭力。

### 銀髮經濟浪潮下的戰略聚焦與實踐

中國老齡化進程持續加速，銀髮經濟已成為國家戰略性新興產業的重要支柱。本集團緊抓政策與市場雙重機遇，以長三角地區為重點，深耕普惠型、機構養老服務市場。我們的「北康醫養」品牌已建立起良好的市場聲譽，七家運營及管理的養老機構合計提供1,373張床位，平均入住率約75%，經營現金流穩定。年內，養老業務板塊實現收入人民幣5,537萬元，同比增長約23%；錄得淨利潤人民幣331萬元，同比增長約55%，彰顯了我們卓越的運營效率與盈利能力提升。

All key projects also performed exceptionally well: Guangyi Geriatric Care Center, as a provincial-level demonstration project, has consistently maintained a high occupancy rate of 92% ; Xuejia and Wuhe projects have seen steady revenue growth; and Huifeng, Luoxi, and Wuhu Golden Sun projects have achieved rapid increases in occupancy rates and revenue through service optimization and model innovation. The newly opened Rizhao City Investment Geriatric Care Center\* (日照城投頤養中心), a quality health care community in cooperation with state-owned enterprises, has made a smooth kick-start with promising future development potential.

### DUAL-ENGINE GROWTH: INDUSTRY EXPANSION ALONG WITH BUSINESS TRANSFORMATION

In the Health Industry Park segment, we adhere to the concept of “industry-city integration” by promoting the construction and operation of multiple industry park projects to attract high-quality enterprises across the greater health industry chain so as to achieve steady appreciation of asset value and ensure consistent contributions of rental income.

Meanwhile, our medical and geriatric products and home furnishing businesses successfully achieved a strategic transformation in 2025. Vissam Prosperity, a company under the Group actively expanded into the educational furniture market that a dual-engine growth model with “a solid base in medical and geriatric furniture + new growth in educational furniture” was established. During the Year, the Group successfully won the bids for several key university projects, with annual contracted amount reaching nearly RMB130 million, marking the maturity of our new business growth curve. Our continuous investment in product innovation, qualification development, and brand promotion has laid a solid foundation for the long-term development of our businesses.

### LOOKING AHEAD: SUSTAINABLE GROWTH AND SOCIAL COMMITMENT

Looking ahead to 2026 and beyond, the Group has clearly outlined its development blueprint. In respect of geriatric care business, newly contracted projects such as the Wuxi Ancient Canal Nursing Home and the Anhui Guangde project are progressing steadily, with an expected addition of approximately 740 beds. Meanwhile, we have launched an online value-added service platform, aiming to integrate “offline beds + online services” into a seamless, full-process chain to enhance our comprehensive service value. Our medium-to-long-term goal is to steadily expand our total capacity to over 5,000 beds for geriatric care, eventually advancing toward a more ambitious visionary milestone of 10,000 beds. We are committed to building a comprehensive service network of urban geriatric care that centers on institutional geriatric care while radiating towards product offerings and home-based services.

各重點項目亦表現亮眼：廣益養老中心作為省級示範項目，入住率長期保持在92%的高位；薛家、五河項目收入增長穩健；惠楓、羅溪及蕪湖金太陽等項目通過服務優化與模式創新，實現了入住率與收入的快速躍升。新開業的日照城投頤養中心，作為與國有企業合作的高品質康養社區，已順利起步，未來發展潛力可期。

### 雙輪驅動：產業拓展與業務轉型

在健康產業園板塊，我們秉持產城融合理念，推進多個產業園項目的建設與運營，吸引大健康產業鏈優質企業入駐，以實現資產價值的穩步提升與租金收入的持續貢獻。

與此同時，我們的醫養產品及家具業務在二零二五年成功實現戰略轉型。旗下偉森盛業公司積極拓展教育家具市場，形成「醫養家具基本盤+教育家具新增長」的雙驅動格局。年內成功中標多個重點高校項目，全年簽約金額近人民幣1.3億元，標誌著新業務增長曲線已步入成熟階段。我們在產品創新、資質建設及品牌推廣方面的持續投入，為業務的長期發展奠定了堅實基礎。

### 展望未來：持續成長與社會責任

展望二零二六年及更長遠的未來，本集團已清晰規劃發展藍圖。養老業務方面，新簽約的無錫古運河護理院及安徽廣德等項目正有序推進，預計將新增約740張床位。同時，我們已啟用線上增值服務平台，致力於打通「線下床位+線上服務」的全流程鏈條，提升綜合服務價值。我們的中長期目標是穩步將養老總床位規模提升至5,000張以上，並向著10,000張乃至更宏偉的願景邁進，構建以機構養老為核心、輻射產品與居家服務的城市養老綜合服務網路。

In respect of the furniture business, we will continue to optimize our business structure, consolidating our leading position in the educational furniture market while refining our medical and geriatric care furniture product lines. Through intelligent and green upgrades, we are committed to becoming a leading service provider of healthy learning and health care spaces.

While pursuing commercial success, the Group consistently and proactively fulfills its corporate social responsibilities. # Management Discussion and Analysis

## 管理層討論與分析

### BUSINESS REVIEW

#### Overview

In 2025, the Group closely aligned with the nation's "Healthy China" initiative and proactively responded to aging population strategy. Centered around our three core pillars "Geriatric Care Services + Health Industry Parks + Medical and Geriatric Products and Home Furnishings", we have built an "All-Scenario Healthy Living" ecosystem. Through the synergies created by online and offline multi-channel integration, we have achieved unified development across institutional geriatric care, home-based elderly-friendly care, and industrial support. Driven by the dual engines of "silver economy" policy advantages and market demand, the Group's business generally maintained steady growth with significant increases in both occupancy rates and revenues of key projects, demonstrating the competitive advantages of its model of "standardized chain operation with integrated medical and geriatric care".

Against the backdrop of a complex and volatile macro landscape and intensified industry competition, the Group has continued to optimize its existing asset portfolio and refine its management, while adopted a prudent approach to facilitate new project investments, prioritizing risk control and capital returns to ensure that the overall business performance remains aligned with its strategic direction.

#### Geriatric Care and Medical and Healthcare Business

The growth rate of China's aging population continues to rise rapidly, which has already exceeded 300 million in 2025 and is expected to exceed 400 million by 2035. The "silver economy" is considered as one of the key strategic emerging industries focused by the country for development. The 2025 Government Work Report explicitly proposed to "refine policy mechanisms for the development of geriatric care services and industries, and vigorously promote the silver economy". In December of the same year, eight departments, including the Ministry of Civil Affairs, jointly issued the "Several Measures on Cultivating Geriatric Care Service Entities and Promoting the Development of the Silver Economy\*" (《關於培育養老服務經營主體促進銀髮經濟發展的若干措施》), which outlined 14 specific initiatives covering brand building, supply-demand platform construction, and business environment optimization to further improve the policy system for the geriatric care service industry. The market scale of the silver economy is expected to surpass RMB30 trillion in the future, indicating promising prospects for industrial development.

#### 業務回顧

##### 總體概況

於二零二五年，本集團緊扣國家「健康中國」及積極應對人口老齡化戰略，圍繞「養老服務+健康產業園+醫養產品及家具」三大板塊，構建「全場景健康生活」生態系統，通過線上線下多管道協同，實現機構養老、居家適老及產業配套的一體化發展。在銀髮經濟政策紅利及市場需求雙輪驅動下，集團整體業務保持穩健增長，重點項目入住率及收入均錄得顯著提升，體現「醫養結合、連鎖標準化」模式的競爭優勢。

在複雜多變的宏觀環境及行業競爭加劇背景下，集團一方面持續優化存量資產組合及精細化管理，另一方面審慎推進新項目投資，著重風險控制及資本回報，整體業務表現與策略方向保持一致。

##### 養老及醫療健康業務

中國老齡人口持續快速增長，二零二五年老年人口規模已突破三億，預計二零三五年將超過四億人，銀髮經濟被視為國家重點培育的戰略性新興產業之一。二零二五年政府工作報告明確提出「完善發展養老事業和養老產業政策機制，大力發展銀髮經濟」，同年十二月民政部等八部門聯合印發的《關於培育養老服務經營主體促進銀髮經濟發展的若干措施》提出十四項具體舉措，從品牌化建設、供需平台搭建及營商環境優化等多方面，進一步完善養老服務產業政策體系，銀髮經濟市場規模未來有望突破三十萬億元人民幣，行業發展前景廣闊。

The Group remains closely aligned with the national strategies addressing aging population and the “Healthy China” initiative and continues to deepen its presence in the inclusive, institutional geriatric care market with a strategic focus on the Yangtze River Delta region. By adopting the business model of “chain operation with integrated medical and geriatric care”, the Group has expanded its portfolio of high-quality geriatric care assets through diverse channels including self-construction, self-operation and partnerships. After years of development, the Group has established “Beikang Geriatric Care” (北康醫養) as a well-recognized geriatric care service brand in China and accumulated extensive experience in investment and operation of medical and geriatric care. The scale of our self-trained team of geriatric care and medical and nursing professionals continues to grow, and the occupancy rates of beds have consistently remained at a high level, representing widespread recognition from local governments and customers.

As of 31 December 2025, the Group operated and managed seven geriatric care institutions in China with a total capacity of 1,373 beds mainly located in the Yangtze River Delta Region, including a total of 849 beds for medical care in four medical institutions. During the Reporting Period, the average occupancy rate of the Group’s geriatric care institutions reached approximately 75% with overall operating cash flow remained stable, indicating consistently high levels of asset utilization rate and operational efficiency. During the Year, revenue from beds of geriatric care institutions amounted to RMB55.37 million (2024: RMB45.08 million), representing a year-on-year increase of approximately 23%, and recorded a net profit of RMB3.31 million (2024: RMB2.14 million), representing a year-on-year increase of approximately 55%. The significant growth in both revenue and profit was mainly driven by the expansion of bed capacity, increased occupancy rates, higher revenue from the “integrated medical and geriatric care” model and the value-added services, as well as contributions from some newly commissioned projects.

本集團緊跟國家應對人口老化及「健康中國」戰略方向，持續深耕以長三角地區為重點的普惠型、機構養老院舍市場，採用「連鎖經營、醫養結合」的運營模式，通過自建、自營及合作等多元方式拓展優質養老資產。經過多年發展，本集團已在內地打造具有一定知名度的「北康醫養」養老服務品牌，積累了豐富的醫養投資與運營經驗，自行培養的專業養老及醫療護理團隊規模不斷擴大，床位入住率長期維持在較高水平，獲得地方政府及客戶的廣泛認可。

截至二零二五年十二月三十一日，本集團於國內經營及管理七家養老機構，共提供1,373張床位，主要分佈於長三角地區，其中包括四家醫療機構合共提供849張醫療床位。報告期內，集團養老機構平均入住率達到約75%，整體經營現金流保持穩定，反映資產利用率及運營效率持續處於良好水準。本年度養老機構床位實現收入人民幣5,537萬元(二零二四年：人民幣4,508萬元)，同比增長約23%；錄得淨利潤人民幣331萬元(二零二四年：人民幣214萬元)，同比增長約55%。收益及盈利均錄得較大幅度提升，主要受惠於床位規模及入住率增加、醫養結合及增值服務收益提升，以及部分新投運項目的貢獻。

### Individual Project Highlights

#### Guangyi Geriatric Care Center and Nursing Home

Guangyi Geriatric Care Center and Nursing Home is a reconstruction project of the local government for the benefits of the people. With a long-standing history, it has been honored with provincial and municipal demonstrative geriatric care institutions for many years. In 2025, it achieved revenue of RMB22.77 million, representing a year-on-year increase of approximately 10%, with an occupancy rate of approximately 92%. The performance growth was further driven by the related value-added services of integrated medical and geriatric care.

#### Wuhe Geriatric Care Center and Nursing Home

During the year, the Wuhe Geriatric Care Center and Nursing Home generated operating revenue of RMB7.33 million, representing a year-on-year increase of 25%, with an occupancy rate of 63%. The renovation project launched last year has been completed, and the occupancy rate has continued to rise.

#### Xuejia Aixin Geriatric Care Center and Nursing Home

In 2025, Xuejia Aixin Geriatric Care Center and Nursing Home generated operating revenue of RMB13.92 million, representing a year-on-year increase of 23%, with an occupancy rate of 79%. The facility operated smoothly and demonstrated significant growth in performance. During the year, it received approval for 106 new medical beds, bringing the total number of medical beds to 205 and laying the foundation for future growth in revenue from medical and nursing services.

#### Huifeng Geriatric Care Center

Huifeng Geriatric Care Center achieved revenue growth of approximately 62% in 2025, with an occupancy rate increased to approximately 67% after the completion of its improvement of integrated medical and geriatric care and the acquisition of a medical license. These demonstrated that the medical resources introduction and the service structure optimization have substantially boosted both occupancy rate and revenue.

#### Wuhu Golden Sun Geriatric Care Center

Wuhu Golden Sun Geriatric Care Center underwent internal renovation work in response to market demand and launched value-added services such as a new catering center which is open to the public, resulting in a year-on-year increase of revenue of approximately 35% and a further increase in the occupancy rate to approximately 96%.

### 個別項目亮點

#### 廣益養老中心及護理院

本院為地方政府惠民工程重建項目，歷史悠久，連續多年獲評為省、市示範性養老機構。二零二五年實現收入人民幣2,277萬元，同比增長約10%，入住率約92%，醫養結合相關增值服務進一步帶動業績增長。

#### 五河養老中心及護理院

本年度，五河養老中心及護理院實現營業收入人民幣733萬元，同比增長25%，入住率63%。上年度啟動的翻新改造工程已完成，入住率亦續步回升。

#### 薛家愛心養老中心及護理院

薛家愛心養老中心及護理院二零二五年實現營業收入人民幣1,392萬元，同比增長23%，入住率79%。薛家愛心養老中心及護理院運營良好，業績增長明顯。於年內新獲批106張醫療床位，令總醫療床位增至205張，為未來醫療護理服務收入增長奠定基礎。

#### 惠楓養老中心

在完成醫養結合提升及取得醫療牌照後，二零二五年收入增長約62%，入住率提升至約67%，顯示醫療資源導入及服務結構優化對入住率及收益均產生明顯拉動。

#### 蕪湖金太陽養老中心

因應市場需求進行內部改造，開辦對外助餐中心等增值服務，帶動收入同比增長約35%，入住率進一步提升至約96%。

### *Luoxi District Geriatric Care Center and Nursing Home*

Luoxi District Geriatric Care Center and Nursing Home was officially put into operation in 2024 and achieved a year-on-year increase of revenue of approximately 137% in 2025, with an occupancy rate of 60%. Since its opening, the project has maintained rapid growth in both occupancy rate and revenue, demonstrating the scale-up effect following the commencement of operations for newly contracted projects.

### *Rizhao City Investment Geriatric Care Center*

Rizhao City Investment Geriatric Care Center is a project jointly operated by the Group and a local state-owned enterprise. Located in Donggang District, Rizhao City, Shandong Province, it offers 130 beds and has already admitted over 20 seniors since its opening in October 2025, with an occupancy rate of approximately 16% at the end of the Period, and recorded revenue of RMB180,000. Positioned as a high-quality healthcare community integrating professional geriatric care, medical rehabilitation, and pleasant and comfortable living environment, it is expected that the occupancy rate of the project will steadily increase as brand recognition and the medical and geriatric care service system gradually improve.

### *Newly-signed Projects*

#### *Guangde Elderly Care Service Center Project in Anhui Province*

On 30 July 2025, Wuxi Beikang Hongtai Geriatric Services Limited\* (無錫北康宏泰養老服務有限公司), a subsidiary of the Group, successfully won the bid for the Guangde Elderly Care Service Center project in Anhui Province through an open tender. The project has a total gross floor area of approximately 10,000 square meters and is planned to provide approximately 290 beds in total with investment for construction to be provided by the Guangde Municipal Government of Anhui Province, the Group will provide professional healthcare furniture and equipment, as well as subsequent operations and management. The project is expected to take approximately 16 months to complete construction. It is expected to meet the healthcare needs of the elderly from surrounding major cities such as Shanghai and Hangzhou in the future.

## HEALTH INDUSTRIAL PARK AND INDUSTRY INVESTMENT

In respect of Health Industrial Park, guided by the concept of “industry-city integration”, the Group continues to promote the construction and operational management of the greater health industrial park projects, aiming at attracting enterprises spanning medical services, rehabilitation and nursing, intelligent geriatric care, and healthcare technology to settle in, thereby refining the supporting functions and industrial chain layout of the park. By employing a parallel model of self-operation and partnerships, the Group has introduced professional operating partners and innovative healthcare service institutions, which drives a steady increase in both occupancy rate and operational efficiency across the park.

### *羅溪養老中心及護理院*

於二零二四年正式投入運營，二零二五年收入同比增長約137%，入住率達60%。項目自開業以來入住率與收入保持較快增長，體現新簽約項目投運後的放量效應。

### *日照城投頤養中心*

為本集團與當地國有企業合作運營的項目，位於山東省日照市東港區，設有130張床位。二零二五年十月開業後已入住逾二十名長者，期末入住率約16%，並錄得收入人民幣18萬元。該項目定位為集專業養老照護、醫療康復與宜居環境於一體的高品質康養社區，預期隨著品牌認知度及醫養服務體系逐步完善，入住率將穩步提升。

### *新簽項目*

#### *安徽省廣德市養老服務中心項目*

於二零二五年七月三十日，本集團附屬公司無錫北康宏泰養老服務有限公司通過公開招標方式成功中標安徽省廣德市養老服務中心項目。該項目總建築面積約1萬平方米，總設計床位約290張，項目由安徽省廣德市政府負責投資興建，本集團負責提供專業康養家具和設備以及後期營運管理。項目預計總籌建時間約16個月。未來將承載來自上海市、杭州市等周邊大城市的老齡康養需求。

## 健康產業園及產業投資

健康產業園方面，集團以產城融合理念為指引，持續推進大健康產業園項目建設及運營管理，吸引醫療服務、康復護理、智慧養老及健康科技等企業進駐，以完善園區配套功能及產業鏈佈局。集團通過自營與合作並行模式，引入專業運營夥伴及創新型健康服務機構，帶動園區出租率與運營效率的穩步提升。

In terms of industry investment, the Group focuses on the theme of “greater health + geriatric care” and continues to identify high-quality targets with growth potential covering areas such as medical services, intelligent healthcare and elderly-friendly technology. The Group strives to enhance its comprehensive competitiveness in the geriatric care and healthcare services market across the country through equity investment and industrial synergies.

As of 31 December 2025, the Group participated in five health industry park projects with a total land area of over 400,000 square meters. The estimated value of the properties under development was approximately HK\$759,845,000, and the rental income was HK\$13,103,000. The progress of each project is as follows:

### Medical and Geriatric Products and Home Furnishing Business

#### Overview

The Medical and Geriatric Products and Home Furnishing business is a key growth driver that the Group has been actively expanding in recent years, which is mainly operated by our subsidiary, Beijing Vissam Prosperity Furniture Limited\* (北京偉森盛業家具有限公司) (“Vissam Prosperity”) and the related platforms. In 2025, this segment achieved strategic transformation and upgrade to gradually expanding from traditional medical and geriatric furniture into educational furniture market. This has formed a “dual-engine” layout with a “solid base in medical and geriatric furniture + new growth in educational furniture”.

#### Market Environment and Business Performance

In 2025, the B2B furniture market in China was characterized by “moderate recovery, structural optimization, demand differentiation, and digital+intelligence upgrades”. The Group has actively adapted to these industry trends, and steadily maintained its solid base of medical and geriatric furniture business while aggressively expanded into the educational furniture market to attain rapid growth in such niche segment.

During the Year, Vissam Prosperity successfully secured several key university and medical institution projects, including Guzhenkou Campus of China University of Petroleum (East China) project, the Dingjiaqiao and Jiulonghu Campuses of Southeast University project, the desks and chairs for logistics support at Zhengzhou University project, the Guangzhou Campus of Sun Yat-sen University project, the “Three-Chemical” classroom renovation at Jilin University project, as well as smart classrooms at the University of Health and Rehabilitation Sciences project and other key projects. Sales contracts with a contracted amount reached RMB130 million for the year, and recognized a revenue of RMB130 million with major contributions from the educational furniture segment, marking the maturity of business transformation.

#### Qualifications Development and Certifications

To support the deep expansion into the educational furniture market, the Group has continuously strengthened its related product qualification development. In 2025, it obtained new China Environmental Certifications (CEC) for metal laboratory furniture, metal teaching furniture, and metal dormitory furniture, further enhancing the professionalism and market recognition of its educational furniture products. Meanwhile, the Group continues to hold the China Forest Certification (PEFC), a Triple-A (AAA) Corporate Credit Rating, and various ISO management system certifications. These credentials provide systematic support for the large-scale development of its educational furniture business.

### 醫養產品及家具業務

#### 業務概況

醫養產品及家具業務是本集團近年積極拓展的重要增長點，主要由旗下北京偉森盛業家具有限公司(以下簡稱「偉森盛業」)及相關平台負責運營。二零二五年，該板塊實現戰略轉型升級，從傳統醫養家具逐步向教育家具市場擴展，形成「醫養家具基本盤+教育家具新增長」的雙驅動格局。

#### 市場環境及業務表現

二零二五年，中國B端家具市場呈現「溫和復蘇、結構優化、需求分化、數智升級」的總體特徵。本集團積極順應行業發展趨勢，在穩步維持醫養家具基本盤的同時，全力拓展教育家具市場，實現該細分領域的快速成長。

年內偉森盛業成功攬獲多個重點高校及醫療機構項目，包括中國石油大學(華東)古鎮口校區項目、東南大學丁家橋及九龍湖校區項目、鄭州大學後勤保障課桌椅項目、中山大學廣州校區項目、吉林大學三化教室改造項目、康復大學智慧教室項目等重點項目。全年銷售合同簽約金額達人民幣1.3億元，確認收入達人民幣1.3億元，其中教育家具貢獻佔比顯著，標誌業務轉型已步入成熟階段。

#### 資質建設與認證

為配合向教育家具市場的深度拓展，本集團持續加強相關產品資質建設。二零二五年新增中國環保認證(金屬實驗室家具、金屬教學家具、金屬公寓家具)，進一步強化教育家具產品的專業性與市場認可度。同時，繼續持有中國森林認證(PEFC)、AAA級企業信用等級及多項管理體系認證，為教育家具業務的規模化發展提供系統化支援。

### *Marketing and Brand Building*

The Group enhanced its brand influence continuously in the educational furniture sector through integrated online and offline promotion. Throughout the year, it participated in 7 industry exhibitions, hosted 423 clients, resulting in a significant progress in securing effective educational projects. The total exposure of its new media matrix exceeded 19.46 million times, effectively reinforcing its brand positioning as a “provider of healthy campus furniture solutions”.

### *Innovation and Social Responsibility*

The design team of the Company participated in the “2025 Beijing Home-Based Elderly-Friendly Renovation Design and Innovation Competition” and won the fourth prize in the “Spatial Design and Concept Solution Category”, demonstrating its forward-looking layout in the field of elderly-friendly product design. In addition, Vissam Prosperity fulfilled its corporate social responsibilities by carrying out the “Respecting Talents and Warming Hearts in Laiyuan” charity donation activity in Laiyuan County, Hebei Province, bringing warmth to the elderly locally and deepening the Group’s social value proposition of “health + care”.

## **FUTURE PROSPECT**

### **Expansion of Geriatric Care Business**

In respect of the geriatric care industry, the Group will continue to increase its investment and expansion efforts in the geriatric care industry, continuously adding new beds. The Group’s newly contracted Wuxi Ancient Canal Nursing Home and Anhui Guangde projects are progressing as planned with preliminary works such as fire safety inspections and renovations. These projects are expected to commence operations in phases starting from 2026, adding a total of approximately 740 beds, which will further expand the Group’s total number of geriatric care beds and broaden its regional footprint. At the same time, the Group has launched online value-added service platform to provide comprehensive value-added services, including elderly nutritious meals, nursing products, home-based on-site nursing services and accompanying services for medical appointment and caring. The goal is to integrate the entire geriatric care service chain of “offline beds + online services” in order to improve the comprehensive service revenue per elderly client and strengthen customer stickiness.

### *市場推廣與品牌建設*

本集團通過線上線下融合推廣，持續提升在教育家具領域的品牌影響力。全年參與行業展會7場，接待客戶423人次，獲取有效教育類項目顯著。新媒體矩陣總曝光量超過1,946萬次，有效強化「健康校園家具解決方案提供者」的品牌定位。

### *創新與社會責任*

公司設計團隊參與《2025北京市居家適老化改造設計創新大賽》，於「空間設計概念方案組」榮獲四等獎，體現其在適老化產品設計領域的前瞻佈局。此外，偉森盛業履行企業公民責任，赴河北省涿源縣開展「重陽敬才情暖涿源」愛心捐贈活動，為當地長者送溫暖，深化集團「健康+關懷」的社會價值主張。

## **未來展望**

### **養老業務拓展**

在養老產業方面，本集團將持續加大養老產業領域的投資和拓展力度，將不斷新增床位。本集團新簽約的無錫古運河護理院及安徽廣德市等項目，正按計劃推進消防驗收及裝修改造等前期工作，預期二零二六年起將陸續投運，合計新增床位規模約740張，將進一步擴大本集團養老床位總量及區域覆蓋。同時，本集團已啟用線上增值服務平台，提供老年營養餐、護理產品、上門護理服務及陪診陪護等綜合性增值服務，目標是打通「線下床位+線上服務」的全流程養老服務鏈條，提升單位長者的綜合服務收益及客戶黏性。

In the future, the Group will focus on building the “Beikang Medical and Geriatric Care” brand and continue to leverage on the advantages of our operation model “chain operation with integrated medical and geriatric care”. The Group will continue to reinforce and strengthen its core competitiveness in “chain management, standardization, specialization” and “integration of medical and geriatric care”, as well as continue its deep penetration into the Yangtze River Delta region, which is characterized by its robust economy and strong consumer demand, and to accelerate the expansion of the number of the geriatric care beds. At the same time, the Group will extend its business to the areas of elderly-friendly products and digitalized home-based geriatric care services, forming a comprehensive “point-and-surface” integrated service layout of urban geriatric care business, centered around beds for geriatric care as the core business, radiating towards product offerings and family services.

The Group’s short-to-medium-term goal is to increase the scale of geriatric care to a total capacity of 5,000 beds, with a mid-term target of exceeding 10,000 beds, and a long-term vision of achieving 100,000 beds. Meanwhile, the Group also expanded into the areas of elderly-friendly products and digitalized home care services, forming a comprehensive service layout of “point-and-surface” integrated urban geriatric care with institutional geriatric care beds as the backbone to extend its product offerings and family services, striving to become a leading group in the domestic comprehensive geriatric care service industry.

In respect of health industrial parks, in the face of uncertainties in the macro environment, the Group will not increase its investment in health parks in China for the time being. Instead, the Group will actively identify suitable partners to dispose of certain projects in a timely manner. As for the Group’s investment projects in Canada, the Group will speed up the government approval process for the Royal Tower project and prepare the preliminary work for the project’s pre-sale. Meanwhile, the Group will actively explore other development opportunities locally or overseas.

In respect of the medical and geriatric care products business, Vissam Prosperity continues to optimize its furniture business structure, consolidate its leading position in the educational furniture market, and continuously improves its medical and geriatric care furniture product lines, so as to promote the synergistic development of these two major segments. Through product upgrades in intelligence and green technology, and the enhancement of its all-scenario solution capabilities, Vissam Prosperity is committed to becoming a professional service provider of healthy learning and healthcare spaces, thereby creating sustainable returns for shareholders.

未來，本集團將重點打造「北康醫養」品牌，繼續發揮「連鎖經營、醫養結合」運營模式的優勢，持續鞏固和強化「連鎖化、標準化、專業化」和「醫養結合」的核心競爭力，將繼續深耕經濟實力強、消費需求旺的長三角地區，加快拓展養老床位。同時，將向適老化產品和數位化居家養老服務業務領域延伸，形成以養老床位為載體和業務主幹，向產品端和家庭端輻射的「點面結合」的城市養老綜合服務業務佈局。

本集團中短期目標是將養老總床位規模提升至5,000張以上，中期突破10,000張，長遠則以達至100,000張床位為願景。同時向適老化產品及數字化居家養老服務延伸，形成以機構養老床位為主幹、向產品端及家庭端輻射的「點面結合」城市養老綜合服務佈局，致力成為內地綜合養老服務行業的領先集團。

在健康產業園方面，面對宏觀環境不明朗，本集團暫不會加大於中國之健康產業園的投入，相反，本集團將積極物色合適的合作夥伴適時出售部份項目。至於本集團於加拿大的投資項目，本集團將會加快皇家山項目的政府審批手續及準備項目預售的前期工作。同時，積極拓展本港或其他海外發展機會。

在醫養產品業務方面，偉森盛業繼續優化家具業務結構，鞏固教育家具市場主導地位，並持續完善醫養家具產品線，推動兩大板塊協同發展。通過產品智慧化、綠色化升級與全場景解決方案能力的提升，致力於成為健康學習與康養空間的專業服務商，為股東創造可持續回報。

In respect of the Group's overall strategy, we will exercise stringent cost control and optimize cost effectiveness by putting resources to good use. We will manage our own capital prudently and enhance our financial position by increasing free cash income through appropriate investments in wealth management products from banks, equity and bonds. At the same time, we will also seek investment opportunities in the sports industry from time to time to add new growth drivers to our investment target of the "greater healthcare industry".

### MATERIAL INVESTMENTS

The Group had no additional material investment for the year ended 31 December 2025.

The Group is actively identifying and exploring suitable investments with potential and synergy effect to its existing businesses. The Group will only consider any potential investments which are in the interests of the Company and the shareholders as a whole. No agreement for material investment has been entered into as of the date of this report.

### MAJOR ACQUISITIONS AND DISPOSALS

The Group completed one acquisition transaction and one disposal transaction during the year, details of which are set out in Note 34 "Business combination" and Note 35 "Disposal of Subsidiaries".

### FINANCIAL REVIEW

#### Operating revenue

As of 31 December 2025, the revenue of the Group was approximately HK\$157,200,000 (2024: HK\$149,945,000), representing an increase of 4.8% as compared to 2024, which was mainly due to the moderate growth in revenue from the sales of medical and geriatric products and revenue from geriatric care business. The increase in revenue of the medical and geriatric products segment was mainly attributed to the success of the new educational furniture product line developed by the Group in previous years, with continued year-on-year increase in related sales, offsetting declines in sales of hospital and geriatric furniture. Customers for the educational furniture were mainly domestic colleges and universities, resulting in strong cash flow and lower risk of bad debts. The increase in revenue from geriatric care business was mainly due to an increase in occupancy rate.

#### Cost of Sales

Cost of sales increased slightly by HK\$482,000 to approximately HK\$114,747,000, representing an increase of less than 1% compared to the corresponding period last year. Cost of sales mainly includes cost of purchases, freight, installation fees and wage expenses.

在集團整體策略方面，我們將嚴謹管控成本，讓資源用得其所，優化成本效益。審慎管理自有資金，通過適量的銀行理財、股票及債券投資提高自由現金收益，加強本集團的財務狀況。與此同時，我們亦會不時尋覓於體育運動行業的投資機會，為我們「大健康產業」的投資目標增加新的增長動力。

### 重大投資

截至二零二五年十二月三十一日止年度，本集團並無新增任何重大投資。

本集團正積極尋找及探索潛在及具有協同效應的合適投資，以將其帶至現行的業務。本集團將只考慮以本公司及股東整體利益為依歸的任何潛在投資。截至本報告日期，並未訂立重大投資的協議。

### 主要收購及出售

本集團於年內完成一項收購交易及一項出售交易，交易詳情載於附註34「業務合併」及附註35「出售附屬公司」。

### 財務回顧

#### 營業收入

截至二零二五年十二月三十一日，本集團收入約為157,200,000港元（二零二四年：149,945,000港元），比二零二四年增加4.8%，主要是由於醫養產品銷售收入及養老業務收入相繼溫和增長。醫養產品分部的收入增加主要是本集團於早年開拓新的教育類傢俱產品線見效，相關的銷售續年增加並足以抵銷醫院類傢俱及養老類傢俱銷售的下跌。教育類傢俱的客戶均為國內各大專院校，現金流強勁及壞賬風險較低。養老業務收入增加主要是因為入住率上升所致。

#### 銷售成本

銷售成本較去年同期輕微增加482,000港元至約114,747,000港元，升幅不足1%。銷售成本主要包括採購成本、運費、安裝費及工資費用等。

### Gross Profit Margin

During the year, the overall gross profit margin of the Group was 27.0%, compared to 23.8% for the corresponding period last year, representing an increase of 3.2%. The increase in gross profit margin was mainly attributable to an increase in the proportion of orders for educational furniture products, which have higher gross profit margins.

### Other Income and Gains/(losses), Net

As of 31 December 2025, other income and gains/(losses), net amounted to approximately HK\$15,013,000 of gains, compared with a loss of HK\$15,678,000 for the same period last year. These include one-off losses incurred as of 31 December 2025, such as a loss on the disposal of a subsidiary of approximately HK\$21,369,000 and a loss on the transfer of properties under development, property, plant and equipment, and right-of-use assets to investment properties of approximately HK\$14,532,000. In addition, one-off gains were incurred, such as a gain from the disposal of a joint venture of approximately HK\$6,222,000 and reversal of impairment loss on investment in an associate of HK\$10,717,000.

Excluding the aforementioned one-off gains/losses, net other income and gains/(losses) amounted to approximately HK\$33,975,000, mainly comprising a foreign exchange gain of HK\$3,097,000 in 2025 resulting from the appreciation of the Canadian dollar against the Hong Kong dollar by approximately 4% in 2025, whereas an exchange loss of HK\$29,290,000, a fair value loss of HK\$5,435,000 on investment properties (2024: HK\$13,892,000), rental income of HK\$13,103,000 (2024: HK\$9,483,000), investment income of approximately HK\$16,180,000 (2024: HK\$5,106,000) and banks and other interest income of HK\$6,149,000 (2024: HK\$4,845,000) were recorded in 2024.

### Selling and Distribution Expenses

As of 31 December 2025, the selling and distribution expenses of the Group were approximately HK\$17,930,000 (2024: HK\$14,331,000), representing 11.4% of the total sales amount (2024: 9.6%). The selling and distribution expenses mainly comprise of remuneration of HK\$6,058,000 (2024: HK\$4,720,000), travelling expenses of HK\$910,000 (2024: HK\$726,000), promotion fee of HK\$4,091,000 (2024: HK\$3,739,000), office costs of approximately HK\$2,733,000 (2024: HK\$2,948,000) and license fees of HK\$3,009,000 (2024: HK\$1,218,000).

### 毛利率

本年度，本集團整體毛利率為27.0%，而去年同期則為23.8%，上升3.2%，毛利率上升主要由於毛利率較高的教育類傢具產品訂單比重上升所致。

### 其他收入及收益／(虧損)淨額

截至二零二五年十二月三十一日，其他收入及收益／(虧損)淨額約為15,013,000港元之收益，而去年同期則為15,678,000港元之虧損。其中截至二零二五年十二月三十一日產生一次性虧損，如出售附屬公司之虧損約21,369,000港元及發展中物業、物業、廠房及設備及使用權資產轉移至投資物業虧損約14,532,000港元，另外亦產生一次性收益，如出售合營公司之收益約6,222,000港元及聯營公司之投資減值撥回10,717,000港元。

除去上述一次性收益／虧損，其他收入及收益／(虧損)淨額約33,975,000港元，主要包括由於加拿大元兌港元於二零二五年上升約4%，以致二零二五年產生匯兌差額收益3,097,000港元，而二零二四年則產生匯兌差額虧損29,290,000港元、投資物業之公平值虧損5,435,000港元(二零二四年：13,892,000港元)、租金收入13,103,000港元(二零二四年：9,483,000港元)、投資收益約16,180,000港元(二零二四年：5,106,000港元)及銀行及其他利息收入6,149,000港元(二零二四年：4,845,000港元)。

### 銷售及分銷開支

截至二零二五年十二月三十一日，本集團之銷售及分銷開支約為17,930,000港元(二零二四年：14,331,000港元)，佔總銷售金額11.4%(二零二四年：9.6%)。銷售及分銷開支主要包括薪酬6,058,000港元(二零二四年：4,720,000港元)、差旅費用910,000港元(二零二四年：726,000港元)、推廣費用4,091,000港元(二零二四年：3,739,000港元)、辦公費用約2,733,000港元(二零二四年：2,948,000港元)及特許權費用3,009,000港元(二零二四年：1,218,000港元)。

### Administrative Expenses

As of 31 December 2025, the administrative expenses were HK\$77,217,000, representing a decrease of 4.3% in expenses as compared to HK\$80,716,000 in 2024. The administrative expenses mainly included staff costs (including directors' remuneration) of HK\$35,281,000 (2024: HK\$36,216,000), professional advisory fees of HK\$7,042,000 (2024: HK\$7,324,000), office expenses of HK\$2,743,000 (2024: HK\$4,001,000), depreciation and amortization costs of HK\$19,037,000 (2024: HK\$19,545,000), business entertainment expenses of HK\$3,108,000 (2024: HK\$2,709,000), travelling expenses of HK\$3,926,000 (2024: HK\$3,881,000) and audit expenses of HK\$1,410,000 (2024: HK\$1,954,000). Administrative expenses decreased mainly as a result of the Group's implementation of a cost saving policy, under which various administrative expenses were effectively reduced.

### Impairment Losses of Financial Assets, Net

Impairment loss on financial assets was mainly attributable to the impairment provision made against the Group's trade and other receivables. During the year, certain trade receivables and other receivables were not repaid when due. Taking into account the repayment ability of the defaulters, the Group has made a provision for impairment of the affected balances.

The significant increase in impairment losses on financial assets, net from HK\$5,751,000 in 2024 to HK\$46,392,000 in 2025 was primarily due to an additional expected credit loss ("ECL") provision of approximately HK\$45,085,000 recognised for a loan due from Borrower B (as detailed in note 23(a) to the consolidated financial statements). This substantial increase arose because the expected repayment date of the Borrower B loan was extended from within one year to within three years, reflecting a reassessment of the property sales schedule and a corresponding lengthening of the credit risk exposure period. The Group has accordingly reclassified the loan from current to non-current receivables and measured the ECL based on the revised repayment timeline.

### Other Expenses and Losses

Other expenses and losses were mainly attributable to the one-off non-cash expenses. As of 31 December 2025, the other expenses and losses of the Group was HK\$5,000 (2024: HK\$7,963,000). As of 31 December 2024, other expenses and losses mainly represent a provision for impairment of investment in an associate of approximately HK\$7,912,000, whereas a reversal on the impairment of an investment in an associate of HK\$10,717,000 was recorded in net other income and gains/(losses) in 2025.

### 行政開支

截至二零二五年十二月三十一日，行政開支為77,217,000港元，較二零二四年80,716,000港元的開支減少4.3%。行政開支主要包括員工成本（包括董事薪酬）35,281,000港元（二零二四年：36,216,000港元）、專業諮詢費7,042,000港元（二零二四年：7,324,000港元）、辦公費2,743,000港元（二零二四年：4,001,000港元）、折舊及攤銷費用19,037,000港元（二零二四年：19,545,000港元）、業務招待費3,108,000港元（二零二四年：2,709,000港元）、差旅費3,926,000港元（二零二四年：3,881,000港元）及審計費用1,410,000港元（二零二四年：1,954,000港元）等。行政開支減少主要是由於本集團實施緊縮開支政策，各項行政開支均得到有效的減少。

### 金融資產減值虧損淨額

金融資產減值虧損主要為對本集團之應收貿易賬款及其他應收款項所作之減值撥備。本年度由於部份應收貿易賬款及其他應收款項未能按期償還。經考慮到欠款人之還款能力，本集團已對受影響之餘額作出減值撥備。

金融資產減值虧損淨額由二零二四年之5,751,000港元大幅增加至二零二五年之46,392,000港元，主要原因為就借款人乙之貸款（詳見綜合財務報表附註23(a)）額外確認預期信貸虧損（「預期信貸虧損」）撥備約45,085,000港元。該大幅上升是由於借款人乙貸款之預期還款日期由一年內延長至三年內，反映對物業銷售進度之重新評估及信貸風險暴露期相應延長。本集團已將該貸款由流動應收款項重新分類為非流動應收款項，並按經修訂之還款時間表計量預期信貸虧損。

### 其他開支及虧損

其他開支及虧損主要為一次性非現金支出的費用，截至二零二五年十二月三十一日，本集團之其他開支及虧損為5,000港元（二零二四年：7,963,000港元）。截至二零二四年十二月三十一日，其他開支及虧損主要為出售為於一間聯營公司之投資減值撥備約7,912,000港元，而二零二五年則為記錄至其他收入及收益／（虧損）淨額中之聯營公司之投資減值回撥10,717,000港元。

### Finance Cost

As of 31 December 2025, the Group's total financing costs amounted to approximately HK\$2,520,000 (2024: HK\$228,000), representing an increase of more than tenfold compared with the same period last year. The significant increase was mainly attributable to the borrowing interest of approximately HK\$2,266,000 (2024: HK\$Nil) arising from the consolidation of the interest-bearing bank and other borrowings of 1121695 B.C. Ltd. in mid-year, following the Group's deemed acquisition of the Canadian joint venture, 1121695 B.C. Ltd..

### Share of Losses of a Joint Venture

Share of losses of a joint venture were mainly the share of 47.47% of loss attributable to shareholders of 1121695 B.C. Ltd. of approximately HK\$7,141,000 (2024: HK\$13,446,000). The decrease in the share of losses of joint ventures was mainly due to the reduction in interest expenses of the joint venture resulting from the decline in borrowing rates in Canada, as well as the cessation of loss sharing of 1121695 B.C. Ltd. since 24 October 2025, when it was deemed to have become a subsidiary of the Company.

### Share of Losses of Associates

Share of losses of associates mainly included the share of 25.07% of loss attributable to shareholders of Beijing Sports and Entertainment Industry Group Limited of approximately HK\$6,189,000 (2024: HK\$5,727,000) and the share of 20% of loss attributable to shareholders of Shanghai Junbo Textiles Limited\* ("Shanghai Junbo") of approximately HK\$174,000 (2024: HK\$10,277,000). The decrease in the share of losses of associates was mainly attributable to the disposal of the 20% equity interest in Shanghai Junbo in March 2025, after which the Group was no longer required to share the losses of Shanghai Junbo.

### Net Assets

As at 31 December 2025, the net assets of the Group was approximately HK\$1,753,719,000, representing an increase of approximately HK\$13,293,000 from approximately HK\$1,740,426,000 as at 31 December 2024. Excluding the generation of loss of approximately HK\$101,996,000 during the year, the net assets increased by HK\$115,289,000 as compared to 31 December 2024, which was mainly due to (i) the appreciation of Renminbi against Hong Kong dollars by approximately 2.5% in 2025, resulting in an exchange gain of HK\$37,046,000 recognised in other comprehensive income and losses of the Group; (ii) a fair value gain of HK\$11,601,000 on equity investments designated at fair value through other comprehensive income; (iii) the Group's deemed acquisition of the Company's Canadian joint venture, 1121695 B.C. Ltd., leading to a corresponding increase in non-controlling interests of HK\$50,488,000; and (iv) a corresponding increase in non-controlling interests of HK\$20,084,000 arising from the capital injection by all shareholders of the Group's non-wholly owned subsidiary, Wuxi Beikang Yiyue Health Industry Co., Ltd.\* and Rizhao Beikang Yiyue Health Industry Development Co., Ltd.\*, in proportion to their respective shareholdings.

### 融資成本

截至二零二五年十二月三十一日，本集團之總融資成本約2,520,000港元(二零二四年：228,000港元)，較去年同期大幅增加逾十倍，主要是由於本集團於年中因視作收購加拿大合營公司1121695 B.C. Ltd.而合併1121695 B.C. Ltd.之計息銀行及其他借款所產生之借款利息約2,266,000港元(二零二四年：零港元)。

### 應佔合營公司虧損

應佔合營公司虧損主要為應佔1121695 B.C. Ltd.的股東應佔虧損之47.47%約7,141,000港元(二零二四年：13,446,000港元)。應佔合營公司虧損減少主要是由於加拿大借款利率下降導致合營公司之利息支出減少以及自二零二五年十月二十四日起1121695 B.C. Ltd.已被視作為本公司之附屬公司而停止分攤1121695 B.C. Ltd.之虧損。

### 應佔聯營公司虧損

應佔聯營公司虧損主要包括應佔北京體育文化產業集團有限公司之股東應佔虧損之25.07%約6,189,000港元(二零二四年：5,727,000港元)及應佔上海駿帛紡織品有限公司(「上海駿帛」)之股東應佔虧損之20%約174,000港元(二零二四年：10,277,000港元)。應佔聯營公司虧損減少主要由於上海駿帛之20%股權已於二零二五年三月出售，自此再無需分攤上海駿帛之虧損。

### 資產淨值

於二零二五年十二月三十一日，本集團資產淨值約為1,753,719,000港元，較二零二四年十二月三十一日約1,740,426,000港元增加約13,293,000港元。除本年度產生虧損約101,996,000港元外，資產淨值較二零二四年十二月三十一日增加115,289,000港元，主要由於(i)人民幣兌港元匯率於二零二五年增值約2.5%，集團於其他全面收益虧損確認匯兌溢利37,046,000港元；(ii)指定為透過其他全面收益以公平值列賬之權益投資的公平值溢利11,601,000港元；(iii)本集團視作收購本公司加拿大合營公司1121695 B.C. Ltd.導致非控股權益相應增加50,488,000港元；及(iv)本集團非全資附屬公司無錫北康益悅健康產業有限公司及日照北康益悅健康產業發展有限公司全體股東按股權比例增資擴股導致非控股權益相應增加20,084,000港元所致。

### Liquidity and Financial Resources

As at 31 December 2025, cash and cash equivalents held by the Group was approximately HK\$140,538,000 (2024: HK\$77,865,000), and balance of wealth management products from banks was approximately HK\$79,235,000 (2024: HK\$118,441,000). Cash and cash equivalents and total balance of wealth management products from banks increased by approximately HK\$23,467,000, mainly due to the receipt in mid-year of consideration of approximately HK\$16,924,000 for the disposal of a 20% equity interest in Shanghai Junbo.

As at 31 December 2025, the Group's interest-bearing bank and other borrowings was approximately HK\$109,570,000 (2024: HK\$nil). The increase in total debt was mainly attributable to bank and other borrowings of approximately HK\$109,570,000 resulting from the acquisition of 1121695 B.C. Ltd. as a subsidiary of the Company, effective from 24 October 2025. As at 31 December 2025, the net current assets of the Group amounted to HK\$71,730,000 and the current ratio was approximately 1.3 times. The Group maintained sufficient bank credit facilities to meet working capital needs and had sufficient cash resources to finance its capital expenditure in the foreseeable future.

The Group agreed that meticulous management on cash flow is the key to success. To ensure that there is sufficient capital to satisfy the need of the Group's rapid growth, the Group remains good relationships with each of the banks from time to time, so that the Group gains easy access to application for loans.

### Capital Structure

The Group took full advantage of the financing platform as a listed company by striving for a constant optimisation of the capital and financing structure, so as to obtain sufficient funds to finance the future projects of health and geriatric care. During the year, the Group's operations were mainly financed by internal resources and bank loans.

As at 31 December 2025, the number of issued share of the Company was 6,058,772,027 shares. Equity attributable to shareholders of the Company amounted to approximately HK\$1,659,983,000 (2024: approximately HK\$1,716,111,000) and net assets per share attributable to shareholders amounted to approximately HK\$0.274 (2024: HK\$0.283).

### 流動資金及財務資源

於二零二五年十二月三十一日，本集團持有之現金及現金等值物約140,538,000港元(二零二四年：77,865,000港元)，銀行理財產品結餘約79,235,000港元(二零二四年：118,441,000港元)。現金及現金等值物及銀行理財產品總結餘增加約23,467,000港元主要由於年中收取出售上海駿昂20%股權之對價約16,924,000港元。

於二零二五年十二月三十一日，本集團之計息銀行及其他借款約109,570,000港元(二零二四年：零港元)。債務總額增加主要由於自二零二五年十月二十四日起視作收購1121695 B.C. Ltd.為本公司附屬公司所帶來的銀行及其他借款約109,570,000港元所致。於二零二五年十二月三十一日，本集團淨流動資產達71,730,000港元，流動比率為約1.3倍。本集團保持足夠銀行信貸融資以滿足營運資金需要，並持有充裕現金資源於可見未來撥付資本開支。

本集團認為審慎之現金流管理乃成功之關鍵。為確保資金足以應付本集團之快速增長，本集團不時與各銀行保持良好業務關係，以便本集團日後易於提出借貸申請。

### 資本結構

本集團充分利用作為上市公司的融資平台優勢，力求不斷優化資本及融資結構，以為未來健康及養老產業項目取得充足資金。年內，本集團的業務運作主要透過內部資源及銀行貸款提供資金。

於二零二五年十二月三十一日，本公司已發行股數為6,058,772,027股股份，本公司股東應佔權益約1,659,983,000港元(二零二四年：約1,716,111,000港元)，股東應佔每股資產淨值約0.274港元(二零二四年：0.283港元)。

### Capital Expenditure

As at 31 December 2025, the Group's capital expenditure was approximately HK\$12,528,000 (2024: HK\$6,638,000), which was mainly due to the purchase of properties, plants and equipment.

### Pledge of assets

As at 31 December 2025, the Group used properties under development in Canada as collateral for bank loans, with a total carrying amount of HK\$397,620,000 (2024: HK\$Nil).

### Contingent liabilities

As of 31 December 2025, the Group has no significant contingent liabilities.

As at 31 December 2024, the Group has contingent liabilities up to RMB28,000,000 (equivalent to approximately HK\$30,238,000) as a guarantor for the bank facility granted to an associate of the Company. The associate has utilised bank loans of approximately RMB24,235,000 (equivalent to approximately HK\$26,172,000) which is guaranteed by the Group.

### Foreign exchange risk

Majority of the subsidiaries of the Group operate in the PRC with most of the transactions denominated and settled in RMB. Fluctuations of RMB exchange rates would impact the Group's net asset value in the preparation of the Group's consolidated accounts. If RMB appreciates/depreciates against HK\$, the Group would record a(n) increase/decrease in the Group's net asset value. Also, the Group has exposure to foreign exchange risks in relation to other receivables and borrowings settled in CAD. As of 31 December 2025, in respect of the Group's exposure to potential foreign exchange risks arising from the currency exchange rate fluctuations, it did not make any arrangement or use any financial instruments to hedge against potential foreign exchange risks. However, the management will continue to monitor foreign exchange risks and adopt hedging measures where necessary.

### 資本開支

截至二零二五年十二月三十一日，本集團資本開支為約12,528,000港元(二零二四年：6,638,000港元)，主要為購置物業、廠房及設備。

### 資產抵押

於二零二五年十二月三十一日，本集團以位於加拿大之發展中物業作為銀行貸款之抵押擔保，其總賬面值為397,620,000港元(二零二四年：零港元)。

### 或然負債

截至二零二五年十二月三十一日，本集團並無重大或然負債。

於二零二四年十二月三十一日，本集團就授予本公司一間聯營公司之銀行融資作為擔保人，擁有或然負債最多人民幣28,000,000元(相當於約30,238,000港元)。該聯營公司已動用由本集團提供擔保的銀行貸款約人民幣24,235,000元(相當於約26,172,000港元)。

### 外匯風險

本集團大部分附屬公司於中國經營，且大部分交易以人民幣計值及結算。在編製本集團綜合賬目時會因人民幣匯率波動而影響本集團的資產淨值。倘人民幣兌港元出現升值／貶值，則本集團將錄得本集團資產淨值增加／減少。此外，本集團同時承受來自於以加拿大元結算的其他應收款項及借款的外匯風險。截至二零二五年十二月三十一日，本集團面對貨幣匯率波動所產生之潛在匯風險，並無作出任何安排或利用任何財務工具對沖潛在匯風險，然而，管理層將繼續監察外匯風險，並在需要時採取對沖措施。

### RELATIONSHIPS WITH EMPLOYEES, SUPPLIERS AND CUSTOMERS

The Group endeavours to maintain sustainable development in the long term, continuously create value for its employees and customers, and foster good relationships with its suppliers. The Group understands that employees are its valuable assets, and the realisation and enhancement of employees' values will facilitate the achievement of the Group's overall goals. For the year ended 31 December 2025, the Group provided generous social security benefits to its employees to motivate their proactivity at work while heightening their sense of belonging. The Group also understands the importance of maintaining good relationships with its suppliers and customers to the overall development of the Group. The Group places emphasis on supplier selection and encourages fair and open competition to foster long-term relationships with quality suppliers on the basis of mutual trust. To maintain the competitiveness of its brand and products, the Group abides by the principles of honesty and trustworthiness and commits itself to consistently providing quality products to establish a reliable service environment for its customers. For the year ended 31 December 2025, there was no significant and material dispute between the Group and its suppliers and/or customers.

### EMPLOYEES AND REMUNERATION POLICY

As at 31 December 2025, the Group had approximately 207 employees, of which 91 were males and 116 were females (2024: 179 employees, of which 80 were males and 99 were females). Total staff costs (excluding Directors' remuneration) as of 31 December 2025 amounted to approximately HK\$36,621,000 (2024: HK\$35,888,000). The Board of Directors (the “Board”) of the Company is pleased to present this Corporate Governance Report in the Group’s Annual Report for the year ended 31 December 2025.

The manner in which the principles and code provisions in the Corporate Governance Code (the “CG Code”) contained in Appendix C1 to the Rules Governing the Listing of Securities (the “Listing Rules”) on The Stock Exchange of Hong Kong Limited (the “Stock Exchange”) are applied and implemented is explained below.

### CORPORATE GOVERNANCE

The Group acknowledges the vital importance of good corporate governance to the Group’s success and sustainability. We are committed to achieving a high standard of corporate governance as an essential component of quality and have introduced corporate governance practices appropriate to the conduct and growth of our business.

The Company has applied most of the principles set out in the CG Code.

The Company has adopted different measures to ensure a high standard of corporate governance and has put in place corporate governance practices that are considered to be relevant to the Group, to meet the CG Code.

Throughout the year ended 31 December 2025, the Company has complied with the code provisions as set out in the CG Code.

The Company has reviewed its corporate governance practices and has taken appropriate actions to comply with the CG Code which are explained in the relevant paragraphs of the Report.

### CORPORATE CULTURE AND STRATEGY

The Company’s mission is to restore health, wishing all stakeholders to live a healthy life and providing multi-scenario healthy living packages. Its vision is to become a leader in the geriatric care and health industry in China as well as the preferred partner for customers and other stakeholders. To achieve this long-term vision, the Company focuses its attention on certain strategic areas, including investing in beds of geriatric care institutions and nurturing professional talents.

Full particulars of such public censure and the director unsuitability statement imposed on Mr. Siu were set out in the regulatory announcement published by the Stock Exchange on 8 October 2025.
- Mr. Tse Man Kit, Keith, an Independent Non-executive Director of the Company, was appointed as an independent non-executive director of China High Speed Transmission Equipment Group Co., Ltd. (HKEX Stock Code: 658) with effect from 16 January 2026.

Each Director is normally able to seek independent professional advice in appropriate circumstances at the Company's expenses, upon making request to the Board.

Currently, the Chairman of the Board is Mr. Zhu Shi Xing and the Chief Executive Officer of the Group is Mr. Liu Xue Heng. The roles of Chairman on the one hand and the Chief Executive Officers on the other hand are segregated and their respective responsibilities are clearly defined and set out in writing.

The Chairman's principal role is to provide leadership for the Board on corporate and strategic planning, ensure proper proceedings of the Board and encourage all Directors to have active contributions to the Board's affairs.

The day-to-day management, administration and operation of the Company are delegated to the Chief Executive Officer and the senior management. The delegated functions and responsibilities are periodically reviewed. Approval has to be obtained from the Board prior to any significant transactions entered into by the aforesaid officers.

### Independent Non-executive Directors

Every Independent Non-executive Director is appointed for a specific term of 3 years under his letter of appointment. All Directors including Independent Non-executive Directors are subject to retirement by rotation and eligible for re-election at the annual general meeting of the Company at least once every three years in accordance with the Articles of Association of the Company. The Company has issued formal letter of appointments to its Independent Non-executive Directors setting out key terms of their appointments.

According to code provision B.2.3 of the CG Code, if an independent non-executive director has served more than nine years, such director's further appointment should be subject to a separate resolution to be approved by the Shareholders. Three Independent Non-executive Directors (being Mr. Tse Man Kit, Keith, Mr. Wu Yong Xin and Mr. Zhang Yun Zhou) have been appointed as Independent Non-executive Directors for more than 9 years since 2024. The Company has received annual confirmations of independence from each of the existing Independent Non-executive Directors in accordance with Rule 3.13 of the Listing Rules. Taking into consideration of three Independent Non-executive Directors' independent scope of work in the past years, the Board considers all of them to be independent under the Listing Rules despite the fact that they have served the Company for more than 9 years. The three Independent Non-executive Directors have confirmed that they will continue to devote sufficient time for the discharge of their functions and responsibilities as Independent Non-Executive Directors. With their background, the three Independent Non-executive Directors are fully aware of the responsibilities and expected amount of time dedicated to the Company. Based on the foregoing, the Board believes that their positions outside the Company will not affect them in maintaining their current roles in, and their functions and responsibilities for the Company. The Board also believes that their continued tenure will bring considerable stability to the Board and the Board has benefited greatly from the presence of all of them who have over time gained valuable insight of the Group.

每名獨立非執行董事乃根據其委任函按三年的特定任期獲委任。根據本公司組織章程細則，包括獨立非執行董事在內之全體董事須至少每三年輪值退任一次，並於本公司股東週年大會合資格重選連任。本公司已向其獨立非執行董事發出正式委任函，當中載有董事委任之主要條款。

根據企業管治守則的守則條文B.2.3，倘獨立非執行董事任職逾九年，任何進一步委任有關董事須經股東以獨立決議案批准。於二零二四年起三名獨立非執行董事謝文傑先生、吳永新先生及張運周先生均已獲委任為獨立非執行董事逾九年。根據上市規則第3.13條，本公司已接獲現任獨立非執行董事各自的年度獨立確認書。經計及三名獨立非執行董事往年之獨立工作範疇，董事會認為儘管彼等已服務本公司逾九年，彼等全體均屬上市規則下的獨立人士。三名獨立非執行董事經已確認彼等將繼續奉獻充足時間履行彼等作為獨立非執行董事之職責。基於其背景，三名獨立非執行董事均充分了解彼等對本公司的責任及預期投入時間。基於前文所述，董事會相信，彼等於本公司以外的職務不會影響彼等目前於本公司擔任的職務以及履行其職責。董事會亦相信，彼等繼續其任期可令董事會穩定性顯著提高，而董事會亦因彼等於在任時對本集團所累積的長期寶貴見解而大為受益。

During the year ended 31 December 2025, the Board has reviewed and monitored the training and continuous professional development of Directors and senior management. The Board has also reviewed and ensured compliance of the relevant legal and regulatory requirements, the code of conducts, the CG Code and the disclosure in this Corporate Governance Report.

Pursuant to the requirements of the code provisions set out in the CG Code, all Directors are required to provide to the Company with records of the training they received to ensure that their contributions to the Board remains informed and relevant.

### MODEL CODE FOR SECURITIES TRANSACTIONS

The Company has adopted the Model Code for Securities Transactions by Directors of Listed Issuers (the "Model Code") as set out in Appendix C3 to the Listing Rules.

Specific enquiry has been made of all the Directors and the Directors have confirmed that they have complied with the Model Code throughout the year ended 31 December 2025.

The Company has applied the Model Code to the relevant employees who are likely to be in possession of unpublished price-sensitive information of the Company. No incident of non-compliance of the Model Code by the relevant employees was noted by the Company.

### BOARD COMMITTEES

The Board has established four committees, namely, the Audit Committee, the Remuneration Committee, the Nomination Committee and the Investment and Risk Management Committee, for overseeing particular aspects of the Company's affairs. All Board committees of the Company are established with defined written terms of reference. The terms of reference of the Board committees are posted on the Company's website and the Stock Exchange's website and are available to shareholders upon request.

The majority of the members of each Board committee are Independent Non-executive Directors (except for the Investment and Risk Management Committee) and the current list of the chairman and members of each Board committee is set out under "Corporate Information" on page 2.

Board committees are provided with sufficient resources to discharge their duties and, upon reasonable request, are able to seek independent professional advice in appropriate circumstances at the Company's expense.

### 董事委員會

### Audit Committee

The Audit Committee currently comprises four members, namely, Mr. Tse Man Kit, Keith (Chairman of the Committee), Mr. Zhang Yun Zhou, Mr. Wu Yong Xin and Ms. Yang Xiao Yan. All of them are Independent Non-executive Directors (including one Independent Non-executive Director with the appropriate professional qualifications or accounting or related financial management expertise). None of the members of the Audit Committee is a former partner of the Company's existing external auditors.

The main duties of the Audit Committee include the following:

- To review the financial statements and reports and consider any significant or unusual items raised by the internal auditor or external auditors before submission to the Board
- To review the relationship with the external auditors by reference to the work performed by the auditors, their fees and terms of engagement, and make recommendations to the Board on the appointment, re-appointment and removal of external auditors
- To review the adequacy and effectiveness of the Company's financial reporting system, internal control system and risk management system and associated procedures

The Audit Committee held two meetings during the year to review the financial results and reports, financial reporting and compliance procedures, the report of the internal auditor on the Company's internal control and risk management systems and processes, the reappointment of the external auditors and arrangements for employees to raise concerns about possible improprieties.

The Company's annual results for the year ended 31 December 2025 have been reviewed by the Audit Committee.

The Audit Committee also met the external auditors two times without the presence of the Management.

### Remuneration Committee

The primary objectives of the Remuneration Committee include making recommendations on and approving the remuneration policy and structure and remuneration packages of the Directors and the senior management. The Remuneration Committee is also responsible for establishing transparent procedures for developing such remuneration policy and structure to ensure that no Director or any of his associates will participate in deciding his own remuneration, which remuneration will be determined by reference to the performance of the individual and the Company as well as market practice and conditions.

During the year ended 31 December 2025, the Remuneration Committee met once to review the remuneration policy and structure of the Company, and the remuneration packages of the Directors and senior management and other related matters.

The details of the remuneration of the Directors and senior management of the Company are set out in notes 8 and 9 to the consolidated audited financial statements.

### Nomination Committee

The Nomination Committee currently comprises five members, namely, Mr. Wu Yong Xin (Chairman of the Committee), Mr. Zhu Shi Xing, Mr. Tse Man Kit, Keith, Mr. Zhang Yun Zhou and Ms. Yang Xiao Yan. The majority of them are Independent Non-executive Directors.

Principal duties of the Nomination Committee include reviewing the Board composition, identifying suitable candidates for appointment as Directors and making recommendations to the Board on the appointment and succession planning of Directors.

In assessing the Board composition, the Nomination Committee would take into account various aspects set out in the Board Diversity Policy, including but not limited to gender, age, cultural and ethnicity, in addition to educational background, professional experience, skills, knowledge and length of service. The Nomination Committee would discuss and agree on measurable objectives for achieving diversity on the Board, where necessary, and recommend them to the Board for adoption.

During the year ended 31 December 2025, the Nomination Committee met once to review the structure, size and composition of the Board to ensure that it has a balance of expertise, skills and experience appropriate for the requirements of the business of the Company.

In accordance with Article 108 of the Articles of Association, Mr. Gu Shan Chao, Mr. Wang Zheng Chun and Mr. Zhang Yun Zhou shall retire by rotation at the Annual General Meeting. All of the above retiring Directors, being eligible, will offer themselves for re-election at the Annual General Meeting.

The Nomination Committee recommended the re-appointment of the Directors standing for re-election at the forthcoming annual general meeting of the Company.

The Company's circular dated 29 April 2026 contains detailed information of the Directors standing for re-election.

### *Board Diversity Policy*

The Company has adopted a board diversity policy (the "Board Diversity Policy") setting out the approach to achieve diversity on the Board.

The Company recognizes the importance of having a diverse team of Board members, which is an essential element in maintaining an effective Board and enhancing corporate governance standard. The Nomination Committee of the Company is delegated the authority (amongst other things) to review and assess the diversity of the Board, with the objective of maintaining an appropriate mix and balance of skills, knowledge, experience and diversity of perspectives on the Board which are appropriate to the requirements of the Company's business.

Selection of candidates will be based on a range of diversity perspectives, including but not limited to skills, knowledge, industry and professional experience, cultural and educational background, gender, age and length of service. The ultimate decision will be based on merit and contribution that the selected candidates will bring to the Board. The Nomination Committee shall discuss and where necessary, agree on the measurable objectives for achieving diversity on the Board and make recommendation to the Board. The Board may adopt and/or amend from time to time (as applicable) such diversity perspectives and/or measurable objectives that are appropriate to the Company's business and Board succession planning, as applicable.

The Nomination Committee has reviewed the implementation and effectiveness of the Board Diversity Policy and the Director Nomination Policy and considered that they remain effective and appropriate for the Company.

### **Investment and Risk Management Committee**

The Board of the Group has overseen the management in the design, implementation and monitoring the risk management and internal control system. The Board has confirmed that it is its duty to establish a risk management and internal control system, and that it will constantly oversee the system and ensure a regular review of the effectiveness of the system will be conducted at least once a year.

The Board and the Audit Committee of the Company have also confirmed that during the reporting period, they have reviewed the effectiveness of the risk management and internal control systems of the Group and its subsidiaries, covering all important control aspects including financial control, operational control and compliance control.

During the reporting period, the Board and the Audit Committee of the Company have evaluated the effectiveness of the risk management and internal control system, the procedures of which include:

- (1) To determine the extent of the system, identify risks and prepare risk checklists;
- (2) To assess and prioritize the impacts of the risks based on their impacts on the operational efficiency, sustainable development capability and reputation in accordance with the generally accepted risk management framework, with reference to the probability of various types of potential risks, the extent of the management's concerns and the possible financial loss arising from the risks;
- (3) To ensure risk management measures are in place to identify significant risks, to conduct internal control evaluation on the design and implementation of such risk management measures and to take actions to rectify the control gaps;
- (4) To conduct a regular review and summary on the effectiveness of the risk management and internal control system through evaluation on the significant risks and implementation of rectification measures carried out by the management, so as to maximize and continuously enhance the risk management;
- (5) To prepare a risk management manual that determines the duties and responsibilities of management, board of directors and Audit Committee in risk management, and to provide guideline for constantly monitoring the risk management and internal control system;
- (6) The management has reported to the Audit Committee on the results of regular review and evaluation on the risk management, internal control systems, significant risk factors and corresponding measures during the reporting period.

Nevertheless, the risk management and internal control system is designed to manage rather than eliminate the risks that arising from unsuccessful business objectives, and only to make reasonable, but not absolute assurances for the non-material misrepresentation or losses.

As to the procedures and internal controls for handling and disseminating the inside information, the Company:

- is aware of its obligations under the Securities and Futures Ordinance and the Listing Rules, and the overriding principle of dealing with the inside information is to make announcement immediately after such information comes to its attention and/or a relevant decision has been made, unless such information falling within the provision of “Safe Harbours” as provided in the Securities and Futures Ordinance;
- conducts its affairs in strict compliance with the “Guidelines on Disclosure of Inside Information” issued by the Securities and Futures Commission in June 2012;
- has established and implemented procedures for responding to external enquiries about the Group’s affairs. Senior executives of the Group are designated and authorised to act as the Company’s spokespersons and respond to specific enquiries;
- has implemented and disclosed its own Code of Conduct for share transaction by relevant employee and inside information disclosure policy.

The Company has set up an internal audit function and engaged professional consultants to assist in the risk identification and evaluation so as to formulate its risk management measure. The Company has evaluated the design and implementation of internal control measures for significant risks. The Board has reviewed the effectiveness of the risk management and internal control system and considered it is effective and adequate and will continue to enhance the effectiveness in the coming future.

### Whistleblowing Policy

In compliance with code provision D.2.6 of the CG Code, the Board adopted a Whistleblowing Policy on 30 December 2022. It provides employees and the relevant third parties who deal with the Group (e.g. customers, suppliers, creditors and debtors) with guidance and reporting channels on reporting any suspected improprieties in any matters related to the Group directly addressed to the designated person.

An email account (enquiry@bjhl.com.hk) has been set up for this purpose. All reported matters will be investigated independently and, in the meantime, all information received from a whistleblower and its identity will be kept confidential.

The Board and the Audit Committee will regularly review the Whistleblowing Policy and mechanism to improve its effectiveness.

### Anti-bribery and Anti-corruption Policy

In compliance with the new code provision D.2.7 of the CG Code, the Board adopted an Anti-Bribery and Anti-Corruption Policy on 30 March 2022. It outlines guidelines and the minimum standards of conducts, all applicable laws and regulations in relation to the anti-corruption and anti-bribery, the responsibilities of employees to resist fraud, to help the Group defend against corrupt practices and to report any reasonably suspected case of fraud and corruption or any attempts thereof, to the management or through an appropriate reporting channel. The Group would not tolerate all forms of bribery and corruption among all employees and those acting in an agency or fiduciary capacity on behalf of the Group, and in its business dealing with third parties.

The Board and the Audit Committee will review the Anti-Bribery and Anti-Corruption Policy and mechanism periodically to ensure its effectiveness and enforce the commitment of the Group to the prevention, deterrence, detection and investigation of all forms of Bribery and corruption.

### SHAREHOLDERS' RIGHTS

To safeguard shareholder interests and rights, a separate resolution is proposed for each substantially separate issue at shareholder meetings, including the election of individual directors. All resolutions put forward at shareholder meetings will be voted on by poll pursuant to the Listing Rules and poll results will be posted on the websites of the Company and of the Stock Exchange after each shareholder meeting.

### Convening an Extraordinary General Meeting by Shareholders

Pursuant to Article 64 of the Company's Articles of Association, an extraordinary general meeting shall be called by the Board on the written requisition of any one or more shareholders of the Company, provided that such shareholders held at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company carrying the right of voting at general meetings of the Company. Such meeting shall be called for the transaction of any business specified in the written requisition to the Board or the Secretary of the Company; and shall be held within two months after the deposit of such requisition. If within twenty-one days of such deposit the Board fails to proceed to convene such meeting, the requisitionist(s) himself (themselves) may do so in the same manner, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to the requisitionist(s) by the Company.

董事會及審核委員會將定期審閱反賄賂和反貪污政策及機制，以確保其成效，並履行本集團對防止、遏止、偵測及調查所有形式的賄賂及貪污的承諾。

### 股東權利

為保障股東的利益及權利，本公司會於股東大會上就每項實質獨立事項(包括選舉個別董事)提呈獨立決議案。於股東大會上提呈之所有決議案將根據上市規則投票表決，投票結果將於各股東大會結束後於本公司及聯交所網站刊登。

### 股東召開股東特別大會

根據本公司組織章程細則第64條，董事會須應一名或多名本公司股東之書面要求召開股東特別大會，惟該等股東於提交要求之日，須持有有權於本公司股東大會上投票之本公司實繳股本不少於十分之一。該大會應予召開，以處理董事會或公司秘書接獲之書面要求列明之任何業務，並應於提交該項要求起計兩個月內舉行。倘於該項要求經已提交二十一日，而董事會未能著手召開該大會，則提出要求者本人(彼等)可以相同方式召開大會，而本公司須向提出要求者償付提出要求者因董事會未能召開股東大會而產生之所有合理開支。

# Directors' Report

## 董事會報告

The Directors present their annual report and the audited consolidated financial statements of the Company for the year ended 31 December 2025.

### PRINCIPAL ACTIVITIES AND BUSINESS REVIEW

The Company acts as an investment holding company. The activities of its principal subsidiaries are set out in note 1 to the consolidated financial statements.

Further discussion and analysis of the business review as required by Schedule 5 to the Hong Kong Companies Ordinance, including future development in the Group's business, can be found in the "Management Discussion and Analysis" section of this annual report. The above section forms part of this "Directors' Report".

### POSSIBLE RISK EXPOSURE

The financial condition, results of operation, business and prospects of the Group could be affected by certain risks and uncertainties. The following are the main risks and uncertainties identified by the Group. In addition, there may be other risks and uncertainties that the Group has not yet discovered or currently regards as immaterial, and these risks and uncertainties may have a significant impact on the Group in the future.

#### Risk of Investment Decisions

**Risk Analysis:** In line with the Group's development strategies focused on acquiring and operating geriatric care institutions, the selection of high-quality projects and the scientific rigor of investment decisions are critical. Incorrect assessments of market demand, regulatory approvals, operational viability, or partnership reliability could lead to capital misallocation, suboptimal returns, or project failures, adversely impacting the Group's financial health and growth trajectory.

**Tackling Measures:** The Group adheres to a stringent, multi-stage investment appraisal process. This includes comprehensive due diligence covering legal, financial, operational, and market aspects. We leverage both internal expertise and external professional advisors. Investment decision indicators are regularly reviewed against corporate strategy. Furthermore, we maintain close communication with relevant government authorities and industry partners to stay informed on policy directions and local market dynamics, thereby improving the accuracy of our forecasts and project entry timing.

### 可能面對的風險

本集團的財務狀況、經營業績、業務及前景或會受到一定風險及不確定因素影響。以下為本集團已識別的主要風險及不確定因素。另外，可能有其他本集團尚未發現或目前尚不重大的風險及不確定因素，而該等風險及不確定因素日後可能對本集團有重大影響。

#### 投資決策風險

**風險分析：**本集團專注於收購及運營老年護理機構的發展策略，優質項目的選擇及投資決策的科學嚴謹性至關重要。若對市場需求、監管審批、運營可行性或合作夥伴可靠性評估不當，可能導致資本配置失當、回報欠佳或項目失敗，從而對本集團的財務狀況及增長軌跡造成不利影響。

**應對措施：**本集團遵循嚴格的多階段投資評估流程。這包括涵蓋法律、財務、運營及市場層面的全面盡職調查。我們善用內部專業知識及外部專業顧問。投資決策指標會定期對照企業戰略進行審視。此外，我們與相關政府部門及行業合作夥伴保持密切溝通，及時了解政策方向及地方市場動態，從而提高預測準確性及項目進入時機的把握。

### Market and Operational Risk

**Risk Analysis:** The Group's medical and geriatric furniture business operates primarily on a business-to-business model. Economic fluctuations, changes in corporate customer procurement budgets, and intensified competition could lead to reduced order volumes, frequency, or pressure on profit margins. Furthermore, the operational performance of our geriatric care facilities is subject to risks related to occupancy rates, staffing costs, and service quality standards.

**Tackling Measures:** We proactively engage with major clients to understand their long-term needs and strengthen partnerships. The Company continuously collects and analyses industry information to monitor market trends and competitor activities. Internally, we focus on operational excellence, cost control, and service quality enhancement to maintain competitiveness. The Group is also exploring innovative service models and technological applications to diversify revenue streams and improve operational efficiency across all business segments.

### Regulatory and Policy Risk

**Risk Analysis:** The healthcare and elderly care sectors in China are heavily influenced by national and local regulations, including licensing, pricing, service standards, and subsidy policies. Changes in these policies, or inconsistencies in enforcement across different regions, could affect the Group's compliance costs, operational models, and profitability.

**Tackling Measures:** The Group has established a dedicated function to monitor developments in healthcare, elderly care, and related economic policies at all government levels. We maintain an active dialogue with industry associations, peer entities, and regulatory bodies to understand policy intentions and implementation details. This intelligence is used to adapt our business strategies and operational plans promptly. We also invest in robust compliance systems and training to ensure our operations meet all legal and regulatory requirements.

### Foreign Exchange Risk

**Risk Analysis:** As the Group's overseas investments (notably in Canada) form part of its portfolio, the translation of overseas earnings and asset values into the Group's reporting currency (Hong Kong Dollars) is exposed to fluctuations in foreign exchange rates, which may cause volatility in reported financial results.

**Tackling Measures:** The Company's finance team closely monitors foreign exchange market trends. While our primary focus is on operational performance, we maintain an awareness of financial hedging instruments. The Board and management will consider applying appropriate hedging strategies in consultation with financial advisors if and when the scale of foreign currency exposure reaches a level that warrants such action, with the aim of mitigating material adverse effects on the Group's financials.

### 市場與運營風險

**風險分析：**本集團的醫療及老年家具業務主要採用企業對企業模式。經濟波動、企業客戶採購預算變化及競爭加劇可能導致訂單數量減少、訂單頻率下降或利潤率受壓。此外，本集團老年護理機構的運營業績受到入住率、員工成本及服務質量標準相關風險的影響。

**應對措施：**我們積極與主要客戶溝通，了解其長期需求並加強合作關係。公司持續收集及分析行業資訊，以監測市場趨勢及競爭對手動態。在內部，我們專注於卓越運營、成本控制及服務質量提升，以保持競爭力。本集團亦正探索創新服務模式及技術應用，以多元化收入來源並提升所有業務板塊的運營效率。

### 監管與政策風險

**風險分析：**中國的醫療及養老服務業受到國家及地方法規的重大影響，包括許可證、定價、服務標準及補貼政策等。這些政策的變動，或不同地區執法不一致，可能影響本集團的合規成本、運營模式及盈利能力。

**應對措施：**本集團已設立專職部門，監察各級政府在醫療、養老及相關經濟政策方面的發展動態。我們與行業協會、同業實體及監管機構保持積極對話，以了解政策意圖及實施細節。這些資訊將用於及時調整我們的業務策略及運營計劃。我們亦投資於健全的合規體系及培訓，以確保運營符合所有法律法規要求。

### 外匯風險

**風險分析：**由於本集團的海外投資（特別是在加拿大）構成其投資組合的一部分，將海外收益及資產價值折算為本集團的報告貨幣（港幣）時，會受到外匯匯率波動的影響，這可能導致報告財務業績出現波動。

**應對措施：**本公司財務團隊密切監察外匯市場走勢。雖然我們主要關注運營業績，但亦對金融對沖工具保持關注。董事會及管理層將在諮詢財務顧問後，若外幣風險敞口規模達到需要採取行動的水平，考慮應用適當的對沖策略，以減輕對本集團財務狀況的重大不利影響。

### Reputational Risk

Risk Analysis: As a provider of healthcare and elderly care services, the Group's reputation is paramount. Any incident related to service quality, patient safety, data privacy, or corporate governance could severely damage public trust, leading to regulatory scrutiny, loss of clients, and negative financial impact.

Tackling Measures: The Group has zero tolerance for compromises on quality and safety. We enforce stringent operational protocols, regular audits, and continuous staff training. A comprehensive crisis management and communication plan is in place to respond effectively to any potential incident. Our Whistleblowing Policy and Anti-Bribery and Anti-Corruption Policy further reinforce our commitment to ethical conduct and good governance, which are fundamental to safeguarding our reputation.

### RESULTS AND APPROPRIATIONS

The results of the Company and its subsidiaries (collectively known as the "Group") for the year ended 31 December 2025 are set out in the consolidated statement of profit or loss and other comprehensive income on pages 68 to 70.

The Directors do not recommend the payment of any dividend for the year. The Board believes in balancing returns to shareholders with investment to support future growth and has decided that it would be in the Group's best interests to reserve sufficient financial resources for future business developments.

### Dividend Policy

The Board adopted a dividend policy on 29 March 2019 (the "Dividend Policy"). According to the Dividend Policy, when determining whether to declare any dividend in the future and the amount of dividend to be declared, the Company shall consider a number of factors, including but not limited to:

- the Group's actual and expected financial results;
- the general economic conditions and other internal or external factors that may have an impact on the business or financial performance and position of the Company;
- the Company's business operation strategy, including expected working capital requirements, capital expenditure requirements and future expansion plans;
- the Company's liquidity position;
- retained earnings and distributable profit reserves of the Company;

### 聲譽風險

風險分析：作為醫療及養老服務提供者，本集團的聲譽至關重要。任何與服務質量、患者安全、數據隱私或公司治理相關的事件，均可能嚴重損害公眾信任，導致監管審查、客戶流失及負面財務影響。

應對措施：本集團對質量及安全的妥協持零容忍態度。我們執行嚴格的運營規程、定期審計及持續員工培訓。我們已制定全面的危機管理及溝通計劃，以有效應對任何潛在事件。我們的《舉報政策》及《反賄賂及反貪腐政策》進一步強化了我們對道德行為及良好治理的承諾，這是維護我們聲譽的基礎。

### 業績及分配

本公司及其附屬公司（統稱「本集團」）截至二零二五年十二月三十一日止年度之業績載於第68至70頁之綜合損益及其他全面收益表內。

董事並不建議就本年度派付任何股息。董事會相信我們必須在股東回報和投資未來增長之間作出平衡，並已決定保留足夠財務資源供未來業務發展符合本集團的最佳利益。

As at 31 December 2025, the Company's reserves available for distribution amounted to HK\$807,794,000 which consisted of share premium of HK\$1,773,257,000 net of accumulated losses of HK\$965,463,000.

### SHARE CAPITAL AND SHARE OPTIONS

The Group recognised an allowance for expected credit losses ("ECLs") for other receivables at amortised cost and subject to impairment under the general approach in accordance with HKFRS 9. The carrying amount of other receivables of approximately HK\$145 million as of 31 December 2025 was material to the consolidated financial statements. #### Goodwill impairment 商譽減值

In accordance with Hong Kong Accounting Standard (“HKAS”) 36 *Impairment of Assets*, the Group is required to annually test the amount of goodwill for impairment. This annual impairment test was significant to our audit because the net carrying amount of goodwill of approximately HK\$80 million as of 31 December 2025 was material to the consolidated financial statements. The recoverable amount has been determined by reference to the higher of fair value less costs of disposal and value in use of each relevant cash-generating unit (“CGU”). When assessing the recoverable amount, significant judgement and estimation were involved, such as identifying comparable market transactions in determining the fair value less costs of disposal of the CGU and estimating the future cash flow and discount rate in determining the value in use of the CGU. These estimates and assumptions are subject to risk and uncertainty.

#### How our audit addressed the key audit matter

We obtained an understanding of the Group's reference of market transaction and assessed the comparability. We obtained an understanding of the Group's impairment testing methodology and involved our internal valuation specialists in evaluating the methodology, assumptions and parameters such as discount rate, and terminal growth rate of the relevant cash-generating unit used by the valuer and the Group. We assessed key assumptions including budgeted gross margin and growth rate by companies to the historical performance of the related cash-generating unit. We performed sensitivity analysis, which included assessing the effect of reasonably possible reductions in growth rate and increase of discount rate. We also reviewed the disclosures in relation to the Group's goodwill impairment.

### 1. CORPORATE AND GROUP INFORMATION

Beijing Health (Holdings) Limited (the “Company”) is a limited liability company incorporated in the Cayman Islands and its shares have been listed on the Main Board of The Stock Exchange of Hong Kong Limited (the “Stock Exchange”) since 26 April 2002. ### 2. ACCOUNTING POLICIES

#### 2.1 Basis of preparation

These consolidated financial statements have been prepared in accordance with HKFRS Accounting Standards (which include all Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards (“HKASs”) and Interpretations) as issued by the Hong Kong Institute of Certified Public Accountants (“HKICPA”) and the disclosure requirements of the Hong Kong Companies Ordinance. They have been prepared under the historical cost convention, except for investment properties, financial assets at fair value through profit or loss, equity investments designated at fair value through other comprehensive income, and debt investment at fair value through other comprehensive income which have been measured at fair value. These consolidated financial statements are presented in Hong Kong dollars (“HK\$”) and all values are rounded to the nearest thousand except when otherwise indicated.

#### *Basis of consolidation*

The consolidated financial statements include the financial statements of the Company and its subsidiaries (collectively referred as the “Group”) for the year ended 31 December 2025. A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

General, there is a presumption that a majority of voting rights results in control. When the Company has, less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- (a) the contractual arrangement with the other vote holders of the investee;
- (b) rights arising from other contractual arrangements; and
- (c) the Group’s voting rights and potential voting rights.

The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases.

### 2. 會計政策

#### 2.1 編製基準

該等綜合財務報表乃根據香港會計師公會(「香港會計師公會」)頒佈的香港財務報告準則會計準則(當中亦包括所有香港財務報告準則、香港會計準則(「香港會計準則」)及詮釋)及香港公司條例之披露規定編製。該等財務報表已根據歷史成本常規編製，惟按公平值計量的投資物業、透過損益以公平值列賬之金融資產、指定為透過其他全面收益以公平值列賬之權益投資及透過其他全面收益以公平值列賬之債權投資除外。該等綜合財務報表以港元(「港元」)呈列，而除另有指明外，所有數值均調整至最接近的千位數。

#### *綜合基準*

綜合財務報表包括本公司及其附屬公司(統稱為「本集團」)截至二零二五年十二月三十一日止年度的財務報表。附屬公司為本公司直接或間接控制的實體(包括結構性實體)。當本集團因參與投資對象的業務而可或有權獲得可變回報，並有能力透過對投資對象的權力(即賦予本集團目前主導投資對象相關業務的能力的現有權利)影響該等回報時，則視為擁有控制權。

一般而言，假設大多數投票權導致控制權。倘本公司擁有少於投資對象大多數投票或類似權利，則本集團於評估其是否擁有對投資對象的權力時會考慮一切相關事實及情況，包括：

- (a) 與投資對象其他投票持有人的合約安排；
- (b) 其他合約安排所產生的權利；及
- (c) 本集團的投票權及潛在投票權。

附屬公司的財務報表乃按與本公司一致的報告期及會計政策編製。附屬公司的業績由本集團取得控制權當日起綜合計算，並繼續綜合計算，直至該控制權終止之日為止。

##### *Basis of consolidation (continued)*

Profit or loss and each component of other comprehensive income are attributed to the owners of the parent of the Group and to the non-controlling interests, even if this results in the non-controlling interests having a deficit balance. All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control described above. A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction.

If the Group loses control over a subsidiary, it derecognises the related assets (including goodwill), liabilities, any non-controlling interest and the exchange fluctuation reserve; and recognises the fair value of any investment retained and any resulting surplus or deficit in profit or loss. The Group's share of components previously recognised in other comprehensive income is reclassified to profit or loss or retained profits, as appropriate, on the same basis as would be required if the Group had directly disposed of the related assets or liabilities.

#### 2.2 Changes in accounting policies and disclosures

The Group has adopted amendments to HKAS 21 *Lack of Exchangeability* for the first time for the current year's financial statements. The Group has not early adopted any other standard or amendment that has been issued but is not yet effective.

Amendments to HKAS 21 specify how an entity shall assess whether a currency is exchangeable into another currency and how it shall estimate a spot exchange rate at a measurement date when exchangeability is lacking. The amendments require disclosures of information that enable users of financial statements to understand the impact of a currency not being exchangeable. As the currencies that the Group had transacted in and the functional currencies of overseas subsidiaries, joint ventures and associates for translation into the Group's presentation currency were exchangeable, the amendments did not have any impact on the Group's financial statements.

Further information about those HKFRS Accounting Standards that are expected to be applicable to the Group is described below.

HKFRS 18 replaces HKAS 1 *Presentation of Financial Statements*. While a number of sections have been brought forward from HKAS 1 with limited changes, HKFRS 18 introduces new requirements for presentation within the statement of profit or loss, including specified totals and subtotals. Entities are required to classify all income and expenses within the statement of profit or loss into one of the five categories: operating, investing, financing, income taxes and discontinued operations and to present two new defined subtotals. It also requires disclosures about management-defined performance measures in a single note and introduces enhanced requirements on the grouping (aggregation and disaggregation) and the location of information in both the primary financial statements and the notes. Some requirements previously included in HKAS 1 are moved to HKAS 8 *Accounting Policies, Changes in Accounting Estimates and Errors*, which is renamed as HKAS 8 *Basis of Preparation of Financial Statements*. As a consequence of the issuance of HKFRS 18, limited, but widely applicable, amendments are made to HKAS 7 *Statement of Cash Flows*, HKAS 33 *Earnings per Share* and HKAS 34 *Interim Financial Reporting*. In addition, there are minor consequential amendments to other HKFRS Accounting Standards. HKFRS 18 and the consequential amendments to other HKFRS Accounting Standards are effective for annual periods beginning on or after 1 January 2027 with earlier application permitted. Retrospective application is required. The Group is currently analysing the new requirements and assessing the impact of HKFRS 18 on the presentation and disclosure of the Group's financial statements.

To be eligible, at the end of the reporting period, an entity must be a subsidiary as defined in HKFRS 10 *Consolidated Financial Statements*, cannot have public accountability and must have a parent (ultimate or intermediate) that prepares consolidated financial statements available for public use which comply with HKFRS Accounting Standards or IFRS Accounting Standards. HKFRS 19 was amended in April 2025 to include IFRS Accounting Standards in the eligibility criteria for applying the standard. The standard was further amended in October 2025 to (i) remove disclosure objectives from HKFRS 19; (ii) reduce the disclosure requirements relating to supplier finance arrangements and a specific class of financial liabilities; and (iii) replace disclosure requirements relating to management-defined performance measures with a cross-reference to HKFRS 18 for entities that use these measures. Earlier application is permitted. As the Company is a listed company, it is not eligible to elect to apply HKFRS 19 and its amendments. Some of the Company's subsidiaries are considering the application of HKFRS 19 and its amendments in their specified financial statements.

The amendments require a full recognition of a gain or loss resulting from a downstream transaction when the sale or contribution of assets constitutes a business. For a transaction involving assets that do not constitute a business, a gain or loss resulting from the transaction is recognised in the investor's profit or loss only to the extent of the unrelated investor's interest in that associate or joint venture. The amendments are to be applied prospectively. The previous mandatory effective date of amendments to HKFRS 10 and HKAS 28 was removed by the HKICPA. However, the amendments are available for adoption now.

Amendments to HKAS 21 Translation to a Hyperinflationary Presentation Currency require the translation from a non-hyperinflationary functional currency into a hyperinflationary presentation currency at the closing rate. The amendments also require an entity whose functional currency and presentation currency are the currency of a hyperinflationary economy to restate the comparative amounts of a foreign operation whose functional currency is that of a non-hyperinflationary economy, by applying the general price index, in accordance with paragraph 34 of HKAS 29 Financial Reporting in Hyperinflationary Economies, to the foreign operation's comparative figures. The amendments introduce certain additional disclosures. Earlier application is permitted. The amendments are not expected to have any significant impact on the Group's financial statements. - **HKFRS 7 *Financial Instruments: Disclosures*:** The amendments have updated certain wording in paragraph B38 of HKFRS 7 and paragraphs IG1, IG14 and IG20B of the *Guidance on implementing HKFRS 7* for the purpose of simplification or achieving consistency with other paragraphs in the standard and/or with the concepts and terminology used in other standards. However, the amendments do not address how a lessee distinguishes between a lease modification as defined in HKFRS 16 and an extinguishment of a lease liability in accordance with HKFRS 9. In addition, the amendments have updated certain wording in paragraph 5.1.3 of HKFRS 9 and Appendix A of HKFRS 9 to remove potential confusion. Earlier application is permitted. #### 2.4 Material accounting policies

##### *Investments in associates and a joint venture*

An associate is an entity in which the Group has a long term interest of generally not less than 20% of the equity voting rights and over which it has significant influence. Significant influence is the power to participate in the financial and operating policy decisions of the investee, but is not control or joint control over those policies.

A joint venture is a type of joint arrangement whereby the parties that have joint control of the arrangement have rights to the net assets of the joint venture. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require the unanimous consent of the parties sharing control.

The Group's investments in associates and a joint venture are stated in the consolidated statement of financial position at the Group's share of net assets under the equity method of accounting, less any impairment losses. Adjustments are made to bring into line any dissimilar accounting policies that may exist.

聯營公司指本集團持有其長期權益(通常不少於20%股本投票權)，且對其有重大影響力之實體。重大影響力指的是參與投資對象之財務及經營決策之權力，但並非控制或共同控制該等決策之權力。

合營公司指一種合營安排，對安排擁有共同控制權的訂約方據此對合營公司的資產淨值擁有權利。共同控制指按照合約協定對一項安排所共有的控制，共同控制僅在有關活動要求享有控制權的訂約方作出一致同意的決定時存在。

本集團於聯營公司及一間合營公司之投資根據權益會計法按本集團應佔資產淨值減任何減值虧損於綜合財務狀況表列賬。倘若會計政策存在任何不一致，則會作出相應調整。

The Group's share of the post-acquisition results and other comprehensive income of associates and a joint venture is included in consolidated statement of profit or loss and other comprehensive income, respectively. In addition, when there has been a change recognised directly in the equity of the associate or joint venture, the Group recognises its share of any changes, when applicable, in the consolidated statement of changes in equity. Unrealised gains and losses resulting from transactions between the Group and its associates or a joint venture are eliminated to the extent of the Group's investments in the associates or a joint venture, except where unrealised losses provide evidence of an impairment of the assets transferred. Goodwill arising from the acquisition of associates or a joint venture is included as part of the Group's investments in associates or a joint venture.

If an investment in an associate becomes an investment in a joint venture or vice versa, the retained interest is not remeasured. Instead, the investment continues to be accounted for under the equity method. In all other cases, upon loss of significant influence over the associate or joint control over the joint venture, the Group measures and recognises any retained investment at its fair value. Any difference between the carrying amount of the associate or joint venture upon loss of significant influence or joint control and the fair value of the retained investment and proceeds from disposal is recognised in profit or loss.

When an investment in an associate or a joint venture is classified as held for sale, it is accounted for in accordance with HKFRS 5 *Non-current Assets Held for Sale and Discontinued Operations*.

##### *Business combinations and goodwill*

Business combinations are accounted for using the acquisition method. The consideration transferred is measured at the acquisition date fair value which is the sum of the acquisition date fair values of assets transferred by the Group, liabilities assumed by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. For each business combination, the Group elects whether to measure the non-controlling interests in the acquiree at fair value or at the proportionate share of the acquiree's identifiable net assets. All other components of non-controlling interests are measured at fair value. Acquisition-related costs are expensed as incurred.

本集團於綜合損益及其他全面收益表分別計入其分佔聯營公司及一間合營公司收購後業績及其他全面收益。此外，當直接確認聯營公司及合營公司之權益有變動時，則本集團於綜合權益變動表確認其適用之任何應佔變動。本集團與其聯營公司或一間合營公司之交易產生之未變現盈虧會對銷，對銷金額以本集團對聯營公司或一間合營公司之投資為限，除非未變現虧損能證明被轉移資產出現減值。收購聯營公司或一間合營公司產生之商譽被納入為本集團於聯營公司或合營公司投資之一部分。

倘於聯營公司的投資變為於一間合營公司的投資或出現相反情況，則不會重新計量保留權益。反之，該投資繼續根據權益法入賬。在所有其他情況下，對於失去對聯營公司的重大影響力或對合營公司的共同控制權後，本集團按其公平值計量及確認任何保留投資。於失去重大影響力或共同控制權後聯營公司或合營公司的賬面值與保留投資及出售所得款項的公平值之間的任何差額於損益內確認。

當於聯營公司或合營公司的投資分類為持作出售，其根據香港財務報告準則第5號持作出售的非流動資產及已終止經營業務入賬。

業務合併按收購法列賬。轉讓代價乃按收購日期之公平值計量，該公平值為本集團轉讓的資產於收購日期的公平值、本集團自被收購方的前擁有人承擔的負債及本集團發行以換取被收購方控股權的股本權益的總和。就各項業務合併而言，本集團選擇以公平值或被收購方可識別資產淨值的應佔比例，計算於被收購方之非控股權益。非控股權益之一切其他部分乃按公平值計量。收購相關成本於產生時列為開支。

The Group determines that it has acquired a business when the acquired set of activities and assets includes an input and a substantive process that together significantly contribute to the ability to create outputs.

When the Group acquires a business, it assesses the financial assets and liabilities assumed for appropriate classification and designation in accordance with the contractual terms, economic circumstances and pertinent conditions as at the acquisition date. This includes the separation of embedded derivatives in host contracts of the acquiree.

If the business combination is achieved in stages, the previously held equity interest is remeasured at its acquisition date fair value and any resulting gain or loss is recognised in profit or loss or other comprehensive income, as appropriate.

Any contingent consideration to be transferred by the acquirer is recognised at fair value at the acquisition date. Contingent consideration classified as an asset or liability is measured at fair value with changes in fair value recognised in profit or loss. Contingent consideration that is classified as equity is not remeasured and subsequent settlement is accounted for within equity.

Goodwill is initially measured at cost, being the excess of the aggregate of the consideration transferred, the amount recognised for non-controlling interests and any fair value of the Group's previously held equity interests in the acquiree over the identifiable net assets acquired and liabilities assumed. If the sum of this consideration and other items is lower than the fair value of the net assets acquired, the difference is, after reassessment, recognised in profit or loss as a gain on bargain purchase.

當所收購的一組活動及資產包括一項投入及一項重要過程，而兩者對形成產出的能力有重大貢獻，本集團認為其已收購一項業務。

本集團收購一項業務時會根據合約條款、收購日之經濟狀況及有關條件評估取得的金融資產及承擔的金融負債，以進行適當分類及指定。此包括分離被收購方主合同中的嵌入式衍生工具。

倘業務合併為分階段實現，先前持有的股本權益應按收購日的公平值重新計算，產生的任何收益或虧損於損益中或其他全面收益(如適用)中確認。

收購方轉讓的任何或然代價將以收購日的公平值確認。或然代價被分類為資產或負債乃按公平值確認，其公平值的變化於損益確認。或然代價被分類為權益，則不再對其重新計量，後續的結算會計入權益中。

商譽初步按成本計量，即轉讓代價、確認為非控股權益的金額及本集團此前持有的被收購方股本權益的任何公平值之和超出所收購可識別資產淨值及所承擔負債的部分。倘該代價及其他項目之和低於所收購資產淨值的公平值，有關差額在重估後於損益確認為議價收購收益。

After initial recognition, goodwill is measured at cost less any accumulated impairment losses. Goodwill is tested for impairment annually or more frequently if events or changes in circumstances indicate that the carrying value may be impaired. The Group performs its annual impairment test of goodwill as at 31 December. For the purpose of impairment testing, goodwill acquired in a business combination is, from the acquisition date, allocated to each of the Group's cash-generating units, or groups of cash-generating units, that are expected to benefit from the synergies of the combination, irrespective of whether other assets or liabilities of the Group are assigned to those units or groups of units.

Impairment is determined by assessing the recoverable amount of the cash-generating unit (group of cash-generating units) to which the goodwill relates. Where the recoverable amount of the cash-generating unit (group of cash-generating units) is less than the carrying amount, an impairment loss is recognised. An impairment loss recognised for goodwill is not reversed in a subsequent period.

Where goodwill has been allocated to a cash-generating unit (or group of cash-generating units) and part of the operation within that unit is disposed of, the goodwill associated with the operation disposed of is included in the carrying amount of the operation when determining the gain or loss on the disposal. Goodwill disposed of in these circumstances is measured based on the relative value of the operation disposed of and the portion of the cash-generating unit retained.

初始確認後，商譽按成本減任何累計減值虧損計量。如有任何事件或情況變動表明賬面值可能減值，則每年或更頻繁地對商譽進行減值測試。本集團每年於十二月三十一日對商譽進行減值測試。就減值測試而言，於業務合併時收購的商譽自收購日起分配至預期將從合併協同效應受益之本集團各現金產生單位或現金產生單位組別，而不論本集團之其他資產或負債是否已被分配至該等單位或單位組別。

減值數額通過評估商譽所屬的現金產生單位(現金產生單位組別)的可收回金額而釐定。倘現金產生單位(現金產生單位組別)的可收回金額低於賬面值，則確認減值虧損。就商譽所確認的減值虧損不會於其後期間撥回。

倘商譽被分配至某現金產生單位(或現金產生單位組別)，而該單位內的部分業務被出售，與被出售業務有關的商譽將於釐定出售該業務的收益或虧損時計入該業務賬面值。在此情況下被出售的商譽按被出售業務的相對價值及保留的現金產生單位部分計量。

##### *Fair value measurement*

The Group measures its investment properties, financial assets at fair value through profit or loss, equity investments designated at fair value through other comprehensive income and debt investment at fair value through other comprehensive income at fair value at the end of each reporting period. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either in the principal market for the asset or liability, or in the absence of a principal market, in the most advantageous market for the asset or liability. The principal or the most advantageous market must be accessible by the Group. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

All assets and liabilities for which fair value is measured or disclosed in the consolidated financial statements are categorised within the fair value hierarchy, described as follows, based on the lowest level input that is significant to the fair value measurement as a whole:

Level 1 – based on quoted prices (unadjusted) in active markets for identical assets or liabilities

Level 2 – based on valuation techniques for which the lowest level input that is significant to the fair value measurement is observable, either directly or indirectly

Level 3 – based on valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable

For assets and liabilities that are recognised in the consolidated financial statements on a recurring basis, the Group determines whether transfers have occurred between levels in the hierarchy by reassessing categorisation (based on the lowest level input that is significant to the fair value measurement as a whole) at the end of each reporting period.

非金融資產的公平值計量會計及一名市場參與者透過以最大限度使用該資產達致最佳用途，或透過將資產出售予將以最大限度使用該資產達致最佳用途的另一名市場參與者而產生經濟利益的能力。

本集團使用適用於不同情況且具備足夠可用數據以計量公平值的估值方法，以盡量使用相關可觀察輸入值及盡量減少使用不可觀察輸入值。

於綜合財務報表計量或披露公平值的所有資產及負債，均根據對公平值計量整體而言屬重大的最低級別輸入值在下述公平值等級內進行分類：

第一級 – 基於相同資產或負債於活躍市場的報價(未經調整)

第二級 – 基於對公平值計量而言屬重大的可觀察(直接或間接)最低級別輸入值的估值方法

##### *Impairment of non-financial assets*

Where an indication of impairment exists, or when annual impairment testing for an asset is required (other than inventories, deferred tax assets, financial assets and investment properties, the asset's recoverable amount is estimated. An asset's recoverable amount is the higher of the asset's or cash-generating unit's value in use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cash-generating unit to which the asset belongs. In testing a cash-generating unit for impairment, a portion of the carrying amount of a corporate asset (e.g., a headquarters building) is allocated to an individual cash-generating unit if it can be allocated on a reasonable and consistent basis or, otherwise, to the smallest group of cash-generating units.

An impairment loss is recognised only if the carrying amount of an asset exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to profit or loss in the period in which it arises in those expense categories consistent with the function of the impaired asset.

An assessment is made at the end of each reporting period as to whether there is an indication that previously recognised impairment losses may no longer exist or may have decreased. If such an indication exists, the recoverable amount is estimated. A previously recognised impairment loss of an asset other than goodwill is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined (net of any depreciation/amortisation) had no impairment loss been recognised for the asset in prior years. A reversal of such an impairment loss is credited to profit or loss in the period in which it arises, unless the asset is carried at a revalued amount, in which case the reversal of the impairment loss is accounted for in accordance with the relevant accounting policy for that revalued asset.

當資產(存貨、遞延稅項資產、金融資產及投資物業除外)有減值跡象或須對資產進行年度減值測試時，會估計資產的可收回金額。資產的可收回金額指個別資產或現金產生單位的使用價值與其已扣除銷售成本的公平值兩者之中的較高者，除非該資產所產生的現金流入並非基本上獨立於其他資產或資產組別，在該情況下可收回金額按資產所屬現金產生單位釐定。在對現金產生單位進行減值測試時，倘部分公司資產(例如總部大樓)的賬面值能按合理一致基準分配，則分配至個別現金產生單位，否則將分配至最小現金產生單位組別。

減值虧損僅可在資產賬面值超過其可收回金額時方獲確認。在評估使用價值時，估計未來現金流量會以可反映現時市場對金錢時間值及該資產特有風險評估之稅前貼現率貼現至現值。減值虧損乃在其產生期間自損益內與減值資產功能相符之費用類別扣除。

於各報告期末均會作出評估，以確認是否有跡象顯示過往確認之減值虧損不再出現或可能已經減少。如有任何該等跡象，則會估計可收回金額。先前確認之資產(不包括商譽)減值虧損僅於釐定該資產之可收回金額所使用之估計方法出現改變時方會撥回，然而撥回後之數額不可超過有關資產未有於過往年度確認減值虧損時可釐定之賬面值(扣除任何折舊/攤銷)。撥回之減值虧損於產生期間記入損益內，惟按重估金額入賬的資產則除外，在該情況下，減值虧損撥回乃按照就該重估資產的相關會計政策入賬。

##### *Property, plant and equipment and depreciation*

Property, plant and equipment, other than construction in progress, are stated at cost less accumulated depreciation and any impairment losses. When an item of property, plant and equipment is classified as held for sale or when it is part of disposal groups classified as held for sale, it is not depreciated and is accounted for in accordance with HKFRS 5, as further explained in the accounting policy for “Non-current assets and disposal groups held for sale”. The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use.

Expenditure incurred after items of property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to profit or loss in the period in which it is incurred. In situations where the recognition criteria are satisfied, the expenditure for a major inspection is capitalised in the carrying amount of the asset as a replacement. Where significant parts of property, plant and equipment are required to be replaced at intervals, the Group recognises such parts as individual assets with specific useful lives and depreciates them accordingly.

除在建工程外，物業、廠房及設備乃按成本減累計折舊及任何減值虧損列賬。當一項物業、廠房及設備項目獲分類為持作出售或其為獲分類為持作出售的出售集團的一部分，則不作折舊處理並根據香港財務報告準則第5號入賬，如「持作出售的非流動資產及出售集團」之會計政策所進一步闡述。物業、廠房及設備項目成本包括其購買價及將該資產達至運作狀況及地點以作擬定用途之任何直接應佔費用。

物業、廠房及設備項目投入運作後所產生維修保養等支出，一般於其產生期間自損益扣除。倘達到確認標準，重大視察的開支資本化到該作為重置資產的賬面值。倘物業、廠房及設備的重大部分須定期替換，則本集團將該等部分確認為獨立資產，並賦予特定可使用年期及按此折舊。

Depreciation is calculated on the straight-line basis to write off the cost of each item of property, plant and equipment to its residual value over its estimated useful life. The principal annual rates used for this purpose are as follows:

Leasehold improvements	Over the shorter of the lease terms and 20%
Furniture and fixtures	10% to 33%
Computer equipment	19% to 32%
Motor vehicles	6% to 19%

Where parts of an item of property, plant and equipment have different useful lives, the cost of that item is allocated on a reasonable basis among the parts and each part is depreciated separately. Residual values, useful lives and the depreciation method are reviewed, and adjusted if appropriate, at least at each financial year end.

An item of property, plant and equipment including any significant part initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss on disposal or retirement recognised in profit or loss in the year the asset is derecognised is the difference between the net sales proceeds and the carrying amount of the relevant asset.

Construction in progress is stated at cost less any impairment losses, and is not depreciated. It is reclassified to the appropriate category of property, plant and equipment when completed and ready for use.

折舊按直線法於其估計可用年期撇銷各物業、廠房及設備項目的成本至其剩餘價值計算。按此採用的主要年率如下：

傢俬及裝置	10%至33%
電腦設備	19%至32%
汽車	6%至19%

倘某項物業、廠房及設備項目其中部分的可使用年期不同，該項目的成本會按合理基準分配至有關部分，而各部分均分開計提折舊。剩餘價值、可使用年期及折舊方法將至少於各財政年度末檢討及進行調整(如適用)。

物業、廠房及設備項目(包括任何初次確認的重大部分)於出售或預期使用或出售有關項目不會產生未來經濟利益時終止確認。於終止確認資產年度在損益確認的出售或報廢資產的收益或虧損，為出售有關資產所得款項淨額與其賬面值兩者間的差額。

在建工程按成本減任何減值虧損列賬，且不予折舊。其於落成及可供使用時重新分類為適當類別的物業、廠房及設備。

##### *Investment properties*

Investment properties are interests in land and buildings (including right-of-use assets) held to earn rental income and/or for capital appreciation. Such properties are measured initially at cost, including transaction costs. Subsequent to initial recognition, investment properties are stated at fair value, which reflects market conditions at the end of the reporting period.

Gains or losses arising from changes in the fair values of investment properties are included in profit or loss in the year in which they arise.

Any gains or losses on the retirement or disposal of an investment property are recognised in profit or loss in the year of the retirement or disposal.

##### *Intangible assets (other than goodwill)*

Intangible assets acquired separately are measured on initial recognition at cost. The cost of intangible assets acquired in a business combination is the fair value at the date of acquisition. The useful lives of intangible assets are assessed to be either finite or indefinite. Intangible assets with finite lives are subsequently amortised over the useful economic life and assessed for impairment whenever there is an indication that the intangible asset may be impaired. The amortisation period and the amortisation method for an intangible asset with a finite useful life are reviewed at least at each financial year end.

##### *Leases*

The Group assesses at contract inception whether a contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

投資物業乃持作賺取租金收入及／或作資本增值之土地及樓宇權益(包括使用權資產)。該等物業初始按成本計量(包括交易成本)。於初始確認後，投資物業以反映於報告期末市況之公平值入賬。

投資物業公平值變動產生之損益於其產生年度之損益中入賬。

因投資物業報廢或出售而產生之任何損益於報廢或出售年度之損益內確認。

##### *無形資產(商譽除外)*

單獨購入之無形資產於初始確認時以成本計量。於業務合併中所購入無形資產的成本為其於收購日期之公平值。無形資產的可使用年期可被評估為有限或無限。年期有限的無形資產於後續使用經濟壽命內攤銷，並於有跡象顯示無形資產可能出現減值時作減值評估。可使用年期有限的無形資產的攤銷年期及攤銷方法至少於各財政年度末審查一次。

##### *租賃*

本集團於合約開始時評估合約是否為或包含租賃。倘合約為換取代價而給予在一段時間內控制可識別資產使用的權利，則該合約屬於或包含租賃。

*Group as a lessee*

The Group applies a single recognition and measurement approach for all leases, except for short-term leases and leases of low-value assets. The Group recognises lease liabilities to make lease payments and right-of-use assets representing the right to use the underlying assets.

(a) Right-of-use assets

Right-of-use assets are recognised at the commencement date of the lease (that is the date the underlying asset is available for use). Right-of-use assets are measured at cost, less accumulated depreciation and any impairment losses, and adjusted for any remeasurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognised, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received. Right-of-use assets are depreciated on a straight-line basis over the shorter of the lease terms and the estimated useful lives of the assets as follows:

Leasehold land	47 to 51 years
Buildings	2 to 3 years

If ownership of the leased asset transfers to the Group by the end of the lease term or the cost reflects the exercise of a purchase option, depreciation is calculated using the estimated useful life of the asset.

(b) Lease liabilities

Lease liabilities are recognised at the commencement date of the lease at the present value of lease payments to be made over the lease term. The lease payments include fixed payments (including in-substance fixed payments) less any lease incentives receivable, variable lease payments that depend on an index or a rate, and amounts expected to be paid under residual value guarantees. The lease payments also include the exercise price of a purchase option reasonably certain to be exercised by the Group and payments of penalties for termination of a lease, if the lease term reflects the Group exercising the option to terminate the lease. The variable lease payments that do not depend on an index or a rate are recognised as an expense in the period in which the event or condition that triggers the payment occurs.

本集團對所有租賃(惟短期租賃及低價值資產租賃除外)應用單一確認及計量方法。本集團確認租賃負債以作出租賃付款，而使用權資產指使用相關資產的權利。

(a) 使用權資產

使用權資產於租賃開始日期(即相關資產可供使用當日)確認。使用權資產按成本減累計折舊及任何減值虧損計量，並就任何重新計量租賃負債作出調整。使用權資產成本包括已確認租賃負債的款額、已產生初始直接成本及於開始日期或之前作出的租賃付款減任何已收租賃獎勵。使用權資產按直線法於租期及資產估計可使用年期(以較短者為準)折舊，如下：

倘租賃資產的所有權於租期結束前轉移至本集團，或成本反映購買選擇權獲行使，則折舊乃採用該資產的估計可使用年期計算。

(b) 租賃負債

於租賃開始日期，租賃負債按租期內作出的租賃付款現值予以確認。租賃款項包括定額付款(含實質定額付款)減任何應收租賃獎勵、取決於指數或利率的可變租賃付款以及預期根據剩餘價值擔保下支付的金額。租賃付款亦包括本集團合理確定行使的購買選擇權的行使價及倘在租期內反映本集團正行使終止租約選擇權時，有關終止租賃的罰款付款。不取決於指數或利率的可變租賃付款在發生觸發付款的事件或條件的期間內確認為支出。

(b) Lease liabilities (continued)

In calculating the present value of lease payments, the Group uses its incremental borrowing rate at the lease commencement date because the interest rate implicit in the lease is not readily determinable. After the commencement date, the amount of lease liabilities is increased to reflect the accretion of interest and reduced for the lease payments made. In addition, the carrying amount of lease liabilities is remeasured if there is a modification, a change in the lease term, a change in lease payments (e.g., a change to future lease payments resulting from a change in an index or rate) or a change in assessment of an option to purchase the underlying asset.

(c) Short-term leases and leases of low-value assets

The Group applies the short-term lease recognition exemption to its short-term leases of buildings (that is those leases that have a lease term of 12 months or less from the commencement date and do not contain a purchase option). It also applies the recognition exemption for leases of low-value assets to leases of office equipment and laptop computers that are considered to be of low value.

Lease payments on short-term leases and leases of low-value assets are recognised as an expense on a straight-line basis over the lease term.

於計算租賃付款的現值時，由於租賃內所含利率不易釐定，故本集團應用租賃開始日期的增量借款利率計算。於開始日期後，租賃負債金額有所增加以反映利息的增加，並因作出租賃付款而減少。此外，倘有修改、租期變更、租賃付款變更(例如指數或比率的變更導致未來租賃付款發生變化)或購買相關資產的選擇權評估的變更，則重新計量租賃負債的賬面值。

##### *Group as a lessor*

When the Group acts as a lessor, it classifies at lease inception (or when there is a lease modification) each of its leases as either an operating lease or a finance lease.

Leases in which the Group does not transfer substantially all the risks and rewards incidental to ownership of an asset are classified as operating leases. When a contract contains lease and non-lease components, the Group allocates the consideration in the contract to each component on a relative stand-alone selling price basis. Rental income is accounted for on a straight-line basis over the lease term and is included in revenue in profit or loss due to its operating nature. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised over the lease term on the same basis as rental income. Contingent rents are recognised as revenue in the period in which they are earned.

Leases that transfer substantially all the risks and rewards incidental to ownership of an underlying asset to the lessees are accounted for as finance leases.

##### *Initial recognition and measurement*

Financial assets are classified, at initial recognition, as subsequently measured at amortised cost, fair value through other comprehensive income, and fair value through profit or loss.

The classification of financial assets at initial recognition depends on the financial asset's contractual cash flow characteristics and the Group's business model for managing them. With the exception of trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient of not adjusting the effect of a significant financing component, the Group initially measures a financial asset at its fair value plus in the case of a financial asset not at fair value through profit or loss, transaction costs. Trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient are measured at the transaction price determined under HKFRS 15 in accordance with the policies set out for "Revenue recognition" below.

倘本集團作為出租人，則於租賃開始時(或於租賃修訂時)將各租賃分類為經營租賃或融資租賃。

本集團並未轉讓資產擁有權所附帶的絕大部分風險及回報的租賃均歸類為經營租賃。倘合約包括租賃及非租賃部分，本集團根據相對獨立的售價基準將合約代價分配予各部分。基於其經營性質，租金收入於租期內按直線法列賬並計入損益中的收益。於磋商及安排經營租賃時產生的初始直接成本乃計入租賃資產的賬面值，並於租期內按相同基準確認為租金收入。或然租金乃於所賺取的期間內確認為收益。

相關資產擁有權所附帶的絕大部分風險及回報均轉嫁予承租人之租賃按融資租賃入賬。

In order for a financial asset to be classified and measured at amortised cost or fair value through other comprehensive income, it needs to give rise to cash flows that are solely payments of principal and interest ("SPPI") on the principal amount outstanding. Financial assets with cash flows that are not SPPI are classified and measured at fair value through profit or loss, irrespective of the business model.

The Group's business model for managing financial assets refers to how it manages its financial assets in order to generate cash flows. The business model determines whether cash flows will result from collecting contractual cash flows, selling the financial assets, or both. Financial assets classified and measured at amortised cost are held within a business model with the objective to hold financial assets in order to collect contractual cash flows, while financial assets classified and measured at fair value through other comprehensive income are held within a business model with the objective of both holding to collect contractual cash flows and selling. Financial assets which are not held within the aforementioned business models are classified and measured at fair value through profit or loss.

Purchases or sales of financial assets that require delivery of assets within the period generally established by regulation or convention in the marketplace are recognised on the trade date, that is, the date that the Group commits to purchase or sell the asset.

*Subsequent measurement*

The subsequent measurement of financial assets depends on their classification as follows:

Financial assets at amortised cost (debt instruments)

Financial assets at amortised cost are subsequently measured using the effective interest method and are subject to impairment. Gains and losses are recognised in profit or loss when the asset is derecognised, modified or impaired.

Financial assets at fair value through other comprehensive income (debt instruments)

For debt investments at fair value through other comprehensive income, interest income, foreign exchange revaluation and impairment losses or reversals are recognised in profit or loss and computed in the same manner as for financial assets measured at amortised cost. The remaining fair value changes are recognised in other comprehensive income. Upon derecognition, the cumulative fair value change recognised in other comprehensive income is recycled to profit or loss.

Financial assets designated at fair value through other comprehensive income (equity investments)

Upon initial recognition, the Group can elect to classify irrevocably its equity investments as equity investments designated at fair value through other comprehensive income when they meet the definition of equity under HKAS 32 *Financial Instruments: Presentation* and are not held for trading. The classification is determined on an instrument-by-instrument basis.

Gains and losses on these financial assets are never recycled to profit or loss. Dividends are recognised as other income in profit or loss when the right of payment has been established, except when the Group benefits from such proceeds as a recovery of part of the cost of the financial asset, in which case, such gains are recorded in other comprehensive income. Equity investments designated at fair value through other comprehensive income are not subject to impairment assessment.

Financial assets at fair value through profit or loss

Financial assets at fair value through profit or loss are carried in the statement of financial position at fair value with net changes in fair value recognised in profit or loss.

This category includes derivative instruments and equity investments which the Group had not irrevocably elected to classify at fair value through other comprehensive income. Dividends on the equity investments are also recognised as other income in profit or loss when the right of payment has been established.

指定為透過其他全面收益以公平值列賬之金融資產(權益投資)

於初始確認時，本集團可選擇於權益投資符合香港會計準則第32號*金融工具：呈列*項下權益的定義且並非持作買賣時，將其權益投資不可撤回地分類為指定為透過其他全面收益以公平值列賬之權益投資。分類乃按個別工具基準釐定。

該等金融資產的收益及虧損概不會被重新計入損益。當確立支付權時，股息於損益中確認為其他收益，惟當本集團於作為收回金融資產一部分成本的該等所得款項中獲益時則除外。於此等情況下，該等收益於其他全面收益入賬。指定為透過其他全面收益以公平值列賬之權益投資不受減值評估影響。

透過損益以公平值列賬之金融資產

透過損益以公平值列賬之金融資產按公平值於財務狀況表列賬，而公平值變動淨額於損益中確認。

A derivative embedded in a hybrid contract, with a financial liability or non-financial host, is separated from the host and accounted for as a separate derivative if the economic characteristics and risks are not closely related to the host; a separate instrument with the same terms as the embedded derivative would meet the definition of a derivative; and the hybrid contract is not measured at fair value through profit or loss. Embedded derivatives are measured at fair value with changes in fair value recognised in profit or loss. Reassessment only occurs if there is a change in the terms of the contract that significantly modifies the cash flows.

A derivative embedded within a hybrid contract containing a financial asset host is not accounted for separately. The financial asset host together with the embedded derivative is required to be classified in its entirety as a financial asset at fair value through profit or loss.

*Derecognition of financial assets*

A financial asset (or, where applicable, a part of a financial asset or part of a group of similar financial assets) is primarily derecognised (i.e., removed from the Group's consolidated statement of financial position) when:

- the rights to receive cash flows from the asset have expired; or

When the Group has transferred its rights to receive cash flows from an asset or has entered into a pass-through arrangement, it evaluates if, and to what extent, it has retained the risk and rewards of ownership of the asset. When it has neither transferred nor retained substantially all the risks and rewards of the asset nor transferred control of the asset, the Group continues to recognise the transferred asset to the extent of the Group's continuing involvement. In that case, the Group also recognises an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Group has retained.

Continuing involvement that takes the form of a guarantee over the transferred asset is measured at the lower of the original carrying amount of the asset and the maximum amount of consideration that the Group could be required to repay.

*Impairment of financial assets*

The Group recognises an allowance for expected credit losses ("ECLs") for all debt instruments not held at fair value through profit or loss. ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive, discounted at an approximation of the original effective interest rate. The expected cash flows will include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms.

General approach

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12 months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

當本集團已轉讓其收取一項資產所得現金流量的權利或已訂立一項轉付安排，則其將評估其是否保留資產所有權的風險及回報，以及保留程度。倘其並無轉讓或保留該項資產的絕大部分風險及回報，且並無轉讓該項資產的控制權，本集團繼續按本集團的持續參與程度確認該轉讓資產。在此情況下，本集團亦確認相關負債。已轉讓的資產及相關負債按反映本集團已保留的權利及責任的基準計量。

持續參與指就已轉讓資產作出的保證，並按該項資產的原賬面值及本集團或須償還的代價數額上限(以較低者為準)計算。

*金融資產減值*

本集團確認對並非透過損益以公平值列賬之所有債務工具預期信貸虧損(「預期信貸虧損」)的撥備。預期信貸虧損乃基於根據合約到期的合約現金流量與本集團預期收取的所有現金流量之間的差額而釐定，並以原實際利率的近似值貼現。預期現金流量將包括出售所持抵押的現金流量或組成合約條款的其他提升信貸措施。

一般方法

預期信貸虧損分兩個階段進行確認。就自初始確認起未有顯著增加的信貸風險而言，預期信貸虧損乃就由未來12個月內可能發生違約事件而導致的信貸虧損(12個月預期信貸虧損)作撥備。就自初始確認起經已顯著增加的信貸風險而言，不論何時發生違約，於餘下風險年期內的預期信貸虧損均須計提虧損撥備(全期預期信貸虧損)。

At each reporting date, the Group assesses whether the credit risk on a financial instrument has increased significantly since initial recognition. When making the assessment, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition and considers reasonable and supportable information that is available without undue cost or effort, including historical and forward-looking information. The Group considers that there has been a significant increase in credit risk when contractual payments are more than 30 days past due.

The Group considers a financial asset in default when contractual payments are 90 days past due. However, in certain cases, the Group may also consider a financial asset to be in default when internal or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group.

A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

Debt investments at fair value through other comprehensive income and financial assets at amortised cost are subject to impairment under the general approach and they are classified within the following stages for measurement of ECLs except for trade receivables which apply the simplified approach as detailed below.

本集團於各報告日期評估金融工具信貸風險自初始確認後有否大幅增加。進行評估時，本集團會比較金融工具於報告日期發生違約的風險與金融工具於初始確認日期發生違約的風險，並考慮毋需付出不必要成本或努力而可得的合理且有證據支持的資料，包括歷史及前瞻性資料。本集團認為，當合約付款逾期30天以上，信貸風險已大幅增加。

本集團認為，倘合約付款逾期90天，則為發生金融資產違約事件。然而，在若干情況下，倘內部或外部資料顯示本集團在計及任何本集團持有的信貸增級前不可能悉數收取未收取合約金額，則本集團亦可認為發生金融資產違約事件。

當並無合理預期能回收合約現金流量時，則撇銷金融資產。

除應收貿易賬款採用下述簡化方法外，透過其他全面收益以公平值列賬之債權投資及按攤銷成本計量的金融資產按一般方法進行減值，並按下列預期信貸虧損計量階段分類。

Stage 1 – Financial instruments for which credit risk has not increased significantly since initial recognition and for which the loss allowance is measured at an amount equal to 12-month ECLs

Stage 2 – Financial instruments for which credit risk has increased significantly since initial recognition but that are not credit-impaired financial assets and for which the loss allowance is measured at an amount equal to lifetime ECLs

Simplified approach

For trade receivables that do not contain a significant financing component or when the Group applies the practical expedient of not adjusting the effect of a significant financing component, the Group applies the simplified approach in calculating ECLs. Under the simplified approach, the Group does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date. The Group has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

簡化方法

對於並無包含重大融資部分的應收貿易賬款，或本集團採用毋須調整重大融資部分影響的可行權宜方法時，本集團採用簡化方法計量預期信貸虧損。根據簡化方法，本集團不會追蹤信貸風險的變化，而是根據各個報告日期的全期預期信貸虧損確認虧損撥備。本集團已根據其歷史信貸虧損經驗建立撥備矩陣，並因應有關債務人及經濟環境的特定前瞻因素作出調整。

##### *Financial liabilities*

##### *Initial recognition and measurement*

Financial liabilities are classified, at initial recognition, as loans and borrowings, payables, as appropriate.

All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings, and payables, net of directly attributable transaction costs.

The Group's financial liabilities include trade and other payables and interest-bearing bank and other borrowings.

##### *Subsequent measurement*

The subsequent measurement of financial liabilities depends on their classification as follows:

Financial liabilities at amortised cost (trade and other payables and interest-bearing bank and other borrowings)

After initial recognition, trade and other payables and interest-bearing bank and other borrowings are subsequently measured at amortised cost, using the effective interest rate method unless the effect of discounting would be immaterial, in which case they are stated at cost. Gains and losses are recognised in profit or loss when the liabilities are derecognised as well as through the effective interest rate amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in finance costs in profit or loss.

##### *Derecognition of financial liabilities*

A financial liability is derecognised when the obligation under the liability is discharged or cancelled, or expires.

When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and a recognition of a new liability, and the difference between the respective carrying amounts is recognised in profit or loss.

##### *Offsetting of financial instruments*

Financial assets and financial liabilities are offset and the net amount is reported in the statement of financial position if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

##### *Treasury shares*

Own equity instruments which are reacquired and held by the Company or the Group (treasury shares) are recognised directly in equity at cost. No gain or loss is recognised in the statement of profit or loss on the purchase, sale, issue or cancellation of the Group's own equity instruments.

##### *Inventories*

Inventories are stated at the lower of cost and net realisable value. Cost is determined on the first-in, first-out basis. Net realisable value is based on estimated selling prices less any estimated costs to be incurred to completion and disposal.

##### *Properties under development*

Properties under development are stated at the lower of cost and net realisable value and comprise construction costs, borrowing costs, professional fees and other costs directly attributable to such properties incurred during the development period.

Properties under development which have been pre-sold or intended for sale and are expected to be completed within one year from the end of the reporting period are classified under current assets. On completion, the properties are transferred to properties held for sale.

##### *抵銷金融工具*

倘目前擁有可強制執行的法律權力以抵銷已確認金額且有意按淨額基準結算或同時變現資產及結清負債時，金融資產與金融負債可予抵銷，而淨額在財務狀況表呈報。

##### *庫存股份*

本公司或本集團重新收購及持有的本身的權益工具(庫存股份)按成本直接於權益確認。概無就購買、出售、發行或註銷本集團本身的權益工具而於損益表確認收益或虧損。

##### *存貨*

存貨以成本及可變現淨值兩者中的較低者列賬。成本按先入先出基準釐定。可變現淨值根據估計售價減直至完成及出售時產生的任何估計成本計算。

##### *發展中物業*

發展中物業按成本與可變現淨值兩者中的較低者列賬，並包括於發展期間內產生之建築成本、借款成本、專業費用及直接歸屬於該等物業的其他成本。

經已預售或擬作銷售且預期將於報告期末起計一年內完成之發展中物業會分類為流動資產。於完成時，該等物業會轉移至持作銷售物業。

##### *Cash and cash equivalents*

Cash and cash equivalents in the statement of financial position comprise cash on hand and at banks, and short-term highly liquid deposits with a maturity of generally within three months that are readily convertible into known amounts of cash, subject to an insignificant risk of changes in value and held for the purpose of meeting short-term cash commitments.

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and at banks, and short-term deposits as defined above, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

##### *Provisions*

A provision is recognised when a present obligation (legal or constructive) has arisen as a result of a past event and it is probable that a future outflow of resources will be required to settle the obligation, provided that a reliable estimate can be made of the amount of the obligation.

When the effect of discounting is material, the amount recognised for a provision is the present value at the end of the reporting period of the future expenditures expected to be required to settle the obligation. The increase in the discounted present value amount arising from the passage of time is included in finance costs in profit or loss.

The Group provides for warranties in relation to the sale of furniture for general repairs of defects occurring during the warranty period. Provisions for these assurance-type warranties granted by the Group are initially recognised based on sales volume and past experience of the level of repairs and returns, discounted to their present values as appropriate. The warranty-related cost is revised annually.

Income tax comprises current and deferred tax. Income tax relating to items recognised outside profit or loss is recognised outside profit or loss, either in other comprehensive income or directly in equity.

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period, taking into consideration interpretations and practices prevailing in the countries in which the Group operates.

Deferred tax is provided, using the liability method, on all temporary differences at the end of the reporting period between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes.

Deferred tax liabilities are recognised for all taxable temporary differences, except:

- when the deferred tax liability arises from the initial recognition of goodwill or an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss and does not give rise to equal taxable and deductible temporary differences; and

- when the deferred tax asset relating to the deductible temporary differences arises from the initial recognition of an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss and does not give rise to equal taxable and deductible temporary differences; and
- in respect of deductible temporary differences associated with investments in subsidiaries, associates and joint ventures, deferred tax assets are only recognised to the extent that it is probable that the temporary differences will reverse in the foreseeable future and taxable profit will be available against which the temporary differences can be utilised.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be utilised. Unrecognised deferred tax assets are reassessed at the end of each reporting period and are recognised to the extent that it has become probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be recovered.

##### *Government grants*

Government grants are recognised at their fair value where there is reasonable assurance that the grant will be received and all attaching conditions will be complied with. When the grant relates to an expense item, it is recognised as income on a systematic basis over the periods that the costs, for which it is intended to compensate, are expensed.

##### *Revenue from contracts with customers*

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services.

When the consideration in a contract includes a variable amount, the amount of consideration is estimated to which the Group will be entitled in exchange for transferring the goods or services to the customer. The variable consideration is estimated at contract inception and constrained until it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognised will not occur when the associated uncertainty with the variable consideration is subsequently resolved.

When the contract contains a financing component which provides the customer with a significant benefit of financing the transfer of goods or services to the customer for more than one year, revenue is measured at the present value of the amount receivable, discounted using the discount rate that would be reflected in a separate financing transaction between the Group and the customer at contract inception. When the contract contains a financing component which provides the Group with a significant financial benefit for more than one year, revenue recognised under the contract includes the interest expense accreted on the contract liability under the effective interest method. For a contract where the period between the payment by the customer and the transfer of the promised goods or services is one year or less, the transaction price is not adjusted for the effects of a significant financing component, using the practical expedient in HKFRS 15.

來自客戶合約的收入乃於貨品或服務的控制權轉讓予客戶時確認，該金額能反映本集團預期就交換該等貨品或服務有權獲得的代價。

當合約中的代價包含可變金額時，代價金額於本集團向客戶轉讓貨品或服務而有權獲得交換時估計。可變代價於合約開始時估計並受到約束，直至與可變代價相關的不確定因素得到解決時，確認的累計收入金額極有可能不會發生重大收入撥回。

(a) Sale of goods

Revenue from the sale of goods is recognised at the point in time when control of the asset is transferred to the customer, generally upon completion of the installation services.

Warranty obligations

The Group provides warranties that are either solely assurance-type warranties or extended warranties, which are service-type warranties, to a customer. The service-type warranties can be obtained from other providers and do not significantly customise or modify the products.

Contracts for bundled sales of goods and service-type warranties are comprised of two performance obligations because the promise to transfer goods and provide service-type warranties are capable of being distinct and separately identifiable. Accordingly, the transaction price is allocated based on the relative stand-alone selling prices of goods and service-type warranties.

Revenue from service-type warranties is recognised over time, using a straight-line basis because the customer simultaneously receives and consumes the benefits provided by the Group.

(b) Rendering of services

The Group provides medical care, health care and geriatric care related services. These services are rendered on their own contracts with customers. Revenue from the rendering of services is recognised over the time because the customer simultaneously receives and consumes the benefits provided by the Group.

(a) 銷售貨品

銷售貨品的收入於資產控制權轉移至客戶的時間點(一般為於安裝服務完成時)確認。

保養責任

一併提供銷售貨品及服務類保養的合約構成兩項履約責任，原因為轉移貨品及提供服務類保養的承諾能夠獨立及單獨識別。因此，交易價格乃根據貨品及服務類保養的相關獨立售價分配。

*Other income*

Rental income is recognised on a time proportion basis over the lease terms. Variable lease payments that do not depend on an index or a rate are recognised as income in the accounting period in which they are incurred.

Interest income is recognised on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial asset.

Dividend income is recognised when the shareholders' right to receive payment has been established, it is probable that the economic benefits associated with the dividend will flow to the Group and the amount of the dividend can be measured reliably.

*Contract liabilities*

A contract liability is recognised when a payment is received or a payment is due (whichever is earlier) from a customer before the Group transfers the related goods or services. Contract liabilities are recognised as revenue when the Group performs under the contract (i.e., transfers control of the related goods or services to the customer).

The Company operates several share option schemes. Employees (including directors) and consultants of the Group receive remuneration in the form of share-based payments, whereby employees and consultants render services in exchange for equity instruments (“equity-settled transactions”). The cost of equity-settled transactions with employees is measured by reference to the fair value at the date at which they are granted. The fair value is determined by an external valuer using a binomial model, further details of which are given in note 31 to the consolidated financial statements.

The cost of equity-settled transactions is recognised in equity-settled share-based payment expenses, together with a corresponding increase in equity, over the period in which the performance and/or service conditions are fulfilled. The cumulative expense recognised for equity-settled transactions at the end of each reporting period until the vesting date reflects the extent to which the vesting period has expired and the Group’s best estimate of the number of equity instruments that will ultimately vest. The charge or credit to profit or loss for a period represents the movement in the cumulative expense recognised as at the beginning and end of that period.

Service and non-market performance conditions are not taken into account when determining the grant date fair value of awards, but the likelihood of the conditions being met is assessed as part of the Group’s best estimate of the number of equity instruments that will ultimately vest. Market performance conditions are reflected within the grant date fair value. Any other conditions attached to an award, but without an associated service requirement, are considered to be non-vesting conditions. Non-vesting conditions are reflected in the fair value of an award and lead to an immediate expensing of an award unless there are also service and/or performance conditions.

本公司設有多項購股權計劃。本集團的僱員(包括董事)及顧問收取以股份為基礎付款的酬金，而僱員及顧問則提供服務換取股本工具(「股權結算交易」)。與僱員進行股權結算交易的成本乃參照授出日期的公平值計算。公平值乃由外聘估值師採用購股權的二項式模型釐定。進一步詳情載於綜合財務報表附註31。

Where the terms of an equity-settled award are modified, as a minimum an expense is recognised as if the terms had not been modified, if the original terms of the award are met. In addition, an expense is recognised for any modification that increases the total fair value of the share-based payments, or is otherwise beneficial to the employee as measured at the date of modification. Where an equity-settled award is cancelled, it is treated as if it had vested on the date of cancellation, and any expense not yet recognised for the award is recognised immediately. This includes any award where non-vesting conditions within the control of either the Group or the employee are not met. However, if a new award is substituted for the cancelled award, and is designated as a replacement award on the date that it is granted, the cancelled and new awards are treated as if they were a modification of the original award, as described in the previous paragraph.

The dilutive effect of outstanding options is reflected as additional share dilution in the computation of earnings per share.

因未能達至非市場表現及/或服務條件，而導致最終並無歸屬之獎勵並不會確認支銷，惟倘獎勵包括市場或非歸屬條件，則無論市場或非歸屬條件是否達成，交易均會被視為已歸屬，前提是所有其他表現及/或服務條件須已達成。

##### *Other employee benefits*

##### *Pension schemes*

The Group operates a defined contribution Mandatory Provident Fund retirement benefit scheme (the "MPF Scheme") under the Mandatory Provident Fund Schemes Ordinance for those eligible Hong Kong employees. Contributions are made based on a percentage of the employees' basic salaries and are charged to profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when contributed into the MPF Scheme.

The employees of the Group's subsidiaries which operate in the Chinese Mainland are required to participate in a central pension scheme operated by the local municipal government. These subsidiaries are required to contribute certain percentages of its payroll costs to the central pension scheme. The contributions are charged to profit or loss as they become payable in accordance with the rules of the central pension scheme.

##### *Borrowing costs*

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, i.e., assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalised as part of the cost of those assets. The capitalisation of such borrowing costs ceases when the assets are substantially ready for their intended use or sale. All other borrowing costs are expensed in the period in which they are incurred. Borrowing costs consist of interest and other costs that an entity incurs in connection with the borrowing of funds.

##### *退休金計劃*

本集團根據強制性公積金計劃條例為合資格的香港僱員設立定額供款強制性公積金退休福利計劃(「強積金計劃」)。供款乃按僱員基本薪金的百分比計算，並根據強積金計劃的規則於應付時在損益扣除。強積金計劃資產與本集團資產分開存放，由獨立管理的基金持有。本集團一經向強積金計劃供款，有關僱主供款即全數歸僱員所有。

本集團於中國內地經營的附屬公司的僱員須參與地方市政府管理的中央退休金計劃。該等附屬公司須按其薪酬成本的若干百分比向中央退休金計劃供款。供款於根據中央退休金計劃的規則應付時於損益扣除。

##### *借款成本*

收購、興建或生產合資格資產(即必須經過相當長時間方可作擬定用途或可供銷售的資產)直接應佔的借款成本會作為該等資產成本的一部分而予以資本化。當資產實質上可作擬定用途或可供銷售，有關借款成本不再資本化。所有其他借款成本均於其產生期間列作開支。借款成本包括實體就借入資金所產生的利息及其他成本。

##### *Dividends*

Final dividends are recognised as a liability when they are approved by the shareholders in a general meeting. Interim dividends are simultaneously proposed and declared, because the Company's memorandum and articles of association grant the directors the authority to declare interim dividends. Consequently, interim dividends are recognised immediately as a liability when they are proposed and declared.

##### *Foreign currencies*

These financial statements are presented in Hong Kong dollars, which is the Company's functional currency. Each entity in the Group determines its own functional currency and items included in the consolidated financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of the reporting period. Differences arising on settlement or translation of monetary items are recognised in profit or loss.

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rate at the date when the fair value was measured. The gain or loss arising on translation of a non-monetary item measured at fair value is treated in line with the recognition of the gain or loss on change in fair value of the item (i.e., translation difference on the item whose fair value gain or loss is recognised in other comprehensive income or profit or loss is also recognised in other comprehensive income or profit or loss, respectively).

當末期股息於股東大會上獲股東批准時，即確認為負債。因本公司的組織章程大綱及細則授權董事宣派中期股息，故中期股息於獲建議時宣派。因此，中期股息於建議及宣派時即時確認為負債。

##### *外幣*

財務報表以港元(即本公司的功能貨幣)呈報。本集團內各實體自行釐定其各自的功能貨幣，而各實體的綜合財務報表項目乃以該功能貨幣計量。本集團旗下實體記賬的外幣交易初步按該等實體各自於交易日通行的功能貨幣匯率入賬。以外幣計值的貨幣資產及負債，按有關功能貨幣於報告期末的適用匯率換算。因結算或換算貨幣項目而產生的差額於損益確認。

以外幣按歷史成本計量的非貨幣項目，採用初始交易日期的匯率換算。以外幣按公平值計量的非貨幣項目，採用計量公平值當日的匯率換算。因換算按公平值計量的非貨幣項目而產生的損益，亦按該項目公平值變動的損益確認(即於其他全面收益或損益中確認其公平值損益的項目的匯兌差額，亦分別於其他全面收益或損益中確認)。

##### *Foreign currencies (continued)*

In determining the exchange rate on initial recognition of the related asset, expense or income on the derecognition of a non-monetary asset or non-monetary liability relating to an advance consideration, the date of initial transaction is the date on which the Group initially recognises the non-monetary asset or non-monetary liability arising from the advance consideration. If there are multiple payments or receipts in advance, the Group determines the transaction date for each payment or receipt of the advance consideration.

The functional currency of certain subsidiaries and associates operating in Mainland China is a currency other than the Hong Kong dollar. As at the end of the reporting period, the assets and liabilities of these entities are translated into Hong Kong dollars at the exchange rate prevailing at the end of the reporting period and their profit or loss are translated into Hong Kong dollars at the exchange rates that approximate to those prevailing at the dates of the transaction.

The resulting exchange differences are recognised in other comprehensive income and accumulated in the exchange fluctuation reserve, except to the extent that the differences are attributable to non-controlling interests. On disposal of a foreign operation, the cumulative amount in the reserve relating to that particular foreign operation is recognised in profit or loss.

Any goodwill arising on the acquisition of a foreign operation and any fair value adjustments to the carrying amounts of assets and liabilities arising on acquisition are treated as assets and liabilities of the foreign operation and translated at the closing rate.

For the purpose of the consolidated statement of cash flows, the cash flows of subsidiaries operating in Mainland China are translated into Hong Kong dollars at the exchange rates ruling at the dates of the cash flows. Frequently recurring cash flows of subsidiaries operating in Mainland China which arise throughout the year are translated into Hong Kong dollars at the weighted average exchange rate for the year.

在釐定有關預付代價的非貨幣資產或非貨幣負債終止確認時，相關資產、開支或收入於初始確認時的匯率，初始交易日期為本集團初始確認因支付或收到預付代價而產生的非貨幣資產或非貨幣負債的日期。倘於確認相關項目之前支付或收取多筆預付款項，則本集團應確定所支付或收取的每筆預付代價的交易日期。

若干於中國內地營運的附屬公司及聯營公司的功能貨幣為港元以外之貨幣。於報告期末，該等實體的資產與負債按報告期末通行的匯率換算為港元，其損益則按於交易日通行的相若匯率換算為港元。

因此而產生的匯兌差額於其他全面收益內確認並累計至匯兌波動儲備，非控股權益應佔的差額除外。出售海外業務時，就該項海外業務在儲備的累積金額會在損益確認。

收購海外業務產生的任何商譽及收購所導致資產及負債賬面值的任何公平值調整被當作海外業務的資產及負債，並按收市匯率換算。

就綜合現金流量表而言，所有於中國內地營運的附屬公司的現金流量按現金流量日期的適用匯率換算為港元。所有於中國內地營運的附屬公司於整個年度產生的經常性現金流量則按年內的加權平均匯率換算為港元。

The preparation of the Group's financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and their accompanying disclosures, and the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that could require a material adjustment to the carrying amounts of the assets or liabilities affected in the future.

#### Judgements

In the process of applying the Group's accounting policies, management has made the following judgements, apart from those involving estimations, which have the most significant effect on the amounts recognised in the consolidated financial statements:

##### *Revenue from contracts with customers*

The Group has applied the following judgements that significantly affect the determination of the amount and timing of revenue from contracts with customers:

(a) *Identifying performance obligations in a bundled sale of goods and installation services*

The Group provides installation services with the sale of goods to customers. The Group assessed that the installation services bundled together with the sale of goods are not distinct and are not separate obligations under HKFRS 15, because the customers only accept goods at the point when goods are delivered and installation is completed. Therefore, the adoption of HKFRS 15 did not have an impact on the timing of revenue recognition.

(b) *Identifying warranty obligations in sale of furniture products*

The Group generally provides for warranties for general repairs of 3 to 5 years based on statutory requirements and product features, and does not provide extended warranties in its contracts of sale of furniture products with customers. However, in certain non-standard contracts, the Group provides extended warranties. The Group assessed that such warranties are service-type warranties and therefore, are accounted for as separate performance obligations to which the Group allocates a portion of the transaction price. Revenue is subsequently recognised over time based on the time elapsed.

#### 判斷

在應用本集團會計政策的過程中，管理層已作出以下判斷(涉及估計的判斷除外)，有關判斷對在綜合財務報表確認的款額構成最為重大的影響：

##### *來自客戶合約之收入*

本集團已應用以下大幅影響釐定來自客戶合約的收入金額及時間之判斷：

(a) *識別一併銷售貨品及安裝服務的履約責任*

本集團向客戶提供安裝服務連同銷售貨品。本集團評估與銷售產品時一併提供的安裝服務並非獨特，故並非香港財務報告準則第15號項下的獨立責任，原因是客戶僅於交付貨品及完成安裝之時間點方會接納貨品。因此，採納香港財務報告準則第15號並無對收入確認的時間造成影響。

(b) *識別銷售傢私產品的保養責任*

本集團一般按照法定規定及產品特性就一般維修提供達三至五年的保養，且於與其客戶之銷售傢私產品合約中並無提供延長保養。然而，在若干非標準合約中，本集團提供經延長保養。本集團評估該等保養為服務類保養，故將會作為獨立履約責任入賬，而本集團會就其分配交易價格的一部分。根據時間的推移，收入於其後隨時間確認。

##### *Property lease classification – Group as lessor*

The Group has entered into leases on its investment property portfolio. The Group has determined, based on an evaluation of the terms and conditions of the arrangements, such as the lease term not constituting a major part of the economic life of the building and the present value of the minimum lease payments not amounting to substantially all the fair value of the building, that it retains substantially all the significant risks and rewards incidental to ownership of these properties which are leased out and accounts for the contracts as operating leases.

##### *Classification between investment properties and owner-occupied properties*

The Group determines whether a property qualifies as an investment property, and has developed criteria in making that judgement. Investment property is a property held to earn rentals or for capital appreciation or both. Therefore, the Group considers whether a property generates cash flows largely independently of the other assets held by the Group. Some properties comprise a portion that is held to earn rentals or for capital appreciation and another portion that is held for use in the production or supply of goods or services or for administrative purposes. If these portions could be sold separately or leased out separately under a finance lease, the Group accounts for the portions separately. If the portions could not be sold separately, the property is an investment property only if an insignificant portion is held for use in the production or supply of goods or services or for administrative purposes. Judgement is made on an individual property basis to determine whether ancillary services are so significant that a property does not qualify as an investment property.

##### *物業租賃分類—本集團作為出租人*

本集團已就其投資物業組合訂立租約。本集團按照該等安排之條款及條件之評估為基準，如租期不構成樓宇之經濟壽命的主要部分且最低租賃款項現值不等於樓宇之絕大部分公平值，本集團決定其保留此等物業擁有權附帶之絕大部分重大風險及回報，並按經營租賃租出及將有關合約以經營租賃入賬。

##### *投資物業與自用物業之間的分類*

本集團確定一幢物業是否可列作投資物業，並已制定判斷之準則。投資物業乃持作賺取租金或資金增值或兩者兼有之用途。因此，本集團考慮一幢物業在產出現金流量時，是否大多獨立於本集團所持之其他資產。若干物業乃部分持作賺取租金或資本增值，其餘部分則持作生產或供應貨品或服務或行政用途。如該部分獨立出售(或以融資租賃方式獨立出租)，本集團將獨立處理。如該部分不能獨立出售，則僅在持作生產或供應貨品或服務或行政用途佔極少部分時，該物業方會列作投資物業。釐定輔助服務是否重要至致使物業不被列為投資物業的判斷乃按個別物業基準作出。

#### Estimation uncertainty

The key assumptions concerning the future and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are described below.

#### *Impairment of goodwill*

The Group determines whether goodwill is impaired at least on an annual basis. This requires an estimation of the value in use of the cash-generating units to which the goodwill is allocated. Estimating the value in use requires the Group to make an estimate of the expected future cash flows from the cash-generating units and also to choose a suitable discount rate in order to calculate the present value of those cash flows. The carrying amount of goodwill at 31 December 2025 was HK\$79,979,000 (2024: HK\$79,979,000). Further details are given in note 16 to the consolidated financial statements.

#### *Provision for expected credit losses on trade and other receivables*

The policy for provision for expected credit losses on trade and other receivables of the Group is based on an ECL model. A considerable amount of estimation is required in assessing the available information which includes information about past events, current conditions and forecasts future economic conditions to estimate the ECL. The carrying amounts of trade receivables and other receivables in the consolidated statement of financial position as at 31 December 2025 were HK\$42,209,000 (2024: HK\$22,858,000) and HK\$165,284,000 (2024: HK\$289,481,000), respectively, further details of which are set out in notes 22 and 23 to the consolidated financial statements.

#### 估計的不確定性

於報告期末有關未來的主要假設及其他估計不明朗因素的主要來源載述如下，該等因素極有可能使下一財政年度的資產及負債賬面值出現重大調整。

#### *商譽減值*

本集團最少每年一次釐定商譽有否減值。此要求估計商譽獲分配之現金產生單位之使用價值。估計使用價值要求本集團估計來自現金產生單位之預期未來現金流量，並選擇適當之貼現率以計算該等現金流量之現值。商譽於二零二五年十二月三十一日之賬面值為79,979,000港元(二零二四年：79,979,000港元)。進一步詳情載於綜合財務報表附註16。

#### *應收貿易賬款及其他應收款項的預期信貸虧損撥備*

本集團有關應收貿易賬款及其他應收款項的預期信貸虧損撥備政策乃基於預期信貸虧損模型。於評估包括有關過往事件、現時狀況及預測未來經濟狀況之資料的可供資料時需要大量估計，以對預期信貸虧損進行估算。於二零二五年十二月三十一日，綜合財務狀況表中的應收貿易賬款及其他應收款項賬面值分別為42,209,000港元(二零二四年：22,858,000港元)及165,284,000港元(二零二四年：289,481,000港元)，其進一步詳情載於綜合財務報表內附註22及23。

##### *Estimation of fair value of investment properties*

In the absence of current prices in an active market for similar properties, the Group considers information from a variety of sources, including:

- (a) current prices in an active market for properties of a different nature, condition or location, adjusted to reflect those differences; and
- (b) recent prices of similar properties on less active markets, with adjustments to reflect any changes in economic conditions since the date of the transactions that occurred at those prices; and discounted cash flow projections based on reliable estimates of future cash flows, supported by the terms of any existing lease and other contracts and (when possible) by external evidence such as current market rents for similar properties in the same location and condition, and using discount rates that reflect current market assessments of the uncertainty in the amount and timing of the cash flows.

The carrying amount of investment properties at 31 December 2025 was HK\$242,194,000 (2024: HK\$120,397,000). Further details, including the key assumptions used for fair value measurement, are given in note 14 to the consolidated financial statements.

##### *投資物業之公平值估計*

倘缺乏同類物業於活躍市場的現有價格，則本集團會考慮來自多個來源的資料，包括：

- (a) 不同性質、狀況或地點的物業於活躍市場的現有價格(經調整以反映各項差異)；及
- (b) 活躍程度稍遜的市場所提供同類物業近期價格(經調整以反映自按該等價格進行交易當日以來經濟狀況的任何變動)；及根據未來現金流量所作可靠估計預測的經貼現現金流量，此項預測以任何現有租約及其他合約的條款以及(在可行情況下)外來證據(如地點及狀況相同的類似物業現有市場租金)為憑證，並採用可反映有關現金流量金額及時間不明朗因素當時市場評估的貼現率。

投資物業於二零二五年十二月三十一日的賬面值為242,194,000港元(二零二四年：120,397,000港元)。進一步詳情(包括公平值計量所使用的主要假設)載於綜合財務報表附註14。

##### *Deferred tax assets*

Deferred tax assets are recognised for all unused tax losses to the extent that it is probable that taxable profit will be available against which the losses can be utilised. Significant management judgement is required to determine the amount of deferred tax assets that can be recognised, based upon the likely timing and level of future taxable profits together with future tax planning strategies. The amount of unrecognised tax losses at 31 December 2025 was approximately HK\$110,165,000 (2024: HK\$133,273,000). Further details are contained in note 28 to the consolidated financial statements.

##### *Fair values of unlisted equity investments*

The unlisted equity investments have been valued based on the quoted price from the relevant institutions, its net asset value or a market-based valuation technique as detailed in note 41 to the consolidated financial statements. The valuation requires the Group to determine the comparable public companies (peers) and select the price multiple. In addition, the Group makes estimates about the discount for illiquidity and size differences. The Group classifies the fair values of these investments as Level 2 or Level 3. The derivative instrument has been valued using Black-Scholes model with the underlying equity value determined under market approach. This valuation requires the Group to make estimates about the underlying equity value, risk-free interest rate, volatilities and dividends yield.

The fair values of the unlisted investments at 31 December 2025 were HK\$141,367,000 (2024: HK\$252,558,000). Further details are included in notes 19, 24 and 41 to the consolidated financial statements.

##### *遞延稅項資產*

如有可能有足夠的應課稅溢利抵扣虧損，應就所有未動用的稅項虧損確認遞延稅項資產。這需要管理層運用大量的判斷來估計未來應課稅溢利可能發生的時間和金額，結合未來納稅籌劃策略，以決定應確認的遞延稅項資產的金額。於二零二五年十二月三十一日，未確認的稅項虧損約為110,165,000港元(二零二四年：133,273,000港元)。進一步詳情載於綜合財務報表附註28。

##### *非上市權益投資的公平值*

非上市權益投資乃按綜合財務報表附註41所詳述的相關機構報價、其資產淨值或市場化估值技術估值。有關估值要求本集團釐定可資比較公眾公司(同業)及選擇價格倍數。此外，本集團就低流通性及規模差異的貼現作出估計。本集團將該等投資的公平值分類為第二級或第三級。衍生工具已採用柏力克-舒爾斯模式根據市場法而釐定之相關權益值估值。此估值需要本集團估計相關權益值、無風險利率、波幅及收益率。

於二零二五年十二月三十一日，非上市投資之公平值為141,367,000港元(二零二四年：252,558,000港元)。進一步詳情載於綜合財務報表附註19、24及41。

*Impairment of non-financial assets (other than goodwill)*

The Group assesses whether there are any indicators of impairment for all non-financial assets (including the right-of-use assets) at the end of each reporting period. Indefinite life intangible assets are tested for impairment annually and at other times when such an indicator exists. Other non-financial assets are tested for impairment when there are indicators that the carrying amounts may not be recoverable. An impairment exists when the carrying value of an asset or a cash-generating unit exceeds its recoverable amount, which is the higher of its fair value less costs of disposal and its value in use. The calculation of the fair value less costs of disposal is based on available data from binding sales transactions in an arm's length transaction of similar assets or observable market prices less incremental costs for disposing of the asset. When value in use calculations are undertaken, management must estimate the expected future cash flows from the asset or cash-generating unit and choose a suitable discount rate in order to calculate the present value of those cash flows.

For management purposes, the Group has one single operating and reportable segment, which is the provision of medical care, health care and geriatric care related services and products. All of the Group's operating results are generated from this single segment. During the year, 100% (2024: 100%) of the Group's revenue was generated from customers in Mainland China, and over 65% and 24% (2024: over 92% and 0%) the Group's non-current assets, excluding financial instruments and deferred tax assets, were located in Mainland China and Canada respectively.

Revenue of approximately HK\$17,452,000 (2024: HK\$10,462,000) was derived from sales of goods to a single customer, including sales to a group of entities which are known to be under common control with that customer.

The Group's investment properties consist of four commercial properties, one industrial property and one residential property in Hong Kong, Shanghai and Beijing, the PRC. The directors of the Company have determined that all of the Group's investment properties are commercial properties, based on the nature, characteristics and risks of the properties. The Group's investment properties were revalued on 31 December 2025 based on valuations performed by Vincorn Consulting and Appraisal Limited (2024: Greater China Appraisal Limited), an independent professionally qualified appraiser, at HK\$242,194,000. Each year, the Group's management decides to appoint which external appraiser to be responsible for the external valuations of the Group's properties. Selection criterias include market knowledge, reputation, independence and whether professional standards are maintained.

For the year ended 31 December 2025, amounts of HK\$60,415,000, HK\$16,735,000 and HK\$60,176,000 were transferred from properties under development, property, plant and equipment, and right-of-use assets, respectively, to investment properties, following a change in use of the land for leasing purposes. The land is located at No. 1699, Hongmei South Road, Minhang District, Shanghai, China. Together with a fair value loss on initial recognition of investment properties of HK\$14,532,000, the total amount transferred to investment properties was HK\$122,794,000.

The investment properties are leased to third parties under operating leases, further summary details of which are included in note 15 to the consolidated financial statements.

As at 31 December 2025, the outstanding loan balance is HK\$18,000,000 (2024: HK\$50,000,000) and bearing 5% interest rate per annum. Personal guarantee is provided by Mr. Chan Siu Yeung for Borrower A's performance of its obligations under the relevant loan agreement. The repayment was overdue since 8 April 2021.

Upon maturity of the loan, Borrower A has settled all the outstanding interest to the Group except for the repayment of the principal amount. In June 2021, the Group's legal representatives issued a demand letter to Borrower A and its guarantor demanding the settlement of all outstanding loan amount and default interest. In order to secure the recovery of the loan and reduce the risk of impairment loss, on 13 December 2021, the Group filed an application for arbitration proceedings via the Hong Kong International Arbitration Centre against Borrower A and its guarantor for breaching the loan agreement.

The arbitration was completed on 7 January 2025 and an award in favour of the Group was granted. A leave to enforce was also granted by High Court on 19 February 2025 for enforcement of the award.

On 7 May 2025, the settlement deal was agreed by both parties pursuant to which the Borrower A agreed to repay the loan amount plus interest by installments. Borrower A has repaid the first two installments amounted of HK\$32,000,000 in 2025 according to the schedule and the remaining amount needed be repayable from 2026 to 2031.

(ii) Borrower B is a partnership formed in Canada and is principally engaged in property development in Canada. Borrower B is ultimately owned by Mr. Yu Lu Ning.

As at 31 December 2025, the outstanding loan balance is HK\$93,602,000 (2024: HK\$90,170,000), bearing 10% interest rate per annum but become interest-free since 1 January 2024 (see below for detail). Personal guarantee is provided by Mr. Yu Lu Ning for Borrower B's performance of its obligations under the relevant loan agreements. The loan is repayable on demand.

The development of the relevant property development project in Canada was completed in early 2024 and the handover to customers was conducted during the first half of 2024. There are 38 units remain unsold as at 31 December 2025. Borrower B has proposed to transfer majority of the unsold units to the Group as settlement in kind and the Group is willing to accept such an offer. However, Canada has enacted a law of "Prohibition on the Purchase of Residential Property by Non-Canadians Act" since 2022 which prohibit non-Canadians to purchase, directly or indirectly, any residential property.

Borrower B totally relying on the sales of the unsold units for settlement of the outstanding loan balance, in order to accelerate the sales of the unsold units, Borrower B and the Group has concluded an agreement on 13 November 2024 that:

Based on the recent market environment, it is expected that the remaining properties would be sold in the next three years and the outstanding amount under the loan (including the corresponding interest) is expected to be repaid by the end of 2028. The loan was reclassified to non-current receivables as at 31 December 2025 and an expected credit loss of HK\$50,311,000 (2024: HK\$5,000,000) was recognised during the year, after considering the recent selling prices of properties and the time value of the loan.

#### Reasons for granting of the relevant loans

##### Loans to Borrower A

In 2017, the Group disposed of a property holding company (which held a parcel of land in Beijing) to an independent third party and received total cash consideration of approximately RMB1.23 billion, details of which were disclosed in the circular and announcement of the Company dated 20 June 2017 and 20 July 2017, respectively.

Since then, the Group had sought to identify investment opportunities for the sale proceeds from the said disposal to generate better return to its shareholders, but no suitable targets can be identified having considered the then market uncertainty and the sluggish global economic recovery. As the cash balance of the Group remained relatively high and in order to make better use of the idle funds, the Group has frequently made time deposits in banks in the PRC and Hong Kong to earn interest income. However, as the interest rate of time deposit was relatively low, the Group started to better manage its idle funds by investing in publicly-traded bonds, funds, private equity funds, listed stock in Hong Kong, corporate bonds as well as making private loans to third parties to diversify the income base and enhance the returns. In the circumstances, given that (i) the interest income to be generated from the idle funds; (ii) the interest rates of the loan transactions are generally higher than the then prevailing interest rate for short term fixed deposit; and (iii) the Group could continue to identify investment opportunities to generate better return to its shareholders upon repayment of the loan transactions; and having considered the working capital need and projections of the Group, the provision of the loans to Borrower A would not affect the ordinary business operation of the Group, the entering into of the respective loan transactions in relation to the provision of the loans are fair and reasonable, meet the Group's business strategy and in the interest of the Company and its shareholders as a whole.

##### Loans to Borrower B

The Company started the Health Industrial Park Business in the year ended 31 December 2015 with an aim to develop property with specific value-added elements, such as elderly care related and health related elements. In 2015, the Directors explored the opportunity to invest in overseas in order to diversify the geographical reach of the Group's business, which was heavily focused in the PRC at the time, and came across with an investment opportunity to invest in a property development project in Canada carried out by Borrower B. Since this was the first investment by the Group on overseas property development project, after considering the risk of the project and the difficulty in managing the project, the Directors eventually decided to invest in the project through debt investment to earn stable interest return. Therefore, since 2015, the Group provided several loans to Borrower B according to the progress of the property development.

#### 授出相關貸款的理由

##### 向借款人甲貸款

於二零一七年，本集團向獨立第三方出售一家物業控股公司(該公司持有北京一幅土地)，並收取總現金代價約人民幣12.3億元，有關詳情分別於本公司日期為二零一七年六月二十日及二零一七年七月二十日的通函及公告中披露。

此後，本集團一直尋求就上述出售所得款項物色投資機會，以為其股東帶來更佳回報，但考慮到當時市場的不確定性及全球經濟復甦乏力，未能物色到合適的目標。由於本集團現金結餘仍相對較高，為更善用閒置資金，本集團經常在中國及香港的銀行進行定期存款以賺取利息收入。然而，由於定期存款利率相對較低，本集團開始以更佳方式管理其閒置資金，透過投資公開交易債券、基金、私募基金、香港上市股票、公司債券以及向第三方提供私人貸款等方式，以令收入基礎多元化，提高回報。在此情況下，考慮到(i)閒置資金將產生的利息收入；(ii)貸款交易的利率普遍高於當時的短期定期存款利率；及(iii)償還貸款交易後，本集團可繼續物色投資機會，為其股東帶來更佳回報；及經考慮本集團的營運資金需求及預測，向借款人甲提供貸款不會影響本集團的正常業務營運，與提供貸款有關的各貸款交易之訂立屬公平合理，符合本集團的業務策略，並符合本公司及其股東的整體利益。

##### 向借款人乙貸款

本公司於截至二零一五年十二月三十一日止年度啟動健康產業園業務，旨在開發具有特定增值元素的物業，例如養老相關及健康相關元素。於二零一五年，董事尋求海外投資機會，以令本集團當時主要集中在中國的業務地域範圍多元化，並發現到投資借款人乙在加拿大進行的房地產開發項目的投資機會。由於該項目乃本集團首次投資海外房地產開發項目，考慮到項目的風險及項目管理的難度，董事最終決定透過債權投資的方式投資該項目，以獲得穩定的利息回報。因此，自二零一五年起，本集團根據房地產開發進度向借款人乙提供了多筆貸款。

#### Methodology and basis adopted in determining the impairment loss

The Group performs impairment assessment on loans to third parties under the expected credit losses (“ECL”) model which are estimated by applying a loss rate approach. The loss rate is adjusted to reflect the current conditions and forecasts of future economic conditions, as appropriate. The Directors regularly at each reporting date review the changes in credit risk on loans to third parties since initial recognition. For loans to third parties relating to accounts that are long overdue with significant amounts, known insolvencies or non-response to collection activities, they are assessed individually for impairment allowance. A provision for expected credit loss of HK\$15,000,000 and HK\$50,311,000 was made by the Group for the loan to Borrower A and Borrower B respectively.

- (b) The loans to a joint venture are unsecured, bear interest at 10% per annum and are repayable on demand. The joint venture has become a subsidiary of the Group during the year.

The percentage to be appropriated to such statutory reserve funds is determined according to the relevant regulations in the PRC at 10% or at the discretion of the boards of directors of the respective companies.

#### Other reserves

Other reserves consist of assets revaluation reserve and capital reserve. The asset revaluation reserve arose from the change in use from owner-occupied properties to investment properties carried at fair value. The capital reserve comprises the Group's share of the equity-settled share-based payment reserve in an associate and the reserve arose from the partial disposal of subsidiaries without loss of control.

### 42. FINANCIAL RISK MANAGEMENT OBJECTIVES AND POLICIES

The financial assets of the Group mainly include cash and cash equivalents, restricted bank balances, trade receivables, financial assets at fair value through profit or loss, equity investments designated at fair value through other comprehensive income, a debt investment at fair value through other comprehensive income and deposits and other receivables, which arise directly from its operations. Financial liabilities of the Group mainly include trade payables, other payables and accruals, lease liabilities and interest-bearing bank and other borrowings.

The main risks arising from the Group's financial instruments are foreign currency risk, credit risk and liquidity risk. The board of directors reviews and agrees policies for managing each of these risks and they are summarised below.

#### Foreign currency risk

The Group's businesses are located in the PRC and most of the transactions are conducted in RMB.

The Group's exposure to foreign exchange risks was primarily related to bank balances, other receivables and financial assets denominated in CAD and USD. The Group currently does not have a foreign currency hedging policy. It manages its foreign currency risk by closely monitoring the movements in the foreign currency rates.
