**SUPPLEMENTAL ANNOUNCEMENT
INSIDER INFORMATION: (1) DELAY IN PUBLICATION OF ANNUAL RESULTS
AND (2) SUSPENSION OF TRADING**

Reference is made to the announcement of Asia Cassava Resources Holdings Limited (the “Company”) dated 23 June 2026 in relation to the possible delay in publication of annual results and possible suspension of trading and the announcement dated 3 July 2026 in relation to suspension of trading, respectively (the “Announcements”). Unless otherwise defined, capitalised terms used herein shall have the same meanings as those defined in the Announcements.

The Company would like to provide the following supplementary information as below:

The Board hereby further explained that the Company was not able to publish the Annual Results on 30 June 2026 due to the reason that the auditors have not yet obtained certain confirmations (including, inter alia, banks, debtors/creditors) and valuation reports on certain overseas properties in Thailand and Lao that are required to finalise the audit for the year ended 31 March 2026. As such, additional time is required for the auditors to complete the relevant audit procedures. The Directors will continue to use their best endeavors to assist the auditors to complete the audit work and preliminarily expects that the announcement of the Annual Results will be published on 13 July 2026 which are agreed by the auditors.

SUSPENSION OF TRADING

Pursuant to Rule 13.50 of the Listing Rules, if the issuer fails to publish periodic financial information in accordance with the Listing Rules, the Stock Exchange will normally request suspension of trading in the issuer’s securities and the suspension will normally continue until the issuer publishes an announcement containing the requisite financial information. Accordingly, trading in the shares of the Company on the Stock Exchange will be suspended with effect from 9:00 a.m. on 2 July 2026 until the publication of the announcement in relation to the Annual Results by the Company.

Shareholders and potential investors of the Company are advised to exercise caution when dealing in the shares of the Company.
