**RESULTS**

For the year ended 31st March, 2026, the Group's revenue decreased by 12.6% to approximately HK\$782 million. A loss of approximately HK\$105 million was recorded, compared to a loss of approximately HK\$27million last year.

Looking back on the financial year, the global macro environment was turbulent, with operational challenges persisting throughout the year. In the first half of the year, the monetary policy paths of major economies remained unclear, while the trade dispute between China and the US intensified again. The punitive tariff barriers imposed by the US on many countries directly cooled customers' willingness to place orders, and some major customers deliberately deferred their orders. Entering the second half of the year, geopolitical risks, far from easing, escalated sharply due to the military standoff between the US and Iran in the Strait of Hormuz in early 2026. The threat to this key shipping route not only pushed up global logistics costs, but also severely disrupted the stability of supply chains and delivery timeliness, further affecting the Group's operational flexibility.

Facing heavy pressure on revenue throughout the year, the Group found it difficult in the short term to make substantial adjustments to its existing operating scale and staffing arrangements to match the temporarily contracted business volume. As a result, human resources costs and fixed manufacturing expenses could not be reduced in step with revenue, and their proportion to revenue rose correspondingly. At the same time, the industry became increasingly crowded, and market competition reached fever pitch in the second half of the year. To defend market share in a contracting market, industry peers launched aggressive price wars, and this irrational price competition imposed a double squeeze on the Group's gross profit margin. The combined effect of the above factors led to a significant decrease in gross profit margin of approximately four percentage points compared with last year, which was the core reason for the Group's loss.

**業績**

本集團截至二零二六年三月三十一日止年度的收入約為七億八千二百萬港元，較去年度下跌百分之十二點六。集團年內錄得約一億零五百萬港元虧損，去年同期則錄得約二千七百萬港元虧損。

回顧本財政年度，環球宏觀環境風高浪急，營運挑戰貫穿全年。上半年，主要經濟體貨幣政策路徑混沌未明，加上中美貿易爭端再度激化，美方針對多國實施的懲罰性關稅壁壘，直接冷卻了客戶的下單意願，部分主力客戶採取了明顯的訂單遞延策略。邁入下半年，地緣政治風險非但未見緩解，反而因二零二六年初美國與伊朗在霍爾木茲海峽的軍事對峙而急劇升溫。這一關鍵航運要道遭受威脅，不僅推高了全球物流成本，更嚴重擾亂了供應鏈的穩定性與交貨時效，進一步影響集團的營運靈活性。

面對全年收入的沉重擠壓，集團在短期內難以對既有的經營規模與人力配置進行大幅度調整以匹配短暫萎縮的業務量，使人力資源成本及固定製造費用無法隨著收入同步縮減，佔收入比率因而被動攀升。與此同時，行業賽道擁擠，市場競爭在下半年進入白熱化階段。為了在緊縮的市場中保住份額，同業紛紛發動激進的價格戰，這種非理性的定價廝殺對集團毛利率構成雙重擠壓。上述因素疊加發酵，導致本年度毛利率較去年顯著下跌約四個百分點，乃集團錄得虧損的核心根源。

The knock-on effects of the severe macro environment spread across the Group's three plants in China and the ASEAN market, with the operational resilience of each tested to varying degrees. Both the Guangzhou and Shaoguan plants recorded losses due to reduced export orders and intensified market competition; the Suzhou plant's losses expanded due to delayed orders from major export customers affected by the new round of tariffs imposed by the US government; and although the Southeast Asia plants actively undertook diverted orders, they also recorded losses as they remained in the ramp-up stage and faced increased unit production costs.

Rising trade protectionism and the normalisation of regional conflicts will continue to inject a high degree of uncertainty into the stability of global supply chains. The Group will maintain keen risk awareness at all times, dynamically refine its operating strategies, and accelerate its production capacity footprint expansion in Southeast Asia to fundamentally diversify the operational risks arising from geopolitical rivalry. As for internal momentum, the Group will focus on technological and intelligent upgrades, striving to improve operational efficiency across the entire process and achieve substantive optimisation of its cost structure. In addition, the Group is making every effort to expand non-traditional business areas in Chinese Mainland, including e-commerce, high-end boutique packaging, board games, cultural and creative products of its original brand, TEAM GREEN®, and intellectual property (IP) licensing operations. Through deepened industry-academia-research collaboration and forward-looking technology introduction, the Group will strengthen the added value and differentiation barriers of its products, move its business portfolio towards a more diversified and balanced structure, and lay a solid foundation for consolidating its long-term market position. Details are set out in the section headed "BUSINESS REVIEW AND PROSPECTS".

嚴峻的宏觀環境所引發的連鎖反應，全面波及了集團在中國境內的三個廠區與亞世安市場，各自的營運韌性均面臨著不同程度的考驗。廣州及韶關廠區因外銷訂單減少及市場競爭加劇均錄得虧損；蘇州廠區受美國政府新一輪關稅影響，主要外銷客戶延遲下單，導致虧損擴大；東南亞廠區雖積極承接轉移訂單，但因處於爬坡期階段，單位生產成本上升，同樣錄得虧損。

貿易保護主義升溫與區域衝突常態化，將持續為全球供應鏈的穩定性格局注入高度不確定性。集團將始終保持敏銳的風險感知能力，動態優化經營方針，加速推進東南亞產能佈局，以從根本上分散地緣政治博弈所帶來的營運風險。在內部動能方面，集團將聚焦技術與智能化升級，致力提升全流程運營效率、實現成本結構的實質性優化。此外，集團正全力拓展中國內地電子商貿、高端精品包裝、桌遊、綠團原創品牌文創及知識產權(IP)授權營運等非傳統業務賽道，透過深化產學研協作與前瞻性技術引進，強化產品的附加價值與差異化壁壘，推動業務組合邁向更多元、更均衡的結構，為鞏固市場長遠地位奠定堅實基礎。相關詳細內容請參閱「業務概況及前瞻」章節。

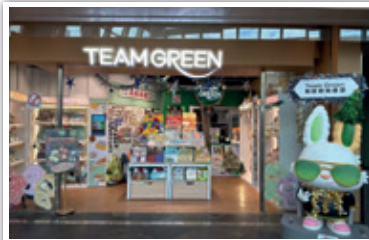

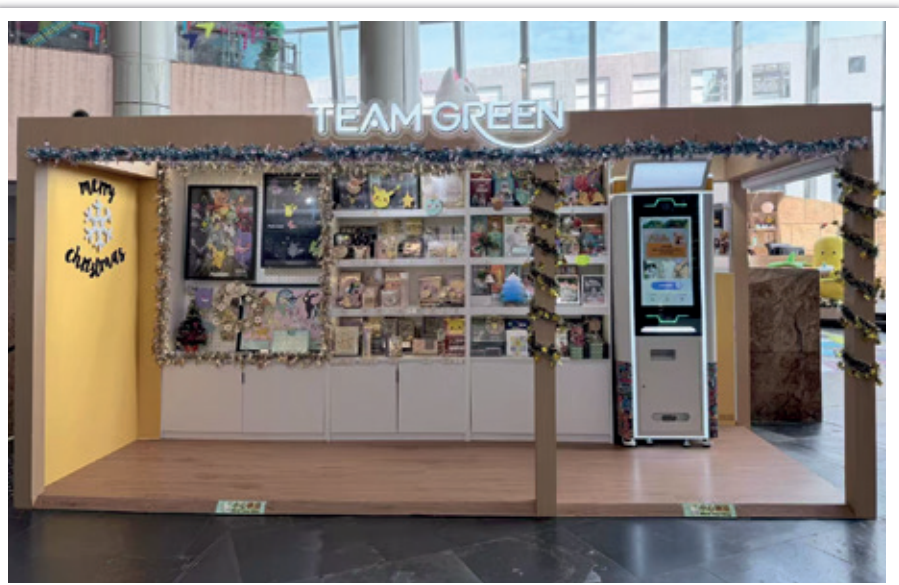

**BUSINESS REVIEW AND PROSPECTS****Hong Kong/Chinese Mainland Operations****Overview**

During the period under review, global manufacturing underwent a profound reshaping of its order and restructuring of value chains. Sharpening geopolitical confrontation and a strong resurgence of trade protectionism, particularly the punitive tariffs imposed by the US on China, presented an unprecedented and severe test for export-reliant printing industry peers in China. Tariff barriers not only directly eroded export profits and substantially weakened price competitiveness, but also catalysed the fragmentation and realignment of global supply chains, compelling the industry to accelerate the pace of shifting production capacity to Southeast Asia. In the face of the turbulent external environment, the Group responded with composure, pursuing a dual-track strategy combining prudent defence with proactive transformation. Internally, we practised lean management, strictly controlled expenses and comprehensively advanced intelligent manufacturing and automation upgrades, striving to cushion the impact of pressure on gross profit margin; externally, we decisively adjusted our global production capacity footprint and accelerated the configuration upgrade of our Malaysia production base, so as to effectively mitigate geopolitical tariff risks and strengthen our resilience and responsiveness in serving multinational customers. At the same time, the Group strategically increased resource investment in high-potential segments such as domestic high-end packaging and cultural and creative products of its own brand, TEAM GREEN®, and through industry-academia collaboration and in-depth technological development, strengthened the premium-pricing power and differentiated positioning of its products, actively incubating new profit engines to pave the way for steady medium- to long-term growth.

**業務概況及前瞻****香港／中國內地業務****概覽**

回顧期內，環球製造業經歷深刻的秩序重塑與價值鏈重構。地緣對立尖銳化及貿易保護主義強勢回潮，尤其美國對華加徵的懲罰性關稅，為一眾依賴出口的中國印刷同業帶來了史無前例的嚴峻考驗。關稅壁壘不僅直接侵蝕出口利潤、大幅削弱價格競爭力，更催化了全球供應鏈的撕裂與重新佈局，倒逼業界加快向東南亞轉移產能的步伐。面對外圍驚濤駭浪，集團沉著應對，奉行審慎防守與主動求變並舉的雙軌策略。對內，我們精益管理、嚴控開支，全面推進智能化製造及自動化升級，竭力緩衝毛利受壓的衝擊；對外，果斷調整全球產能矩陣，全力加快馬來西亞生產基地的配置升級，以有效規避地緣關稅風險，強化服務跨國客戶的韌性與響應能力。與此同時，集團策略性地加大對內銷高端包裝、綠團自家品牌文創產品等高潛力板塊的資源投放，透過產學協作與技術深耕，強化產品溢價能力與差異化定位，積極孵化新的盈利引擎，為中長期穩健增長鋪路。

During the year, despite unabated external headwinds, the Group remained unwavering in its investment in technological innovation, with remarkable R&D results. The production bases secured a total of seventeen patent grants during the year, of which the Guangzhou plant garnered five utility model patents, the Shaoguan plant obtained four utility model patents and one design patent, and the Suzhou plant accounted for seven utility model patents, fully attesting to the Group's deep expertise in process innovation and product development. At the same time, the Group stayed closely attuned to the wave of digitalisation, continuing to deepen the penetration and integration of AI technology across the entire business chain. From intelligent document management and creative design enablement to the precise control of production processes, the deep integration of AI not only substantially improved operational efficiency and decision-making quality, but also built a solid technical backstop for the Group against market volatility. In the field of intelligent manufacturing, the Team Green® dark factory, jointly developed by the Group and the Chinese Academy of Sciences, has commenced full production and operation, successfully achieving fully unmanned operations across production workshops and warehousing and logistics, setting a new benchmark for the industry.

From the perspective of regional operations, the Group's production bases fell short of their targets during the year. In Southern China, the profitability of the Guangzhou and Shaoguan plants came under short-term pressure amid the continued impact of tariff barriers. In Eastern China, the Suzhou plant was significantly dragged down by the postponement of order schedules by major customers of its greeting card business, with both revenue and profit contribution declining and performance falling short of expectations. By contrast, the Southeast Asia market recorded growth in business scale during the year; however, as the relocation of production capacity was still at a critical ramp-up stage, the operational efficiency and workforce proficiency of the production bases required further time to build up, and economies of scale had yet to be fully realised, leaving the region loss-making for the full year.

年內，儘管外圍逆風未減，集團對技術創新的投放始終堅定不移，研發成果斐然。各生產基地年內合計收獲十七項專利授權，其中廣州廠區囊括五項實用新型專利，韶關廠區獲得四項實用新型專利及一項外觀設計專利，蘇州廠區則有七項實用新型專利，充分印證集團在工藝革新與產品研發領域的深厚底蘊。與此同時，集團緊握數字化浪潮脈搏，持續深化人工智能技術於業務全鏈條的滲透與融合。從智慧文檔管理、創意設計賦能，到生產流程的精準調控，人工智能的深度融入，不僅大幅提升了營運效率與決策質量，更為集團抵禦市場波動構築了堅實的技術後盾。在智能製造版圖上，集團與中國科學院攜手打造的綠團黑燈工廠已全面投產運營，成功實現生產車間與倉儲物流環節的全流程無人化運作，樹立行業新標桿。

從區域營運維度審視，年內集團各生產基地未達預期目標。華南板塊的廣州及韶關廠區，在關稅壁壘的持續衝擊下，盈利能力短期受壓。華東地區的蘇州廠區，則因主要賀卡業務客戶訂單計劃推遲而深受拖累，營收體量與利潤貢獻雙雙回落，表現未及預期。反觀東南亞市場，年內業務規模雖錄得增長，惟因產能轉移尚處於爬坡攻堅階段，生產基地的營運效率與人員熟練度仍需時間積累沉澱，規模效應尚未充分釋放，導致該區域全年仍未能擺脫虧損局面。

In the face of the profound reshaping of the global economic landscape and the normalisation of market volatility, the Group maintained its strategic resolve throughout, building a keen dynamic monitoring system to track international trade and economic developments in real time, and flexibly applying a diversified capital allocation approach to capture structural opportunities amid the turbulence. During the year, the Group firmly consolidated its partnerships with core customers and its delivery quality, while accelerating its expansion into non-US markets such as Europe, the Middle East and ASEAN, deepening its domestic new retail and cross-border e-commerce channels, and carefully maintaining key customer relationships. Leveraging its cross-regional supply footprint and delivery flexibility, the Group successfully defended its market share despite the impact of trade barriers. The marketing team made active appearances at international trade exhibitions, including the 30th China Beauty Expo, sparing no effort to develop high-end niche segments such as cosmetics packaging. During the period, the Group also clinched the Gold Award for Book Printing: Children Book at the 36th Hong Kong Print Awards, a top honour that once again attests to the Group's excellence in printing craftsmanship and creative design. In addition, the Group's founder and Chairman, Mr. Lam Kwong Yu, was honoured with the 10th Hong Kong Cultural and Creative Industries Award 2026 presented by the Asia Pacific Creativity Industries Association, in recognition of his outstanding achievements in technology, cultural and creative industries, and environmental protection.

面對全球經濟版圖的深度重塑與市場震盪常態化，集團始終恪守戰略定力，構建敏銳的動態監測體系以實時掌握國際經貿脈搏，並靈活運用多元化資本配置方針，在動盪中捕捉結構性機遇。年內，集團牢牢穩固核心客戶合作關係與交付品質，同步加速開拓歐洲、中東及東盟等非美市場，深耕內銷新零售與跨境電商渠道，同時悉心維繫關鍵客戶，憑藉跨地域供應佈局與交付彈性優勢，在貿易壁壘衝擊下仍成功守住市場份額。營銷團隊積極亮相國際專業展會，包括第三十屆中國美容博覽會，全力開拓美妝包裝等高端細分賽道。期內集團更一舉奪得第三十六屆香港印製大獎書刊印刷「兒童圖書」金獎，此項頂尖殊榮再次印證集團在印刷工藝與創意設計領域的卓越實力。另外集團創辦人林光如主席榮獲亞太文化創意產業總會頒發第十屆香港文化創意產業大獎2026，表揚其在科技、文創、環保三方面的傑出成就。

On another front, riding the policy tailwinds of the HKSAR Government's accelerated development of Hong Kong as a regional intellectual property trading centre, and seizing the historic opportunity presented by the strategies of expanding domestic demand and promoting two-way investment under the national Outline of the 15th Five-Year Plan, the Group strategically launched a flagship new business during the year — Starlite IPC Limited. With IP value realisation and industrialised operation as its core positioning, Starlite IPC focuses on three pillars — brand strategy planning, design and development, and licensing operation — with a business footprint spanning innovative IP incubation, copyright trading, and designer agency and management services. Grounded in the creation, intelligent production and protection of intellectual property, it provides full-chain value enablement — from copyright licensing, strategic conception and design development to marketing — for the cultural-creative and cultural-tourism industries as well as major cultural events. Since its official launch on 1st January, 2026, Starlite IPC has, within a very short time, successfully built an IP agency platform bringing together renowned Asian designers, rapidly established a designer ecosystem and copyright trading hub with strong industry appeal, and seen its brand recognition rise markedly in the licensing market. It has also initially completed the loop from IP incubation and licensing conversion to commercial monetisation, laying a solid foundation for subsequent expansion towards scale and industrialisation, and marking the opening of a new chapter in the Group's development.

### Southern China Operation

For the twelve months ended 31st March, 2026, the Group's Southern China operation suffered a heavy blow from the deterioration of the external trade environment. The US government intensively introduced and implemented a new round of punitive tariffs targeting a wide range of imported Chinese goods, sweeping in product coverage and steep in the rates imposed, which exerted a direct and severe squeeze on the export costs of printed products, packaging materials and cultural and creative products. The rapid pace of this round of tariff policy from formulation to implementation meant that the Southern China operation, anchored on overseas markets as its core pillar, bore the brunt, with its operational resilience severely tested. As tariff costs surged abruptly, end customers in Europe and the US, seeking to pass on their own supply chain cost pressures, widely adopted defensive measures such as reducing order volumes, postponing delivery schedules or seeking alternative production capacity. Under the combined effect of these factors, export orders in Southern China contracted markedly during the year, ultimately resulting in a loss for the region's operations.

另一方面，乘著香港特區政府加快建設區域知識產權貿易中心的政策東風，並把握國家《十五五規劃綱要》推動內需擴張及雙向投資戰略的歷史契機，集團於年內戰略性推出旗艦級新業務——星光文博有限公司。星光文博以IP價值兌現及產業化營運為核心定位，專注於品牌策略規劃、設計開發及授權營運三大支柱，業務版圖橫跨創新型IP孵化、版權交易及設計師代理經理人服務，以知識產權創設、智造與保護為根基，為文創文旅產業乃至大型文化盛事，提供從版權授權、策略構思、設計研發到市場推廣的全鏈條價值賦能。星光文博自二零二六年一月一日正式啟航以來，在極短時間內已成功打造匯聚亞洲知名設計師的IP代理平台，迅速構建起具備行業號召力的設計師生態圈及版權交易樞紐，品牌知名度在授權市場中顯著躍升，並初步打通從IP孵化、授權轉化到商業變現的完整閉環，為後續規模化、產業化擴張奠定堅實根基，標誌著集團發展正式翻開嶄新篇章。

### 華南業務

截至二零二六年三月三十一日止十二個月，集團華南業務板塊深受對外貿易環境惡化的沉重打擊。美國政府針對多類中國進口商品密集出台並實施新一輪懲罰性關稅，覆蓋品類廣泛、加徵幅度淩厲，對印刷製品、包裝物料及文創類產品的出口成本構成直接且猛烈的擠壓。此輪關稅政策從醞釀到落地節奏急促，令以海外市場為核心支柱的華南業務陣地首當其衝，營運韌性備受考驗。關稅成本驟然飆升之際，歐美終端客戶為轉嫁自身供應鏈成本壓力，普遍採取縮減訂單批量、推遲交付時間表或轉尋替代產能等防禦性部署，多重因素疊加下，華南地區外銷訂單於年內出現顯著萎縮，致使該區域業務最終錄得虧損。

Despite the bitter chill in external markets and significant downward pressure on revenue, the Group did not confine itself to passive defence; instead, it treated this adversity as a strategic window for tempering its internal strength and rebuilding its cost competitiveness. To counter the external shocks, the Group accelerated the deep integration of informatisation and its lean production system. In terms of digital foundation upgrades, the Southern China operation fully completed the iterative deployment of a new-generation enterprise resource planning system. This core system seamlessly links supply chain collaboration, production scheduling and financial accounting, achieving full-chain data visibility and visualised control across the business. Its benefits encompass accurate demand forecasting, streamlined procurement and inventory management, and efficient capacity scheduling, significantly improving equipment utilisation and output per employee, and ensuring that production lines maintain flexible, agile and efficient operation even under the structural new normal of increasingly fragmented and small-batch orders. On the lean innovation front, the Southern China team spearheaded a series of automation breakthrough initiatives and process re-engineering projects. During the year, the Shaoguan plant introduced a range of innovative automation equipment, including intelligent cover forming machines, automatic book folding machines, automatic rotary edge rounding machines, visual tracking glue dispensing machines, double grey automatic glueing machines and book sound testing machines, while Southern China secured a total of nine utility model patents for the year, covering independently developed achievements such as automatic feeding machines for laser machines, assembly line page-turning machines and rotary robotic arms. The widespread adoption of automated machinery directly reduced reliance on manual operations and effectively lowered unit production costs, while securing consistent quality and efficiency of output amid fluctuating order volumes.

儘管外圍市場寒風凜冽、營收端承受顯著下行壓力，集團並未止步於被動防守，反而將此逆境視為淬煉內功、重塑成本競爭優勢的戰略窗口期。為抗衡外部衝擊，集團加速推進資訊化建設與精益生產體系的深度交融。在數字化底座升級層面，華南業務板塊已全面完成新一代企業資源規劃系統的反覆運算部署。該核心系統將供應鏈協同、生產排程與財務核算無縫串聯，實現了全鏈條業務的數據穿透與可視化管控。其效益涵蓋精準的需求預判、精簡的採購與庫存管理，以及高效的產能調度，顯著提升了設備使用率與人均產出，確保即便在訂單日趨碎片化、小批量化的結構性新常態下，產線仍能維持靈活敏捷的高效運轉。在精益革新方面，華南團隊全力策動了一系列自動化技術攻關與流程再造項目。年內，韶關廠區導入了多項自動化創新裝備，包括智能天地蓋成型機、自動折書機、自動旋轉圓邊機、視覺跟隨點膠機、雙灰自動上膠機及書本發聲檢測機等；而華南地區全年合計收獲九項實用新型專利，涵蓋鐳射機自動上料裝置、流水線翻頁機、旋轉機械手等自主研發成果。自動化機器的深度普及，直接縮減了對人工作業的依賴，有效壓降單位生產成本，同時在訂單量起伏波動的環境中，穩固了產品輸出的一貫品質與效率。

During the year, the Group's original eco-friendly design brand "TEAM GREEN®" achieved business expansion by leaps and bounds, with brand visibility and market appeal rising in tandem. In terms of retail footprint expansion, having successfully taken root in Hong Kong's core commercial districts, the Langham Place and Peak stores continued to deliver winning results, with Hong Kong tourism-themed products proving the most sought-after; the team also actively introduced products on diverse themes, continually injecting freshness and shopping surprises into the consumer experience. The brand's social buzz and word-of-mouth ratings on Xiaohongshu and other new media platforms climbed steadily, successfully capturing the favour of a large young following, while the synergy between online traffic generation and offline conversion grew increasingly mature. On channel expansion, Team Green® successfully entered four major Hong Kong stores of the renowned retail brand MINISO, where the first batch of products on the shelves immediately sparked a buying frenzy; moving into the second half of the year, the brand entered multiple new sales locations in quick succession, including AEON, Kai Tak Sports Park and Hong Kong souvenir shops, while its distribution network with convenience store giant 7-Eleven expanded substantially to fifty-nine stores, driving a marked jump in the total number of points of sale in Hong Kong and a significant increase in market coverage density. Looking ahead, MINISO will add ten more stores, and 7-Eleven plans to extend distribution to a further fifty stocking points, with channel momentum poised for take-off. In the dimension of IP crossovers and product innovation, Team Green® joined hands in the Chinese Mainland market with the heavyweight intellectual property "The Three-Body Problem" to co-develop a number of co-branded products, and forged partnerships with internationally renowned IP brands such as Pokémon and Bluey, continually enriching its product portfolio and successfully reaching entirely new consumer segments. In addition, the Group launched a new trend brand, Moonlite, to considerable attention during the year; its debut series, including the Hong Kong Babies Blindbox and the Veron Reborn Blindbox, paired distinctive designs with local cultural elements, and the brand quickly made a name for itself, adding a strong new engine of growth to the Group's cultural and creative business footprint.

年內，集團旗下原創環保設計品牌「綠團」(TEAM GREEN®)實現了跨越式的業務擴張，品牌聲量與市場號召力同步攀升。在零售版圖拓展方面，繼成功紮根香港核心商業地段後，朗豪坊及山頂分店業績持續報捷，當中以香港旅遊主題產品最受市場追捧；團隊亦積極引進多元主題產品，不斷為消費者注入新鮮感與購物驚喜。品牌在小紅書等新媒體平台的社交熱度與口碑評價穩步上揚，成功擄獲大批年輕族群的青睞，線上引流、線下轉化的協同效應日趨成熟。渠道拓展方面，綠團成功打入知名零售品牌名創優品(MINISO)位於香港的四大門店，首批上架產品旋即掀起搶購熱潮；進入下半年，品牌更一口氣進駐AEON、啟德體育園、香港手信店等多個全新銷售據點，連同便利店巨頭7-11的鋪貨網絡大幅擴張至五十九家分店，帶動香港整體銷售點大幅度躍升，市場覆蓋密度顯著提高。展望未來，名創優品將再新增十家門店，7-11亦計劃進一步拓展五十個上架點，渠道勢能蓄勢待發。在IP聯乘與產品創新維度，綠團於內地市場攜手重量級知識產權「三體」，聯合開發多個聯名商品，並與寶可夢(POKEMON)、布魯伊(BLUEY)等國際知名IP品牌締結合作關係，產品矩陣持續豐富，成功觸達全新消費圈層。此外，集團於年內矚目推出全新潮流品牌「光之夢」，首發系列包括香港寶寶盲盒及重生獅花豬盲盒，以獨特設計與本地文化元素迅速打響名號，為集團文創業務版圖再添強勁增長。

### Eastern China Operation

In review of the financial year, the Eastern China operation underwent a profound strategic transformation and a reshaping of its business landscape. The Suzhou plant saw its core export greeting card customers defer order deliveries under the heavy impact of trade policy turbulence, resulting in considerable fluctuations in revenue for the year. Facing this sudden demand gap, the management team swiftly activated its contingency mechanism, turning external pressure into a catalyst for internal upgrading and decisively pursuing a market portfolio diversification strategy. During the period, the Suzhou team successfully forged a strategic alliance with a leading service provider in the mainland board game sector, which subsequently helped fill part of the vacated order capacity, building a cushion for business stability. In technological innovation and intelligent manufacturing, the Suzhou plant continued to step up equipment investment and independent R&D, achieving multiple breakthroughs in the intelligence level of its production. On the hardware upgrade front, the plant newly acquired a Heidelberg six-colour printing press, comprehensively raising the capacity and product quality of its printing processes; in parallel, it introduced a batch of automation equipment, including fully automatic cover machines, fully automatic book-shaped box assembly machines, visual multi-function positioning lines and fully automatic cover forming machines, continually optimising its production hardware system. In industry standard-setting, Starlite Suzhou took an active part in the development of the national printing standardisation system, participating in depth in the drafting and formulation of two national standards during the year. In recognition of an outstanding contribution to the work of the Packaging and Printing Sub-technical Committee of the National Technical Committee for Printing Standardisation, the General Manager of Suzhou was awarded the honorary title of "Outstanding Committee Member", fully demonstrating the Group's influence and professional standing in industry standard-setting. At the same time, the Suzhou plant attained the Suzhou Municipal Green Factory accreditation during the year and successively passed a number of authoritative assessments, including occupational health and safety management system certification, energy management system certification and carbon footprint verification, honouring the Group's firm commitment to sustainable development through concrete action and setting a benchmark for green manufacturing.

### 華東業務

回顧本財政年度，華東業務板塊經歷了一場深刻的戰略轉型與格局重塑。蘇州廠區因其核心外銷賀卡客戶深受貿易政策震盪而遞延訂單交付，導致全年營收出現較大幅度起伏。面對突如其來的需求缺口，管理團隊迅速啟動應急機制，將外部壓力化為內部升級的催化劑，果斷推行市場組合多元化戰略。期內，蘇州團隊成功與內地桌遊領域的領軍服務商締結戰略合作聯盟，後續有效幫助填補部份空缺的訂單產能，為業務穩定築起緩衝墊。在技術創新與智能製造方面，蘇州廠區持續加大設備投入與自主研發力度，生產智能化水平實現多項突破。硬件升級層面，廠區新購置海德堡六色印刷機，全面提升印刷環節的產能與產品品質；同步引進全自動封面機、全自動書型盒組裝機、視覺多功能定位線、全自動天地蓋成型機等一批自動化設備，持續優化生產硬件體系。在行業標準引領方面，星光蘇州積極投身國家級印刷標準化體系建設，本年度深度參與兩項國家標準的起草制定工作。憑藉對全國印刷標準化技術委員會包裝印刷分技術委員會工作的卓越貢獻，蘇州總經理獲授予「優秀委員」榮譽稱號，充分彰顯集團在行業規範層面的話語權與專業地位。與此同時，蘇州廠區年內獲得蘇州市綠色工廠評核並先後通過職業健康安全管理体系認證、能源管理体系認證及碳足跡核查等多項權威評審，以實際行動切實履行集團對可持續發展的堅定承諾，為綠色製造樹立標桿。

On another front, the reporting period coincided with the thirty-third anniversary of the Group's listing, and the Suzhou plant grandly hosted the Starlite Group Thirty-Third Listing Anniversary Celebration cum Suzhou Cherry Blossom Festival series of events. This grand occasion brought together business partners, customers from home and abroad, local government representatives and members of the banking sector, and featured a diverse programme including cherry blossom-themed cultural experiences, cultural and creative product exhibitions and a design masters exchange forum, standing as an important marker of the Group's entry into a new stage of development. During the events, visiting guests toured the Suzhou Team Green® production workshops and product showroom in person, gaining an in-depth view of Team Green®'s production floor. The highly automated production lines, intelligent AGV (automated guided vehicle) logistics equipment and advanced production facilities offered a vivid demonstration of the Group's solid foundations in intelligent manufacturing and lean management. The events attracted wide coverage across major media and social platforms, significantly raising the Group's brand recognition and industry influence. Thirty-three years of dedicated cultivation and accumulated strength have fortified the foundations of the Group's development, and the successful conclusion of the celebration also marked the start of a new journey of development for the enterprise.

另一方面，本報告期恰逢集團上市三十三周年，蘇州廠區隆重舉辦星光集團上市三十三周年慶典暨蘇州櫻花節系列活動。本次盛會邀請合作夥伴、國內外客戶、地方政府代表及銀行界人士等共同參與，活動設置櫻花主題文化體驗、文創產品展示、設計大師交流論壇等多元環節，成為集團開啟全新發展階段的重要標誌。活動期間，來訪嘉賓實地走訪蘇州綠園生產車間與產品展廳，深入了解綠園生產現場。高度自動化產線、智能AGV物流設備與先進生產設施，直觀展現了集團在智能製造、精益管理領域的紮實功底。本次活動獲得各大媒體及社交平台廣泛傳播，顯著提升了集團品牌知名度與行業影響力。三十三年的深耕積澱，為集團發展築牢根基，慶典的圓滿結束也標誌著企業正式踏上全新發展征程。

### South East Asia Operation

As a key strategic hub in the Group's global production capacity footprint, the Southeast Asia operation recorded a steady climb in sales during the year, fully attesting to the structural trend of international customers accelerating the migration of orders from traditional manufacturing bases to Southeast Asia. During the period under review, the regionalised restructuring of global supply chains gathered further pace, compounded by the continued escalation of the US-China trade rivalry and the turbulence in the Middle East early in the year that pushed up shipping costs; more and more multinational brand customers placed the diversification of geopolitical risks and the shortening of delivery lead times high on their agendas, and the strategic position of Southeast Asia as an alternative production capacity destination grew ever more prominent. Although the newly undertaken diverted projects remained at the critical ramp-up stage — with equipment run-in and commissioning, optimisation of process parameters and the maturing of front-line workforce skills inevitably pushing up unit production costs in the short term — the Group moved swiftly to assist the local operation with production process optimisation and core technology transfer, effectively accelerating the compression of the learning curve. At the same time, keenly aware that regional demand is shifting from a purely cost-driven contest to competition on integrated services combining high quality and rapid turnaround, the Group has decisively launched the blueprint for its next stage of capacity expansion, covering the introduction of advanced equipment and the upgrading of supporting infrastructure, so as to secure in advance the capacity to absorb customers' continued order ramp-up and to make the best possible preparations for the scaled-up advancement of the Southeast Asia operation.

### 東南亞業務

東南亞業務作為集團全球產能矩陣中的關鍵戰略樞紐，年內銷售額錄得穩健攀升，充分印證了國際客戶訂單從傳統製造基地向東南亞加速遷移的結構性趨勢。回顧期內，全球供應鏈區域化重組步伐進一步加快，疊加中美貿易博弈持續升溫及年初中東局勢動盪推高航運成本，愈來愈多跨國品牌客戶將分散地緣風險、縮短交付周期列為優先議題，東南亞作為替代產能目的地的戰略地位因而愈發凸顯。儘管新承接的轉移項目仍處於產能爬坡攻堅期，設備磨合調試、工藝參數優化及一線人員技能成熟等因素，在短期內無可避免地推高了單位生產成本，但集團已迅速協助當地進行生產流程優化與核心技術轉移，有效加速學習曲線的壓縮進程。與此同時，集團洞悉區域需求正從單一成本導向轉向高品質、高時效的綜合服務競爭，已果斷啟動下一階段產能擴充藍圖，涵蓋先進設備引進及配套基建升級，以提前鎖定客戶對未來訂單持續放量的承載能力，為東南亞業務的規模化躍升做最佳的準備。

As the core base of the Group's deep cultivation of Southeast Asia, the Malaysia plant continued to press ahead in depth along two dimensions during the year: lean operations and the building of a local talent pipeline. As the competitive focus of the global printing and packaging industry shifts from pure price competition to a contest of depth of craftsmanship and speed of service response, a growing number of international customers have firm plans to shift high-value-added product lines, such as high-end colour boxes and boutique packaging, to the Malaysia plant for production, drawing on its superior geographic location, mature supporting ecosystem and the Group's accumulated experience in multinational operations to achieve a dual enhancement of supply chain resilience and product competitiveness. It is foreseeable that, under the combined drivers of gradually released economies of scale and continually accumulating technical capabilities, the Malaysia plant will steadily rise to become a core engine pulling the Group's overall results growth, and will establish a differentiated leading position in the Southeast Asian printing and packaging market.

#### LIQUIDITY AND FINANCIAL RESOURCES

The Group's sources of funding include cash generated from the Group's operations and banking facilities provided to the Group by banks mainly in Hong Kong and Chinese Mainland. As at 31st March, 2026, the Group's cash and bank balances and short-term bank deposits amounted to approximately HK\$121 million (31st March, 2025: HK\$199 million), among which approximately 27% was denominated in Hong Kong dollars, approximately 29% was denominated in Renminbi, approximately 21% was denominated in United States dollars, approximately 9% denominated in Euro and the remaining 14% was denominated in other currencies.

As at 31st March, 2026, the Group's total bank borrowings amounted to approximately HK\$38 million (31st March, 2025: HK\$73.5 million). The bank borrowings are denominated in Hong Kong dollars and Renminbi representing 96% and 4% respectively. As at 31st March, 2026, all of the Group's bank borrowings were guaranteed and/or secured, and with the repayment due dates ranging from 2026 to 2030. As at 31st March, 2026, all the bank borrowings bore floating interest rates.

During the year under review, the interest expense of the Group amounted to approximately HK\$2 million compared to approximately HK\$2 million recorded last year.

馬來西亞廠區作為集團深耕東南亞的核心據點，年內在精益運營與本地人才梯隊建設兩大維度持續縱深推進。隨著全球印刷包裝行業的競爭焦點從純價格比拼轉向工藝深度與服務響應速度的較量，愈來愈多國際客戶明確計劃將高端彩盒、精品包裝等高附加值產品線轉移至馬來西亞廠生產，以借助其優越的地理區位、成熟的配套生態及集團累積的跨國營運經驗，實現供應鏈韌性與產品競爭力的雙重提升。可以預見，在規模效應逐步釋放與技術能力持續積累的疊加驅動下，馬來西亞廠區將穩步躍升為拉動集團整體業績增長的核心引擎，並在東南亞印刷包裝市場中確立差異化領先地位。

#### 流動資金及財務資源

集團的主要資金來源，包括業務經營帶來的現金收入及中港兩地銀行界提供的信貸融資。截至二零二六年三月三十一日，集團的現金和銀行結餘及短期銀行存款共約一億二千一百萬港元（二零二五年三月三十一日：一億九千九百萬港元），其中約27%以港元計值、約29%以人民幣計值、約21%以美元計值、約9%以歐元計值而餘下14%以其他貨幣計值。

截至二零二六年三月三十一日，集團的銀行融資總額共約三千八百萬港元（二零二五年三月三十一日：七千三百五十萬港元）。銀行融資以港元及人民幣列值，分別約為96%及4%。於二零二六年三月三十一日，本集團所有銀行融資均為有擔保及／或有抵押，到期還款日期介乎二零二六年至二零三零年，於二零二六年三月三十一日，全部銀行融資均按浮動利率計息。

回顧年度內，集團的利息支出約為二百萬港元，去年約為二百萬港元。

As at 31st March, 2026, the Group had a working capital surplus of approximately HK\$145 million compared to a working capital surplus of approximately HK\$213 million as at 31st March, 2025. The Group was in net cash position as at 31st March, 2026 and 2025, based on short-term and long-term bank borrowings, lease liabilities and bills payables net of bank balance and cash of approximately HK\$71 million (net cash) (2025: HK\$120 million (net cash)) and shareholders' equity of approximately HK\$504 million (2025: HK\$580 million). The Group's gearing ratio as at 31st March, 2026 was 9.9% (2025: 13.6%), based on short-term and long-term bank borrowings, lease liabilities and bills payables of approximately HK\$50 million (2025: HK\$79 million) and shareholders' equity of approximately HK\$504 million (2025: HK\$580 million).

### CHARGE ON ASSETS

As at 31st March, 2026, certain assets of the Group with an aggregate book carrying value of approximately HK\$8 million (31st March, 2025: HK\$48 million) were pledged to secure the banking facilities of the Group.

### TREASURY POLICY

The Group has adopted a conservative approach towards its treasury policies and thus maintained a healthy liquidity position throughout the reporting period for the year ended 31st March, 2026. The Group strives to reduce exposure to credit risk by performing ongoing credit assessments and evaluations of the financial status of its customers. To manage liquidity risk, the Board closely monitors the Group's liquidity position to ensure that the liquidity structure of the Group's assets, liabilities and other commitments can meet its funding requirements from time to time.

### SIGNIFICANT INVESTMENTS AND MATERIAL ACQUISITIONS AND DISPOSALS

On 13th March, 2026, Hong Kong Inno-Tech Association Limited ("Hong Kong Inno-Tech") (being an indirect wholly-owned subsidiary of the Company), China Greater Bay Area Education Innovative Technology Center Limited ("CGBA-EITC") and StarSphere Innovation Limited (the "JV Company") entered into the Joint Venture Agreement, pursuant to which the parties agreed to (a) Hong Kong Inno-Tech and CGBA-EITC subscribe for shares in the JV Company; (b) form a joint venture through the JV Company with an aggregate share capital of HK\$50,000,000; and (c) regulate their respective rights and obligations in the JV Company. Following the Subscription Completions, the JV Company will be owned as to 70% by CGBA-EITC and 30% by Hong Kong Inno-Tech respectively.

於二零二六年三月三十一日，集團營運資金錄得約一億四千五百萬港元盈餘，而二零二五年三月三十一日則約有二億一千三百萬港元盈餘。集團截至二零二六年及二零二五年三月三十一日為淨現金狀況，乃根據短期及長期銀行貸款、租賃負債及應付票據，減銀行存款及現金約七千一百萬港元（淨現金）（二零二五年：一億二千萬港元（淨現金））與股東權益約五億零四百萬港元（二零二五年：五億八千萬港元）計算。本集團於二零二六年三月三十一日當日的債務權益比率為百分之九點九（二零二五年：百分之十三點六），乃根據短期及長期帶息銀行借款、租賃負債及應付票據約五千萬港元（二零二五年：七千九百萬港元）與股東權益約五億零四百萬港元（二零二五年：五億八千萬港元）計算。

### 資產抵押

於二零二六年三月三十一日，本集團賬面淨值合共約八百萬港元（二零二五年三月三十一日：四千八百萬港元）之資產已按予銀行作為後者授予本集團貸款之抵押。

### 財務政策

本集團針對其財務政策採取審慎態度，因此於截至二零二六年三月三十一日止年度整個報告期間維持穩健的流動資金狀況。本集團致力透過持續進行信貸評估及評估其客戶的財務狀況，減低信貸風險。為管理流動資金風險，董事會密切監察本集團的流動資金狀況，確保本集團的資產、負債及其他承擔的流動資金架構可滿足其不時之資金需求。

### 重大投資和重大收購及出售

於二零二六年三月十三日，香港啟智科技協會有限公司（「香港啟智科技」）（為本公司之間接全資附屬公司）、粵港澳教育科技創新中心有限公司（「粵港澳教育科技創新中心」）與中科星寰創新有限公司（「合營公司」）訂立合營企業協議，據此，訂約方同意：(a) 由香港啟智科技及粵港澳教育科技創新中心認購合營公司之股份；(b) 透過合營公司成立一間股本總額為50,000,000港元之合營企業；及(c) 規定各方於合營公司中的權利與義務。於認購事項完成後，合營公司將由粵港澳教育科技創新中心擁有70%權益及由香港啟智科技擁有30%權益。

As at the date of this annual report, the First Completion (as defined under the Announcement dated 13th March, 2026) has not yet taken place, as the parties to the Joint Venture Agreement are currently in discussions to address the additional time required to fulfil and provide certain completion deliverables in respect of the First Subscription Completion. The Company will make further announcement(s) to keep its shareholders and potential investors informed of any progress as and when appropriate.

Save as disclosed above, the Group did not have any significant investments or material acquisitions or disposals of subsidiaries, associates or joint ventures during the year ended 31st March, 2026.

### EXCHANGE RATE EXPOSURE

All the Group's assets, liabilities and transactions are denominated in Hong Kong dollars, US dollars, Chinese Renminbi, Malaysian ringgit, Singapore dollars or Euro. The exchange rate of US dollars/Hong Kong dollars is relatively stable due to the current peg system in Hong Kong. The Renminbi-denominated sales revenue helps to set off the Group's commitments of Renminbi-denominated operating expenses in Chinese Mainland, accordingly reducing Renminbi exchange rate exposure.

### HUMAN RESOURCES DEVELOPMENT

Currently the Group has approximately 2,600 employees. The Group maintains good relationships with its employees, providing them with competitive packages, incentive schemes as well as various training programmes. The Group has maintained a Share Option Scheme under which share options can be granted to certain employees (including executive directors and non-executive directors of the Company (excluding independent non-executive directors)) as incentive for their contribution to the Group. The Group provides various training and development programmes to staff on an ongoing basis. The Group will explore the possibility of launching other special training programmes with universities in Chinese Mainland and education institutions abroad to enhance its staff quality.

截至本年報之日，由於合資協議各方目前正在協商解決完成和交付某些第一期認購事項完成事項所需額外時間的事宜，因此第一期認購事項完成（「定議見二零二六年三月十三日的公告」）尚未達成。本公司將在適當時候發布進一步公告向股東和潛在投資者公告任何進展。

除上文所披露者外，本集團於截至二零二六年三月三十一日止年度內，並無進行任何重大投資或重大收購或出售附屬公司、聯營公司或合營公司。

### 匯兌風險

本集團大部分資產、負債及交易均以港元、美元、人民幣、馬來西亞元、新加坡元或歐元結算。香港現行之聯繫匯率制度令美元／港元匯率相對穩定。而集團現有以人民幣結算之銷售收益，有助減低集團內地附屬公司以人民幣結算之經營費用所承擔之貨幣風險。

### 人力資源發展

集團現僱用約二千六百名員工。集團與員工一直保持良好關係，除為員工提供合理薪酬和獎勵外，並實施各項員工技能培訓計劃。集團設有購股權計劃，可選擇部分對集團有貢獻的員工（包括本公司執行董事及非執行董事（不包括獨立非執行董事））授予購股權。集團致力為員工提供各項持續性的培訓及人才發展計劃。集團將繼續研究與中國內地的大學和海外的教育機構合作，開辦其他專業實用技術課程。

## CAPITAL COMMITMENTS AND CONTINGENT LIABILITIES

Save as disclosed in Note 29 to the consolidated financial statements, as at 31st March, 2026 the Group did not have any material capital commitments and any material contingent liabilities.

## DIVIDENDS

The Company maintains a dividend policy (the "Policy") and the Board decided the payment of dividends for the year ended 31st March, 2026 in accordance with the Policy.

In view the Group recorded a loss of approximately HK\$105 million for the year ended 31st March, 2026 and in order to retain resources for the Group's future development, the Board of Directors does not recommend the payment of a final dividend for the year ended 31st March, 2026 (2025: Nil). No interim dividend was paid for the six months ended 30th September, 2025 (six months ended 30th September, 2024: HK1 cent). The Group will implement cost control measures and expansion of customer base to improve its operating results.

## SOCIAL RESPONSIBILITY

As a responsible corporation, the Group is committed to promoting social enhancement whilst developing its businesses, through active participation in social welfare and environmental protection activities to realize its mission. Regardless of where the Group operates, the Group treats the local communities as family members and strives to contribute to such communities.

In the past years, the Group has allocated significant resources to energy conservation and environmental protection, provided venues and platforms of training and job opportunities for young people, and actively supported help-poor and schooling campaigns as well as disaster relief efforts in China. Apart from providing financial support, the Group also contributes people and time to various charity drives. In many circumstances, the Group's Chairman makes initiative to organize joint efforts with other enterprises and friends to pool resources together for the maximum benefits of those in need.

## 資本承擔及或然負債

## 股息

鑒於本集團於截至二零二六年三月三十一日止年度錄得虧損約一億零五百萬港元，及為保留資源以供集團發展之用，董事會已議決不派發截至二零二六年三月三十一日止年度之末期股息（二零二五年：零）。並無派發截至二零二五年九月三十日止六個月中期股息（截至二零二四年九月三十日止六個月：港幣1仙）。本集團將實施成本控制措施及擴大客戶基礎，以改善其經營業績。

## LOOKING AHEAD

According to the latest World Economic Outlook report released by the International Monetary Fund in April 2026, the momentum of the global economic recovery has turned more guarded than previously expected. The report notes that the forecast for global economic growth in 2026 has been revised down to the 3.0% level, reflecting the gradual emergence of multiple downside risks, including the continued accumulation of trade barriers, elevated policy uncertainty and deepening geopolitical fractures. Nevertheless, the global economic system continues to demonstrate considerable resilience and adaptability, with enterprises driving the diversification of their supply chain footprints and the reshaping of trade routes with unprecedented vigour, responding with agility to a fast-changing external environment. It is worth noting that economic and trade linkages within Asia are bucking the trend, with trade interdependence among ASEAN and the member states of the Regional Comprehensive Economic Partnership (RCEP) continuing to climb, opening a new window of growth for enterprises in the region.

## 未來展望

根據國際貨幣基金組織於二零二六年四月發佈的最新《世界經濟展望》報告，環球經濟復甦勢頭較此前預期更趨審慎。報告指出，二零二六年全球經濟增速預測已下調至3.0%水平，反映貿易壁壘持續累積、政策不確定性高企及地緣政治裂痕加深等多重下行風險正在逐步浮現。儘管如此，全球經濟體系仍展現出可觀的韌性與適應能力，企業正以前所未有的力度推動供應鏈多元化佈局與貿易路徑重塑，以靈活身段應對瞬息萬變的外部環境。值得注意的是，亞洲區域內的經貿聯動正逆勢增強，東盟及區域全面經濟夥伴關係協定(RCEP)成員國之間的貿易依存度持續攀升，為區內企業打開了新的增長視窗。

Amid a complex and fluid landscape in which opportunities and challenges coexist, the Group will steadfastly uphold its dual-engine core strategy of technological innovation and sustainable development, unswervingly increasing resource allocation to artificial intelligence, clean energy applications and full-process digital transformation, and committing itself to building a smart operations framework with greater foresight and agility. At the same time, the Group will further strengthen cross-regional production capacity synergies and refine its risk early-warning and hedging mechanisms, enhancing its strategic depth in a multipolar world. We will closely capture the institutional dividends arising from the continued deepening of RCEP and the accelerating opening of the ASEAN market, strategically expanding our non-traditional business footprint and high-value-added product portfolio, shifting from passive response to proactive shaping, and striving to forge a globalised supply chain that combines resilience with competitive advantage.

The Group firmly believes that, anchored by the foundation of customer trust accumulated over decades, its deep technical heritage and brand equity widely recognised by the market, and complemented by a prudent, flexible operating philosophy that adapts with the times, it will surely navigate the dense fog of the current cycle, capture structural opportunities amid the turbulence, and continue to create long-term, sustainable value returns for its shareholders, employees and society.

The Directors have the pleasure of presenting their annual report together with the audited financial statements of Starlite Holdings Limited (“the Company”) and its subsidiaries (“the Group”) for the year ended 31st March, 2026.

#### Principal activities

The Company is an investment holding company. Its subsidiaries are principally engaged in the printing and manufacturing of packaging materials, labels and paper products, including environmentally friendly paper products.

Details of the Group’s revenue and segment results are set out in Note 5 to the accompanying financial statements.

#### Business review

A review of the business of the Group during the year as required by Schedule 5 of the Hong Kong Companies Ordinance (Cap. 622) are covered in different sections of this annual report as set out below, which shall form part of this Report of the Directors.

A fair review of the Group’s business, a discussion of the principal risks and uncertainties facing the Group and an indication of likely future development in the Group’s business, can be found in the Chairman’s Statement and Chairman’s Letter set out on pages 7 to 27.

#### Compliance with laws and regulations

The Group has established procedures in place to ensure that its operations comply with applicable laws, rules and regulations. A senior management committee of the Company is delegated by the Board to monitor the Group’s policies and practices for achieving compliance with legal and other regulatory requirements, and such policies and practices are regularly reviewed. Any changes in the applicable laws, rules and regulations are brought to the attention of relevant employees and relevant operating units whenever necessary.

As far as the Company is aware, the Group has complied in all material respects with laws and regulations that have a significant impact on the Group’s business and operations.

#### 主要業務

本公司乃一投資控股公司。其附屬公司主要從事印刷及製造包裝材料、標籤，及紙類製品，包括環保紙類產品。

#### 遵守法律及法規

本集團亦建立程序確保業務運作符合適用的法律、規則及規例。本公司的董事會授權管理委員會監察本集團的政策及守則，以符合法律與其他監管要求，並會定期檢討有關政策及守則。適用的相關法律、規則及規例若有任何變動，本集團會在必要時告知相關員工及營運單位。

就本公司所知，本集團在所有重要議題均符合對本集團業務及營運有重大影響的相關法律及法規的規定。

**Major customers and suppliers**

For the year ended 31st March, 2026, the five largest customers accounted for approximately 20.9% of the Group's total revenue and the five largest suppliers accounted for approximately 25.7% of the Group's total purchases. In addition, the largest customer accounted for approximately 6.3% of the Group's revenue while the largest supplier accounted for approximately 7.2% of the Group's total purchases.

None of the directors, their associates, or any shareholder (which, to the knowledge of the Company's Directors, owned more than 5% of the Company's share capital) had a beneficial interest in the Group's five largest customers or suppliers.

**Relationship with stakeholders**

The Group recognises that employees, customers and business partners are keys to its sustainable development. The Group is committed to establishing a close and caring relationship with its employees, providing quality services to its customers and enhancing co-operation with its business partners.

**Results and appropriations**

Details of the Group's results for the year ended 31st March, 2026 are set out in the consolidated income statement on page 92 of this annual report.

The Board of directors does not recommend the payment of a final dividend for the year ended 31st March, 2026 (2025: Nil). No interim dividend was paid for the six months ended 30th September, 2025 (six months ended 30th September 2024: HK1 cent). The Company strives at ensuring high standards of corporate governance in the interests of shareholders and takes care to identify practices designed to achieve effective oversight, transparency and ethical behavior.

全年會議時間的安排經由董事會於年初商討及批准，每次會議議程內容均在事前充份諮詢各董事會成員意見後，經主席確認制訂。所有會議材料連同會議議程會及時送達全體董事會成員審閱。

All Directors have access to the Company Secretary who is responsible for ensuring that Board procedures are complied with and advises the Board on corporate governance and compliance matters. They are also encouraged to take independent professional advice at the Company's expense in performance of their duties, if necessary. Furthermore, all the Directors are covered by the Directors' & Officers' Liability Insurance, which is also part of our best practices.

所有董事均可聯絡公司秘書，而公司秘書則負責確保董事會符合程序及就企業管治及法規事項向董事會提出意見。本公司鼓勵所有董事於有需要的情況下諮詢獨立專業人士的意見，以履行其職務，有關費用將由公司支付。此外，所有董事均獲得董事及行政人員責任保險保障，有關安排亦屬於本集團最佳常規之一部份。

### Chairman and Chief Executive Officer

Code Provision C.2.1 stipulates that the roles of chairman and chief executive officer should be separate and should not be performed by the same individual. During the period from 1st April, 2025 to 31st December, 2025, the Company does not have a separate Chairman and Chief Executive Officer and Mr. Lam Kwong Yu holds both positions. For the purposes of corporate governance enhancements and for better compliance of Code Provision C.2.1 of Part 2 of the CG code, with effect from 1st January, 2026, Mr. Lam Kwong Yu relinquished his role as the Chief Executive Officer and re-designated as the Executive Chairman of the Company and Ms. Zhao Chunyan was appointed as the Chief Executive Officer of the Company.

Code Provision C.2.7 stipulates that the chairman should at least annually hold meetings with the independent non-executive directors without the presence of other directors. As Mr. Lam Kwong Yu, the Executive Chairman of the Company, is also an Executive Director of the Company, this code provision is not applicable.

### Non-Executive Director

Ms. Yeung Chui has been re-designated from the position of Executive Director to Non-Executive Director upon her retirement. Ms. Yeung has not been appointed for a specific term as she is subject to retirement by rotation and re-election at AGM in accordance with the Bye-laws of the Company.

### Independent Non-Executive Directors

The roles of the Independent Non-Executive Directors include the following:

- participating in board meetings to bring an independent judgement to bear on issues of strategy, policy, performance, accountability, resources, key appointments and standards of conduct;
- take the lead where potential conflicts of interests arise;
- serve on committees if invited; and
- scrutinize performance of the Group and monitor performance reporting.

### 主席及行政總裁

守則條文第C.2.1條規定，應區分主席與行政總裁的角色，並不應由一人同時兼任。於二零二五年四月一日至二零二五年十二月三十一日期內，本公司並無區分主席與行政總裁，林光如先生同時兼任該兩個職位。為了加強企業管治及確保遵守聯交所上市規則附錄C1第二部分所載企業管治常規守則之守則條文第C.2.1條，自二零二六年一月一日起，林光如先生放棄其首席執行長的角色並調職為本公司執行主席以及委任趙春燕女士為本公司首席執行長。

守則條文第C.2.7條規定，主席應至少每年與獨立非執行董事舉行一次無其他董事列席之會議。由於本公司執行主席林光如先生亦為本公司執行董事，故本守則條文並不適用。

### 非執行董事

楊翠女士自退休後，彼由執行董事調職為非執行董事。楊翠女士並無按特定任期委任，彼須按本公司細則於股東週年大會上輪值告退及重選。

### 獨立非執行董事

獨立非執行董事的角色包括下列各項：

- 參與董事會會議，在涉及策略、政策、公司表現、問責性、資源、主要委任及操守準則等事宜上，提供獨立的意見；
- 於出現潛在利益衝突時作出處理；
- 如獲邀請則出任委員會成員；及
- 監察本集團表現，並監察匯報表現的事宜。

The Independent Non-Executive Directors of the Company and their immediate family receive no payment from the Company or its subsidiaries (except the Director fee). No family member of any Independent Non-Executive Directors is employed as an executive officer of the Company or its subsidiaries, or has been so in the past two years. The Independent Non-Executive Directors are subject to retirement by rotation and re-election at the annual general meeting in accordance with the Bye-laws of the Company. Each Independent Non-Executive Director has provided a confirmation of his/her independence with reference to the independence guidelines as set out in the Listing Rules.

The Nomination Committee and the Board has assessed the independence of all the Independent Non-Executive Directors of the Company and considers all of them to be independent having regard to (i) their annual confirmation on independence as required under the Listing Rules, (ii) the absence of involvement in the daily management of the Company and (iii) the absence of any relationships or circumstances which would interfere with the exercise of their independent judgement.

Mr. Chan Yue Kwong, Michael, Mr. Kwok Lam Kwong, Larry, SBS, JP and Mr. Tam King Ching, Kenny have served as Independent Non-Executive Directors of the Company for more than 9 years. In addition to their confirmation of independence in accordance with Rule 3.13 of the Listing Rules, Mr. Chan, Mr. Kwok and Mr. Tam continue to demonstrate the attributes of an independent non-executive director and there is no evidence that their tenure have any impact on their independence. The Nomination Committee and the Board are of the opinion that Mr. Chan, Mr. Kwok and Mr. Tam remain independent notwithstanding the length of their service and believe that their valuable knowledge and experience continue to generate significant contribution to the Company and the shareholders as a whole.

本公司獨立非執行董事及其直屬家眷並無收取本公司或其附屬公司的任何款項(董事袍金除外)。概無任何獨立非執行董事的家族成員現在或於過往兩年受聘為本公司或其附屬公司的行政人員。獨立非執行董事須按本公司的細則於股東週年大會上輪值告退及重選。各獨立非執行董事已根據上市規則所載的獨立指引提供其獨立性的確認書。

提名委員會及董事會已評估本公司所有獨立非執行董事之獨立性，及經考慮(i)根據上市規則要求遞交的獨立性的年度確認書，(ii)其並無參與本公司日常管理，及(iii)且不會有任何關係或情況影響而對其行使獨立判斷有干預，認為本公司所有獨立非執行董事均屬獨立。

陳裕光先生、郭琳廣先生，銀紫荊星章，太平紳士及譚競正先生擔任本公司獨立非執行董事已超過九年。除確認其符合上市規則第3.13條的獨立因素外，陳先生、郭先生及譚先生持續展示獨立非執行董事的特質，並無證據顯示其任期對其獨立性有任何影響。提名委員會及董事會認為，陳先生、郭先生及譚先生縱使長期服務仍保持獨立，而其對本集團業務之寶貴知識與經驗，以及對一般商業之敏銳觸角繼續對本公司及股東整體提供重大貢獻。

Code Provision B.2.4 stipulates that where all the independent non-executive directors of an issuer have served more than nine years on the board, the issuer should (a) disclose the length of tenure of each existing independent non-executive directors on a named basis in the circular to shareholders and/or explanatory statement accompanying the notice of the annual general meeting; and (b) appoint a new independent non-executive directors on the board at the forthcoming annual general meeting ("AGM"). On 28th March, 2023, Ms. Elizabeth Law was appointed as an independent non-executive director of the Company with effect from 1st April, 2023 to fulfil the requirement of Code Provision B.2.4(b).

#### Appointments, Re-election and Removal

There is a formal, considered and transparent procedure for the appointment of new directors to the Board, the primary responsibility of which has been delegated to the Nomination Committee. The structure, size and composition of the Board will be reviewed from time to time by the Nomination Committee to ensure that the Board has a balanced skill and expertise for providing effective leadership to the Company.

In accordance with the Bye-laws of the Company, at each AGM, not less than one-third of the directors shall retire from office by rotation provided that every Director (including those appointed for a specific term) shall retire at least once every three years. The retiring directors shall be eligible for re-election. New appointments either to fill a casual vacancy or as an addition to the Board are subject to re-election by shareholders of the Company at the next following AGM.

#### 委任、膺選連任及撤換

本公司設有一個正式、經審慎考慮並具透明度的新董事委任程序，有關責任已授權予提名委員會執行。提名委員會不時檢討董事會的架構、人數和成員組合，以確保董事會由具備不同技術和專業知識的人士所組成，能為本公司繼續提供有效的領導。

根據本公司細則，於各股東週年大會上不少於三分之一董事須輪值告退，惟各董事(包括受委任特定任期之董事)將至少每三年退任一次，退任董事合資格膺選連任。填補臨時空缺或增加董事會董事名額的新委任須經本公司股東於本公司下屆股東週年大會上重選方可作實。

All Non-Executive Directors including Independent Non-Executive Directors of the Company have not been appointed for a specific term as they are subject to retirement by rotation and re-election at AGM in accordance with the Bye-laws of the Company.

### Responsibilities of Directors

Upon acceptance of appointment, a new Director is provided with sufficient orientation package, including introduction to Group activities (when necessary), induction into their responsibilities and duties, and other regulatory requirements, to ensure that he/she has a proper understanding of the business and his/her responsibilities as a Director of the Company.

All Directors are committed to devote sufficient time and attention to the affairs of the Group. Directors are given guideline on their time commitments to the affairs of the Company. Directors have also disclosed to the Company the number and nature of offices held in Hong Kong or overseas listed public companies or organizations and other significant commitments, with the identity of the public companies or organizations. Directors are reminded to notify the Company in a timely manner of any changes of such information.

### Directors' Continuous Professional Development

To ensure their contributions to the Board remains informed and relevant, all the Directors are encouraged to participate in continuous professional development to develop and refresh their knowledge and skill. During the year, the Company had arranged in-house trainings for Executive Directors and the Non-Executive Director in form of seminar and provision of training materials. In addition, the Company also provided regular updates to the Directors in respect of the business and operations of the Group through monthly reports; and the updates on the changes in Listing Rules, Corporate Governance Code and related regulatory requirements, if any.

### 董事之責任

所有董事已承諾為本集團的事務投入足夠的時間及專注力。董事獲發有關彼等對本公司事務所需投入時間的指引。董事亦已向本公司披露其於香港或海外上市的公眾公司或組織機構所任職務的數目及性質，以及其他重大承擔，並提供有關公眾公司或組織機構的名稱，董事已獲提醒應向本公司及時披露上述資料的任何變動。

### Remuneration Committee

The Remuneration Committee comprises of all the four Independent Non-Executive Directors of the Company, namely Mr. Chan Yue Kwong, Michael (Chairman), Mr. Kwok Lam Kwong, Larry, SBS, JP, Mr. Tam King Ching, Kenny and Ms. Elizabeth Law.

The Remuneration Committee was set up with the responsibility of recommending to the Board the remuneration policy and package of all the Directors and senior management, assessing performance of executive directors and senior management, review and approving annual performance bonus, approving the terms of service contracts of executive directors and senior management and approving matters relating to share schemes of the Company.

The Committee Chairman is required to report to the Board on its proceedings after each meeting on all matters within its duties and responsibilities.

During the year ended 31st March, 2026, the Remuneration Committee approved and recommended to the Board the payment of annual bonus to Executive Directors and reviewed the new service contracts and remuneration package of Executive Directors with reference to the Company's remuneration policy and the Directors' duties and responsibilities. The Remuneration Committee also reviewed and recommended to the Board the remuneration package of the newly appointed Executive Director and Chief Executive Officer of the Company, Ms. Zhao Chunyan and the remuneration package of Mr. Lam Kwong Yu subsequent to his re-designation as Executive Chairman of the Company. The Remuneration Committee also reviewed and recommended to the Board the remuneration package of Mr. Cheung Ching Choi, the proposed candidate to be elected as an independent non-executive director in the forthcoming AGM.

### 董事會授權

#### 董事委員會

於本報告日期，本公司已設立三個董事會轄下委員會（「董事委員會」），並制定有關職權範圍（已於本集團及聯交所網站刊載），該等董事委員會為薪酬委員會、提名委員會及審計委員會。

#### 薪酬委員會

薪酬委員會由本公司之所有四位獨立非執行董事組成，即陳裕光先生（主席）、郭琳廣先生，銀紫荊星章，太平紳士、譚競正先生及羅君美女士。

薪酬委員會的職責為向董事會建議所有董事及高級管理層之酬金政策及薪酬組合，評估執行董事及高級管理層之表現，考慮及批准年度表現獎金及批准執行董事及高級管理層之服務合約條款，審閱及／或批准本公司有關股份計劃的事宜。

委員會主席須於每次會議後向董事會匯報其職責及責任範圍內之所有事項處理程序。

於二零二六年三月三十一日止年度內，薪酬委員會批准及向董事會建議派發執行董事的年度花紅及參考本公司之薪酬政策及董事之職責，審閱執行董事的新服務合約及其薪酬待遇。薪酬委員會亦檢討及向董事會建議本公司新任執行董事及首席執行長趙春燕女士之整體薪酬待遇及林光如先生調職為本公司執行主席後之整體薪酬待遇。薪酬委員會亦審閱並向董事會建議於即將舉行之股東週年大會上選為獨立非執行董事之建議候選人張正才先生之整體薪酬待遇。

The Remuneration Committee is authorised to investigate any matter within its Terms of Reference and seek any information it requires from any employee and obtain outside legal or other independent professional advice at the cost of the Company if it considers necessary. The Remuneration Committee has reviewed the compensation of the Directors and senior executives for 2026.

### Remuneration Policy

The remuneration of Directors and senior executives is determined with reference to their expertise and experience in the industry, the performance and profitability of the Group as well as remuneration benchmarks from other local companies and prevailing market conditions. Executive Directors and employee also participate in bonus arrangements which are determined in accordance with the performance of the Group and the individual's performance.

Director's fee of Executive Directors is HK\$150,000 per annum, Non-executive Directors is HK\$150,000 per annum and Independent Non-Executive Directors is HK\$200,000 per annum.

薪酬委員會獲授權調查屬於其職權範圍內任何事項，並可向任何僱員搜集其需要之任何資料，及徵詢法律或其他獨立專業人士的意見，以履行其職務，有關費用需由公司支付。薪酬委員會已審閱董事及高級行政人員二零二六年之薪酬。

### 薪酬政策

董事與高級行政人員之薪酬是根據他們在業內之專業知識與經驗、本集團之表現和盈利能力，並參考其他本地公司之薪酬基準與現行市場情況而釐定。執行董事與員工亦參與按本集團與個人表現釐定之花紅安排。

執行董事的董事袍金為每年150,000港元，非執行董事為每年150,000港元，及獨立非執行董事為每年200,000港元。

During the year ended 31st March, 2026, total Directors' remuneration amounted to approximately HK\$13,049,000 (2025: HK\$13,241,000) and senior executives' remuneration amounted to HK\$1,182,000 (2025: HK\$1,151,000), individual details of which are disclosed in Note 10 to the financial statements. Executive Directors and senior executives' compensation including incentive bonus shall be based on the corporate and individual performance.

### Nomination Committee

The Nomination Committee comprises of four Independent Non-Executive Directors, namely Mr. Kwok Lam Kwong, Larry, *SBS, JP* (Chairman), Mr. Chan Yue Kwong, Michael, Mr. Tam King Ching, Kenny and Ms. Elizabeth Law, one Non-Executive Director, Ms. Yeung Chui and Executive Chairman of the Board, Mr. Lam Kwong Yu.

The main duties of the Nomination Committee include:

- (a) to review the structure, size and composition (including the skills, knowledge and experience) of the Board, assist the Board in maintaining a board skills matrix, and make recommendations on any proposed changes to the Board;
- (b) to identify individuals suitably qualified to become members of the Board and to select or to make recommendations to the Board on the selection of individuals nominated for directorships;
- (c) to assess the independence of the Independent Non-Executive Directors;
- (d) to make recommendations to the Board on the appointment or re-appointment of Directors and succession planning for Directors; and
- (e) to support the Company's regular evaluation of the Board's performance.

### Nomination Policy

The Board has adopted a nomination policy which sets out the criteria and process in the nomination and appointment of Directors. Below are the nomination procedures and the process and criteria adopted by the Nomination Committee to select and recommend candidates for directorship.

### 提名政策

### Selection Criteria

The Nomination Committee shall consider the following criteria in evaluating and selecting candidates for directorships:

### 提名準則

提名委員會於提名時應考慮多項因素，包括但不限於以下各項：

#### (a) Skills and Experience

The candidate should possess the skills, knowledge and experience which are relevant to the operations of the Company and its subsidiaries.

#### (a) 技能及經驗

人選應具備與本公司及其附屬公司業務相關之技能、知識及經驗。

#### (b) Diversity

Candidates should be considered on merit and against objective criteria, with due regard to the diversity perspectives set out in the Board Diversity Policy of the Company and the balance of skills and experience in board composition.

#### (b) 多元化

應根據人選之長處及客觀標準作考慮，並適當參考載於本公司董事會成員多元化政策中的多元化範疇以及董事會組成的技能和經驗之平衡。

**(c) Commitment**

The candidate should be able to devote sufficient time to attend board meetings and participate in induction, trainings and other board associated activities. In particular, if the proposed candidate will be nominated as an independent non-executive director (“INED”) and will be holding his/her seventh (or more) listed company directorship, the Nomination Committee should consider the reason given by the candidate for being able to devote sufficient time to the Board.

**(d) Standing**

The candidate must satisfy the Board and the Stock Exchange that he/she has the character, experience and integrity, and is able to demonstrate a standard of competence commensurate with the relevant position as a director of the Company.

**(e) Independence**

The candidate to be nominated as an INED must satisfy the independence criteria set out in Rule 3.13 of the Listing Rules.

**Nomination Procedures**

- (a) If the Nomination Committee determines that an additional or replacement director is required, the Committee may take such measures that it considers appropriate in connection with its identification and evaluation of a candidate.
- (b) The Nomination Committee may propose to the Board a candidate recommended or offered for nomination by a shareholder of the Company as a nominee for election to the Board.
- (c) On making recommendation, the Nomination Committee may submit the candidate's personal profile to the Board for consideration. The Board may appoint the candidate(s) as director(s) to fill a casual vacancy(ies) or as an addition to the Board or recommend such candidate to shareholders for election or re-election (where appropriate) at the general meeting.

**(c) 投入時間**

人選應能夠投入足夠時間出席董事會會議，並參加入職引介、培訓及其他與董事會相關之活動。尤其如果建議人選將獲提名為獨立非執行董事並將擔任彼之第七個(或以上)上市公司董事職位時，提名委員會應考慮該人選提出能夠為董事會投入足夠時間之原因。

**(d) 信譽**

人選必須令董事會及聯交所確信彼具備適當的個性、經驗及品格，並證明彼具備足夠的才幹勝任本公司董事相關職務。

**(e) 獨立性**

獲提名為獨立非執行董事之人選必須符合上市規則第3.13條所載之獨立性標準。

**提名程序**

- (a) 如提名委員會確定需要額外增加或替換董事，委員會可採取其認為適當的措施，以物色及評估人選。
- (b) 提名委員會可向董事會建議由本公司股東推薦之人士或提名之膺選人士作為候選董事。
- (c) 於提出建議時，提名委員會可向董事會提交人選之個人簡歷以作考慮。董事會可委任該人選擔任董事以填補臨時空缺或作為額外增加之董事，或向股東推薦該人選以供彼等於股東大會上進行選任或重選(如適用)。

During the year under review, the Nomination Committee reviewed the structure, size and composition (including the skills, knowledge and experience) of the Board, the Board Diversity Policy and the Nomination Policy, and considered that the said policies were appropriate and effective. Further, the Nomination Committee also assessed the independence of all independent non-executive directors of the Company and recommended to the Board for approval of the re-election of the retiring Directors at the 2025 AGM. The Nomination Committee also assessed the background and qualifications of Ms. Zhao Chunyan ("Ms. Zhao") and nominated Ms. Zhao to the Board for her appointment as Executive Director and Chief Executive Officer of the Company with effect from 1st January, 2026.

#### Audit Committee

The Audit Committee comprises of all the four Independent Non-Executive Directors of the Company, namely Mr. Tam King Ching, Kenny (Chairman), Mr. Chan Yue Kwong, Michael, Mr. Kwok Lam Kwong, Larry, SBS, JP, and Ms. Elizabeth Law.

Under its terms of reference, the Audit Committee is required to oversee the relationship between the Company and its external auditors, review with management the financial information, accounting principles and practice adopted by the Group and discussed auditing, risk management and internal control system, and financial reporting matters, including the review of financial statements for the year ended 31st March, 2026.

於回顧年度內，提名委員會檢討董事會之架構、人數及組成(包括技能、知識及經驗方面)、董事會成員多元化政策及提名政策，並認為該等政策為合適及有效。另外，提名委員會也評核所有獨立非執行董事之獨立性，並向董事會建議於二零二五年股東週年大會上通過退任董事之重選。提名委員會亦已評估趙春燕女士(「趙女士」)的背景及資歷，並向董事會提名委任趙女士為本公司執行董事及首席執行長，自二零二六年一月一日起生效。

#### 審計委員會

審計委員會由本公司之所有四位獨立非執行董事組成，即譚競正先生(主席)、陳裕光先生、郭琳廣先生，銀紫荊星章、太平紳士及羅君美女士。

根據審計委員會職權範圍，審計委員會的職責包括監察本公司與外聘核數師的關係、與管理層審議本集團之財務資料、採用之會計準則及常規，及商討審計、風險管理及內部監控系統，以及財務匯報事項，包括審議此等截至二零二六年三月三十一日之年度財務報表。

The Audit Committee has reviewed the interim and annual results for the year ended 31st March, 2026 and was content that the accounting policies of the Group are in accordance with the generally accepted accounting practices in Hong Kong. It also meets twice a year with the Group's external auditor, PricewaterhouseCoopers ("PwC"), to consider their report on the scope, strategy, progress and outcome of their independent review of the annual audit of the consolidated financial statements. During the year ended 31st March, 2026, two meetings were held, attendance of the meetings held by the Audit Committee is set out below:

### Independent Views of the Board

The Company has established mechanisms as detailed below to ensure that a strong independent element on, and independent views and input are available to the Board.

1. to allow the Directors to seek independent professional opinion in respect of the performance of their duties and responsibilities at the cost of the Company to ensure that the Board can obtain independent views and opinions;
2. the Directors (including independent non-executive directors) shall not vote or be counted in the quorum on any board resolution approving any contract or arrangement in which such Director has a conflict of interest; and
3. the Board is required to review its structure, size, composition (including skills, knowledge and experience) and diversity policy at least annually to ensure that the composition of the Board complies with the relevant requirements of the Listing Rules including maintaining a balanced mix of executive and non-executive Directors (including independent non-executive Directors) so that the Board has a strong element of independence which can effectively exercise independent judgment.

The implementation and effectiveness of such mechanism was reviewed on an annual basis. The Board considers that such mechanism has been implemented properly and effectively during the year ended 31st March, 2026.

### Board Performance Evaluation

No formal evaluation of the Board's performance has been conducted during the year ended 31st March, 2026. The Board plans to conduct its performance review during the financial year ending 31st March, 2027 to comply with the CG Code requirement.

### 董事會的獨立意見

本公司已成立機制以確保董事會具備強大獨立元素，且能得到獨立觀點及意見，詳情如下。

1. 允許董事在履行其職責及責任方面尋求獨立的專業意見，費用由本公司承擔，以確保董事會能夠獲得獨立的觀點及意見；

該機制的實施及成效將每年審閱一次。董事會認為已於截至二零二六年三月三十一日止年度期間適當及有效地實施該機制。

### 董事會績效評估

於截至二零二六年三月三十一日止年度，尚未對董事會的績效進行正式評估。董事會計劃於截至二零二七年三月三十一日止之財政年度內進行績效檢討，以符合企業管治守則的要求。

**COMPANY SECRETARY**

Mr. Poon Kwok Ching, Senior Vice Present of the Group, he has been appointed as Company Secretary of the Company with effect from 1st April, 2019. He is responsible to the Board for ensuring that Board procedures are followed and Board activities are efficiently and effectively conducted. These objectives are achieved through adherence to proper Board processes and the timely preparation and dissemination to Directors comprehensive meeting agendas and papers. Minutes of all Board meetings and Board committees are prepared and maintained by the Company Secretary to record in sufficient details the matters considered and decisions reached by the Board or Committee, including any concerns raised or dissenting views voiced by any Director. All minutes are sent to Directors and are available for inspection by any Director upon request.

The Company Secretary is responsible for ensuring that the Board is fully apprised of all legislative, regulatory and corporate governance developments relating to the Group and also responsible for the Group's statutory compliance. The selection, appointment and removal of the Company Secretary is subject to Board approval in accordance with the Bye-laws of the Company. The Company Secretary reports to the Board, all members of the Board have access to the advice and service of the Company Secretary. The Company Secretary of the Company has day-to-day knowledge of the Group's affairs. In response to specific enquiries made, the Company Secretary confirmed that he has complied with all the proposed qualifications, experience and training requirements of the Listing Rules.

Mr. Poon confirmed that he has taken no less than 15 hours relevant professional training during the year.

**公司秘書**

## DIRECTORS' SECURITIES TRANSACTIONS

The Company has also established written guidelines, the Code for Securities Transactions by Employees (the "Employees Code"), with terms no less exacting than the Model Code for securities transactions by employees who are likely to be in possession of unpublished price-sensitive information of the Company. No incident of non-compliance of the Employees Code by the employees was noted by the Company during the year ended 31st March, 2026.

## ACCOUNTABILITY AND AUDIT

### Financial Reporting

The Board is responsible for the preparation of financial statements for each financial period which give a true and fair view of the state of affairs of the Group and of the results and cash flow for that period. In preparing the financial statements for the year ended 31st March, 2026, the Directors have selected suitable accounting policies and applied them consistently; adopted appropriate HKFRS Accounting Standards; made adjustments and estimates that are prudent and reasonable; and have prepared the financial statements on the going concern basis. The Directors are also responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the Company.

The Company provides budget, forecast and monthly updates to the Board to assess the Group's financial performance, position and prospects in sufficient details to enable the Board members to discharge their duties under the Listing Rules.

### Risk Management and Internal Control

The main features of the risk management and internal control systems of the Group are to provide a clear governance structure, policies and procedures, as well as reporting mechanism to facilitate the Group to manage its risks across business operations.

## 董事之證券交易

本公司已就董事進行證券交易採納上市規則附錄C3所載上市發行人董事進行證券交易的標準守則(「標準守則」)，全體董事均已確認，截至二零二六年三月三十一日止年度，彼等一直遵守有關董事進行證券交易之標準守則所載規定標準。

就可能擁有本公司尚未公佈股價敏感資料的僱員進行的證券交易而言，本公司亦制定條款不遜於標準守則的書面指引《僱員進行證券交易守則》(「僱員守則」)。於截至二零二六年三月三十一日止年度，本公司並無發現僱員未有遵守僱員守則的事件。

## 問責性及審核

### 財務匯報

董事有責任就每個財政期間編製真實兼公平反映本集團財務狀況的財務報表以及該期間的業績及現金流量。在編撰截至二零二六年三月三十一日止年度的財務報表時，董事必須採用適當的會計政策及貫徹應用該等會計政策；採納香港會計師公會頒佈適當的香港財務報告會計準則；作出審慎及合理的調整及估計；及按持續經營基準編製財務報表。董事亦須負責保存適當的會計記錄，並可於任何時間以合理準確方式披露本公司的財務狀況。

本公司向董事會成員提供預算、預測和每月詳盡的更新資料，以評估本集團的表現，財務狀況及前景，讓董事會履行上市規則所規定的職責。

### 風險管理及內部監控

本集團的風險管理程序及內部監控系統的主要特點是以清晰的治理架構、政策及程序以及彙報機制，協助本集團管理各業務範疇的風險。

The Group has established a risk management framework, which consists of the Board, the Audit Committee and the senior management of the Group ("Senior Management"). The Board determines the nature and extent of risks that shall be taken in achieving the Group's strategic objectives, and has the overall responsibility for monitoring the design, implementation and the overall effectiveness of risk management and internal control systems. The Board, through the Audit Committee, conducts reviews of the effectiveness of such systems at least annually, covering all material controls including financial, operational, environmental, social and governance ("ESG") performance and reporting as well as compliance controls.

During its annual review, the Board also considers the adequacy of resources, qualifications and experience, training programmes and budget of the Group's accounting, internal audit, financial reporting functions, and those relating to the Company's ESG performance and reporting.

The Group has formulated and adopted Risk Management Policy in providing directions in identifying, evaluating and managing significant risks (including ESG risks). At least on an annual basis, the Senior Management identifies risks that would adversely affect the achievement of the Group's objectives, and assesses and prioritizes the identified risks according to a set of standard criteria. Risk mitigation plans and risk owners are then established for those risks considered to be significant.

In addition, the Group has engaged an independent professional advisor to assist the Board and the Audit Committee in ongoing monitoring of the risk management (including ESG risks) and internal control systems of the Group and in performing the internal audit functions for the Group. Deficiencies in the design and implementation of internal controls are identified and recommendations are proposed for improvement. Significant internal control deficiencies are reported to the Audit Committee and the Board on a timely basis to ensure prompt remediation actions are taken.

本集團已制定風險管理組織框架，由本集團董事會、審計委員會及高級管理層（「高級管理層」）組成。董事會釐定就達成本集團策略目標應承擔的風險性質及程度，並負責風險管理及內部監控系統的設計、實施及整體有效性。董事會透過審計委員會至少每年一次檢討有關系統的有效性，範圍涵蓋所有重大控制措施，包括財務、營運、環境、社會及管治（「環境、社會及管治」）表現及匯報以及合規控制措施。

在年度審查期間，董事會亦會考慮員工資歷及經驗、培訓課程以及本集團在會計、內部審核及財務匯報職能方面的預算以及與本公司環境、社會及管治表現和匯報相關的資源是否足夠。

本集團亦已制定及採納風險管理政策，提供識別、評估及管理重大風險（包括環境、社會及管治風險）的指示。高級管理層至少每年一次識別對實現本集團目標造成不利影響的風險，並根據一套標準準則評估及排列所識別風險的優先次序，從而對主要風險制定風險緩解計劃及指定風險負責人。

此外，本集團外聘獨立專業顧問以協助董事會及審計委員會持續監督本集團的風險管理（包括環境、社會及管治風險）及內部監控系統以及履行本集團的內部審計職能，識別內部監控設計及實施的不足之處並推薦改進建議。重大內部監控缺失會及時向審計委員會及董事會彙報，以確保採取及時補救行動。

Risk management report, internal control report and ESG report are submitted to the Audit Committee and the Board at least once a year. The Board, through the Audit Committee, had performed annual review on the effectiveness of the Group's risk management and internal control systems, including but not limited to the Group's ability to cope with its business transformation and changing external environment; the scope and quality of management's review on risk management and internal control systems; result of internal audit work; the extent and frequency of communication with the Board in relation to result of risk and internal control review; significant failures or weaknesses identified and their related implications; and status of compliance with the Listing Rules.

The Board has assessed the Group's risk management and internal control systems and considers the systems were effective and adequate during the year.

The risk management and internal control systems of the Group are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss.

The Group has the Inside Information Policy which sets out guidelines to the Directors and senior management of the Group to ensure inside information of the Group would be disseminated to the public in equal and timely manner in accordance with applicable laws and regulations.

The Group has established a whistle-blowing policy under which it encourages the employees who have concerns about any suspected misconduct or malpractice within the Group to come forward and voice those concerns to the members of the Audit Committee. Code of conduct to promote and support anti-corruption practices is also set in the staff handbook or inside staff assessable public system.

## CONNECTED TRANSACTIONS AND RELATED PARTY TRANSACTIONS

During the year ended 31st March, 2026, certain transactions between the Group and parties regarded as "related parties" under the applicable accounting standards subsisted. Certain of these related party transactions also constituted connected transactions as defined under the Listing Rules. Details of related party transactions are disclosed in note 31 to the consolidated financial statements.

風險管理報告、內部監控報告及環境、社會及管治報告均至少每年提交予審計委員會及董事會。董事會已透過審計委員會就本集團的風險管理及內部監控系統是否有效進行年度檢討，包括但不限於本集團應付其業務轉型及不斷轉變的外在環境的能力、管理層檢討風險管理及內部監控系統的工作範疇及素質、內部審計工作結果、就風險及內部監控檢討結果與董事會通訊的詳盡程度及次數、已識別的重大監控失誤或弱項以及有關影響，以及就上市規則的合規情況。

董事會已評估本年度本集團的風險管理及內部監控系統有效及充足。

本集團風險管理及內部監控系統旨在管理而非消除未能達成業務目標的風險，且僅可就重大的失實陳述或損失作出合理而非絕對的保證。

本集團設有內幕消息政策，當中列載董事及本集團高級管理層適用之指引，從而確保本集團之內幕消息可遵照適用法律及法規，以公平適時之方式，向公眾發佈。

本集團已制定舉報政策，鼓勵對本集團任何涉嫌不當行為或失職行為有疑慮之僱員挺身而出，向審計委員會成員表達有關事宜。員工手冊或內部員工可接達之公共系統亦載列促進及支持反貪污實踐之行為守則。

## 關連交易及關連人士交易

截至二零二六年三月三十一日止年度內，本集團與適用會計準則稱之為「有關連人士」的人士之間的若干交易仍然存續。若干此等有關連人士交易亦構成關連交易（按上市規則之定義）。關於有關連人士交易的詳情於綜合財務報表附註31中披露。

## AUDITOR'S REMUNERATION

The consolidated financial statements for the year have been audited by PwC. During the year, remuneration of approximately HK\$2,051,000 was for the provision of audit services. In addition, approximately HK\$515,000 was for other non-audit services. The non-audit services mainly consist of tax compliance and advisory services.

## DIVERSITY

### Board Diversity Policy

The Company has adopted a board diversity policy (the "Policy") which sets out the approach to achieve and maintain diversity on the Board in order to enhance the effectiveness of the Board. Pursuant to the Policy, the Company seeks to achieve Board diversity through the consideration of a number of factors, including but not limited to gender, age, cultural and education background, ethnicity, professional experience, skills, knowledge and length of service.

The Nomination Committee will report annually on the composition of the Board under diversified perspective, and monitor the implementation of this policy to ensure its effectiveness. It will discuss any revisions that may be required and recommend such revisions to the Board for consideration and approval.

The Board appointed Ms. Elizabeth Law as an independent non-executive director of the Company with effect from 1st April, 2023 and appointed Ms. Zhao Chunyan as Executive Director and Chief Executive Officer of the Company with effect from 1st January, 2026 which demonstrate the Company's commitment to gender diversity in the Board. As at the date of this report, the Board had three female members, representing approximately 30% of the Board. The Board committed the Company to maintaining an appropriate level of female members on the Board, which shall not be less than 20%.

## 核數師酬金

本年度綜合財務報表已由羅兵咸永道審核。於本年度內，就提供審計服務而計提的酬金約2,051,000港元。此外，就其他非審計服務的款項約為515,000港元。非審計服務主要包括稅務法規及顧問服務。

## 多元化

### 董事會成員多元化政策

本公司已採納董事會成員多元化政策（「該政策」），當中列載董事會為達致及維持成員多元化以提升董事會之有效性而採取之方針。根據該政策，本公司為尋求達致董事會成員多元化會考慮眾多因素，包括但不限於性別、年齡、文化及教育背景、族群特性、專業經驗、技能、知識及服務年資。

提名委員會將每年向董事會報告在多元化層面之成員組合，並監察該政策之執行，確保其行之有效。提名委員會將會討論任何或需作出之修訂建議，再由董事會考慮及批准。

Subject to availability of experienced management personnel in the industry, we have also adopted measures to promote gender diversity in developing a pipeline of female senior management and potential successors to the Board, including putting gender diversity as a strategic priority when sourcing for the Director candidates, forging and keeping relationship with the potential candidates, as well as engaging more resources in training female staff who have long and relevant experience in our business, with the aim of promoting them to the senior management or directorship of the Group.

視乎業內經驗豐富管理人員的可用性，我們亦採取措施推動性別多元化以建立女性高級管理人員及潛在董事繼任人的管道，包括物色董事候選人時以性別多元化為策略重點，與潛在候選人建立及保持關係，以及使用更多資源向擁有長期及相關業務經驗的女性職員提供培訓，旨在推動彼等升任本集團高級管理人員或董事職位。

Depending on the business needs of the Group, the Board will take opportunities to increase the proportion of female members over time as and when appropriate candidates are identified. As at the date of this annual report, the Board is of the view that the Board of the Company satisfied the board diversity policy.

### Workforce diversity

As at 31st March, 2026, the gender ratio of the Group's workforce (including senior management) was 49.6%:50.4% male to female. The Board considers that the Group's workforce (including senior management) are diverse in terms of gender, the overall split of male and female employees across the Group as a whole is relatively balanced. However the technical roles in operating printing press and machinery as well as automation division filled disproportionately by male, whereas the production process mainly filled by female. The Group is working hard to overcome these barriers such as through on the job training, anonymising job applications to help eliminate biases in selection processes and increased job advertisements across a broader range of platforms to reach a wider, more diverse audience.

Diversity and anti-discrimination training is provided during orientation training for all new joiners. Equal opportunity seminars are also provided to all employees on a regular basis to promote diversity and inclusion. We will target to maintain gender diversity in the workforce by continuing to ensure that the proportion of neither gender drops below 40%.

Details of the Group's gender diversity at workforce level are set out in the Group's ESG report published separately.

根據本集團的業務需要，董事會將在物色合適人選時，把握機會逐步增加女性成員的比例。於本年報日期，董事會認為本公司董事會符合董事會多樣性政策。

### 員工多元化

於二零二六年三月三十一日，本集團員工的男女（包括高級管理層）比例為49.6%:50.4%。董事會認為，本集團的員工（包括高級管理層）在性別方面呈現多元化。集團全體員工的男女比例雖然相對平均，但於操作印刷機及其他機械以及自動化部門的技術職位，主要由男性擔任，但生產車間主要為女性擔任。集團竭盡所能解決這些困難，例如透過在職培訓、匿名求職申請，協助在遴選過程中的消除偏見，並在更多不同的平台上刊登招聘廣告，務求覆蓋更廣大、更多元化的受眾。

所有新員工的入職培訓都包含了職場多元化和反歧視的主題。我們亦定期舉辦平等機會研討會，以推廣職場多元化和共融。我們致力維持員工性別多元化，繼續確保男性或女性性別的比例各自不低於40%。

本集團員工層面性別多元化詳情載於本集團單獨刊發之環境、社會及管治報告。

## COMMUNICATION WITH SHAREHOLDERS

Communication with shareholders is given high priority. Extensive information about the Group's activities is provided in the annual report and the interim report. The Group's website ([www.hkstarlite.com](http://www.hkstarlite.com)) provides regularly updated Group information to shareholders. Enquiries on matters relating to shareholdings and the business of the Group are welcome, and are dealt with in an informative and timely manner. The Group encourages all shareholders to attend AGM and Special General Meeting ("SGM"). Notice of the AGM and related papers are sent to shareholders at least twenty-one (21) clear days prior to the date of AGM. All other general meetings (including a special general meeting) may be called by notice in writing of not less than fourteen (14) clear days unless otherwise specified in the Bye-Laws.

The chairmen of all Board Committees are invited to attend the AGM. The Chairman of the Board and the chairman of all the Board Committees are available to answer questions at the AGM. Auditor is also invited to attend the AGM to answer questions about the conduct of the audit, the preparation and content of the auditor's report, the accounting policies and auditor's independence. Pursuant to the Listing Rules, any vote of shareholders at a general meeting will be taken by poll. Detailed procedures for conducting a poll will be explained to the shareholders in the general meeting so that shareholders are familiar with such voting procedures. The poll results will be posted on the websites of the Stock Exchange and the Company on the day of the general meeting. Moreover, a separate resolution will be proposed by the chairman of a general meeting in respect of each substantially separate issue.

The Company has established the Shareholders' Communication Policy setting out the formal channels of communication with shareholders and other stakeholders for ensuring fair disclosure and comprehensive and transparent reporting of the Group's performance and activities, a copy of the policy has been posted to the website of the Group.

## 與股東的聯繫

本公司已制訂股東通訊政策，訂明多種與股東及其他利益相關者的正式溝通渠道，以確保本公司的表現及活動得以公平、全面且具透明度的披露及報告，此政策已登載於本集團的網頁。

During the year ended 31st March, 2026, the Board reviewed the implementation and effectiveness of the Shareholder Communication Policy. The Group's website was updated on a regular basis to maintain an effective ongoing communication with Shareholders and Shareholders could access the latest information of the Company through the Group's website. Information released by the Company to the Stock Exchange was also posted on the Group's website as soon as reasonably practicable thereafter. Shareholders were provided with the opportunities to communicate with the Directors and senior management directly at general meetings. Enquiries from Shareholders were responded within a specific timeframe. Based on the above, the Board was of the view that the Shareholder Communication Policy was effective.

### Shareholders' Rights

In accordance with the Bye-laws of the Company, Directors of the Company shall on the requisition of members of the Company holding at the date of the deposit of the requisition not less than one-tenth of such of the paid up capital of the Company carries the right of voting at general meetings of the Company, shall at all times have the right, by written requisition to the Board or the Secretary of the Company, to require a special general meeting to be called by the Board for the transaction of any business or resolution specified in such requisition and to add resolutions to a meeting agenda; and such meeting shall be held within two (2) months after the deposit of such requisition. If within twenty-one (21) days of such deposit the Board fails to proceed to convene such meeting the requisitionists themselves may proceed to convene a physical meeting at only one location which will be the principal meeting place (as defined in Bye-Law 63).

Details of the procedures for shareholders to convene and put forward proposals at an AGM or SGM are set out in the Company's website. Shareholders may send their enquires requiring the Board's attention to the Company's principal place of business at 3/F., Perfect Industrial Building, 31 Tai Yau Street, Sanpokong, Kowloon, Hong Kong or by e-mail to enquiry@hkstarlite.com. Questions about the procedures for convening or putting forward proposals at an AGM or SGM may also be put to the Company by the same means.

The Company also values and is eager to hear suggestions and comments from shareholders and investors. For enquiries from institutional investors and securities analysts please contact our Company Secretary.

**Dividend Policy**

The Company has established a Dividend Policy which was adopted by the Board to set out the guidelines for the Board to determine (i) whether dividends are to be declared and paid; and (ii) the level of the dividend to be paid to the shareholders. It is the policy to allow the shareholders to participate in the Company's profits whilst to retain adequate reserves for future growth.

In determining/recommending the frequency, amount and form of any dividend in any financial year/period, the Board shall consider the following factors:

- (i) the Group's actual and expected financial performance;
- (ii) the Group's expected working capital requirements and future development plans;
- (iii) the Group's liquidity position;
- (iv) general economic conditions, business cycle of the Group's business and other internal or external factors that may have an impact on the business or financial performance and position of the Company;
- (v) the possible effects on the Group's credit-worthiness, the financial covenants to which the Group is subject and any restrictions on the payment of dividends that may be imposed by the Group's lenders;

**股息政策**

The payment of dividend is also subject to the compliance with applicable laws and regulations, including the laws of Bermuda, the financial reporting standards that the Group has adopted and the Company's Bye-laws.

In view the Group recorded a loss of approximately HK\$105 million for the year ended 31st March, 2026 and in order to retain resources for the Group's future development, the Board of Directors does not recommend the payment of a final dividend for the year ended 31st March, 2026 (2025: Nil). No interim dividend was paid for the six months ended 30th September, 2025 (six months ended 30th September, 2024: HK1 cent). The Group will implement cost control measures and expansion of customer base to improve its operating results.

#### Constitutional Documents

There was no change to the Company's Memorandum of Association and Bye-laws during the year ended 31st March, 2026. A copy of the latest consolidated version of the Memorandum of Association and Bye-laws is posted on the websites of the Company and HKEX.

The Board proposed to amend the existing bye-laws of the Company (the "Existing Bye-laws") for the purposes of, among other things, (i) aligning with the Listing Rules amendments in relation to the uncertificated securities market (USM) regime; (ii) bringing the Bye-laws in line with other relevant requirements of the Listing Rules and applicable laws of Bermuda; and (iii) making other consequential and housekeeping amendments (collectively, the "Proposed Amendments"). The Proposed Amendments are subject to the approval of the Shareholders by way of a special resolution at the forthcoming annual general meeting to be held on 26th August, 2026.

**Mr. Lam Kwong Yu**, aged 79, has been an Executive Director of the Company since 1992. He is the founder of the Group, the Executive Chairman of the Board and a member of the Nomination Committee. He holds a Master degree in business administration and received a Distinguished Alumni Award from the National University of Singapore. Mr. Lam has been involved in community work in China and Hong Kong for many years. He is a member of the Standing Committee of the 10th, 11th and 12th National Committees of the Chinese People's Political Consultative Conference, a director of the Chinese Overseas Friendship Association, a member of the Selection Committee for the Government of the HKSAR and a committee member of the Election Committee Subsector Elections, Chairman of the Mainland Affairs Committee of the Scout Association of Hong Kong, Deputy Chairman of the Federation of Hong Kong Guangdong Community Organizations Charitable Foundation Limited, Chairman of the Polar Museum Foundation, Director of Future Star, an Adjunct Professor of the College of Business of City University of Hong Kong and Director of Guangzhou Jinan University. Mr. Lam has received several prominent awards, including the "Hong Kong Ten Outstanding Young Persons Award 1986", "Young Industrialist Award of Hong Kong 1988", the first "Hong Kong Entrepreneurs Award 1990", the "Outstanding Achievements Award" of the "Hong Kong Print Award 1999" and the "Medal of Honor (M.H.)" from the government of the Hong Kong Special Administrative Region in 2002. She was appointed as director of certain subsidiaries within the Group with effect from 2nd June, 2026. Ms. Zhao is responsible for the Group's strategic planning and overseeing the production and operation of the Shaoguan factory. She has extensive experience in management, production quality control and strategic planning and has over 30 years' of experience in printing and packaging business. She has recently completed the Advanced Training Course on Quality Management and Brand Building of Guangdong Provincial Department of Industry and Information Technology organised by Shanghai Jiao Tong University.

We performed the following procedures to address this key audit matter:

The Group has approximately HK\$319,145,000 of property, plant and equipment ("PP&E"), right-of-use assets ("ROU") and prepayments for non-current assets as at 31st March, 2026, of which approximately HK\$60,550,000, HK\$207,240,000 and HK\$51,355,000 are related to the Group's production plant and machinery, ROU and prepayments for non-current assets in Eastern and Southern China segments and South East Asia segment respectively. The Group's Eastern and Southern China segments and South East Asia segment are three separate Cash Generating Units ("CGUs").

貴集團於二零二六年三月三十一日的物業、廠房及設備（「物業、廠房及設備」）、使用權資產（「使用權資產」）以及非流動資產之預付款約為319,145,000港元，其中約60,550,000港元、207,240,000港元以及51,355,000港元與貴集團分別於華東及華南分部以及東南亞分部的生產廠房及機器、使用權資產以及非流動資產之預付款有關。本集團之華東及華南分部以及東南亞分部為三個獨立現金產生單位（「現金產生單位」）。

Management considered there were impairment indicators for Eastern and Southern China segments and South East Asia segment, as these segments incurred losses during the year ended 31st March, 2026.

Management assessed the recoverable amounts of these CGUs based on the higher of values in use or fair values less cost of disposal. The values in use and fair values less cost of disposal are determined by management based on the future cash flow generated by these CGUs and the market value of these assets respectively. Management engaged independent external valuers to assist them to value these CGUs.

管理層會進行評價以評估各現金產生單位之可收回價值，即其使用價值或其公允價值減出售成本之較高者。管理層分別根據此等現金產生單位所產生的未來現金流量以及此等資產的市場價值，釐定使用價值及公允價值減出售成本。管理層聘請獨立外聘估值師以協助管理層估算此等現金產生單位的價值。

Based on management's impairment assessments, provision for impairment loss of HK\$27,627,000 was recorded for property, plant and equipment and HK\$1,373,000 for right-of-use assets for the year ended 31st March, 2026.

- For value in use calculations, we assessed the management's impairment assessments based on the future cash flow forecasts, by comparing sales growth rates to the underlying assumptions in the latest Board approved budgets and the discount rates to the cost of capital for the Company and comparable organisations. We tested the mathematical accuracy of the calculations of the management's impairment assessments derived from the forecast models and assessed key inputs in the calculations by reference to management's approved budgets. We also checked the key data inputs, on a sample basis, of management's approved budgets by reference to third parties information such as purchase orders, and we assessed the historical reliability of the budgets.

We focused on this area because significant judgements are involved in management's impairment assessments in the determination of the recoverable amounts of the CGUs which are based on various key assumptions and estimates such as sales growth rates and discount rates in the value in use calculations and other assumptions and data inputs such as comparable transactions and market values in determining the fair values.

我們專注於此，是因為管理層的減值評估涉及重大判斷，此乃由於釐定現金產生單位的可收回價值是基於多項關鍵假設及對未來預算的估計，例如銷售增長率及計算使用價值的貼現率及其他假設以及輸入數據，例如可資比較的交易以及市場價值以釐定其公允價值。

- We performed sensitivity analysis on the key assumptions underlying management's impairment assessments based on the cash flow forecasts and valuation by considering the variables and fluctuations in those underlying key assumptions by checking to available market information and other supporting evidence.

- We assessed the adequacy of the disclosures related to impairment of property, plant and equipment and right-of-use assets in the context of HKFRS Accounting Standards disclosure requirements.

Based on the procedures performed above, we considered the key assumptions and estimates used by management in assessing the impairment of property, plant and equipment, right-of-use assets and prepayments for non-current assets to be supportable.

If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

**Responsibilities of Directors and the Audit Committee for the Consolidated Financial Statements**

The directors of the Company are responsible for the preparation of the consolidated financial statements that give a true and fair view in accordance with HKFRS Accounting Standards as issued by the HKICPA and the disclosure requirements of the Hong Kong Companies Ordinance, and for such internal control as the directors determine is necessary to enable the preparation of consolidated financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the consolidated financial statements, the directors are responsible for assessing the Group's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the directors either intend to liquidate the Group or to cease operations, or have no realistic alternative but to do so.

The Audit Committee is responsible for overseeing the Group's financial reporting process.

**1 General information**

Starlite Holdings Limited (the “Company”) is an investment holding company. Its subsidiaries are principally engaged in the printing and manufacturing of packaging materials, labels and paper products, including environmentally friendly paper products. The Company and its subsidiaries are collectively referred to the “Group”.

The Company was incorporated in Bermuda on 3rd November, 1992, as an exempted company with limited liability under the Companies Act 1981 of Bermuda. The address of its registered office is Victoria Place, 5th Floor, 31 Victoria Street, Hamilton HM 10, Bermuda and its principal place of business is 3/F, Perfect Industrial Building, 31 Tai Yau Street, Sanpokong, Kowloon, Hong Kong. The Company’s shares have been listed on The Stock Exchange of Hong Kong Limited since 1993.

These consolidated financial statements are presented in Hong Kong dollars (“HK\$”), unless otherwise stated.

**2 Basis of preparation**

The consolidated financial statements of the Group have been prepared in accordance with HKFRS Accounting Standards (“HKFRSs”), as issued by the Hong Kong Institute of Certified Public Accountants (“HKICPA”), and the disclosure requirements of the Hong Kong Companies Ordinance. The consolidated financial statements have been prepared under the historical cost convention, except for financial assets at fair value through other comprehensive income and financial assets at fair value through profit or loss which are measured at fair value.

**1 一般資料**

星光集團有限公司(「本公司」)乃一家投資控股公司。其附屬公司的主要業務為印刷及製造包裝材料、標籤及紙類製品，包括環保紙類產品，本公司及其附屬公司統稱(「本集團」)。

本公司於一九九二年十一月三日根據百慕達公司條例(1981)於百慕達註冊成立為獲豁免有限公司。其註冊辦事處地址為Victoria Place, 5th Floor, 31 Victoria Street, Hamilton HM 10, Bermuda及其主要營業地址為香港九龍新蒲崗大有街三十一號善美工業大廈三樓。本公司股份自一九九三年起於香港聯合交易所有限公司上市。

除另有指明外，此等綜合財務報表以港元(「港元」)呈列。

**2 編製基準**

本集團綜合財務報表乃按照香港會計師公會(「香港會計師公會」)頒佈之香港財務報告準則會計準則(「香港財務報告準則」)及香港公司條例之披露規定而編製。除按公允價值計入其他全面收益的金融資產及按公允價值計入損益的金融資產按公允價值計量外，綜合財務報表乃按歷史成本法編製。

The preparation of consolidated financial statements in conformity with HKFRSs requires the use of certain critical accounting estimates. It also requires management to exercise its judgement in the process of applying the Group's accounting policies. The areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the consolidated financial statements, are disclosed in Note 4.

Further information about those HKFRSs that are expected to be applicable to the Group is described below.

HKFRS 18 introduces new requirements for presentation within the consolidated statement of comprehensive income, including specified totals and subtotals. Furthermore, entities are required to classify all income and expenses within the statement of profit or loss into one of five categories: operating, investing, financing, income taxes and discontinued operations, whereof the first three are new. It also requires disclosure of newly defined management defined performance measures, subtotals of income and expenses, and includes new requirements for aggregation and disaggregation of financial information based on the identified “roles” of the primary financial statements and notes. In addition, narrow-scope amendments have been made to HKAS 7 Statement of Cash Flows, which include changing the starting point for determining cash flows from operations under the indirect method, from “profit or loss” to “operating profit or loss” and removing the optionality around classification of cash flows from dividends and interest. There are also consequential amendments to several other standards. HKFRS 18 is effective for reporting periods beginning on or after 1st January, 2027, but earlier application is permitted and must be disclosed. HKFRS 18 will apply retrospectively. The new requirements are expected to impact the Group’s presentation of the statement of profit or loss and disclosures of the Group’s financial performance. So far, the Group considers that the adoption of HKFRS 18 is unlikely to have a significant impact on the Group’s results of operations and financial position.

The Group's principal activities expose it to a variety of financial risks: market risk (including foreign exchange risk, fair value interest rate risk and cash flow interest rate risk), credit risk, liquidity risk and price risk. The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance. Risk management is carried out by senior management of the Group under policies approved by the Board of Directors of the Company.

###### (i) Foreign exchange risk

Subsidiaries of the Company operate in the People's Republic of China ("PRC"), Hong Kong, Singapore and Malaysia with most transactions denominated in either Renminbi ("RMB"), Hong Kong dollars, Singapore dollars ("SGD"), United States dollars ("US\$") or Malaysian ringgit ("RM"). The Group is exposed to foreign exchange risk primarily through sales and purchases transactions that are denominated in a currency other than the functional currency of the relevant subsidiary. The Group considers its foreign currency exposure mainly arises from the exposure of RMB and SGD against Hong Kong dollars and/or US\$. As Hong Kong dollars is pegged to US\$, the Group believes the exposure of transactions denominated in US\$ which are entered by group companies with a functional currency of Hong Kong dollars to be insignificant.

The Group manages its exposures to foreign currency transactions by monitoring the level of foreign currency receipts and payments. The Group ensures that the net exposure to foreign exchange risk is kept to an acceptable level from time to time. The Group also regularly reviews the portfolio of local and international customers and the currencies in which the transactions are denominated so as to minimise the Group's exposure to foreign exchange risk.

本公司之附屬公司於中國(「中國」)、香港、新加坡及馬來西亞經營業務，大部份交易主要以人民幣(「人民幣」)、港元、新加坡元(「新加坡元」)、美元(「美元」)或馬來西亞元(「馬來西亞元」)計值。本集團所承擔之外匯風險主要來自有關附屬公司之銷售及採購交易以功能貨幣以外之貨幣結算。本集團認為其匯風險主要來自人民幣及新加坡元兌換港元及／或美元的風險。由於港元與美元掛鈎，本集團相信以港元作為功能貨幣的集團公司訂立以美元計算的交易須承受的風險並不重大。

本集團通過監控外幣收入及支付水平管理其外幣交易所承受之風險。本集團確保其不時之外匯風險淨額維持在可接受的範圍內。本集團亦經常審閱本地及國際客戶的組合及交易計值之貨幣，以將集團的外匯風險降至最低。

The credit risk of the Group mainly arises from trade receivables and deposits with banks and financial institutions.

Credit risk on trade debtors is managed by the managements of the individual business units and monitored by the Group's management on a group basis. Most customers are sizable and renowned. Management assesses the credit quality of smaller customers by considering their financial position, past experience therewith and other relevant factors. The utilisation of credit limits is regularly monitored. Debtors with overdue balances will be requested to settle their outstanding balances.

At 31st March, 2026, the Group had a concentration of credit risk as 25% (2025: 30%) of the total trade receivable were due from the Group's five largest customers and 9% (2025: 14%) of the total trade receivable were due from the Group's largest customer.

To measure the expected credit losses, trade receivables have been grouped based on shared credit risk characteristics and the days past due.

The Group categorises its trade receivables, based on the nature and geographical areas of the business, shared credit risk characteristics and ageing profile collectively. The expected credit loss rates are determined based on past repayment history and historical credit losses experience. The expected credit loss rates are adjusted to reflect current and forward-looking information on macroeconomic factors affecting the ability of the customers to settle the receivables.

Trade receivables are written off when there is no reasonable expectation of recovery. Indicators that there is no reasonable expectation of recovery include, amongst others, the failure of a debtor to engage in a repayment plan with the Group.

Impairment losses on trade receivables are presented as net impairment losses within operating loss. Subsequent recoveries of amounts previously written off are credited against the same line item.

Deposits and other receivables are subject to impairment requirement of HKFRS 9. The credit quality of deposit and other receivables has been assessed with reference to historical information about the default rates and financial position of the counterparties. Management is of the opinion that the credit risk of deposits and other receivables is low due to the sound collection history and financial stability of the counterparties. Therefore, expected credit loss rate of the deposits and other receivables is assessed to be immaterial as of 31st March, 2026 and 2025.

The Group has policies that limit the amount of credit exposure to any individual financial institution. The Group's bank deposits are all deposited in renowned and established banks or financial institutions in Hong Kong, Singapore, Malaysia and the PRC. Management considers that the credit risk associated with deposits with banks and financial institutions is low.

當貿易應收賬款無合理預期可以收回，即予以沖銷，合理預期收回的指標其中包括債務人與本集團無法達成任何還款計劃。

貿易應收賬款減值虧損於經營虧損中以減值虧損淨額呈列，其後追回以前已沖銷的金額於同一項目中計入。

Prudent liquidity risk management implies maintaining sufficient cash and the availability of funding through an adequate amount of committed credit facilities. Due to the dynamic nature of the underlying businesses, the Group's management aims to maintain flexibility in funding by maintaining availability under committed credit lines.

Management monitors rolling forecasts of the Group's liquidity reserve which comprises cash and cash equivalents and bank deposits with maturity over 3 months from date of deposits (Note 21) and undrawn borrowing facilities (Note 30) on the basis of expected cash flows.

The table below analyses the Group's non-derivative financial liabilities into relevant maturity groupings based on the remaining period at the date of statement of financial position date to contractual maturity date. The amounts disclosed in the table are the contractual undiscounted cash flows. Balances due within twelve months equal their carrying balances, as the impact of discounting is not significant.

The Group is exposed to price risk arising from its investments in equity securities which are classified on the consolidated statement of financial position as financial assets at fair value through other comprehensive income. To manage its price risk arising from investments in equity securities, the Group diversifies its investment portfolio.

The equity securities invested by the Group are publicly traded on The Hong Kong Stock Exchange.

At 31st March, 2026, if the prices of the equity securities invested by the Group had been lower/higher by 10%, with all other variables held constant, the Group's equity would have been approximately HK\$104,000 (2025: HK\$120,000) lower/higher.

The fair value of the unlisted insurance policies invested by the Group will fluctuate, subject to the returns which are at the discretion of the issuer of the insurance policies. Such policies have a minimum guaranteed returns during the holding period. Management is of the opinion that the price risk arising from these policies is insignificant.

The Group's objectives when managing capital are to safeguard the Group's ability to continue as a going concern in order to provide returns for shareholders and benefits for other stakeholders and to maintain an optimal capital structure to reduce the cost of capital.

In order to maintain or adjust the capital structure, the Group may adjust the amount of dividends paid to shareholders, repurchase the Company's shares, return capital to shareholders, issue new shares or sell assets to reduce debt.

The Group monitors capital on the basis of the net gearing ratio. This ratio is calculated as net debt divided by total capital. Net debt is calculated as total borrowings (including current and non-current borrowings, bill payables and lease liabilities as shown in the consolidated statement of financial position) less cash and cash equivalents. Total capital is calculated as "equity", as shown in the consolidated statement of financial position.

#### 3.3 Fair value estimation (Continued)

##### (a) *Financial instruments in level 1*

The fair value of financial instruments traded in active markets (such as publicly traded derivatives, and equity securities) is based on quoted market prices at the end of the reporting period. The quoted market price used for financial assets held by the Group is the current bid price. These instruments are included in level 1.

##### (b) *Financial instruments in level 2*

The fair value of financial instruments that are not traded in an active market (for example, over-the-counter derivatives) is determined using valuation techniques which maximise the use of observable market data and rely as little as possible on entity specific estimates. If all significant inputs required to fair value an instrument are observable, the instrument is included in level 2.

##### (c) *Financial instruments in level 3*

If one or more of the significant inputs is not based on observable market data, the instrument is included in level 3. This is the case for unlisted equity securities and for instruments where climate risk gives rise to a significant unobservable adjustment (Note 18).

**4 Critical accounting estimates and judgements**

Estimates and judgments are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

The Group makes estimates and assumptions concerning the future. The resulting accounting estimates will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are discussed below.

**(a) Impairment of non-financial assets**

The Group conducts impairment reviews of assets when events or changes in circumstances indicate that their carrying amounts may not be recoverable or annually in accordance with relevant accounting standards. An impairment loss is recognised when the carrying amount of an asset is lower than the greater of its fair value less costs of disposal and value in use. In determining the value in use, management assesses the present value of the estimated future cash flows expected to arise from the continuing use of the asset and from its disposal at the end of its useful life. In determining the fair value less costs of disposal, management estimates the present value of the estimated future cash flows expected to arise from the asset using the discounted cash flow method, less the incremental costs directly attributable to the disposal of the asset.

Management judgement is required in the area of asset impairment particularly in assessing: (i) whether an event has occurred that may indicate that the related asset values may not be recoverable; (ii) whether the carrying value of an asset can be supported by the recoverable amount, being the higher of fair value less costs of disposal and value-in-use which is the net present value of future cash flows which are estimated based upon the continued use of the asset in the business; and (iii) the appropriate key assumptions to be applied in preparing cash flow forecast including whether these cash flow forecast is discounted using an appropriate rate. Changing the assumptions selected by management in assessing impairment, including the discount rates, the gross profit margin or the revenue growth rate assumptions in the cash flow forecast, could affect the net present value used in the impairment test and as a result affect the Group's financial position and results of operations.

##### (a) Impairment of non-financial assets (Continued)

As at 31st March, 2026, the Group has certain non-financial assets, including property, plant and equipment, right-of-use assets and prepayments for non-current assets in the Eastern China segment, the Southern China segment and the South East Asia segment, amounting to approximately HK\$60,550,000, HK\$207,240,000 and HK\$51,355,000 respectively. Management assessed the impairment indicators of the Cash Generating Units ("CGUs") whenever events or changes in circumstances indicate the carrying amount of a CGU may not be recoverable. Management considered the Eastern China segment, Southern China segment and South East Asia segment as separate CGUs. Management considered there were impairment indicators for Eastern and Southern China segments and South East Asia segment, as these segments incurred losses during the year ended 31st March, 2026. Management has performed impairment assessments on these CGUs. Management has also performed sensitivity analysis over the key assumptions of the cash flow forecasts and valuation, including future revenue growth rate, gross profit margin, discount rate and unit price per square meter, in order to assess the potential impact of a range of possible outcomes. Details are disclosed in Note 14.

##### (b) Net realisable value of inventories

Net realisable value of inventories is the estimated selling price in the ordinary course of business, less estimated costs of completion and applicable variable selling expenses. These estimates are based on current market conditions and the historical experience of manufacturing and selling products of a similar nature. It could change significantly as a result of changes in customer taste and competitor actions in response to industry cycles. Management reassesses these estimates at the end of each reporting period.

##### (a) 非金融資產減值(續)

##### (b) 存貨可變現淨值

存貨可變現淨值指日常業務估計售價扣除估計完工成本及銷售開支。有關估計根據現行市況及過往製造及出售類似產品之經驗而作出。相關估計可能因客戶口味及競爭對手對抗行業週期而出現重大變動。管理層於每個報告結束日重新評估此等估計。

**4 Critical accounting estimates and judgements (Continued)****(c) Impairment of financial assets**

The loss allowances for financial assets are based on assumptions about risk of default and expected loss rates. The Group uses judgement in making these assumptions and selecting the inputs to the impairment calculation, based on the Group's past history, existing market conditions as well as forward looking estimates at the end of each reporting period. Details of the key assumptions and inputs used are disclosed in Note 3.1(b).

**(d) Fair value of financial assets**

For the fair values of financial assets not traded in an active market, the Group would use the quoted price provided by counterparty to estimate the fair values. For the fair values of financial assets not based on observable market data, the Group would use other valuation approaches to measure the fair values. The methodologies, models and assumptions used in valuing these financial assets require judgement by management which are mainly based on market conditions existing at each reporting date.

Contract liability is the obligation to transfer goods or services to a customer for which the Group has received a consideration (or an amount of consideration that is due) from the customer. If a customer pays the consideration before the Group transfers goods or services to the customer, a contract liability is recognised when the payment is made or the payment is due (whichever is earlier). Contract liabilities are recognised as revenue when the Group performs under the contract.

The Group has arranged for its Hong Kong employees to join the Hong Kong Mandatory Provident Fund Scheme (the "MPF Scheme"), which is a defined contribution scheme managed by independent trustees. Under the MPF Scheme, each of the group companies (the employer) and its employees make monthly contributions to the scheme at 5% of the employees' earnings as defined under the Hong Kong Mandatory Provident Fund legislation. The monthly contributions of each of the employer and the employee are subject to a cap of HK\$1,500 and thereafter contributions are voluntary.

As stipulated by rules and regulations in Chinese Mainland, group companies operating in Chinese Mainland contribute to state-sponsored retirement plans for their employees. The employees contribute approximately 8% of their salaries, while the group companies contribute approximately 14% to 16% of the salaries of their employees and have no further obligations for the actual payment of pensions or post-retirement benefits beyond the annual contributions. The state-sponsored retirement plans are responsible for the entire pension obligations payable to retired employees.

As stipulated by rules and regulations in Singapore, the group company operating in Singapore contributes to the Singapore Central Provident Fund, a statutory pension scheme. Under the scheme, the employees contribute approximately 20% of their wages, while the group companies contribute approximately 17% of the wages of its employees. The employer's and employees' contributions are subject to a cap of ordinary wages of SGD6,800 (equivalent to approximately HK\$41,000 during the year ended 31st March, 2026).

As stipulated by rules and regulations in Malaysia, the group company operating in Malaysia contributes to the Malaysia Central Provident Fund, a statutory pension scheme. Under the scheme, the employees contribute approximately 11% of their wages, while the group companies contribute approximately 12% to 13% of the wages of its employees. The employer's and employees' contributions are not subject to a cap.

本集團已為香港員工參加強制性公積金計劃(「強積金計劃」)，該計劃為界定供款並由獨立信託人管理。根據強積金計劃，集團各公司(僱主)及其僱員每月供款為僱員有關入息(按強制性公積金計劃條例之定義)之5%。而僱主及僱員供款每月之上限為1,500港元，超過上限的供款均為自願性供款。

根據中國內地法規，本集團於中國內地有業務之公司為其僱員設立一個界定供款並由國家資助的退休金計劃。員工之供款額約為基本薪金之約8%，而集團公司之供款額約為其僱員基本薪金之約14%至16%。除年度供款外，集團公司就實際的退休金付款或退休後福利並不負上任何責任。該個由國家資助的退休金計劃承擔對退休僱員的所有退休金責任。

根據新加坡法規，本集團於新加坡有業務之分公司需供款至一個名為新加坡中央公積金的法定退休金計劃。按該計劃，僱員供款額為薪金之約20%，而集團公司之供款額按僱員薪金約17%，僱主及僱員須供款之上限於二零二六年三月三十一日年度為6,800新加坡元(相等於約41,000港元)。

根據馬來西亞法規，本集團於馬來西亞有業務之分公司需供款至一個名為馬來西亞中央公積金的法定退休金計劃。按該計劃，僱員供款額為薪金之約11%，而集團公司之供款額按僱員薪金之約12%至13%。僱主及僱員之供款並無上限。

### Accounting Policy

#### (a) *Employee leave entitlements*

Employee entitlements to annual leave and long service leave are recognised when they accrue to employees. A provision is made for the estimated liability for annual leave and long service leave as a result of services rendered by employees up to the date of statement of financial position.

Employee entitlements to sick leave and maternity leave are not recognised until the time of leave.

#### (b) *Retirement benefits*

The Group participates in various defined contribution retirement benefit schemes. A defined contribution plan is a retirement benefit scheme under which the Group pays fixed contributions into a separate entity. The Group has no legal or constructive obligations to pay further contribution for post-retirement benefits beyond these fixed contributions.

The schemes are generally funded through payments to government authorities, insurance companies or trustee-administered funds. The Group pays contributions on a mandatory, contractual or voluntary basis. The contributions are recognised as employment benefit expense when they are due. Prepaid contributions are recognised as an asset to the extent that a cash refund or a reduction in the future payments is available.

#### (c) *Share-based compensation*

The fair value of the employee services received in exchange for the grant of share options is recognised as an expense over the vesting periods of the options granted. The total amount to be expensed over the vesting period is determined by reference to the fair value of the options granted excluding the impact of any non-market vesting conditions. Non-market vesting conditions are included in the assumption that the number of options that are expected to become exercisable. At the end of each reporting date, the Group revises its estimates of the number of options that are expected to vest. It recognises the impact of the revision of original estimates, if any, in the consolidated income statement, with a corresponding adjustment to equity.

The proceeds received net of any directly attributable transaction costs are credited to share capital (nominal value) and share premium when the options are exercised.

#### (d) *Profit-sharing and bonus plans*

The Group recognises a liability and an expense for bonuses and profit-sharing, based on a formula that takes into consideration the profit attributable to the Company's shareholders after certain adjustments. The Group recognises a provision where contractually obliged or where there is a past practice that has created a constructive obligation.

Investment properties, principally a residential building and industrial buildings, are held for long-term rental yields and are not occupied by the Group. Investment properties are initially measured at cost, including related transaction costs and where applicable borrowing costs. After initial recognition, investment properties are carried at carrying values, representing cost less depreciation and provision for impairment loss, if any.

Historical cost includes expenditure that is directly attributable to the acquisition of the assets. Subsequent expenditure is charged to the carrying amount of the asset only when it is probable that future economic benefits associated with the property will flow to the Group and the cost of the property can be measured reliably. All other repair and maintenance costs are expensed in the consolidated income statement during the financial period in which they are incurred.

Depreciation is calculated using the straight-line method to write off the cost over the estimated useful lives to their estimated residual values. Estimated useful lives of land and buildings are from 25 to 50 years.

The residual values and useful lives are reviewed, and adjusted if appropriate, at each statement of financial position date. The carrying amounts of assets are reviewed regularly. Borrowings are subsequently carried at amortised cost; any difference between the proceeds (net of transaction costs) and the redemption value is recognised in the consolidated income statement over the period of the borrowings using the effective interest method.

Out of the total, deferred tax assets of approximately HK\$35,214,000 (2025: HK\$29,879,000) in respect of tax losses that can be carried forward indefinitely to set off against future taxable income and deferred tax assets of the remaining tax losses of approximately HK\$15,759,000 (2025: HK\$13,506,000) will expire in 2026 to 2030 (2025: 2025 to 2029). The estimated tax losses are subject to approval by the relevant tax authorities.

Pursuant to the Detailed Implementation Regulations for implementation of the Corporate Income Tax Law issued on 6th December, 2007, withholding income tax of 10% shall be levied on the dividends remitted by the companies established in the PRC to their foreign investors starting from 1st January, 2008. A lower withholding tax rate may be applied if there is a tax treaty between the PRC and the jurisdiction of the foreign investors. All dividends coming from the profits generated by the PRC entities after 1st January, 2008 shall be subject to this withholding income tax.

The Group has no legal or constructive obligation to repurchase or settle the options in cash.

### 34 Summary of other potentially material accounting policies

This note provides a list of other potentially material accounting policies adopted in the preparation of these consolidated financial statements. These policies have been consistently applied to all the years presented, unless otherwise stated.

#### 34.1 Subsidiaries

Subsidiaries are all entities (including structured entities) over which the Group has control. The Group controls an entity when the Group is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power to direct the activities of the entity. Subsidiaries are fully consolidated from the date on which control is transferred to the Group. They are deconsolidated from the date that control ceases.

The acquisition method of accounting is used to account for business combinations by the Group (see Note 34.2).

Intercompany transactions, balances and unrealised gains on transactions between group companies are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the transferred asset. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the Group.

Non-controlling interests in the results and equity of subsidiaries are shown separately in the consolidated income statement, consolidated statement of comprehensive income, consolidated statement of changes in equity and consolidated statement of financial position respectively.

#### 34.1 附屬公司

附屬公司為本集團控制之所有實體（包括結構實體）。當本集團對參與實體業務之浮動回報承擔風險或享有權利以及能透過指示實體的活動之權力影響該等回報時，即取得控制權。附屬公司在控制權轉移至本集團之日綜合入賬。附屬公司在控制權終止之日起停止綜合入賬。

本集團採用收購法為業務合併入賬（見附註34.2）。

集團公司之間的交易、結餘及未實現收益予以對銷。未實現虧損亦予以對銷，除非該交易提供證明證實轉移資產減值。如有需要，附屬公司之會計政策將會變動以確保與本集團採納之會計政策符合一致。

附屬公司業績和權益中的非控股權益在綜合利潤表、綜合全面收益表、綜合權益變動表及綜合財務狀況表中分開列示。

#### 34.2 Business combinations

The acquisition method of accounting is used to account for all business combinations, regardless of whether equity instruments or other assets are acquired. The consideration transferred for the acquisition of a subsidiary comprises the:

- fair values of the assets transferred,
- liabilities incurred to the former owners of the acquired business,
- equity interests issued by the Group,
- fair value of any asset or liability resulting from a contingent consideration arrangement, and
- fair value of any pre-existing equity interest in the subsidiary.

Identifiable assets acquired and liabilities and contingent liabilities assumed in a business combination are, with limited exceptions, measured initially at their fair values at the acquisition date.

The Group recognises any non-controlling interest in the acquired entity on an acquisition-by-acquisition basis either at fair value or at the non-controlling interest's proportionate share of the acquired entity's net identifiable assets.

Acquisition-related costs are expensed as incurred.

If those amounts are less than the fair value of the net identifiable assets of the business acquired, the difference is recognised directly in the consolidated income statement as a bargain purchase. Contingent consideration is classified either as equity or a financial liability. Amounts classified as a financial liability are subsequently remeasured to fair value with changes in fair value recognised in the consolidated income statement.

If the business combination is achieved in stages, the acquisition date carrying value of the acquirer's previously held equity interest in the acquiree is remeasured to fair value at the acquisition date. Any gains or losses arising from such remeasurement are recognised in the consolidated income statement.

#### 34.3 Change in ownership interests

The Group treats transactions with non-controlling interests that do not result in a loss of control as transactions with equity owners of the Group. A change in ownership interest results in an adjustment between the carrying amounts of the controlling and non-controlling interests to reflect their relative interests in the subsidiary. Any difference between the amount of the adjustment to non-controlling interests and any consideration paid or received is recognised in a separate reserve within equity attributable to owners of the Company.

When the Group ceases to consolidate or equity account for an investment because of a loss of control, joint control or significant influence, any retained interest in the entity is remeasured to its fair value with the change in carrying amount recognised in profit or loss. This fair value becomes the initial carrying amount for the purposes of subsequently accounting for the retained interest as an associate, joint venture or financial asset. In addition, any amounts previously recognised in other comprehensive income in respect of that entity are accounted for as if the Group had directly disposed of the related assets or liabilities. This may mean that amounts previously recognised in other comprehensive income are reclassified to the consolidated income statement or transferred to another category of equity as specified/permitted by applicable HKFRSs.

#### 34.3 所有權權益變動

本集團將不會導致失去控制權的非控制性權益交易視為與本集團權益擁有人的交易。所有權權益變動導致控制性與非控制性權益賬面值之間的調整，以反映彼等於附屬公司的相關權益。非控制性權益調整數額與任何已付或已收代價之間的任何差額於本公司擁有人應佔權益中的獨立儲備內確認。

In the Company's statement of financial position, investments in subsidiaries are accounted for at cost less impairment. Cost also includes direct attributable costs of investment. The results of subsidiaries are accounted for by the Company on the basis of dividend received and receivable.

Impairment testing of the investments in subsidiaries is required upon receiving dividends from these investments if the dividend exceeds the total comprehensive income of the subsidiary in the period the dividend is declared or if the carrying amount of the investment in the separate financial statements exceeds the carrying amount in the consolidated financial statements of the investee's net assets including goodwill.

#### 34.5 Segment reporting

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operating decision-maker. The chief operating decision-maker, who is responsible for allocating resources and assessing performance of the operating segments, has been identified as the Executive Chairman and Chief Executive Officer who makes strategic decisions.

#### 34.4 獨立財務報表

於本公司之財務狀況表，附屬公司投資按成本扣除減值，成本亦包括直接歸屬的投資成本。本公司按照股息收入為基準將附屬公司之業績計算入賬。

在接獲於附屬公司的投資的股息後，倘股息超出附屬公司在宣派股息期內的全面收益總額，或倘於個別財務報表的投資賬面值高於被投資公司資產淨值(包括商譽)於綜合財務報表的賬面值，則須對於附屬公司之投資進行減值測試。

#### 34.5 分部報告

經營分部乃按提供與主要營運決策者之內部報告一致之方式予以呈報。主要營運決策者負責分配資源及評估經營分部之表現，執行主席及首席執行長被視為主要營運決策者，彼負責制定策略決定。

#### 34.6 Foreign currency translation

##### (a) *Functional and presentation currency*

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). The consolidated financial statements are presented in HK\$, which is the Company's functional and the Group's presentation currency.

##### (b) *Transactions and balances*

Foreign currency transactions are translated into the functional currency using the exchange rates at the dates of the transactions. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at year-end exchange rates of monetary assets and liabilities denominated in foreign currencies are generally recognised in the consolidated income statement.

All other foreign exchange gains and losses are presented in the consolidated income statement within "other (expenses)/income and gains — net".

Translation differences on non-monetary financial assets and liabilities such as equities held at fair value through profit or loss are recognised in profit or loss as part of the fair value gain or loss. Translation differences on non-monetary financial assets, such as equities classified as financial assets at fair value through other comprehensive income, are included in other comprehensive income.

#### 34.6 外幣換算

##### (a) *功能貨幣和呈列貨幣*

本集團每個實體的財務報表所列項目均以該實體營運所在的主要經濟環境之貨幣計量(「功能貨幣」)。綜合財務報表以港元呈報，港元為本公司的功能貨幣及本集團的呈列貨幣。

##### (b) *交易及結餘*

外幣交易採用交易日之匯率換算為功能貨幣。結算此等交易產生之匯兌損益以及將外幣計值之貨幣性資產和負債以年結匯率換算產生之匯兌損益一般在綜合利潤表確認。

所有其他外幣匯兌損益均列入綜合利潤表(「其他(開支)／收入及收益 — 淨額」)內。

非貨幣性金融資產及負債(如以公允價值計量且其變動計入損益的權益)之匯兌差額，則於損益內確認為公允價值損益一部份。非貨幣性金融資產(如歸類為按公允價值計入其他全面收益的金融資產之權益)之匯兌差額，則計入其他全面收益內。

##### (c) Group companies

The results and financial position of all the group entities (none of which has the currency of a hyperinflationary economy) that have a functional currency different from the presentation currency are translated into the presentation currency as follows:

- (i) assets and liabilities for each statement of financial position presented are translated at the closing rate at the date of that statement of financial position;
- (ii) income and expenses for each income statement are translated at average exchange rates (unless this average is not a reasonable approximation of the cumulative effect of the rates prevailing on the transaction dates, in which case income and expenses are translated at the rate on the dates of the transactions); and
- (iii) all resulting currency translation differences are recognised in other comprehensive income.

On consolidation, exchange differences arising from the translation of any net investment in foreign entities, and of borrowings and other financial instruments designated as hedges of such investments, are recognised in other comprehensive income. When a foreign operation is sold or any borrowings forming part of the net investment are repaid, the associated exchange differences are reclassified to profit or loss, as part of the gain or loss on sales.

##### (c) 集團公司

所有功能貨幣與呈列貨幣不同之本集團實體(當中沒有嚴重通貨膨脹貨幣)之業績及財務狀況均按以下方法換算為呈列貨幣：

- (i) 各財務狀況表呈列之資產及負債項目均以該財務狀況表結算日之收市匯率折算；
- (ii) 各利潤表所呈報之收入及開支項目均按平均匯率換算(除非該平均值並不反映於交易日通行匯率累計影響之合理近似值，在此情況下收入及開支乃按交易日之匯率換算)；及

Goodwill and fair value adjustments arising on the acquisition of a foreign entity are treated as assets and liabilities of the foreign entity and translated at the closing rate. Currency translation differences arising are recognised in other comprehensive income.

##### (d) *Disposal of foreign operation and partial disposal*

On the disposal of a foreign operation (that is, a disposal of the Group's entire interest in a foreign operation), or a disposal involving loss of control over a subsidiary that includes a foreign operation, all of the currency translation differences accumulated in equity in respect of that operation attributable to the owners of the Company are reclassified to consolidated income statement.

In the case of a partial disposal that does not result in the Group losing control over a subsidiary that includes a foreign operation, the proportionate share of accumulated currency translation differences are re-attributed to non-controlling interests and are not recognised in consolidated income statement.

#### 34.7 Impairment of non-financial assets

Assets that are subject to amortisation are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs of disposal and value in use. For the purposes of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash flows ("cash-generating units"). Non-financial assets other than goodwill that suffered an impairment are reviewed for possible reversal of the impairment at each reporting date.

#### 34.8 Offsetting financial instruments

Financial assets and liabilities are offset and the net amount reported in the consolidated statement of financial position when there is a legally enforceable right to offset the recognised amounts and there is an intention to settle on a net basis or realise the asset and settle the liability simultaneously. The legally enforceable right must not be contingent on future events and must be enforceable in the normal course of business and in the event of default, insolvency or bankruptcy of the Company or the counterparty.

#### 34.7 非金融資產之減值

需要作出攤銷的資產在有事件出現或情況變動顯示出現賬面值無法收回時就減值進行評估。減值虧損按資產賬面值超越其可收回價值的數額確認。可收回價值為資產公允價值減銷售成本後的價值，與其使用價值之間的較高者。為評估資產減值，資產按可獨立地區分其現金流量(現金產生單位)的最低層次組合。於每個報告日，均會對曾出現減值之非金融資產(商譽除外)作出評估，以確定是否可能作出減值撥回。

#### 34.8 抵銷金融工具

當有法定可執行權力可抵銷已確認金額，並有意圖按淨額基準結算或同時變現資產和結算負債時，財務資產與負債可互相抵銷，並在綜合財務狀況表報告其淨額。法定可執行權利不可依賴未來事件而定，而在一般業務過程中倘本公司或交易對手一旦出現違約、無償債能力或破產時，這也必須具有約束力。

#### 34.9 Provisions

Provisions are recognised when the Group has a present legal or constructive obligation as a result of past events; it is probable that an outflow of resources will be required to settle the obligation; and the amount has been reliably estimated. Provisions are not recognised for future operating losses.

Where there are a number of similar obligations, the likelihood that an outflow will be required in settlement is determined by considering the class of obligations as a whole. A provision is recognised even if the likelihood of an outflow with respect to any one item included in the same class of obligations may be small.

Provisions are measured at the present value of the expenditures expected to be required to settle the obligation using a pre-tax rate that reflects current market assessments of the time value of money and the risk specific to the obligation. The increase in the provision due to the passage of time is recognised as interest expense.

#### 34.10 Dividend distributions

Dividend distributions to the Company's shareholders are recognised as a liability in the Group's consolidated financial statements and the Company's financial statements in the period in which the dividends are approved by the Company's shareholders.

#### 34.9 撥備

本集團因已發生之事件而產生現有法律或推定責任；很有可能需要資源流出以償付責任；金額已被可靠估計作出撥備。不就未來營運虧損確認撥備。

如有多項類似責任，其需要在償付中流出資源的可能性，根據責任的類別整體考慮。即使在同一責任類別所包含的任何一個項目相關的資源流出的可能性極低，仍須確認撥備。

撥備採用稅前利率按照預期需償付有關責任的開支的現值計量，該利率反映當時市場對金錢時間值和有關責任固有風險的評估。隨著時間過去而增加的撥備確認為利息開支。

#### 34.10 股息分派

向本公司股東分派的股息在股息獲本公司股東批准期間於本集團的綜合財務報表及本公司的財務報表確認為負債。
