Readboy Education Holding Company Limited (“**Readboy**” or the “**Company**”, together with its subsidiaries, the “**Group**”) (Stock Code: 2385) has been listed on the Stock Exchange since 12 July 2022. The Group’s main business covers personal learning devices for students, digital and smart campus and education informatization solutions, certain wearable and other intelligent products, as well as related software, content and support services. The Group operates through a business model combining product sales and service-based solutions, and provides products and services to individual consumers, schools and institutional customers in the PRC through online and offline channels.

The Group continues to advance its “AI + Education” strategy by applying technologies such as artificial intelligence, data analytics and cloud-based capabilities to home learning, in-school teaching management and after-school learning service scenarios. The Group also continues to enhance functions such as intelligent diagnostics, learning progress analysis, personalised content recommendations and interactive learning assistance, with a view to enhancing user experience, learning efficiency and the differentiation of its products and services.

MANAGEMENT DISCUSSION AND ANALYSIS

INDUSTRY REVIEW

In the first half of 2026, China's smart education and education technology sectors continued to evolve, driven by the ongoing digitalisation of education and the development of artificial intelligence technologies. The integration of large AI models, Education Agents, data analytics and intelligent hardware further expanded the application of AI in areas such as learning diagnostics, personalised recommendations, homework analysis, interactive question-and-answer functions and teaching management.

As general-purpose AI models and related development tools become more widely adopted, the focus of market competition has gradually extended beyond individual hardware specifications or model capabilities to whether enterprises can integrate hardware devices, digital educational resources, AI capabilities, continuous learning progress data and education service processes into a sustainable product and service ecosystem. In addition to enhancing AI functions and content quality, education technology enterprises are also required to continuously assess whether their products can be effectively integrated into day-to-day usage scenarios such as home learning, homework marking, learning progress analysis, after-school companion learning and school teaching management.

Competition in the sector remained intense during the Period. Product pricing, promotional spending, online traffic acquisition costs, execution efficiency at offline points of sale, content quality and after-sales services were among the key factors affecting the operating performance of market participants. Market demand for personalised learning and greater visibility of learning outcomes has also encouraged industry participants to continue exploring a transition from traditional hardware sales towards business models combining "hardware + content + AI-enabled services".

At the same time, evolving requirements relating to education content compliance, data security, personal information and privacy protection, the protection of minors, and algorithm and AI governance continued to affect the design, deployment and operation of education technology products. Enterprises are therefore required to establish appropriate internal controls and compliance mechanisms across product development, data collection and use, content review, marketing and campus deployment.

Against the above industry backdrop, the Group will continue to monitor market demand, technological developments and regulatory changes, and adjust its product planning, channel strategies and resource allocation in response to actual circumstances, with a view to continuously enhancing the competitiveness of its products and services, operational efficiency and compliance management capabilities.

行業回顧

2026年上半年，中國智慧教育及教育科技行業繼續在教育數字化及人工智能技術發展的推動下演進。人工智能大模型、教育智能體、數據分析及智能硬件的融合，進一步拓展了人工智能在學情診斷、個性化推薦、作業分析、互動式答疑及教學管理等場景的應用。

隨着通用人工智能模型及相關開發工具的應用日益普及，市場競爭的焦點逐步由單一硬件規格或模型能力，延伸至企業能否將硬件設備、數字化教輔資源、人工智能能力、持續學情數據及教育服務流程整合為可持續運行的產品及服務體系。教育科技企業除須提升人工智能功能及內容質量外，亦須持續驗證有關產品能否有效融入家庭學習、作業批改、學情分析、課後伴學及學校教學管理等日常使用場景。

行業競爭於期內仍然激烈，產品定價、促銷投入、線上流量成本、線下銷售點執行效率、內容質量及售後服務，均為影響企業經營表現的重要因素。市場對個性化及可視化學習效果的需求，亦促使業內企業持續探索由傳統硬件銷售向「硬件+內容+人工智能服務」相結合的業務模式發展。

與此同時，教育內容合規、數據安全、個人信息及私隱保護、未成年人保護、算法及人工智能應用治理等要求不斷演進，繼續影響教育科技產品的設計、部署及運營。企業需要在產品開發、數據收集與使用、內容審核、市場推廣及校園部署等環節建立相應的內部監控及合規機制。

在上述行業環境下，本集團將繼續關注市場需求、技術演進及監管發展，並按實際情況調整產品規劃、渠道策略及資源配置，持續提升產品及服務競爭力、營運效率及合規管理水平。

BUSINESS REVIEW

In the first half of 2026, amid intensifying industry competition and uncertain macro-economic environment, the Group responded proactively and continued to focus on product innovation and planning of business digitalisation. For the six months ended 30 June 2026, the Group recorded revenue of approximately RMB74.5 million, which decreased by approximately 59.0% from RMB182.0 million in the same period of 2025. Gross profit for the Period was RMB10.9 million, with a gross profit margin of approximately 14.6% (2025: 22.2%), representing a decrease of 7.6 percentage points from approximately 22.2% in the corresponding period of 2025. Despite the decrease in gross profit margin during the Period, the Group continued to optimise its operations and strengthen cost control. The benefits of these measures gradually became evident, with the loss for the Period narrowing as compared with the corresponding period in 2025.

By business line, personal student tablets remained the Group's main revenue contributor, generating revenue of RMB52.7 million (2025: RMB151.6 million) for the Period. Revenue from wearable products and other products decreased significantly to RMB6.3 million and RMB6.2 million respectively (2025: RMB12.0 million and RMB9.3 million respectively). Revenue from smart classroom and digital solutions was RMB6.6 million (2025: RMB5.0 million). Advertising and content licensing revenue was RMB2.9 million (2025: RMB4.1 million).

From the cost perspective, selling and distribution expenses were RMB16.2 million (2025: RMB40.5 million) for the Period. Administrative expenses were RMB23.4 million (2025: RMB21.3 million), and research and development expenses were RMB12.2 million (2025: RMB21.6 million). Other income and gains totalled RMB18.5 million (2025: RMB10.2 million) for the Period. The Group recorded a loss before tax of approximately RMB31.5 million for the Period, representing a decrease of approximately 29.9% from approximately RMB44.9 million for the corresponding period in 2025. The Group's loss for the Period amounted to approximately RMB31.3 million, representing a decrease of approximately 30.1% from approximately RMB44.8 million for the corresponding period in 2025.

業務回顧

2026年上半年，本集團面對行業競爭加劇及宏觀經濟環境不確定性，積極應對各項挑戰，繼續堅持產品創新及數字化業務佈局。於截至2026年6月30日止六個月，本集團錄得收入約人民幣74.5百萬元，較2025年同期的182.0百萬元減少約59.0%。期內毛利為人民幣10.9百萬元，毛利率約14.6%（2025年：22.2%），較2025年同期約22.2%下降7.6個百分點。儘管期內毛利率有所下降，本集團持續優化營運及加強成本控制，有關措施的成效逐步顯現，期內虧損較2025年同期有所收窄。

業務類別方面，個人學生平板業務依然為本集團收入主要來源，期內錄得收入約人民幣52.7百萬元（2025年同期：人民幣151.6百萬元）。可穿戴產品及其他產品收入顯著減少，分別錄得人民幣6.3百萬元及6.2百萬元（2025年同期：人民幣12.0百萬元及9.3百萬元）。智能課堂及數字化解決方案業務收入為人民幣6.6百萬元（2025年同期：人民幣5.0百萬元）。廣告與內容授權收入為人民幣2.9百萬元（2025年同期：人民幣4.1百萬元）。

費用方面，本集團期內產生銷售及分銷開支人民幣16.2百萬元（2025年同期：人民幣40.5百萬元）；行政開支人民幣23.4百萬元（2025年同期：人民幣21.3百萬元），研發開支人民幣12.2百萬元（2025年同期：人民幣21.6百萬元）。期內其他收入及收益為人民幣18.5百萬元（2025年同期：人民幣10.2百萬元）。期內，本集團錄得稅前虧損約人民幣31.5百萬元，較2025年同期約人民幣44.9百萬元收窄約29.9%。本集團期內虧損約為人民幣31.3百萬元，較2025年同期約人民幣44.8百萬元收窄約30.1%。

As at 30 June 2026, total assets were RMB318.6 million (31 December 2025: RMB414.9 million). Cash and cash equivalents stood at RMB90.8 million (31 December 2025: RMB155.7 million), and the Group's financial position remained sound. Net assets were RMB168.9 million (31 December 2025: RMB198.3 million) for the Period.

Overall, affected by market competition and changes in demand, the Group's revenue for the first half of 2026 decreased by approximately 59.0% year-on-year, and its gross profit margin also declined from approximately 22.2% to approximately 14.6%. Nevertheless, the loss for the Period narrowed as compared with the corresponding period last year. The management will continue to tighten cost control and improve operating efficiency, with a focus on product innovation and market expansion. The Group will take advantage of opportunities arising from applications of AI and big data and the favourable national smart-education policy to strengthen its core competitiveness and create long-term value for shareholders.

PRODUCT AND BUSINESS DEVELOPMENT

“AI + Education” Capability Building

In the first half of 2026, the Group continued to advance its “AI + Education” strategy. Focusing on home learning, in-school teaching management and after-school learning service scenarios, the Group continued to enhance its related intelligent learning devices, platforms, content and services.

During the Period, the Group continued to promote the application of AI capabilities in areas such as intelligent question answering, guided questioning, learning diagnostics, personalised content recommendations, homework analysis and learning-path planning. It also explored the integration of AI models, learning progress data, teaching tools and business processes, with a view to enhancing product functionality and service efficiency.

The Group believes that the application of AI in education should not be confined to standalone dialogue or question-answering functions. Subject to obtaining the necessary authorisations and complying with applicable requirements relating to data security, personal information protection and the protection of minors, AI should be integrated into actual teaching and learning processes. Accordingly, the Group continued to enhance its service processes covering the collection and analysis of learning progress information, feedback, correction and subsequent practice, with a view to enabling AI-generated analysis to be further applied in areas such as teaching activities, student learning and home-school communication.

於2026年6月30日，本集團總資產為人民幣318.6百萬元（2025年12月31日：人民幣414.9百萬元），現金及現金等價物結餘為人民幣90.8百萬元（2025年12月31日：人民幣155.7百萬元），財務狀況保持穩健。本期間集團淨資產為人民幣168.9百萬元（2025年12月31日：人民幣198.3百萬元）。

整體而言，受市場競爭及需求變化影響，本集團於2026年上半年收入同比下降約59.0%，毛利率亦由約22.2%下降至約14.6%。儘管如此，期內虧損較去年同期收窄。管理層將繼續加強成本控制 and 提升營運效率，聚焦產品創新及市場拓展，把握AI、大數據等新技術應用及國家智慧教育政策利好帶來的發展機遇，鞏固本集團核心競爭力，為股東創造長遠價值。

產品及業務發展

「AI + 教育」能力建設

2026年上半年，本集團繼續推進「AI + 教育」策略，圍繞家庭學習、校內教學管理及課後學習服務場景，持續完善相關智能學習設備、平台、內容及服務。

期內，本集團繼續推動人工智能能力於智能答疑、引導式提問、學情診斷、個性化內容推薦、作業分析及學習路徑規劃等場景的應用，並探索將人工智能模型、學情數據、教學工具及業務流程相融合，以提升產品功能及服務效率。

本集團認為，人工智能在教育領域的應用不應僅局限於獨立的對話或答疑功能，而應在取得所需授權及遵守適用數據安全、個人信息保護和未成年人保護規定的前提下，與實際教學及學習流程相結合。為此，本集團繼續完善由學情信息收集、分析、反饋、訂正及後續練習組成的服務流程，務求令人工智能分析結果可進一步應用於教師教學、學生學習及家校溝通等場景。

AI AIXUE CENTRE

In the first half of 2026, the Group upgraded the “Readboy AI Smart Learning Room” brand to the “Readboy AI Aixue Centre” and further extended its service positioning from the provision of intelligent learning spaces to comprehensive learning services centred on learning progress management, intelligent companion learning and targeted improvement.

Through the integration of AI, big data, intelligent learning devices and offline service scenarios, the AI Aixue Centre explores the establishment of a service ecosystem covering daily companion learning, management of incorrect answers, pre-examination revision, holiday learning programmes and specialised interactive courses. Based on students’ actual learning progress, the relevant services continuously collect and analyse their learning performance across practice, incorrect answers, corrections and revision, and provide students and parents with corresponding learning feedback and recommendations for improvement.

During the Period, the Group also continued to provide AI Aixue Centre partners with support in areas such as branding, products, training and operations. It continued to assess product suitability, user acceptance and the business models applicable to different service scenarios. As at 30 June 2026, the AI Aixue Centre and its predecessor, the AI Smart Learning Room, had a total of 1,213 partner operators/centres.

MAGIC CLASSROOM

During the Period, the Group launched/continued to enhance “Magic Classroom”, an AI-enabled interactive course solution under the AI Aixue Centre service ecosystem.

Magic Classroom combines AI-assisted teaching content, online and/or offline companion learning support and after-class consolidation exercises, and explores the establishment of an integrated learning process covering “teaching, learning, practice, assessment, diagnosis and improvement”. Based on students’ classroom interactions, practice performance, incorrect answers and homework completion, Magic Classroom can generate corresponding learning progress records. Subject to obtaining the necessary authorisations and complying with applicable regulatory requirements, such records may be combined with other relevant learning information to provide students with more targeted learning content and consolidation exercises.

Magic Classroom may be used in various learning settings, including home-based self-directed learning, AI Aixue Centres and school teaching, and supports online, offline and blended teaching formats. The Group will continue to enhance the relevant course content, AI-enabled interactive functions, companion learning processes and service standards based on actual operations and user feedback.

AI 愛學中心

2026年上半年，本集團將「讀書郎AI智習室」品牌升級為「讀書郎AI愛學中心」，並將其服務定位由提供智能學習空間，進一步延伸至以學情管理、智慧伴學及精準提升為核心的綜合學習服務。

AI愛學中心透過人工智能、大數據、智能學習設備及線下服務場景的協同，探索建立涵蓋日常伴學、錯題管理、考前複習、假期學習及特色互動課程的服務體系。相關服務以學生的實際學情為基礎，透過持續收集及分析學生於練習、錯題、訂正及複習等環節的學習表現，向學生及家長提供相應的學習反饋及改善建議。

期內，本集團亦繼續向AI愛學中心合作夥伴提供品牌、產品、培訓及運營等方面的支持，並持續評估不同服務場景的產品適配程度、用戶接受程度及商業模式。於2026年6月30日，AI愛學中心及其前身AI智習室的合作營運商／門店數目為1,213家／間。

魔法課堂

期內，本集團推出／持續完善「魔法課堂」，作為AI愛學中心服務體系下的人工智能互動課程方案。

魔法課堂採用人工智能輔助教學內容、線上及／或線下伴學服務與課後鞏固練習相結合的模式，探索建立「教、學、練、測、診斷及提升」的學習閉環。課堂可根據學生的課堂互動、練習表現、錯題及作業完成情況形成相應的學情記錄，並在取得所需授權及符合適用法規要求的前提下，結合其他相關學習資料，為學生提供較具針對性的學習內容及鞏固練習。

魔法課堂可應用於家庭自主學習、AI愛學中心及學校教學等學習場景，並支持線上、線下及線上線下融合等授課方式。本集團將繼續透過實際運營及用戶反饋，完善有關課程內容、人工智能互動功能、伴學流程及服務標準。

In-school Smart Education and Education Agent

In the first half of 2026, the Group continued to advance the implementation of its in-school smart education products and services, focusing on high-frequency teaching management scenarios such as homework, examinations, learning progress analysis, teaching feedback and home-school services.

Through the Homework Marking and Traceability Device, the AI Aixue Platform and related learning progress data platforms, the Group explored the establishment of a service process covering the collection of information from paper-based homework and examinations, learning progress analysis, teaching feedback, correction of incorrect answers and subsequent practice. While preserving schools' existing paper-based homework processes and teaching practices, the Homework Marking and Traceability Device is designed to convert information relating to homework, examinations, incorrect answers and marking results into teaching information that may be used for further analysis. The AI Aixue Platform then processes the relevant information and generates learning progress analyses and teaching feedback across different dimensions, including classes, students, subjects and knowledge points.

The Group also continued to explore the application of an education agent (the "Education Agent") in actual teaching processes. Unlike standalone conversational AI tools, the Education Agent being explored by the Group is based on continuous learning progress information and actual business processes, and connects homework, analysis, feedback, practice and home-school services, with a view to converting AI-generated analyses into teaching and learning support that may be used by teachers, students, schools and families.

As at 30 June 2026, the Group's AI Aixue Platform and Homework Marking and Traceability Device had been deployed or trialed in approximately 833 schools across 269 regions nationwide. During the Period, the relevant projects were mainly at the stages of product deployment, pilot validation, teacher training, standardisation of service processes and validation of business models. They contributed RMB6.6 million to the Group's revenue for the Period, representing approximately 8.8% of the Group's total revenue.

校內智慧教育及教育 Agent

2026年上半年，本集團繼續推進校內智慧教育產品及服務的落地，並聚焦作業、考試、學情分析、教學反饋及家校服務等高頻教學管理場景。

本集團透過作業留痕批改機、AI愛學網及相關學情數據平台，探索建立由紙質作業及考試信息收集、學情分析、教學反饋、錯題訂正及後續練習組成的服務流程。作業留痕批改機旨在保留學校原有紙筆作業及教學習慣的基礎上，將作業、考試、錯題及批改結果轉化為可供進一步分析的教學信息；AI愛學網則承接相關信息，從班級、學生、學科及知識點等不同維度形成學情分析及教學反饋。

本集團亦持續探索教育智能體（「教育 Agent」）於實際教學流程中的應用。與單一對話式人工智能工具不同，本集團所探索的教育 Agent 以持續學情及實際業務流程為基礎，連接作業、分析、反饋、練習及家校服務等環節，務求將人工智能分析轉化為可供教師、學生、學校及家庭使用的教學及學習支持。

於2026年6月30日，本集團的AI愛學網及作業留痕批改機已於全國約833所學校部署或試用，覆蓋269個地區。期內相關項目主要處於產品部署、試點驗證、教師培訓、服務流程標準化及商業模式驗證階段，對本集團期內收入的貢獻為人民幣6.6百萬元，佔本集團總收入約8.8%。

AI Aixue Platform and Homework Marking and Traceability Device

In the first half of 2026, the Group continued to advance the development, deployment and application of the AI Aixue Platform, the Homework Marking and Traceability Device and related in-school smart education solutions. It also explored the further integration of AI capabilities into actual education scenarios, including homework, examinations, learning progress analysis, teaching feedback, personalised practice and home-school communication.

The Group's relevant solutions primarily comprise three interconnected layers: learning data acquisition, learning progress analysis and teaching applications. The Homework Marking and Traceability Device and related intelligent terminals primarily serve as entry points for acquiring learning information. The AI Aixue Platform processes the relevant information to generate learning progress analyses, teaching feedback and personalised learning services. AI and related analytical models are applied in areas such as question recognition, learning diagnostics, analysis of the causes of incorrect answers, content recommendations and task generation.

Through the above products and services, the Group aims to establish a continuous feedback mechanism covering the acquisition of learning information, AI analysis, teaching recommendations, student correction and subsequent practice. Subject to compliance with applicable laws and regulations, obtaining the necessary authorisations and safeguarding data security, information generated from homework and examinations may be further applied to teaching activities, student learning, school management and home-school communication.

AI Aixue Platform

The AI Aixue Platform is a smart education platform provided by the Group to schools, teachers, students and parents. Its principal functions include the digitalisation of educational resources, school-based resource management, homework and examination management, learning progress analysis, classroom review, personalised practice and learning reports.

In relation to the digitalisation of educational resources, the AI Aixue Platform uses functions such as AI-assisted question input, question recognition and labelling to assist in converting paper-based or electronic questions, examination papers and supplementary educational materials into structured digital resources. Such resources may be categorised by knowledge point, question type, difficulty level and other applicable labels. Schools and teachers may establish and manage their own school-based resource repositories according to their teaching needs.

AI 愛學網及作業留痕批改機

2026年上半年，本集團繼續推進AI愛學網、作業留痕批改機及相關校內智慧教育解決方案的產品開發、部署及應用，並探索將人工智能能力進一步融入作業、考試、學情分析、教學反饋、個性化練習及家校溝通等實際教育場景。

本集團相關解決方案主要由學習數據獲取、學情分析及教學應用三個相互連接的層次組成。作業留痕批改機及相關智能終端主要作為學習信息獲取入口；AI愛學網主要承接有關信息，形成學情分析、教學反饋及個性化學習服務；人工智能及相關分析模型則應用於題目識別、學情診斷、錯因分析、內容推薦及任務生成等環節。

本集團旨在透過上述產品及服務建立由學習信息獲取、人工智能分析、教學建議、學生訂正及後續練習組成的持續反饋機制，使作業及考試所產生的信息可在符合適用法律法規、取得所需授權及保障數據安全的前提下，進一步應用於教師教學、學生學習、學校管理及家校溝通。

AI 愛學網

AI愛學網為本集團面向學校、教師、學生及家長提供的智慧教育平台，主要涵蓋教育資源數字化、校本資源管理、作業及考試管理、學情分析、課堂講評、個性化練習及學習報告等功能。

在教育資源數字化方面，AI愛學網透過AI錄題、題目識別及標註等功能，協助將紙質或電子版題目、試卷及教輔資料轉化為結構化數字資源，並可按知識點、題型、難度及其他適用標籤進行分類。學校及教師可根據自身教學需要建立及管理校本資源庫。

In relation to learning progress analysis, the AI Aixue Platform may generate analytical results across different dimensions, including classes, students, subjects, questions and knowledge points, based on homework and examination results. This assists teachers in identifying common issues within a class and understanding the learning progress of individual students. The platform may also provide corresponding practice content and learning feedback based on students' incorrect answers, corrections and subsequent practice.

In relation to teaching applications, teachers may use the platform to review the overall results of homework and examinations, students' original answer scripts, common incorrect answers and mastery of knowledge points. Such information may also be used to prepare classroom reviews and subsequent teaching arrangements. The Group will continue to enhance the resource management, learning progress analysis, teaching feedback and personalised learning functions of the AI Aixue Platform based on its actual use by schools and teachers.

Homework Marking and Traceability Device

The Homework Marking and Traceability Device is one of the intelligent terminals forming part of the Group's in-school smart education solutions. It is designed to operate alongside schools' existing paper-based homework and examination processes and to convert paper-based homework, answers, incorrect answers and marking information into digital learning data that may be used for subsequent analysis.

The Homework Marking and Traceability Device supports the recognition and marking of questions across all subjects and almost all question types at the primary and secondary school levels, and may retain students' original answer scripts and relevant marking records. The relevant results may be transmitted to the AI Aixue Platform to generate information relating to homework analysis, mastery of knowledge points, common incorrect answers and the learning progress of individual students.

Following review by teachers, the platform may generate homework or classroom review reports based on the relevant results. These reports assist teachers in selecting questions that require particular attention during classroom review and may also provide students with corresponding correction and consolidation exercises. Through the coordination of intelligent terminals and the platform, the Group aims to reduce certain repetitive data-processing tasks and enhance the efficiency of homework feedback and teaching analysis, without significantly changing the existing practices of teachers and students.

在學情分析方面，AI愛學網可根據作業及考試結果，從班級、學生、學科、題目及知識點等不同維度形成相應的分析結果，協助教師了解班級共性問題及學生個別學習情況。平台亦可根據學生的錯題、訂正及後續練習情況，提供相應的練習內容及學習反饋。

在教學應用方面，教師可透過平台查看作業及考試的整體情況、學生原卷、常見錯題及知識點掌握情況，並可使用相關資料準備課堂講評及後續教學安排。本集團將繼續根據學校及教師的實際使用情況，完善AI愛學網的資源管理、學情分析、教學反饋及個性化學習功能。

作業留痕批改機

作業留痕批改機為本集團校內智慧教育解決方案的智能終端之一，旨在配合學校原有的紙筆作業及考試流程，將紙質作業、答題結果、錯題及批改信息轉化為可供後續分析的數字化學習數據。

作業留痕批改機支持中小學階段全學科及幾乎全部題型的識別及批閱，並可保留學生原卷及相關批改記錄。相關結果可傳送至AI愛學網，用於形成作業分析、知識點掌握情況、常見錯題及個別學生學情等資料。

在教師覆核後，平台可根據有關結果生成作業或課堂講評報告，協助教師選取需要重點講解的題目，並可向學生提供相應的訂正及鞏固練習。本集團期望透過智能終端及平台的協同，在不大幅改變教師及學生原有使用習慣的情況下，減少部分重複性資料整理工作，提升作業反饋及教學分析效率。

AI Learning Progress Analysis and Teaching Closed Loop

The Group continued to explore the use of AI to analyse learning data generated by students through homework, examinations, corrections and practice. Such analysis may cover mastery of knowledge points, types of incorrect answers, learning progress and other applicable dimensions.

Based on the relevant analysis, the system may provide teachers with learning progress information relating to classes and individual students, common incorrect answers and corresponding teaching references. It may also provide students with correction, consolidation or other relevant practice content. The results generated after students complete subsequent practice may be used to update the relevant learning progress analysis, thereby forming a service process covering “learning information acquisition — AI analysis — teaching and learning recommendations — implementation — feedback”.

The Group believes that the practical value of AI in education lies not only in providing standalone question-answering or content-generation functions, but also in whether AI capabilities can be integrated into continuous teaching and learning processes, subject to compliance with applicable laws and regulations and the relevant data security and authorisation requirements. During the Period, the Group continued to enhance the relevant products and services. However, certain related functions and business models remained at the deployment, validation and optimisation stages.

Application Exploration of Education Agent

In the first half of 2026, the Group continued to explore the application of an education agent (the “Education Agent”) in actual education scenarios.

The Education Agent being explored by the Group is not merely a standalone conversational tool. Rather, it is based on actual teaching and learning information and integrates AI models with tools and processes relating to homework analysis, learning diagnostics, teaching feedback, personalised practice and home-school services. Its development direction is to assist in generating corresponding analytical results, tasks and recommendations based on students’ learning progress and actual teaching needs, and to deliver such results through the service processes used by teachers, students, schools and parents.

The Group is progressively exploring the application of AI in areas such as multimodal question recognition, knowledge-point labelling, analysis of the causes of incorrect answers, learning progress reports, classroom review recommendations for teachers, correction tasks for students and parent-oriented interpretation of learning progress. The relevant functions remain subject to continuing validation and optimisation based on actual product development, model performance, user feedback and compliance requirements.

人工智能學情分析及教學閉環

本集團持續探索以人工智能分析學生於作業、考試、訂正及練習等環節形成的學習資料，並從知識點掌握情況、錯題類型、學習進度及其他適用維度形成學情分析。

根據有關分析，系統可向教師提供班級及個別學生的學情信息、常見錯題及相應的教學參考，並可向學生提供訂正、鞏固或相關練習內容。學生完成後續練習後所產生的結果可進一步用作更新相關學情分析，形成由「學習信息獲取—人工智能分析—教學及學習建議—執行—反饋」組成的服務流程。

本集團認為，教育人工智能的實際價值不僅在於提供獨立的問答或內容生成功能，亦在於能否在符合適用法律法規、數據安全和授權要求的前提下，將人工智能能力融入持續的教學及學習流程。期內，本集團繼續完善有關產品及服務，惟部分相關功能及商業模式仍處於部署、驗證及優化階段。

教育 Agent 應用探索

2026年上半年，本集團繼續探索教育智能體（「教育 Agent」）於實際教育場景中的應用。

本集團所探索的教育 Agent 並非僅為獨立的對話式工具，而是以實際教學及學習信息為基礎，將人工智能模型與作業分析、學情診斷、教學反饋、個性化練習及家校服務等工具和流程相結合。其發展方向為根據學生的學情狀態及實際教學需要，協助生成相應的分析結果、任務及建議，並將有關結果反饋至教師、學生、學校及家長所使用的服務流程。

本集團正逐步探索人工智能於多模態題目識別、知識點標註、錯因分析、學情報告、教師講評建議、學生訂正任務及家長端學情解讀等場景中的應用。相關功能仍須按實際產品進度、模型表現、用戶反饋及合規要求持續驗證及優化。

In-school Deployment and Professional Services

In addition to intelligent terminals and software platforms, the Group's in-school smart education solutions may, depending on the needs of individual projects, include system deployment, user account setup, digitalisation of educational resources, training for teachers and administrators, support for homework and examination processes, system operation and maintenance, and after-sales services.

For certain projects, the Group seeks to understand schools' teaching processes, information technology environments and actual usage needs before deployment. It may then provide corresponding training and operational support according to the project arrangements, including assistance with the digitalisation of educational resources, training on system use, homework and examination-related operations, and system operation, maintenance and technical support.

The Group also continued to explore the standardisation of the relevant deployment and service processes, with a view to enhancing delivery efficiency, service consistency and replicability across projects in different schools and regions. As at 30 June 2026, the Group had deployed or trialed the AI Aixue Platform and the Homework Marking and Traceability Device in approximately 833 schools across 269 regions. During the Period, approximately 415 schools were newly added to the Group's deployment or trial arrangements.

Project Implementation and Application

In the first half of 2026, the Group continued to advance the deployment or trial use of the AI Aixue Platform, the Homework Marking and Traceability Device and other related smart education products and services in Guangdong, Zhejiang, Hubei, Inner Mongolia and other regions. The relevant projects covered application scenarios such as daily homework, examination analysis, learning diagnostics, school-based resource management, classroom review and personalised practice.

In certain school projects, the Group used the Homework Marking and Traceability Device alongside existing paper-based homework and examination processes to collect relevant answer and marking information. The AI Aixue Platform was then used to process and analyse such information, assisting teachers in understanding the overall performance of classes, common incorrect answers and the learning progress of individual students. Following review of the relevant results by teachers, such information may be applied to classroom review, student correction and subsequent practice.

校內部署及專業服務

本集團的校內智慧教育解決方案除包括智能終端及軟件平台外，亦可根據項目需要提供系統部署、用戶賬號設置、教育資源數字化、教師及管理人員培訓、作業及考試流程支持、系統運維及售後服務。

在部分項目中，本集團會在部署前了解學校的教學流程、信息化環境及實際使用需求，並按項目安排提供相應的培訓及運營支持，包括協助處理教育資源數字化、系統使用培訓、作業及考試相關操作，以及系統運維及技術支援。

本集團亦持續探索將相關部署及服務流程標準化，以提升不同學校及地區項目的交付效率、服務一致性及可複製程度。截至2026年6月30日，本集團已於約833所學校部署或試用AI愛學網及作業留痕批改機，覆蓋269個地區。期內新增部署或試用學校約415所。

項目落地及應用情況

於2026年上半年，本集團繼續在廣東、浙江、湖北、內蒙古及其他地區推進AI愛學網、作業留痕批改機及其他相關智慧教育產品及服務的部署或試用。相關項目涵蓋日常作業、考試分析、學情診斷、校本資源管理、課堂講評及個性化練習等應用場景。

在部分學校項目中，本集團透過作業留痕批改機配合原有紙筆作業及考試流程收集相關作答及批改信息，並透過AI愛學網整理及分析有關信息，協助教師了解班級整體表現、常見錯題及個別學生的學習情況。教師可在覆核相關結果後，將有關資料應用於課堂講評、學生訂正及後續練習。

As at 30 June 2026, the Group's relevant products and services had been deployed or trialed in approximately 2,000 schools nationwide, covering 20 provinces, autonomous regions or municipalities. In addition to the aforementioned AI Aixue Platform and Homework Marking and Traceability Device, such products and services also included smart classroom tablets, all-in-one devices and other related products previously deployed by the Group in schools. The approximately 2,000 schools included the aforementioned approximately 833 schools in which the AI Aixue Platform and/or the Homework Marking and Traceability Device had been deployed or trialed. During the Period, the Group continued to collect feedback from schools and teachers through actual projects, with a view to enhancing product functionality, deployment processes, training arrangements and continuing service mechanisms.

Industry Recognition

At the 2026 Second National New Quality After-school Care Capability Conference held from 23 to 24 May 2026, the Group received the "2026 Innovative Service Model Award" in recognition of the AI Aixue Centre's exploration and practice in the application of AI to education services.

The Group believes that the award reflects the industry's interest in service models integrating AI and after-school education services. The Group will continue to enhance the products, courses, service processes and partner support system of the AI Aixue Centre and will prudently advance the development of the relevant business.

Outlook for the Second Half of 2026

Looking ahead to the second half of 2026, the Group expects the smart education industry to continue to be affected by various factors, including the continued digitalisation of education, developments in AI technologies, industry competition, product pricing and promotional activities, and the macro consumption environment. The further integration of AI with hardware devices, supplementary educational content and education services will create opportunities for product and service innovation. However, product differentiation, user acceptance, the pace of commercialisation and compliance requirements may also present challenges to industry participants.

In terms of products and technology, the Group will continue to advance its "AI + Education" strategy and enhance functions such as intelligent question answering, guided questioning, learning diagnostics, personalised content recommendations, homework analysis and learning-path planning. It will also continue to improve the user experience and differentiation of its core intelligent learning devices. Based on actual product use and user feedback, the Group will prudently advance the application of AI models, educational content and data analytics capabilities across additional learning scenarios.

截至2026年6月30日，本集團的相關產品及服務已於全國約2,000所學校部署或試用，覆蓋20個省、自治區或直轄市。上述相關產品及服務除包括前述AI愛學網及作業留痕批改機外，亦包括本集團過往已進駐學校的智慧課堂平板電腦、一體機及其他相關產品；上述約2,000所學校亦包括前述已部署或試用AI愛學網及／或作業留痕批改機的約833所學校。期內，本集團繼續透過實際項目收集學校及教師的使用反饋，以完善產品功能、部署流程、培訓安排及持續服務機制。

行業認可

於2026年5月23日至24日舉行的2026第二屆(全國)新質托管力大會上，本集團憑藉AI愛學中心在人工智能賦能教育服務方面的探索及實踐，獲頒「2026年度創新服務典範獎」。

本集團認為，有關獎項反映業界對人工智能與課後教育服務融合模式的關注。本集團將繼續完善AI愛學中心的產品、課程、服務流程及合作夥伴支持體系，並審慎推動相關業務發展。

2026年下半年展望

展望2026年下半年，本集團預期智慧教育行業將繼續受到教育數字化、人工智能技術發展、行業競爭、產品價格及促銷活動，以及宏觀消費環境等多項因素影響。人工智能與硬件設備、教輔內容及教育服務的進一步融合，將為產品及服務創新帶來機遇，但產品差異化、用戶接受程度、商業化進度及合規要求亦可能為行業參與者帶來挑戰。

在產品及技術方面，本集團將繼續推進「AI+教育」策略，完善智能答疑、引導式提問、學情診斷、個性化內容推薦、作業分析及學習路徑規劃等功能，並持續提升核心智能學習設備的用戶體驗及產品差異化能力。本集團亦將根據產品實際使用情況及用戶反饋，審慎推進人工智能模型、教育內容及數據分析能力於更多學習場景中的應用。

In relation to in-school smart education, the Group will continue to advance the deployment and optimisation of the AI Aixue Platform, the Homework Marking and Traceability Device and related learning progress analysis products. It will also seek to further connect the service processes covering the acquisition of homework and examination information, learning progress analysis, classroom review by teachers, student correction, personalised practice and home-school feedback. Based on the actual needs of schools and teachers, the Group will continue to enhance product functionality, deployment procedures, teacher training, operational support and after-sales services. It will also assess the feasibility of expanding the relevant products and services from pilot projects to broader applications.

The Group will continue to explore the application of education-specific large models and the Education Agent in areas such as multimodal question recognition, analysis of the causes of incorrect answers, knowledge-point diagnosis, learning progress reports, teaching recommendations, student learning tasks and parent-oriented interpretation of learning progress. Related investment will focus on enhancing product usability, analytical accuracy, the explainability of output, data security and business process efficiency. The Group will prudently allocate relevant resources according to actual product validation, customer use and commercialisation progress.

In relation to after-school learning services, the Group will continue to advance the brand and service upgrade of the AI Aixue Centre and enhance service scenarios including daily companion learning, management of incorrect answers, pre-examination revision, holiday learning and Magic Classroom. Through the standardisation of product and service processes, partner training and operational support, the Group will seek to enhance the user experience and operational efficiency of the relevant services and will prudently assess their commercial performance.

In terms of channels and operations, the Group will continue to optimise its online and offline channel mix, enhance product display, customer experience, conversion and after-sales service capabilities at points of sale, and strengthen expense management, inventory management, monitoring of receivables and working capital management, with a view to improving resource utilisation efficiency and operational resilience.

In terms of compliance and risk management, the Group will continue to monitor regulatory requirements relating to education content, data security, personal information and privacy protection, the protection of minors, AI applications, and advertising and promotional activities. It will also continue to enhance mechanisms relating to pre-launch product review, data access management, content review and internal training.

在課後學習服務方面，本集團將繼續推進AI愛學中心的品牌及服務升級，完善日常伴學、錯題管理、考前複習、假期學習及魔法課堂等服務場景。本集團將透過產品及服務流程標準化、合作夥伴培訓及運營支持，提升相關服務的用戶體驗及運營效率，並審慎評估其商業化表現。

在渠道及運營方面，本集團將繼續優化線上及線下渠道結構，提升銷售點的產品展示、體驗、轉化及售後服務能力，並加強費用管理、庫存管理、應收款項監控及營運資金管理，以提升資源使用效率及經營韌性。

在合規及風險管理方面，本集團將繼續關注教育內容、數據安全、個人信息及私隱保護、未成年人保護、人工智能應用及廣告宣傳等方面的監管要求，並持續完善產品上線前審查、數據權限管理、內容審核及內部培訓等機制。

Despite continuing uncertainty in the market environment, the Group will maintain a prudent approach to resource allocation and treasury management. It will focus on its core products and services, AI capability building, in-school smart education and the AI Aixue Centre, and will adjust the pace of investment according to market demand and actual commercialisation progress, with a view to improving operational efficiency and revenue quality and laying a foundation for the Group's medium-to-long-term development.

Personal Student Tablets

Personal student tablets designed by Readboy are tailored for personal end-users who are primary and secondary (including middle and high school) students aged 6 to 18, equipped with abundant digital educational resources, including synchronous lesson preparation, review and learning materials, which are designed to supplement classroom teaching under the compulsory education curriculum. In addition, Readboy has curated some distinctive learning resources to meet students' personalised needs.

Personal student tablets are preloaded with a large number of courseware resources and are highly customisable to adjust to students' needs and schools' teaching plans. It can also connect to Readboy's online learning platform, which offers a wealth of recorded video resources, enabling students to engage in learning anytime, anywhere.

Readboy's personal student tablets are dedicated to providing a comprehensive learning platform for primary and secondary school students that integrates learning, interaction and entertainment, allowing students to easily learn outside the classroom and enhance learning effectiveness. By using our personal student tablets, students can better adapt to the trend of educational informatization, cultivate independent learning, and foster the ability for autonomous exploration.

Revenue derived from the sales of personal student tablets decreased by approximately 65.3% from RMB151.6 million in 2025 Interim to RMB52.7 million in 2026 Interim. 學生個人平板

讀書郎的學生個人平板專為6至18歲的中小學（包括初中及高中）學生個人終端用戶設計，配備豐富的數位化教輔資源，包括同步預習、複習以及學習材料，這些資源旨在補充義務教育課堂教學。此外，讀書郎還精選了一些特色學習資源，以滿足學生的個性化需求。

學生個人平板中已預裝大量課件資源，並且具有可擴展性，可以根據學生的需求和學校的教學計劃進行調整。學生個人平板還可以連接到讀書郎提供的線上學習平台，該平台包含大量錄播視頻資源，學生可隨時隨地參與學習。

讀書郎的學生個人平板致力於為中小學生提供一個集學習、互動、娛樂於一體的綜合性學習平台，讓學生在課堂之外也能輕鬆學習，提高學習效果。通過使用我們的學生個人平板，學生可以更好地適應教育信息化的發展趨勢，培養獨立學習和自主探索的能力。

學生個人平板的銷售收入由2025年中期的人民幣151.6百萬元減少約65.3%至2026年中期的人民幣52.7百萬元。該減幅乃主要由於1)國內經濟受到國際大環境影響，產品銷售在一定程度上受到負面影響；2)智能學習硬件行業已進入存量競爭階段，終端消費需求疲軟，行業價格戰加劇，產品售價與毛利率持續承壓；3)AI大模型快速迭代，普通消費設備普遍搭載免費AI學習工具，分流專用學習硬件用戶；4)其他行業的企業加入教育電子行業，使行業的競爭壓力加劇。

Digital and Smart Classroom Solutions

The Group's digital and smart classroom solutions aim to provide schools and education institutions with software, hardware and services covering scenarios such as educational resource management, daily homework, examination marking, learning progress analysis, precision teaching, classroom review, English listening and speaking training, and home-school communication.

The relevant products and services mainly include the AI Aixue Platform, the Homework Marking and Traceability Device, intelligent examination marking systems, digital homework systems, precision teaching systems, integrated teaching and research platforms, English listening and speaking examination and training systems, and home-school collaboration platforms.

Through the Homework Marking and Traceability Device and related intelligent terminals, the Group may collect information relating to homework, answers and marking while operating alongside schools' existing paper-based homework and examination processes. The AI Aixue Platform may then process and analyse the relevant information and generate learning progress data across different dimensions, including classes, students, subjects and knowledge points. This supports teachers in reviewing homework, conducting classroom reviews, arranging teaching activities and providing subsequent practice for individual students.

Depending on the needs of individual projects, the Group may also provide schools with system deployment, user account setup, digitalisation of educational resources, training, operational services and technical support. The relevant solutions aim to reduce certain repetitive data-processing tasks, assist teachers in understanding students' learning progress more effectively and provide corresponding data support for schools' teaching management.

Revenue derived from the sales of the digital and smart classroom solutions increased by approximately 32.1% from RMB5.0 million in 2025 Interim to RMB6.6 million in 2026 Interim. The increase was mainly attributable to the smart education products and solutions previously developed by the Company, which achieved significant enhancements in technology and functionality and gained growing recognition from education authorities and schools, leading to their procurement and deployment and thereby driving an increase in revenue.

數智校園解決方案

本集團的數智校園解決方案旨在為學校及教育機構提供涵蓋教育資源管理、日常作業、考試閱卷、學情分析、精準教學、課堂講評、英語聽說訓練及家校溝通等場景的軟硬件及服務。

相關產品及服務主要包括AI愛學網、作業留痕批改機、智慧閱卷系統、數智作業系統、精準教學系統、教學研一體化平台、英語聽說考練系統及家校共育平台等。

透過作業留痕批改機及相關智能終端，本集團可在配合學校原有紙筆作業及考試流程的基礎上，收集作業、答題及批改信息。AI愛學網則可對相關信息進行整理及分析，並從班級、學生、學科及知識點等維度形成相應的學情資料，以支援教師進行作業覆核、課堂講評、教學安排及個別學生的後續練習。

本集團亦可根據項目需要向學校提供系統部署、用戶設置、教育資源數字化、培訓、運營及技術支援。相關解決方案旨在減少部分重複性資料整理工作，協助教師更有效地了解學生的學習情況，並為學校的教學管理提供相應資料支持。

數智校園解決方案的銷售收入由2025年中期人民幣5.0百萬元增加約32.1%至2026年中期人民幣6.6百萬元。該增幅乃主要由於公司前期開發的智慧教育產品和解決方案，技術和功能都獲得較大的提升，獲得越來越多的教育主管部門、學校的認可，並購入使用，進而導致收入增加。

Wearable Products

We believe that under the new era, wearable educational accessories are playing an increasingly pivotal role in education. They enable students to access a variety of audio-visual educational resources wirelessly and hands-free during fragmented time outside the classroom. These devices extend the educational scenarios, enhancing the joy and motivation of learning within these fragmented periods. Therefore, we have specifically developed a smartwatch focused on educational features and functionality. This watch comes pre-installed with a daily bilingual (Chinese and English) vocabulary learning feature, and is equipped with traditional functions such as GPS, video calling, health monitoring and emergency assistance.

Revenue from the sales of wearable products decreased by approximately 47.6% from RMB12.0 million in 2025 Interim to RMB6.3 million in 2026 Interim, primarily due to 1) the domestic economy being affected by the macro international environment, which negatively impacted product sales to a certain extent; 2) the smart learning hardware industry entering a stage of competition for existing market demand, characterized by sluggish end-consumer demand, escalating industry price wars, and ongoing pressure on selling prices and gross profit margins; 3) the rapid iteration of large AI models, leading general consumer devices to commonly feature free AI learning tools, which diverted users away from dedicated learning hardware; 4) the entry of enterprises from other industries into the educational electronics sector, further intensifying competitive pressure within the industry; and 5) the continuous decline in the K12 school-age population, leading to a year-on-year contraction of the overall industry market, shifting from incremental expansion to zero-sum stock-market rivalry, and escalating competition to a white-hot state.

Other Products

As we continually monitor market demands and trends, we are dedicated to developing educational and learning products that are compatible with our smart learning devices to enhance the efficiency and effectiveness of the learning process. Although we previously launched an AI dictionary pen with smart recognition capabilities that could identify and read words and sentences in both Chinese and English, we are now focusing on promoting a more comprehensive new product to replace the traditional AI dictionary pen.

我們認為，在新時代的教育中，可穿戴式教育小配件扮演著越來越重要的角色。它們能讓學生在課堂之外的碎片化時間裡，通過無線和免提的方式獲取各種視聽教輔資源。這些設備拓展了教育場景，增加了學生在碎片化時間內的學習樂趣和動力。因此，我們專門開發了一款專注於教育特色和功能的智慧手錶。此款手錶預裝了學習詞彙的中英文每日一詞功能，並配備了GPS、視頻電話、健康監測和緊急援助等傳統功能。

可穿戴產品的銷售收入由2025年中期的人民幣12.0百萬元減少約47.6%至2026年中期的人民幣6.3百萬元，此乃主要由於1)國內經濟受到國際大環境影響，產品銷售在一定程度上受到負面影響；2)智能學習硬件行業已進入存量競爭階段，終端消費需求疲軟，行業價格戰加劇，產品售價與毛利率持續承壓；3) AI大模型快速迭代，普通消費設備普遍搭載免費AI學習工具，分流專用學習硬件用戶；4)其他行業的企業加入教育電子行業，使行業的競爭壓力加劇；5) K12適齡人口連續下滑，行業大盤同比收縮，從增量擴張轉入零和博弈的存量內卷，競爭白熱化。

其他產品

隨著我們不斷追蹤市場需求和趨勢，我們致力於開發與我們智能學習設備相容的教學及學習配套產品，以提高學習過程的效率與成效。儘管我們此前推出了具備智能識別功能的AI詞典筆，該產品能識別並朗讀中英文詞彙及句子，我們現在轉而專注於推廣一款功能更全面的新產品，用以取代傳統的AI詞典筆。

Revenue from the sales of these accessory products decreased by approximately 33.7% from RMB9.3 million in 2025 Interim to RMB6.2 million in 2026 Interim. The decrease was mainly due to: 1) the domestic economy being affected by the macro international environment, which negatively impacted product sales to a certain extent; 2) the smart learning hardware industry entering a stage of competition for existing market demand, characterized by sluggish end-consumer demand, escalating industry price wars, and ongoing pressure on selling prices and gross profit margins; 3) the rapid iteration of large AI models, leading general consumer devices to commonly feature free AI learning tools, which diverted users away from dedicated learning hardware; 4) the entry of enterprises from other industries into the educational electronics sector, further intensifying competitive pressure within the industry; and 5) the continuous decline in the K12 school-age population, leading to a year-on-year contraction of the overall industry market, shifting from incremental expansion to zero-sum stock-market rivalry, and escalating competition to a white-hot state.

Advertisement and Content Licensing

Revenue from advertisement and content licensing mainly derived from third parties placing in-app advertisements with us, and from those offering our licensed digital educational resources on their platforms or devices based on revenue-sharing arrangements. Typically, we place links to our clients' applications on the devices we sell and charge fees based on the fixed price per click or download stipulated in the contract signed with the client, as well as the number of clicks by end users. Additionally, we also license our pre-recorded video resources to third-party channels, who then offer the digital educational resources on their platforms for sale to end users or install our digital educational resources on their devices for end users to use. When users purchase digital educational resources from the platform, we are entitled to a fixed percentage of the total earnings collected by the channel, or when end users activate the third parties' devices, we are entitled to collect a fixed amount per activated device.

Revenue generated from advertisement and content licensing decreased by approximately 30.6% from approximately RMB4.1 million in 2025 Interim to approximately RMB2.9 million in 2026 Interim, primarily due to the decrease in sales volume of the Company's products, which led to a corresponding decrease in advertising and licensing revenue derived from product sales.

廣告及內容授權

來自廣告及內容授權的收入主要來自向我們投放應用程式內廣告的第三方，以及根據利潤分成安排在其平台或設備提供我們授權的數字化教輔資源的第三方的收入。通常情況下，我們會在銷售的設備上放置客戶的應用程式的鏈接，並根據與客戶簽訂的合同約定的每次點擊或下載的固定價格以及終端用戶的點擊次數來收取費用。此外，我們還將預先錄製的視頻資源授權予第三方渠道，由第三方渠道將數字化教輔資源投放在其平台上銷售予終端用戶或將數字化教輔資源安裝在其設備上以供終端用戶使用。當用戶從平台購買數字化教輔資源時，我們有權獲得渠道所收取的總所得款項的固定百分比，且當終端用戶激活第三方設備時，我們有權就每台激活設備收取固定金額的費用。

廣告及內容授權產生的收入由2025年中期的約人民幣4.1百萬元減少約30.6%至2026年中期的約人民幣2.9百萬元，此乃主要由於公司產品銷量減少，導致依附產品銷量而產生的廣告及授權收入相應減少。

Distribution Network

The Group primarily sells its products through third-party offline distributors. These distributors have their own sales networks and customer bases, which can assist us in promoting our products more extensively. We also distribute through online channels comprising of our self-operated online stores on mainstream e-commerce marketplaces and a limited number of online distributors.

By selling our products through online channels, we can expose our brand and products to a broader array of potential customers. Our self-operated online store provides a convenient shopping platform allowing customers to easily purchase our products. Simultaneously, we collaborate with several online distributors, such as mainstream e-commerce platforms like Taobao and JD.com, offering our customers a more convenient shopping experience, while expanding the exposure and sales channels of our products.

Our sales strategy is diversified, relying on both offline distributors and online sales channels to ensure that our products can be discovered and purchased by a larger customer base.

The table below sets forth the revenue contribution by our sales channels.

通過在線上渠道銷售產品，我們可以讓更多的潛在客戶發現我們的品牌和產品。我們的自營網店提供了一個方便的購物平台，讓客戶可以輕鬆地購買我們的產品。同時，我們也與一些線上經銷商合作，例如淘寶和京東等主流電商平台，我們可以為客戶提供更加便捷的購物體驗，同時擴大我們產品的曝光率和銷售渠道。

我們的銷售策略是多元化的，既依賴線下經銷商，也通過線上渠道進行銷售，以確保我們的產品可以被更多的客戶發現和購買。

Readboy Institute of Education Technology

We strive to explore educational resources and deliver high-quality digital educational resources to Chinese students. We established the Readboy Institute of Education Technology in 2017. The Institute is our in-house educational resource research and development center, mainly responsible for content research, educational resource design and development, courseware and pre-recorded video resource production, and other relevant supportive services. We have four educational technology institutes located in Beijing, Huanggang, Zhongshan, and Zhuhai to further enhance our research and support in this area.

Zhuhai Big Data Centre

The Zhuhai Big Data Centre commenced operation in 2024. It aims to support the operation of education data and AI applications, showcase the Company's products, receive customer visits and provide practical product application experiences. For details of the use of funds relating to the Zhuhai Big Data Centre, please refer to the section headed "Use of Proceeds from the Global Offering" in this report.

In the first half of 2026, the Zhuhai Big Data Centre continued to support the Group's capability building in areas such as education data processing, cloud computing resources, algorithm optimisation and product feature iteration. It also provided technical support for certain AI applications and the deployment of products in in-school smart education scenarios.

Subject to compliance with applicable requirements relating to data security, personal information protection and the protection of minors, the Group will continue to enhance the relevant data infrastructure and management mechanisms to support product development, learning progress analysis and personalised services. As at 30 June 2026, the cumulative use of funds for the project was generally in line with the budget set out in the Prospectus, and no cost overrun had occurred.

讀書郎教育科技有限公司

我們致力於挖掘教輔資源，並向中國學生提供優質的數字化教輔資源。於2017年，我們成立了讀書郎教育科技有限公司，作為內部的教輔資源研發中心，主要負責內容研究、教輔資源設計與開發、課件及錄播視頻資源製作等相關支援服務。我們在北京、黃岡、中山及珠海設有4個教育科技有限公司，進一步加強這方面的研發與支持。

珠海大數據中心

珠海大數據中心於2024年投入使用，旨在支持教育數據運營與人工智能應用、展示本公司產品、接待客戶及提供產品實際應用體驗。有關珠海大數據中心的資金使用詳情，請參閱本報告「全球發售所得款項用途」一節。

於2026年上半年，珠海大數據中心繼續為本集團在教育數據處理、雲端算力、算法優化及產品功能迭代等方面的能力建設提供支持，並為若干人工智能應用及校內智慧教育場景的產品部署提供技術支援。

本集團將在遵守適用數據安全、個人信息保護及未成年人保護規定的前提下，持續完善相關數據基礎設施及管理機制，以支持產品開發、學情分析及個性化服務。於2026年6月30日，該項目的累計資金使用情況整體符合招股章程所載預算，並無出現超支情況。

FINANCIAL REVIEW

Revenue

The revenue of the Group decreased by approximately 59.0% from RMB182.0 million in 2025 Interim to RMB74.5 million in 2026 Interim. The decrease in revenue was mainly attributable to the decline in revenue from personal student tablets, wearable products, other products, and advertising and content licensing, which was partially offset by the increase in revenue from digital and smart classroom solutions.

財務回顧

收入

本集團的收入由2025年中期的人民幣182.0百萬元減少約59.0%至2026年中期的人民幣74.5百萬元。收入下降主要由於學生個人平板、可穿戴產品、其他產品以及廣告及內容授權收入減少，部分被數智校園解決方案收入增加所抵銷。

Cost of Sales

Our cost of sales decreased by approximately 55.1% from RMB141.6 million in 2025 Interim to RMB63.6 million in 2026 Interim. The decrease in cost of sales was mainly attributable to the decline in revenue and sales volume of the related products during the Period.

銷售成本

我們的銷售成本由2025年中期的人民幣141.6百萬元減少約55.1%至2026年中期的人民幣63.6百萬元。銷售成本下降主要由於期內收入及相關產品銷量下降。

Gross Profit and Gross Profit Margin

Our gross profit decreased by approximately 72.9% from RMB40.3 million in 2025 Interim to RMB10.9 million in 2026 Interim, while our gross profit margin decreased from 22.2% in 2025 Interim to 14.6% in 2026 Interim. The decrease was primarily due to the discounted sales of learning tablet inventory, as well as the provision of more special-offer models to support channel sales, resulting in a lower gross profit.

毛利及毛利率

我們的毛利由2025年中期的人民幣40.3百萬元減少約72.9%至2026年中期的人民幣10.9百萬元，毛利率則由2025年中期22.2%減少至2026年中期14.6%，該減幅乃主要由於學習平板庫存產品折價銷售，同時，為支持渠道銷售，公司提供更多的特價機，導致毛利降低。

Other Income and Gains

Other income and gains increased by approximately 81.2% from RMB10.2 million in 2025 Interim to RMB18.5 million in 2026 Interim, which was mainly due to the increase of VAT additional deduction.

Selling and Distribution Expenses

Our selling and distribution expenses decreased by approximately 60.1% from RMB40.5 million in 2025 Interim to RMB16.2 million in 2026 Interim, which was primarily due to the decrease in marketing and promotion expenses of the Company.

Administrative Expenses

Our administrative expenses increased by approximately 10.1% from RMB21.3 million in 2025 Interim to RMB23.4 million in 2026 Interim, which was primarily due to the increase in termination benefit expenses.

Impairment losses on financial assets

Our impairment losses on financial assets decreased by approximately 94.9% from RMB5.3 million in 2025 Interim to RMB0.3 million in 2026 Interim which was mainly due to the Company incurred less expected credit losses on accounts receivable, prepayments, other receivables and other assets than last period.

Research and Development Expenses

Our research and development expenses decreased by approximately 43.4% from RMB21.6 million in 2025 Interim to RMB12.2 million in 2026 Interim, primarily due to the Company focusing more on research and development of software and reducing the number of research and development of hardware, which in turn lowered spending on third-party professional services, testing fees and sample materials.

Other Expenses

Our other expenses increased by approximately 56.1% from RMB4.9 million in 2025 Interim to RMB7.7 million in 2026 Interim, primarily due to the increase in exchange losses.

其他收入及收益由2025年中期的人民幣10.2百萬元增加約81.2%至2026年中期的人民幣18.5百萬元，此乃主要由於增值稅加計扣除增加所致。

銷售及經銷開支

銷售及經銷開支由2025年中期的人民幣40.5百萬元減少約60.1%至2026年中期的人民幣16.2百萬元，此乃主要由於公司在營銷推廣方面的費用減少。

行政開支

我們的行政開支由2025年中期的人民幣21.3百萬元增加約10.1%至2026年中期的人民幣23.4百萬元，此乃主要由於離職福利開支增加。

金融資產減值虧損

我們的金融資產減值虧損由2025年中期的人民幣5.3百萬元減少約94.9%至2026年中期的人民幣0.3百萬元，此乃主要由於與過往期間相比本公司應收賬款、預付款、其他應收款項及其他資產的預期信貸虧損有所減少。

研發開支

我們的研發開支由2025年中期的人民幣21.6百萬元減少約43.4%至2026年中期的人民幣12.2百萬元，主要由於本公司為更集中研發軟件，減少硬件研發數目，一定程度減少了專業機構服務費、檢測費、樣品材料等的資源投放。

其他開支

我們的其他開支由2025年中期的人民幣4.9百萬元增加約56.1%至2026年中期的人民幣7.7百萬元，主要由於匯兌虧損增加。

Finance Costs

Our finance costs increased by approximately 5.8% from RMB1.0 million in 2025 Interim to RMB1.1 million in 2026 Interim, primarily due to the increase in interest expense from Interest-bearing bank borrowings.

Fair value loss on financial assets at fair value through profit or loss

For the six months ended 30 June 2026, the Group did not record any fair value loss on financial assets at fair value through profit or loss (2025 Interim: RMB0.7 million), primarily because the Group disposed of its listed equity investment in Flowing Cloud Technology Ltd in 2025 and no longer held the relevant financial assets as at 30 June 2026.

按公允價值計入損益的金融資產公允價值虧損

截至2026年6月30日止六個月，本集團並無錄得按公允價值計入損益的金融資產公允價值虧損（2025年中期：人民幣0.7百萬元），主要由於本集團已於2025年出售其於飛天雲動科技有限公司的上市股權投資，且於2026年6月30日不再持有相關金融資產。

Loss Before Tax

As a result of the foregoing, our loss before tax was RMB44.9 million in 2025 Interim and our loss before tax was RMB31.5 million in 2026 Interim.

Income Tax Credit

We recorded income tax credit of RMB180,000 in 2026 Interim, mainly as a result of the fluctuation in deferred tax assets of right-of-use assets and lease liabilities. Income tax credit amounted to RMB79,000 was recorded in 2025 Interim.

Loss for the Period

As a result of the foregoing, we recognised a net loss of RMB31.3 million and a net loss of RMB44.8 million for 2026 Interim and 2025 Interim, respectively. The change in net loss was mainly attributable to the combined effect of (i) the decrease in gross profit by approximately RMB29.4 million; partially offset by (ii) the increase in other income and gains by RMB8.3 million; (iii) the decrease in selling and distribution expenses by RMB24.4 million and (iv) the decrease in research and development expenses by RMB9.4 million.

Non-HKFRS Measures

To supplement the Group's unaudited consolidated financial statements, which are presented in accordance with HKFRS, we also present adjusted net profit or loss as additional financial measures, which are not required by, or presented in accordance with, HKFRS. Adjusted net profit or loss, as we present it, represents profit or loss for the period before fair value loss on financial assets at fair value through profit or loss. Fair value loss on financial assets at fair value through profit or loss are non-cash expenses in connection with the Group's listed equity investment in Flowing Cloud. We believe that the presentation of non-HKFRS measures, when shown in conjunction with the corresponding HKFRS measures, provides useful information to investors and management.

While these non-HKFRS measures provide additional financial measures for investors to assess our operating performance, the use of these non-HKFRS measures has certain limitations because they do not reflect all items of income and expense that affect our operations. Our presentation of these non-HKFRS measures should not be construed as an inference that our future results will be unaffected by such unusual items.

These non-HKFRS measures should not be considered in isolation or construed as a substitute for analysis of HKFRSs financial measures. In addition, as these measures may not be calculated in the same manner by all companies, our adjusted net profit or loss (a non-HKFRS measure) may not be comparable to the same or similarly titled measures presented by other companies.

LIQUIDITY, FINANCIAL AND CAPITAL STRUCTURE

流動資金、財務及資本架構

The Group has always adhered to a prudent financial management policy. As at 30 June 2026, the Group maintains a liquidity level sufficient to support its daily operations and short-term financial obligations. However, management will continue to closely monitor cash flow, borrowing arrangements and working capital changes to ensure financial soundness. Therefore, the management does not expect a material funding shortfall in the near term.

本集團一貫奉行審慎的資金管理政策。於2026年6月30日，本集團維持足以支持日常營運及短期財務承擔的流動資金水平。然而，管理層將繼續密切監察現金流、借款安排及營運資金變化，以確保財務穩健。因此，管理層預期短期內不會出現重大資金短缺。

The Group does not currently have any major capital investment plans and has no plans to conduct any fundraising activities. The Group intends to fund its operations and financial requirements primarily through its existing cash resources, available banking facilities and cash generated from future operations.

Looking ahead, the Group will continue to closely monitor its financial position and the market changes in assessing funding needs based on practical considerations, in order to ensure financial stability.

As at 30 June 2026, the Group had unutilised banking facilities of approximately RMB54.4 million (as at 31 December 2025: RMB31.4 million).

Cash Position

As at 30 June 2026, the Group had cash and cash equivalents of RMB90.8 million (as at 31 December 2025: RMB155.7 million), which primarily consisted of deposits in bank denominated in RMB, USD and HKD.

Gearing Ratio

Our gearing ratio is calculated as the total liabilities divided by total assets. As at 30 June 2026, our gearing ratio was 47.0%, as compared with 52.2% as at 31 December 2025. The decrease was mainly attributable to the decline in total liabilities exceeding the decline in total assets.

Contingent Liabilities and Guarantees

As at 30 June 2026, the Group did not have significant contingent liabilities, guarantees or any litigations or claims of material importance (as at 31 December 2025: nil).

Significant Investments, Major Acquisitions and Disposals

During the six months ended 30 June 2026, the Group (i) did not have any single investment accounting for 5% or more of the total assets of the Group as at 30 June 2026; and (ii) did not conduct material acquisitions or disposals of subsidiaries, joint ventures and associates (2025 Interim: nil). Save as disclosed in the sections headed “Business” and “Future Plans and Use of Proceeds” in the Prospectus, the Group did not have any future plans for significant investment or acquisition of material capital assets or other businesses as at 30 June 2026.

Accordingly, the Group considers its exposure to currency risk to be insignificant. As at 30 June 2026, the Group has not entered into any hedging transaction against foreign currency risks (as at 31 December 2025: nil). However, the Board will remain alert to any relevant risks and, if necessary, consider to hedge any material potential foreign exchange risk.

USE OF PROCEEDS FROM THE GLOBAL OFFERING

The Company's Shares have been listed on the Stock Exchange since the Listing Date.

Net proceeds from the Global Offering received by the Company were approximately HK\$364.6 million with 52,000,000 new ordinary Shares issued at the price of HK\$7.60 per Share. The total amount of net proceeds from the Global Offering are proposed to be used for the purposes and in the amounts (adjusted on pro rata basis based on the actual net proceeds) as disclosed in the Prospectus as follows:

During the six months ended 30 June 2026, the total amount of net proceeds from the Global Offering has been used according to the intentions previously disclosed in the Prospectus. Unutilised net proceeds were deposited into short-term demand deposits with licensed banks or authorised financial institutions. The unutilised net proceeds are intended to be used in the same manner as stated in the Prospectus.

EMPLOYEE AND REMUNERATION POLICY

As at 30 June 2026, the Group had a total of 209 full-time employees (as at 31 December 2025: 341 full-time employees). For the six months ended 30 June 2026, the Group recognised staff costs of approximately RMB25.1 million (2025 Interim: RMB30.2 million). The Group provided employees with salaries and benefits that, in its opinion, were competitive with market standards and regularly reviewed the remuneration policies based on employees' contributions and industry standards. The Group also contributed to medical insurance, pension insurance, maternity insurance, unemployment insurance, work-related injury insurance and housing provident funds for our employees and paid relevant insurance premiums. In addition, the Group also engaged external experts to provide internal training courses for its employees from time to time, with the aim of enabling the Group's staff and management at all levels to enhance their skills and acquire professional knowledge while boosting their morale. Further, the Group has adopted the RSU Scheme (as defined below), the Post-IPO Share Option Scheme (as defined below) and the Share Award Scheme (as defined below) to reward the eligible participants for their contribution to the success of the Group and to provide incentives for their continuing contribution. No RSU has been granted, outstanding, vested, unvested, cancelled, or lapsed since the Adoption Date and up to the Latest Practicable Date.

Contributions to the defined contribution plan by the Group for its employees are fully and immediately vested when the contributions are made and may not be reduced by contributions forfeited by employees who leave the schemes prior to vesting fully in the contributions. Accordingly, during the six months ended 30 June 2026, there were no forfeited contributions under the aforementioned defined contribution retirement benefit plans which may be used by the Group to reduce the contribution payable.

The Group's employees do not negotiate their terms of employment through any labor union or by way of collective bargaining agreements. During the six months ended 30 June 2026, no labor dispute had occurred which materially and adversely affected or was likely to have a material and adverse effect on the operations of the Group.

CONNECTED TRANSACTION UPDATE

2025 Loan Agreement

On 15 May 2025, Readboy Educational Technology Company Limited (“Readboy Technology”), an indirect wholly-owned subsidiary of the Company, entered into a loan agreement with Zhuhai Dreamcatcher Network Technology Co., Ltd. (“Zhuhai Dreamcatcher”), pursuant to which Readboy Technology agreed to provide Zhuhai Dreamcatcher with a loan in the maximum principal amount of RMB4.0 million. The actual amount of the loan provided was RMB3.6 million, bearing interest at a rate of 2.86% per annum and maturing on 14 May 2026.

As Zhuhai Dreamcatcher is jointly held by Mr. Chen Zhiyong and Mr. Qin Shuguang, each being a Director and a Controlling Shareholder of the Company, Zhuhai Dreamcatcher is a connected person of the Company. Accordingly, the provision of the loan constituted a connected transaction of the Company. Details of the transaction are set out in the announcement of the Company dated 15 May 2025.

On 21 April 2026, Zhuhai Dreamcatcher fully repaid to Readboy Technology the principal amount of RMB3.6 million and all accrued interest under the above loan. Accordingly, as at 30 June 2026, there was no outstanding balance under the loan.

SHARE INCENTIVE SCHEMES

1. RSU Scheme

The Company approved and adopted the RSU Scheme on 21 June 2022 (the “**Adoption Date**”), and the remaining life of the RSU Scheme was approximately five years and nine months as at the Latest Practicable Date.

As at the Latest Practicable Date, 13,365,371 Shares were held by Driving Force as reserve for future grant of RSUs under the RSU Scheme. Driving Force is a limited liability company wholly-owned by Ms. Liu Zhilan. Pursuant to a declaration of trust dated 21 March 2022, Ms. Liu Zhilan (as the RSU Trustee) confirmed that (i) she held the entire shareholding interests of Driving Force for the sole purpose of setting up the RSU Scheme for the Company; and (ii) she in the capacity as the RSU Trustee will vest the relevant underlying Shares (reserved and held by Driving Force) of the RSUs granted under the RSU Scheme in accordance with the instruction of the Company for the benefit of the employees of the Company.

No RSU has been granted, outstanding, vested, unvested, cancelled, or lapsed since the Adoption Date and up to the Latest Practicable Date. As at the Listing Date, 31 December 2025, 30 June 2026 and the Latest Practicable Date, the number of Shares available for grant under the RSU Scheme was 13,365,371 Shares. As at 1 January 2026, 30 June 2026 and the Latest Practicable Date, the number of Shares available for grant under the RSU Scheme was still 13,365,371 Shares. Such number of Shares represents approximately 3.80% of the total number of Shares in issue as at the date of the 2026 interim report considering that there has been no change in the total number of Shares in issue since the Listing Date and up to the Latest Practicable Date. There is no service provider sublimit being defined under the RSU Scheme as stated below.

A summary of principal terms of the RSU Scheme is set out as follows:

(a) Purpose

The purpose of the RSU Scheme is to reward the RSU Grantees for their services and contribution to the success of the Group, and to provide incentives to them to further contribute to the Group.

Any decision of the Board made in accordance with the rules of the RSU Scheme shall be final, conclusive and binding, provided in each case that such decision is made in accordance with the Articles and any applicable laws.

The Board may delegate the authority to administer the RSU Scheme to any one or more Directors.

Under the terms of the RSU Scheme, there is no specified maximum entitlement of Shares to be granted to each participant.

(f) *Who may join*

The Directors (which expression shall, for the purpose of this paragraph, include a duly authorised committee thereof) may, at their absolute discretion, invite any person belonging to any of the following classes of participants, who the Board considers, in its sole discretion, has contributed or will contribute to the Group, to receive RSU(s) under the RSU Scheme (collectively the “**Eligible Persons**”):

- (i) employees of the Group (including director, chief executive officer, members of senior management, key technical personnel or employees of any member of the Group); and
- (ii) any other person selected by the Board at its sole discretion from time to time.

- (d) where our Company has information that must be disclosed under Rule 13.09 of the Listing Rules or where the Company reasonably believes there is inside information which must be disclosed under Part XIVA of the SFO (as may be amended from time to time), until such price sensitive/inside information has been published on the websites of the Stock Exchange and the Company;

- (f) the grant would result in breach of the limit of the RSU Scheme or other rules of the RSU Scheme.

(h) *Grant of RSU(s)*

Subject to the limitations and conditions of the RSU Scheme, the Board or the RSU Trustee (upon receipt of the notification from the Board) shall grant an offer of grant of RSU(s) to any Selected Person by way of a letter (the “**Grant Letter**”) on such terms and conditions as the Board may determine.

To the extent that the offer of grant of a RSU(s) is not accepted by the Selected Person within the time period or in a manner prescribed in the Grant Letter, it shall be deemed that such offer has been irrevocably declined and thus the grant has immediately lapsed.

(i) *Vesting*

The Board has the sole discretion to determine the vesting schedule and vesting criteria (if any) for any grant of award(s) to any RSU Grantee, which may also be adjusted and redetermined by the Board from time to time. The RSU Trustee should administer the vesting of the awards granted to each RSU Grantee pursuant to the vesting schedule and vesting criteria (if any) determined by the Board.

(c) *Restrictions on time of grant*

No grant of options shall be made after any inside information has come to the knowledge of our Company until such inside information has been announced pursuant to the requirements of the Listing Rules. In particular, no option shall be granted during the period of one month immediately preceding the earlier of: (i) the date of our Board meeting as shall have been notified to the Stock Exchange for the approval of our Company’s results for any year, half-year, quarterly or any other interim period (whether or not required under the Listing Rules); and (ii) the deadline for our Company to publish an announcement of its results for any year or half-year under the Listing Rules or quarterly or any other interim period (whether or not required under the Listing Rules), and ending on the actual date of the results announcement for such year, half-year, quarterly or interim period (as the case may be). The period during which no option may be granted will cover any period of delay in the publication of a results announcement.

(d) Grant to connected persons

Any grant of options to a connected person must be approved by all independent non-executive Directors (excluding any independent non-executive Director who is also a proposed Option Grantee of the options, the vote of such independent non-executive Director shall not be counted for the purposes of approving the grant).

(e) Grant to substantial shareholders and independent non-executive directors

Without prejudice to sub-paragraph 4(c) above, any grant of options to a substantial shareholder or an independent non-executive Director of our Company or any of their respective associates shall be subject to, in addition to the approval of our independent non-executive Directors in sub-paragraph (d) above, the issue of a circular by our Company to its Shareholders and the approval of our Shareholders in general meeting if our Shares issued and to be issued upon exercise of all options already granted and proposed to be granted to him (whether exercised, canceled or outstanding) under the Share Option Scheme or any other scheme in the twelve (12) month period up to and including the Offer Date:

- (i) would represent in aggregate more than 0.1%, or such other percentage as may from time to time be provided under the Listing Rules, of our Shares in issue on the Offer Date; and
- (ii) would have an aggregate value, based on the official closing price of our Shares as stated in the daily quotation sheets of the Stock Exchange on the Offer Date, in excess of HKD5,000,000 (or such other amount as shall be permissible under the Listing Rules from time to time).

There is no specific performance targets stipulated under the terms of the Share Option Scheme and our Board currently has no intention to set any specific performance targets on the exercise of any options granted or to be granted under the Share Option Scheme.

(h) *Vesting*

Options granted under the Share Option Scheme shall be subject to such vesting conditions as set forth in the respective Option Grantee's Offer Document. In addition to such other performance-based vesting conditions (if any) set forth in the respective Option Grantee's Offer Document and unless otherwise approved by the Board in writing, (i) the vesting schedule requires continued employment of or service by the respective Option Grantee through each applicable vesting date as a condition to the vesting of the applicable percentage of the option and the rights and benefits under the Share Option Scheme and the respective Option Grantee's Offer Document; and (ii) employment or service for only a portion of the respective vesting period, even if a substantial portion, will not entitle the respective Option Grantee to any proportionate vesting of the option.

The price per Share at which an Option Grantee may subscribe for Shares upon exercise of an option (the “**Exercise Price**”) shall, subject to any adjustment(s) under the terms of the Share Option Scheme, be determined by our Board in its sole discretion but in any event shall be at least the highest of:

- (i) the official closing price of our Shares as stated in the Stock Exchange’s daily quotations sheets on the Offer Date;
- (ii) the average of the official closing prices of our Shares as stated in the Stock Exchange’s daily quotation sheets for the five business days immediately preceding the Offer Date; and
- (iii) the nominal value of a Share; provided that for the purpose of determining Exercise Price under subparagraph 5(ii) above where our Shares have been listed on the Stock Exchange for less than five Business Days preceding the Offer Date, the issue price of our Shares in connection with such listing shall be deemed to be the closing price of our Shares for each Business Day falling within the period before the listing of our Shares on the Stock Exchange.

(6) Maximum number of Shares available for subscription

(a) Scheme limit

Subject to sub-paragraphs 6(b) and 6(c) below, the maximum number of Shares in respect of which options may be granted under the Share Option Scheme and any other Share Option Schemes of our Company shall not in aggregate exceed the number of Shares that shall represent 10% of the total number of Shares in issue immediately upon completion of the Global Offering and the Capitalization Issue (the “**Scheme Limit**”) which is 35,200,000 Shares. For the purpose of calculating the Scheme Limit, options which have lapsed in accordance with the terms of the Share Option Scheme (or any other share option schemes of the Company) shall not be counted.

Our Company may seek separate approval by our Shareholders in general meeting for granting options beyond the Scheme Limit provided that the options in excess of the Scheme Limit are granted only to Eligible Participants who are specifically identified by our Board before such approval is sought.

For the purpose of seeking the approval of our Shareholders under this sub-paragraph (6)(c), our Company must send a circular to our Shareholders containing a generic description of the specified Eligible Participants who may be granted such options, the number and terms of the options to be granted, the purpose of granting such options to the Option Grantees with an explanation as to how the terms of options serve such purpose and the information required under Rule 17.02(2)(d) of the Listing Rules.

Shares to be allotted upon exercise of an option will be subject to all the provisions of the Articles of Association and will rank *pari passu* with the fully paid Shares in issue on the date of issue. Accordingly, such Shares will entitle the holders to have the same voting, dividend, transfer and other rights, and to participate in all dividends or other distributions paid or made on or after the date on which the allottee is registered as a member (the “**Registration Date**”) other than any dividends or other distributions previously declared or recommended or resolved to be paid or made with respect to a record date which is before the Registration Date.

A Share issued upon the exercise of an option shall not carry any voting rights until completion of registration of the Option Grantee or his nominee as the holder of such Share on the register of members of our Company. Shares issued on the exercise of an option shall not rank for any rights attaching to Shares by reference to a record date preceding the date of allotment.

(8) Exercise of options

Unless otherwise provided in the respective Option Grantee’s Offer Document, an option may be exercised by an Option Grantee at any time or times during the period notified by our Board during which the Option Grantee may exercise his option(s) (the “**Option Period**”) provided that:

- (a) in the event of the Option Grantee ceasing to be an Eligible Participant for any reason other than his death, ill-health, injury, disability or the termination of his relationship with our Company and/or any of its subsidiaries on one or more of the grounds specified under the terms of Share Option Scheme, the Option Grantee may exercise the option up to his entitlement at the date of cessation of being an Eligible Participant (to the extent not already exercised) within the period of thirty (30) days (or such longer period as our Board may determine) following the date of such cessation (which date shall be, in relation to an Option Grantee who is an Eligible Participant by reason of his employment with our Company or any of its subsidiaries, the last actual working day with our Company or the relevant subsidiary whether salary is paid in lieu of notice or not);

(d) if a compromise or arrangement between our Company and our Shareholders and/or creditors is proposed for the purposes of or in connection with a scheme for the reconstruction of our Company or its amalgamation with any other company or companies pursuant to the Companies Law, our Company shall give notice thereof to all the Option Grantees (together with a notice of the existence of the provisions of this paragraph) on the same day as it despatches to Shareholders and/or creditors of our Company a notice summoning the meeting to consider such a compromise or arrangement, and thereupon each Option Grantee shall be entitled to exercise all or any of his options in whole or in part at any time prior to noon (Hong Kong time) on the Business Day immediately preceding the date of the general meeting directed to be convened by the relevant court for the purposes of considering such compromise or arrangement and if there is more than one meeting for such purpose, the date of the first meeting. With effect from the date of such meeting, the rights of all Option Grantees to exercise their respective options shall forthwith be suspended. Upon such compromise or arrangement becoming effective, all options shall, to the extent that they have not been exercised, lapse and determine. 3. Share Award Scheme

The Company has adopted the Share Award Scheme on 28 April 2023. The Board intends to instruct Equiom Fiduciary Services (Hong Kong) Limited and any additional or replacement trustees, being the trustee or trustees of the trust of the Share Award Scheme (the “**Trustee**”) to purchase a certain number of existing Shares on the Stock Exchange at the market trading price as and when appropriate in accordance with the applicable laws and regulations and the rules relating to the Share Award Scheme (the “**Share Award Scheme Rules**”) as the awarded Shares for the Share Award Scheme. The remaining life of the Share Award Scheme was approximately six years and seven months as of the Latest Practicable Date.

3. 股份獎勵計劃

本公司於2023年4月28日採納股份獎勵計劃。董事會計劃於適當時候根據適用法律法規及股份獎勵計劃規則（「**股份獎勵計劃規則**」）指示Equiom Fiduciary Services (Hong Kong) Limited及任何額外或替代受託人，即股份獎勵計劃中的信託的一名或多名受託人（「**受託人**」）於聯交所按照市場交易價購買若干數目的現有股份作為股份獎勵計劃的獎勵股份。截至最後實際可行日期，股份獎勵計劃的餘下年期約為六年七個月。

No Share award has been granted, outstanding, vested, unvested, cancelled or lapsed since the adoption date of the Share Award Scheme, 1 January 2026, 30 June 2026 and up to the Latest Practicable Date. There is no service provider sublimit being defined under the Share Award Scheme.

A summary of the principal terms of the Share Award Scheme Rules is set out as follows:

(a) Purposes and participants

The purposes of the Share Award Scheme are to recognize and acknowledge the contributions by the person(s) who are eligible to be selected as a Share award grantee (the “**Share Award Grantee**”) according to the terms of the Share Award Scheme, which include (i) the Directors and employees of the Group (excluding Directors, chief executive of the Company, core connected person of the Group or any of their respective associates); (ii) directors and employees (excluding Directors, chief executive of the Company, core connected person of the Group or any of their respective associates) of (a) any direct or indirect holding company of the Company; (b) any direct or indirect subsidiary of any company include in (a) above; and (c) any associated company of the Company, but excluding any members of the Group; and (iii) any service providers of the Group on a continuing and recurring basis in its ordinary and usual course of businesses which are material to the long-term growth of the Group (excluding Directors, chief executive of the Company, core connected person of the Group or any of their respective associates) whom the Board or the committee of the Share Award Scheme, in its sole discretion, determines that have contributed or will contribute to the Group (collectively, the “**Eligible Participants**”) and to provide them with incentives in order to motivate them to optimise their performance and efficiency for the benefit of the Group, as well as to attract and retain or otherwise maintaining ongoing business relationships with the Eligible Participants whose contributions are, or, will or are expected to be, beneficial to the Group.

(b) Duration

Subject to any early termination as may be determined by the Board or the committee of the Share Award Scheme, the Share Award Scheme shall be valid and effective for a period of ten years commencing on the adoption date of the Share Award Scheme (i.e. 28 April 2023).

Any early termination of the Share Award Scheme shall not affect any subsisting rights of any Eligible Participants or Share Award Grantees. Upon termination, (i) no further grant of the award may be made under the Share Award Scheme; (ii) all awarded Shares and the related income shall become vested in the relevant Share Award Grantees on such date of termination; and (iii) net sale proceeds (after making appropriate deductions) of the awarded Shares or related income which are not vested and/or forfeited in accordance with the terms of the Share Award Scheme Rules (the **“Returned Shares”**) and the residual cash and such other funds remaining in the trust (the **“Trust”**) constituted by the trust deed to be entered into between the Company and the Trustee (**“Trust Deed”**) shall be remitted to the Company.

(c) Administration

The Share Award Scheme is subject to the administration by the Board or the committee of the Share Award Scheme (as delegated by the Board) in accordance with the Share Award Scheme Rules and terms of the Trust Deed.

(b) 期限

除董事會或股份獎勵計劃委員會可能決定作出任何提前終止外，股份獎勵計劃將於股份獎勵計劃採納日期（即2023年4月28日）起計之十年期間內生效及有效。

(c) 管理

(d) Operation of the Share Award Scheme

The committee of the Share Award Scheme has been delegated with authority by the Board to maintain an oversight of the operations of the Share Award Scheme and to make recommendations to the Board from time to time for its consideration and approval on the operations of the Share Award Scheme, including the selection of the Eligible Participants, the terms of the grant of awards and the other related matters as expressly provided under the Share Award Scheme Rules and the Listing Rules. The Board or the committee of the Share Award Scheme shall cause to be paid to the Trustee (or its nominee) the purchase price and the related expenses for the purchase of Shares from the Stock Exchange at the market trading price. The Trustee must hold the Shares until they are vested in accordance with the Share Award Scheme Rules. When the Share Award Grantee has satisfied all vesting conditions (if any) specified by the Board or the committee of the Share Award Scheme at the time of making the award and become entitled to the Shares forming the subject of the award, the Board or the committee of the Share Award Scheme may instruct the Trustee (i) to transfer the relevant vested Shares to the Share Award Grantee; or (ii) to sell the relevant vested Shares on the market and transfer the net sales proceeds to the Share Award Grantee.

The Trustee shall administer the Share Award Scheme in the manner specified in the Trust Deed and the Share Award Scheme Rules.

Subject to and in accordance with the Share Award Scheme Rules, the Listing Rules and all applicable laws and regulations, the Board or the committee of the Share Award Scheme shall be entitled (after considering recommendations and proposals from the committee of the Share Award Scheme in accordance with its terms of reference), at any time on any business day of Hong Kong during the period of ten (10) years commencing on the adoption date of the Share Award Scheme (i.e. 28 April 2023), subject to any early termination of the Share Award Scheme, to grant an award to any Eligible Participant, as the Board or the committee of the Share Award Scheme may in its absolute discretion select.

(d) 股份獎勵計劃的運作

股份獎勵計劃委員會已獲董事會授權監督股份獎勵計劃的運作，並不時就股份獎勵計劃的運作向董事會作出建議，供其審議及批准，包括篩選合資格參與者、授出獎勵的條款以及股份獎勵計劃規則及上市規則明文規定的其他相關事宜。董事會或股份獎勵計劃委員會須促使向受託人（或其代名人）支付自聯交所按照市場交易價購買股份的購買價及相關開支。受託人必須持有股份直至股份根據股份獎勵計劃規則歸屬為止。當股份獎勵承授人於作出獎勵時已滿足董事會或股份獎勵計劃委員會訂明的所有歸屬條件（如有）並有權獲得構成獎勵標的的股份時，董事會或股份獎勵計劃委員會可指示受託人(i)將相關已歸屬股份轉讓予股份獎勵承授人；或(ii)於市場出售相關已歸屬股份，並將出售所得款項淨額轉讓予股份獎勵承授人。

受託人須按照信託契據及股份獎勵計劃規則指定的方式管理股份獎勵計劃。

於股份獎勵計劃規則、上市規則及所有適用法律法規的規限下，董事會或股份獎勵計劃委員會自股份獎勵計劃獲採納之日（即2023年4月28日）起十(10)年期內的任何香港營業日隨時有權（經考慮股份獎勵計劃委員會根據其職權範圍作出的推薦建議及建議後）向董事會或股份獎勵計劃委員會全權酌情選定的任何合資格參與者授予獎勵，惟須受提早終止股份獎勵計劃規限。

No acceptance price or purchase price of award Share was specified under the Share Award Scheme Rules, and the basis of determining the purchase price of award Share was not specified under the Share Award Scheme Rules.

(e) Vesting and lapse

Unless otherwise determined by the Board or the committee of the Share Award Scheme at its discretion, the number of Shares awards held by the Trustee on Trust and which are entitled by a Share Award Grantee shall be vested to that Share Award Grantee in accordance with the Share Award Scheme Rules and any specific conditions as determined by the Board or the committee of the Share Award Scheme at its absolute discretion.

A Share Award Grantee shall not have any interest or rights (including the right to receive dividends) in the awarded Shares prior to the vesting date of the awarded Shares. An Eligible Participant or Share Award Grantee shall also have no rights in the residual cash of the Trust or Shares or such other trust fund or property held by the trust.

(e) 歸屬及失效

除董事會或股份獎勵計劃委員會另行酌情釐定外，受託人以信託形式持有且股份獎勵承授人有權享有的獎勵股份數目將按股份獎勵計劃規則及董事會或股份獎勵計劃委員會全權酌情釐定的任何具體條件歸屬予該股份獎勵承授人。

股份獎勵承授人於獎勵股份歸屬日期前不得於獎勵股份中擁有任何權益或權利（包括收取股息的權利）。合資格參與者或股份獎勵承授人亦不得於信託的剩餘現金或股份或信託持有的有關其他信託基金或財產中擁有任何權利。

The Share award, unless the Board or the committee of the Share Award Scheme otherwise determines, will be forfeited and the relevant awarded Shares shall not be vested on the relevant vesting date of the awarded Shares but become Returned Shares for the purpose of the Share Award Scheme.

(f) Share Award Scheme limit and maximum entitlement of each Eligible Participant

The Board or the committee of the Share Award Scheme shall not make any further award of awarded Shares which will result in the number of Shares awarded by the Board or the committee of the Share Award Scheme under the Share Award Scheme exceeding ten per cent (10%) of the issued share capital of the Company as at the adoption date (i.e. 28 April 2023) of the Share Award Scheme (i.e. 35,200,000 Shares), accounting for approximately 10% of the total number of Shares in issue as at the adoption date.

There is no maximum entitlement of award Shares of each Eligible Participant under the Share Award Scheme Rules.

倘股份獎勵承授人 (i) 由於嚴重行為不當或無力償債或破產或無法償還債務或與債權人訂立任何一般債務償還安排或債務重組協議或任何涉及個人品格或誠信之刑事罪行或僱主有權立刻終止其聘用之任何其他原因，終止其聘用或董事資格而不再為合資格參與者；(ii) 將其獎勵轉讓、分配予任何其他人士；或 (iii) 因任何其他原因不再為合資格參與者，則尚未歸屬的股份獎勵將被沒收。除非董事會或股份獎勵計劃委員會另行決定，否則股份獎勵將被沒收，相關獎勵股份將不會在相關獎勵股份歸屬日期歸屬，但就股份獎勵計劃而言將成為退還股份。

(f) 股份獎勵計劃限額及每名合資格參與者的最高可獲授數目

董事會或股份獎勵計劃委員會不應作出任何進一步獎勵股份獎勵致股份獎勵計劃項下由董事會或股份獎勵計劃委員會獎勵的股份數目超過本公司於股份獎勵計劃採納日期（即2023年4月28日）已發行股本的百分之十（10%）（即35,200,000股股份，佔採納日期已發行股份總數的約10%）。

股份獎勵計劃規則並無規定可授予每名合資格參與者獎勵股份的最高可獲授數目。

(g) Voting rights

No instructions shall be given by a Share Award Grantee (including, without limitation, voting rights) to the Trustee in respect of the awarded Shares that have not been vested, and such other properties of the trust fund managed by the Trustee (or its nominee). Notwithstanding that the Trustee (or its nominee) is the legal registered holder of the Shares held upon trust pursuant to the Trust Deed or the Share Award Scheme Rules, the Trustee (or its nominee) holding unvested Shares of the Share Award Scheme, whether directly or indirectly, shall not exercise the voting rights attached to such Shares and abstain from voting on matters that require Shareholders' approval under the Listing Rules, unless otherwise required by law to vote in accordance with the beneficial owner's direction and such a direction is given.

(h) Interest in the Share award

Any award made under the Share Award Scheme shall be personal to the Share Award Grantee to whom it is made and shall not be transferable or assignable, and no Share Award Grantee shall in any way sell, transfer, charge, mortgage, encumber or create any interest in favour of any other person except for any company that is wholly-owned by the Share Award Grantee or a Trust which the settlor is the Share Award Grantee over or in relation to such Share award.

For other details of the Share Award Scheme, please refer to the announcement of the Company dated 28 April 2023.

The Company has three share incentive schemes in place, namely the RSU Scheme, the Share Option Scheme, and the Share Award Scheme. These schemes are designed to motivate and reward eligible individuals who contribute to the development of the Company. As of the Latest Practicable Date, no awards have been granted or exercised under any of these three schemes.

During the six months ended 30 June 2026, the number of Shares that may be issued in respect of options and awards granted under all share schemes of the Company divided by the weighted average number of Shares in issue for the period was nil.

(g) 投票權

股份獎勵承授人不得就尚未歸屬的獎勵股份及受託人(或其代名人)所管理信託基金的有關其他財產向受託人發出任何指示(包括但不限於投票權)。儘管受託人(或其代名人)根據信託契據或股份獎勵計劃規則為以信託方式持有的股份的合法登記持有人,持有股份獎勵計劃項下未歸屬股份的受託人(或其代名人)(無論直接或間接)不得行使有關股份附有的投票權,並須就上市規則項下須經股東批准的事項放棄投票,除非法律另有規定須根據實益擁有人的指示進行投票且該指示已發出,則另作他論。

(h) 於股份獎勵的權益

任何根據股份獎勵計劃作出的獎勵應為股份獎勵承授人個人所有且不得轉讓或出讓,而股份獎勵承授人不得以任何方式出售、轉讓、質押、按揭、設立產權負擔或以任何其他人士為受益人增設任何權益,惟股份獎勵承授人全資擁有的任何公司或財產授予人為股份獎勵承授人的信託除外。

有關股份獎勵計劃的其他詳情,請參閱本公司日期為2023年4月28日的公告。

本公司設有受限制股份單位計劃、購股權計劃和股份獎勵計劃三個股份獎勵計劃,旨在激勵和獎勵對公司發展做出貢獻的合資格人士。於最後實際可行日期,這三個計劃均未被行使或授出任何獎勵。

截至2026年6月30日止六個月,本公司所有股份計劃項下已授出的購股權及獎勵可予發行的股份數目除以期內已發行股份加權平均數的比例為零。

COMPLIANCE WITH CORPORATE GOVERNANCE CODE

The Board believes that high corporate governance standards are essential in providing a framework for the Group to safeguard the interests of its shareholders and to enhance its corporate value and accountability. The Board and the management of the Company are committed to the maintenance of good corporate governance practices and procedures.

The Company has adopted Part 2 of the CG Code contained in Appendix C1 to the Listing Rules as its own code on corporate governance. To the best knowledge of the Directors, save as the deviation from code provisions C.2.1 of Part 2, the Company has complied with all the principles and the applicable code provisions under Part 2 of the CG Code during the six months ended 30 June 2026 and up to the date of this Report.

Pursuant to Code Provision C.2.1 of Part 2 of the CG Code, the roles of chairman of the Board and chief executive should be separate and should not be performed by the same individual. The division of responsibilities between the chairman and chief executive should be clearly established and set out in writing.

The roles of chairman of the Board and chief executive officer of our Company are currently performed by Mr. Qin. In view of Mr. Qin's substantial contribution to our Group since our establishment and his extensive experience, we consider that having Mr. Qin acting as both our chairman of the Board and chief executive officer will provide strong and consistent leadership to our Group and facilitate the efficient execution of our business strategies. We consider it appropriate and beneficial to our business development and prospects that Mr. Qin continues to act as both our chairman of the Board and chief executive officer after the Listing, and therefore currently do not propose to separate the functions of chairman of the Board and chief executive officer.

遵守企業管治守則

董事會相信，高水準的企業管治對於為本集團提供框架以保障其股東權益及提高其企業價值及問責性而言至關重要。董事會及本公司管理層致力於維持良好的企業管治常規及程序。

本公司已採納上市規則附錄C1所載的企業管治守則第2部作為其自身的企業管治守則。就董事所知，於截至2026年6月30日止六個月及直至本報告日期，除偏離第2部分第C.2.1條守則條文的情況外，本公司一直遵守企業管治守則第2部項下的所有原則及適用守則條文。

根據企業管治守則守則條文第二部分第C.2.1條，董事會主席及首席執行官的職務應予以區分，不應由同一人士擔任。主席及首席執行官的職責劃分應清晰界定並以書面述明。

董事會主席與本公司首席執行官的角色目前由秦先生兼任。由於秦先生自本集團成立以來貢獻良多，且經驗豐富，我們認為由秦先生兼任董事會主席與首席執行官，將使本集團的領導扎實有力及貫徹一致，並促進業務策略落實到位。我們認為，秦先生於上市後繼續兼任董事會主席與首席執行官屬恰當且有利我們的業務發展及前景，故目前無意區分董事會主席與首席執行官的職能。

While this would constitute a deviation from Code Provision C.2.1 of Part 2 of the CG Code, the Board believes that this structure will not impair the balance of power and authority between the Board and the management of our Company, given that: (i) there are sufficient checks and balances in the Board, as a decision to be made by our Board requires approval by at least a majority of our Directors, and our Board comprises of three independent non-executive Directors, which is in compliance with the requirement under the Listing Rules; (ii) Mr. Qin and the other Directors are aware of and undertake to fulfill their fiduciary duties as Directors, which require, among other things, that he acts for the benefit and in the best interests of our Company and will make decisions for our Group accordingly; and (iii) the balance of power and authority is ensured by the operations of the Board which comprises of experienced and high caliber individuals who meet regularly to discuss issues affecting the operations of our Company. Moreover, the overall strategic and other key business, financial, and operational policies of our Group are made collectively after thorough discussion at both Board and senior management levels.

The Board will continue to review the effectiveness of the corporate governance structure of our Group in order to assess whether separation of the roles of chairman of the Board and chief executive is necessary.

儘管此舉偏離企業管治守則的守則條文第2部份第C.2.1條，但董事會認為，此架構將不會損害董事會與本公司管理層之間的權力與權限的平衡，理據為：(i)董事會有足夠制衡，原因為董事會作出的決定須經至少大多數董事批准，且董事會包括三名獨立非執行董事，符合上市規則的規定；(ii)秦先生及其他董事知悉及承諾履行董事的受信責任，有關責任規定(其中包括)其須以符合本公司最佳利益的方式為本公司的利益行事，並據此為本集團作出決策；及(iii)董事會由經驗豐富及才能出眾的人士(定期會面討論影響本公司營運的事宜)組成，確保權力與權限之間的平衡。此外，本集團的整體策略性及其他主要業務、財務及營運政策乃經董事會及高級管理層的詳細討論後共同制定。

董事會將持續檢討本集團的企業管治架構的成效，以評估是否有必要區分董事會主席與首席执行官的角色。

CONTRACTUAL ARRANGEMENTS

We currently conduct our smart learning device service business through Zhuhai Readboy in the PRC. Our digital educational resources production and sales business, comprising the production of short-form animation courseware, offering of pre-recorded video resources held by us through our online platform and mobile apps and making available access to online free educational resources provided by third parties on our smart learning devices, is considered as value-added telecommunications services in the PRC. PRC laws and regulations generally restrict foreign ownership in value-added telecommunications services in the PRC and also impose qualification requirements on the foreign owners. Given that our business falls within the scope of “value-added telecommunications” which requires an ICP License to operate in the PRC, we cannot hold a direct controlling interest in Zhuhai Readboy, which holds the licenses and permits required for its business operations. To comply with the relevant PRC laws and regulations, we maintain effective control over Zhuhai Readboy and its business operations through Contractual Arrangements. For further details of the Contractual Arrangements and the foreign investment restrictions relating to the Contractual Arrangements, please refer to the section headed “Contractual Arrangements” in the Prospectus. For the six months ended 30 June 2026 and up to the Latest Practicable Date, the Board has reviewed the overall performance of the Contractual Arrangements and confirmed that the Group has complied with the Contractual Arrangements in all material respects.

合約安排

我們目前通過珠海讀書郎於中國開展智能學習設備服務業務。我們的數字化教輔資源製作及銷售業務(包括製作短篇動畫課件、通過我們的網絡平台及移動應用程序提供由我們講授的錄播視頻資源及在我們的智能學習設備上提供第三方提供的線上免費教輔資源的訪問權限)於中國被認為是增值電信業務。中國法律法規通常限制外資擁有權參與中國增值電信業務，並對外資擁有人提出資格規定。鑒於我們的業務屬於「增值電信」範疇，於中國的經營須取得ICP許可證，我們無法持有珠海讀書郎的直接控股權，而珠海讀書郎持有其業務運營所需的牌照及許可證。為遵守相關中國法律及法規，我們透過合約安排保持對珠海讀書郎及其業務運營的有效控制。有關更多合約安排及有關合約安排的外商投資限制的詳情，請參閱招股章程「合約安排」一節。截至2026年6月30日止六個月及直至最後實際可行日期，董事會已審閱合約安排的整體表現，並確認本集團已在所有重大方面均遵守合約安排。

The Board confirmed that during the 2026 Interim, save as disclosed in the Prospectus (please refer to the paragraph headed “Contractual Arrangements – PRC laws and regulations relating to foreign ownership restriction” in the Prospectus for details), there is no material change in the Contractual Arrangements and/or the circumstances under which they were adopted.

Since the Listing Date and up to the Latest Practicable Date, there has been no update on the Foreign Investment Law(《中華人民共和國外商投資法》)(the “FIL”) and the relevant foreign investor qualification requirements, and the Company is not aware of any non-compliance of the Contractual Arrangements with the relevant PRC laws, rules and regulations (including but not limited to the FIL) and the Foreign Investment Regulation as stipulated under the paragraphs headed “Development in the PRC Legislation on Foreign Investment” in the Prospectus, and had not encountered interference or encumbrance from any governing bodies in operating our businesses through the PRC Operating Entity under the Contractual Arrangements. There have been no change in our plan and progress in acquiring the relevant experience to meet the qualification requirements; and the Company will continue to monitor the developments of the relevant laws, decision, regulations, rules and administration measures in this regard, and will make further announcements in respect thereof in accordance with the Listing Rules as and when necessary.

During 2026 Interim, there were no business or interest of each Director (including independent non-executive Directors) and his/her associates that competes or may compete with the business of the Group and any other conflicts of interests which any such person have or may have with the Group, which were required to be discussed or reviewed by the Board (including independent non-executive Directors).

董事會確認，於2026年中期，除招股章程（詳情請參閱招股章程「合約安排－有關外資擁有權限制的中國法律法規」一段）所披露者外，所採納的合約安排及／或相關情況概無發生重大變動。

自上市日期起及直至最後實際可行日期，《中華人民共和國外商投資法》（「外商投資法」）及相關外國投資者資格規定並無任何更新，且本公司並不知悉合約安排有任何不遵守相關中國法律、規則及法規（包括但不限於外商投資法）以及外商投資條例（定義見招股章程「中國外商投資立法的發展」各段）的情況，且根據合約安排通過中國經營實體經營業務時亦無面臨任何管理機構的干擾或阻礙。我們招攬具備相關經驗人士以符合資格規定的方案及進展並無變動；本公司將繼續監察相關法律、決策、法規、規則及行政措施於此方面的發展，並於必要時根據上市規則就此作出進一步公告。

於2026年中期，各董事（包括獨立非執行董事）及其聯繫人的業務或權益概無與本集團的業務構成競爭或可能構成競爭，亦無與本集團有或可能有任何其他利益衝突而須經董事會（包括獨立非執行董事）討論或審議。

1. CORPORATE AND GROUP INFORMATION

Readboy Education Holding Company Limited (the “**Company**”) was incorporated in the Cayman Islands on 8 February 2021 as an exempted company with limited liability under the Companies Act of the Cayman Islands. The registered address of the Company is Cricket Square, Hutchins Drive, PO Box, 2681, Grand Cayman, KY1-1111, Cayman Islands.

The Company is an investment holding company. During the period, the Company and its subsidiaries (together, the “**Group**”) were principally engaged in the production and sale of personal student tablets, digital and smart classroom solutions, wearable products, other products and advertisement and content licensing in the People’s Republic of China (the “**PRC**”).

2. BASIS OF PREPARATION

The unaudited interim condensed consolidated financial information for the six months ended 30 June 2026 has been prepared in accordance with HKAS 34 *Interim Financial Reporting*. The unaudited interim condensed consolidated financial information does not include all the information and disclosures required in the annual financial statements, and should be read in conjunction with the Group’s annual consolidated financial statements for the year ended 31 December 2025.

The unaudited interim condensed consolidated financial information has been prepared under the historical cost convention, except for equity investments designated at fair value through other comprehensive income which have been measured at fair value. The interim condensed financial information is presented in Renminbi (“**RMB**”), and all values are rounded to the nearest thousand (RMB’000) except when otherwise indicated.

1. 公司及集團資料

The amendments also include additional disclosures for investments in equity instruments designated at fair value through other comprehensive income and financial instruments with contingent features. Since the Group's accounting policy for the derecognition of financial assets and liabilities in prior years aligned with the amendments and the Group did not have the financial assets that were addressed by the amendments, the amendments did not have any impact on the interim condensed consolidated financial information. The Group will provide additional disclosures for its equity investments designated at fair value through other comprehensive income in the Group's consolidated financial statements for the year ending 31 December 2026.
- (b) Amendments to HKFRs 9 and HKFRS 7 *Contracts Referencing Nature-dependent Electricity* clarify the application of the "own-use" requirements for in-scope contracts and amend the designation requirements for a hedged item in a cash flow hedging relationship for in-scope contracts.
