RESULTS, BUSINESS REVIEW AND PROSPECTS

Results

For the six months ended 30 June 2026, AMCO United Holding Limited (the “Company”) and its subsidiaries (collectively referred to as the “Group”) are principally engaged in (i) manufacture and sale of medical devices products (“Medical Products Business”); (ii) manufacture and sale of plastic moulding products (“Plastic Products Business”); (iii) provision of money lending (“Money Lending Business”); and (iv) investment in securities (“Securities Investment”).

During the period under review, revenue of the Group amounted to HK\$35.1 million, representing an increase of HK\$8.0 million or 29.5% from HK\$27.1 million for the corresponding period last year. Such increase was mainly attributable to the increase in revenue from the Medical Products Business.

Gross profit of the Group was HK\$5.1 million, representing a decrease of HK\$3.3 million or 39.3% as compared to HK\$8.4 million for the corresponding period last year. Gross profit margin decreased to 14.6% (30 June 2025: 30.9%).

Other income and other gains during the period under review recorded gains of HK\$38.8 million as compared to HK\$3.4 million in the corresponding period of 2025. The amount included realised and unrealised fair value gain of held-for-trading investments arising from Securities Investment in the current period.

業績、業務回顧及前景

業績

截至二零二六年六月三十日止六個月，雋泰控股有限公司（「本公司」）及其附屬公司（統稱為「本集團」）之主要業務為(i)製造及銷售醫療設備產品（「醫療產品業務」）；(ii)製造及銷售塑膠模具產品（「塑膠產品業務」）；(iii)提供放貸（「放貸業務」）；及(iv)證券投資（「證券投資」）。

於回顧期間，本集團之收入為35,100,000港元，較去年同期之27,100,000港元增加8,000,000港元或29.5%。該增加乃主要由於來自醫療產品業務之收入增加所致。

本集團毛利為5,100,000港元，較去年同期之8,400,000港元減少3,300,000港元或39.3%。毛利率減少至14.6%（二零二五年六月三十日：30.9%）。

其他收入及其他收益於回顧期間錄得收益38,800,000港元，而二零二五年同期為3,400,000港元。該金額包括本期間證券投資產生之持作買賣投資已變現及未變現公允價值收益。

The distribution costs decreased by HK\$2.5 million to zero representing a decrease of 100% during the period under review (30 June 2025: HK\$2.5 million). The administrative expenses decreased by HK\$0.7 million to HK\$5.7 million (30 June 2025: HK\$6.4 million), representing a decrease of 10.9% over the corresponding period last year.

Finance costs amounted to HK\$1.8 million (30 June 2025: HK\$1.8 million) for the period under review, which represented interest on bond payables.

As a result, the overall profit attributable to owners of the Company was HK\$36.3 million, representing an increase of HK\$35.2 million, as compared to HK\$1.1 million for the corresponding period last year.

Business Review

Medical Products Business

For the six months ended 30 June 2026, the revenue from the Medical Products Business increased by HK\$8.3 million to HK\$30.4 million, as compared to revenue of HK\$22.1 million recorded in the same period last year, which accounted for 86.6% of the Group's total revenue for the period under review. In the first half of 2026, the sales increased primarily attributable to the initial execution of the Group's strategic plan to expand service coverage and diversify its product portfolio within the Medical Products Business.

於回顧期間，分銷成本減少2,500,000港元至零，降幅為100%（二零二五年六月三十日：2,500,000港元）。行政開支減少700,000港元至5,700,000港元（二零二五年六月三十日：6,400,000港元），較去年同期減少10.9%。

於回顧期間，財務費用為1,800,000港元（二零二五年六月三十日：1,800,000港元），該費用指應付債券的利息。

因此，本公司擁有人應佔整體溢利為36,300,000港元，較去年同期的1,100,000港元增加35,200,000港元。

業務回顧

醫療產品業務

截至二零二六年六月三十日止六個月，醫療產品業務之收入為30,400,000港元，較去年同期錄得收入22,100,000港元增加8,300,000港元，佔本集團於回顧期間總收入之86.6%。於二零二六年上半年銷售增長，主要歸因於本集團初步落實於醫療產品業務內擴展服務覆蓋範圍及多元化其產品組合的戰略計劃。

Segment profit of the Medical Products Business amounted to HK\$0.08 million for the six months ended 30 June 2026, as compared to segment profit of HK\$3.3 million in the corresponding period last year. To cope with the challenge of fluctuating sales order, the Group is persisting to deploy business strategies of streamlining and outsourcing of business processes, implementing strict cost control and ensuring effective utilisation of resources with an aim to maintain its long-term sustainable competitive advantages in the business segment. In the meantime, the Group is actively exploring and identifying potential business opportunities to expand its customer base and also the products and services portfolio of the business segment in order to generate and broaden the income streams of the Medical Products Business.

Money Lending Business

For the six months ended 30 June 2026, the Group recorded loan interest income of HK\$4.7 million from its Money Lending Business, representing a decrease of HK\$0.4 million or 7.8% as compared to HK\$5.1 million for the corresponding period last year, which accounted for 13.4% of the Group's total revenue for the period under review. Segment profit of the Money Lending Business amounted to HK\$2.6 million (30 June 2025: loss of HK\$1.3 million). The outstanding principal and interest amount of loan receivables as at 30 June 2026 was HK\$120.3 million (31 December 2025: HK\$127.4 million). The Group will continue to develop this business by employing prudent credit control procedures and strategies to hold a balance between the business growth and the risk management.

截至二零二六年六月三十日止六個月，醫療產品業務分部溢利為80,000港元，而去年同期之分部溢利為3,300,000港元。為應對銷售訂單波動的挑戰，本集團堅持施行精簡及外判業務流程、落實嚴緊成本控制及確保資源有效利用之業務策略，以維持其於該業務分部之長期可持續競爭優勢。同時，本集團正積極開拓及識別潛在業務商機以擴展其業務分部之客戶群以及產品及服務組合，以產生及擴寬醫療產品業務之收入流。

放貸業務

截至二零二六年六月三十日止六個月，本集團錄得放貸業務貸款利息收入4,700,000港元，較去年同期之5,100,000港元減少400,000港元或7.8%，佔本集團回顧期間總收入之13.4%。放貸業務之分部溢利為2,600,000港元（二零二五年六月三十日：虧損1,300,000港元）。於二零二六年六月三十日，應收貸款之未償還本金額及利息為120,300,000港元（二零二五年十二月三十一日：127,400,000港元）。本集團將透過採用審慎信貸控制程序及維持業務增長與風險管理相平衡策略，繼續發展該業務。

Securities Investment

During the period under review, the Group recorded net unrealised and realised gain of HK\$38.8 million (30 June 2025: HK\$3.4 million) arising on change in fair value of held-for-trading investments of listed equity securities in Hong Kong for the six months ended 30 June 2026. No dividend income was received from the held-for-trading investments during the period under review (30 June 2025: nil). Segment profit of the Securities Investment amounted to HK\$38.7 million (30 June 2025: loss of HK\$3.4 million).

As at 30 June 2026, the Group held 31 listed equity securities in Hong Kong with the fair value of HK\$150.2 million. In light of the recent volatile financial market in Hong Kong, the Group intends to diversify its investment portfolio in order to reduce the relevant concentration and investment risks and will closely monitor the performance of this business. The Group will keep adopting a prudent investment attitude and develop its investment strategy with the aim to improve the capital usage efficiency and generate additional investment returns on the idle funds of the Group.

證券投資

於回顧期間，本集團因截至二零二六年六月三十日止六個月香港上市股本證券持作買賣投資之公允價值變動而錄得未變現及已變現收益淨額38,800,000港元（二零二五年六月三十日：3,400,000港元）。於回顧期間，並無自持作買賣投資收到任何股息收入（二零二五年六月三十日：無）。證券投資分部溢利為38,700,000港元（二零二五年六月三十日：虧損3,400,000港元）。

於二零二六年六月三十日，本集團持有之31隻香港上市股本證券之公允價值為150,200,000港元。鑒於近期香港金融市場動盪，本集團擬多元化其投資組合以減低有關集中及投資風險，並將密切監察該業務之表現。本集團將繼續採取審慎投資態度及制定其投資策略，旨在提高資本利用率及利用本集團閒置資金帶來額外投資回報。

(a) CNCGL and its subsidiaries are principally engaged in the provision of design services and advertising via mobile devices, e-commerce for selling products online, film trading and production, and providing other film-related services. As disclosed in the annual report of CNCGL for the year ended 31 March 2026, it recorded net profit attributable to its owners of HK\$12.6 million for the year ended 31 March 2026.

As at 30 June 2026, the Group owned 10,899,000 shares of CNCGL, representing 4.7% equity interests in CNCGL with a carrying amount of the Group's interest in CNCGL of approximately HK\$47.5 million, representing approximately 18.7% of the total assets of the Company as at 30 June 2026. Up to 30 June 2026, no dividends was received from CNCGL. The fair value of CNCGL is based on quoted market prices.

- (b) Asia Strategy is principally engaged in manufacture and sales of umbrellas and the relevant products. As disclosed in the annual report of Asia Strategy for the year ended 31 December 2025, it recorded audited net loss attributable to its owners of HK\$10 million for the year ended 31 December 2025.

As at 30 June 2026, the Group owned 5,960,000 shares of Asia Strategy, representing 1.4% equity interests in Asia Strategy with a carrying amount of the Group's interest in Asia Strategy of approximately HK\$19.1 million, representing approximately 7.5% of the total assets of the Company as at 30 June 2026. Up to 30 June 2026, no dividends was received from Asia Strategy. The fair value of Asia Strategy is based on quoted market prices.

- (c) BFB and its subsidiaries are principally engaged in the provision of advertising agency services in the People's Republic of China ("PRC") and the securities broking business and money lending business in Hong Kong. As disclosed in the annual report of BFB for the year ended 31 December 2025, it recorded net loss attributable to its owners of HK\$21 million for the year ended 31 December 2025.

As at 30 June 2026, the Group owned 16,371,000 shares of BFB, representing 1.3% equity interests in BFB with a carrying amount of the Group's interest in BFB of approximately HK\$16.5 million, representing approximately 6.5% of the total assets of the Company as at 30 June 2026. Up to 30 June 2026, no dividends was received from BFB. The fair value of BFB is based on quoted market prices.

- (d) TKHL principally undertakes site leveling and decoration works in Hong Kong. As disclosed in the annual report of TKHL for the year ended 30 April 2026, it recorded audited net profit attributable to its owners of HK\$24.6 million for the year ended 30 April 2026.

As at 30 June 2026, the Group owned 7,976,000 shares of TKHL, representing 1.5% equity interests in TKHL with a carrying amount of the Group's interest in TKHL of approximately HK\$14.2 million, representing approximately 5.6% of the total assets of the Company as at 30 June 2026. Up to 30 June 2026, no dividends was received from TKHL. The fair value of TKHL is based on quoted market prices.

- (b) 亞洲策略主要從事製造及銷售雨傘及相關產品。誠如亞洲策略截至二零二五年十二月三十一日止年度的年報所披露，其於截至二零二五年十二月三十一日止年度錄得經審核擁有人應佔虧損淨額10,000,000港元。

於二零二六年六月三十日，本集團擁有5,960,000股亞洲策略股份，佔亞洲策略1.4%股權，本集團於亞洲策略權益的賬面值約為19,100,000港元，佔本公司於二零二六年六月三十日資產總值約7.5%。直至二零二六年六月三十日，並無自亞洲策略收取任何股息。亞洲策略的公允價值根據市場報價計算。

於二零二六年六月三十日，本集團擁有16,371,000股BFB股份，佔BFB 1.3%股權，本集團於BFB權益的賬面值約為16,500,000港元，佔本公司於二零二六年六月三十日資產總值約6.5%。直至二零二六年六月三十日，並無自BFB收取任何股息。BFB的公允價值根據市場報價計算。

- (d) 泰錦控股主要在香港從事地盤平整及裝修工程。誠如泰錦控股截至二零二六年四月三十日止年度的年報所披露，其於截至二零二六年四月三十日止年度錄得經審核擁有人應佔溢利淨額24,600,000港元。

於二零二六年六月三十日，本集團擁有7,976,000股泰錦控股股份，佔泰錦控股1.5%股權，本集團於泰錦控股權益的賬面值約為14,200,000港元，佔本公司於二零二六年六月三十日資產總值約5.6%。直至二零二六年六月三十日，並無自泰錦控股收取任何股息。泰錦控股的公允價值根據市場報價計算。

- (e) The Group's investment strategy is to deliver a diversified and flexible investment portfolio that will maximize sustained long-term returns and strive to achieve high growth, while the traditional business of the Group will continue its stable growth. None of these investments represented more than 5% of the total assets of the Group as at 30 June 2026.

Looking ahead, the Directors believe that the future performance of the above investments held by the Group will be volatile and substantially affected by overall economic environment, equity market conditions, investor sentiment and the business performance and development of the investee companies. Accordingly, the Group will continue to maintain a diversified portfolio of investment of various industries to minimise the possible financial risks. Also, the Directors will cautiously assess the performance progress of the investment portfolio from time to time.

Prospects

Amid the complex global landscape of 2026 – shaped by ongoing economic recalibration and persistent financial market volatility – the Group remains steadfast in its commitment to capitalise on emerging tailwinds. Notably, the Medical Devices Business stands to benefit from a confluence of positive catalysts. Heightened global awareness of personal health and well-being continues to drive consumer and institutional focus toward advanced medical solutions. Concurrently, while we express our profound regret over the recent geopolitical tensions and conflicts that have brought suffering to affected communities, these events have also underscored the critical importance of robust, well-equipped healthcare infrastructure worldwide. This, in turn, has accelerated demand for essential medical technologies, including surgical instruments, diagnostic tools, and sterilization products. While we lament the circumstances that give rise to such needs, this favourable environment is expected to contribute meaningfully to the segment's upward trajectory. To harness this momentum responsibly, the Group will adopt a forwardlooking posture, proactively fine-tuning its business strategies to unlock growth, while reinforcing operational resilience to navigate broader macroeconomic fluctuations.

- (e) 本集團的投資戰略為構建一個多元化及靈活的投資組合，最大化可持續長期回報並努力實現高增長，同時本集團傳統業務將繼續穩定增長。於二零二六年六月三十日，該等投資概無佔本集團資產總值之5%以上。

展望未來，董事認為本集團所持之上述投資未來表現將會波動並受整體經濟環境、股市狀況、投資者情緒以及被投資公司之業務表現及發展的重大影響。因此，本集團將繼續維持一個涉及多個行業投資之多元化組合，以將潛在金融風險減至最低。此外，董事將不時審慎評估投資組合之表現進度。

前景

二零二六年全球環境錯綜複雜，經濟持續調整、金融市場波動持續，本集團仍堅定致力於把握新出現的有利發展機遇。其中，醫療器械業務將迎來多重積極驅動因素。全球公眾健康意識持續提升，推動消費者及機構聚焦於高端醫療解決方案。與此同時，雖然我們對近期地緣政治緊張局勢及衝突對受影響地區帶來的困境深表遺憾，但相關事件亦進一步突顯了全球醫療體系完善、醫療物資保障充足的重要性，從而帶動手術器械、診斷設備及消毒滅菌產品等關鍵醫療技術需求加速釋放。儘管催生相關需求的外部環境令人惋惜，但該積極態勢預期將為該分部業務增長提供有力支撐。為穩健把握發展契機，本集團將秉持前瞻佈局、主動優化業務策略以釋放增長潛力，同時強化經營韌性，應對宏觀經濟波動。

In parallel, the Group is committed to the continuous optimisation of its diversified portfolio. Resources – including capital, assets, and manpower – will be dynamically reallocated to segments demonstrating the strongest potential and strategic alignment, with a particular focus on nurturing high-value opportunities within the Medical Devices sector. This is complemented by a rigorous, ongoing assessment of business performance to ensure agility in decision-making. Financial discipline remains a cornerstone of our approach; through vigilant working capital management and stringent cost control, the Group will preserve robust liquidity. By maintaining a lean operational structure and cultivating a culture of efficiency, we are well-positioned to adapt to evolving market conditions. Ultimately, our strategy is driven by the pursuit of sustainable prosperity, as we continue to explore and exploit promising investment avenues to enhance long-term shareholder value and secure enduring growth.

FINANCIAL REVIEW

Capital structure

As of 30 June 2026, the Group's consolidated net asset was approximately HK\$155.6 million, representing an increase of approximately HK\$36.4 million as compared to that of HK\$119.2 million as at 31 December 2025.

As at 30 June 2026, the Company has 967,551,792 (31 December 2025: 967,551,792) ordinary shares of HK\$0.05 each in issue.

Except for the changes mentioned elsewhere in the interim report, there has been no change in the capital structure of the Company since then.

與此同時，本集團致力持續優化其多元化業務組合，將資金、資產及人力等資源動態傾斜配置至發展潛力突出、與集團戰略高度契合的業務板塊，重點培育醫療器械領域的高價值增長機會。本集團亦將持續對業務表現進行嚴謹評估，確保決策高效靈活。財務穩健始終是集團經營的核心原則：通過審慎的營運資金管理及嚴格的成本控制，本集團將維持穩健的流動資金。憑藉精簡高效的營運架構及精益管理文化，我們具備充分能力適應市場變化。以可持續發展為策略導向，我們將持續發掘並把握優質投資機會，致力提升股東長期價值，實現穩健持久的增長。

財務回顧

資本架構

截至二零二六年六月三十日，本集團之綜合資產淨值為約155,600,000港元，較於二零二五年十二月三十一日之119,200,000港元增加約36,400,000港元。

於二零二六年六月三十日，本公司有967,551,792股（二零二五年十二月三十一日：967,551,792股）每股面值0.05港元之已發行普通股。

除中期報告其他部分所提述的變動外，本公司的資本架構自此概無發生任何變動。

Debt structure

The Group's total borrowings from financial institutions were zero as at 30 June 2026 and 31 December 2025. The Group's total cash and bank balances amounted to approximately HK\$10.6 million as at 30 June 2026, which increased HK\$3.4 million as compared to that of HK\$7.2 million as at 31 December 2025.

As at 30 June 2026, the Company had bond payables of HK\$24.9 million (31 December 2025: HK\$24.9 million) which represented unlisted bonds issued to independent third parties with an aggregate principal amount of HK\$4.9 million, which will mature in July 2026 and HK\$20 million, which will mature in March 2030.

The Group's gearing ratio was 9.2% as at 30 June 2026 (31 December 2025: 14.8%). The ratio was determined by net debt, which was defined as total interest-bearing liabilities comprising bond payables, financial liabilities at FVTPL and lease liabilities less cash and cash equivalents, over shareholders' equity.

Working capital and liquidity

As at 30 June 2026, the Group's current ratio were 3.3 (31 December 2025: 2.6).

Contingent liabilities and charges

The Group had not pledged any assets to secure bank facilities and other borrowings as at 30 June 2026 and 31 December 2025. The Group had no material contingent liability as at 30 June 2026 and 31 December 2025.

債務架構

於二零二六年六月三十日及二零二五年十二月三十一日，本集團來自金融機構之總借貸為零。於二零二六年六月三十日，本集團之現金及銀行結餘總額為約10,600,000港元，較於二零二五年十二月三十一日之7,200,000港元增加3,400,000港元。

於二零二六年六月三十日，本公司的應付債券為24,900,000港元（二零二五年十二月三十一日：24,900,000港元），即向獨立第三方發行的本金總額為4,900,000港元（將於二零二六年七月到期）及20,000,000港元（將於二零三零年三月到期）之非上市債券。

本集團於二零二六年六月三十日之資產負債比率為9.2%（二零二五年十二月三十一日：14.8%）。該比率乃由淨債務除以股東權益釐定，淨債務定義為計息負債（包括應付債券、透過損益按公允價值列賬之財務負債及租賃負債）總額減現金及現金等價物。

營運資金及流動資金

1. GENERAL INFORMATION

AMCO United Holding Limited (the “Company”) was incorporated in Bermuda with limited liability on 19 August 1994 as an exempted company under the Companies Act 1981 of Bermuda with its shares listed on the Main Board of The Stock Exchange of Hong Kong Limited (the “Stock Exchange”) since 28 November 1996.

The Company and its subsidiaries (hereinafter collectively referred to as the “Group”) are principally engaged in (i) manufacture and sale of medical devices products; (ii) manufacture and sale of plastic moulding products; (iii) provision of money lending; and (iv) investment in securities.

2. BASIS OF PREPARATION AND ACCOUNTING POLICIES

The interim condensed consolidated financial statements for the six months ended 30 June 2026 have been prepared in accordance with the applicable disclosure requirements of Appendix 16 to the Rules Governing the Listing of Securities on the Stock Exchange and with the Hong Kong Accounting Standard 34 “Interim Financial Reporting”, issued by the Hong Kong Institute of Certified Public Accountants (“HKICPA”). The interim condensed consolidated financial statements are unaudited but have been reviewed by the Company’s audit committee.

The interim condensed consolidated financial statements should be read in conjunction with the Group’s annual financial statements for the year ended 31 December 2025, which have been prepared in accordance with Hong Kong Financial Reporting Standards (“HKFRSs”).

1. 一般資料

雋泰控股有限公司（「本公司」）於一九九四年八月十九日根據百慕達一九八一年公司法在百慕達註冊成立為一間獲豁免有限公司，其股份自一九九六年十一月二十八日起於香港聯合交易所有限公司（「聯交所」）主板上市。

本公司及其附屬公司（以下統稱為「本集團」）主要從事(i)製造及銷售醫療設備產品；(ii)製造及銷售塑膠模具產品；(iii)提供放貸；及(iv)證券投資。

2. 編製基準及會計政策

截至二零二六年六月三十日止六個月之簡明綜合中期財務報表乃按照聯交所證券上市規則附錄十六之適用披露規定，以及香港會計師公會（「香港會計師公會」）頒佈之香港會計準則第34號「中期財務報告」編製。簡明綜合中期財務報表為未經審核，惟已由本公司之審核委員會審閱。
