FINANCIAL SUMMARY

財務概要

FINANCIAL HIGHLIGHTS FOR THE SIX MONTHS ENDED 30 JUNE 2026:

For the six months ended 30 June 2026, revenue of the Group amounted to RMB82.8 million, representing an increase of 2.6% as compared with the six months ended 30 June 2025.

For the six months ended 30 June 2026, gross profit of the Group amounted to RMB17.9 million and gross profit margin of the Group was 21.6%, representing an increase of 10.5% and an increase of 1.5 percentage points as compared with the six months ended 30 June 2025, respectively.

For the six months ended 30 June 2026, the Group recorded net loss amounted to RMB14.5 million, and net loss margin of the Group was 17.5%, compared with net loss of RMB9.9 million and net loss margin of 12.3% for the six months ended 30 June 2025.

For the six months ended 30 June 2026, loss attributable to owners of the Company was RMB12.3 million, compared with loss attributable to owners of the Company amounted to RMB7.3 million for the six months ended 30 June 2025.

For the six months ended 30 June 2026, basic and diluted loss per share attributable to owners of the Company was RMB0.920 cents, compared with basic and diluted loss per share attributable to owners of the Company amounted to RMB0.551 cents for the six months ended 30 June 2025.

截至2026年6月30日止六個月的財務摘要：

截至2026年6月30日止六個月，本集團的收入為人民幣82.8百萬元，較截至2025年6月30日止六個月增加2.6%。

截至2026年6月30日止六個月，本集團的毛利為人民幣17.9百萬元，而本集團的毛利率則為21.6%，分別較截至2025年6月30日止六個月增加10.5%及增加1.5個百分點。

與截至2025年6月30日止六個月的淨虧損人民幣9.9百萬元及淨虧損率12.3%相比，本集團截至2026年6月30日止六個月錄得淨虧損人民幣14.5百萬元及淨虧損率17.5%。

與截至2025年6月30日止六個月本公司擁有人應佔虧損人民幣7.3百萬元相比，截至2026年6月30日止六個月本公司擁有人應佔虧損為人民幣12.3百萬元。

與截至2025年6月30日止六個月本公司擁有人應佔每股基本及攤薄虧損為人民幣0.551分相比，截至2026年6月30日止六個月本公司擁有人應佔每股基本及攤薄虧損為人民幣0.920分。

I. BUSINESS REVIEW

The Group is a leading comprehensive hazardous waste incineration turnkey solution provider in the PRC focused on the research, design, integration and commissioning of solid waste treatment systems, particularly for hazardous waste incineration. Leveraging its experience and expertise in hazardous waste incineration, the Group has expanded its offerings to other areas of solid waste treatment, such as cement plant parallel kiln co-treatment and pyrolysis treatment of solid waste. The Group conducts research and development of technologies related to these new areas and have successfully applied some of them to its new solid waste treatment projects.

The Group is also engaged in the business of provision of oilfield auxiliary services and oil sludge thermal desorption treatment in Xinjiang Uygur Autonomous Region. With years of local market development and project experience accumulation, the oilfield auxiliary services business has been growing steadily year by year.

In the first half of 2026, the Group's primary sources of revenue were the design, integration and commissioning of hazardous waste incineration treatment systems and oilfield auxiliary services in the PRC.

Provision of Hazardous Waste Incineration Solutions

Before 2026, the Group had completed 55 hazardous waste incineration projects with aggregate designed disposal capacity of 1,303,500 tonnes per annum which were passed to the Group's customers in normal operation. In the first half of 2026, the Group completed a hazardous waste incineration project with an aggregate designed disposal capacity of approximately 30,000 tonnes per annum. As at 30 June 2026, the Group had 3 ongoing hazardous waste incineration projects, covering 2 cities in the PRC with an aggregate designed disposal capacity of approximately 60,000 tonnes per annum. The table below sets out the summary of the completed hazardous waste incineration projects in the first half of 2026 and the ongoing hazardous waste incineration projects as at 30 June 2026:

I. 業務回顧

本集團是中國領先的綜合危險廢物焚燒處置整體解決方案提供商，專注於固體廢物處理系統（尤其是危險廢物焚燒處置系統）的研究、設計、集成及調試。憑藉本集團在危險廢物焚燒處置方面的經驗及專業知識，本集團已將業務擴展至固體廢物處理的其他領域，如水泥回轉窯平行協同處置、固體廢物的無氧裂解處理等。本集團開展與該等新領域相關的技術研發，並已成功地將部分研發成果應用於新的固體廢物處理項目。

本集團亦於新疆維吾爾自治區內從事油田周邊服務業務及油泥熱脫附處置。憑藉多年的當地市場開拓與項目經驗積累，油田周邊服務業務逐年穩步增長。

於2026年上半年，本集團的主要收入來源是在中國提供危險廢物焚燒處置系統的設計、集成及調試和油田周邊服務。

提供危險廢物焚燒處置解決方案

於2026年前，本集團完成了55個危險廢物焚燒處置項目並已於正常運營下轉交予本集團的客戶，累計設計處置能力為1,303,500噸／年。於2026年6月30日，本集團完成了1個危險廢物焚燒處置項目，累計設計處置能力約為30,000噸／年。於2026年6月30日，本集團有3個危險廢物焚燒處置項目尚未完工，遍佈中國2個城市，累計設計處置能力約為60,000噸／年。下表載列於2026年6月30日竣工危險廢物焚燒處置項目及於2026年6月30日尚未完工危險廢物焚燒處置項目的概要：

Provision of Oilfield Auxiliary Services and Oil Sludge Thermal Desorption Treatment

The oilfield auxiliary services primarily refer to the provision of transportation, technical support, pipeline installation, oil well cleaning management, instrument and meter maintenance and appraisal services to the Karamay Oilfield and its supporting industries in Xinjiang Uygur Autonomous Region, etc. The Group's revenue from the provision of oilfield auxiliary services amounted to RMB52.0 million during the Reporting Period (for the six months ended 30 June 2025: RMB48.4 million).

In addition, the Group constructed and operated an oil sludge thermal desorption treatment project near the Karamay Oilfield, which mainly focused on the harmless treatment and resource utilization of oily sludge waste. The overall design treatment capacity of the project was 200,000 tons per year. In July 2023, the project officially obtained a hazardous waste operation permit issued by the local authorities. At the beginning of 2024, the project successfully won the bidding and entered into an oily sludge treatment contract with a related subsidiary of PetroChina (中國石油) through public tendering. The project was officially put into trial operation in late March 2024. The project generated revenue of RMB9.0 million from waste disposal during the Reporting Period.

Cement Plant Parallel Kiln Co-Treatment

The Group built and operated a cement plant parallel kiln co-treatment project ("Yunfu Project") in Yunfu City, Guangdong Province through signing cooperation agreements with relevant partners. The project mainly focused on harmless treatment of solid waste, with an overall designed disposal capacity of 83,600 tons per year. The project obtained the hazardous waste operation permit issued by the local government agency in August 2022 and was officially put into trial operation in September 2022.

The Group, through its non-wholly-owned subsidiary, Maoming Jingsheng Environmental Protection Technology Limited (茂名景勝環保科技有限公司), is also constructing and operating another cement plant parallel co-treatment project in Maoming City, Guangdong Province with a total designed disposal capacity of 88,900 tons per year. The project was granted by the local official agency with a 5-year hazardous waste operation permit to operate from December 2024 and was officially put into trial operation in 2024.

提供油田周邊服務及油泥熱脫附處置

油田周邊服務業務主要指本集團為新疆維吾爾自治區的克拉瑪依油田及配套產業提供運輸、技術、管道安裝、油井清潔管理、儀器儀表維修鑒定等服務。本集團報告期內提供油田周邊服務所產生的收入為人民幣52.0百萬元（截至2025年6月30日止六個月：人民幣48.4百萬元）。

同位於克拉瑪依油田附近，本集團亦建設並運營一個油泥熱脫附處置項目，項目主要針對含油污泥廢物進行無害化處理和資源化利用，總體設計處置能力為20萬噸／年。該項目於2023年7月正式取得當地政府機構頒發的危險廢物經營許可證，並於2024年年初通過公開招投標並成功中標的方式與中國石油的相關附屬公司簽署含油污泥處置合同，項目於2024年3月下旬已正式投產試運營。該項目於報告期內提供廢物處置所產生的收入為人民幣9.0百萬元。

水泥回轉窯平行協同處置

本集團通過與相關合作方通過簽署合作協議的方式，於廣東省雲浮市建設並運營一個水泥回轉窯平行協同處置項目（「雲浮項目」），項目主要針對固體廢棄物進行無害化處理，總體設計處置能力為8.36萬噸／年。該項目已於2022年8月取得當地政府機構頒發的危險廢物經營許可證，並於2022年9月正式投產試運營。

本集團亦通過非全資附屬公司茂名景勝環保科技有限公司於廣東省茂名市建設並運營另一個水泥回轉窯平行協同處置項目，總體設計處置能力為8.89萬噸／年。該項目於2024年12月取得當地政府機構頒發的五年期危險廢物經營許可證，並已於2024年正式投產試運營。

The above two cement plant parallel kiln co-treatment projects generated revenue of RMB11.7 million (for the six months ended 30 June 2025: RMB18.2 million) from waste disposal during the Reporting Period.

Pyrolysis Solid Waste Treatment

In 2024, the Group utilized its own industrial land located in Heshan City, Guangdong Province to construct and operate a project that converts low value waste plastics into fuel oil using pyrolysis technology and processes solid waste into alternative fuels. The overall designed disposal capacity was 220,000 tons per year. Construction of the project officially commenced in February 2024, employing a phased construction approach and incorporating technical upgrades to the production lines, the initial plan is for the first production line to commence trial operation in the third quarter of 2026.

II. FINANCIAL POSITION AND OPERATING RESULTS

Revenue

Revenue increased by 2.6% from RMB80.7 million for the six months ended 30 June 2025 to RMB82.8 million for the six months ended 30 June 2026. Such increase was mainly attributable to the increase in revenue from oilfield auxiliary services.

The Group generally derived the majority of its revenue from provision of hazardous waste incineration solutions and oilfield auxiliary services, and the remainder from provision of cement plant parallel kiln co-treatment services, and other services including oil sludge thermal desorption treatment services, technical upgrading, maintenance services and pyrolysis solid waste treatment solutions.

Revenue from hazardous waste incineration solutions decreased by 46.4% from RMB11.0 million for the six months ended 30 June 2025 to RMB5.9 million for the six months ended 30 June 2026. Such decrease was mainly attributable to the gradual saturation of the market, the decrease in demand, and fierce competition.

上述兩個水泥回轉窯平行協同處置於報告期內提供廢物處置所產生的收入為人民幣11.7百萬元（截至2025年6月30日止六個月：人民幣18.2百萬元）。

固體廢物的無氧裂解處理

於2024年，本集團利用自有的位於廣東省鶴山市的工業用地，建設並運營一個利用無氧裂解技術將低值廢塑料製成燃料油以及將固廢處理製成替代燃料的項目，總體設計處置能力為22萬噸／年。該項目已於2024年2月正式開工建設，採用分期建設的方式，生產線由於技術改造，計劃第一條生產線將於2026年三季度投產試運營。

II. 財務狀況及經營業績

收入

收入由截至2025年6月30日止六個月的人民幣80.7百萬元增加2.6%至截至2026年6月30日止六個月的人民幣82.8百萬元。該增加主要由於油田周邊服務業務收入的增加。

一般而言，本集團的大部分收入來自提供危險廢物焚燒處置解決方案和油田周邊服務，剩餘收入來自提供水泥回轉窯平行協同處置服務及其他服務（包括油泥熱脫附服務，技術升級、維護服務及固體廢物的無氧裂解處理解決方案）。

危險廢物焚燒處置解決方案的收入從截至2025年6月30日止六個月的人民幣11.0百萬元減少46.4%至截至2026年6月30日止六個月的人民幣5.9百萬元。該減少主要由於市場漸趨飽和，需求下降，同時競爭激烈所致。

Revenue from oilfield auxiliary services increased by 7.4% from RMB48.4 million for the six months ended 30 June 2025 to RMB52.0 million for the six months ended 30 June 2026. The increase was attributed to the increase in demand for oil market services.

Revenue from cement plant parallel kiln co-treatment services decreased by 35.7% from RMB18.2 million for the six months ended 30 June 2025 to RMB11.7 million for the six months ended 30 June 2026, which was mainly due to the reduced operating time of Yunfu and Maoming project.

Revenue from oil sludge thermal desorption treatment services increased by 2,150% from RMB0.4 million for the six months ended 30 June 2025 to RMB9.0 million for the six months ended 30 June 2026, which was mainly due to the operations of Karamay Project in Xinjiang.

Revenue from maintenance services increased by 50.0% from RMB2.8 million for the six months ended 30 June 2025 to RMB4.2 million for the six months ended 30 June 2026. Such increase was attributable to more technical upgrading and maintenance services demand from customers for the six months ended 30 June 2026.

Cost of Services

Cost of services increased by 0.6% from RMB64.5 million for the six months ended 30 June 2025 to RMB64.9 million for the six months ended 30 June 2026. Such increase was mainly attributable to the increase in revenue from provision of oil sludge thermal desorption treatments services.

Cost of services for the Group's hazardous waste incineration treatment business consists primarily of (i) cost of equipment and materials; (ii) direct labour costs; (iii) sub-contracting costs; and (iv) others.

來自油田周邊服務的收入由截至2025年6月30日止六個月的人民幣48.4百萬元增加7.4%至截至2026年6月30日止六個月的人民幣52.0百萬元。該增加歸因於石油市場服務需求增加。

來自水泥回轉窯平行協同處置服務的收入由截至2025年6月30日止六個月的人民幣18.2百萬元減少35.7%至截至2026年6月30日止六個月的人民幣11.7百萬元，主要源於雲浮和茂名項目的運營時間減少。

來自油泥熱脫附處置服務的收入由截至2025年6月30日止六個月的人民幣0.4百萬元增加2,150%至截至2026年6月30日止六個月的人民幣9.0百萬元，主要源於新疆克拉瑪依項目的運營。

來自維護服務的收入由截至2025年6月30日止六個月的人民幣2.8百萬元增加50.0%至截至2026年6月30日止六個月的人民幣4.2百萬元。該增加主要歸因於截至2026年6月30日止六個月內客戶的技術升級及技術維護服務需求增加。

服務成本

服務成本由截至2025年6月30日止六個月的人民幣64.5百萬元增加0.6%至截至2026年6月30日止六個月的人民幣64.9百萬元。該增加主要由於油泥熱脫附處置服務收入的增加。

本集團危險廢物焚燒處置業務的服務成本主要包括：(i)設備及材料成本；(ii)直接人工成本；(iii)分包成本；及(iv)其他。

The cost of services for the Group's hazardous waste incineration treatment business increased by 26.5% from RMB3.4 million for the six months ended 30 June 2025 to RMB4.3 million for six months ended 30 June 2026. Such increase was mainly attributable to the increase in procurement costs of the relevant projects.

The Group's cost of oilfield auxiliary services decreased by 6.7% from RMB41.8 million for the six months ended 30 June 2025 to RMB39.0 million for the six months ended 30 June 2026. Such decrease was mainly attributable to better cost control of the services.

The Group's cost of cement plant parallel kiln co-treatment solution services decreased by 27.1% from RMB14.4 million for the six months ended 30 June 2025 to RMB10.5 million for the six months ended 30 June 2026. Such decrease was mainly attributable to the decrease in revenue from the relevant segment.

The Group's cost of oil sludge thermal desorption treatments services increased by 212.5% from RMB2.4 million for the six months ended 30 June 2025 to RMB7.5 million for the six months ended 30 June 2026. Such increase was mainly attributable to the increase in revenue from the relevant segment.

Cost of services for maintenance services increased by 44.0% from RMB2.5 million for the six months ended 30 June 2025 to RMB3.6 million for the six months ended 30 June 2026. Such increase was attributable to the increase in revenue from other services.

Gross Profit and Gross Profit Margin

The Group's gross profit increased by 10.5% from RMB16.2 million for the six months ended 30 June 2025 to RMB17.9 million for the six months ended 30 June 2026, while the gross profit margin increased from 20.1% for the six months ended 30 June 2025 to 21.6% for the six months ended 30 June 2026.

本集團危險廢物焚燒處置業務的服務成本從截至2025年6月30日止六個月的人民幣3.4百萬元增加26.5%至截至2026年6月30日止六個月的人民幣4.3百萬元。該增加主要由於相關項目採購成本增加。

本集團來自油田周邊服務的服務成本從截至2025年6月30日止六個月的人民幣41.8百萬元減少6.7%至截至2026年6月30日止六個月的人民幣39.0百萬元。該減少主要由於該服務更好的進行成本控制。

本集團來自水泥回轉窯平行協同處置服務的服務成本從截至2025年6月30日止六個月的人民幣14.4百萬元減少27.1%至截至2026年6月30日止六個月的人民幣10.5百萬元。該減少主要由於該業務收入的減少。

本集團來自油泥熱脫附處置服務成本從截至2025年6月30日止六個月的人民幣2.4百萬元增加212.5%至截至2026年6月30日止六個月的人民幣7.5百萬元。該增加主要由於該業務收入的增加。

來自維護服務的服務成本從截至2025年6月30日止六個月的人民幣2.5百萬元增加44.0%至截至2026年6月30日止六個月的人民幣3.6百萬元。該增加歸因於其他服務收入的增加。

毛利及毛利率

The gross profit of hazardous waste incineration solutions decreased by 78.9% from RMB7.6 million for the six months ended 30 June 2025 to RMB1.6 million for the six months ended 30 June 2026. Such decrease was mainly attributable to the decrease by 46.4% in revenue and increase in procurement costs.

危險廢物焚燒處置解決方案的毛利由截至2025年6月30日止六個月的人民幣7.6百萬元減少78.9%至截至2026年6月30日止六個月的人民幣1.6百萬元。該減少主要歸因於收入減少46.4%和採購成本的增加。

The gross profit of oilfield auxiliary services increased by 100% from RMB6.5 million for the six months ended 30 June 2025 to RMB13.0 million for the six months ended 30 June 2026. Such increase was mainly attributable to the increase by 7.4% in revenue.

油田周邊服務的毛利由截至2025年6月30日止六個月的人民幣6.5百萬元增加100%至截至2026年6月30日止六個月的人民幣13.0百萬元。該增加主要歸因於收入的增加7.4%。

The gross profit of cement plant parallel kiln co-treatment solution services decreased by 68.4% from RMB3.8 million for the six months ended 30 June 2025 to RMB1.2 million for the six months ended 30 June 2026. Such decrease was mainly attributable to the decrease by 35.7% in revenue.

水泥回轉窯平行協同處置服務的毛利由截至2025年6月30日止六個月的人民幣3.8百萬元減少68.4%至截至2026年6月30日止六個月的人民幣1.2百萬元。該減少主要歸因於收入的減少35.7%。

The gross profit of oil sludge thermal desorption treatment services increased by 175% from gross loss of RMB2.0 million for the six months ended 30 June 2025 to a gross profit of RMB1.5 million for the six months ended 30 June 2026. Such increase was mainly attributable to the increase by 2,150% in revenue.

The gross profit of maintenance services increased by 100% from RMB0.3 million for the six months ended 30 June 2025 to RMB0.6 million for the six months ended 30 June 2026. Such increase was mainly attributable to the increase by 50% in revenue.

Other Income, Gains and Losses

For the six months ended 30 June 2026, the Group recognized other income, gains and losses amounted to RMB0.7 million, a decrease from the net other income of RMB2.3 million for the six months ended 30 June 2025. Such decrease was attributable to the absence of the waivers of trade payable during the current period, a loss on write-off of intangible assets of RMB0.4 million, and a decrease in sundry income of RMB0.5 million.

Administrative Expenses

The Group's administrative expenses decreased by 8.7% from RMB25.2 million for the six months ended 30 June 2025 to RMB23.0 million for the six months ended 30 June 2026, which was relatively steady.

Research and Development Costs

Research and development costs mainly include staff costs, material and other related costs in connection with the research and development of solid waste treatment applications.

The Group's research and development costs increased by 29.2% from RMB4.8 million for the six months ended 30 June 2025 to RMB6.2 million for the six months ended 30 June 2026 due to the fact that the Group has incurred more R&D costs of pyrolysis solid waste treatment during the Reporting Period.

Impairment Losses Reversed on Financial Assets and Contract Assets

The Group's impairment losses reversed based on financial assets and contract assets decreased from RMB8.3 million for the six months ended 30 June 2025 to RMB3.2 million reversal for the six months ended 30 June 2026. The decrease in reversal of impairment losses was primarily attributable to the fact that Guangzhou Weigang Environmental Protection Technology Co., Ltd., a subsidiary of the Group, realised more substantial cash collections on its accounts receivable in the corresponding period of 2025 as compared to the first half of 2026, which resulted in a higher reversal of impairment losses being recognised in the corresponding period of 2025.

其他收入、收益及虧損

截至2026年6月30日止六個月，本集團確認其他收入、收益及虧損人民幣0.7百萬元，較截至2025年6月30日止六個月確認其他收入淨額人民幣2.3百萬元有所減少，減少歸因於本期無貿易應付款項豁免，及無形資產撇銷虧損人民幣0.4百萬元，及雜項收入減少人民幣0.5百萬元。

行政開支

本集團之行政開支從截至2025年6月30日止六個月的人民幣25.2百萬元減少8.7%至截至2026年6月30日止六個月的人民幣23.0百萬元，相對穩定。

研發成本

研發成本主要包括與固體廢物處理應用研發有關的人工成本、材料及其他相關成本。

本集團的研發成本從截至2025年6月30日止六個月的人民幣4.8百萬元增加29.2%至截至2026年6月30日止六個月的人民幣6.2百萬元，歸因於本集團於報告期內在固體廢物的無氧裂解處置的研發費用增加。

金融資產及合約資產的減值虧損撥回

本集團之金融資產及合約資產的減值虧損撥回從截至2025年6月30日止六個月的人民幣8.3百萬元減少至截至2026年6月30日止六個月的人民幣3.2百萬元撥回。減少主要歸因於本集團子公司廣州維港環保科技有限公司的應收賬款與2026年前六個月對比，2025年同期錄得較大金額的應收款項款回款，因此於2025年同期確認較大金額的預期信用減值撥回。

Finance Costs

The Group's finance costs was relatively steady.

Income Tax Expense

Income tax expense consists of current tax and deferred tax for PRC enterprise income tax. The Company primarily operated through its PRC subsidiaries which generally paid the PRC enterprise income tax at a statutory rate of 25% on its estimated assessable profits for the six months ended 30 June 2026 (for the six months ended 30 June 2025: 25%).

Additionally, according to the relevant tax rules and regulations and preferential tax policies in the PRC, the Group's subsidiaries, Guangzhou Weigang Environmental Protection Technology Limited and Karamay Shuangxin Co., Ltd., were entitled to a preferential PRC income tax rate of 15%.

Loss for the Period

For the six months ended 30 June 2026, the Group recorded net loss amounted to RMB14.5 million, and the net loss margin of the Group was 17.5%, compared with the net loss amounted to RMB9.9 million and the net loss margin of 12.3% for the six months ended 30 June 2025. Such increase in loss was mainly due to the increase in R&D costs and the decrease in the reversal of impairment losses.

Trade and Note Receivables

The decrease in trade and note receivables from RMB213.5 million as at 31 December 2025 to RMB177.4 million as at 30 June 2026, was primarily due to the Group continued to increase its efforts to collect trade and note receivables in first half of year.

Trade Payables

The decrease in trade payables from RMB125.6 million as at 31 December 2025 to RMB83.8 million as at 30 June 2026 was primarily due to the fewer number of ongoing projects.

融資成本

本集團的融資成本保持相對穩定。

所得稅開支

所得稅開支包括中國企業所得稅的即期稅項及遞延稅項。本公司主要透過中國附屬公司運營業務，該等附屬公司於截至2026年6月30日止六個月就估計應課稅利潤通常按25%（截至2025年6月30日止六個月：25%）的法定稅率繳納中國企業所得稅。

另外，根據中國相關稅務法規及稅收優惠政策，本集團附屬公司廣州維港環保科技有限公司和克拉瑪依雙信有限責任公司於報告期內享受15%的中國所得稅稅率優惠。

期內虧損

與截至2025年6月30日止六個月的淨虧損人民幣9.9百萬元及淨虧損率12.3%相比，本集團截至2026年6月30日止六個月錄得淨虧損人民幣14.5百萬元，而本集團的淨虧損率則為17.5%。虧損增加之主要原因為研發成本的增加及減值準備撥回的減少。

貿易應收款項及應收票據

貿易應收款項及應收票據自2025年12月31日的人民幣213.5百萬元減少至2026年6月30日的人民幣177.4百萬元，主要因為本集團上半年繼續加大收款力度。

貿易應付款項

貿易應付款項自2025年12月31日的人民幣125.6百萬元減少至2026年6月30日的人民幣83.8百萬元，主要由於尚未完工的項目數目減少。

Contract Assets

The decrease in contract assets from RMB19.9 million as at 31 December 2025 to RMB2.7 million as at 30 June 2026 was primarily due to the fewer number of ongoing projects.

Contract Liabilities

The increase in contract liabilities from RMB34.2 million as at 31 December 2025 to RMB37.2 million as at 30 June 2026 was primarily due to an increase in contract liability related to a project in Guangdong Meizhou.

Borrowings

As at 30 June 2026, the Group had borrowings of RMB62.5 million provided by several financial institutions in China, which were dominated in Renminbi and were secured by the Group's assets and personal guarantee provided by, among others, the Group's controlling shareholder, Mr. Cai Zhuhua, and his spouse, Ms. Huang Ying (as at 31 December 2025: RMB74.8 million).

Capital Expenditure

For the six months ended 30 June 2026, the Group's material capital expenditure amounted to approximately RMB9.3 million (for the six months ended 30 June 2025: RMB33.0 million), mainly used for purchase of property, plant and equipment.

Capital Commitment

As at 30 June 2026, the Group had capital commitment amounted to RMB1.0 million (as at 31 December 2025: RMB1.0 million) which consisted mainly of payments to be made for the pyrolysis solid waste treatment project in Jiangmen.

合約資產

合約資產自2025年12月31日的人民幣19.9百萬元減少至2026年6月30日的人民幣2.7百萬元，主要原因是尚未完工的項目數目減少。

合約負債

合約負債自2025年12月31日的人民幣34.2百萬元增加至2026年6月30日的人民幣37.2百萬元，主要由於一項與廣東梅州項目有關的合約負債增加。

借款

於2026年6月30日，本集團獲數間中國金融機構提供借款人民幣62.5百萬元，有關借款以人民幣計值，且由（其中包括）本集團的資產提供擔保及本集團控股股東蔡珠華先生及其配偶黃瑛女士等人提供個人擔保（於2025年12月31日：人民幣74.8百萬元）。

資本開支

截至2026年6月30日止六個月，本集團的重大資本開支約為人民幣9.3百萬元（截至2025年6月30日止六個月：人民幣33.0百萬元），主要用於購置物業、廠房及設備。

資本承擔

於2026年6月30日，本集團的資本承擔為人民幣1.0百萬元（於2025年12月31日：人民幣1.0百萬元），主要包括為江門無氧裂解項目固體廢物處置項目所作的付款。

Pledge of Assets

As at 30 June 2026, the Group had pledged trade receivables and right-of-use assets amounted to RMB32.6 million and RMB17.0 million respectively (as at 31 December 2025: pledged trade receivables and right-of-use assets amounted to RMB32.0 million and RMB17.2 million respectively).

Contingent Liabilities

As at 30 June 2026, the Group had no material contingent liabilities.

Liquidity and Financial Resources

Cash and cash equivalents of the Group as at 30 June 2026 were approximately RMB87.7 million (as at 31 December 2025: RMB95.8 million). As at 30 June 2026, the Group had net current assets of approximately RMB149.8 million (as at 31 December 2025: RMB153.6 million).

To meet our working capital needs, the Group secured bank borrowings. As at 30 June 2026, The Group's bank borrowings amounted to approximately RMB62.5 million (as at 31 December 2025: RMB74.8 million), all of which are fixed-rate.

Gearing Ratio

As at 30 June 2026, the current assets of the Group were approximately RMB359.8 million, total assets were approximately RMB633.9 million, current liabilities were approximately RMB210.0 million and total liabilities were approximately RMB250.0 million. The gearing ratio (total liabilities/total assets) of the Group was approximately 39.4% (as at 31 December 2025: 43.6%).

Significant investments held, material acquisitions and disposals

Save for the termination of the joint venture agreement as disclosed in the Company's announcement dated 18 June 2026, the Group had no significant investments held, material acquisitions and disposals of subsidiaries or associated companies, or investment projects for sale for the six months ended 30 June 2026.

為滿足我們的營運資金需求，本集團獲取銀行借款。於2026年6月30日，本集團的銀行借款金額約為人民幣62.5百萬元（於2025年12月31日：人民幣74.8百萬元），均為固定利率。

資本負債比率

於2026年6月30日，本集團之流動資產約為人民幣359.8百萬元，總資產約為人民幣633.9百萬元，流動負債約為人民幣210.0百萬元及總負債約為人民幣250.0百萬元。本集團之資本負債比率（負債總額／資產總額）約為39.4%（於2025年12月31日：43.6%）。

除本公司於2026年6月18日公告所披露的終止合資協議外，截至2026年6月30日止六個月，本集團並無所持重大投資、重大收購、出售附屬公司或聯營公司或可供出售投資項目。

Treasury policy

The bank balance and cash held by the Group were denominated in Renminbi, Hong Kong dollars and United States dollars. The Group currently does not have a foreign currency and interest rate hedging policy. However, the management of the Group monitors foreign currency and interest rate exposure from time to time and considers hedging significant foreign currency and interest rate exposure when necessary.

Future plans for material investments and capital assets

As of 30 June 2026, the Group did not have any future plan for material investments or capital assets.

III. PROSPECTS

In recent years, the PRC government has over time introduced a series of policies that have far-reaching impact on the development of the environmental protection industry, and promoted the sustained and rapid development of environmental protection. The realisation of “Beautiful China Initiative” and “Ecological Civilization” has been written into the PRC Constitution, highlighting the importance of ecological civilization construction in the overall layout of the country, and the construction of ecological civilization has risen to the level of national will. The report of the 20th National Congress of the Communist Party of China further listed ecological environment as a separate chapter, specifically expounding “Pursuing Green Development and Promoting Harmony between Humanity and Nature”. It means that ecological environment protection has become an important part to guarantee for the sustainable development of the whole society in our country, and a key part of its policy.

近年，中國政府已隨時間推出一系列對環保行業發展有深遠影響的政策，並促進環境保護的可持續及急速發展。實現「美麗中國倡議」及「生態文明」已獲納入中國憲法，強調建立生態文明對國家整體佈局的重要性，且建立生態文明已提升至國家願景層面。黨的二十大報告將生態環境單列一章，具體闡述「推動綠色發展，促進人與自然和諧共生」。意味著生態環境保護在我國已然成為關乎全社會可持續發展的重要保障，也是執政施政的關鍵一環。

As China's economy continues to advance and urbanization rates rise, alongside improvements in living standards, the establishment of facilities for the harmless treatment and resource utilization of solid waste has become indispensable component of urban development infrastructure. The national government has issued a number of policies to support and guide the development of the solid waste treatment industry, such as the "Comprehensive Solid Waste Management Action Plan", "Work Plan for the Construction of "Waste-Free City" during the "15th Five-Year Plan" Period", "Environmental Infrastructure Construction Standard Improvement Action (2026-2030)" and so on. With a strong support from national policies, the demand for solid waste treatment will continue to grow. The Group will seize these development opportunities by virtue of its own strength and a leading solid waste treatment solutions provider in China.

The Group will continue to capture the opportunities brought by the policies for the development of the environmental protection industry, and actively seize more business opportunities from solid waste treatment by commercialising its advanced solid waste treatment technologies to market with the resources from strategic shareholders, the capital market network, and its strong R&D capabilities. The Group will continue to focus on the technology innovation, actively use the major technological breakthroughs and R&D project experience in the past few years, and take advantage of the domestic economic recovery, to further expand the Group's business scope, maintain the Group's leading position in the market, maximize shareholder returns. Looking forward, the Group will carry out the following tasks based on its existing advantages:

Continue to strengthening the market position and expand the market share on hazardous waste incineration

The Group will focus on: (1) further improving techniques on hazardous waste incineration treatments; (2) continuing to cultivate customer relationships as well as to explore new customers in both China and overseas markets; (3) facilitating more frequent communications and providing more comprehensive value-added services with industry participants; and (4) further investment on other area of hazardous waste treatment, including applying the facilities of oil sludge thermal desorption technology, upgrading cement production facilities to implement hazardous waste cooperative disposal system and etc.

本集團將繼續抓住環保行業發展政策所帶來的機遇，憑藉策略性股東的資源、資本市場網絡及其強大的研發能力將先進的固體廢物處理技術商業化，從而積極把握更多來自固體廢物處理的商機。本集團將繼續專注於技術創新，積極利用過去幾年的重大技術突破和研發項目經驗，乘著國內經濟復甦的東風，進一步拓展本集團的業務範疇，維持本集團的市場領先地位，為股東帶來最大回報。展望未來，本集團將繼續以其現有優勢進行以下任務：

繼續鞏固市場地位，並擴大在危險廢物處置領域的市場份額

本集團將專注於：(1)進一步提高危險廢物焚燒處理技術；(2)於國內外市場繼續培養客戶關係及發掘新客戶；(3)與行業參與者進行更頻繁的溝通及提供更全面的增值服務；及(4)進一步投資危險廢物處理的其他範疇，包括應用油泥熱脫附技術及升級水泥生產設施以推行協作處置系統等。

Grasp more business opportunities on solid waste treatment through industrialization of pyrolysis technology

The Group will explore the market demand by developing and commercializing solutions for a number of new solid waste treatment applications such as with respect to waste plastics and waste paper residues.

Further enhance our competitiveness and risk management with the adoption of more project models

The Group will continue to seek opportunities to participate in solid waste treatment projects by exploring different project models, such as the first operation and maintenance services project, an oil sludge treatment facility designed and commissioned in Karamay. In future, the Group may also consider investing in and/or operating its own solid waste treatment projects as primary or joint project owner in other new area of solid waste treatment industry.

Actively explore innovative applications of artificial intelligence (AI) in the environmental technology sector

The Group will actively explore the application potential of AI and other digital technologies in the environmental protection sector to drive business upgrade through technological innovation. AI technology demonstrates its significant value in processes optimization, operational efficiency improvement, and environmental data analysis capability enhancement. By continuing to promote intelligent exploration, we expect to further enhance our technological innovation capability and project management, thereby contributing our technological expertise to the sustainable development of the environmental industry.

Utilize capital market platform to realize enterprise value appreciation

While developing business and expanding the markets, the Group will leverage its strong capital strength to enter the fields of solid waste treatment through various approaches, such as technology cooperation, investment, mergers and acquisitions, so as to build an integrated environmental industry group.

1 GENERAL INFORMATION

Weigang Environmental Technology Holding Group Limited (the “**Company**”) was incorporated in the Cayman Islands on 18 May 2017 as an exempted company with limited liability under the Companies Law of the Cayman Islands. The immediate holding company and the ultimate holding company of the Company are WeiGang Technology Limited and Weigang Green Technology Limited (“**Weigang Green**”), respectively, both of which were incorporated in the British Virgin Islands (“**BVI**”). Weigang Green is wholly owned by Mr. Cai Zhuhua (“**Mr. Cai**”), the ultimate controlling shareholder of the Company, who is also the chairman and executive director of the Company. The shares of the Company has been listed on the Main Board of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) since 3 January 2019.

The address of the registered office of the Company is 190 Elgin Avenue, George Town, Grand Cayman, KY1-9008, Cayman Islands and the address of principal place of business of the Company is Unit 3904, 39/F, AIA Tower, 183 Electric Road, North Point, Hong Kong.

The Company and its subsidiaries (collectively referred to as a “**Group**”) are principally engaged in hazardous waste incineration turnkey solution provider in the People’s Republic of China (the “**PRC**”) focused on the research, design, integration and commissioning of solid waste treatment systems particularly for oilfield auxiliary services, cement plant parallel kiln co-treatment solution services and hazardous waste incineration.

The condensed consolidated financial statements are presented in Renminbi (“**RMB**”), which is also the functional currency of the Company.

2 BASIS OF PREPARATION

The condensed consolidated financial statements have been prepared in accordance with International Accounting Standard (“**IAS**”) 34, “Interim Financial Reporting” issued by the International Accounting Standards Board (“**IASB**”) as well as with the applicable disclosure requirements of the Rules Governing the Listing of Securities on the Stock Exchange.

12 PROPERTY, PLANT AND EQUIPMENT, RIGHT-OF-USE ASSETS AND INTANGIBLE ASSETS

During the current interim period, the Group acquired property, plant and equipment with an aggregate cost of approximately RMB6,347,000 (six months ended 30 June 2025: RMB3,273,000). The Group has also invested approximately RMB2,955,000 (six months ended 30 June 2025: RMB29,728,000) for construction in progress during the six months ended 30 June 2026.

During the current interim period, the Group disposed of certain motor vehicles (six months ended 30 June 2025: office equipment and motor vehicles) with an aggregate carrying amount of approximately RMB87,000 (six months ended 30 June 2025: RMB233,000), for proceeds of approximately RMB76,000 (six months ended 30 June 2025: RMB226,000) in aggregate, resulting in a loss on disposal of approximately RMB11,000 (six months ended 30 June 2025: RMB7,000).

During the current interim period, the Group entered into a (six months ended 30 June 2025: one) new lease agreement with lease term of 2 years (six months ended 30 June 2025: 10 years). On date of lease commencement, the Group recognised a right-of-use asset of approximately RMB1,163,000 (six months ended 30 June 2025: RMB3,067,000) and a lease liability of approximately RMB1,163,000 (six months ended 30 June 2025: RMB3,067,000).

During the six months ended 30 June 2025, on date of lease modification, the Group derecognised right-of-use assets approximately RMB436,000 and lease liabilities of approximately RMB361,000.

During the current interim period, the Group had written-off certain intangible assets with an aggregate cost and accumulated amortisation of approximately RMB1,900,000 and RMB1,472,000, respectively, resulting in loss on write-off of RMB428,000.
